J. G. Hunt, 89, Area Pioneer, Dies April 9

One of the County's true pioneers, Jesse Grover Hunt, 89, died in Collingsworth General Hospital Tuesday, April 9, at 10:00 a.m. He had been in ill health several years and was unable to leave his home.

He was born at Tupelo, Miss., September 15, 1884, but he was only seven years old when his parents, Jesse Ivy and Sarah Pounds Hunt, chartered a freight car, and bringing with them their younger children, set out on their move to the lower Panhandle of Texas.

They left the train at Childress, and continued northward to the Arlie community. Grover Hunt was the youngest of 11 children and the last surviving. Those who were older remained in Mississippi when the family came west, following various professions. Three

Hay Camp Names Terry as Golf Pro

Hay Camp Country Club approaches its second season with the announcement of several major new developments.

Perhaps of greatest interest is the announcement that Jim Terry has joined the staff as golf professional and course superintendent.

Other developments disclos-

ed by A.B. Dean, owner, concern the golf course, swimming pool and new lounge.

Seeding the course will begin within a few days, Mr. Dean said, and should be opened to the membership in July or August for play.

Located a short distance from the entrance of the club grounds, the course is described by Mr. Terry as promising to be the most interesting and beautiful above all others that he has helped to develop. Likewise, it will be one of the most challenging in the lower Panhandle. The pro shop was completed last year.

Mr. Terry grew up on a sand green golf course in Amarillo and has been a golf professional all his life with the exception of five years during World War II, when he was an officer and pilot in the Naval Air Corps. As a Class A member of the Professional Golf Association, he has held positions at Hereford, Amarillo, Childress, Los Alamos, N'M, Seminole and Clarendon.

Hay Camp is the eighth golf course he has been associated with in building. He and his wife, Irma, have three children, Susan, a teacher in Fayetteville, Ark., Douglas, a student in Texas Tech, and Alicia, who attends Wellington High School.

Located next to the pro shop is the swimming pool—possibly the only one in the region where swimmers may laze in the water of a hilltop pool and look out over rolling tree-studded hills.

First Storm Damage This Year Received at Dodson and Loco

The county's first storm damage of this year came Wednesday, April 10, at 10:30 p.m. as twisters struck west of Dodson, east of Loco and south-east of Dodson.

About the same time, a funnel cloud was reported about four miles southwest of Wellington. It did not touch ground, and after it went back into the cloud, it was not sighted again, according to the office of Sheriff John Rainey.

It was unmistakably a twister that damaged the southeast part of the county, residents say. It is not known, however, if the damage came from one twister that dropped down out of the clouds several times, or if there were several funnels.

West of Dodson, most damage was to cotton trailers, other equipment and outbuildings.

East of Loco, however, a substantial 5-room house on the Silas Crawford farm was so badly damaged it is thought to be a total loss, a three-room house was destroyed, and several cotton trailers were destroyed or badly damaged, according to Mrs. Crawford.

The twister dipped down 300 yards west of the Garland Hightower farm. One farm trailer was completely demolished and others were broken and twisted. A highline pole was twisted off and a barn left in a leaning position.

Mr. Hightower reported a 10-foot livestock water tank was picked up, hurled over the house and dropped down 200 yards farther on, rightside up and in the middle of the road. Damage was not heavy. The family was in the house when

this occurred, not having had time to go to a cellar.

Three-quarters of a mile away, the twister struck at a farm owned by Kenneth Hudson and Truett Holland farms. Southeast of Dodson, a barn was reported destroyed at the Reggie Lewis farm.

Around Dodson, there were no injuries and no reports of

anything but minor damage to homes.

A considerable length of fencing was torn out on the Hightower, Dodson, Hudson and Truett Holland farms.

Rainfall measured three-quarters of an inch.

Wellington received .25 inch of rain, said Charles Floyd, Weather Bureau observer. Most residents of the town were not aware of the storm activity so near by.

Special Election Called to Elect Council Member

The City Council has called a special election for Tuesday, May 28, to fill a vacancy now existing in that body.

Garner Altom, who received the high vote in the regular city council election, notified Mayor Bill Hatch on May 12 that he now believes there could be a conflict of interest in his holding the post of administrator of Collingsworth General Hospital and the office of councilman, since both are salaried by the taxpayers.

Mr. Altom declined to be sworn into office. The other two new council members, Wayne Cudd and Earl Lynn Bartlett, took the oath of office Monday night, April 15. Going off the council were Loyd Vines and Ralph Owens.

A check of the Texas Election Laws showed that if an elected council member resigns before he is sworn in, that vacancy must be filled in a special election.

Mr. Altom's letter to Mayor Hatch pointed out that it was his strong conviction that every citizen in any community should at some time make him-

self available to serve the community, plus the urging of some citizens, that led him to seek the office.

"Although the courts have not tested specifically the case

In 1894, Jesse Hunt and his sons built a half dug-out of native stone, bringing the rock from Red River. It became a landmark of the area.

Years later, Highway US 62 passed by it, and people traveling the road watched for the building, which stood until recent years. There are still remains. A number of artists have painted it, either intact or the ruins.

Mr. Hunt attended school in another dugout - the first Buck Creek School. It served the area before the school west of town was founded with the same name.

Mr. Hunt was married in 1912 to Miss Willie Preston White, daughter of the late Mr. and Mrs. F.L. White, Sr., pioneers of the Kelley community. They had been married 62 years at the time of his death.

He was a member of the Baptist church 75 years and served as president of the Training Union of First Baptist several years.

Mr. Hunt, with his brothers, Claude Hunt and Aubrey Hunt, opened the first furniture store in Dodson after it was established in 1910. Later he farmed. The family has made their home at 1301 Arlington Street for many years.

Funeral services were conducted at First Baptist Church at 2:30 p.m. Friday, April 12. Officiating were the Rev. Roy D. Collins, Jr., pastor, and the Rev. Howard Jones of Hamlin, a former pastor. Burial was in Fairview Cemetery under the direction of Kelso Funeral Home.

Pall bearers were Herman Childress, Gene Morrow, Robert Posey, Louis Allred, David Peters and Oran Starkey.

Surviving Mr. Hunt are his wife; a son, Randolph Hunt of Wellington; three daughters, Mrs. Maurine Carman of Ft. Walton Beach, Fla., Mrs. Betty Jo Conant of Wellington and Mrs. Billye Sue Houchins of Altus, Oklahoma. There are 7 grandchildren and two great grandchildren.

"My responsibility to our community, as I feel it, is to give myself first to the position at the hospital for which I was employed and second to do whatever I can through my church, Chamber of Commerce and civic organizations for the good of our area.

"I would not knowingly or willfully do anything that would place in jeopardy your hospital and your hospital board, therefore, I apologize to all who entrusted their vote to me or in any way might have been inconvenienced."

Mr. Alton told The Wellington Leader he consulted with an attorney and with hospital board members before reaching his decision.

The remainder of the council's agenda was light. City Manager Lyman Daniel reported the city has received a \$5, 885 Revenue Sharing check, and also that the new loader is due to be delivered this week.

Home Management

By Mrs. Arla Felts

Refined peanut oil -- one of the "best cooking oils known to domestic sciences" -- is widely used for deep fat frying in the food industry.

At the same time, however, homemakers traditionally haven't used it.

Defining "smoke point," it's the lowest temperature at which an oil decomposes to produce smoke.

Peanut oil's smoke point is 450-470 degrees F. -- which means it can be heated to those temperatures before it will smoke, making it a good cooking -- especially frying -- oil.

It also can be used successfully in fondues for frying donuts, meat pies or fried pies.

Turning to flavor, the nutty, pleasing flavor and the amber color of the oil is dependent upon the variety of peanut, growth conditions and refining process. Some peanut oils of good quality may be slightly darker in appearances.

Substitution of this oil in any recipe specifying a melted shortening assures excellent results.

Certain salad dressings and pastries take on unique flavors when made with peanut oil. They include, for example, Oil and Vinegar Dressing, Sunset Dressing, and Peanut Butterscotch Squares.

Also, recipes specifying olive oil are equally as tasty when peanut oil is used.

Peanut oil is termed "very stable" -- meaning it will store at room temperature for considerable periods of time.

Noting that peanut oil is almost 98.3 per cent digestible by man, one tablespoon -- or 14 grams -- of the oil contains 124 calories, 14 grams of fat and 7.3 grams of polyunsaturated fatty acids.

PEANUT BUTTERSCOTCH SQUARES

- 1/2 cup peanut oil
 - 1 cup dark brown sugar
 - 1 egg
 - 1 teaspoon vanilla
 - 2 cups sifted enriched flour
 - 1/2 teaspoon baking powder
 - 2 to 3 tablespoons milk
 - 1/2 cup chopped salted peanuts
- Frost as desired

Measure peanut oil, brown sugar, egg and vanilla into mixing bowl. Mix thoroughly. Stir flour with baking powder and stir into oil-sugar-egg mixture, adding enough milk to leave dough quite stiff, but slightly moist. Stir in peanuts. Pour dough into greased 9-inch square baking pan. Bake (350 degrees F.) 25 to 30 minutes or until lightly browned around edges.

- 1/2 cup peanut oil
- 1/4 cup vinegar
- 1/4 cup catsup
- 1 teaspoon salt
- Dash Hot Sauce
- 2 hard-cooked egg yolks, crumbled
- 2 tablespoons minced green pepper
- 1 teaspoon minced onion

Place all ingredients in a bottle with tight lid. Shake vigorously until thoroughly mixed. Serve over meat or fish salad.

Fix-It Tip

The first year for a new house is the break-in period. Count on some trouble just as you might with a new car. Major defects should be brought to the attention of the builder. Some minor problems are bound to occur and you should expect them and not worry about them.

Every new house settles. It can be a little or a lot. And you can figure some materials in the house will shrink while others swell.

Houses don't settle evenly. If they did there wouldn't be any problems. The earth under the house will settle in one area but not another. The result is structural cracks. Hairline cracks around windows and in corners will not affect the strength of the walls.

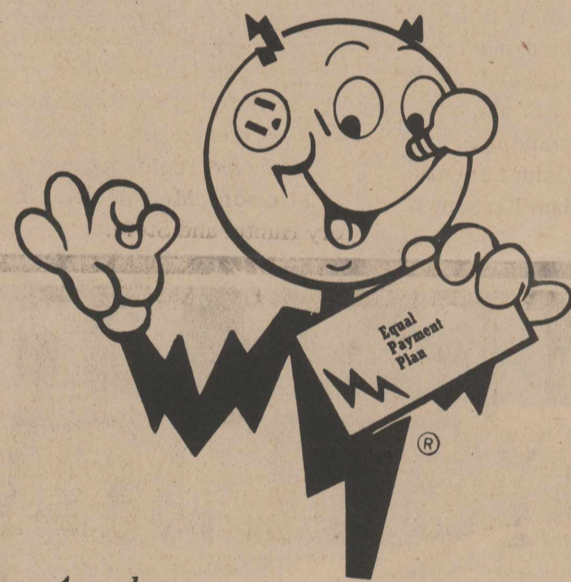

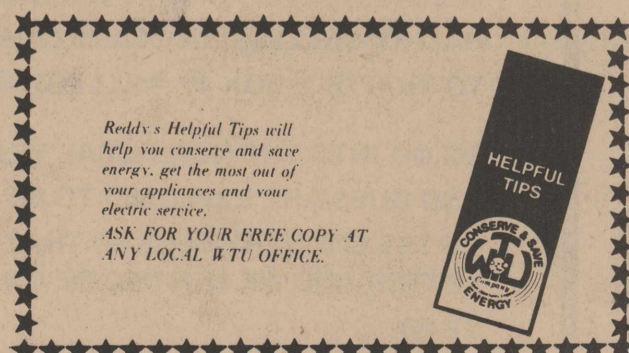

Happy Homemaking

To remove perspiration odors from foam rubber pillows and mattresses, fill an empty window spray bottle with vinegar and lightly spray the items to be deodorized, letting them dry thoroughly.

Instead of putting candles on your child's next birthday cake, make a clock face with icing of a contrasting color, and have the hour hand pointing to the age of the child.

To fix a snag in a knit, push a large-eyed needle down into the fabric right by the snag so the pulled thread can be threaded through the nee-

dle's eye and pulled back where it can be tied.

To remove milk stains from carpets, pour a small amount of club soda on a rag or sponge and rub gently -- no rinsing needed.

A tablespoon or so of ammonia in a small open bowl of water will dissipate tobacco odors and can be left out all the time.

Next time you wash your car, put your roll of paper towels over the car's antenna. The towels will not be blown away, and you have easy access to them to speed your drying.

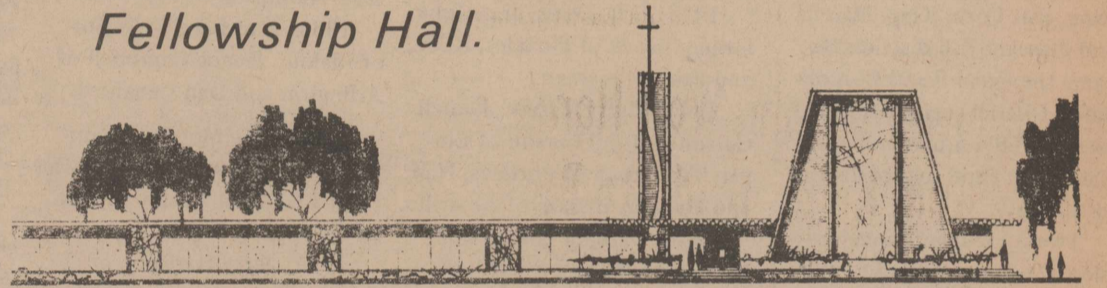

Quail Ex-Students Gather For Annual Banquet Sat.

Quail ex-students gathered to reminisce during their annual reunion Saturday, April 13, but there was one feature recalling the early years of consolidation they did not call for. The sand blew all day long, just as it had so many times during the latter years of the 1930s and intermittently since then. Nevertheless, the school gymnasium was filled with former students, some returning for the first time.

During the short business session, Cary Don Neeley of Quail was elected president; Billy Moseley vice president; Melba Langley, treasurer; and Martha Johnson Morris, secretary.

Dale Morris of Samnorwood, president, was toastmaster at the banquet which ended the 1974 festivities.

The program was directed by Jenny Ann Kennedy Davis and Judith Wilson McQuay, both of Amarillo. Mrs. McQuay showed slides and pictures, while Mrs. Davis gave the commentary. Much of the early history of the school flashed before the reunion audience eyes. Here are excerpts from Mrs. Davis' remarks.

During the spring of 1935, the citizens of seven school districts in the western part of Collingsworth County voted to combine their districts in order to secure for the children of these communities better educational facilities. As a result of this move, the Quail, Lillie, Ring, Salt Fork, King, Marella and Pleasant Hill districts became the Quail Rural Consolidated District, comprising an area of 168 1/2 square miles -- the largest rural school district in the state.

Twenty teachers were employed by the trustees of this new district, and arrangements were made to offer 22 subjects for the high school.

In May, 1935, Quail School District consolidated. September 9, 1935 was the first school day of the new school. Also in 1935, the first issue of the Quail Echo was published.

In 1936, the first Quail Community Fair, dedication of the new school building and the first Quail Annual Basketball tournament were held.

In 1937, Marella Ward School moved to Quail. Also the Quail boys and girls won the first Coun-

ty Basketball championship, with the boys team continuing on to win the State Championship.

The year 1939 began with the dedication of the Homemaking Cottage. Ester Johnson, a world famous musician, presented a concert, and the Bray and McKnight High School students came to Quail.

The first Quail alumni Banquet was held in 1940. In 1941 Quail won both county and district league meet.

Other pictures and slides recalled how youngsters did a principal part of the hand harvesting of cotton during the 1940 of the Future Farmers of America projects and teams, of "a lost art at Quail, broadcasting in radio dramatics."

The skating rink was recalled, and boxing matches. Dalton Vaughan, boxing coach, was present for this reunion.

The senior class of 1950 was pictured the day it went boll pulling, with Jerol Morris and Doodle Langley the champions.

There were pie eating and watermelon eating contests from 1953.

Individual and group pictures, many of them hilarious, made up the remainder of the program.

and the surrounding counties, 7,500 tons per day, will be burned in Union Electric boilers to generate electricity under a mixture of 20% trash and 80% coal. This will save Union Electric 1-million tons of coal a year and get rid of a massive trash problem for St. Louis and the surrounding area. The fuel savings to Union Electric are estimated \$10-million a year and these savings will increase as the price of coal rises in the future.

Union Electric also expects to reap additional financial benefits by receiving the dumping fees now paid by commercial sanitation hauling companies for places to dump trash for landfill or to incinerate it. Too, a ton of garbage contains approximately 150 pounds of usable steel and about 20 pounds of other metals which can be sold for scrap.

It has taken two years and \$3.3-million to prove the feasibility of such a project. Most ventures such as this wind up being sponsored by municipalities or counties. The refreshing thing about the St. Louis project is that it is sponsored by an investor-owned utility.

So far only coal-burning electric generating plants can convert to garbage fuel, but experiments are being made to see if garbage can be converted to a fuel similar to oil which can then be used in oil-fueled electric generating plants.

Since a 20%-80% garbage and coal fuel mixture has been used successfully, a project is now underway to get the fuel mixture up to a 50-50 ratio in plants specifically designed for garbage fuel.

What a great accomplishment to discover that garbage, which costs huge sums of money to dispose of, now has a valuable and worthwhile use to benefit mankind. Now that's progress.

Perceptive visitors and those who have come in recent years almost invariably have this to say: The recreational possibilities of Collingsworth are amazing. In this, we might take note from the area around Bandera, which a number of years ago began its move into dude ranch country.

These are not giant dude ranch complexes, but for the most part small family operations. Some are working ranches.

What they do offer is comfort and relaxation and the type of entertainment we are all used to - country barbecues, rodeos on occasion, fishing, etc. Some offer both food and lodging. Others have modern cabins with kitchenettes where the vacationer prepares his own meals.

We have a considerable amount of country, much of it in the rougher areas off the pavement, that has as much to offer in beauty as some of our more famous dude ranch country.

Metropolitan business and professional people, and many in small towns as well, work at a hard pace, and they value a few days relaxation of this sort. Moreover, they are willing to pay well for it.

Medics to the Rescue

Vice President Ford has suggested a practical way to improve medical care in rural areas. His plan would enlist veteran paramedics, who received considerable on-the-job experience in Vietnam, to care for the basic medical needs of people in areas which don't have doctors.

The ideal plan would be to train enough doctors and convince some of them to practice in rural areas.

But the severe shortage of adequate medical care in rural areas (many counties don't even have a public health nurse) needs immediate attention. The idea of letting nurses and paramedics handle more responsibility in such places is being tried in a few areas and offers a practical solution to the problem.

"With our vast resources and higher standards of living," Mr. Ford said, "there is no excuse for a single rural American to be deprived of the finest available treatment."

Indeed there is not.

AUSTIN, Tex. - It's show and tell time for political candidates, and many of them don't have as much to show as they would like to for their fund-raising efforts.

Gov. Dolph Briscoe ran second to Republican gubernatorial candidate Jim Granberry in campaign spending up to March 25, according to the first contribution-spending reports filed with the secretary of state.

Granberry reported contributions and loans of \$171,425 (including \$22,500 of his own money) and spending of \$171,425 since last summer when he began his race.

Briscoe's spending - including a \$120,000 loan of his own money - was pegged at \$153,754.

Frances "Sissy" Farenthold reported some \$40,865 in expenditures and debts.

The effort is far below that of 1972 when Briscoe spent nearly \$1.6 million in the primaries, and Mrs. Farenthold spent \$672,441.

Comptroller Candidate Bob Bullock has reported spending of about \$60,000 in his Democratic race, and Hugh Edubrg said he has outlays of about \$12,900.

Edubrg acknowledged he is using about \$7,000 of his own money. Bullock said he has used \$12,600 from his own resources, and has \$38,300 in loans from his business partner, Ken Wendler of Austin.

One of the big-spending groups so far has been the Texas Citizens for Parimutuel Horse Racing, which reported a \$7,000-cost campaign to get the issue of legalizing race track betting on primary ballots.

NEW CONVENTION GOAL - With the Constitutional Convention in recess, President Price Daniel Jr. has a new goal: he is aiming to wind up the revision task by May 31.

Actually, he conceded the first or second week of June is a more realistic target.

Two of the toughest articles - judiciary and general provisions (which includes the controversial right to work issue) - remain to be debated when delegates return to Austin.

They must also vote again (and muster a two-thirds majority) on the seven articles approved tentatively so far, and then decide the form of submission of the constitution, and alternative proposals to voters.

PRISONER COLLEGE PLAN OFFERED - Prison inmates at Ramsey Unit will be the first in the U.S. to be offered a chance at four-year college degrees through the University of Houston at Clear Lake City. Junior college associate de-

grees have been available since 1965 through special programs.

Thirty-to-60 students will begin classes at Ramsey Unit in June. Next fall, Stephen F. Austin University is due to extend courses to inmates at Coffield Unit near Palestine.

"The more education a man has, the less likely he is to return to prison," said State Prison System Director W. J. Estelle.

CONTRACT AWARDED - A contract for the first modernization of property tax laws since 1925 has been awarded by the Legislative Property Tax Committee.

Law Research Corporation of Texas, an Austin group, received the maximum \$125,590 - cost recodification contract.

LPTC abandoned a plan to conduct an intensive school property tax survey on a totally-random-selection basis. The 35 school districts will be re-selected to insure a geographic spread in five regions.

COURTS SPEAK - Power of city governments to regulate extended area telephone rates was approved by the State Supreme Court.

The High Court turned down a Houston woman's appeal in a lawsuit in which she has unsuccessfully claimed \$635,000 in damages against a doctor due to an unusually large appendectomy scar.

The Court of Criminal Appeals reversed a San Saba murder conviction because the jury didn't decide a sanity question.

Murder conviction of a Dallas man who set fire to car in which another was asphyxiated lost an appeal from a life sentence.

Attorneys for former House Speaker Gus Mutscher, appealing a conviction for bribery conspiracy, argued before the Court of Criminal Appeals that no conspiracy was ever proved and the principal witness was not asked about it.

FAMILIES NOTIFIED - A new state program offering toll-free telephone service has contacted 861 families, relaying messages on runaway children, Governor Briscoe reported.

Since last September, Briscoe said, the program, "Operation Peace of Mind," has received 1,890 calls from runaways in 42 states. The national hotline enables the runaways to relay messages to their parents from a round-the-clock, volunteer-manned center in Houston.

APPOINTMENTS - Frank Hutchinson is new director of Minority Business Enterprise.

Robert A. Sartwelle of Houston was appointed by Governor Briscoe to the San Jacinto Historical Advisory Board.

Dann Barger of Brownwood is new superintendent of the Crockett State School.

MIGRANT OFFICE CREATED - A Migrant Affairs Office and Migrant Fuel Allocation Plan for Texas were set up by executive order of the governor last week.

The MAC will act as liaison with all agencies which serve migrant groups and try to identify present and future resources at federal, state and local levels to aid with problems.

The fuel program will permit migrants to obtain gasoline at 51 designated truck stops as they move north during agricultural seasons.

"PRIVATE" SUPERPORT ENDORSED - A Senate committee endorsed private ownership of a Texas superport,

but two coastal area senators objected.

The Committee report said it is not "the responsibility of state government to underwrite this kind of risk when private enterprise is ready and willing to accept the challenge."

Sens. D. Roy Harrington of Port Arthur and Bob Gammage of Houston said state ownership of the proposed offshore unloading terminal for oil tankers is in the best public interest.

Deck's DIDACTICS

—by Deskins Wells

COLLEGE graduates this year will have an easier time locating good jobs than did their predecessors in June of 1973 and 1972. Those were the years when many of the young hopefuls discovered to their disappointment that they were over-educated for the jobs available. Those with bachelors degrees found it easier to find employment than those who had put in more work to obtain a master's degree. The reason was simple. The companies wanted to do a good part of the training themselves.

IN THOSE years the higher educated, holding doctors degrees, found themselves walking the streets or taking jobs such as taxi drivers or whatever they could find. The age of space travel put such emphasis on advanced scientific learning that thousands of young men and women worked and sacrificed to obtain the higher degrees only to find there was no market for their specialized abilities.

IT IS good to know that the future of the June graduate is brighter this year. The big companies are recruiting this year. Once again they have representatives on the college campuses talking to the prospective employees.

THIS IS a good trend and indicates health in the economy; for this nation needs educated people. It needs people who have a knowledge of more than their jobs and of the vast changes that are going on around us.

WHILE there are more jobs for the graduates, there are still even more job openings in the skilled trades and in other, blue collar workers need not be so skilled. There are still too many young people entering college who could do better financially by learning to be mechanics, plumbers and cooks. And when you consider that many of these start earning good money four, eight and even twelve years ahead of those who graduate from colleges and universities, it becomes evident that they could earn more money over their entire lifetime. Many of them will be young enough to pursue another vocation after they retire.

JACK SANFORD gave me a cloud chart containing pictures of 35 different kinds of clouds. They range from the innocent cirrus family of clouds to the stratocumulus which is a treating storm cloud. The most dangerous cloud on land is the cumulonimbus which causes heavy rain and sometimes hail and tornadoes.

EVERYONE has vivid memories of clouds varying from the fluffy little white clouds floating lazily in the summer sky to the low hanging dark clouds that promise rain but probably not tornadoes or hail. None of us called the clouds by their scientific names; but we had names for the different kinds.

THE LITTLE fluffy clouds were sometimes called lambs in the meadow. They were welcomed by a man and his team plowing under the blazing sun and by the man on horse-back in the middle of a long ride. The approach of one of the larger ones was watched with anticipation and if it passed overhead the brief shade was appreciated.

THE MOST majestic clouds seen on the plains is the thunderhead, a fair weather cumulus cloud that can build into afternoon and evening showers. They are also the clouds that provide our marvelous sunsets in September and October. That does not mean that there are not

Farmers Co-up Members Hold Annual Meeting

Carl Wischkaemper was re-elected president of the board of directors of The Farmers Co-op Society, No. 1, following the annual stockholders meeting Saturday, April 13. R.L. Mabery was elected vice-president to succeed Louis Allred, who asked that he not be nominated for another term on the board. C.G. Lewis was re-elected secretary-treasurer, with W.E. Marchant named assistant secretary and J.N. Glasgow assistant treasurer. Re-elected by the membership to the board of directors for the coming year were Mr. Wischkaemper, Mr. Mabery, Mr. Lewis, Dan Henard, Jr., Jerol Morris and Dan Langford. Woodrow Wood was elected the new member to succeed Mr. Allred.

A highlight of the meeting was the distribution of \$208,431.47 in rebate checks, an average of approximately \$10 per bale on 21,549 bales ginned. In this connection it was pointed out that the grower who sold his seed received a slightly larger check than the grower who caught his seed as well as the grower who sold his cotton through the Farmers Co-op Gin.

Mr. Wischkaemper presided at the meeting, attended by approximately 65 members. He explained that \$24,000 was retained from the earnings to meet certain expenses. It will be necessary, he brought out, that in the future, all bales be of uniform size and of more nearly uniform weight. Overweight bales will be docked from \$5.00 to \$10 per bale, he said. To meet the uniform bale provision, certain changes will be required in the presses of both gin plants.

Three representatives of the National Cotton Council, Mack Alexander and Pete Brown of Lubbock and Gary Setliff of Sweetwater, presented films which discussed Cotton's future in the economy.

It brought out the image which the cotton farmer has in the eyes of the nation -- and the intensive nation-wide campaign being carried on by the National Cotton Council to counteract this.

JACK'S FOLDER has some interesting information as well as pictures. In one place it says: "A barometer is helpful in interpreting those signs, but only when its dial working is 'ignored' and attention is confined only to the rapidity of the rise and fall. Newspaper weather maps are of little use since weather fronts move about 600 miles in 24 hours, and newspaper maps usually appear 24 hours later. Thus today's map is yesterday's weather."

THAT IS WHAT I have been thinking about some of these maps in the magazines. It is either last month's weather or something that did not get here.
