## TAX REDUCTION IS PLANNED BY LITTLEFIELD SCHOOL BOARD

### RESOLUTION PASSED AGREEING TO REDUCTION OF PROPERTY VALUATIONS IN DISTRICT

Resolutions were taken by the members of the Littlefield school board in a meeting held this week to reduce school taxes in this district at least twenty per cent.

The board passed a resolution at the meeting agreeing to a one-fourth reduction in property valuation in the district to bring about the proposed tax cut.

In order to bring about the reduction, a substantial cut in expenses of the school district must be made, the resolution disclosed.

Following is a copy of the resolution passed by the board:

**Resolution:**  
WHEREAS, it appears to the School Board that the present economic and financial conditions of our school district warrant substantial reductions of expenses all along the line to the end that the School Taxes for the current year 1932, may be reduced;

Therefore, be it resolved by the School Board of the Littlefield Independent School District that the school board go on record as agreeing and do agree to reduce property valuations in this school district this year at least twenty-five per cent.

## DISCRIMINATION IS ALLEGED IN FAILURE OF LITTLEFIELD SCHOOLS TO GET TRANSPORTATION AID

Alleging discrimination against the Littlefield Independent School District, in the matter of state aid in the operation of school busses, the Littlefield Chamber of Commerce Tuesday directed a vigorous protest to S. M. N. Marrs, state superintendent of public instruction.

A letter, which was sent to Mr. Marrs, was signed by a large number of the members of the Littlefield Chamber of Commerce and by many other taxpayers and citizens.

The matter was brought to attention of the Chamber of Commerce by Arthur P. Duggan, president of that body and also president of the board of the Littlefield Independent School District.

Mr. Duggan said that the department had advised the Littlefield Independent School District that state aid in the operation of school busses would not be forthcoming because this school district "did not need it," notwithstanding the fact that it had been approved by a representative of the department.

The letter which was sent to Mr. Marrs was read to the gathering by R. E. McCaskill, also a member of the school board, and later the signatures were affixed.

County Superintendent of Schools Rochelle is working with the Littlefield Independent School District in an effort to obtain the state aid in connection with the operation of the busses.

Mr. Duggan pointed out that the state aid will amount to \$7,000 and that with this money it would be possible to close the present school year with all expenses paid.

The letter to Mr. Marrs.

The following is the letter which was sent to Mr. Marrs:

Littlefield, Texas,  
March 22nd, 1932.

Hon. S. M. N. Marrs,  
State Supt. of Public Instruction,  
Austin, Texas.

Dear Mr. Marrs:

"We, the undersigned citizens and taxpayers of the Littlefield Independent School District have been advised that your department has refused transportation aid for the Littlefield School District, the reason assigned being that we do not need it; that our ESTIMATED receipts and ESTIMATED disbursements are about the same, and that you are going to give transportation aid to other districts.

"Mr. Marrs your attention is called to the fact that ESTIMATED receipts do not always materialize. Such is the case in this school district now. Our people have been unable to pay their school taxes, on account of low prices, and we now have some \$30,000 in delinquents. Our school board has depended on this transportation aid; must have it in order to continue our school; we have complied with all the requirements of the law; we are entitled to it and we most EARNESTLY

The same year the schools of the county raised themselves \$203,443.64. Citizens of this county think a fair deal of their schools, and are not tax themselves heavily to run the best possible. The year the county paid into the treasury the sum of \$65,551.41. The same year the county received from the state the sum of \$203,443.64. The land area in Lamb county is 1,023 square miles, and the value of its lands is \$8.05 per acre.

Reports show Polk coun- ty with a population of 17,555 (scholastic population 5,549), area 1,217 square miles, value of lands \$7.88 per acre. Population, values, and area of the two counties are as near as possible.

### BULA GIN COMPLETELY BURNED SATURDAY NIGHT; WILL REBUILD

Fire of unknown origin completely  
destroyed the Bula Gin Saturday eve-  
ning, about 8:30 o'clock, which is  
owned and operated by J. A. Nickels.  
The building, which was a 24x90  
frame building, was constructed in  
the Spring of 1929, and the plant,  
and structure according to Mr. Nick-  
els, represented an investment of ap-  
proximately \$25,000.

The fire which occurred about  
8:30 p. m., is believed to have origi-  
nated in the seed house, and was  
first discovered by M. Calthorp, who  
lives across the street from the gin,  
and who turned in the alarm to the  
Littlefield Fire Department. The  
fire boys immediately responded, but  
the structure had already burned to  
the ground when they arrived on the  
scene.

According to the owner, insurance  
to the amount of about one-half the  
value of the loss was carried.  
Mr. and Mrs. Nickels left Bula a  
few days previous for a month's va-  
cation, and at the time of the fire  
were visiting a son, O. V. Nickels, at  
Blum, Texas. They were summoned  
home, and arrived Sunday.  
Mr. Nickels says they will start re-  
building in the near future, and that  
the building will be replaced in plen-  
ty of time for 1932 ginning.

the effect of soldiers in rank march-  
ing across a bridge in regular step.  
If they keep step, their rhythmic foot-  
falls would set up a vibration so se-  
vere that the bridge would crash if  
not a strong structure. So soldiers  
break step when they cross bridges.

closely, you can't tell that there is  
any variation in the size of the  
blocks in this silent all-weather de-  
sign, yet in that tread is the applica-  
tion of a principle that eliminate ob-  
jectionable hum.

**LITTLEFIELD LOSES  
ELECTION ON THE  
COUNTY SEAT**

A complete summary of the voting by precincts is published elsewhere in this issue of the Lamb County Leader.

In the county seat election Saturday Littlefield failed to obtain the necessary two-thirds majority to move the county's capital from Olton to this city, failing by 431 votes.

Littlefield polled 2923 votes; Amherst, which also sought to obtain the county's seat of government, obtained 1241 votes, and 935 votes were cast in favor of leaving the county seat at Olton.

There were 5,099 ballots cast in the election.

In the 1929 county seat election a total of 3848 ballots were cast, of which Littlefield received 2108 votes, or a percentage of the total vote of 54.78 per cent. In the election of Saturday last, 5,099 votes were cast, of which Littlefield received 2934, or 57.52 per cent of the total, making a gain over the 1929 election of 2.54 per cent.

Littlefield drew only two blanks in Saturday's contest, these occurring in the Sod House and Y. L. boxes.

A total of 1805 votes were cast at the Littlefield box.
