WAXAHACHIE, Apr. 10.—Within two hours after the state unexpectedly had rested in the trial of the civil-ouster suit against Le-grande J. Woods, county attorney of Navarro county, five witnesses had testified today that Woods' reputation for honesty and fair dealing was good, and that he was a vigorous prosecu-

M. Albright of Barry, who was of the October, 1927, grand jury at Corsicana, testified that Woods was a "fearless" prosecutor. Woods, he said, had served as county attorney for one year before he was removed from office on the order of District Judge Hawkins Scar-

ould impeach testimony testimony of George Pollan of was used in an attempt to im- that of Goldie Fay Smith, a member of a cold drink stand at Corsicana, who was one of the state witnesses. Goldie Fay Smith told that she "hated" Woods. Pollan B. Dodd of Navarro county appeared before the Navarro grand jury as a witness in the investigation of Domino parlors at Corsicana. He said he did not know what the grand jury did with the facts it obtained, but that Woods was with the grand jury and brought out all the facts.

Grand Jury Member Called

B. T. Matthews of Dawson, a member of the April, 1927, grand jury, said that the grand jury at that time investigated an automobile transaction involving B. Franklin and H. P. May. He said that Judge Scarborough in his charge declared that "some automobile company" in Dallas was "pulling shady deals" among negroes and oil field workers. The investigation brought the indictment of May and Woods did not use undue influence to get the grand jury to return a true bill, he testified.

J. S. Dyer of Rice, cotton buyer and farmer and a member of the April, 1927, grand jury, testified that Woods' reputation for honesty and fair dealing was good, and that he was a "fearless, fair and able" prosecutor. Woods, Dyer testified, was extremely "hard" on bootleg-

DEFICIENCY IS ALLOWED TECH

SUMMER SCHOOL FUND OF \$7,500 APPROVED BY GOVERNOR

(By Associated Press)

AUSTIN, April 10.—A \$7,500 deficiency appropriation to allow the operation of a summer at the Texas Tech college, Lubbock, will be authorized, Governor Moody said today.

The executive has numerous other requests for deficiencies pending before him. He construes the constitution as limiting him to \$200,000 biennially and has announced that pleas will be cut materially.

Fund Slashed But Full Session Seen

Plans for the coming summer session were made on the above deficiency appropriation. Dr. Paul W. Horn, president of the college said today. The sum will allow for a full session, he said, although the amount asked for was considerably reduced. The amount asked for meant to apply on extra work which was intended to have been employed during the coming session.

The announcement will in no way affect the session's business, Dr. Horn said, and plans and preparations are continuing for it. Officials were informed weeks back that the appropriation of \$7,500 was all that could be allowed for this session.

VIOLENCE MARKS VOTING ORGY

CHICAGO ASTIR WITH PRIMARY IN FULL SWING

SHOOTING, KIDNAPING AND SLUGGINGS ARE REPORTED EARLY

(By Associated Press)

CHICAGO, Apr. 10.—One shooting, several kidnappings, sluggings, ballot box stuffing and minor disorders were reported today less than two hours after the polls had opened following Chicago's hottest and most vituperative primary campaign.

The sun shone bright as more than a million voters started to the polls and election officials said that the fine weather, added to the interest in the campaign would result in a heavy Republican vote. Interest in the Democratic primary was not so intense because heads of the ticket were for the most part unopposed.

Candidate Missing

Before the polls had opened Titus Haffa, alderman, indicted for violation of federal prohibition laws and candidate for Republican committee on the ticket of Mayor Thompson, was reported missing and his headquarters believed he had been kidnapped.

R. H. Taylor, a Deneen precinct committeeman, was kidnapped by several men who forced him into their automobile as he was delivering ballots, beat him severely then shoved him out into the street.

Squads of detectives were rushed to several precincts shortly after the polls had opened on reports that election officials were permitting the stuffing of ballot boxes.

One Negro Is Shot

A negro was shot, another kidnapped in election disputes in the twentieth ward in the negro district. The most trouble during early hours was reported from the twentieth ward where hoodlums were reported chasing voters away from the polls. Detective squads and election officials were sent to investigate conditions.

A worker allied with the Senator Deneen Republican organization was reported kidnapped from one precinct in the twentieth ward.

At least one of the reported kidnappings fizzled out. Haffa, for whom his headquarters hunted all night in the belief that he had been kidnapped, was found by one of the 80 detective squads fast asleep in a Republican club in his ward.

Dumas Is Lodged In Travis County Jail

AUSTIN, Apr. 10.—J. H. Dumas, arrested in Lubbock Monday by the county grand jury's indictment charging him with murder and conspiracy to commit murder in connection with the slaying of two men at Rankin as alleged bank robbers, was brought here Tuesday by Ranger Jim McCoy for safe keeping.

Dumas was put in the Travis county jail. Another man who drew a similar indictment after Ranger Captain Frank Hamer had explained before the grand jury his charge that a "murder ring" had come up after the State Bankers' association offered \$5,000 rewards for dead bank robbers, had not been apprehended as far as could be learned here.

Tech Studes Meet To Plan Election

With the approach of the annual elections on the Tech campus in which various student officials are selected, the student council is meeting tonight to plan for the elections. It was announced today by Leslie Jennings, president of the student association.

Officials to be selected include the president, vice-president and secretary of the student association, the editor and business manager of the La Ventana and the Treasurer, and the life leaders.

The elections are to be held sometime during the month of May.

BOX SCORE

CHICAGO, April 10.—Four Chicago's election today's state primary started off with a rush to the polls under a benevolent blue sky and a fusillade of reports of violence which promised records.

Only the heavy voting continued, however, once the city's most elaborate plans for keeping an election clean began to function, and at noon the primary had become remarkably peaceful, considering the issues at stake.

FOUR DIE, FOUR HURT AS FIRE WRECKS HOUSE

MOTHER AND CHILDREN SUCCUMB TO FLAMES IN CHICAGO HOME

CHICAGO, April 10.—Four persons, a mother and her three children, were burned to death today, and four others were injured when fire destroyed their home.

A policeman saw the smoke belching from the house of Leslie Whitaker in the northwest part of the city. After crashing in the front door, he carried a woman outside and called the fire department.

Whitaker was found by the firemen wandering about the back yard blindfolded by the flames. His wife, Elizabeth, 22, and his three children, ranging from 18 months to 3-1/2 years, were dead.

Aunt Carried Out

The woman carried out by the patrolman was Mrs. Elizabeth Brayton, 62, of Warrensburg, N. Y., an aunt. Her burns, as well as those of Mr. Whitaker may prove fatal. Others injured were Mrs. C. B. Whitaker, a grandmother, and Tobias Pitt, 20, brother of Mrs. Whitaker.

The fire was believed to have started from a tank of oil in a shed which became ignited.

Liquor Explosion Fatal To Janitor

COLORADO, Tex., April 7.—Conroe Boyd, negro janitor, who was bled and died after several days when a quantity of confiscated alcohol exploded, died today.

Sheriff R. E. Gregory and deputies Bass and Rice, who also were burned, are recovering.

SHERIFF JOHNSTON IS UNWORRIED BY TWO DAMAGE SUITS FILED BY KIN OF BILL RICHARDSON, SLAIN IN ARREST

Although two civil damage suits, aggregating \$55,600, were filed against him and his bondsman, Sheriff John Johnston of Lubbock county, today said he was not worried by the suits.

Mrs. Richardson's suit asks \$15,000 actual damages, \$20,000 exemplary damages and the recovery of \$600, which her petition states was subtracted from a \$1,000 roll of bills which she claims was on her husband's person at the time of his death. Her petition alleges that the sheriff and his deputies, acting in their capacities as officers, "unlawfully, wilfully, wickedly and maliciously, and with formed design to kill and murder her husband" deprived her of her sole means of support.

DENVER TURNS ATTENTION TO LUBBOCK LINE

STEEL BEING LAID IN THIS DIRECTION; TO BE HERE MAY 5

Steel rails are again being laid in the direction of Lubbock by the track laying crews of the Fort Worth and Denver South Plains Railroad Construction workers, word from Faye Guthrie, secretary of the Lockney Chamber of Commerce Tuesday at noon stated.

The crews have been busy for the past several weeks laying the rails from Junction north of Lockney to Plainview. Prior to the work on the Plainview line, the crew completed the line from Estilene to Lockney. The crew will be working out of Lockney by the afternoon and then only 48 miles will be incomplete on the new rail line from Estilene to Lubbock, which will give the railroad "Hub" of the Plains, direct connection with Fort Worth, Dallas, Wichita Falls and other north Texas commercial centers.

Reach Here About May 5

The rails are expected to reach Lubbock about May 5, a statement made here recently by Frank E. Clarity, Fort Worth, vice president and general manager of the railroad.

The rails have already reached Turkey, Quitaque, under the cap rock and South Plains, Junction, Plainview and Lockney on the plains. Petersburg, a little city situated in the southeast corner of Hale county and heretofore buried in the center of a virgin agricultural territory but with no rail service and poor highway connections which the Denver rails, after Petersburg is reached, the construction train will have a 23 mile run to make to Lubbock.

Other Work Planned

Lines from Plainview to Dimmitt and from Junction to Silverton will be laid after Lubbock is reached. These two lines will do for Dimmitt and Silverton what the new line is to do for Petersburg as it will give rail service to rich territories that have heretofore been handicapped from lack of rail facilities coupled with poor highway connections.

Lockney has agreed to close several streets and alleys in accordance with a request from officials of the Denver, Guthrie states, and a site for a brick depot has been located. Construction on the depot is to start within a short time.

FLAPPER' WIFE OF MINISTER IS CAUSE OF FUSS

WOMAN ADMITS LOVE FOR LIFE AND SAYS SHE WON'T CHANGE

OAKLAND, Calif., April 10.—The fashionable Albany community Methodist Episcopal church congregation today was rent in twain as the result of a controversy over its minister's wife, Mrs. Thelma Gragg, 24, who admits she is a "flapper" and who is conceded to be "very pretty."

The minister, Rev. Ira T. Gragg, dramatically announced his resignation at the end of his sermon Sunday night. The Rev. Mr. Gragg is 29 years old and formerly held pastorates in Missouri. The Graggs have one child, Thelma, 6 years old.

Reads Card on Bouquet

During the evening services Mr. Gragg stopped to read a card accompanying a bouquet of roses given to him by the young people society of the church. The card read:

"In grateful remembrance for loving cooperation, and greetings from younger and drover minded members of the congregation."

The pastor's only comment then was that "you will have to forgive youth for its broadmindedness."

Speaking of the resignation, Mrs. Gragg said:

Refuses to Change

"They call me a flapper. Yes, I guess I am. I wear my skirts short and bob my hair and love life. I like to sing. I suppose that if I were an old tramp they (the conservatives of the congregation) like me better. But I am going to keep on being a flapper."

H. E. Leavess, director of the choir has quit as a result of the resignation and said several other singers would join him. Other members of the congregation also said they would quit.

Veteran Banker Is Victim Of Suicide

LOUISIANA, Mo., April 10.—Charles Wenkle, 60, for twenty years cashier of the Peoples Bank of Bowling Green, near here, committed suicide today by shooting himself while in his garage. The bank did not open, pending an investigation.

CHILD WELFARE CONFERENCE EXPECTED TO BE BEST EVER HELD; MANY WOMEN ATTEND

The buzz of feminine voices resounded from the First Methodist church this afternoon as activities in the fifth annual child welfare conference of the eighth district of the Texas Congress of Mothers and Parent-Teachers got under way in what is predicted to be the most colorful session of the association.

The conference is predicted the most colorful due to the fact that it will be the last time that the 150 associations, comprising the 42 counties of this district, will be in session together, as re-districting of the associations, allowing only 14 counties to the district to take place soon after the close of the conference.

Registration and assignment of homes for the 200 visiting delegates began shortly after one thirty and a two-thirty had just gained momentum. Visitors began to pour into the church from all the nearby towns and practically every association was in representation during the afternoon.

School of Instruction

Following the registration and assignment of homes, delegates and officers will be in the school of instruction with Mrs. A. F. Woods, of Athens, first vice-president in charge. District officers who are here to attend the conference include: Mrs. J. I. Kendrick, Amarillo, president; Mrs. T. H. Lawson, Wichita Falls, vice-president; Mrs. Josephine Young, Amarillo, recording secretary; Mrs. J. M. Crain, Claude, corresponding secretary; Mrs. Nine McComas, Plainview, treasurer; and Mrs. R. G. Cleming, Tulsa, historian.

Tonight the conference will be in session in full force, the various organizations of the city participating in the welcome of the visitors. The general theme of the meeting is to be "The Challenge of Childhood" with Mrs. E. W. Camp, president of the Lubbock council of Parents and Teachers, presiding. Mayor H. D. Charge Is Denied

DALLAS — George Butcher of Dallas, who was secretary of Dallas Klan No. 96 from 1922 through 1924, and who was an officer of the national organization until Sept. 1, 1925, when he resigned, denied today that the Dallas Klan participated in the burning of anyone during the time he was connected officially with the organization. Referring to testimony by Clarence W. Ludlow at Pittsburgh, that Ludlow had seen seven or eight men burned alive by Ku Klux Klansmen in Texas, Butcher said: "Such a thing most certainly did not happen when he was connected with the organization. Neither do I recall any instance where a white man was tarred, oiled, and burned at Terrell, Texas."

Negro Must Die

AUSTIN — The plea of Willie Fisher, a negro, for commutation of the death sentence given him for killing his wife in Harris county, was denied Tuesday by Governor Moody. He had been granted a reprieve. He originally was scheduled for the chair on March 23 and now will go just after midnight Wednesday.

Wheat Condition

WASHINGTON — The condition of the winter wheat crop on April 1, the department of agriculture announced today, was 68.8 percent of a normal, a decrease of 17.2 points from December 1, last.

Armour Head Dies

FORT WORTH, April 10.—W. C. Summers, 51, former general manager of the Armour and Company interests in Fort Worth, died Tuesday. He resigned as general manager on March 10 because of failing health.

Project Okehed

WASHINGTON.—The Port Aransas, Texas, harbor project, was adopted today by the house rivers and harbors committee. The project which provides for the dredging of a channel from the Gulf of Mexico to Harbor Island, carries an authorized expenditure of \$500,000 with \$230,000 yearly for maintenance.

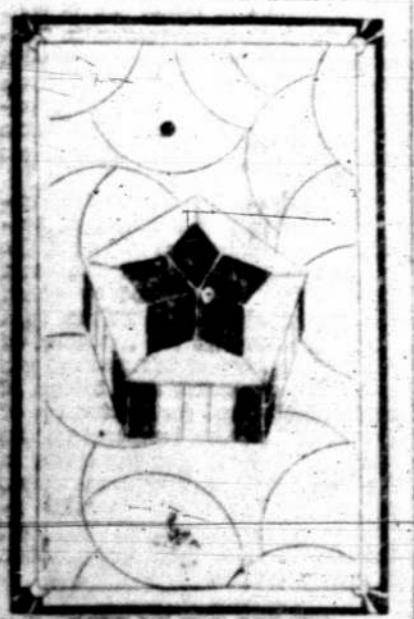

Summer Sportswear Takes To Prints



Here's how prints combine with plain fabrics to give summer sportswear distinction: brown polka dots, set off by brown stripes, creep at the cuffs, girdle and neck, fashion the intriguing suit at the left; the tier is of the new tweed silk combined with plain English red.

Polka dots stand first in popularity. And because of their variety in the realm of sports wear, polka dots take liberty with sizes and may be as big as a dollar or as small as a penny.

Next to polka dots for sports come the new tweed patterned silks. These, in colors, in appearance and in effect resemble the finest of imported tweeds, plus that luxurious something that silk has over and above all its other appeal.

Plain and Prints Continued
In the manner of fashioning these new printed sports things—the feminine style is the right one. But never, never on out-of-door things can fussiness be tolerated this spring. The sharply defined up-and-down of last season is not far enough back for furrows to have any favor at all.

It is still better to combine plain material with prints than to have either stand alone. And in the manner of combining we have the distinctive touches that this year's clothes can not live without.

Many sports costumes take top-coats or cardigans over their two-piece suits to form ensembles good for cooler days. These top coats may be real tweed in matching tones and designs. Or they may be the plain silk over the printed suit.

Back fullness is one thing some new skirts are featuring. All skirts are fuller. Many insist on belts. If so they usually put them near the normal waistline and, if they prefer a summer style, the normal waistline will be the only one that counts by the time July is here.

Two of the smartest sports suits in print make much use of the diagonal lines. And both make a point of the V-neck and emphasize it by the cut of the inserts in the jumper.

Newest in sports wear is a brown and string covered polka, dotted crepe suit combined with brown flat crepe. Its skirt is frankly gored a very new note. This gives a little more freedom and, does away with a banglesome hip-line.

Deep cuffs of brown add a novel note—similar to the long dark kid gloves of another era. Across the body of this suit the brown crepe runs in a diagonal edged banding and brown edges the V neck, running on down like a jabot right on the dress.

Tapering Diagonal Lines
With this goes an eye-shade pallid hat, a new shiny, rough straw that has the crispness and assurance of youth in its weave. This needs only a simple band of brown to be vastly chic. Its crown is deeper in front than back, giving a line not dissimilar to the points on the jumper banding.

On the other model shows the new tweed silk at its best—in a charming English red, that new, bright shade that women find so becoming. Here we have tapering diagonal lines giving the broad-shouldered effect that is sportive looking. A collar of tweed opens out, banded with red.

The skirt of red and beige tweed silk has tufts running up and down and inserts of stitched tufts running across. Very novel and quite full is this skirt when its tufts let out their fullness.

A feminine touch that is new is the sleeve with its puff of tweed silk gathered into a plain cuff of red.

With this jaunty sports suit goes one of the Rebois three-cornered ballcap hats of English red and a deep tan. This season is the first to sponsor the tricorne for almost a decade. Always becoming, it is no wonder women are finding them to their liking again.

Galli-Curi's Own Beauty Secrets

Opera Star Tells Her Charm Formulas

EDITOR'S NOTE: In this third article of her exclusive Journal series on beauty, Amelia Galli-Curi, Metropolitan Opera star, further describes her intimate methods of facial make-up.

By AMELITA GALLI-CURI
Only a proper blending of rouge paste on the foundation cream will secure a natural effect. Remember that nature blends face coloring gradually; the outer edge merges by almost imperceptible degrees into the general tone of the skin. Do this blending with a rabbit foot.

Last of all comes the face powder. In putting this on, a down puff is better than violent, but use lightly, or it will look like a mask. Deluging the nose with powder seems to me not only unnatural, but vulgar. Rachel powder or natural flesh color is best; no one's skin is pure white. For some lighter toned skins and for blonds I recommend lavender powder for evening. Rouge on the lips should not be greasy. I like a good bit of it for brunettes; it gives character. Blondes, however, should use rouge only in pastel shades on the lips.

For the daytime I never make up my hands. But in the evening application of liquid powder on hands, arms, neck and back for décolleté is necessary, otherwise, contrast with the pale shade of the evening dress and under artificial light would make one look black.

Eyebrows should be darkened with cosmetic, but I do not recommend plucking them, which to me appears ridiculous and artificial. Everything is best done in moderation, and following nature. For both brunettes and blonde eyelashes look well darkened with black cosmetic. Some trim their eyelashes to secure, though not always with success, a thicker growth, but until they do grow out again the result is awful.

My reason for keeping the hair that nature has given me is due to enlightening advice. To tell the truth, women are growing bald. And this "going, going" disaster has been brought on by bobbing the hair, as women neglect to brush it. It admits bobbed hair immensely for some faces, but I followed a plan of watchful waiting to see how it would turn out with others, having no ambition to wear my diamond tiara hand part.

BAD WEATHER BIG HINDRANCE IN FINAL WORK

WINNING ATTENDANCE UP GOAL OF TEAMS ON OPENING DAY

DALLAS, April 10.—With inclement weather hampering workouts, the curtain drops on the 1928 opening season, interest in Texas league circles has centered on open day activities tomorrow.
Managers are picking starting lineups, players are on edge for the getaway in the long pennant race, and fans are ready to turn in huge numbers to cop President Frank Roberts' attendance goal of 10,000 Wichita Falls goal.

When thousands is the attendance goal set at Wichita Falls where the Shreveport Sports. Twenty thousand is the mark of Dallas. Other cities plan equally big attendance figures. Chambers of commerce and other civic organizations have given services to get out the crowds.

It always has been understood that Sande was always out to win, because of the general knowledge that his mounts would be given to their last ounce of power. He had the largest following of any jockey on the American tracks.

Sorted to Tricks
His employers never have denied he generally believed story that Sande never was given instructions, but it is that he never was told that would be all right if he didn't in and when he appeared in the saddle on a good mount it was as good as gospel that his mount was going to try to win.

Sande is not the winning habit then he was making his greatest reputation with the horses in the anconas Stable. He always had a mount and he didn't have to resort to any tricks in win, but when he had the saddle later on races that were not quite so fleet

Darry Vance, the strikeout king, and Bob Grove the leading fanner of the American league, have seemed even faster than before this season and there is no reason to believe they have lost the cunning which enables them to send batsmen back to the bench for drinks of water.

All the holders of the miscellaneous records are back to defend their titles. George Sisler the base running monarch of the American league, has changed uniforms but this will not keep him from stealing any bases he finds lying around loose.

ROBERTS SAYS BRIBE GIVEN; COUNSEL FOR ACCUSED COUNTERS

WASHINGTON, April 10 (AP)—Government charges that Harry P. Sinclair had paid Albert B. Fall a total of \$250,000 as bribe for oil leases and the assertion that the defense would show this money was paid in legitimate business deals, today were laid before the jury trying Sinclair.

The trial got early under way today with Owen J. Roberts, for the government, painting a black picture of conspiracy between Sinclair and Fall and with a prolonged denunciation of the oil operator and the former secretary of the interior by Daniel Thew Wright of the Sinclair legal staff.

"Secrecy and Suspicion" Roberts said the \$250,000 in four payments to Fall were made under "circumstances of secrecy and suspicion" which the jury would be unable to ignore.

Wright drew a picture which took from Fall the responsibility for initiating the oil leases, declaring the possibility of damage, the question of national defense and other things had troubled Secretary Denby of the

navy and his staff, and had ultimately led to the leasing policy.

The navy itself had decided it was unwise to have public bids for the property, Wright said, and he quoted Assistant Secretary Theodore Roosevelt as having said the navy wanted the plans kept secret.

Contrasting views of the famous \$250,000 liberty bond deal between Fall and Sinclair were given by the opposing attorneys, Roberts, in a chronological exposition of what the government expected to prove, insisted that this transaction was made in a manner wholly inconsistent with good faith or with ordinary business dealings. He said no written memorandum was made; the bonds were brought to Washington by Sinclair in his private car, and that the ostensible purpose of the delivery was an alleged business transaction which had no basis in fact.

On the other hand, Wright said J. W. Zevoy, Sinclair's lawyer, at the time, knowing of Sinclair's ambition to have an interest in the Fall New Mexico ranch, told Fall Sinclair was in earnest in wanting to make such a deal.

"Everhart and Fall agreed," said the attorney, "that if anyone wanted one-third interest in the ranch, it would cost them \$225,000."

"When Fall returned to Washington, Zevoy completed the terms of the sale, Fall asking for liberty bonds, because of bank failures in Southern Texas," he said.

"Sinclair did not give them to Fall—but M. T. Everhart, Fall's son-in-law, himself met Sinclair and got \$198,000 in bonds."

He then told how Everhart collected the remainder in New York, took them to Pueblo to pay the ranch's debts, and sent the remainder of the bonds, \$99,000, to Fall in El Paso. But all of this, said Wright, finally went to pay ranch debts.

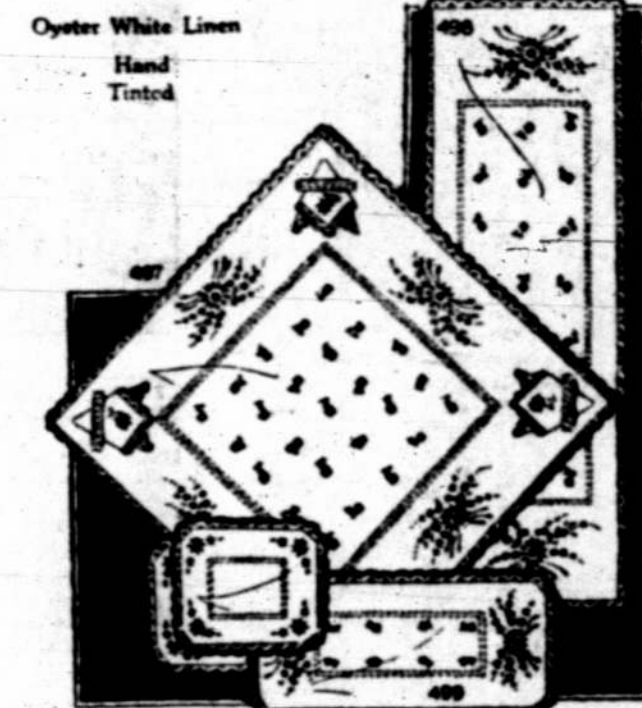

Richardson 'Nervous Wreck'

According to Richardson's petition, which is couched in legal terms and phrases, he alleges that the officers arrested him to put him "out of the way" while they carried out their plans to "unlawfully kill his father, W. H. Richardson." He charges that he was threatened with death by Deputy Ford at the time of his arrest, that he was placed in jail without an opportunity to call bondsmen and that Roberts owned both car and whiskey at the time of the arrest. Richardson further states that as a result of the unlawful arrest he was made to suffer great physical pain and mental anguish and inconvenience and that he "suffered a great nervous shock—his nervous system has been deranged and he has been ever since a nervous wreck."

'Politics,' Says Johnston

"PRESIDENTIAL CAMPAIGN PORTRAITS"

THE STORY OF JIM REED

Jim Reed Won His Fight Against League Pact, But Nearly Wrecked His Career In Doing It

EDITOR'S NOTE: This is the second of a series of articles on outstanding presidential candidates written for The Journal and NEA Service by Robert Talley. This article continues the story of Senator James A. Reed, which will be concluded tomorrow.

ASHINGTON, April 10. — For nearly a decade before his historic clash with Woodrow Wilson over the League of Nations in 1919, Jim Reed of Missouri had been a member of the U. S. Senate, but the country had heard comparatively little of him until then.

It was then that Reed's inherent ability as a fighter manifested itself to be met by that of Wilson, who was no less uncompromising. Reed won insofar as the league proposal was defeated in the Senate, but his battle made him tremendously unpopular with a large part of his party, climaxed by the refusal to allow him a seat at the Democratic national convention at San Francisco in 1920.

It has been said that the bitter opposition of Senator Lodge—the cultured, scholarly and sensitive leader of the anti-league Republicans—was bred of wounded vanity, following Wilson's failure to take him as a delegate to the Versailles peace conference. But no such considerations motivated Reed; a stern Andrew Jackson type Democrat, he was opposed to setting up any government that could be greater than our own.

After his first election to the Senate in 1910, Reed had fought for lower tariffs, championed the re-election of senators and helped unseat Senator Lorimer (Rep.) on charges of fraudulent election in 1912. He supported Wilson in the Mexican crisis of 1914, on the Adamson eight-hour law and stood with him on the bulk of pro-reform measures.

Reed voted for war and, as he afterward said, voted for "every war, every man every ship and every gun the president asked to try on the war."

Their first real clash came on the federal reserve act, which had been rushed through the House at Wilson's insistence. Reed, however, demanded hearings in the Senate and succeeded in making amendments to the bill before it was finally passed. Next, Reed voted for the Panama Canal toll bill, despite Wilson's pleas that he break again when Reed blocked Wilson's nomination of Thomas Jones to the Federal Reserve board, charging that Jones was allied with the "harvester trust."

Then future historians write the story of that widening breach and followed, they will probably find that both Reed and Wilson were equally sincere. They doubtless will explain that each had the right to hate bitterly, and that in the game of hating Wilson was the real of Reed.

In 1910, Wilson came back from Europe, riding on the crest of a wide-wave of popularity that men in history have enjoyed bringing with him his cherished League of Nations covenant for ratification by the Senate.

For a time it seemed inevitable that it would be accepted. Wilson's prestige seemed certain to carry it over. But there were a few U. S. senators who had their doubts about the matter of "setting up a government superior to our own." One of these was Jim Reed, a Democrat from the Andrew Jackson school. His criticism was of the flaming, thing, independent kind that came from the frontier. His opposition to the League of Nations was instinctive; he could not have been for it, had Wilson wooed him with all the honeyed words in the dictionary.

him speak before it, and throughout that state "Rid Us of Reed" clubs were formed. There were threats of physical violence more than once, but Reed was never molested. Maybe his iron courage explains why.

At a little town in the backhills of the Ozarks, Reed was warned that he might be shot if he made his speech, but Reed went. He spoke in the crude little town hall and after he had finished he looked at his audience in silence for a full minute and then said:

"I am going to walk down the middle aisle of this hall, and if anyone wants to shoot me, let him fire away. Then I'm going to my room in the hotel across the street. The door will be open and visitors will be welcome."

Coolly he walked down the aisle between the dark-faced mountaineers, coolly he crossed the street and went to his room, where, true to his promise, he left the door wide open. He was not molested.

Threats of physical violence were not the only dangers that Reed faced in those days, however. Woodrow Wilson, who could exorcise an enemy as sharply and skillfully as any man in history, turned all the fire of his eloquence on the Missouriian. Wilson's cry of "Mr. Plott!" is still remembered.

The League of Nations plan was beaten, as everybody now knows, and it seemed also that the political career of Jim Reed had been wrecked forever in the same crash.

The worst insult of all came when the Democrats barred Reed, a senator from their San Francisco convention in 1920.

Before Reed—in 1922—lay his race for re-election for another six-year term. A man less able might have given it up as hopeless and retired. Woodrow Wilson was no longer president, but the shadow of Wilson's bitter hatred for him still hung over Reed like a shadow from a tombstone.

But Jim Reed "came back." Despite Missouri's "Rid Us of Reed" clubs despite Wilson's appeal to the voters, he ran for re-election in 1922 and was returned by 43,000 majority. How he did it is another story.

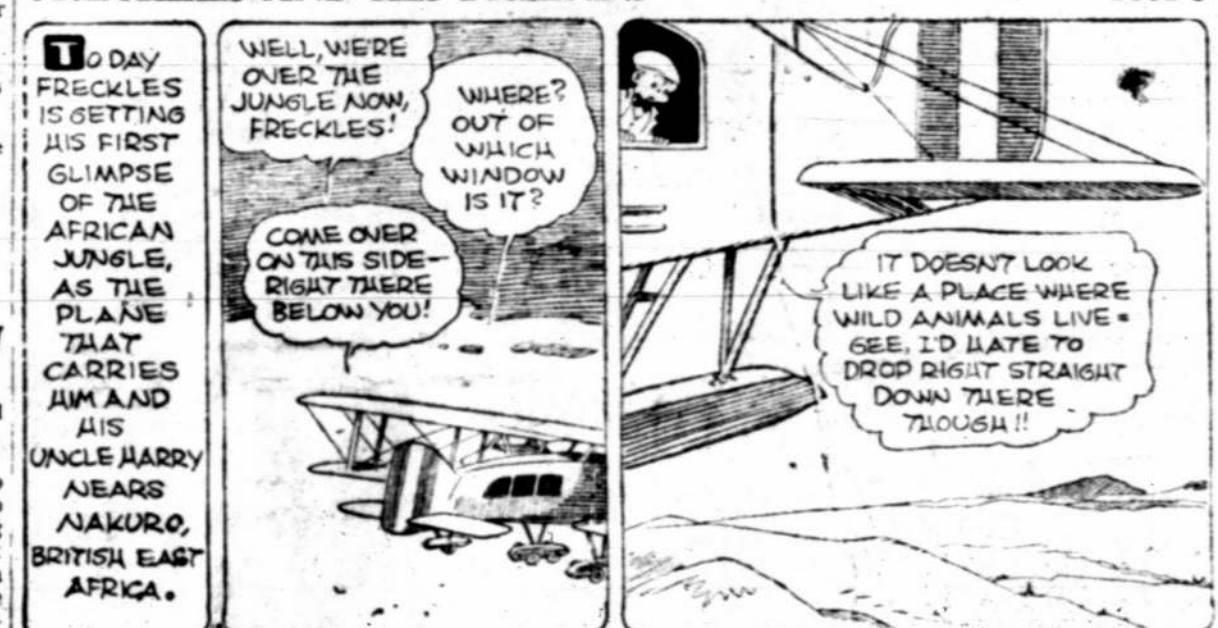

Appomattox

Sixty-three years ago yesterday
 a silver-haired, courtly gentleman
 in a gray uniform sat in a country
 courthouse at Appomattox, Va., fac-
 ing a grim-faced man in blue,
 and surrendered to him the gallant
 army with which, for four years,
 he had made history.

The surrender was complete. The
 soldiers were to lay down their
 arms and disband. All artillery
 and munitions were to be given
 up. The cause was lost forever. The
 letters "C. S. A." on the buttons of
 the gray-clad officer now mean
 only a memory and not an indepen-
 dent nation. When Robert E. Lee
 put his signature on the articles of
 surrender he knew that his de-
 feat was complete. Yesterday 63
 years after that surrender a gi-
 gantic stone figure was unveiled
 at Stone Mountain, Ga. It is a
 significant memorial to the man who
 was beaten, an heroic stone monu-
 ment to the defeated leader of a
 lost cause.

What is the meaning of this
 word "defeated" anyway? What
 do we mean when we say Lee was
 beaten? Why do we build a mem-
 orial to the man who surrendered
 to the federal government 63 years
 ago?

There are various kinds of de-
 feat. There is the kind William
 of Germany suffered, followed by
 ignominious flight over the border,
 and there is the kind that leaves
 the defeated man a hero. Lee's de-
 feat was of the latter kind. Ap-
 pomattox brought to an end his
 military career. But Lee himself
 was a kind of victor on that oc-
 casion. Appomattox did not dim his
 fame. It did not prevent the en-
 tire country, north and south, from
 enshrining him as a hero after-
 ward.

For true greatness can never be
 really beaten. And Lee was not
 only great in a military sense, he
 had that inward serenity and loquac-
 ity that set their possessor apart
 from ordinary men, and make him
 an influence for good long after he
 has passed on. Lee stands today
 with his fame far more secure
 than ever before, a constant inspi-
 ration to the men of his country.

We cannot do without our heroes.
 We must have our tradition of great
 men. Lee takes his place on Amer-
 ica's roll of honor, we feel that
 we are better men and a better
 country because he lived. The
 Stone Mountain memorial is, in a
 way, our public avowal of that fact.

Lee was beaten on the field of
 war. Yet he was a victor in the
 broader, deeper sense. Life could
 not overcome him. He faced it
 squarely and bravely, and came out
 forever triumphant, leaving a name
 like a blazing star to shine down
 the path of his history.

Mad Market

WASHINGTON, April 10.—Tam-
 many Hall, long viewed with alarm,
 often called a "menace to Ameri-
 can politics," Tammany Hall in-
 vestigated, looked into, dreaded,
 feared, made the subject of many a
 political sermon, isn't so bad after
 all, it seems.

Tammany Hall shunned in the
 past in presidential talk, spoken of
 in whispers at convention time, now
 has a rival; it seems, for the black
 sheep role. And recent chapters in
 the Teapot Dome oil scandal have
 tended to strengthen the hand of
 the leading Democratic candidate
 a gentleman named Smith.

The Republicans, having been
 linked up with Sinclair's oil bonds
 through confessions of Will Hays
 and others, will not be in such a
 good position this year to lambast
 Smith for the comparatively mild
 form of graft practiced by the mod-
 ern Tammany.

The Tammany bogey isn't what it
 used to be. Tammany has clean-
 ed itself up with considerable help
 from Al Smith. It may not give
 off an odor of altar of roses, but it
 looks like a wellkept marble swim-
 mingpool alongside a couple of
 open sewers when compared with
 the political machines of Philadel-
 phia and Chicago.

Numerous attempts have been
 made to connect Smith with graft,
 vice, corruption and what-not, but
 every charge has bounced right
 back. Young Mr. Roosevelt at-
 tacked Smith with the charge of
 permitting open vice in Albany.
 Smith's response to that charge
 made the young man the laughing
 stock of politics even among the
 leaders in his own party.

Senator Robinson of Indiana ap-
 parently hadn't heard about what
 happened to people who attacked
 Smith with their guard down. Rob-
 inson's charge that Sinclair was a
 heavy angel in Smith's campaigns
 in New York was not only shown
 to be unfounded but it was demon-
 strated that Sinclair really had con-
 tributed to aid Smith's opponent.

Perhaps Al Smith has been
 lucky. No man in the Senate was
 less fitted to attack the New York
 governor than Robinson, the so-
 called Klan senator, whose state
 machine in Indiana has broken all
 records for queer business.

In the exchange of pleasantries
 between Smith and Senator Nye,
 chairman of the Public Land Com-
 mittee, further gained any great
 honors, although Smith appar-
 ently vindicated his integrity.

Nye had told the Senate in re-
 sponse to Robinson's query that
 "he understood" Sinclair had con-
 tributed heavily to a Smith cam-
 paign. Later he had to admit that
 his only information was a
 letter from a man unnamed New York
 Republican.

Nye gets no credit for making
 the charge against Smith, under
 the circumstances. On the other
 hand, Smith's violent letter, ac-
 cusing Nye along with Robinson of
 partisanship and demagoguery,
 wasn't indicative of good judgment.
 Apparently he assumed that the in-
 surgent Nye was the same sort of
 a Republican as Robinson, where-
 as Nye's work in exposing the oil
 financing in his own party will be
 a big help to Smith in case he is
 nominated.

THE FUNDAMENTAL ISSUE

Eight years ago this summer a
 presidential candidate was hand-
 picked by a small group of politi-
 cians; the candidate was rather a
 colorless character, affable and a
 "good mixer." But he wasn't of
 presidential timber.

His election ushered in one of
 the most appalling periods of mis-
 government the United States has
 ever known. Even today the na-
 tion has learned but a part of the
 story. Constantly new facts are
 brought forth to amaze us by their
 sheer rottenness. A former cabinet
 member, shaken from his position,
 tells enough to cause a people to
 shudder. Investigations dredge up
 deeds of "misrule"; the nation's
 wealth is bartered, confidence in
 the integrity of the government at
 Washington trembles.

But the story is not entirely told.
 For five years now we have wit-
 nessed the eruption of official mis-
 deed. The worst, surely must be
 over. But facing the grave, the
 cabinet member tells other facts.
 How men high in the councils of his
 party, his republican party, advised
 him to make every attempt to con-
 ceal what he had done; test public
 trust be destroyed.

From a southern state comes a
 story told by one who wants to
 step into the great beyond, of "con-
 tributions" extorted in return for
 continued patronage. Believe it?
 It is no more terrible, in all its
 stark ugliness, than other charges
 which have been vindicated.

Eight years now the nation has
 watched this sorry trek of sorry
 facts. It has forgiven much, over-
 looked much. The time may be
 not so far distant when the people
 will rise in their wrath and de-

POLITICAL POT BOILS ANEW IN THREE STATES

SITUATION IS CLARIFIED
BY TWO STATES AND
TWO PROVINCES

(By Associated Press)
WASHINGTON, April 10.—Presidential politics advanced another big stride today with clarification of additional convention delegate rankings in two states and as many regular possessions, in which Hoover and Smith figured, and the bringing up to the front line of battle of more oral artillery for Walsh. By nightfall, three more states—Illinois, Nebraska, and Oklahoma—were to know how they stood, at least partially, for nominees at Kansas City and Houston.

Hoover Now In Lead
Hoover, now ahead in the race for Republican presidential nomination, today could lay claim to perhaps 17 more convention delegates as a result of party conventions and other activity yesterday. Rhode Island's state meeting recommended the commerce secretary to its 13 delegates, the territorial convention at Hawaii instructed its two for delegates and reports from Manila indicated the two Philippine delegates, when as uninstructed last February, now favored Hoover in event President Coolidge was not drafted. Smith, leading in the Democratic race for delegates, apparently was only one of the dozen or more presidential aspirants to pick up support yesterday. The Utah state convention selected 16 delegates, each with a half vote, without expressing a choice, although backers of the New York governor claimed all eight votes could be for their candidate.

Walsh Gets Tribute
Other Monday political developments brought a lengthy tribute to Walsh. Montana's entry in the Democratic convention, by William G. McAdoo, who engaged the memorable deadlock with the state for the 1924 nomination and heads the slate of Walsh delegates in California, and a decision by the Hoover forces to resume campaigning in Ohio where a fight has been in abeyance since the death of his April 24 primary opponent, Senator Willis McAdoo, a son-in-law of the late president Wilson, in a letter to B. Elliott of Los Angeles, and of Walsh's lieutenants in California, described the Montana senator as "one of the strongest supporters of President Wilson's administration," and said "there is no greater in public life today whose achievements entitle him to great honors at the hands of his people."

Two to Make Campaign
Representative Burton, veteran member of the house from Cleveland, and Representative Free, who represents Hoover's home district in California, are to take up the fight again for the cabinet officer before the primary two hence. Burton, neck and neck with Smith in the pre-convention struggle, looked to Illinois today to put out in front again in the delegate contest. The former Illinois governor was the only Republican named in that state's primary today, and his managers expected to get at least 30 of the 50 district delegates. Eleven delegates at large will be selected later. Smith's supporters had claimed that, if not all of the 50 Democratic district delegates voted on in Illinois today, and also the eight

delegates at large to be chosen later.

Favorite Son In Nebraska
In Nebraska, former Senator Hitchcock was entered in the Democratic primary and was conceded the "favorite son" support of the state's 16 delegates. There were two delegate states in the Republican primary, one pledged to Senator Norris with Lowden as second choice.

Democrats looked with interest today to the place convention in Oklahoma, where Smith adherents have claimed here 20 delegates for the doubtful column. Considerable activity had been seen there however, in behalf of Senator Reed, whose nearby home state of Missouri is back of him with 36 delegates.

SINGER GIVES HER ESTATE TO WAR VETERANS

BEAUTIFUL HOME AT
SAN DIEGO DONATED
TO "HER BOYS"

(By Associated Press)
MINNEAPOLIS, Minn., April 10.—Madame Ernestine Schumann-Heink, famous singer, announced last night she had given her estate at Grossmuntz, 14 miles from San Diego, Calif., to "her boys"—disabled war veterans of the World War.

"Mother Schumann," as "her boys" called her, was the guest of honor of local disabled veterans at a "ham and cabbage dinner," her favorite "dish," she said.

The noted singer announced that she had deeded the \$230,000 estate to Mayor George E. Leach of Minneapolis, to be administered as a haven for sick and disabled veterans and their families.

Gave Home to Show Love
She gave the home, she said, to show her love for the "boys," who played "lapse" for her two sons who lost their lives in the World War, one fighting for Germany and the other for America.

"You have honored me by calling me 'mother,'" she said. "You honored me by honoring my boy who died on a submarine. He may have

killed some American boys with his submarine, but he could not help that. It was war, you know. But you honored him. That is why I give you Grossmuntz. I love you; that is why I do this. I will love you until the Great Commander calls me."

Home Overlooks Beautiful Valley

SAN DIEGO, Calif., April 10 (AP).—The Grossmuntz home which Mme. Ernestine Schumann-Heink has given to disabled war veterans occupies one of the most beautiful sites in San Diego county. It comprises two acres and is high above the beautiful El Cajon valley. The home, which was built about eight years ago, is a rambling one-story hacienda type of 14 rooms. From its shady verandas can be seen the San Bernardino mountains, the Cuyamaca peaks, the mountains of Old Mexico and the Pacific ocean beyond the city of San Diego. An artistic concrete wall, topped with tile of old mission design, surrounds the property, enclosing one of the most interesting of southern California's semi-tropical gardens. Some of the finest palms and fruit trees in the country are growing in the gardens.

CHICAGO GOES TO POLLS FOR STORMY JOUST

ENTIRE STATE VOTES BUT CITY HOLDING BIG INTEREST

(By Associated Press)
CHICAGO, April 10.—Bombs, bullets, days of prayer, crime, Klan talk, and "America first" were ground into little x's today to provide Chicago's answer to one of her bristling primary campaigns.

Throughout the state the voting was going on, republicans and democrats nominating their choices for state offices, for congress, for United States senator and for minor offices, but only Chicago felt the pressure to assign a large part of its police power to poll protection; to have scores of detective bureaus cruising through precincts where trouble might brew; and to assign thousands of volunteer civilians, deputized for the day by the election commission, to protect against fraud.

Small at Armageddon
For Governor Len Small today was a political armageddon, for he stood before the republicans of the state asking their endorsement of his seven years' term by renomination to a third term. In Chicago his lot was cast with republican faction led by Mayor Thompson and State's Attorney Crowe.

Louis L. Emmerson, secretary of state, was Governor Small's opponent. He headed the ticket of the republican group led by United States Senator Charles S. Deneen, the bombing of whose home a fortnight ago tore the sides out of the Chicago political situation.

A novelty in the fighting of fraud was introduced with the equipping of several hundred volunteer voting places watchers with cameras. Pictures were to be taken of all persons whom the watch believed might be a repeater. The films were to be promptly developed and prints made, providing a refutable evidence of repeating, provided the films showed the same voter entering voting places in different precincts.

One Man Kidnaped
Taylor, a republican precinct captain in the 5th ward, was kidnaped by six armed men from in front of a polling place just before the polls opened. Police were told the kidnapers, armed with shotguns and pistols, beat him over the head and forced him into an automobile.

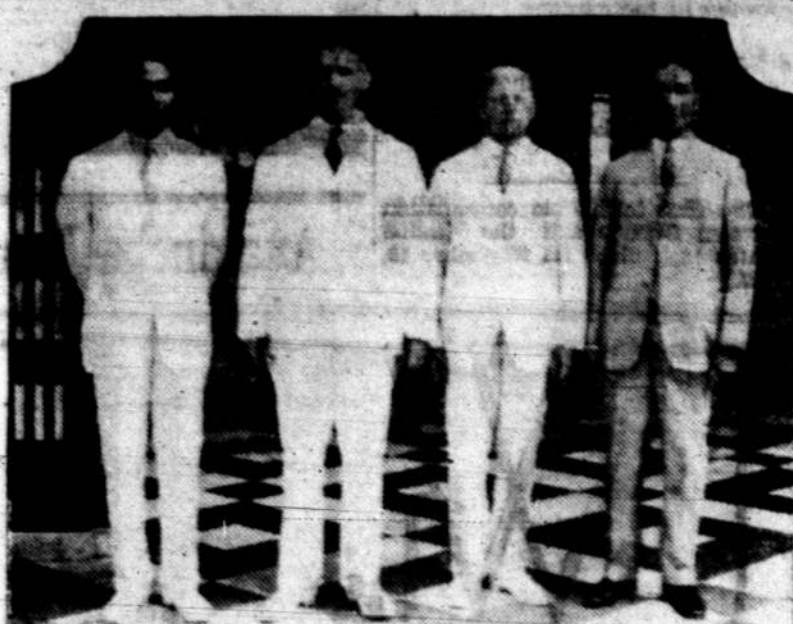

CANADA'S RECORD WATERS REDEED AFTER 6 DROWN

(By Associated Press.)
MONTREAL, April 10.—Flood waters, which had taken six lives and caused large property damage in the provinces of Quebec, Ontario and New Brunswick were receding today as cold weather settled down, checking seasonal melting of ice and snow.

Some suburbs of Montreal were still under water, caused by a huge ice jam in the St. Lawrence river which caused it to back up and spread out over the lowlands, but conditions were improving.

A mother and her infant son were drowned in the swollen waters of a creek near North Bay, Ont., at the height of a blizzard as the husband rescued another son and vainly attempted to save them.

The bodies of two trainmen of the Canadian National railway express which plunged through a flood weakened bridge at Drummondville, Que., have been recovered.

Two other men were drowned when their wagon was swept off a bridge near St. Lambert, Que.

KLAN HEAD IN GOTHAM VIEWS SMITH CHANCE

**GOVERNOR IS BLAMED
FOR DISSENSION IN
RANKS OF ORDER**

(By Associated Press.)
NEW YORK, April 10.—The New York Herald Tribune today says that Dr. Hiram Wesley Evans, imperial wizard of the Ku Klux Klan, is in New York city looking over the political situation, especially in reference to the presidential candidacy of Governor Smith.

The newspaper quotes the Klan leader as blaming the forces of Governor Smith for internal dissension in the Klan such as has led to court action in Pittsburgh.

"Why for two years, brother," Dr. Evans is quoted as saying, "wherever a disgruntled klan member could be found there has been money available for him to stir up what trouble he could. And the directions for spending it all have been post-

marked 'New York.' It is perfectly plain that fear of the Klan's opposition has led the Smith machine to try to disrupt us before this 1928 campaign should come along. That is what is behind this Pennsylvania trouble. They tried to mess with my machine down there but I just took a few little steps, moved a man here and there, and now we're stronger than ever. Wait and see."

Prevented '24 Nomination
The imperial wizard asserted the Klan prevented the nomination of Governor Smith in 1924 but said the New York governor had a good chance this year of being nominated but would fail of election to the presidency.

He refused to "dignify" with comment the Pittsburgh trial in which affidavits taken charge him with murder, swindling, assault, kidnapping, lynchings, inciting to riots and other lesser crimes.

Detective Offers Other Testimony

PITTSBURGH, Pa., April 10 (AP).—A private detective known to the Pennsylvania members of the Ku Klux Klan as "G-2" said he had additional testimony regarding Klan outrages to lay before Federal Judge W. H. S. Thomson today.

The detective, Roy G. Barclay, former investigator for the Klan, told the judge at the first day's

hearing that he had notes giving dates and places which he would bring to court to back up his testimony.

Would Halt Initiations
He is testifying in the suit of the Klan to restrain present officers and banished members of the Pennsylvania organization from holding initiations and collecting fees and a cross suit by those members asking a receivership for the Klan.

Barclay yesterday testified that Dr. Hiram W. Evans, imperial wizard of the Klan, instigated the riots at Carnegie in 1923 in which one man was killed and several others seriously injured. Dr. Evans ordered his followers into the fray but himself remained on a hill safe from harm.

Membership Lists
Barclay said the membership list included University of Pittsburgh students, big business and professional men and one klavern of rough and ready fighters who were used in the same way shock troops and "moppers up" were during the war. In the latter category he placed the homestead Klan, which he said was relied upon by Grand Dragon Sam D. Rich to be present where trouble was expected. Barclay testified Evans sponsored atrocities as "publicity stunts" for the Klan.

On April 9, 1921, "Uncle Joe" Hess conceived the idea of forming a local building and loan association and with his \$9.01, he formed a company and incorporated with the following men interested in the organization: Roscoe Wilson, J. O. Jones, president, W. E. Atkins, J. A. Rix, Sam Arnett, first vice-president, Dr. J. T. Hutchinson, George W. Briggs and H. W. Stanton. On September 26, 1924, J. A. Raley, Jr., joined the group as treasurer.

In connection with their seventh anniversary celebration, officials have announced a reduction in interest rate to all borrowers of one per cent, applicable on both old and new loans.

Parents Of Youth Given Hero Award

Paying tribute to the heroism of their son, a gold Heroism Medal has been awarded to Mr. and Mrs. O. C. Lawrence, of Jayton, parents of William Earl Lawrence, Lone Scout, who lost his life in saving Harold Wade from drowning in May, 1925, a notice received today with the medal by Scout Executive W. P. Knox, stated. The medal is being given by the National Court of Honor of the Boy Scouts.

Mr. Knox plans to make the presentation of the medal to the parents in the near future among proper ceremonies of the scouts. He presented a letter of commendation to the parents of the boys in January of this year and then made application to the court for the medal.

Property Rendition For Texas Is Urged

"Render or go on the unknown list." That is the edict issued today by Rollie C. Burns, county tax assessor, who is completing all assessment work during the coming few weeks. The books of the county tax list will be closed on May 1, Mr. Burns said, and all property not rendered with him before that time will go on the unknown list at the same assessment as last year.

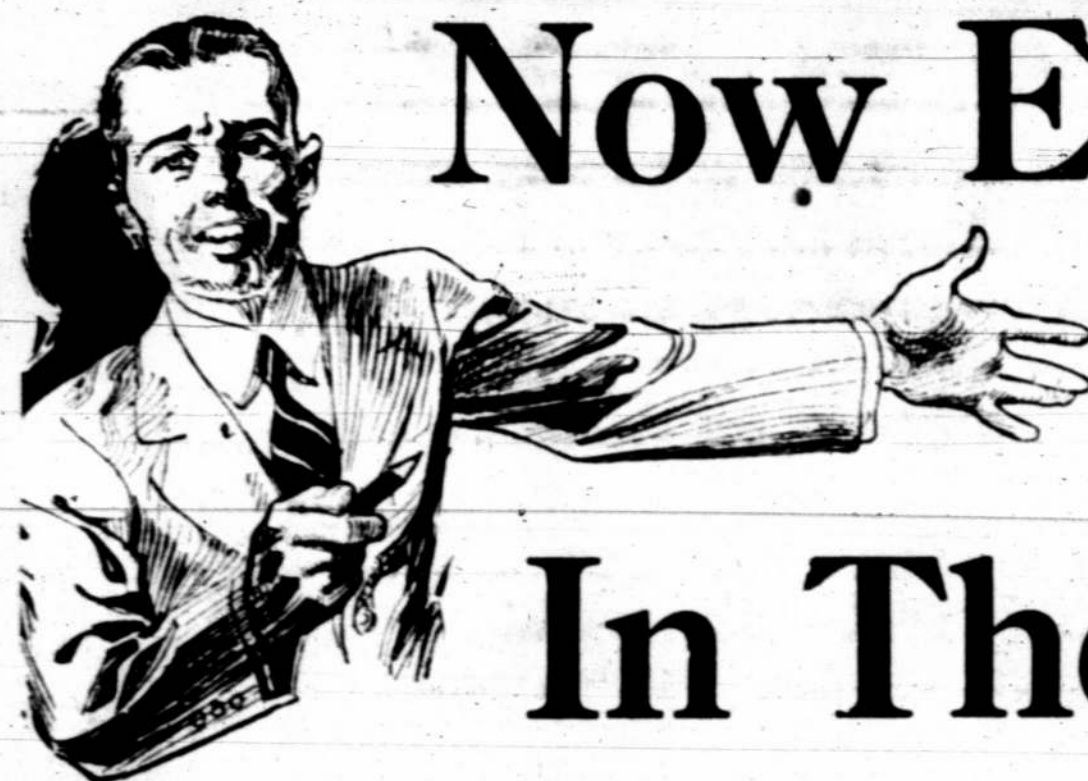
Texas Pioneer Is To Be Buried Today
