COLD CHECK OFFENSE BRINGS 2 YEARS IN JAIL

Same Length of Sentence Is Assessed on Robbery Charges

Several sentences of two years in the penitentiary were handed out this week in district court, which is in session at Olton.

W. E. Houser, arrested in Littlefield last November, faced three worthless check charges. He entered a plea of guilty on one of the charges. The other charges were dismissed, and he was sentenced to two years in the penitentiary. Houser, who was in this section picking cotton, told the authorities that he came from Oklahoma.

Three men, arrested in connection with the attempted robbery of the Amherst Drug Store, were each sentenced to two years in the penitentiary. They gave their names as Wesley Franklin, Clyde Mears, and W. T. "Talbert" Neugent, and said that Amarillo was their home town.

A Littlefield man, one of a pair who were arrested in connection with the entering of a box car on the Santa Fe tracks, was sentenced to two years in the penitentiary.

A hung jury developed in the Barton kidnaping case, and, as a result, the case will again be tried at the next term of court.

Pneumonia Fatal To Three Months Old Littlefield Baby

Rabb Harrison, Jr., three months old son of Mr. and Mrs. T. B. Harrison, died Sunday evening at ten o'clock at the West Texas Hospital, where he was taken Saturday, following an illness of about a week. Whooping cough, which developed into pneumonia the day before, caused the baby's death.

The body left Littlefield on the 12:40 train Monday for Beaumont, where burial took place Tuesday.

The deceased, besides his parents, leaves surviving, a sister three and one-half years old.

NO LIENS AGAINST CITY HALL

Because of false reports spread concerning the payment of the cost of building the Littlefield City Hall, the following documents have been executed by the City Secretary and Treasurer W. G. Street, Mayor T. S. Sales, and Commissioners Homer Hall and Pat Boone:

THE STATE OF TEXAS
THE COUNTY OF LAMB
THE CITY OF LITTLEFIELD

I, W. G. Street, Secretary and Treasurer of the City of Littlefield, Texas, do hereby certify that there are no liens of any sort, kind or description against the City Hall in said City of Littlefield, leased to Lamb County for Court House purposes. And that the \$50,000 of bonds issued by the City to build the said City Hall are due by the municipality as a whole and are not against the City Hall itself.

I further certify that all interest on said City Hall bonds has been paid to January 15, 1932, and that the first of said City Hall bonds does not mature until January 15, 1943. I further certify that the said City of Littlefield has paid all its interest and maturing bonds up to this date.

The records disclosing the above facts are open to investigation by any interested citizen of Lamb County, and any statements made to the contrary

CITY PURCHASES NEW EQUIPMENT FOR NORTH WELL

MORE FIRE PROTECTION FOR TOURIST CAMPS ARRANGED

Existing equipment at the north well, part of the city's waterworks system, will be replaced, according to an announcement Wednesday by City Commissioner Homer Hall.

Mr. Hall said that a gasoline engine will replace the present electrical equipment, and that the city had purchased the engine, a pump jack and casing.

The commissioner also announced a new fire plug will be installed at the intersection of East Sixth street and Highway No. 7, particularly to give additional fire protection to the tourist camps in that section.

The city is replacing a sewer line, which serves Spinks Cafeteria, the old line having had a tendency to break frequently on account of being located too close to the surface.

Mr. Hall said that all the above work was being carried out in line with the present administration's policy of paying cash for everything and assuming no indebtedness.

A survey of the city's finances has just been completed, and will soon be in shape for issuance to the public.

ORDER FOR COUNTY SEAT ELECTION

STATE OF TEXAS COUNTY OF LAMB.

WHEREAS, on the 8th day of February, A. D. 1932, a petition was presented to me, as County Judge of Lamb County, Texas, by O. H. Reeves and six hundred and eighty-four others, stating that it is desirable to remove the county seat of Lamb County, Texas, from Olton, Texas, to Littlefield, Texas, of which there are more than two hundred (200) legal and qualified voters and holders of Lamb County, Texas, residing in said county; praying that an election be held in Lamb County, Texas, at the various voting precincts said county for the purpose of submitting to a vote of the people of Lamb County, Texas, the question of whether or not the county seat of Lamb County, Texas, shall be removed from Olton, Texas, to Littlefield, Texas; and

appearing that said petition bears requisite number of qualified voters and freeholders who are residents said county, and is in every respect in conformity to law:

HEREFORE, I Simon D. Hay, in capacity as County Judge of Lamb County, Texas, do hereby grant said petition and do hereby order an election be held in the various voting precincts of Lamb County, Texas, on Saturday, the 19th day of March, A. D. 1932, for the purpose of determining whether or not the county seat of Lamb County, Texas, shall be removed from Olton, Texas, to Littlefield, Texas.

That said election shall be held in Precinct No. One (1) in the courthouse of Lamb County, Texas; Marshall Covett, A. S. Erb, H. C. Cone and H. E. Ogletree are hereby appointed judges of said election said precinct.

In voting Precinct No. Two (2) the election shall be held at school house; and J. P. Kelley, Jack Henson, E. Whitford and R. L. Drake are hereby appointed judges of said election in said precinct.

In voting Precinct No. Three (3) said election shall be held at Community Church; and G. M. Vann, O. Young, M. L. Green and Jack Clark are hereby appointed judges of said election in said precinct.

In voting Precinct No. Four (4) the election shall be held at the City Hall and Chas. Harless, R. E. McMill, James Ware and Arthur Morgan are hereby appointed judges of said election in said precinct.

In voting Precinct No. Five (5) the election shall be held at School house and C. C. Preston, Ed Lowe, Marshall Low and Joe Foster are hereby appointed judges of said election in said precinct.

In voting Precinct No. Six (6) the election shall be held at School house and W. A. Stevens, J. R. ... are hereby appointed judges of said election in said precinct.

In voting Precinct No. Seven (7) said election shall be held at City Hall; and J. M. Carruth, Joe Covington, Joe West and A. J. McCarty are hereby appointed judges of said election in said precinct.

In voting Precinct No. Eight (8) said election shall be held at school house; and E. T. Phillips, L. D. ... are hereby appointed judges of said election in said precinct.

In voting Precinct No. Nine (9) said election shall be held at school house; and Millard Phillips, O. ... are hereby appointed judges of said election in said precinct.

In voting Precinct No. Ten (10) said election shall be held at Community Building; and Morton ... are hereby appointed judges of said election in said precinct.

In voting Precinct No. Eleven (11) said election shall be held at ... residence; and J. B. Blessing, A. H. Scivally are hereby appointed judges of said election in said precinct.

In voting Precinct No. Twelve said election shall be held at ... and J. W. Jones, Jim ... Roy Hutson and Bert ... are hereby appointed judges of said election in said precinct.

In voting Precinct No. Thirteen said election shall be held at ... residence; and M. J. ... C. Chisholm are hereby appointed judges of said election in said precinct.

In voting Precinct No. Fourteen said election shall be held at ... and W. O. Hendrix, E. ... are hereby appointed judges of said election in said precinct.

In voting Precinct No. Fifteen (15) said election shall be held at ...

Community Building; and J. W. Dent, and H. M. Packard are hereby appointed judges of said election in said precinct.

The said election shall be held under the provisions of Chapter Five (5), Title Thirty-three (33), Revised Statutes of Texas, 1925, and the Constitution and Laws of the State of Texas; and shall be conducted as near as may be in accordance with the general election laws of the State of Texas; and all persons who are qualified voters under the Constitution and Laws of the State of Texas shall be entitled to vote at said election.

Should the voter be in favor of removing the county seat from Olton, Texas, to Littlefield, Texas, he or she shall write or cause to be written or printed on his or her ticket: "For Removal to Littlefield, Texas"; or should the voter be in favor of the county seat remaining at Olton, Texas, he or she shall write or cause to be written or printed on his or her ticket: "For Remaining at Olton, Texas."

A copy of this order signed by the County Judge of Lamb County, Texas, and certified to by the County Clerk of said county shall serve as proper notice of said election. And thirty (30) days notice of the time and places of holding said election shall be given by posting true and correct copies of this order in three (3) public places within each voting precinct in said county, and by publication thereof in the English Language in four (4) weekly issues of a newspaper of general circulation which has been regularly and continuously published for at least one (1) year previous to the date of this order in Lamb County, Texas, and the date of first publication of said notice shall be thirty (30) full days prior to the date of election.

It is further ordered that this order shall be spread and recorded upon the Minutes of the Commissioners' Court of Lamb County, Texas.

THE STATE OF TEXAS COUNTY OF LAMB WHEREAS, on the 8th day of February, A. D. 1932, a petition was presented to me as County Judge of Lamb County, Texas, by O. H. Reeves and six hundred eight-four (684) others, stating it is desirable to remove the county seat of Lamb County, Texas, from Olton, Texas, to Littlefield, Texas; and,

WHEREAS, on the 8th day of February, A. D., 1932, I, as County Judge of Lamb County, Texas, in conformity to said order, did order an election as prayed for in said petition; and,

WHEREAS, afterwards on the same day, being the 8th day of February, A. D., 1932, a petition was presented to me as County Judge of Lamb County, Texas, which petition was signed by W. F. Rowland and two hundred sixty-nine (269) others, requesting that I call an election for the purpose of removing the county seat from its present location in the town of Olton, Lamb County, Texas, to some other point in said county, and that, in the event I complied therewith, I place the name of the town of Amherst upon the ballot to be used in said election.

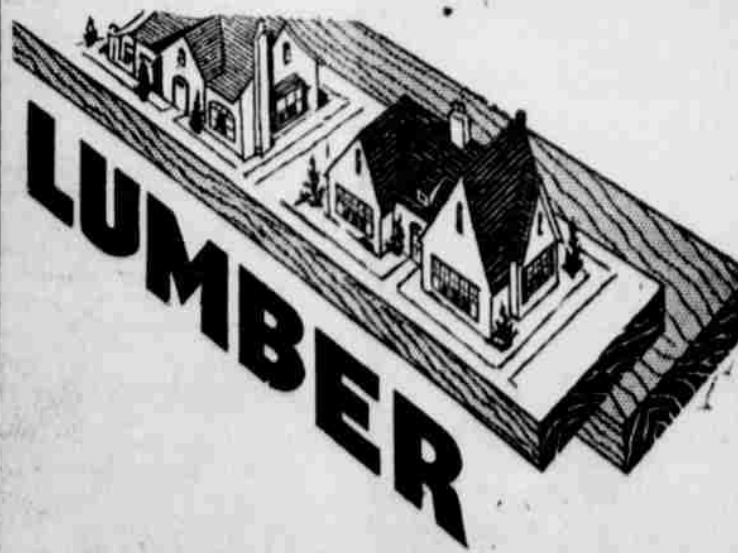

ATTITUDE OF THE COUNTY COMMISSIONERS

How the Commissioners' Court stands in the matter of issuing warrants or bonds for the building of a Court House or Jail, without the people first approving such action by a majority vote, is set out in a document which has been signed by the members of the court. This document reads as follows:

THE STATE OF TEXAS COUNTY OF LAMB We, the undersigned members of the Commissioners' Court of Lamb County, Texas, do hereby state to the citizens of Lamb County that we will not issue any warrants or bonds for the purpose of building either a Court House or a Jail in Lamb County, unless the question shall have first been submitted to a vote of the people, and a majority voting at such election shall have voted in favor of the issuance of such warrants or bonds. SIMON D. HAY, County Judge. C. A. DANIEL, Commissioner Precinct No. 2. C. E. STRAWN, Commissioner Precinct No. 3. E. J. FOUST, Commissioner Precinct No. 4.

Loyal support of the proposal that the county seat be moved to Littlefield is being given by a large percentage of the voters of Sudan and Matric. The Sudan News, in an editorial in last week's issue, said in part: In a question as important as the removal of a county seat, it is the voters sacred duty to investigate thoroughly before casting his or her vote. We have made it a practice to nose around and get the facts in cases like this and have not failed to look the situation over this time. "We find many, many more reasons in favor of its removal to Littlefield than were given in last week's News, and find that after another trip over the field that we could have used our entire first page to set out the good reasons for locating the county seat at Littlefield. "The entire citizenship of Littlefield invites you to visit the commodious City Hall and modern jail that they (Littlefield) are offering FREE to the county for Court House purposes for a term of ten years. This building is

fireproof throughout. "As we see it, if the county seat is moved to Littlefield on March 19th, 1932, it will save the taxpayers of Lamb county from \$100,000 to \$200,000 in the ten year period. Get your pencil and paper out and do some figuring and if we are wrong come in and tell us."

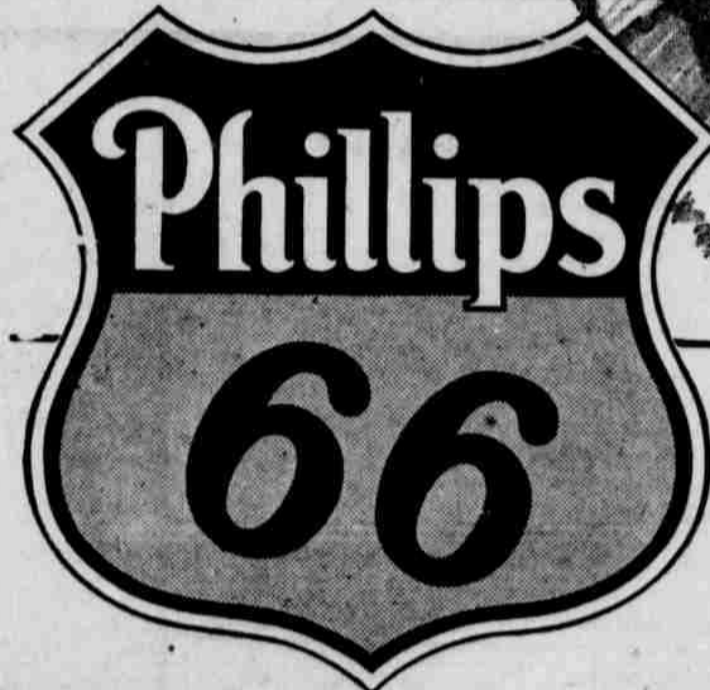

GARNER FOR PRESIDENT

John Garner's chances for the Democratic nomination for the Presidency received quite a boost last week when Senators Sheppard and Connally announced that they were for the sage of Uvalde. But their support was expected. Perhaps the greatest boost that Garner has yet received came Friday from Los Angeles, California, when William Gibbs McAdoo announced in favor of Garner. McAdoo filled several positions with distinction during the Wilson administration and was a strong contender for the nomination himself in 1924. If there is a man in this country better equipped for the Presidency than Garner, that man is McAdoo. His support will swing hundreds of thousands of voters in this country into the Garner procession.—Lynn County News.

The Lynn County News also says:

One reason why we want to see John Garner nominated for the Presidency is that we want the country to find out that Presidential timber grows in other parts of the country than New York, Massachusetts and Ohio.

TAXATION

Taxpayers over the state are organizing, as they have a right, and should do. The main difficulty is that the movement of a great extent is like that of putting a lock on the barn after the horse has been stolen. A large per cent of our high taxes are the result of interest and sinking fund for the various bond issues which were voted in good times to make public improvements. There can be no default in payment of these as the property of the state must stand good for this indebtedness. Of course to have opposed these bond issues when they were voted would have branded one as an old foggy, and back number. Facts are facts, however, and as the matter now stands, we are paying off these bonds at about the rate of two for one in value of money compared to the time when they were voted. Taxpayer organizations will, however, do a lot of good. Leading citizens will scrutinize a little more closely their candidates for office, their record of economy, and take more interest in what is going on in their community, state and nation. In prosperous times the average man does not take the time to consider these things much.—Canyon News.

AN EDITORIAL

"It is a gloomy monument in history. Not for many years, not in the lifetime of most men who read this paper, has there been so much grave and deep apprehension. In our own country there is universal, commercial prostration and panic, and thousands of our poorest fellow-citizens are turned out against the approaching winter without employment.

"In France the political caldron seethes and bubbles with uncertainty. FARM NOTES

The Santa Fe Railroad and the A. & M. College together are conducting a demonstration train over the entire lines of the Santa Fe Railroad. This train will be in Lamb County during the month of March on the 28 and 29. The train will stop over at every station in the county, and the people of the county are urged to attend and go through this train. Livestock, meat work, and other demonstrations will be explained in full.

During the month of January the county agent spent most of his time conducting meat demonstrations throughout the county. All farmers and farm women attended 19 cutting, curing and canning demonstrations conducted by the county agent. Nine communities were reached, and a total of 7 beeves and 42 hogs were used in these demonstrations. At these demonstrations 38 men were trained to kill, cut and cure in an improved way.

A 4-H Club was organized at the Spade school, February 10, with 18 members enrolling. The Hart Camp 4-H Club reorganized with 10 members. The boys at Hart's Camp are conducting a terracing demonstration on the W. E. Heatley farm, February 25.

Under the supervision of County Agent D. A. Adam, contour lines were run on the A. F. Wilson farm south of Sudan, February 12.

Poison grain for poisoning of ground squirrels, prairie dogs, etc., will be available at the county agent's office from now on.

J. C. Jones, Amherst, Texas, reports three duroc Jersey sows, farrowing 42 pigs during this past week.

T. H. Pennington and Mat Nix shipped seven cars of cattle during the past week, and report a 3 pounds a day gain on their heavy steers. Heads and cotton seed were used in their feeding rations.

The Lamb County Meat Show is to be held in Littlefield, March 22nd, and premiums are large enough that every farmer who has cured meat can compete. The Champion ham has a cash prize of \$5.00, and in addition, Morley B. Drake, editor of the Lamb County Leader, is offering a prize of a complete butchering outfit consisting of a meat show, three butcher knives, and a steel for the best ham.

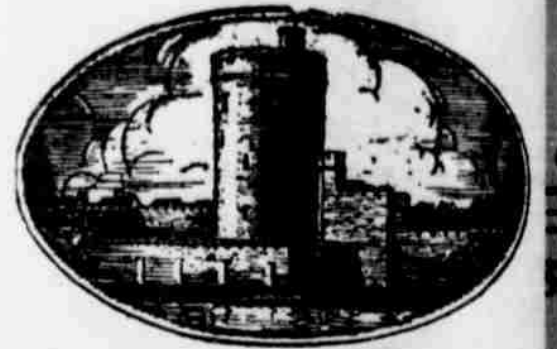

 summer session, and routine matters
 at a meeting held at the college. Clif-
 ford B. Jones was re-elected chair-
 man of the board, Roscoe Wilson of
 Lubbock, vice-chairman, and Houston
 Harte of San Angelo, treasurer.

The board authorized the employ-
 ment of teachers for the coming sum-
 mer session on a basis of seventy per
 cent of their normal salaries.
