**MONEY MAKES MAN**  
Widely Divided Social Distinction Is Wiped Out by Wealth  
CHICAGO, June 16.—"If the possession of the most money is to denote the best man in America—and it looks very much as if it were—then a disregard of ethical distinction is likely to become characteristic of the popular mind, for the suspicion is rapidly gathering in the average man that all wealth is gained," said Rev. Judson Thorburn of Milwaukee, in his address before the graduates of the Chicago Art Institute yesterday.

**CREW CAUSE WRECK**

**HOPES TO RESTORE GAELIC LANGUAGE**  
Dr. Hyde Visits Sixty Cities to Further Cause  
NEW YORK, June 16.—Dr. Douglas Hyde, president of the Gaelic League in Ireland, and Mrs. Hyde sailed for their home in Ireland yesterday on the White Star liner Celtic. Dr. Hyde took back with him a check for \$50,000 to aid the cause of the Gaelic League in Ireland. This sum was raised at the public meetings that Dr. Hyde addressed during his visit of seven months. Before sailing Dr. Hyde said:

**Effort Encouraged**  
"I have found nothing except a generous welcome in America. I traveled 10,000 miles, visited over sixty cities and explained the cause of the Irish struggle to perhaps 80,000 persons. I have not heard a single word that was not favorable to our cause. I understand now, and never before, how much this country and how numerous, strong and powerful are the Irish there in it.

**Refuses Gift**  
A number of Dr. Hyde's friends here offered \$2,500 to buy him a motor car for his work in Ireland. This was refused to have been presented to him on Thursday, but he declared he would not depart from the rule of the league to accept any personal remuneration for his services to the Gaelic cause and in behalf of Irish unity. Contributions were returned to contributors.

**CROP EFFECTS STREET**  
Grain Report Taken Advantage of by New York Brokers  
NEW YORK, June 16.—The week's opening show of strength in the stock market was largely due to the influence in Wall street of the hopeful promise for the grain crops contained in the government's monthly report. Advantage was taken of this to realize on speculative holdings and it was found that the new speculative demands for stocks was insufficient to take care of the holdings accumulated in the professional speculation which had preceded. The growing discouragement of the professional holders was seen in the disposition to close out holdings on declining prices. Some large unloading by stock market holders was given the credit for causing the sharp breaks in prices which occurred. Money has grown firmer again with effect on sentiment owing to the requirements over-hanging the markets.

**BELL STRONG IN HARRIS CO.**  
Gubernatorial Candidates Are Making Strenuous Fight  
**SURPRISES MANY**  
Political Arena Develops Many Changes in Strength of the Opponents

HOUSTON, Texas, June 16.—During the past week interest in the campaign has waxed exceedingly warm in Harris county. The gubernatorial fight has focused the attention of the voters and the followers of Bell, Campbell and Colquitt are making lots of noise and big claims.

Harris county is more widely divided at this stage of the campaign than at any other time in her history. One of the surprises of the past days has been the strength demonstrated by Campbell. Up to the time of the organization of the Campbell Club of Harris county, there was but little talk concerning the man from Palestine, but the call for a mass meeting at which a club was to be organized brought out a large number of enthusiasts and since that time they have not ceased in their efforts to make a showing for their candidate.

**Bell Is Strong**  
Bell is more than holding his own, while Colquitt is admittedly very strong. The Wolters-Colquitt controversy has interested the campaign to a fever heat, locally, and from the Colquitt camp has come many an assertion that Mr. Wolters' letter has shaken the confidence of the campaign in Houston, but there are others who say the issue raised will be forgotten, though it is apparent that the confidence that marked the conduct of his Houston campaign has disappeared within the past week. They now admit that they will not be able to carry Harris county without a fight.

**Bell Club First Organized**  
The Bell supporters are the first to open headquarters. The Bell Club has taken spacious quarters in Franklin avenue and there a secretary and an assistant are in attendance to greet callers and to discuss the campaign and put forth the claims of Judge Bell. County Chairman Gieselman closed the county ticket at 7 o'clock this evening, announcing that no more applications from candidates for a place on the primary ticket would be received.

**SLOCUM DISASTER COMMEMORATED**  
Memorial Services Recall New York Tragedy  
NEW YORK, June 16.—Memorial services to commemorate the second anniversary of the steamer General Slocum disaster were held yesterday at the Lutheran cemetery, Middleville, L. I., under direction of the organization of the General Slocum survivors.

About a thousand persons attended the services, a couple of hundred of whom were actual survivors of the tragic excursion. The remainder consisted of relatives and friends of the 800 and more victims, with the usual sprinkling of sight seers. Most of the gathering were deep mourning.

**Children Left Orphans**  
The pupils of public schools 63 and 25 attended in a body, the girls in white with crape arm bands, the boys in their Sunday best. The children, a few of them survivors, but the greater number orphans of the wreck, brought tears to many an eye. The crowd gathered early and covered the graves of the victims, both known and unidentified, with flowers. Then a band led the mourners to the graves where the unidentified dead were buried in tiers.

**STAND PAT ON MEAT BILL**  
Committee Supports the House Substitute  
**OPPOSE PRESIDENT**  
Conference Remains Firm Despite Objections of President Roosevelt

WASHINGTON, June 16.—Members of the house committee on agriculture, whose vote authorized the report on the substitute meat inspection bill, to which the President objects, began an informal conference Friday.

Members of the committee who attended the conference stated that the committee will "stand pat" on the substitute. After the conference with members who voted for the substitute Mr. Wadsworth discussed the matter with Speaker Cannon.

A minority report, signed by Representatives of Virginia, Iowa, Alabama and Schandler of Mississippi, was filed today on the substitute for the Beveridge meat inspection bill reported by a majority of the members of the house committee.

"In our opinion," the report concludes, "the Beveridge amendment after correcting minor provisions will be a far better bill and accomplish the purpose intended more satisfactorily than is possible under the provisions of the house substitute."

The three points of placing the cost on the government, the court review and the waiving of the civil service law for one year in the selection of inspectors are made the principal points of objection to the substitute in the report. After stating that the packers are to blame for existing conditions the report says:

**Premium Given to Packers**  
"Can it be tolerated that those whose actions have endangered the public health and undermined the public confidence shall escape from the condition which they have created without penalty of any kind, and with the added premium of \$2,000,000 annually from the treasury of the United States to pay the expenses of correcting their own wrongs?"

Commenting on the testimony before the committee the report says that the only contradiction made to the Nell-Reynolds report was by the general manager of one of the packing houses, "who undertook to testify not only as to the conditions in his own establishment, but that of the balance of the Chicago plants and undertook to testify not only in rebuttal of statements made by Messrs. Nell and Reynolds about facts in their knowledge, but actually made a statement upon conditions that had transpired when he was not in Chicago and therefore could not possibly have personal knowledge of the matters about which he assumed to enlighten the committee."

The court review provision of the substitute is characterized by a sworn over the heads of the inspectors engaged in the discharge of their duties, and to cripple materially the efficiency of the service."

**BUILD ALASKAN ROAD**  
Eight Million Dollars Will Be Put Into Construction of Line  
SEATTLE, Wash., June 16.—The stockholders and trustees of the Alaskan Central railroad, at their annual meeting, which closed last night, amended the company's by-laws and tried to provide for the purchase by a syndicate of London and Holland bondholders of the \$5,000,000 of Alaskan Central bonds, with which to finance the construction of the line. An agreement was signed with the Tanana Construction Company to complete the road as far as the Chitana coal fields, 185 miles north of Seward, not later than eighteen months from July 1 of this year.

F. Augustus Heinze of Butte, Mont., was made a trustee. With this exception the old board of trustees was re-elected.

**RIOTERS BURN ENTIRE TOWN**  
Mobs and Troops Fight Regular Pitched Battle  
**MURDERS MANY**  
Massacre of Jews Continues and Shops Are Broken Into and Looted

**By Associated Press.**  
WARSAW, June 16.—The latest message received here from Bialystok says the sacking of Jewish houses and shops accompanied by conflicts in the streets between the mob and troops continued until late last night. Many Jews, Poles, Russian civilians and soldiers were killed and wounded. The suburb Bojaby was totally burned and eight streets of Bialystok completely sacked. The rioting extends from Lapy station on the St. Petersburg railroad and to Stereolec station on the Southwestern railroad. At both places Jewish shops were looted and Jews murdered or beaten. The mob devastated the Jewish shops in the town of Chermayawie, the first station out of Bialystok on the line to Grodno. In Warsaw two police sergeants were shot and killed and another policeman wounded by the terrorists, and the police who pursued the assassins were shot and killed by passing women.

**Fear Peasant Uprising**

ODESSA, June 16.—Instructions have been issued to the effect that all infantry regiments and reserve men in the southern and southwestern provinces are to be temporarily placed on a home war footing with a view of a possibility of the peasants rising against the nobles. Cosacks are mobilizing into flying brigades. It is stated similar instructions have been issued to provincial commanders of the chief central and northern Russia districts.

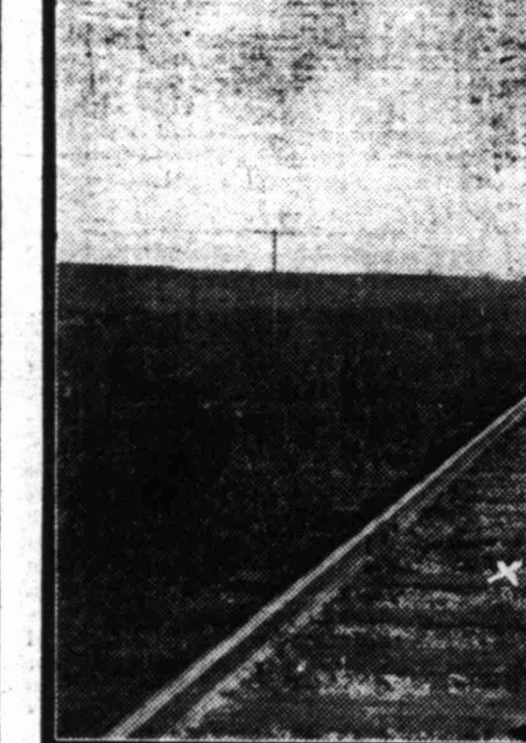
**Rioting Unchecked**

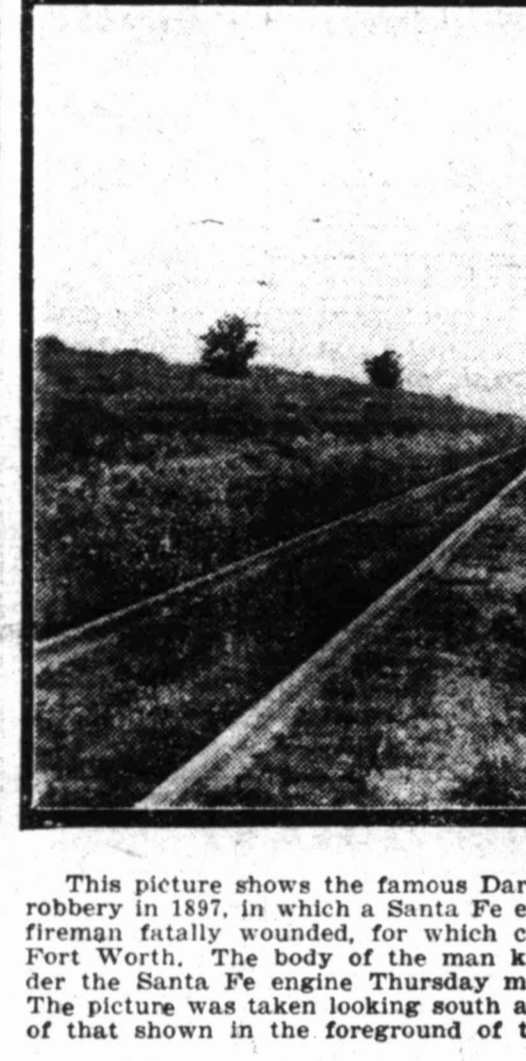
**REIGN OF TERROR AGAIN THREATENED**  
Mob Law and Riot to Follow Recent Outbreak

ST. PETERSBURG, June 16.—The gravity of the general situation grows hourly. The bourses of St. Petersburg and Moscow are in a panicky condition and the social democrats and social revolutionists are considering parliament to precipitate. They are pushing their campaign for an armed uprising with increased vigor.

Demonstrations are daily occurring in the streets of Moscow in favor of a general strike which the proletariat leaders are trying to precipitate. The conflict agitation among workmen here has reached a boiling point and patrols again are in heavy force in the industrial quarters. In country rural districts are throwing their lot with the peasants, refusing to protect landlords. The progress of revolutionary propaganda in the army is seriously alarming the government and to add to the popular excitement comes the massacre of Jews at Bialystok.

**OFFICERS WAITING STORY OF WITNESSES**  
IN SANTA FE DOUBLE KILLING MYSTERY  
Scene of Double Killing on Santa Fe Thursday Morning



Cross shows where first evidences of killing were discovered. From this point the gravel and stones on the track are brushed away as a result of one or more of the bodies being dragged between the rails. The picture was taken looking toward the south. A few yards south of where the cross shows and to the right of the track was found the body of Bishop, and not far from it the broken revolver. **DECLARES MONKEY AND CHILD ALIKE**  
Young Are Guided by a "Dog Conscience"

CHICAGO, June 16.—"Logical elimination" of the criminal, not capital punishment, but simply putting out of the way a menace to society, was the plan advocated by Dr. G. Frank Lydson of the College of Physicians and Surgeons last night at the West Side auditorium. To this he added that the child primarily has no moral sense, is a little animal, almost a little monkey, and can if let alone use its toes as fingers as well as any of its simian ancestors.

He asserted the child for some time there is a "dog conscience," it realizes that there is a spanking on the side and candy at the other, and by that compass it guides its conduct.

Later, there is a "golden crown and harp on one side and perdition on the other, and the child is taught to keep the same sort of "dog conscience" in some cases.

**Parents Blamed**  
"Anyone almost, if he or she is not a raving lunatic, can get a marriage license. That is the first cause," said Dr. Lydson. "A child of parents who have nothing to give it, but sickness or, worse, some disease, some mental taint or physical deformity, which warps the mind, cannot compete in the world. He cannot understand it. Suppose his parents die and the child is left alone to make his way. He must live. Honestly if he can, if he can understand what it means, but he must live. Society does not do anything for him unless he steals, and then it locks him up and if there is anything lacking in his criminal education, the penal institution perfects it."

"We have had capital punishment for years, but still crime is slowly on the increase and so is insanity. If a man is a hopeless criminal degenerate, don't punish him in jail, make him the subject of logical elimination. It is better for him and vastly more so for the community."

**CRUSHED TO DEATH**  
Contractor Meets Death as Brick Wall Falls Upon Him

WACO, Texas, June 16.—D. E. Gossett, a general contractor, whose home is in Mart, was killed yesterday at Riesel in the southeastern portion of the county. He was building a bank structure, and in removing the supports the brick wall gave way, crushing him to death. He leaves a family of four and was about 35 years old.

**INQUEST INTO TWO MENS' DEATH IS DELAYED**  
**ENGINEER ABSENT**  
Man Who Reported Finding Bodies to Section Foreman Is Also Sought

Search for the third man in the Santa Fe killing mystery, in which Jack Bishop of Illinois Bend, Montague county, and another young man known as W. Jackson lost their lives either Wednesday night or early Thursday morning near the north end of the Jim Darlington cut, a mile north of the packing houses, is still being prosecuted by county officers and railroad detectives. A fourth man who was the first to report the tragedy is also being sought in the hope that he may be able to tell something more than the officers already know.

Through Section Foreman Ferguson of the Santa Fe The Telegram has secured an excellent description of this fourth man.

This description is as follows:  
Thirty-five years old, of medium build, somewhat heavy set. Height about 5 feet 6 inches. Weight 160 to 170 pounds. Face smoothly shaven. One front tooth somewhat prominent. When last seen was wearing white hat and carried a cheap suit case such as a laboring man might buy at second hand outfitting store.

**May Be Still in County**  
From this man's actions it is believed he is still in Tarrant county and that if found his testimony might go much toward settling the question whether or not there were two bodies on the track before the southbound train reached the grade leading down to the Darlington cut. Engineer Moore's statement, it is understood by the county officers, is to the effect that he saw only one body.

The fourth man wanted in connection with the tragedy met Section Foreman Ferguson a few minutes after 8 o'clock Thursday morning after the southbound train had passed.

"There are a couple of dead men on the track down there," and passed on. Ferguson and his crew hurried south toward the Darlington cut and reached there before the southbound train which struck at least one of the bodies had moved on toward Fort Worth. Ferguson thinks he got to the pilot of the engine from under which one of the bodies was taken, about ten minutes after the body had been struck. The body was then cold.

Whether the man who reported the finding of the bodies to Ferguson saw them on the track before the train struck or saw them after the train had thrown them from the track and without stopping walked north until he met Ferguson and told him of the circumstance, is not known to Mr. Ferguson.

Or whether the man who reported the tragedy saw the bodies before the train struck them or afterward, depends the importance of his testimony, if he did not see them until afterward he can tell but little. If he saw them before he may be able to tell something the officers would like to know. It is considered reasonable to suppose the man saw the bodies before the engineer of the southbound train did this, by walking steadily north past the train he was able to tell Foreman Ferguson in time for the latter to reach the scene on a hand car before the train crossed left.

Grouse believed that this man is still in Tarrant county is furnished by the fact that he remained in the vicinity of Saginaw until noon Thursday.

**SHERIFF DEFEATS GEORGE J. GOULD**  
Railroad King Forced to Pay \$4,775 Poundsage Fees

NEW YORK, June 16.—By a decision rendered yesterday in the appellate division, Sheriff Hays is entitled to collect \$4,775 in poundsage fees from George J. Gould.

This decision rescinds the order of Supreme Court Justice Fitzgerald, in which it was held that the sheriff was only entitled to about \$150.

Mr. Gould is one of three defendants in a suit brought by John S. Jones, an Ohio railroad man, to recover \$465,000 on an alleged contract by which Jones agreed to purchase for Gould, Joseph Ramsey Jr. and William E. Guy, who constituted the Little Kanawha syndicate, a large tract of coal land in Ohio. Jones alleges that he fulfilled his contract, but was unable to collect either his commissions on the purchase or his expenses.

He got a attachment against Geo. J. Gould and cash and securities valued at several hundred thousand dollars on deposit with the Mercantile Trust Company were seized by the sheriff. Gould released the levy by giving an undertaking in \$500,000 to secure Jones. Gould then demurred to paying the poundsage fees and counsel for the sheriff appealed from Justice Fitzgerald's order, which sustained Gould.

Justice McLaughlin, for the court, says that where a levy is made, the sheriff's right to poundsage fees is absolute and the amount is fixed by statute. Hence Gould is not entitled to the return of his property until he pays the statutory fees in full.

It is charged that the combination has mulcted southern planters and farmers out of many millions of dollars in the last few years through its shrewd and secret methods. The proceedings were brought in the United States circuit court for the middle district of Tennessee. The grand jury returned an indictment against the Virginia-Carolina Chemical Company et al. This is a corporation with a capital of \$50,000,000, existing under the laws of New Jersey. With it are allied a large number of other concerns. A list of the defendants includes Armour & Co. and Swift & Co. of Chicago, the Acme Manufacturing Company of North Carolina, the Federal Chemical Company of Delaware, the Federal Chemical Company of Kentucky and Alabama Chemical Company of New Jersey, the Anderson Phosphate and Oil Company of South Carolina, the Carolina Fertilizer Company, Ltd., of Great Britain and Ireland, the Read Phosphate Company of West Virginia and a score of others.

**PENSION LIST GROWS**  
Eight Thousand Confederate Veterans Entered for Warrants

## HARD PATH OF THE CATTLEMAN

The cattlemen of Texas have had a hard experience for the past four or five years. They have suffered from so many forms of depression and combinations of adverse circumstances that it is wonderful how they have managed to hold up not only their courage and determination, but keep the cattle business of the country from being completely demoralized. The past twenty years have witnessed some staggering changes in the great live stock industry of this country, and there is but little left of the old regime that is recognizable. The old-time cowman is becoming a very scarce figure now as compared with his former presence and standing, and year by year he is becoming less in evidence. The cattle business in Texas has been given over very largely into new hands, new methods have been adopted, and those who cannot adapt themselves to these changed conditions have either quit the cattle business or sought more inviting locations, principally in the republic of Mexico.

One of the old-time cowmen of Texas is C. W. Merchant of Abilene. He has been identified with the live stock industry since back in the days when it first had its origin, and located one of the first ranches out in the great Abilene country. He has seen the passing of the old regime and the development of his section into a great farming and stock raising country, and when he felt too badly crowded he located a big ranch out in the wilds of New Mexico. But the settler has been a Nemesis upon the heels of cattlemen and have dogged his footsteps continually as he has retired toward the setting sun. Mr. Merchant is now preparing to establish a ranch in Old Mexico. The Abilene Reporter says: C. W. Merchant leaves today for old Mexico to buy a big ranch, and will travel over a large portion of the public contiguous to Texas, to find the best and most promising place for the purpose. We are informed by Mr. Merchant, who is one of the most successful stockmen in the southwest, that the outlook for the business in the republic south of us is very fine. He will also put blooded cattle out there. "I have not had a man to offer to buy a beef animal from my ranch in two years," said he yesterday. "I have not sold enough to pay for the food of the boys who look after my cattle."

As Mr. Merchant has thousands of high-grade cattle, all in fine shape, this is a most significant fact. He thinks that the packing house situation now on in Washington will make the buyers still more shy than they have been the past two years. Asked what the stockmen and small farmers who raise calves and hogs will do, if Roosevelt and Bryan are the nominees, in 1908, he made some emphatic remarks about the strenuous ones.

The stockmen who quit the democratic party and voted for McKinley and Roosevelt are talking and hoping. Some are talking and hoping their remarks are not intended for political ears. This does not apply to Mr. Merchant, however, as he is always a Chesterfield, in manners and language. The experience of this Abilene cattleman is that of a thousand others. It faithfully portrays the rapid progress and development that is now going on throughout the west, and which has transformed the whole face of that

section during the past few years so that it is now hardly recognizable. Down in Mexico the big cattlemen are making their last stand, and when the settler crosses the Rio Grande and routs him from that last holding there will be no other place left to go.

The outlook for the cattle business is not good at this time. The unrest and ceaseless agitation that prevails throughout the country is not the harbinger of prosperity in that direction. The markets of the country are in the hands of those who clearly understand how to manipulate and control them, and there seems no relief in sight from these conditions for some time yet to come.

Politics and politicians are cutting a considerable figure in the situation, but it is two years yet before the lines of battle will be laid down in a great national contest. Just about the time the cattlemen arrive at the conclusion that prosperity is about to again dawn for them will come the unsettled conditions that always attend a great national campaign year. The indications are at this time that matters will not settle down upon a permanent basis until after the next national election has been held.

In the meantime, however, the cattlemen who continue the process of improving their herds and only prospering the best will find that there is always a reasonably good market for good stuff.

## THE FREE SEED HUMBUG

The final passing of the free seed appropriation bill in congress after one of the most bitter and persistent fights ever witnessed in that body, is a tribute to those members who regarded it purely as a matter of expediency. And, this matter of expediency is a clear case of getting off on the wrong foot.

Without these were members of congress who really believed they would be summarily wiped out of political existence but for the saving grace of free garden seeds. They imagined that upon their return home from Reubens would be waiting for them at every turn of the political road with stuffed clubs and prepared to swat them for failure to provide the accustomed and expected fraud. But this idea is wholly erroneous.

The farmers of this country care nothing for the pitiful little hand full of free garden seed doled out to them every spring by a paternalistic government. Back in the early days of the free seed business, before the purpose of the idea were prostituted, the farmers of the country were glad to get seeds of new kinds with which to experiment. But since the seed business has degenerated into a form of political graft and they do not know whether to expect washing machines or purple top turnips from the packages received from congress, they have rather lost interest.

The matter of planting a garden is a minor proposition with the average farmer. All the seeds required can be purchased from reputable seed men for a few cents, and the cost of the planting of the garden has been reduced to a minimum through competition between the large number of seed growers that have sprung up all over the country. The little dab of questionable truck received from Washington amounts to absolutely nothing.

And those congressmen who foolishly imagine they are buying the support of the rural districts through the distribution of these pitiful little packages of garden seeds deserve to be summarily retired from the positions they are disgracing. It has been often said that every man has his price, but these congressmen have gotten the rural districts to value them entirely too low. Some of these horny-handed sons of toil might be bought with a bushel of sweet potatoes, or a big sack of Mexican June corn, but when it comes to about four packages of questionable garden seed, worth on an average about one cent each, there is not much doing.

The seedsmen who make a good thing annually out of contracts to furnish the government with the odds and ends they are unable to market elsewhere, have succeeded in again perpetrating upon the people a nuisance that finds little popular favor. They have managed to convince the congressmen that there is salvation in the idea, and so the graft has been perpetuated for another term. But one of these days the people will arise in the might of their righteous indignation and flout this free seed business so completely that it will pass entirely out of existence. It is a form of graft that is absolutely unjustifiable.

The hot season is now upon us, and that fact should be sufficient to admonish the property holder as to the necessity of cleaning up his premises and keeping them clean. An ounce of prevention is a truly worth the proverbial pound of cure.

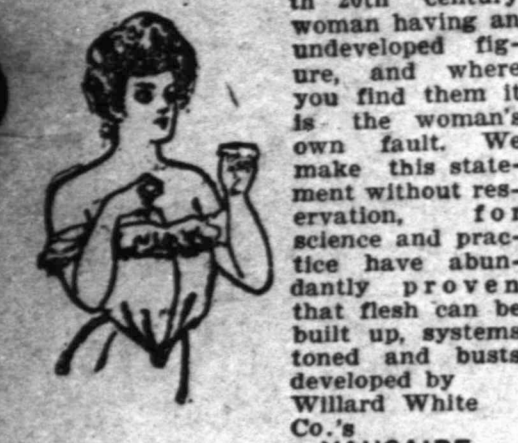

Culberson May Head National Democratic Committee

HONOR FOR STATE

Effort Is to Bring About Reconciliation Between the Senator and Bryan

Special to The Telegram. AUSTIN, Texas, June 15.—The report to the effect that a movement has been started in Texas and which is spreading over the south for the selection of United States Senator C. A. Culberson for chairman of the national democratic executive committee was received in political circles here with a great deal of pleasure.

Senator Culberson has a large number of warm friends here who would be delighted to see him at the head of the national democratic committee. It would be a compliment not only to Culberson but to the south as well. It is said that this movement has been started contemporaneously with the effort to bring out Colonel W. J. Bryan as the democratic nominee for president with a view of bringing about a reconciliation between these two statesmen.

Failure to Endorse Bryan It is said here that on the other hand Senator Culberson would stand a better show of getting at the head of the national democratic organization if his claims were segregated from the idea of bringing out the Nebraska for the nominee of the party next national election. The failure of the state democratic executive committee here to endorse Mr. Bryan as the probable nominee of the democratic party shows that Bryan does not stand in the same high esteem in Texas from a political viewpoint than he did several years ago.

Bishop's Body Buried The mangled body of the man identified as Jack A. Bishop, whose mother and sisters are supposed to live at Illinois Bend, Montague county, was buried by Undertaker George L. Gause Saturday morning. The body could be held no longer, as decomposition had set in. There was no further identification of the body than that heretofore published in The Telegram.

Nothing has been heard from any of Bishop's people, and it is not known even that they have been informed of the tragedy. Illinois Bend is a small town in Montague county, without telephone or telegraphic communication, and all efforts to get in communication with Bishop's people have failed so far. Nothing is known of Jackson's antecedents. Where he came from to Fort Worth, where his people are, if he has any, is a closed book to every one here who had known or seen the man.

Engineer Not Here Engineer Moore of the train that ran over the two men had not appeared in Fort Worth since the killing up to noon Saturday. Because of this, Justice Rowland, who is conducting the inquiry in the case, has been unable to make any further progress. The verdict of the coroner-justice will depend to a great extent on what Engineer Moore will testify. There is plenty of hearsay evidence as to what he said about the body on the track and the condition of it when taken from under the train, but there has been no evidence.

dence on these points before Justice Rowland. Moore, it is said, saw only one body on the track, it being the one identified as William Jackson. It was pulled from under the engine near the mouth of the Darlington cut, 300 yards south of where the other body identified as Bishop was found. Bishop's body was not on the track, having been thrown to one side by the train that struck it.

Engineer Moore, the story goes, did not see this body, the body struck by his engine being some distance south of it. This body was found on the night train first passed over the two bodies.

No Weapons in Hands

There are some statements that have been published in a morning paper that the officers who were first on the ground when the bodies were found say are not correct. According to their statement, the story that an open knife was found in the hand of one of the dead men and a cocked revolver in the hands of another has no foundation whatever. In fact, both arms of one of the men were cut off and the severed hand could not grip a knife or a pistol.

The brass knucks were found in the pocket of the man identified as Jackson, and the only pocket knife found was open and lying on a cross-tie twenty feet from where the body of Bishop was found. The pistol was found on the track just inside one of the rails, opposite where Bishop's body was when the officers reached the scene.

No Money Found In this connection it may be stated that one of the peculiar facts connected with the finding of the bodies is that not a cent of money was found in the pocket of either, although both men were well dressed.

This fact would suggest robbery, yet plenty of other articles were left in the pockets of the two men, including the photograph by which they were identified, the revolver, brass knucks and knife.

RAILROAD RUMBLINGS

TIME TO BE SHORTENED

Run from St. Louis to Houston in 23 Hours Beginning Sunday, June 17, the time between St. Louis and Houston will be shortened to twenty-three hours. This is done by using the fast mail of St. Louis and making a close inter-connection at Longview Junction. No decrease in the time of the northbound train is yet decided on.

LOREE WITH K. C. S.

Election to Directorate Said to Have No Significance L. F. Loree, at one time the president of the Baltimore and Ohio and also of the Rock Island at yet another time, who since his retirement from the latter position has held, it is stated, the position of railroad expert for Speyer & Co., has been elected to the directorate of the Kansas City Southern and made chairman of the board. WESTERN RATES CUT

Three-Cent Charge to Be Effective in Idaho At a conference held Thursday at Omaha it was announced that the passenger rates will be cut on six western states and two territories. In Idaho and parts of Colorado and Wyoming the rate will be on main lines, cents a mile, instead of 4 cents a mile. In California a uniform rate of 3 cents a mile is established in place of the earlier rates which varied. In Nevada the reduction is from 5 to 4 cents a mile, and in New Mexico the change is from 5 to 4 cents a mile. These statements were made at a conference of the officials of the Southern Pacific, the Santa Fe and the Union Pacific, held at Omaha on the date named.

RATON TUNNEL PLANNED

Santa Fe Will Spend \$1,000,000 in Improvement The Santa Fe is to tunnel through the Raton mountains and thus avoid the use of the dangerous switchback over these mountains which has been the scene of so many accidents. The tunnel will pierce a range of much lower elevation than the present crossing. The tunnel will be wide enough for double tracks, about a mile long and the estimated cost is about one million dollars. Electric drills are now on the way to the place of beginning and the work will be done as soon as possible.

Railroad Notes and Personal

The Texas and Pacific pay car came over from Dallas Saturday morning and after paying May salaries here, will go east and pay every station between Fort Worth and New Orleans. When the eastern payments have been completed the pay car will return to Fort Worth and pay stations west to El Paso.
