LAMESA'S SECOND MONTHLY TRADES DAY ATTENDED BY HUNDREDS OF PEOPLE FROM SURROUNDING TRADE TERRITORY

Lamesa's second Trades Day was a big success. Thousands of people came to get the bargains the merchants had to offer—and they really took advantage of the quality merchandise at the lowest price ever offered and bought such goods as they needed—and the fun—boy howdy!—never saw the like.

In the nail driving contest the following women were winners of their groups: Mrs. Joe Vienyard, Mrs. C. F. Cox, Kathleen Hastings, Mrs. G. W. Musick, Mrs. Lois Thorpe, Mrs. Cora Ticer, Mrs. C. H. Miller. All these women received prizes from the various merchants in the city, and of course it was fun to watch the nail driving contest. The women had to drive three 16 penny nails into a two-by-four scantling and run for each nail a distance of twelve yards. To say it was fun merely half way expresses it. One could hear the laughing and

hollering all over town and tourists passing by had to stop and watch the big attraction. They too, got a big kick out of it.

But the big prize, twenty dollars in gold, given by the Dawson County Courier, went to Mrs. F. L. Holley, ask her how she felt when the judges announced she had won. She rushed over to one of Lamesa's progressive business men and proceeded to trade out the twenty. She won, but my at the competition. More than one hundred women entered the contest and the nailing started at ten a. m. and continued until four p. m.

Mrs. Boydon of Lubbock county came sixty-five miles just to enter this contest and she too received a nice prize because she was the winner of the long distance premium, to enter the nail driving contest.

People came to this Trades Day from Borden county, Howard county, Martin county, Andrews county, Gaines county, Terry county, Lynn county and of course hundreds from Dawson county. The people are coming to these trades days. They have

already started and you can bet your soundest dollar they will continue to come. Next Trades Day we predict the largest crowd that has ever come to Lamesa. There is no trades day within a hundred miles of Lamesa and of course the people are going to the town that offers them lots of worthwhile bargains and plenty of fun.

Farmers and stock men have started bringing their stock and tools in for trade on these days. Last Monday several horses and mules and farm tools were brought to town and we are told several sales and trades were made. They will be here in greater numbers next time. The good old First Monday idea is gradually coming back and soon the lots north east of the square will be crowded with stock and tools, hogs, and cows for trade and sale. In fact everything for sale or trade will be there.

LAMESA BOY SCOUTS CARRY OFF HONORS IN DISTRICT MEET FRIDAY AND SATURDAY

The Boy Scout Camp-o-ral of the Southern District of the South Plains Area Council, held in Lamesa Thursday and Friday last week was a marked success according to scout officials and others in attendance. Although some of the towns in the district failed to send troops, the meet was attended by about ninety boys and officials and it is needless to say that every moment of the time was thoroughly enjoyed. Not a single incident happened to mar the pleasantness of the occasion, and we feel that the boys gained considerably from their association with each other and from the friendly competition in the various events. Meetings such as this tend to bring out the many sterling qualities of Scouting and calls for the best there is in the individual boys. Troop 22, Lamesa, won first place in the field meet proper, Friday afternoon and amassed a total of 89 points, winning 5 first places, 6 seconds, and 3 third places out of the eight events. Troop 23, Lamesa with 37 points won second place and Troop 37, Slaton, won third place with 18 points.

The troops arrived in town about five o'clock Thursday afternoon and pitched camp in the old city tourist camp grounds just east of the ball park. Each troop selected its own site and erected its tents and set-up according to its own liking. While the boys were busy preparing and eating their supper a huge council ring and camp fire was arranged by the officials. At 7:30 all took part in an impressive flag ceremony led by John Marr, Eagle Scout of Troop 23. After dark the boys filed into the council ring to the beat of the tom-tom, the Indian Chief gave the opening ceremony and the fire blazed up and the pow-wow was on. Songs and troop stunts amused everyone until the council ring took on the shape of a Court of Honor. Scout Executive R. T. Jennings of Lubbock assisted by Mr. A. Kessel, Slaton, District Court of Honor Chairman, Mr. Hagerman and J. D. Dyre had charge of the Court and a number of boys went up for advancement. Lamesa boys going before the Court were:

Friday started off with a bang Call at 5:25, followed in a few minutes by Reveille, at which time each troop leader put his boys through a few setting-up exercises. After breakfast a playground ball tournament was held and in the first round, Troop 44 defeated Troop 37 and Troop 22 defeated Troop 31. Troop 23 drew a bye but was defeated by Troop 22 in the second round. The final game was between Troops 22 and 43 and resulted in a victory for Troop 22. "Criticism"

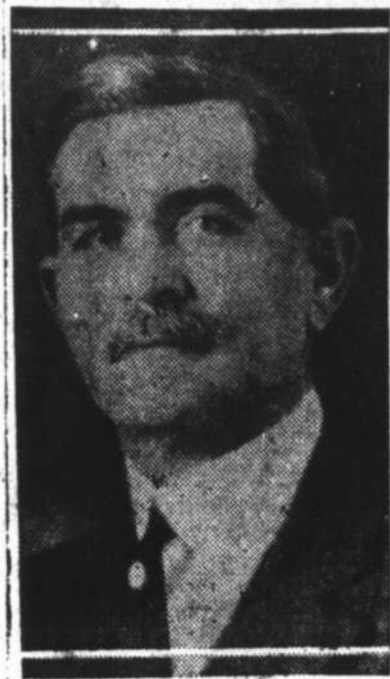

SIX BUSINESS HOUSES BURGLARIZED IN LAMESA MONDAY NIGHT

Although two nightwatchmen reported they had observed nothing unusual, six business houses, including the Santa Fe railway station, were entered by burglars Monday night.

Loot in all places was small, although an attempt was made to rob the Santa Fe safe, knob of which was knocked off. Sheriff Gus White, who states that he had some clues on which to work, indicated the series of robberies was pulled by youngsters of amateurs.

Three locks were broken from the Phillips oil company storage tanks and about 15 gallons of kerosene were stolen. Two 10-gallon cans, believed to have been filled with gasoline, were stolen from the Continental warehouse. An unsuccessful attempt was made on the Conoco gasoline storage tank. Entrance to the warehouse was gained by prying open the front door, and exit was through a rear door.

A rear window of the Santa Fe station was forced, the knob was knocked, about \$1.00 in stamps was taken, and a pinch bar, thought to have been used in other burglaries, was stolen.

The fourth annual yard contest which is conducted by the Civic Department of the local Chamber of Commerce has been announced by Judge J. R. Lowrie, chairman.

In announcing the contest this year Judge Lowrie says all who enter the various classes and win first place in the class entered will receive a certificate from the National Yard Contest Association.

Lowrie states that all entrants must be in the chamber of commerce not later than August the first.

Two gradings will be made of each entry. The first will be in August and the second thirty days later in September. All judging will be done by out of town and disinterested parties. The grades of each entry will be filed in the local chamber of commerce for the inspection of each entrant.

The classes open this year are as follows:

First year resident—Any resident in the city not entered heretofore in these contests.

Second year residence—Any resident that has entered these contests before but has not won first place heretofore.

Back Yard—Any back yard in the city.

Commercial—Any public property, a churches, Hotels, Sanitariums, school grounds, etc.

Rural—Any resident outside the city limits of Lamesa and in Dawson County that has not won first place heretofore.

No first place winners heretofore in these contests will be allowed to enter this year.

It will be noted that these contests have done much to stimulate civic interest in the community during the past three years. It is hoped to achieve the greatest number of entrants this year of any previous year. Who Will Be The First. The papers will carry from time to time a list of entrants.

COTTON DRESS CONTEST

Home Demonstration Clubs of Dawson county are sponsoring a county-wide cotton street dress contest for the women and a cotton school dress contest for the 4-H club girls on June 25th.

Home Demonstration Club women lead by the special wardrobe demonstrators have made for themselves foundation patterns, which are perfectly fitted dress and sleeve patterns with all seam lines, bust, waist, and hip lines clearly marked to avoid any mistakes in fitting.

The women's dresses entered in the contest will be fitted by these patterns. Any tissue paper pattern may be used, for the design of the dress, but it must be altered by the foundation pattern to fit the individual.

These patterns have proved so helpful in eliminating fitting problems that many Home Demonstration Club women have helped make patterns for their neighbors who are not club members, and have listed them as special co-operators. The County Home Demonstration has provided that these women may share in the street dress contest, competing against other special co-operators.

The design chosen should have a sleeve, which may be very short and fullness inserted into the skirt by pleats.

Materials suitable to use for making these dresses are: color fast gingham prints, and plain colors, cotton mesh, pique, linen, broadcloth, soisette, chambray, peplin, and many others heavy cotton materials.

The 4-H girls are modeling the school dresses and slips which they have made in their club work. Records of work in clothing, poultry, and food preservation are to be checked to determine the most outstanding club girl in the county.

Prizes of \$2.00 and \$1.00 are being awarded to the girls winning first and second place in each contest. For the Women Demonstration, dress contest, prizes of \$3.00 for first, \$1.50 for second, and \$1.00 for third places are being offered.

A prize of \$2.00 is offered to the winner of first place in special co-operators dress contest.

The dresses are to be judged in the morning by the committee from outside the county, and in the afternoon these dresses will be modeled in a style review, which all people are cordially invited to attend.

tributes to the amazing amount of idle chatter that goes on behind backs about the poor paper that Mrs. Jones read at the last club meeting, or the unfair treatment that Mr.

Jones accords to his employees, or the terrible extravagance of dear Mabel, or the undue devotion to golf of poor Tom—caustic characterizations which often are betrayed to the unhappiness of all concerned.

The Bible tells us that God is "of purer eyes than to behold evil, and canst not look on iniquity". Human beings may not have attained to the divine love which is said to be unconscious of evil, but a great affection does make light of faults. Most often, and not always wisely employed, we see it between mother and child. But everyone has beheld the loyalty of the small girl for the battered doll, which is dearer to her heart than the grand new one. And what wife has not struggled to separate her husband from an old suit in which he sees no defects?

There is, however, a difference between the love or loyalty which merely overlooks a fault, or the attitude which forgives offenses in such a way that the transgressor is provoked to fresh outbreaks, and that love or loyalty which separates the sin from the sinner, thereby tending toward checking and destroying the fault.

Such love is almost superhuman. But isn't that exactly what we have been saying that we wanted—perfection? The only difference of course is that we have been looking for perfection to blossom in the garden of our husbands or our friends, our employers or our relations; whereas the only growth it has for us comes from our planting. If we succeed in bringing forth the tiniest bud ourselves we shall find it springing into blossom for us however far afield we may go.

It is interesting to note how often the tendencies which provoke us in others are the ones to which we ourselves are prone to fall victims. Two women, both actuated by self-importance, will dislike each other for trying to keep the center of the stage. The tapping pencil in the nervous fingers of one man will worry another. Why?
