No new tax rolls until September—

## Board of Review hears some 65

It is going to be sometime in September before local taxing units will have their new tax rolls.

Some 65 or more tax payers, from the very biggest on down, have been shuttling in and out of the Board of Review's hearing room in Tax Appraiser Jean Westfall's ground floor office in the courthouse Monday, Tuesday, and Wednesday.

The three-member board of review includes Kay Kirkpatrick, Mrs. Iva Hudman, and Ronald Thuett.

Some 25 took their complaints to the board Monday, 20 others were in Tuesday, and 20 more were booked for Wednesday.

A test case is expected to be carried into district court by a rural landowner who

felt not advised in time to have his property evaluated under the new "ag use" provisions.

Some of the taxpayers seeing the board are business men, some are home owners concerned about values placed on their residences, but most of them are farm owners who want to be sure of their "market values" on farm

land. Everybody was too busy to attempt to guess where the total property revaluation will end up, whether it will be cut substantially from the first estimate of \$590,000,000 for the county as a whole.

In the back room of Mrs. Westfall's office Carlton Meredith, the tax attorney from Dallas who represents

George R. Brown and other Garza oil interests, has been working since Monday checking new appraisal values of residences, businesses and farm land.

He wants to be sure that a good job is done on all other property besides minerals in this big reappraisal.

## New 1,000-seat auditorium or tax cut?

Post school trustees have instructed Supt. Bill Shiver to obtain cost estimates on long needed paving around the Post schools and a "ball park figure" on building a new 1,000-seat school auditorium, or expanding the

present auditorium and upgrading its facilities.

This action came last Thursday night at the board's August meeting after Shiver had asked the board for budget guidance on whether to continue the

schools' three-year-old physical plant improvement program, or cut back on property tax needs by approximately \$500,000.

Trustees put off voting either way, but appeared to be "leaning" for continua-

tion of the school improvement program.

Shiver also told the board when the budget discussion began that the state now considers the Post schools to be "a budget balanced school" and unless state operations are changed Post will lose its state support over the next five years at the rate of 20 percent each year.

Post schools are now receiving approximately \$650,000 to \$700,000 in state aid annually.

A "budget balanced school" is one which has such property high valuations that under present state rules does not merit state financial support. There are not too many of these in Texas, most of them being in busy oil producing areas as is the case here.

Air-conditioning of the schools was mentioned in the discussion on future improvement projects for the next fiscal year, but none of the trustees spoke up for it. Shiver told the board air-conditioning was favored by the teachers.

Trustee Charles McCook came up with the suggestion of expanding the present auditorium, but that would mean moving the school's boiler room situated behind the auditorium.

Shiver estimated a 1,000

seat auditorium, which would permit all graduation exercises for example to be held inside, would cost \$1,500,000.

The schools have been financing their improvement program from excess funds left over after they have been needed to finance the schools' operations for the first months of the school year while awaiting property taxes to be paid.

With high interest rates available, oil companies waited until January this last school year to pay their school district taxes thus over a million dollars was required to keep the schools going until this major part of the taxes were paid.

Supt. Shiver insisted to the board these additional funds should not be termed "surplus" as The Dispatch has referred to them in the past.

The administrator said that he could complete the school budget as in recent years which would provide funds for school improvements or he could tighten the budget and ask for \$500,000 less in property taxes.

He said if the \$500,000 were kept in the budget for improvements, no tax rate hearing would be required as the school property tax requirements would be under the three percent total

dollar budget increase from such sources which requires the tax rate hearing.

Thus, the choice is whether to continue the school budget at about the same level as last year as far as property tax needs

are concerned, or whether to cut those needs by \$500,000 and end the school improvement program short of its final goal.

Shiver also told trustees that 50 percent of increases in the new budget will go to

salaries.

These include big local raises voted teachers, plus a state teachers pay hike, and salary boosts to all other school personnel.

### Schools to spend \$57,345—

## OK for paving

An estimated \$57,345 in paving and curb and guttering around Post schools was approved by Post school trustees in an emergency meeting at 5 p.m. Monday for inclusion in the current summer school improvement program.

The added work is expected to be completed prior to the opening of the fall school term Monday, Aug. 31.

Supt. Bill Shiver told the board the paving and curb and guttering added will include the high school gymnasium parking lot, a large area around the cafeteria and band hall, and the parking lot on the east

side of the primary building.

He explained this is not all the paving the board has discussed but "the critical areas" which can be completed now ahead of the start of school. He said school funds for the work is available.

Knox, Gailey and Meador, Inc. of Lubbock, general contractor, for the summer improvement program, will be responsible for the paving work. The firm made the cost estimates Monday and assured Shiver the work could be completed before the start of school.

## 'It's now or never'

The "last chance" for Post and the Post schools to obtain a new and adequate auditorium is now dangling before our eyes.

But the odds? They're probably not good.

Supt. Bill Shiver told school trustees last Thursday night that the board either could spend \$500,000 on their school improvement program next year or reduce their "tax take" from local property taxes by a half million dollars for 1981.

He asked for guidance.

Apparently this caught the school board by surprise. The board did not meet in July because Shiver was recovering from a major operation and trustees had not talked about school improvements for months.

Both a school auditorium and air-conditioning, which was turned down last spring, came up and the board instructed Shiver to find out approximately what a 1,000 seat auditorium would cost.

The school administrator has been told by the school architects that a "shell" of a new auditorium would cost in the neighborhood of \$600,000 and to completely equip it with seating and stage needs would bring the final figure to around a million dollars.

When the Dispatch publisher came to Post 24 years ago, the primary auditorium he found then is the same today with one new curtain and a few coats of paint along the way.

It was inadequate the next year — 1958 — when Danny Thomas performed at Mrs. Merriweather Post's bidding from its stage.

It seats only 500, forcing local high school commencements to be held at the football stadium, its seating is inadequate for many functions, and its stage facilities

are such that performers have to run around outside the building to make an entrance from the other side of the stage.

A new auditorium would of course never pay for itself. It's not unlike the Post Community Center in that respect but Post residents today would not give up the community center without a real fight.

The odds are long for a new auditorium for several reasons. The first is that the school trustees have no more time remaining and must make a snap decision.

Another is with the property tax revaluation program this year taxpayers will think twice about a million-dollar auditorium, especially when they could get a slice off their school taxes as an alternative.

But then again, this probably is the last time around.

That auditorium could probably have been built shortly after the Danny Thomas performance for \$250,000, or \$500,000 in the 1960's. Now if the price is \$1,000,000, it is obvious that it is going to get higher year by year until it goes "out of sight" as far as Post and its future is concerned.

If there is a decision for the auditorium, it probably could be financed for cash in the next two years with a year to get the planning right before construction starts.

By building the auditorium, the school district would not be increasing the total tax burden over last year just keeping it approximately the same.

The Dispatch stands for the auditorium — and if you do too, its high time you made your position known.

If this chance is lost to build the auditorium, we don't expect to see another one.

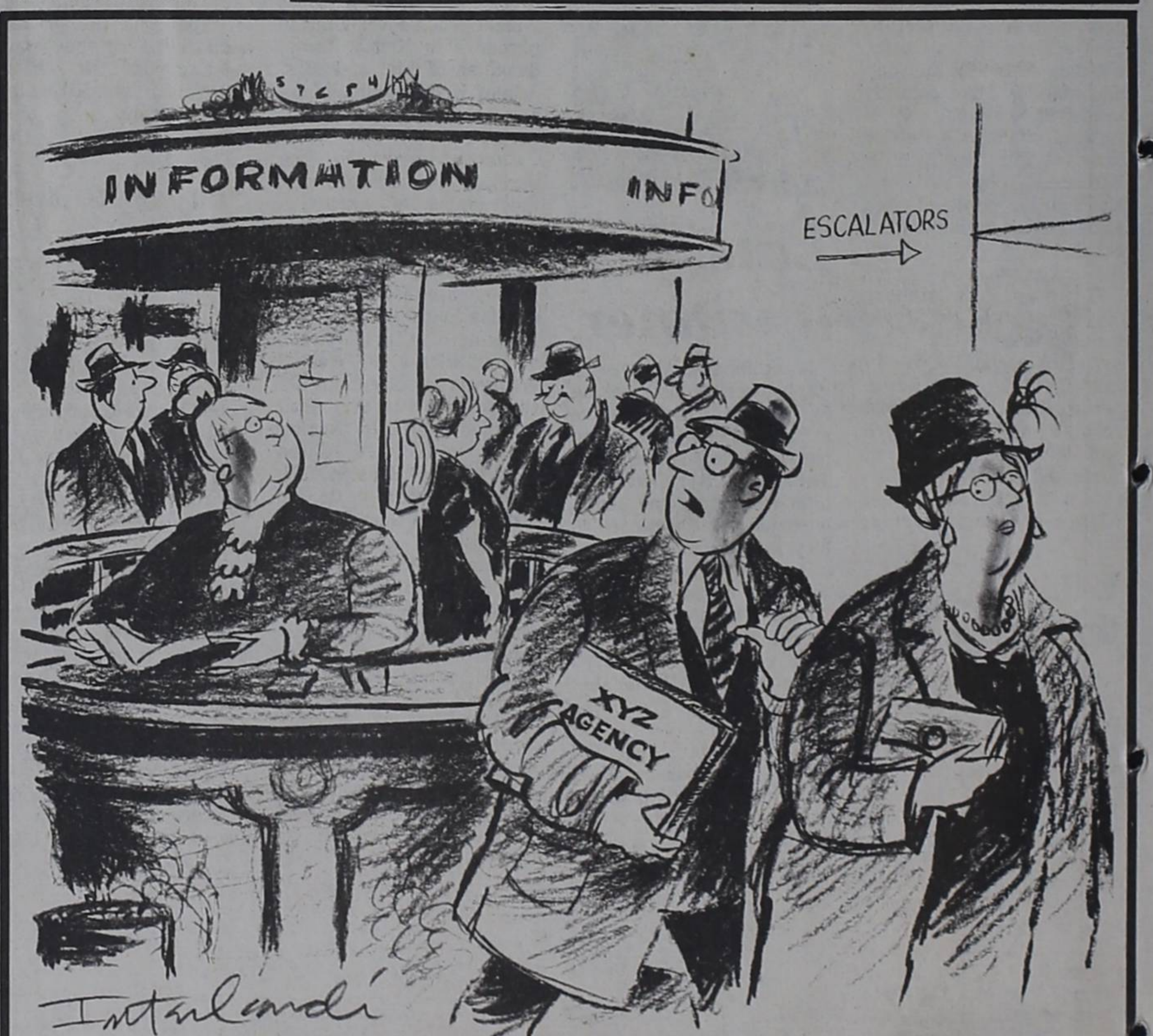

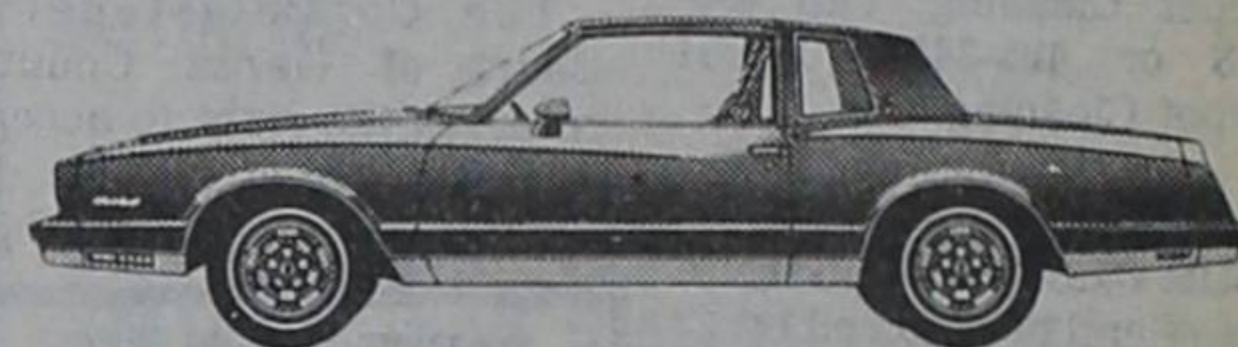

### Congressional Comment

WASHINGTON, D.C. — The 17th Congressional District of Texas sprawls from the diversified agricultural production areas of Cooke, Wise and Parker counties to the east; to the South Plains, where cotton remains king; from wheat country in the northern counties, to the dairy and peanut counties of Eastland, Erath and Comanche in the south.

Scattered throughout the area are some of the nation's most productive areas for grain sorghum, cattle and hogs, with a scattering of sheep and goats and poultry. All combine to make agriculture the largest employer, taxpayer and income producing industry in the District.

For that reason, as well as my 20-year background in the industry, I chose the Agriculture Committee as my first choice of assignments in Congress. It has historically been a troubled industry and, with passage of this year's farm legislation (in its current form) I'm sorry to say I do not believe the situation will improve rapidly.

My commitment to the agricultural industry remains

unchanged: To support legislation that will provide for increased profitability for production. In light of current budgetary restraints, I'll be the first to admit that that is a tall order. The agricultural budget in 1972 was \$5.3 billion and, before we even began cutting this year's federal spending, the agriculture budget was down to \$4.4 billion, not taking inflation into consideration at all.

That spells real trouble for all segments of the industry, all across the nation. We are cutting into muscle — not fat — in agricultural spending this year. But agriculture could not be exempted from budget cuts. All segments of society must shoulder up to the overall responsibility of getting inflation and spending under control.

Where then do we begin? We begin by recognizing first the sheer folly of an agricultural policy that makes it possible for anyone to buy agricultural products below the cost of production. Secondly, we must recognize that sound agricultural policy need not require large government expense.

Let me explain both statements by taking our current wheat crop as an example:

The average cost of production for a bushel of wheat in 1980 is \$5.02. On my own farm in Jones County, the cost was about \$4.20 per bushel and in the most efficient growing areas of the nation it is somewhere between \$3.60 and \$3.80. Yet current farm policy has resulted in the pricing of wheat the first month of this marketing year at \$3.67 per bushel.

Exporting wheat at less than the cost of production to the Soviet Union, for instance, is not only unsound economically for the farmer who grew that wheat, but since current farm policy includes target prices that require the U.S. Treasury to make up the difference between actual market price and the \$3.80 per bushel target price, it is unsound economic policy for the nation as a whole.

A sounder concept, in my opinion, would be to set loan rates at a higher level. That would encourage farmers to store their grain until prices increase, at little or no cost to the federal government, stabilizing both market supplies and, therefore, market prices.

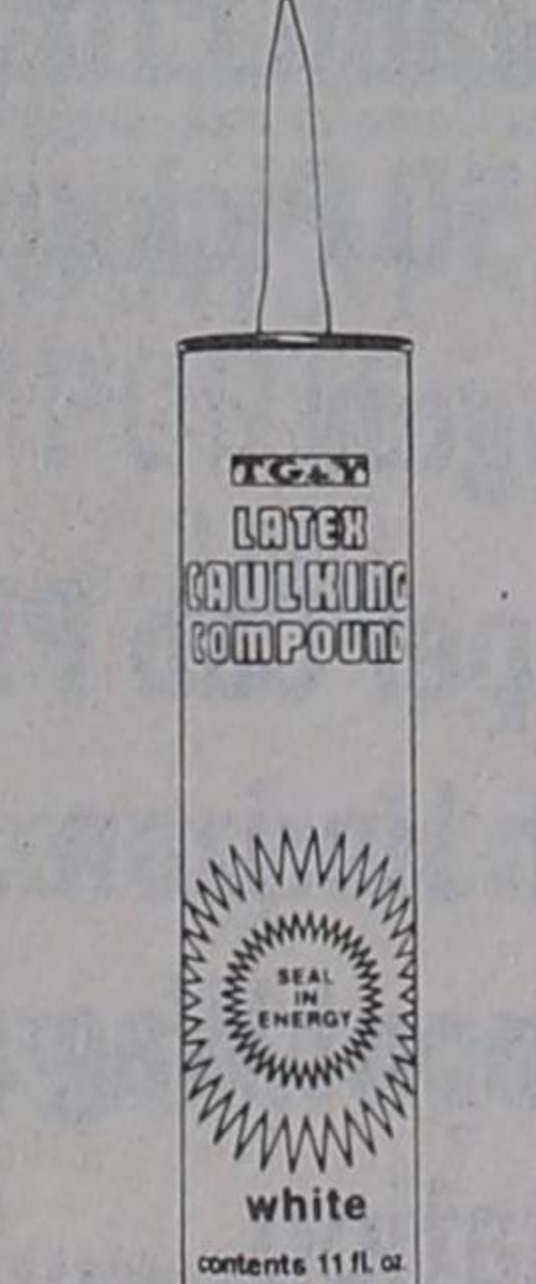

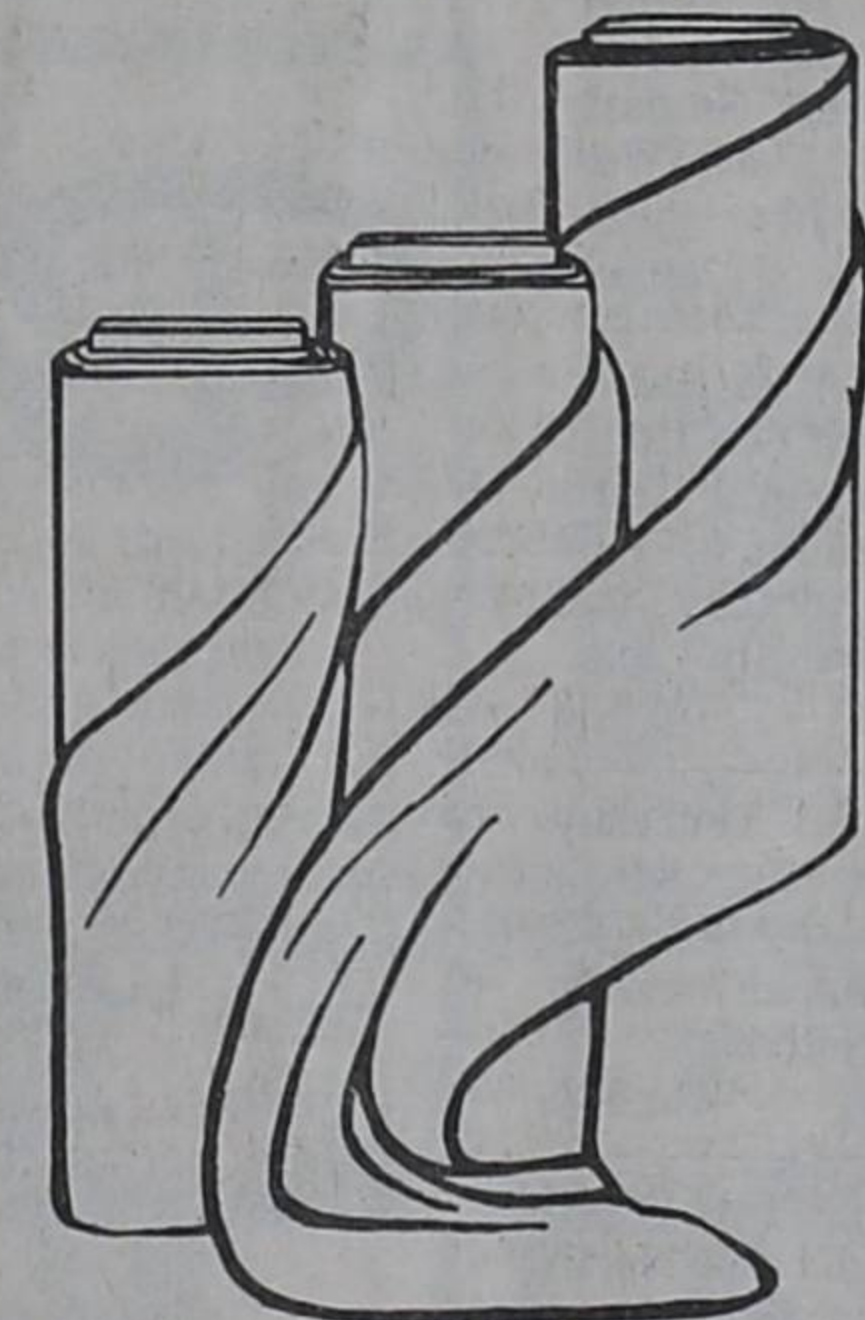

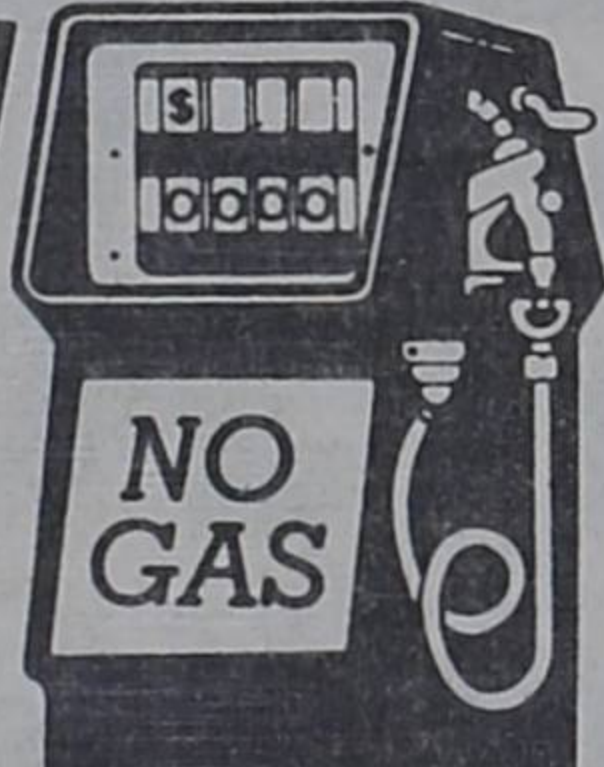

PCG policy calls for a minimum loan level at 65 percent of parity (now about 76 cents) and a retention of the current disaster program until federal crop insurance has proven itself as an acceptable substitute, Johnson points out. Both Senate and House bills now call for a minimum loan of 55 cents and both would eliminate disaster payments beginning in 1982.

Changes may or may not

be made in the House Ag Committee bill before a full vote. But the Senate Committee bill is complete, Johnson notes, and along with its failure to meet the needs of all cotton producers "it contains a separate provision aimed straight at the throats of producers on the High Plains."

That provision, tacked on by Senator Howell Heflin (D-Ala.), would require the Secretary of Agriculture each year to set cotton quality differentials at the simple one-to-one average of the previous year's loan discounts and the August-March average of spot market quotations.

previous year's loan discounts.

"If that authority is taken away from USDA," Johnson believes, "there will be no limit to the discounts that may be applied to below-base quality cottons over the next four years." The Senate Committee report says USDA's discretionary authority in the setting of premiums and discounts has frequently resulted in "artificially high loan rates for lower quality cotton. Thus, in some instances, it may be more profitable to produce lower grade cotton to be used as collateral for a Commodity Credit Corporation (CCC) loan than it is to produce cotton for market consumption."

And, the report continues, the one-to-one amendment "could result in the savings of millions of dollars each

year in CCC budget exposure in the cotton program."

"All of which every High Plains producer knows is absurd," states Johnson. "We are supplying our Senators with CCC statistics going back to 1971 which, together with recent cost of production figures and loan values, will prove that absurdity."

"And," he adds, "we have the assurance of Senators Bentsen and Tower that our arguments will be presented against the Heflin amendment from the Senate floor."

### 911 books are checked out

Library patrons checked 911 books out of the Post Public Library in July to bring circulation for 1981 to date to 5,142.

Young readers in the summer reading program slacked off their efforts a little in July, checking out 364 books to 547 adult books checked out.

Eighty nine new books were added to library shelves during the month, Librarian Pee Wee Pierce's report said, to bring 1981 acquisitions to date to 338.

That brings the library's book offerings to a total of 13,569.

One hundred and forty-three books were discarded during the month in a continuing effort to weed out old and outdated books.

Seven books were checked out on interlibrary loan in

July and 23 reference questions answered. Forty-five youngsters witnessed film strips shown in the library and 217 saw 11 films shown in the library. Thirty-five pre-school youngsters attended the five story hours.

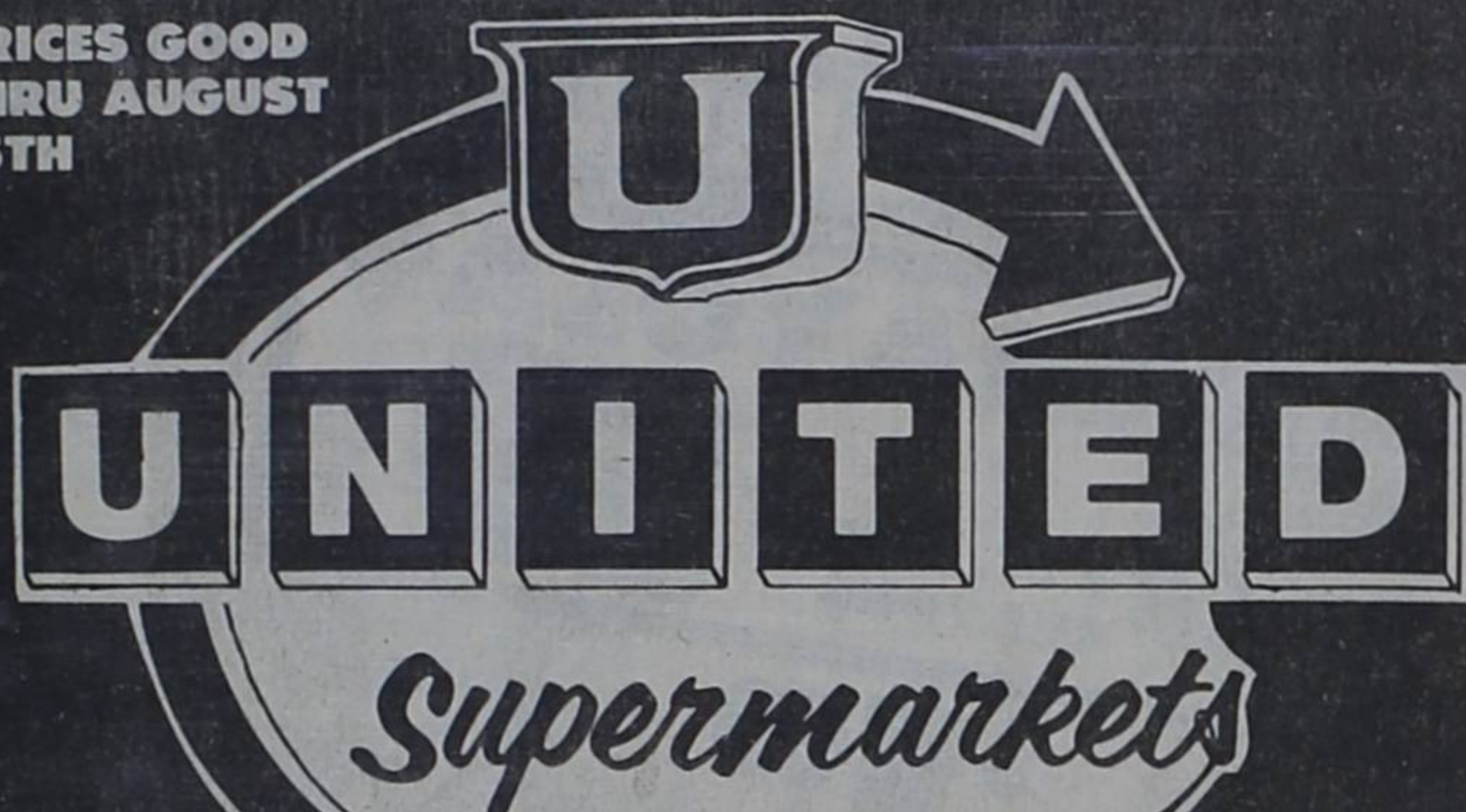



## STATE CAPITAL HIGHLIGHTS

AUSTIN—Following the adjournment of the special session Tuesday night, a question now on lips in Capitol halls is when will the Governor call a special session?

Speculation has it the Legislature will have to meet again in September or October, after the federal budget is approved, to adjust state programs receiving federal revenues.

The feds will leave it up to the states to decide where some of the money is needed.

Although this column went to press before the first special session was gavelled to a close, the political dynamics were already in full action for the three remain-

ing issues: redistricting, property tax reform, and repeal of the 10-cent ad valorem tax.

### Redistricting

Battle lines on redistricting were drawn between Democrats and Republicans, with the Democrats stalling action in the House most of last week.

After forming a coalition of some 78 votes and forcing the Speaker to send the bill back to committee for amendments, the Democrats chose to keep the bill in committee until the end of the week.

The delay was meant to avoid an ambush on the House floor, while backers

lined up support in the Senate. Their strategy was to pass out their plan or none, forcing Gov. Bill Clements to either veto the bill or let the plan stick.

Clements had threatened to veto any plan which did not create a primarily black congressional district in Dallas, but he also stated publicly that he wanted to be rid of two liberal Dallas congressmen, Democrats Jim Mattox and Martin Frost.

The governor's plan also altered the liberal districts to make them strong Republican districts.

### Democrat Counter

The Democrats countered by creating a 61 percent black district, and weakened Mattox and Frost, but drew up two districts which presumably could be won by either a Republican or a conservative Democrat. Clements said he would veto that plan, too, and the Democrats set about to give a chance to do so.

Clements, they felt, would have a hard time explaining

why he vetoed a 61 percent black district.

The Governor, for his part, doesn't have a hard time explaining anything to anybody. The subtleties of cover-up issues were lost long ago on the redistricting issue: it became grab as you can for your political party and survival.

Speaker Clayton offered a compromise congressional plan which put him squarely in the middle between the Governor and the members of his party.

Also caught in the middle were the conservative Democrats, who surprised both the liberals and the GOP. For months now the conservative Democrats have been caught in a squeeze play between Republicans and liberals, with both groups expecting them to disintegrate. But it has been the conservatives who have shown the backbone, choosing to take the heat and avoid a polarization of legislators. Whether they flourish or diminish in the coming elections, of course, remains to be seen.

A non-legislator who has played a key role in forming the coalition is Texas Democrat Party chairman Bob Slagle, who, in sports jargon, was all over the field.

### Ad Valorem Repeal

The Governor scored heavily on the ad valorem issue, putting his foot down on an attempt to lower the 10-cent tax to 3 cents. Clements wants the tax off the books.

The Senate skirted debate on the 3-cent tax when Lt. Gov. Bill Hobby upheld a point of order the bill was not germane to the Governor's call.

The ad valorem tax supplies money for building construction at 17 state colleges, and legislators are hesitant about striking the tax until alternate revenue sources are found.

### Property Tax Reform

The property tax reform bill sailed through the House, was amended slightly in the Senate, and was expected to pass the Legislature.

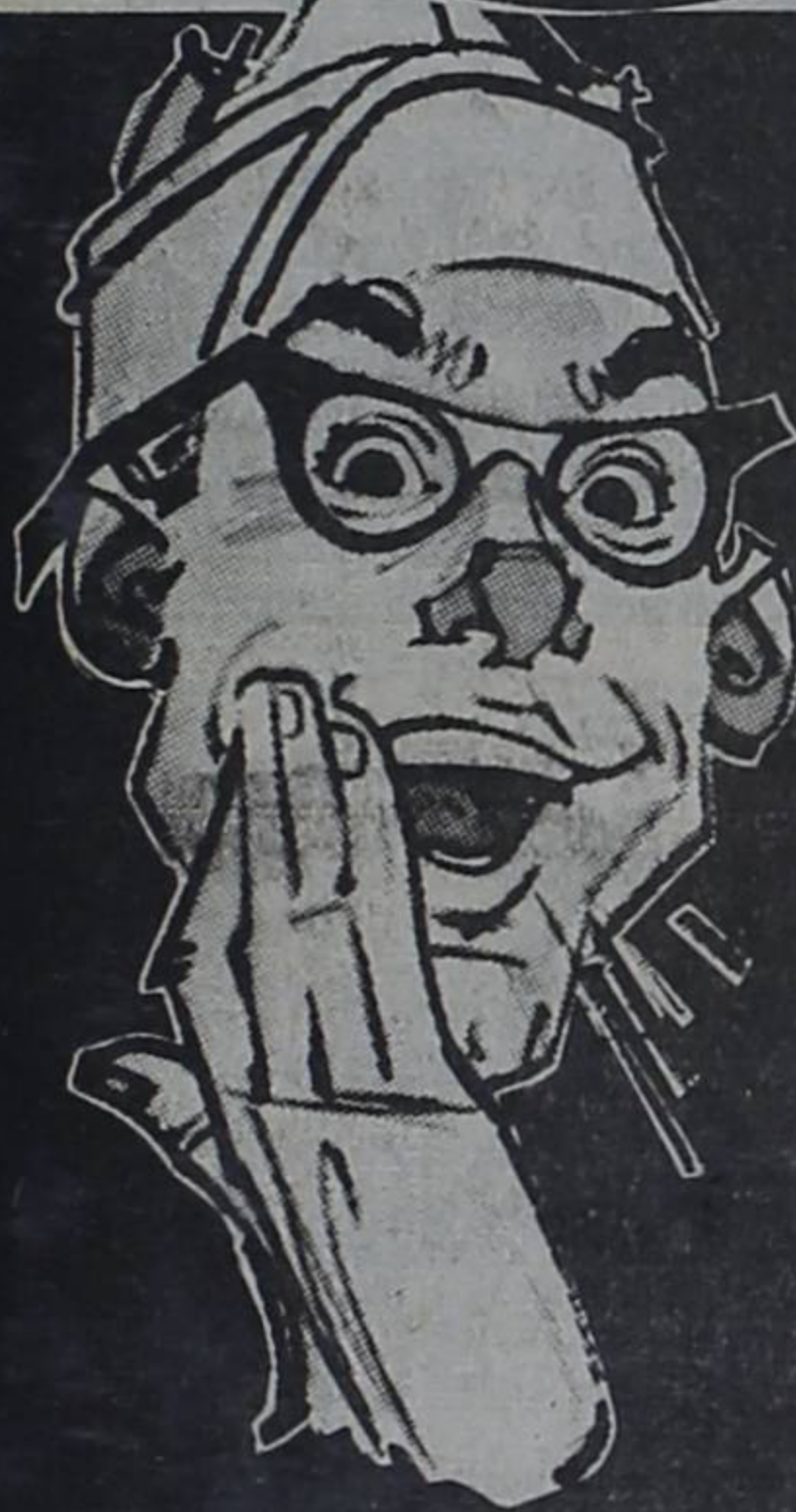

Boosted by \$5 a day the salaries for teacher substitutes. Substitutes who are certified teachers will receive \$30 per day, those with college hours \$27, and those who are only high school graduates \$25.

Supt. Shiver in recommending the boosts for the three principals proposed that each principal appear before the trustees at their September meeting and outline some goals he has set for the school year with the board reviewing whether or not the goals were accomplished at the end of the school year.

The administrator also reported to the board that according to federal court order as it applies to all the schools in the state the Post schools are moving to comply with requirements to provide bilingual education from kindergarten through high school.

Shiver said a questionnaire will be sent parents when school begins to determine how many students in the system will need such class training. He said the schools have only two teachers who can give such training but 21 others have bilingual certification.

Shiver said first a determination must be made as to the size of the bilingual problem here before an instructional program can be organized to TEA standards.

In other action, the board decided to stick with its present student code of conduct and not adopt the voluntary student code of conduct written by the Texas attorney general and the Texas Education agency. The board saw no problems with the present code.

In other actions, trustees: Accepted the resignations of Coach Greg Johansen and Miss Cathy Wallis.

Approved the contracts of Mrs. Willa Didway, Mrs. Patsy Byrd and Mrs. Jan Parker as Title I teachers, and also approved contracts for Coaches Ken Plumley and Fred Postell, both well recommended as teachers, and Miss Tammy Maxfield, a new Tech grad, as the junior high math teacher.

(Continued from Page One) and declared the most important thing about the Reagan victories in both the budget and tax cuts which he supported was the new spirit those victories have brought to America in reversing 40 years of "spend and spend" and "tax and tax."

Senator John Tower gave a 45-minute press conference following the luncheon and said he strongly favored basing America's MX missiles in "holes in the ground" because direct hits would be required to destroy them. He said firing them from planes was "too expensive and not reliable."

The Texas senator, who is chairman of the Senate Military Affairs Committee, said Russia could now destroy 90 to 95 percent of American missiles with a surprise strike, but would not try unless the risks were "acceptable."

He defined "acceptable risks" as far as the Soviets were concerned as "not losing over 15 million people and not having the Russian economy destroyed by American retaliation."

He emphasized that strong public support of United States spending is essential to demonstrate to the Soviets that America now means business.


