SELECTION OF RATLIFF JURY LAGS

HEFLIN LOSES IN TILT WITH PARTY LEADER

ROBINSON GETS VOTE OF CONFIDENCE IN SESSION TODAY

WASHINGTON, Jan. 19.—In overwhelming strength the democratic party in the senate rallied today behind its floor leader, Robinson of Arkansas, whose captaincy had been challenged after he rebuked Senator Hefflin for the Alabama's repeated attacks on the catholic church and Governor Smith.

By formal resolution, adopted in party conference with but one dissenting vote, the Democratic senators declared their "confidence" in their chief. Hefflin is absent. Hefflin himself, who issued the challenge to Robinson's leadership yesterday in an emotional passage at words as the senate has heard in many years, did not attend the conference. He said afterward that the resolution adopted is no rebuke to him, and that he had "just begun" his senate speech-making against the New York Governor and his co-religionists.

No Names Mentioned. The conference resolution did not mention Hefflin by name, but it did take direct issue with him on (Turn to Page 6, Column 3, Please)

POLICE PROBE MYSTERY CASE

FOUR IN FAMILY DIE OF "COUGH SYRUP" GIVEN BY FATHER

CLEVELAND, Ohio, Jan. 19.—While police today sought to determine the contents of a bottle of "cough medicine" which last night caused the deaths of James Potter, 45, and the three members of his family here, word came from Steubenville, Ohio, his former home, that Potter was once a prominent capitalist before he lost his fortune in oil and coal developments. The victims of the "medicine" in addition to Potter, were his wife, Lulu, 43, and their two sons, James Jr., 16, and Robert, 14. Roomers Aroused. Roomers at the house were aroused late last night when Robert and his mother ran screaming from their apartment. Forty five minutes later the entire family was dead in a hospital. "Daddy has given us some cough medicine. I can feel it coming on," Robert cried and collapsed. His mother fell beside him. Police were called and the victims were rushed to a hospital where they were pronounced dead. An indictment returned last week charged that Potter had obtained \$500 from Mrs. Ada Croffer by representing to her that a mortgage rested against a piece of property for which she was responsible.

Charges Filed On Two Accused Boys

Formal charges of robbery, with firearms, were filed by county attorney L. A. Howard against the two Lubbock high school youths with Justice of the Peace O. R. Scott, this afternoon. Bonds were to have been set a few minutes later at \$500 for one boy and \$200 for the other. The youths have confessed, officers say, to the robbery of the College Service Station, a mile southwest of the city, and taking \$20 in cash and a pistol. They were arrested late Tuesday by Sheriff H. L. Johnston and Deputy Vernice Ford following investigations of the affair.

ONE KILLED IN OHIO TORNADO

SIXTH BRIDE OF TEXAN KIDNAPED BY HER FATHER

(By Associated Press) NEW YORK, Jan. 19.—A six-foot Texan complained to police today that his father-in-law had "kidnaped" his sixth and latest bride. John Prite, who said his home was in Nacogdoches county, Texas, declared he married Mrs. Alice Kupinger, 35, of Trenton, N. J., last Wednesday, but that her father, Fred Toft, voiced objections when he learned Prite had been married five times before, and said he was coming to New York to "discuss matters."

MARSHALL MAN ACQUITTED IN SON'S SLAYING

VERDICT REACHED ON FIRST BALLOT OF JURY TODAY

(By Associated Press) MARSHALL, Jan. 19.—The Killingsworth, charged with murder in connection with the slaying of his son, Roy, near here last November, today was acquitted by a jury which deliberated only 20 minutes. As soon as the verdict had been returned, the father burst into tears, and thanked the jury for having freed him. Brushes Tears From Eyes. "God bless," he said, brushing tears from his eyes with the backs of his hands, "I want to tell you the truth—I loved my son. I didn't want to shoot him." The jury deliberated only 20 minutes. Although the case went to them before noon, they had lunch before starting deliberations at 1 o'clock, and the verdict of not guilty was reached on the first ballot. The defense plea was that the father shot in self defense. Roy, his father said on the witness stand yesterday, was "coursed down his cheeks, fired the first shot and he either 'had to shoot or be killed.'"

New Treatment For Ear Drums Shown

DALLAS, Jan. 19 (AP)—A new method of remodeling the Eustachian tube of the ear to relieve deafness was demonstrated at a free clinic here Wednesday by Dr. Curtis H. Munice, New York otologist, who operated on six cases, using only his fingers for instruments before a group of surgeons and ear specialists. One woman, who could hear an acoustometer 24 inches from her ear before the operation said afterward she could hear it ten feet away, it was announced. Many more deaf persons applied for treatment than could be accommodated. No pay cases were taken.

Anxiety Increases Over Mystery Case

ALVORD, Texas, Jan. 19 (AP)—Anxiety for Cecil King, 34, Alvord agent for the American Red cross, who has been missing since last Saturday night, continued to grow here Thursday as facts of his disappearance were broadcast by radio stations throughout the state. King, a former railroad man and well known in the southwest, drove to Wichita Falls Saturday morning on business. He was last seen by a merchant of that city shortly before 8 o'clock Saturday night when he cashed a check for a small amount and said he had an engagement to meet a "prospector for some real estate" later that night. King has a wife and four children.

MANY INJURED AND PROPERTY DAMAGE GREAT

TRAVELING SALESMAN KILLED AS COPING CRASHES AUTO

(By Associated Press) CINCINNATI, Jan. 19.—One man was killed, numerous persons injured, and buildings blown down in a tornado that swept southern Ohio today. First reports indicated the storm extended from Washington Court House near the center of the state down into the blue grass district of Kentucky. A. R. Kruger, Dayton traveling man, was killed instantly when the coping of a building was blown down on his car at Washington Court House. Heaviest damage was indicated at Cumminsville and East Hamilton, suburbs of Cincinnati, and at Hamilton, Ohio. Communications Down. Communication lines were down and definite information was lacking. Early estimates placed damage at more than \$100,000. Hospitals reported that ten persons were being treated for injuries, some serious. Two school children were reported injured at East Hamilton when the storm hit a school building. In Cincinnati several buildings were wrecked, but no one was reported injured. At East Hamilton, the Van Buren public school was damaged, but so far as is known no school children were hurt. Heaviest in Suburbs. Heaviest damage appeared to have been done in Cincinnati's northern suburbs, where houses and barns were unroofed, garages blown over and telephone and telegraph poles and trees leveled. A blinding rain storm accompanied the high wind. The rain was so heavy that for a time automobiles were at a standstill. Shortly before noon the rain abated, and the sun came out. The storm apparently jumped from here toward Louisville, where several persons were reported to have been injured and buildings damaged.

Two Seriously Hurt In Kentucky Storm

LOUISVILLE, Ky., Jan. 19 (AP)—A high wind storm today damaged a number of houses in the western part of Louisville and at Shively, 15 miles from here, seriously injured two men and caused damage estimated as high as \$100,000. L. M. Simpson's leg was broken when the twister ripped a wall from his home, a large brick structure here. Arthur Gregory's leg was broken at Shively and Mrs. Gregory was cut and bruised when their home was wrecked. Three houses on Southern Parkway here were badly damaged and numerous trees were uprooted, garages and small sheds blown down and dozens of windows smashed.

Funeral Of Tahoka Man Set For Today

The funeral of Roy Baxter, 18, of Tahoka, who died in a local sanitarium yesterday afternoon, will be held in Tahoka this afternoon with the Rix Furniture and Undertaking company in charge of the arrangements. The young man's death came as a result of only a few days' illness. He is survived by his widow and parents, Mr. and Mrs. W. B. Baxter, of Tahoka.

Youth's Leg Broken In Auto Collision

Life Preserver In Subs Demonstrated

BOSTON, Jan. 19 (AP)—A device designed to preserve life in men entrapped in sunken submarines has been demonstrated here by its inventor, L. M. Cottrell of Somerville. He permitted himself to be used in the role of "entrapped crew." He was lowered 35 feet under water to the bottom of Boston harbor in a specially constructed steel tank and within 20 minutes the diver had established communication with him. Sandwiches, water, olives and a flash light were sent to him through a hose attached to the tank by means of a coupling device.

COOLIDGE, BACK AT DESK AFTER TRIP TO CUBA, GREATLY PLEASED AT VISIT AND HOPES GOOD WILL IS ENHANCED

(By Associated Press) WASHINGTON, Jan. 19 (AP)—Greatly pleased with his reception in Havana, President Coolidge returned to his desk today in the hope that his first journey to Latin-America would result in a firmer foundation of good will among the nations of the new world. He reached Washington shortly after 7 o'clock and left his special train immediately with Mrs. Coolidge for the White House for breakfast. Secretary Kellogg said before leaving the special train that the President's trip would demonstrate the eagerness of this country to stand on an equality with other countries of the western hemisphere. The president was welcomed at union station by the Cuban charge d'affaires and other members of the embassy staff. The Charge expressed the hope that Mr. and Mrs. Coolidge had enjoyed their trip and the President replied that it had been a most pleasant experience. A light program was mapped out for Mr. Coolidge at his office today in order that he might give most of his time over to resting from his strenuous trip. His only engagement was to pose for a picture on the south lawn of the White House with delegates to the National Association of Dyers and Cleaners.

SEARCH OPENS FOR SLAYER OF STATE'S WARD

FORMER ATTENDANT AT EPILEPTIC COLONY CHARGED IN CASE

(By Associated Press) ABILENE, Jan. 19.—Search for a former attendant at the Abilene state hospital for epileptics, against whom murder charges have been filed in connection with the death of Joe Marze, aged inmate, has uncovered no clues as to his whereabouts. Marze's death, according to Dr. T. B. Bass, hospital superintendent, resulted from abdominal hemorrhages, believed to have been caused by blows. Marze made a statement the day before he died, saying he had been beaten. The missing attendant, Dr. Bass said, came to Abilene about a year ago from Van Zandt county. Marze had been an inmate of the institution since it was opened in 1897.

State Board Calls Probe Into Case

AUSTIN, Jan. 19 (AP)—Investigation of the death of Joe Marze, inmate of the state epileptic hospital at Abilene, last week, apparently fatally beaten, has been requested of the attorney general's department, R. B. Walthall, member of the board of control, said today. Dr. T. E. Bass, superintendent of the institution, discharged an attendant at the institution and filed murder charges against him as a result of the affair, Walthall said. Galloway Calhoun, assistant attorney general, probably will aid in investigation and prosecution.

No Bill Returned In Asylum Slaying

AUSTIN, Jan. 19 (AP)—The Travis county grand jury, recessing until January 5, returned no bill as the result of an investigation of the death of an idiot girl at the Texas colony for the feeble minded, three hours after she was strangled by two imbecile women inmates, last Christmas. District Attorney J. D. Moore said that obviously the imbeciles were irresponsible, and that there was no evidence of negligence on the part of any attendant or officials of the institution.

Frank P. Holland Funeral Is Today

DALLAS, Jan. 19 (AP)—Colonel Frank P. Holland, 75, publisher of Holland's Magazine and Farm and Ranch and one of the southwest's foremost benefactors, who died at his home here Wednesday, was to be buried this afternoon. Colonel Holland died of an illness resulting from a cold contracted on a hunting trip shortly before Christmas, when he was to have celebrated his golden wedding anniversary. Surviving are his widow, a daughter, Mrs. Fred A. Jones, and four sons, Frank P. Jr., R. V. J. P., and M. W. Holland, all of Dallas, and seven grandchildren.

JUDGE REFUSES TO RENEW COURT ORDER IN RATES

(By Associated Press) AUSTIN, Jan. 19.—District Judge George Calhoun refused Thursday to renew his injunction, vacated this week, against the State Railroad Commission's enforcement of an equalized 8 cent cotton rate order last summer on shipments to the Gulf coast. Houston portside cotton interests enjoined the rate, which now applies to back-from-the-water-front and interior concentrators who formerly paid 12-15 cents. Injunction was dissolved, however, on showing that the federal courts have approved the rate for interstate commerce. Houston portside interests, anxious to get the case thrashed out in court on its merits sought renewed injunction, attacking the dissolution of the first one as lacking any basis of inquiry into the "reasonableness" of the rate. While states declared legal holidays and banks and most other commercial institutions suspended business, veterans of the sixties, their sons and daughters, and school children united in ceremonies of devotion. In every state south of the Potomac there were programs of formal praise of the Confederate leader.

Original Order Of General Is Found

LOUISVILLE, Ky., Jan. 19 (AP)—The Courier-Journal today says that a signed copy of General Robert E. Lee's farewell address to his soldiers, valued at \$25,000, has been found here in possession of an attorney. The unnamed lawyer, the Courier-Journal says, has treasured the manuscript as an heirloom and recently showed it to experts of the Library of Congress who declared that it took rank as one of America's most valuable documents, fit to be preserved with the original of the Declaration of Independence and the Constitution of the United States. OBJECTIONS OF COUNSEL FOR BOTH SIDES DELAY ACTION IN CAPITAL PUNISHMENT QUIZZES

(By The Associated Press) EASTLAND, Jan. 19.—Retarded by numerous objections and trivial questions from both state and defense counsel, selection of a jury to try Marshall Ratliff here for robbery of the First National Bank at Cisco on December 23, lagged throughout the morning session today. No jurors had been selected at noon. More than an hour was consumed with the examination of six veniremen, all of whom were excused. Judge G. L. Davenport called attention to the method of questioning and urged more speed. Conscientious scruples against capital punishment led to the disqualification of the first four veniremen examined. The fifth, N. H. Munn, Nimrod farmer, was passed by the district attorney, but attorneys for Ratliff brought out that he was in Cisco on the day of the robbery. "Did you hear shots fired at the bank?" "Yes." "What did you do then?" "Nothing."

G. E. Bedford, 61, Cisco police chief, lay dead in one alley beside the bank. G. W. Carmichael, 80, another Cisco police officer, lay mortally wounded in another alley and in the bandit car L. E. Davis, of Brown, Oklahoma, bled from wounds which caused his death in jail at Fort Worth the following day. Money Abandoned. Davis and the money were abandoned by the fugitives when their efforts to steal another car failed. Ratliff was shot down by a posse and captured near South Bend, two counties away. Four days later, he and his two surviving companions, Henry Helms and Robert Hill, desperate from hunger and weak from wounds virtually surrendered a week after holdup in the town of Graham. All three face charges of robbery with firearms and of murder. Hill already has been arraigned on the bank robbery charge and has pleaded guilty. Ratliff, arraigned Monday, when an unsuccessful attempt to obtain a change started by his attorneys, pleaded not guilty of robbery.

Sleeping Patient Is Reported Better

WICHITA, Kan., Jan. 19 (AP)—C. J. Warner, who has been sleeping for more than 72 hours except for brief periods when he has roused himself long enough to take food, today appeared to be rallying from his stupor. It was reported at the hospital here where he was taken Tuesday when persons at his rooming house could not wake him. Warner resumed his slumber today after rousing long enough to take a little liquid nourishment.

Moody Will Seek Re-Election, Claim

AUSTIN, Jan. 19 (AP)—Re-election will be Governor Moody's 1928 political ambition, it appeared reasonably certain today. Representative A. P. C. Petch, Fredericksburg, said that Mr. Moody would be a candidate for his present office, Petch, like State Senator A. E. Wood of Granger who made a similar statement recently, is one of the Governor's closest personal and political friends.

Negro Sentenced On Assault Count

DALLAS, Jan. 19 (AP)—Tom Williams, negro, who several weeks ago posed as a woman and obtained a job as a servant only to be discovered as a man as he was about to perpetrate an assault on a white woman, was fined \$1,000 and sentenced to two years in jail here today for aggravated assault.

Woman Given Ten Years In Slaying

ST. LOUIS, Jan. 19 (AP)—Mrs. Ana Eason, 31 year old housewife, was found guilty today of second degree murder and sentenced to ten years in the penitentiary for killing her husband with a butcher knife. Mrs. Eason repudiated a purported confession and pleaded self-defense.

Differential On Orient Continued

AUSTIN, Jan. 19 (AP)—Differential rates on West Texas live stock shipments on the Kansas City, Mexico and Orient railroad were extended one year from midnight, January 31, original expiration date, by order of the state railroad commission Thursday. This means that the Orient, which has been fighting to stave off bankruptcy, will enjoy rates giving it seven thousand dollars more than ordinary rates would, for another year. The application for extension was approved by the Live Stock Traffic association, Texas and Southwestern Cattle Raisers association and the Sheep and Goat Raisers association of Texas.

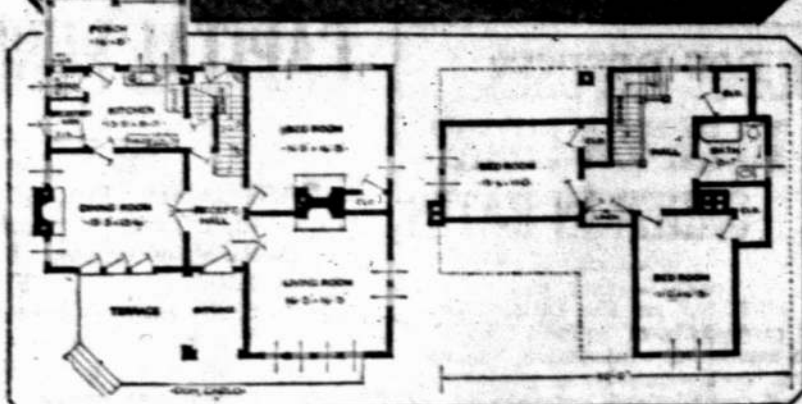

NEW VETERANS FORM NUCLEUS OF GOOD TEAM

FIELD INTACT BUT OTHERS SHIFTED TO QUINN'S JUDGMENT

(By Associated Press) BOSTON, Jan. 19.—A winter of house-cleaning by President Bob Quinn of the Boston Red Sox leaves Manager Bill Carrigan with the dusty corners of the new year clean and a host of new players, mostly young and of no more than average promise, ready to hustle the remaining veterans in the 1928 American league pennant race.

Three pitchers, three catchers and the entire 1927 outfield with the exception of Ira Flagstead, have passed out of the picture in a series of trades, swaps, purchases and releases which have left President Quinn's off-season activities.

A veteran infield intact has been held intact and is expected to prove a foundation for Carrigan to build on in his second "comeback" year along the managerial trail.

Phil Todd at first base, Bill Regan at second, Russell Rawlings at third and Rogell Jack Rothrock and Charles "Buddy" Myer as shortstop or utility points on the base paths are again available.

Rogell plays either second base or third, Myer at short or in the outfield and Rothrock can handle any infield assignment, exclusive of battery work.

The two outstanding infield recruits are Joseph Cicero, a 16-year-old youth who batted for 330 in the Eastern Maryland circuit after leaving school for the diamond, and Paul Hinson, a third baseman purchased from Joplin, Mo. Cicero's mother signed his contract for him.

Trades In Outfield The departure of Walter Shaner, Cleo Carlyle and Frank Welch for the minors leaves Ira Flagstead and Arlie Tuttle as former Ohio state stars, the only prominent patrolmen of the other gardens who graced the roster last year.

The biggest gap was plugged promptly by the purchase of Ken Williams from St. Louis, followed by the acquisition of three promising minor leaguers, Doug Faye, a slugging left hander from Nashville, and G. H. Lepp and Denny Williams, both from Mobile. Lepp had hit 372, while Williams another slugging left hander, is exceptionally fast and hit 330 last year.

The pitching casualties of the winter season included Tony Weiser, Delmar Lundgren and Fred Wingfield. The outstanding replacement seems to be Hebb Bradley, who was farmed to the Waterbury Eastern league club, last year and was recalled in time to hurl several excellent games. Two more ex-Mobile players have been obtained in Ed Morris and Merrill Stelemier. Morris won 15 games with a tail-end club and finished more than 40 contests as a relief hurler. Stelemier is left handed.

Cliff Garriss of the Texas Valley league is another recruit, while the remaining veterans are Slim Harris, Charlie Ruffing, Danny MacFarlan, Jack Russell and Hal Witte.

Catching Department In the catching department, Fred Hoffmann weathered the storm that sent Moore to Mobile. Knox to Nashville and Grover Hartley to Cleveland on waivers. The new recruits added are Charlie Berry from Dallas, John Heving from the Toledo American association, Ed Debery of Holy Cross and Ed Connolly, a New York state semi-pro. TUNNEY MUST WATCH LOUGHRAN, SAYS BRITTON, WHO WOULDN'T BET HIS KALE ON GENE IF TWO BOYS MET

BY HENRY L. FARRELL NEA Service Sports Writer NEW YORK, Jan. 19.—You may get ready to laugh this off. In fact, before it is a laughing matter, chuckles, jeers and assorted brands of razberries can be distinguished in the making in the vicinity of the Tunney estate.

As a sort of introduction it might be mentioned for the sake of formality that Gene Tunney is the heavy champion of the world and that even his critics have to admit that he has an edge on the other current heavyweights.

Under the circumstances any discussion of the heavyweight situation involves matching of opinions as to how long Tunney will be able to hold the title and who will get it from him.

Such a discussion was held recently. Present are nationally known referees of recent years, two or three ranking managers and some well-known fighters.

If there was anything decided in the discussion it was that Tunney would have to age down to his challengers as Dempsey did and that the greatest is a clean living man and hard worker like Tunney might take considerable time.

"What do you think of it, Jack?" was asked of one of the listeners who, as is characteristic with him, hadn't said a word.

"Tunney's better than any of those fellows they're talking about now," Britton answered. "There's only one fighter I wouldn't bet against to beat Tunney—Tommy Loughran."

It might be interposed here that while fighters are notoriously poor as judges of fights and other fighters, Britton is one of the best pickers in the country. He has been right on the winner of every big fight for years and his opinion is respected by some of the biggest operators in the game.

When Britton named Loughran, the light heavyweight champion, as the one fighter he would not bet against in a match with Tunney, there were skeptical glances turned in his direction.

"You're crazy," Dan Morgan, his old manager, said. "Remember you said the same thing in Philadelphia. You went for plenty and I picked up quite a little."

"Here's the way I figure it," Britton went on. "I know how good Tunney is, how he lives and takes care of himself and how he believes in himself. But he's going right now. He can't help it. He goes to get in the same hole that Dempsey was. He won't be able to fight to keep in form. I know from experience that you have 40, keep fighting to keep going. I've been going longer than any of them and I think I ought to know."

"Lots of times I laid off fighting during the summer. I kept in shape, though, by walking, rowing, swimming, handball and other forms of exercise and kept down my weight. But when I went in for the winter work and started fighting I found that it never took me less than two months to get just right. And when I didn't have those stop them and take them like those big fellows, I could take my time working up to big bouts, but those big fellows have to be just right for that one fight."

"They say that Loughran can't hit, but didn't they say the same about Tunney? They say that Loughran is only a fair light heavy weight champion and they said the same thing about Tunney. They say that Loughran has had a lot of bad fights, but didn't they razz Tunney?"

"You may find in looking them over that Loughran is following the same path that Tunney had to follow. A hard road to get recognition. Tunney had to build himself up physically and fight to get a reputation, and Loughran is having to do the same thing.

"They're both got all the confidence in the world, they're both clean living, but Tunney will be forced by circumstances to lay up and Loughran can keep going and getting better and better.

"You may think that Loughran is a second-rate fighter, but I'll tell you that a second-rate fighter who has been fighting right along is a dangerous man for any champion who has been out a long time and has to stop in and fight one great fight. I thought, and still think, that Dempsey was the greatest of the heavyweight champions that I have seen, and I have seen a lot of them in my time. I thought that Tunney was only an ordinary good fighter. But I bet on Tunney to beat Dempsey at Philadelphia and I was ashamed to bet on Tunney in Chicago. I bet on Tunney in Philadelphia because Dempsey had been out of the ring too long. I backed my judgment against the knowledge that Dempsey could knock out anyone with one or two punches and against my knowledge that Tunney has one bad fall—he doesn't duck, and any one that holds his head up for Dempsey is taking a terrible chance.

"Before the fight in Philadelphia I saw Bat Levinsky. He used to be in Morgan's string with me and we are old friends. He's also a smart bettor. He asked me who I liked and I told him Tunney and he told me he was taking all the long-price money he could get the same way. I told him I wasn't betting as much as he was and cautioned him about the way Tunney stood up and the way Dempsey

FIGHT BOSS IS COMING SOUTH TO AID PLANS

TUNNEY CONFERENCE TO PICK "LOGICAL" MAN SCHEDULED

(By Associated Press) NEW YORK, Jan. 19.—Tex Rickard was on his way south today to pick a "logical" opponent for Gene Tunney.

The promoter left New York last night for Miami, Fla. where he plans to spend four weeks with the heavyweight champion, at golf and conferences.

Soon to Post Option On Feb. 1 Rickard will post \$100,000 to bind an option on Tunney's services for 1928 and around the same date he thinks he will have decided who, among the present crop of contenders, will get the next opportunity to attempt to knock the crown from the big marine's head.

Rickard caught his train last night immediately after a long and fruitless conference with the managers of Jack Delaney and Tom Horn, whom he hoped to match in a 15-round elimination bout at Madison Square Garden March 1. Delaney was willing, but Charley Harvey, manager of the New Zealander, admitted he wasn't so keen about it and accompanied this expression of opinion with a demand for \$2-2 per cent of the gate. That broke up the conference.

Rickard left the solution of the tangled situation to John M. Chaspin, "czar" of the six-day bicycle race game, and newly elected assistant general manager of the Garden.

Efforts now are to be made to match Jack Sharkey, who lost some prestige in his draw battle with Henry last week, against Johnny Rizzo, of Cleveland. The latter makes a specialty of taking the "logic out of logical" contenders. This match, if it goes through, will be a 15-round affair at the Garden March 12.

Paulino Uzcudun, Rickard disclosed, no longer is being considered in the plans for developing an outstanding challenger for the heavyweight title.

Heflin Renews His Attack In Senate

WASHINGTON, Jan. 19 (AP)—Undeterred by the action of senate Democrats in voting confidence in the leadership of Senator Robinson of Arkansas, Senator Heflin, of Alabama, gained the senate floor today and renewed his attack on the party chief.

Conference on Marine
Senator Heflin said that on last Tuesday Senator Robinson told him there might be a conference on the merchant marine.

"I thought that was going to be taken up," he explained, referring to today's Democratic conference. "I was merely expressing my own opinion yesterday about Senator Robinson. I thought his conduct was strange, unwarranted, inexcusable and intemperate."

"I didn't expect the conference, however, to remove him," Heflin said, referring to Robinson. "I wonder how many senators knew he was going to bring up the question of his leadership today?"

"Everyone outside of her has told me they thought Senator Robinson's attack on me was outrageous and uncalled for and I agreed with them."

"This question was taken up in my absence at the whitewash resolution was prepared."

"I am looking now to see in the press that I was rebuked by the party conference today—in the bad part of the press."

Smith Declines To Comment On Fuss
ALBANY, N. Y., Jan. 18 (AP)—Governor Al Smith has followed "with interest" the accounts of yesterday's clash in the United States senate between Senators Heflin of Alabama and Robinson of Arkansas regarding his possible candidacy for the Democratic presidential nomination.

At a press conference in the executive offices today, the Governor informed the information that "I have read the accounts from Washington with interest", but when asked for comment, he declined to amplify the brief statement.

Party Leadership At Issue In Meet
WASHINGTON, Jan. 19 (AP)—The senate Democratic leadership of Senator Robinson of Arkansas was at issue today, forced before a party caucus by a bitter clash between Robinson and Senator Heflin of Alabama, involving Catholicism.

The caucus was called by Robinson himself when his leadership challenged by the Alabaman after Heflin had been sharply rebuked by his chief for his repeated attacks upon the Roman Catholic church, its "political machine," Governor Al Smith and Tammany Hall.

Approval At Stake
As drawn by the two senators in a contest of nearly three hours before attentive colleagues and spectators, the issue before the Democrats was whether they approve the steersmanship of Robinson and his opposition to Heflin's anti-Catholic tirades, or support Heflin.

Beginning with Heflin's criticism of William Randolph Hearst for his publication of the Mexican slush fund documents, the drama moved to its startling climax after the Alabaman had demanded Robinson's removal from the committee which investigated the scandal. Robinson quickly met that challenge with a request that the senate vote at once on the question of his removal, but Heflin objected.

Heflin had attributed publication of the purported Mexican documents, naming him and three other senators as slush fund beneficiaries to a Roman Catholic church conspiracy against him. His demand for Robinson's recall from the committee followed the latter's declaration, supported by other committee members, that the Roman Catholic church had nothing to do with the documents.

Attack Denounced
Robinson then denounced Heflin's attack on the Catholic church and Gov. Smith, to which the Alabaman retorted:

"The Senator from Arkansas can not remain leader of the Democrats and fight the Roman Catholic's battle every time it is raised in this body without some expression from a constitutional Democrat."

"Whenever the Senator from Alabama can determine who shall be the leader of the Democratic party in the senate of the United States," Robinson replied. "That party can get somebody else than myself to lead it here."

"Well," Heflin countered. "You have my consent to do that now." Heflin held the floor for more than two hours with his criticism of Hearst before drawing the fire of Robinson when he turned his guns anew on the Catholics and Gov. Smith, attacking the "Pope of Rome" and Al Smith. Heflin warned Democrats not to nominate the New York Governor for President. If Smith is nominated, he said, "The Republicans can defeat him with anybody by from fifteen to twenty million votes."

Know Political Beliefs
"The American people," he added, "knowing what the Roman Catholic political machine is doing, are not going to put him in the White House just now. Any leader in the South who supports Al Smith will never come back to the capitol."

Senator Robinson took Heflin to task for his frequent outbursts against the Catholics and declared that "he does his country no service who lights the torch or sounds the cry of religious intolerance and persecution." He charged that "with peculiarly bad taste, without justification in the conscience of a single one of his colleagues," the Senator from Alabama has lugged into this debate the name of prospective presidential candidates.

Robinson declared that he had so often heard Heflin "denounce

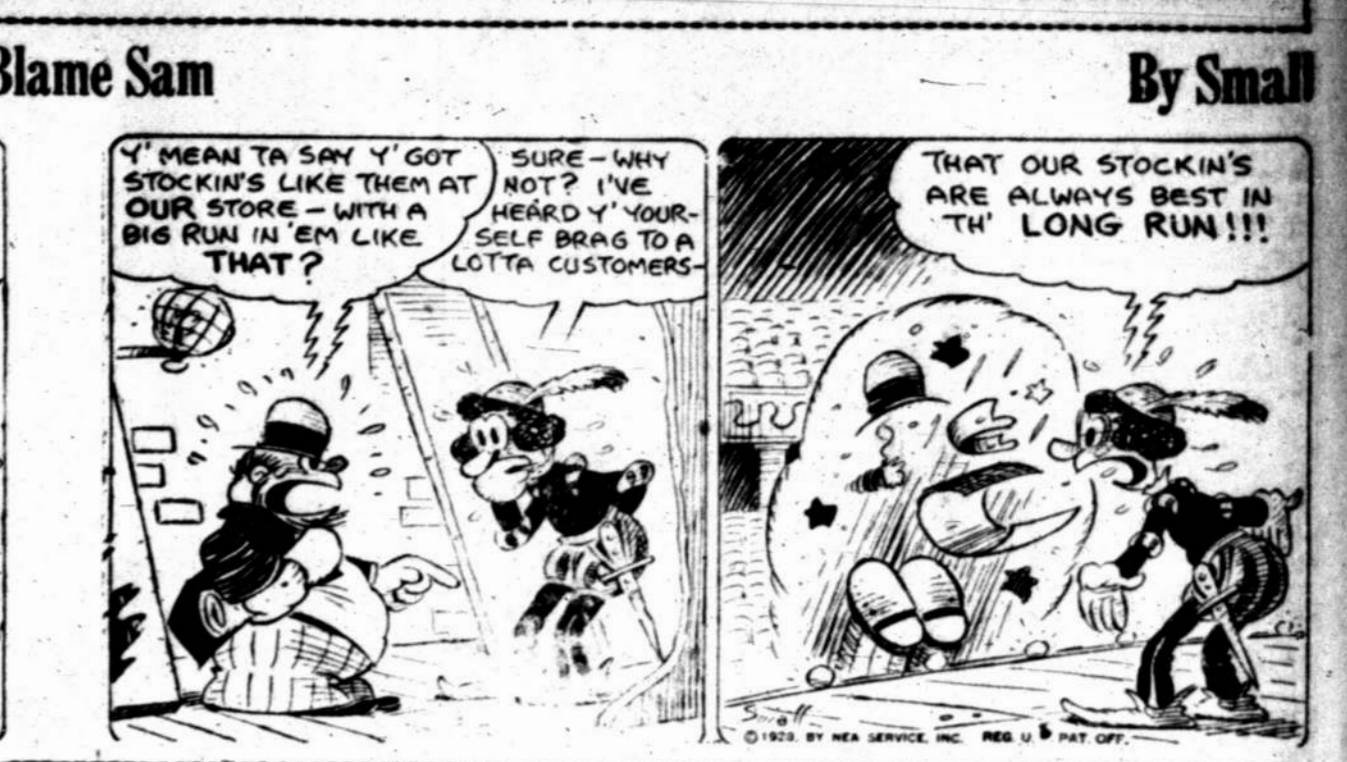

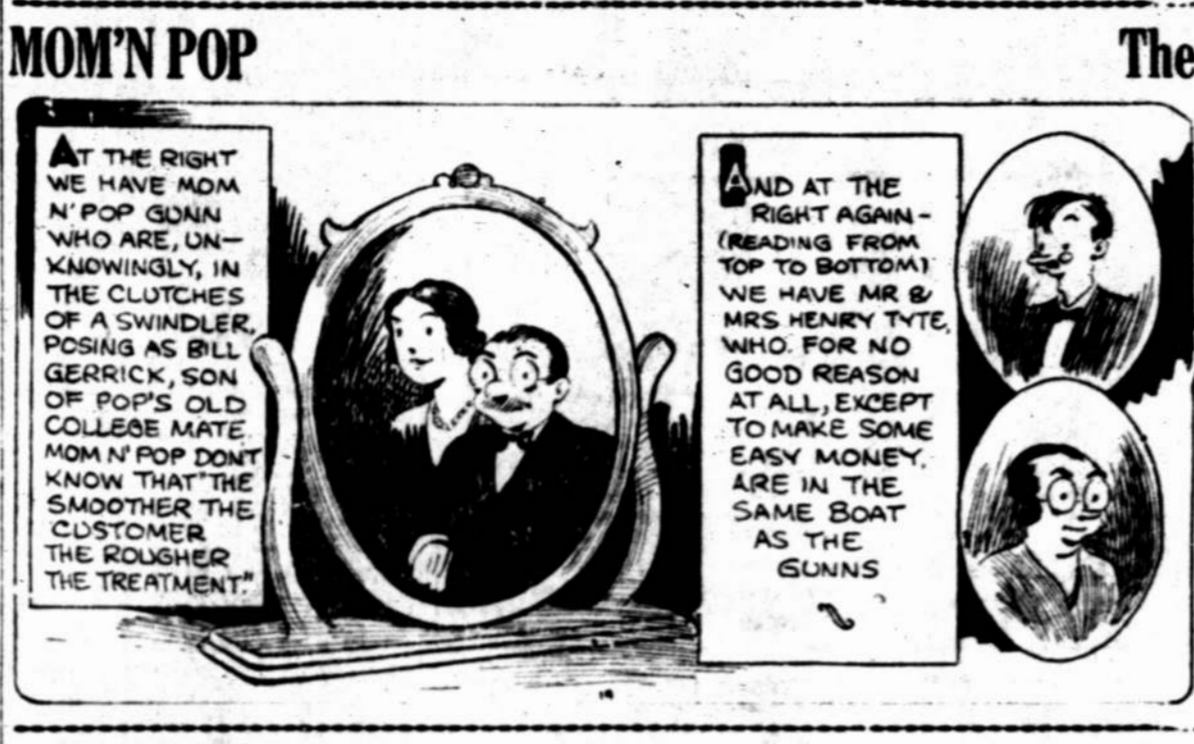

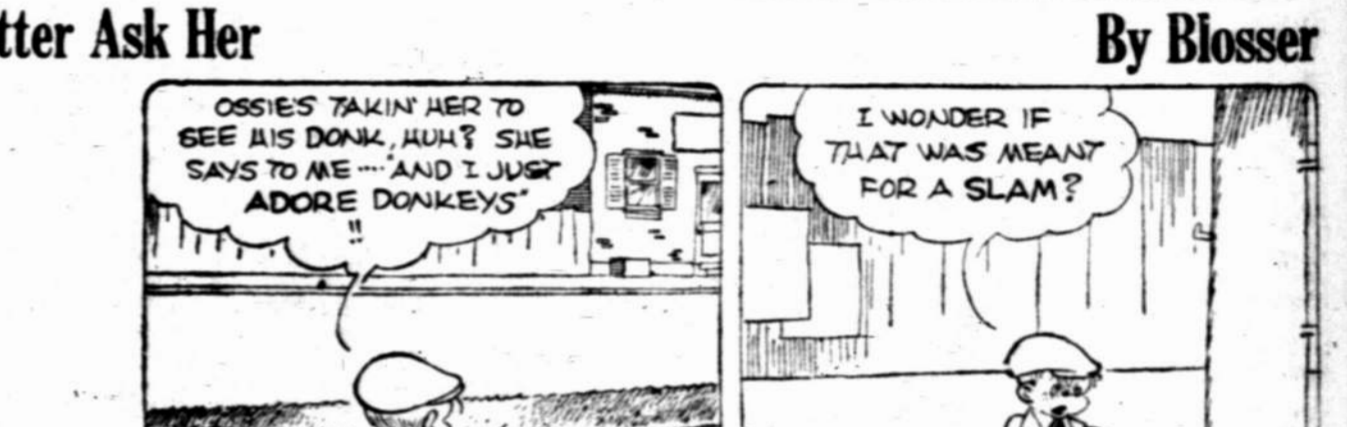

PRESS ECHOES FOREIGN VIEWS ON CUBAN TALK

COOLIDGE SPEECH IS RAPPED, DEFENDED IN MANY LANDS

Echoing the apparent sentiment of foreign government toward the pronouncement of President Coolidge at the opening of the Pan-American congress at Havana Monday, when he stressed equity and justice as the only solution to world problems, foreign press generally has voiced opposition to the Coolidge plan, but more from a standpoint of personalities than from official government scope, it is revealed in Associated Press dispatches today.

Mexico, Germany and Uruguay attack the speech of Mr. Coolidge as not in keeping with the apparent policy of the government in Latin America, the latter going so far as to compare the speaker with the former German emperor at the height of the latter's imperialistic dreams. Mr. Coolidge, however, finds a defender in Peru, where his address is pointed to as a "serene and simple discourse of the defender of American democracy."

Mexico Says Talk Is Inconsistent

MEXICO CITY, Jan. 19 (AP).—Universal in an editorial today said President Coolidge's address at Havana was lost in a sea of misty and sentimental inconsistencies and abounded in commonplaces and contradictions with facts.

The paper asserted that if Coolidge's speech was to be used for the interpretation of future international relations on this hemisphere the meaning of the words such as liberty, law, defense and friendship would be alarming for the weak American nations whose only protection according to Coolidge is found in a vague law by which the mighty are entitled to pay closer attention to the spirit rather than the text.

Nicaraguan Fuss Cited In Germany

BERLIN, Jan. 19 (AP).—Deutsche Allgemeine Zeitung commenting on the Pan-American conference, ironically cites the United States interference in Nicaragua as a patent illustration of President Coolidge's assertion that the United States solves difficulties between American states without recourse to force. Coolidge's speech leaves no doubt, the paper says, that the Monroe Doctrine precedes the League of Nations, even though most Ameri-

can states are members of the league. Nevertheless, the paper declares, the United States never can and never will be an unconcerned spectator to European events.

Defender Is Found In Paper In Peru

LIMA, Peru, Jan. 19 (AP).—In contrast to the criticism heard in some Latin American newspapers about President Coolidge's speech opening the Pan-American conference in Havana, La Prensa, the official government organ, today had nothing but praise for the "serene and simple discourse of the defender of American democracy."

Comparison Drawn With Kaiser Bill

MONTEVIDEO, Uruguay, Jan. 19 (AP).—La Plata, daily newspaper, in an editorial on President Coolidge's speech at Havana, compared the President with Wilhelm Hohenzollern, former German kaiser, at the time of the latter's imperialistic dreams.

The editorial terms the voyage of Coolidge to Havana "futile," calls his speech at the opening of the conference "largely unsubstantial," and points to the display of force accompanying the visit.

Tax Suit Ouster Move Is Defeated

AUSTIN, Jan. 19 (AP).—Attempts of Guy Bonham, Jackson county attorney, to oust the attorney general's department from tax suits originating in his jurisdiction, apparently failed today. The supreme court denied Bonham's plea for permission to file mandamus proceedings against District Judge J. M. Green to force Green to make Bonham sole prosecutor of the cases.

Landing Field On Building Planned

SLAYER TAKES IRE OF COURT TO PEN'S CELL

JUDGE REGRETS HE IS UNABLE TO GIVE HIM DEATH PENALTY

(By Associated Press) FLINT, Mich., Jan. 19.—A judge's vigorously expressed regret that he could not, under the law, impose a death sentence followed Adolph Hotelling today on his journey to a life's cell at the Marquette state prison.

Solitary confinement at hard labor for the rest of his life was the punishment Circuit Judge Fred M. Brennan decreed for Hotelling as the utmost penalty the state could exact for the kidnapping, slaying and mutilation of five-year-old Dorothy Schneider.

Only few minutes used in the trial and sentencing took place yesterday after Hotelling had been spirited into the city from the state reformatory at Ionia. The proceedings required only a few minutes and Hotelling was immediately started on his way to Marquette by automobile, as a precaution against mob violence.

"You appear to have no regrets," said Judge Brennan in passing sentence, after the defendant had admitted details of the assault and slaying without show of emotion.

"The details as shown by this confession and the proof convince me that we should have capital punishment in this state.

"The sentence of this court is that you be confined in the Marquette branch prison in solitary confinement at hard labor for the balance of your life."

Judge Repeats Verdict "The prisoner made no response and the judge shouted: "Hard labor, in solitary confinement, for the rest of your life! Do you understand?"

The slayer nodded his head in acknowledgment and the trial was over. As the stolid church deacon was brought into the court room, Leslie Schneider, father of the child-victim, sprang from his seat and struck

the man squarely in the face. The room was thrown into an uproar, but quiet was soon restored and Schneider was taken from the room.

Secretly Jailed in Saginaw From Flint, Hotelling was taken to Saginaw and locked up. Early today prisoner and guards entrained for Marquette. So secret were the entire proceedings that residents of Saginaw were not aware that the slayer had been harbored there until after the party had left.

During the trip to Saginaw Hotelling alternately broke into fits of praying and weeping.

"How could I do it," he repeated over and over again. Frequently he referred to his own daughter, Louise.

"How I love her," he said. Officers guarded him closely to prevent a suicide attempt.
