## LAW TO PUNISH WITNESSES FAILS IN HOUSE

### EASTLAND COOKING SCHOOL DRAWS WOMEN FROM COUNTY

### EVANGELIST WITNESSES ARE THREATENED

#### MORE EVIDENCE AGAINST WOMAN IS INTRODUCED

Action Is Taken To Protect Those Who Will Testify

LOS ANGELES, Sept. 28.—Further evidence of Aimee Semple McPherson's alleged trial with K. G. Ormiston, "radio man," at Carmel-by-the-Sea was to be introduced by the state today at the hearing of the evangelist on charges of perjury in connection with her kidnapping story.

District Attorney Asa Keyes summoned a number of witnesses "to elicit" the identification of the passenger as the woman who shared the Carmel bungalow with Ormiston shortly after her disappearance, and while she was being mourned by her followers as "dead."

Among the witnesses to be heard today are Mr. and Mrs. H. C. Benedict, owners of the "love cottage"; William Mack, laundryman, and Lawrence Leidig, a grocer.

Asserting that his witnesses in the case were being threatened by mysterious letters, District Attorney Asa Keyes ordered their removal today to secret hiding places.

Score in Attendance.  
More than a score of witnesses from Carmel-by-the-Sea and other cities brought here for hearing of Mrs. McPherson and her mother on charges of conspiracy to obstruct justice were affected by the order.

Action was taken on the reception of a letter by Collins, a garage proprietor at Salinas, Calif., an important state's witness, who claimed he saw the evangelist leaving in an automobile with a man shortly after she disappeared from Ocean Park last May.

Woodcutter on Stand.  
Ernest Renker, Carmel woodcutter, took the stand for cross-examination when the hearing was resumed today.

Renker declared he was positive that Mrs. McPherson was the woman he saw with Ormiston, when he delivered a load of wood at the Carmel "love cottage."

Houston Officers Hunt Ormiston

HOUSTON, Sept. 28.—Kenneth G. Ormiston, the missing radio operator, wanted in connection with the investigation into Aimee Semple McPherson's kidnapping story, was being sought in Houston today. Officers declared that they have "reliable" information that a man resembling Ormiston has been seen in Houston.

The police continued their search, which they admitted had been under way for several days.

Ormiston is alleged to have been in the cottage at Carmel-by-the-Sea when the evangelist was missing in May.

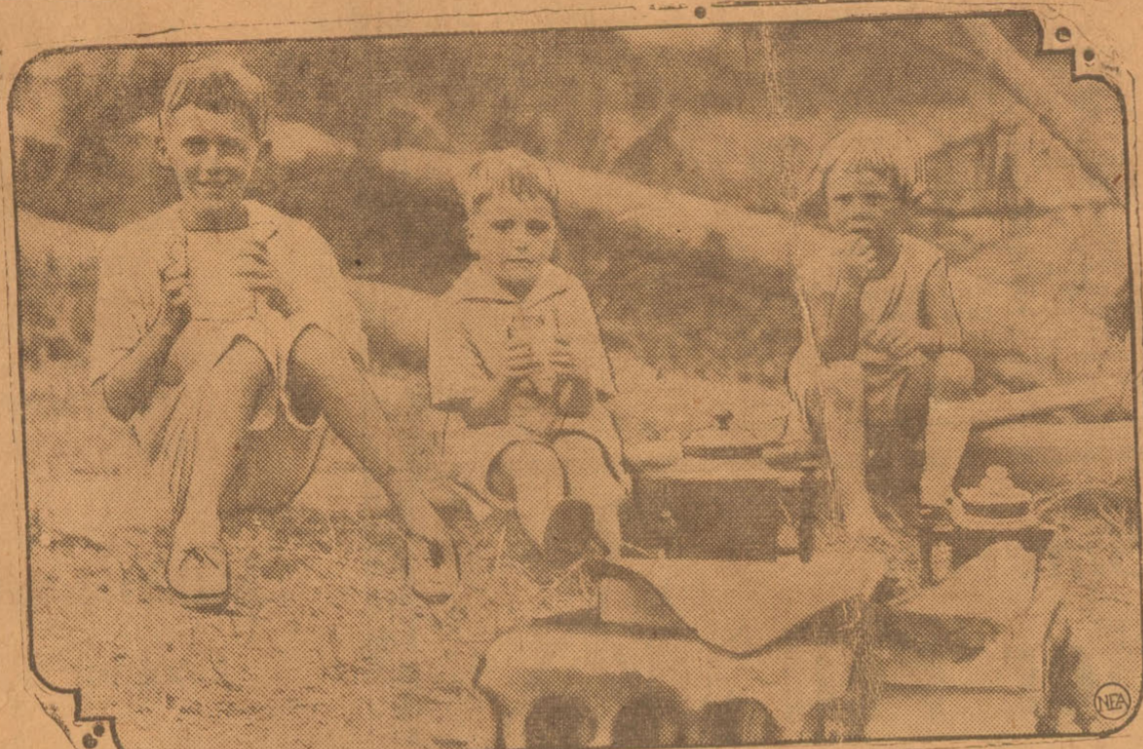

#### FAINT TAPPINGS REVIVES HOPES SAVING MINERS

IRONWOOD, Mich., Sept. 28.—With their hopes revived by faint tapping far down in the bosom of the earth, a fresh rescue crew set to work today in an effort to reach the 43 miners entombed in the George Pabst iron mine.

The tappings were heard by Fred Moakey who succeeded in worming his way down into the workings and tapped on an iron pipe which leads into the eighth level, where the men are believed to be trapped. His taps were answered by eight faint taps and then by eight more taps.

This was taken to be a signal to the rescuers that they are trapped on the eighth level and a certain sign that some of them are alive. Despite this faint hope, it was admitted, it will require at least three days to dig to the eighth level, unless the miners make considerable headway in their own efforts to dig themselves out of their trap. They may be forced to endure some great hardships before they are rescued.

They have been trapped in the mine since last Friday. Oliver Mining company announced today that they hope to reach the 43 entombed men by 8 o'clock tonight.

Continued ramming of the wall of rock which is resisting the drill will reveal whether any of the men have survived the horrors of 96 hours without food, little illumination and no water.

Calculations revealed that in a few hours the drill will break through to the eighth level near where the miners are believed to be entombed.

#### Charlie Basham Murder Trial Is Set Wednesday

The case of the State of Texas vs. Charlie Basham, charged with murder, is set for trial in the ninety-first district court Wednesday. A special venire of 75 men has been summoned from which to select a jury to try the case.

Basham is charged with murder in connection with the shooting and killing of Luther Browder, a prominent figure in Eastland county for the past several years, on the streets of Cisco one afternoon in the early part of last July. Browder was shot through the throat with a shotgun, the entire charge of buck-shot striking him. Browder was armed and was seated in his automobile at the time he was shot.

County Attorney W. J. Barnes stated that the state probably would ask for the death penalty in this case.

#### MERGER HEARING UNDER WAY

L. F. Lorne, author of the consolidation plan will not take the witness stand today as previously announced on account of his late arrival. He is scheduled to appear tomorrow morning.

A hundred or more women were given a number of new practical suggestions that were most acceptable, and after a delightful talk, by Mrs. Chitwood, the mysteries of pie crust making, apple pie filling and apple pie with cheese strips, and cheese rosettes, with another delicious pie, whose contents were to be named today, were demonstrated.

Help to Others  
Mrs. Chitwood said, it was worth every woman's time, regardless of how much money she might have, to try to be a help to others. That those with more money had more time, than those with less. That since women had begun greater activities, both within and without the home, there were much better churches, schools and homes, since women got out, and worked for others. She advised continuing with the wonderful work, and paying no attention to criticism.

According to the officers, there were three or four in the party, one or two of which were women. A description of them has been furnished the officers.

#### BILL TO GIVE SCHOOLS MONEY IN THE SENATE

Highway Department Books Ordered To Be Audited by Seniors

The vote was ten for an unfavorable report, and eight for a favorable report. A minority favoring the act was submitted.

**DIVERSIFICATION CLUBS**

Rochester, Texas, business men and the farmers in that vicinity have set a precedent for others to follow in the organization of a diversification club. This movement should spread all over Texas and when they do spread and diversified farming is adopted along with the use of intensive methods, then the cotton question will practically be settled. If not settled, it will be on the right road for settlement. Until Texas farmers and landlords come to the realization of the necessity for Texas to feed herself, they may expect to see the cotton market manipulated and the price of cotton go down.

When a farmer feeds himself and raises a surplus of meat animals, grains, fruits and vegetables to sell along with his cotton then he can hold his cotton off the market until the price is right.

There is one of the best livestock markets in the country with in twenty-four hours of most any point in Texas, by rail or truck.

To supply the Texas customers with pork products, it is necessary for the packing houses to import hogs for slaughter from the Missouri River and other northern markets. More than \$1,000,000 a year goes out of the pockets of Texas for pork and other products that could be raised on the average Texas farm. If sufficient apples were grown in Eastland county, and they can be grown here, buyers would flock here the same as they go to the Rio Grande Valley to buy grape fruit, cabbage, and other vegetables. If each farmer would just set out a few trees and grow apples commercially, he could find a sale.

The poultry game in Eastland county has been a success and the farmer who has produced eggs and butter has found a good market for them. The Bankhead Poultry Raisers Association products have established a reputation for themselves as being quality products. The poultry raising movement is spreading and in time will be the big industry in Eastland county.

The establishment of creameries in Ranger and other towns is encouraging the farmers to invest in a few head of dairy cattle.

While some few hogs are being raised in Eastland, there ought to be more.

We would suggest to the secretaries of the various commercial bodies in Eastland county to organize diversification clubs and agricultural councils in the various school districts. They are big things. Those clubs could be developed into marketing associations. While financial editor of the one of the metropolitan newspapers of Texas, the writer had occasion to see the workings of the farmer's marketing associations on the Fort Worth stockyards.

Carload after carload of mixed livestock—hogs, sheep, goats, cattle—sold on the yards. The organization had one of its members act as sales agent who accompanied the shipment to market and looked after things for them with the commission firm handling the business. The various district organizations could use trucks now, since the road have been paved to Fort Worth.

You may talk as much as you desire, but diversification and the adoption of intensive methods of farming are the only cures for low price cotton. Farmers of Texas are prone to fight grass all the summer in the cotton patch to buy that grass back in the shape of hay in the winter time to feed their stock. This

**Knows Clothes**  
 That she knew personally, little about new clothes, but could tell you all about the kitchen, and new things to eat, and utensils to use, and of other kitchen and home supplies. Cox, her assistant, with the statement that she was accepting kindness of Domestic Science students, in many of the Southern towns, in lieu of the regular maid, as the students were anxious to take advantage of her knowledge and experience in preparation, and could help others in their home towns, through knowledge thus gained.

**Materials Used**  
 Mrs. Chitwood showed the grade of flour, she using The Belle of Wichita, with which she was delighted. This flour contains a large percentage of gluten, and makes wonderful pastry.

The manner of handling dough was shown, and how to avoid, and pushing the dough with fingers, stamping the heel of the hands should be used.

All pastry should stand thirty-five minutes before using. Wonderful apples from the Eastland Grocery company were prepared in view of the audience, with instructions, that if apple is dry, sprinkle a little lemon juice over the slices, to prevent them turning dark, and to make them more moist for filling, that there must be more acids in the pie than a sweet apple provides, so that a jelly will form, and the pie will not be watery.

For the second example, grated cheese was worked into the pie crust, and these were stripped over the pie, which was baked thirty-five minutes.

Of course there were other preparations and ingredients, not given in this summary. A very handsome enameled gas range, the Favorite, in use by Mrs. Chitwood, was highly eulogized, and its baking and roasting qualities explained.

The market reports show that the price of meat animals is steadily advancing. Prosperity and the employment of labor in the East has created a demand for meat. The farmer who diversifies has the meat animals to sell, and as a result can hold his cotton.

In his diversification program, turkeys should not be forgotten, because they can feed themselves and turn leaf worms, grasshoppers and other pests like these into profits.

Organize Diversification clubs and settle the cotton question.

### Champagne Feast To Ederle To Be Probed By Women

LOS ANGELES, Sept. 27.—The reported champagne toast of William Corcoran, American consul at Boulogne, France, to Gertrude Ederle, American girl-conqueror of the English channel, was one of the many topics scheduled for discussion by the Women's Christian Temperance union meeting here today in annual convalescence.

The feminine dry enthusiasts are expected to go on record in condemnation of such practices if it is established to their satisfaction that the supper given by Corcoran to the girl swimmer the day after her triumph was really "wet." The W. C. T. U. organization some time ago addressed a communication to Washington demanding an explanation of the asserted incident.

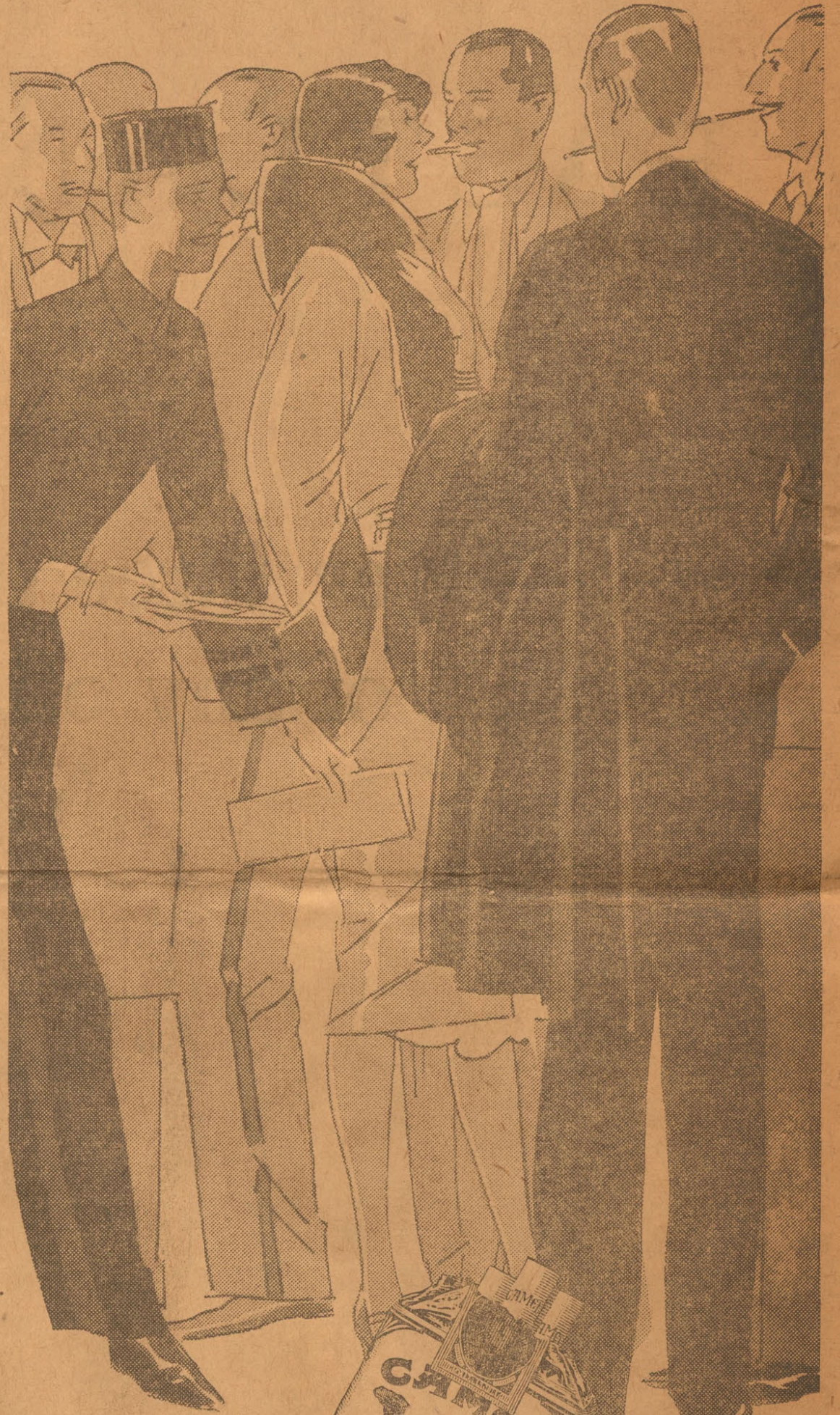

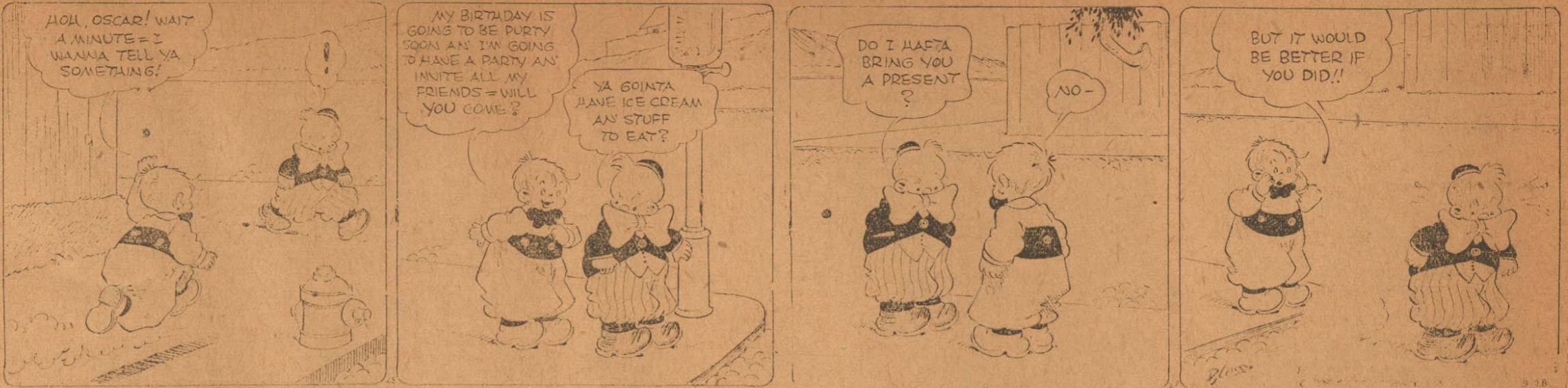
