

## Sugar Laws May Be Used For Reprisal

WASHINGTON (AP)—Rep. Harold D. Cooley (D-NC) said today the administration apparently plans to ask for a new sugar law which he said could be a "weapon of reprisal" against Cuba's Prime Minister Fidel Castro.

Administration sources confirmed that some changes which Cooley opposes are included in a bill they intend to submit next week to the House Agriculture Committee, which Cooley heads. But they denied the administration measure is designed as a club against Cuba, which reaps a 150-million dollar yearly bonus under present law. They said their bill is merited for agricultural reasons, and would not hurt Cuba.

Sugar legislation is an especially hot issue this year because of Castro's attacks on the United States and seizure of American-owned property in Cuba. Some Congressmen see the sugar bill as a golden chance to hit back at Castro. President Eisenhower has declared against retaliation. Cooley spoke to a newsman after conferring late Wednesday with Under Secretary of Agriculture True D. Morse and other officials on administration plans.

Earlier, Secretary of State Christian A. Herter told his news conference that the administration had not completed its sugar law. "As you know, I don't think the President has said we are not going to take countermeasures," Cooley said.

Cooley said Eisenhower's recent Latin-American trip apparently has made no change in earlier administration plans to seek a four-year extension of the sugar law, a slight juggling of sugar quotas which Cooley termed "unfavorable" to Cuba, and executive branch power to cut foreign quotas further.

"That's my proposal," Cooley said. "But I don't think they should even submit the proposal. He added the President said 'he didn't want any reprisals. He shouldn't ask for the weapons of reprisal.'"

Cooley said the mere proposal by the administration of such a plan would set off wide anti-American feeling in Latin America. Havana papers already have screaming headlines to the effect that the President is preparing economic aggression against Cuba," he said.

Cooley said he favors a one-year extension of the law as is—without presidential power to avoid committee hearings because the bill "should not be considered under an emotional atmosphere."

The present law expires at the end of this year. The basic aim of the sugar law, first passed early in the New Deal, is to protect the U.S. sugar industry from violent ups and downs. Quotas prevent an oversupply of sugar in the United States, and prices far above the world market rate are paid for imported sugar to keep it from undercutting domestic growers. Cuba sells about half her annual six million ton production of sugar to the United States.

Supporters of the administration plan said a four-year extension is logical because growers need time for their plantings. Previous extensions have been for four years at a time. They pictured the administration power to change quotas as something that should have been in the law before to allow flexibility to meet changing conditions.

The quota under the administration plan was said to call for a shift of 200,000 tons from Cuba's quota to that given U.S. mainland growers. Cuba in turn would get 200,000 tons of Puerto Rico's quota, if Puerto Rico fails to fill its quota as it has in the past. Cooley said this change would give an "uncertain" 200,000 tons to Cuba in place of a sure 200,000. Administration officials said Puerto Rico was certain to fall short, and eastern U.S. refineries would be a surer source of supply.

## Rescuers' Target Is Revised Again

LOGAN, W. Va. (AP)—Mine officials today extended for a few hours more the target time when they expect to reach 18 men trapped four miles inside a fire-blocked coal mine.

Rescue crews had hoped to tear through the last barricade and reach the stranded men by mid-morning. But after that time had passed, word was issued that the time had been extended a few hours.

That has been the story since the 18 men were trapped behind a slate fall and smoldering fire last Tuesday morning in the Island Creek Coal Co's No. 22 Mine at nearby Holden.

The hours have turned into days. There has been no contact with the 18 since noon Tuesday when

the telephone connection with them went dead, apparently cut by the fire.

Temperatures weren't so cold at the scene Wednesday night. Unofficially the low was 19 degrees above zero, compared with 11 above the night before.

More than a foot of new snow from Wednesday's near-blizzard blanketed the grimy mine buildings, one of which bore a red neon sign with the words: "Be careful!"

The snow subsided to flurries during the morning, but leaden skies held promise of more.

The mine officials said the stubborn fire which has held the men trapped is practically under control and they expect rescuers to move on "as rapidly as possible."

Fog, clouds cover state. Fog and clouds covered most of Texas Thursday morning and temperatures were above freezing throughout the state.

The Panhandle and the area west of the Pecos had nearly clear skies. Dense fog at Texas City was blamed for a traffic death Wednesday night. John L. Johnson, 24, a service station operator, was fatally injured when his car crashed into a culvert.

Fog at Galveston Thursday morning reduced visibility to half a block and halted airship and ship channel traffic. The Weather Bureau said the fog pushed 100 miles inland along the coast.

Temperatures early Thursday ranged from 36 at Amarillo and Texarkana to 68 at Brownsville. The forecasts called for showers in East and South Central portions of the state late Thursday or Friday and temperatures are expected to drop in all areas Friday.

High temperatures Wednesday varied from 93 at Presidio, the warmest spot in the nation, to 57 at Sherman. Most other areas had readings in the 60s or 70s.

## Late Winter Storm Surges Into Eastern U. S. Areas

One of winter's most crippling snowstorms which battered the Midwest and Southern areas into Virginia pounded wide parts in the East today.

The late winter storm lost none of its power as it continued to dump snow and sleet from the Georgia coast northward through the Carolinas across Virginia into Ohio and Pennsylvania.

Heavy snow fell from northern North Carolina, Virginia and West Virginia during the night. Sleet, freezing rain and rain in southern North Carolina threatened to spread northward over mid-Atlantic coastal areas.

The storm that fanned across the middle Mississippi and Ohio valleys appeared to have lost much of its fury as it moved north eastward across the Appalachians. But snow fell through Maryland and Delaware, with falls from 3 to 6 inches. Lesser amounts were forecast in New

Jersey and New York. Meanwhile, a new storm which developed in the central Rockies extended southward across the western Dakotas and more snow was indicated in the storm-weather midcontinent and the upper Ohio Valley.

The major storm spread a heavy blanket of snow across a dozen or more states after sweeping out of the Texas Panhandle Tuesday. The fresh falls piled atop the heavy covering from last week's storm across the same wintry path.

Snow depths were up to two feet in southern Virginia and piled up to record amounts in many communities in Illinois, Indiana, Tennessee, Kentucky and Missouri. The fresh falls piled atop the heavy covering from last week's storm across the same wintry path.

The early March storm, with spring only 11 days away, left scores of towns isolated. Hundreds of travelers were stranded as bus and plane service was disrupted or canceled. Hundreds of

schools, stores and factories were closed. In parts of the storm belt, funeral services were postponed and church services canceled.

There were at least a score of storm-related deaths, including 7 in Illinois, 2 each in Tennessee, Missouri, Nebraska, Georgia and Kentucky and 1 each in Indiana, Iowa and Idaho.

Kentucky, reeling under the worst snowstorm in the state's history, was declared a state of emergency by Gov. Bert Combs. Some 20 inches of fresh snow covered sections of the Blue Grass State. Bowling Green, a city of 32,000, was virtually paralyzed.

The 14 inches of snow in Louisville was a record fall. National Guardsmen were called out in Kentucky, Indiana and Virginia. They were pressed into service helping weary highway crews and aiding police in emergency duties.

## Death Penalty Repeal Fails

SACRAMENTO, Calif. (AP)—A marathon 12½ hour hearing ended early today with narrow defeat in the California Legislature for Gov. Edmund G. Brown's bill to repeal the death penalty.

The 87 vote by the Senate Judiciary Committee may have shattered Cheryl Chessman's last hope in his 11½ year fight to escape the gas chamber.

Sen. Edwin J. Regan, committee chairman, had said before the hearing he expected the Senate to adjourn the special session on capital punishment the day after committee action on the bill if it was defeated. He indicated adjournment was expected today.

He said the 82-year-old widowed slayer of an elderly woman made the admission to the late Warren Harley O. Teets of San Quentin prison.

Leavy, who was Chessman's prosecutor, was the final witness. He said he related the Graham story because a movie of her life left the impression she was innocent.

Even as the Senate committee debated the death penalty question, the California Supreme Court Wednesday turned down Chessman's latest petition. This one challenged legality of his new May 2 execution date.

The 38-year-old prisoner was convicted in 1948 on charges of kidnap-robbery which involved forcing two young women to perform an unnatural sex act.

The Senate committee listened to proponents of repeal for seven hours. It wasn't until 8:30 p.m. that opponents—chiefly law enforcement officers—stepped up to the witness stand in the theater-like hearing room.

All but one of the opposition witnesses argued that the death penalty is a greater deterrent than any other form of punishment.

The execution was Dist. Atty. Roy Garrison of Ventura County, who said that the death penalty is a greater deterrent than life imprisonment.

## Senate Sets Vote; Debate On In House

WASHINGTON (AP)—The Senate votes today on a petition to clamp a time-limit on its civil rights debate, now in its fourth week and likely to continue.

A most simultaneously, the House starts debate on a civil rights bill that is far less objectionable to Southern opponents than the measure before the Senate.

The vote in the Senate was forced by a group of self-styled liberals against the advice of the leaders of both parties, and defeat of the effort was widely predicted.

The vote was ordered on a petition of 31 senators to invoke the Senate's cloture rule under which each senator's speaking time would be limited to one hour.

The rule, not successfully invoked since 1927, can be put into effect only by a two-thirds majority vote of the senators present.

The Senate agreed to meet five hours in advance of the vote, with each side to be allotted equal time to make its arguments.

Sen. Richard B. Russell (D-Ga.), leader of a band of 18 Southern senators fighting against civil rights legislation, denounced the move as an attempt at gag rule.

His forces had carried on a full-scale filibuster through around-the-clock sessions which started Feb. 29 after the first two weeks of debate. The nonstop session ended by agreement Tuesday night and are not expected to be resumed, even if lengthy debate continues.

Sen. Paul H. Douglas (D-Ill.) and Jacob K. Javits (R-N.Y.), chief sponsors of the cloture petition, argued the Senate must show it cannot be immobilized by a small minority.

Navy Band To Be Here On Schedule. The U. S. Navy Band, its ranks thinned by a disastrous plane crash in Brazil recently, will mount a concert unit and appear in Snyder on schedule April 2.

That was the word received this morning by Tim Dennis, president of the Seury Concert Association.

"We wish you to know that the depleted ranks of the United States Navy Band will be moulded to their world famous conductor, Commander Charles Brendler, with assistance of third leader, Warrent Officer Anthony Mitchell, and we will arrive in your city for our appearance per our contracted date," said a telegram from Gib Sanderfer, national tour director for the band.

Nineteen top members of the U. S. Navy band were killed in the collision of two planes in Brazil. Memorial services for the 19 members were conducted Tuesday.

Hirohito's Daughter Weds Clerk. TOKYO (AP)—Emperor Hirohito's youngest daughter exchanged her imperial title and the seclusion of the Japanese court today for a \$50-a-month bank clerk and the life of a housewife.

However, they made no advance claims of victory. Both Majority Leader Lyndon B. Johnson (D-Tex.) and Minority Leader Everett M. Dirksen (R-Ill.) called the move to shut off the debate premature.

Some senators believe the Senate is likely to wind up by taking the House bill if it is not greatly changed. But it will not reach the Senate for another week.

In its present form, the House measure includes only four of the seven sections in the administration bill before the Senate and even these have been toned down in several respects.

However, the House is expected to adopt an amendment providing for court-appointed referees to protect Negro voting rights — an administration proposal already included in the Dirksen bill.

The House bill, unlike the Senate measure, would not give congressional backing to the Supreme Court's 1954 school integration decision. Nor would it set up by law a commission to seek elimination of racial discrimination in employment by government contractors.

These provisions have drawn some of the Southern senators' sharpest criticism. Efforts to add these and other provisions undoubtedly will be made in the House, however.

Man Is Killed In Mishap Near Union. Slick oil and grinding gears claimed the life of a Snyder man this morning in an oil rig accident one mile northwest of Union.

James A. Hembree, 31, was acting as floorhand on a two man well servicing crew when he fell between the wire drums. The winding cables tore off his left arm and crushed his head before H. I. Clark, the unit agent, could get the mechanism stopped.

A spokesman for BAH Well-Service, owner of the swabbing rig, said the weight of the load of water the truck was pulling from the well, coupled with about 2,000 feet of wire still in the ground was tremendous, adding that Clark was fortunate to stay the gears as quickly as he did.

Hembree was pronounced dead at Cogdell Memorial Hospital at 9:10 a.m. He is survived by his parents, Mr. and Mrs. G. F. Hembree of Knapp, two brothers, Clint and Delmer (Lee) both of Snyder, and one sister, Betty.

Funeral services are pending at Bell Funeral Home.

Brigitte's Plea Rejected. PARIS (AP)—The Seine Tribunal today turned down Brigitte Bardot's demand that the Charrier Bottled Water Co. stop down big advertising posters which pose the question, "Does baby like Charrier?"

Brigitte argued that the slogan suggests all is not well between her and her husband Jacques Charrier. In French the word for baby is pronounced like the letters BR, which every Bardot fan knows stands for Brigitte Bardot. The tribunal said there is no urgency to get the posters down because the Charrier company has added a picture of a plump little baby and a bottle of water to its advertisements. The tribunal added there is no reason to think the slogan refers to Brigitte and Charrier.

More Frauds Are Claimed. NEW YORK (AP)—The government will prove frauds "of far greater value" than Current charges against Rep. Adam Clayton Powell Jr., D-N.Y., \$700 in taxes on a joint income on trial on income tax evasion charges.

The trial continues today. A three-count indictment against the Negro congressman accuses him of cheating the government out of \$3,000 in income taxes on the 1951 return of his wife, Negro pianist Hazel Scott, and on his 1952 joint return.

Mrs. Powell is not a defendant. Asst. U.S. Atty. Morton S. Robson, in his opening remarks Wednesday told an all-white jury of nine men and three women:

"Mrs. Powell had nothing to do with it. She had gone to Europe the month before and the preparation of her return was supervised and controlled by her husband, the defendant."

Robson charged that Powell had made tax payments of about \$1,700 for a two-year period in which income of both husband and wife totaled \$160,000.

In 1951 Robson said Miss Scott earned \$50,000 and the tax paid in her name was \$600. Powell earned \$18,500 that year, the prosecutor said, and paid about \$400.

In 1952, said Robson, Powell paid \$700 in taxes on a joint income of \$80,000.

Robson continued: "Powell, determined to pay almost no tax for himself or his wife, deducted in one way or another every check to a restaurant—primarily Sardi's and 21—every check cashed in the two restaurants, his annual \$1,000 bill of over \$500, the cost of two television sets, his cost of tuition at a private school, the repair and maintenance of two boats, approximately 40 per cent of his grocery bills, his laundry bills, his insurance bills, his household expenses, his fuel and light bill, all of his telephone bills and all of the money spent for theater tickets."

Powell, 51, faces a maximum of 15 years in prison and \$20,000 in fines if found guilty on all three counts in the indictment against him.

Edward Bennett Williams, chief defense counsel, several times objected to Robson's remarks, saying they were "argumentative."

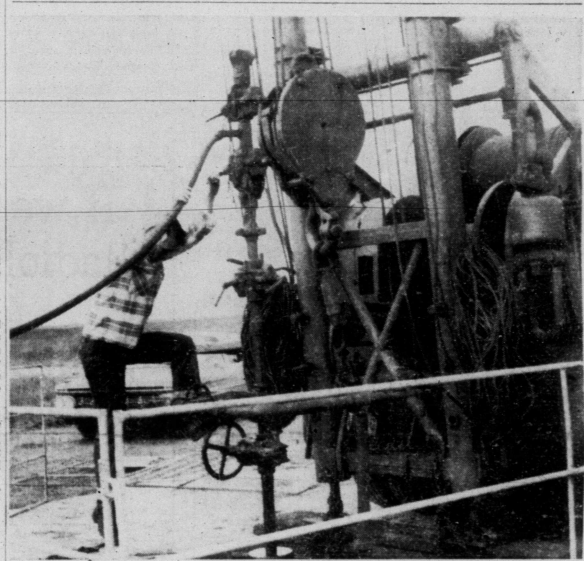

**Moore's Sell Their Home In England**

LUTON, England (AP)—Leo and Yvonne Moore sold their little bungalow today and prepared to leave Luton forever because of the local uproar over their decision to give their baby to an American couple after it is born.

Moore now plans to fly to America with his 36-year-old wife later this week. She will have the baby there and immediately give it for adoption to Mr. and Mrs. Wilbur Prescott of North Charleston, S.C.

Mrs. Moore originally planned to fly to America Wednesday on an Icelandic Airways prop-driven DC6, but the flight was canceled.

The other passengers transferred to a British Airways jet.

Mrs. Moore accepted an offer of 2,450 pounds, or \$6,880, for her home.

"With the money I'll be able to fly to America with Yvonne," he said. "We don't want to return to the bungalow because of all the unpleasantness this affair has caused."

The Prescotts are paying the expenses of Mrs. Moore's trip. The baby is due in mid-April.

### Winter Colds Spread Via Family Dishes

It is generally conceded by health authorities that many of the infectious diseases are spread among members of a family through the dishes, drinking glasses and silverware in daily use.

Though the eating utensils may be washed and dried thoroughly some disease-carrying bacteria will remain when dishes are washed and dried manually.

### Try Cherry Pudding With History

By CECILY BROWNSTONE

AP Newsfeatures Food Editor INTERESTED IN A relative of the fruit cobbler, pandowdy, dumpling, slump and grunt? Then this recipe for country-style cherry pudding may intrigue you.

All these desserts are combinations of fruit and biscuit or batter, quick to make.

One guess as to why these one-time desserts were made so much in American kitchens, is that when Great-grandma put up fruit there was always a little leftover. Tired out from canning and preserving, and in need of a supper ending she mixed up these 'in-a-hurry puddings with the fruit remainders. The desserts were always served fresh from the oven with plenty of pour-over cream.

In her invaluable "West Coast Cook Book," Helen Evans Brown tells how fruit grunt got its name: "It was said to be so irresistible that you'd eat it till you grunt."

Nowadays commercially canned fruit is often used in these desserts. Here we call for dark sweet cherries and make a sauce for the pudding from the cherry syrup.

If you cherish real old-fashioned butter pudding, a little on the heavy side, this recipe is for you. Don't expect anything light and flaky! At the bottom of the baking dish the batter that clings to the cherries has a gelatinous quality that remains us of certain Chinese sweets; next there's a layer golden with melted butter, and finally a plain-jane top. Almond extract adds a haunting flavor all the way through.

INGREDIENTS: 1 can (1 pound and 1 ounce) dark sweet pitted cherries (packed in heavy syrup) 1/2 cup butter or margarine 1 cup sifted flour 2 teaspoons double-acting baking powder, 1/2 teaspoon salt, 1/4 teaspoon nutmeg, 1 cup sugar, 1 cup milk, 1/2 teaspoon almond extract

METHOD: Drain cherries and reserve syrup for sauce. Heat oven to moderate (375 degrees). Melt butter in a 1-quart baking dish in oven; remove. Sift together the flour, baking powder, salt, nutmeg and sugar into a mixing bowl; gradually stir in milk and almond extract but do not beat. Turn into hot baking dish with butter in it; batter will come to top. Spoon drained cherries into center. Bake in preheated oven 40 to 50 minutes or until cake tester comes out clean; make sure batter is set. Allow to stand about 10 minutes before cutting. Serve warm. Makes 6 to 8 servings.

For Pudding Sauce gradually stir 1 cup reserved cherry syrup into 1 tablespoon cornstarch, and a dash of salt, until smooth. Cook and stir constantly over moderate heat until thickened. Stir in 1 tablespoon butter until combined and, if desired, 1 tablespoon dark rum or 1 to 2 tablespoons cognac.

WASHINGTON (AP) — Those two leaders who will soon have to face each other—President Eisenhower and Premier Nikita Khrushchev—are keeping their hands on the table and their voices down.

It has been an intensely interesting study to watch the way these two men have handled themselves since they met last year at Camp David and agreed to meet in May at Paris in a summit conference with Britain and France.

Both have avoided anything which might leave either of them open to the accusation of running chances for summit success by word or conduct before the meeting ever started.

Khrushchev practically black-jacked the United States into inviting him to a visit here, after he had demanded the Allies get their troops out of Berlin.

Although the foreign ministers of this country, the Soviet Union, Britain and France had long meetings last year to try to settle the Berlin issue, Khrushchev never permitted a settlement.

One thing which irked the West was what seemed to be a dead line laid down by Khrushchev for the Allies to get out of Berlin. He later denied setting any deadline, and at Camp David he agreed

"I want to be Little Bo Peep, Daddy," she chirped.

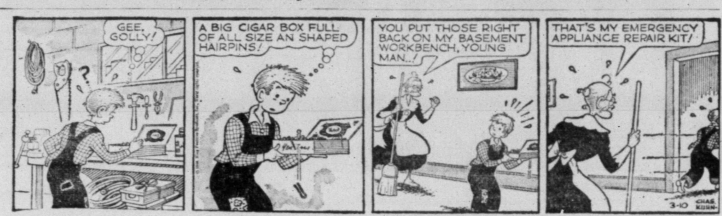
