County to aid VFD in purchasing foam unit

The Colorado City Volunteer Fire Department will be receiving \$7,500 from the County to aid in the purchase of a foam machine for a new truck the VFD is purchasing.

Pat McKinney explained to the Commissioners' Court Tuesday that the Department was purchasing a new truck to be used mainly in rural fire-fighting cases and their "department was needing a little bit of help."

The VFD had raised the money for their truck mainly through the bingo games they sponsor here every Thursday. The money will go towards the foam machine that costs \$12,500 and it can be used with either foam or water and will have a two-year warranty.

The Commissioners also approved a low bid of \$52,889 from Barrett-White GMC from Tyler for a dump truck for precinct two. They received three bids with the next closest bid being \$54,525.35 from Anderson International of San Angelo.

In other action, the Court acknowledged a donation of \$1,500 from the Spade Ranch for the predator control program which will fund the program through

November, approved the specifications and advertisement for bids for a new vehicle for the Sheriff's Department and voted to have installed a re-manufactured engine in another Sheriff's Department car. The new car will replace a vehicle that has logged over 180,000 miles and the rebuilt motor will replace one that has over 140,000 miles on it.

They also amended the legal notices for water and sewer construction and the jack and bore phase to set the date to the 19th of November instead of the 5th. Contractors interested in bidding on this phase of the prison project had asked for the additional time.

Nancy Sullivan stated that this would provide for more accurate bidding and perhaps even a cheaper price on the project.

Deputy Tommy Dill told the Court that the community service project had logged more than 900 hours of service to the community. He stated that 576 hours were totaled in the work program and 528 hours had been volunteered by jail inmates. He cited excellent cooperation between the city and the county in this program.

Police Department urges caution

The Colorado City Police Department is asking that everyone use caution this Saturday night while trick-or-treating on Halloween.

Motorists are asked to "please slow down and be extra alert Saturday night," said Lt. Pat Taylor. He noted that large numbers of children will be out and probably not paying a lot of attention to their own safety.

"Trick-or-treaters are encouraged to wear light colored costumes or those with reflective tape on them," said Taylor.

It is also suggested that children travel in well-lighted areas and in areas that are well-known to them.

"Anyone finding any suspicious candy," Taylor said, "should contact the Police Department immediately."

CHS Band receives III rating

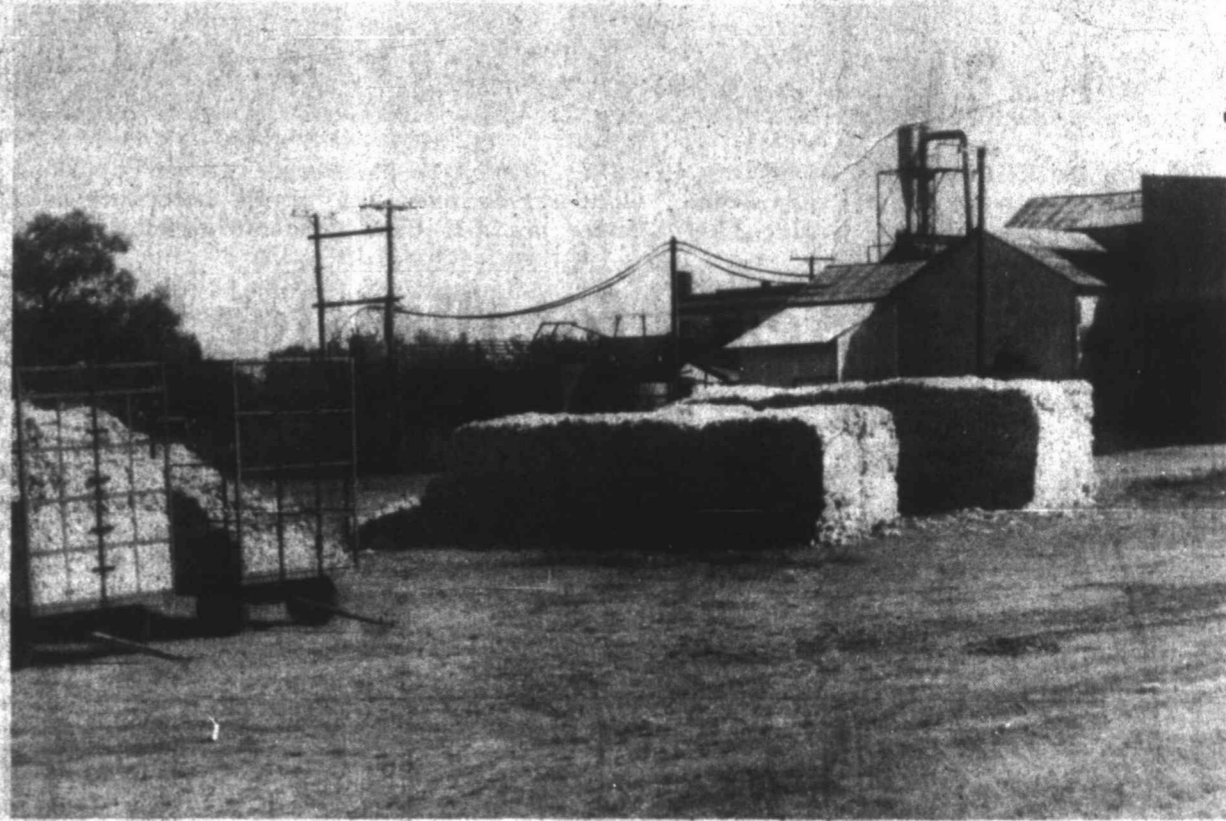
The Colorado High School marching band received a Division III ranking in the UIL marching contest held in Shotwell Stadium in Abilene Saturday.

Loraine battles for first place

"It's certainly the biggest ball game since I've been here," said Loraine football coach Bob Loy in referring to Friday night's match up against Borden County in Gail.

Both teams are undefeated in District 6-A action with 3-0 records while Ira is close behind at 2-1. The Bulldogs will face them next Friday so Loy and his charges have two tough weeks in a row to prepare for.

"I expect a great ball game as both teams can put points on the board," Loy added.

The Bulldogs, who rank number one in the district on offense, will be tested by Clint Wilts who has rushed for over 700 yards in his last two games while scoring 11 touchdowns. He has also recorded 36 tackles in his last two outings against Ira and Trent.

For the year, Loraine has scored 393 points while Borden County has tallied six more.

Leading the way for the Bulldogs Friday night will be Arthur Garcia, who has accounted for 1236 yards rushing while scoring 19 touchdowns. Aunray Crawford has

scored 15 touchdowns while tallying 660 yards on the ground while teammate Dwayne Starlings has rushed for 475 yards while scoring seven times.

Quarterback David Mitchell has passed for ten touchdowns and 331 yards. James Lopez is the leading receiver for the Bulldogs.

Mitchell is also the leading tackler for Loraine with 104 for the year while Jason Shy has recorded 78. Steve Gutierrez has brought down 65 while Craig Findley has 63 tackles.

A pep rally will be held at Loraine High School Friday at 3 p.m. and kickoff is set for 7:30 p.m. in Gail.

Trial postponed

The trial of Leonard L. Dockum, indicted on several counts of criminal activity related to the demise of First Western Savings and Loan Association here in Colorado City, was postponed late Friday by Federal Judge Jerry Buchmeyer.

The trial was set to begin Monday.

Jon Gant, Assistant U.S. Attorney who is prosecuting the case, said Monday the "judge gave no reason for the postponement and I'm disappointed that he did."

It may now go on trial sometime in November or as late as December barring no further delays.

Scheduled to testify in the trial were former members of the Savings and Loan staff who have all pled guilty and are all awaiting sentencing themselves. These include Neva Turner, Marilyn Roberts, Katy Byrd and Roy Byrd.

Wolves travel to Midland

With two games left in the 1992 football season, the Colorado City Wolves stand 1 and 2 in the District 6-3A chase as they prepare to travel to Midland Greenwood this Friday night.

Every team in the district was in the running before last Friday's games and now it has pretty well narrowed down to Big Lake and Kermit representing the district in the playoffs unless some major upsets occur in these last two weeks.

Big Lake, who the Wolves play here on Nov. 6, is undefeated for the year and will play Sonora this Friday. Kermit plays Crane Friday and closes out with Greenwood.

While Big Lake has won with ease all year, Kermit appears to be peaking as playoff time approaches. And this was readily apparent in their victory over the Wolves as they executed their wishbone offense to perfection in rolling up 46 points while allowing only 6.

Wolves head coach Mark Howeth gave a one-word definition of his team's performance Friday night, "flat."

"The spark to play wasn't there," Howeth added, "and we had everything in the world to motivate us in this game."

Howeth went on to say, however, that "in watching the film, we really didn't look as bad as the score indicated. The ball didn't bounce our way at all."

The ball did bounce Kermit's way a couple of times during the tilt, however.

Kermit scored their third touchdown of the game with 11:15 remaining in the third quarter. They scored their fourth touchdown of the game with 11:08 remaining in the same period following a stolen lateral on the ensuing kickoff.

The visitors made it 39-0 with 5:23 left and following another pilfered loose ball, it was 46-0 with only 22-seconds elapsing since their last touchdown!

The Wolves came out of the Kermit game injury-free but as Howeth said, "we have a bunch of people with some injured pride."

Kickoff in Midland Greenwood is at 7:30 p.m.

Deer season to begin soon

Landowners and hunters are reminded that white-tailed deer season in Mitchell County will open Saturday, November 7 and run through January 3, 1993. The bag limit is 4 deer, no more than 2 bucks. No special permits are required for harvesting antlerless deer, however, both bucks and antlerless deer must be tagged with the appropriate tag from a hunting license.

Recently completed deer population surveys in Mitchell County allow the Texas Parks and Wildlife Department to issue the following deer harvest recommendations: In that portion of Mitchell County north of I-20, it is recommended that no antlerless deer be harvested due to light population densities. South of I-20 and east of Highway 208, it is recommended that no antlerless deer be harvested.

recommended harvest is one antlerless deer per 150 acres of one buck per 170 acres. South of I-20 and west of Highway 163, the recommended harvest is one antlerless deer per 500 acres and one buck per 1,495 acres.

These recommendations are based on averages of randomly spaced deer census transects throughout Mitchell County and should be used as general guide lines in determining the proper harvest rate for white-tailed deer in your area. The actual deer population within these areas varies according to land-use practices, habitat conditions, predation, and hunting pressure.

Hunters are reminded to show respect for the land on which they are hunting and to practice gun safety and good sportsmanship. Report game violations to the game warden, Randy Bullard, by calling 728-2365 or by calling OPERATION GAME THIEF - 1-800-792-GAME (4263).

The board of directors of the Mitchell County Hospital filled a vacancy on their board Tuesday night by electing Fred Thompson to the post.

Thompson, who is an employee of Kiker-Seale Funeral Home here in Colorado City, will assume his duties on the board in their November meeting.

He took the place of Kay McCarley who resigned earlier this year. Before this meeting, McCarley was presented a plaque honoring his service to the Hospital District.

The board also approved a two-year lease on a portion of the former First Western Savings and Loan building.

The facility is to be used for the Home Health Agency which has out-grown its current location.

The area for lease is the northern portion of the building and it encompasses some 4,000 square feet. The Dallas-based owner of the facility was asking for a five-year lease but hospital administrator Wendell Alford stated that he felt a five-year lease was too long. Alford stated that the building was certainly adequate for the Home Health Agency now "but a lot could change in five years".

The cost of the lease would be \$1800 per month.

CHIEF LONE WOLF

Who stole the Cuthbert schoolhouse? The folks in Cuthbert know. It was those rascals from Fairview!

The nerve of those people. When Cuthbert residents retired for the night, they had a schoolhouse. When they got up the next morning, it was gone. And they didn't have to look far to find it.

There sat the building, bigger than Dallas, in Fairview! Mrs. Roy Davis Coles, whose father David T. Bozeman founded Cuthbert, says there was bad blood between Cuthbert and Fairview back in the late 1890's.

"Well now, Cuthbert and Fairview never did get along too well," she recalls. "They fussed, first one way and then another. It really upset my father very much for them to take the school building."

The drama of what may have been the first ever theft of a schoolhouse began in 1897. An account of the missing schoolhouse was written some years ago by Mrs. Edna Pace, based upon information provided to her by W.H. Badgett. (Mrs. Linden Solomon, niece of Mrs. Pace, passed it along to us).

It seems Fairview had twenty-five students, but no school-house. Cuthbert had a schoolhouse, but only two pupils. (And one of those was underage).

School officials refused to authorize a school for Fairview because one already existed at nearby Cuthbert. That stalemate produced what may have been the first ever school boycott.

Fairview parents refused to send their children to Cuthbert. Cuthbert reacted predictably. They held classes anyway, with just two students.

Meanwhile, in Fairview, W.H. Badgett had begun constructing a gin and he had completed the gin house, so he offered it as a school for Fairview students. School officials in Colorado City agreed to send a teacher to Fairview and that eased the situation for 1897.

When the next year rolled around, Colorado City school officials decided to bite the bullet. They ordered the Cuthbert school moved to Fairview on George Goodwin's property. Apparently no one bothered to inform Cuthbert citizens of that decision. When the relocation was discovered, a great protest was lodged and Cuthbert residents felt more settlers would move into their community and the schoolhouse would be needed.

It's safe to assume the Cuthbert folks gathered 'round the site where the school house had been. Perhaps they tried to remember the last time anyone had seen the structure. And no doubt they looked down the road toward Fairview (or East Cuthbert, as some called it).

Lucille Owens, who now lives in Colorado City, had grown up hearing about the schoolhouse heist.

"I had heard hints about it," she told us. "I had always heard the school was stolen."

Hmmm, the plot thickens. Now you see it, now you don't. Wilma Womack grew up in the Cuthbert community and she has some strong thoughts on the pilfered building.

"The Womacks claim it was moved during the night," she says.

"Mr. Godwin and my daddy-in-law fell out about it real bad," Mrs. Womack recalls. "I don't know why Cuthbert didn't go and get it from them. I never did figure that out."

Well, wait a minute. How did someone move a schoolhouse so easily?

Mrs. Coles says she understands the building was on wheels.

"They just wheeled the building on down to Fairview," she explains. Mrs. Womack has a different recollection. "It didn't have wheels, it was sittin' on blocks or something."

Well, how was it moved then? "They had slides under there and they just moved it over to Fairview," she figures.

"I don't know how they could do it in one night," Mrs. Womack adds. (See, she's still convinced it was a nighttime operation).

Lucille Owens has this theory: "I think it was on wheels. This was a building they had already moved into Cuthbert and it hadn't been placed on its foundation yet."

It's probably academic how a schoolhouse was moved, but you have to admit, it adds to a good mystery.

And what ever happened to the schoolhouse? It was used in Fairview until 1907 when a destructive storm moved across Mitchell County and leveled the building.

Could this have been an avenging act of God? Depends on your point of view and folks from Fairview would never agree with that.

Meanwhile, Fairview citizens passed the hat and raised enough money to build a new schoolhouse. Bozeman did ask that they not name it Cuthbert because he still held out hope that one day his town would have its own school again.

And he was right. In 1907 a new school building was constructed and Cuthbert kids were back in business, or classes.

There probably oughta be a historical marker to identify the site of that first Cuthbert school.

But on second thought...it too might end up in Fairview.

Clinton offers best vision for nation, world

While it is true that Americans not only elect a president but also a world leader, what the country needs most now is a chief executive with vision, determination and true empathy for the hardships imposed by a stubbornly slow economy.

What the country needs is Bill Clinton. George Bush may be a good and decent man who has worked hard, but he has not been able to succeed in adequately addressing the nation's problems.

Ross Perot, the Dallas billionaire whose money bought him enough exposure to share the spotlight with the Democratic and Republican nominees, is to be thanked for forcing attention to economic solutions. But his on-again, off-again campaign raises doubts about his commitment to the long haul.

Bush's election to the presidency capped a long public service career. Paradoxically, those senior government jobs Bush boasts on his presidency resume isolated him further and further from the people he served. That is why when asked how the recession has affected him, the president is hard put to answer.



Clinton

During the campaign, the president blamed previous Democratic administrations and Congress for the country's malaise. Ultimately, however, the president must accept his share of the burden.

Where the president fails is in identifying and articulating solutions and then turning those concepts into action.

Bush had a long time in Washington to turn his vision into action. It is time for the president to step aside and let someone else try. Make no mistake, whoever is elected faces a daunting task.

The country is changing as is the world. It will take more than just desire to confront those changing needs. The way out of the economic morass will not be easy nor quick nor painless.

But it is past time to begin. Like any other human being, Clinton is not perfect. His flaws have been held up, examined and thoroughly discussed through the long march of the Democratic primaries and the presidential campaign, which ends Nov. 3.

His background has apparently imbued Clinton with the kind of strength born of a life of both struggle and triumph. The stepson of an alcoholic, Clinton learned early of responsibility and leadership.

He did well in school despite a turbulent home life — well enough to be awarded a Rhodes scholarship and a law degree.

His political career taught him a valuable lesson in humility. After

becoming governor of Arkansas in 1978, he lost a bid for re-election because, as he put it, he lost touch. He was too proud of himself, and the voters reminded him who was really in charge.

Despite distortions of Clinton's record by the Bush campaign, Clinton has demonstrated the ability to work with a legislative body to produce results.

Clinton does not claim an "Arkansas Miracle" — it was a poor state before he became governor and remains one. But its governor can boast with accuracy that the state posted the largest percentage of job growth in the country last year, though most of the jobs created were in low-skill positions.

Nonetheless, Clinton has been recognized by a nationwide organization of governors for his work in pulling Arkansas up.

Born in 1946, Clinton faced in his 20s questions about service in the military at a time of war. Like

so many others — including some who raise the issue — Clinton never wore a uniform. It was a tough decision that continues to haunt him 23 years later. It bears little relevance, however, as to how he would perform as commander in chief.

Abraham Lincoln did a brief stint in the Illinois militia and served the country well in wartime. Neither Woodrow Wilson nor Franklin D. Roosevelt served in the military and conducted themselves well as they guided the nation through two world wars.

No, Clinton is not perfect. None of us is. Despite what else can be said about him, Clinton offers a vision and a sense that he can infuse those around him with his determination and commitment to a better country and better world.

This election, Texas and the nation would do well to give Clinton the vote of confidence he needs to do that.

Cowboy doing fine after receiving heart transplant

Editor's note: This article ran in the Dublin Citizen newspaper and Lane is the son of Lily McGee of Colorado City.

Lane McGee says its pretty dang irritating not to be able to whistle up the horses since someone stole his partial plate from his hospital room.

And he worked long and hard before he figured out how to rig up a milk crate on a rope so he could get in and out of his big one ton pickup.

And his new anti-rejection medicine costs a fortune and makes him so hyper he can't sit still.

But all in all, the rugged 56-year-old cowboy with the new heart says he's doing "finer than a frog's hair."

Lane and Carol McGee remember a wonderful evening on June 5, 1991 when Dr. Marilyn Brister delivered their new grandbaby. Less than 24 hours later, Lane had suffered a massive heart attack and he was seeing Dr. Brister again, this time in a DeLeon emergency room.

"After that night I tried to adjust my lifestyle to fit the condition of my heart but it didn't work," he said. "They didn't ever figure out why I had the heart attack-my blood pressure was okay, my cholesterol was okay and they told me that smoking 2 1/2 packs of cigarettes a day probably didn't cause it."

For the next few months, McGee says he "kept going over to the hospital and dying but then my heart would start up again." His condition continued to deteriorate until his heart was functioning at only 10 percent of its capability.

Dr. Brister suggested to McGee that he might be a candidate for a heart transplant and made

arrangements to have him transferred to Baylor Hospital in Dallas for evaluation.

"If you're not 100 percent every other way, they won't let you have a heart," he said.

The preparatory tests were the worst part of it, McGee recalls. The tests went on 24 hours a day for four days and "they would have done a stout cat in and I wasn't very stout."

"The average wait (for a heart transplant) is five months," McGee said, "But I had one in nine days. Everything happened real fast."

"It's pretty traumatic but some people who have already had transplants come by and talk to you," he said. "They are real positive and besides that, they are walking around alive. That convinced me."

After the 12 hour surgery on August 9, McGee had the heart of a 19-year-old man who had shot himself in the head.

"I'm proud I've got it but I'm not proud of the way I got it," he said. "I can't imagine being 19 years old and wanting to kill myself."

McGee stayed in intensive care a few days before being moved to a private room where he stayed two weeks. He and Carol remained in the Dallas area for two months so he could go to the hospital each day.

Friends in Dublin were concerned about Lane's dog. The duo were inseparable and Boliver had become despondent since Lane had been away. So family members loaded the dog into the car and took him to Baylor where dog and man were able to see each other through a window. Both fared better afterwards.

"I had to get out of the hospital and come home," he said. "They just wouldn't let me sleep. They'd

wake you up at 4:30 every morning with a needle. That's a terrible way to wake up."

The anti-rejection drugs, which cost \$240 a week, make McGee "nervous as a cat. I've always been hyper but not like this," he said, demonstrating his shaky hands.

"But I'm not griping," he said. "I'm just glad to be here."

"This whole thing has been a lot harder on Carol than it has been on me," Lane said. "She has slept standing on her head in a corner on the concrete or in the waiting room. And then someone came in the room and stole her money and my partial plate. Why the hell they wanted it, I don't know. But I can't whistle up the horses until I can get a new one."

McGee's symptoms were not classic. His chest and arm didn't hurt but the pain in the center of his back was like a charley horse.

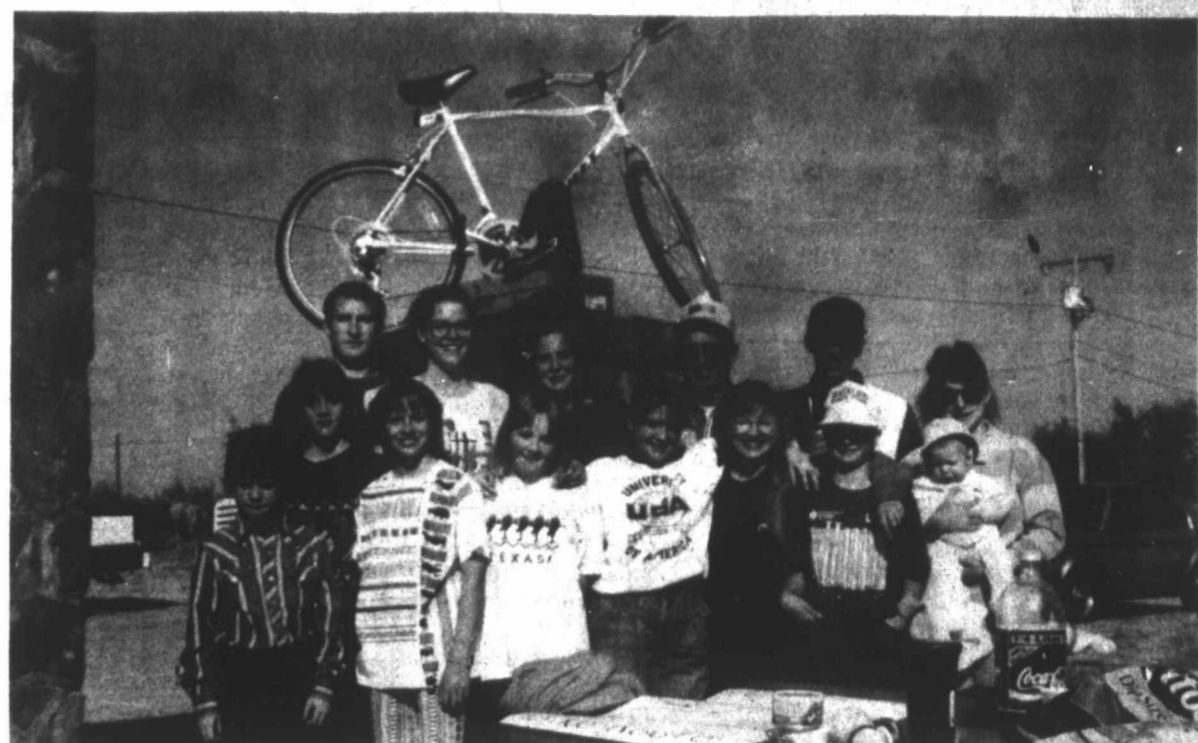
Because symptoms can be so different, McGee says stress tests would be a good idea for anyone who is a heart attack candidate, particularly men from 38 to 50 years of age.

"I wasn't a likely candidate for a heart attack," he said. "I ate well, my cholesterol and blood pressure were okay. I was smoking two and a half packs a day but they say it wasn't a factor. I nearly broke the doctor's mouth to tell me that because he sure hates cigarettes."

"You don't need to be scared of dying the way I died in the emergency room," Lane said. "You're just here and then you're not. A fellow ought to study about living-now that's harder."

We are taxpayers, we buy our homes, our children attend schools, our families are here. It's our choice to live here. but why can't we work here?

We are here-going to the grocery stores, paying our utilities, buying the paper, sending our children to school, watching cable tv, paying for medication, going to the doctor, etc. Last but certainly not least; we are going to church; praying, believing, trusting and keeping the faith; our faith in God is the basis of our accomplishments; because through Christ everything is possible; and one day the color barrier will be broken here and world wide.

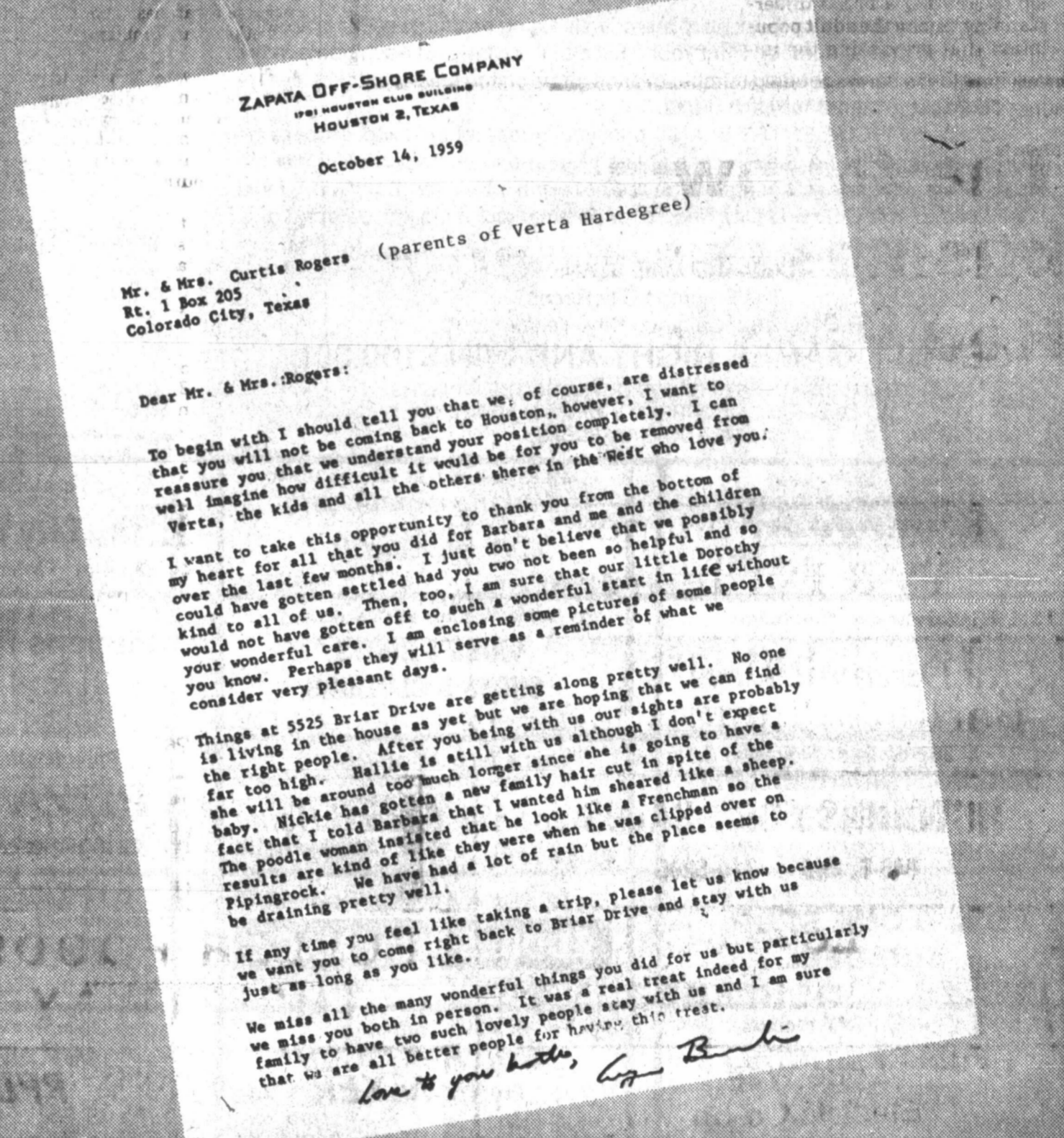


