COMPANY ANXIOUS TO HELP CLEAR THE AIR

Utilities News: With the approach of the winter season and the increasing popularity of the fireside comes radio fandom in full array, tuning in for the long evenings. And comes, too, the open season for "cuss" words directed at that scourge of the ether whom nobody loves, Old Man Static.

And since Old Man Static, with a hide like a rhino, doesn't seem to give a screech what anybody says about him, some there be who cast about for a more sensitive target on which to vent their outraged feelings. And that target, we regret to record, happens frequently to be the poor old electric light company.

Well, the electric company—this one as well as most of the rest of them—are sympathetic listeners, and always ready and anxious to do all it can to clear up the trouble—if it is of a nature that can be cured. But very infrequently is the disturbance due to causes within the power of the electric company to remedy.

It is estimated by experts that less than ten per cent of all complaints of radio-interference directed against power companies are in fact due to company lines. In one recent survey, out of 281 complaint cases investigated only 26 were found to be due to utility equipment. The howls, squeaks and buzzes complained of in all other cases were found to be traceable to a variety of causes, among them defective heating pads, washing machines operated at night, certain types of small electric fans, and (most of all) trouble in the radio sets themselves.

However, West Texas Utilities forces are all anxious to cooperate in keeping the air clear for radioland, and any case of trouble called to the attention of company employees will immediately be investigated and cleared if possible.

THANKSGIVING TURKEYS ARE TO BE MUCH HIGHER

Thanksgiving turkey eating will be somewhat more costly this year than in the past two years, according to a holiday prediction made by the Sears-Roebuck Agricultural Foundation. The turkey crop is not as large as it was last year or the year before, and a prediction of 45 to 48 cents a pound for this year's Thanksgiving turkey is not considered pessimistic.

The cool weather this fall has been favorable "turkey weather." So long as the days and the nights are comparatively warm, turkeys continue to roam the country and fail to put on flesh. When the temperature falls, they are content to cease wandering off, and settle down to grain feeding which rapidly adds pounds of turkey meat. The crop generally is further advanced than at this time in several years, and reports from the country consistently tell of the high quality of the turkeys. In Texas, which is the big early State for turkeys, the crop is believed to exceed last year when many of the young poulters were lost during the hot dry weather. Oklahoma, Arkansas, Missouri, Kansas, Iowa, and Ohio are expected to have fewer turkeys for the market this season while the other States report flocks of about the same size as last year.

Stocks of turkeys in storage are less than half as large as at this time a year ago, and per cent below the five-year average. Reserves of frozen turkeys, therefore, will be less of a market factor this season than last. Holdings of chickens and fowls are five million pounds larger than the five-year average, however, offsetting to some degree the decline in turkeys.

TEXAS AND TEXANS.

Cotton Clothing Style Show

An Ennis citizen has conceived the idea of giving cotton clothing style shows as a means of inducing the women to return to the use of cotton goods. Fifty-four Ennis women gave a style show there, and it is said by those who saw it that, dressed in Texas cotton goods, they looked as stylish as if they had been wearing Japanese silks. The Ennis show was such a success that the ladies were invited to go to Dallas and give it there. Doubtless this will result in other invitations. Here is where local merchants can help. In every town a cotton goods style show would attract attention to cotton goods. Plenty of women will gladly assist if only there is proper leadership. Along with the style show, cotton goods of all kinds could be displayed to advantage. Why not organize and have a cotton goods week, featured by the style shows and cotton goods displays? The motto, "Wear more cotton, use more cotton," adopted by the Ennis women, is a good one for any town.

The big Galvez Cotton Mill will be formally opening December 1, and the Marble Falls mill is placing its machinery and getting ready for its opening. There are now about 25 cotton mills in Texas, where there is room for about 500. The number is increasing at the rate of about two a year. It is easy to figure that about 250 years will be required for Texas cotton manufacturing to catch up with cotton producing, even if no more cotton is grown than is now being produced. The

towns that get busy and organize cotton factories now will be contributing a large share to the right kind of consumption of cotton and adding to their own prosperity and that of the cotton farmer.

Blaming the Other Fellow

It is unfortunate that whenever trouble of any kind overtakes a people they are inclined to place the blame on somebody else than themselves. At first, the slump in cotton prices was charged to the Government reports, but the country has since learned that these reports have not been very far wrong. Now, we are trying to find some other class to blame, and some are saying that if the bankers and merchants would only let the cotton growers carry over their debts to another year the country would be all right. The truth is that too much cotton has been produced, or too little is being consumed, and so much more is being thrown on the market than the market can buy, that prices have tumbled. If the cotton growers were not in debt they would be in position to carry their own cotton for better prices. If merchants and bankers were not operating largely on capital of others, they might be able to carry the load, or a great part of it, for the cotton producers. There is nobody especially to blame for existing conditions, unless it be those who have had a part in growing more cotton than the world wants to use, of those who are responsible for the credit system on which practically all business is largely conducted.

Business-Like Philanthropy

Lew Wentz, of Ponca City, Oklahoma, is a philanthropist

of the right kind—that is, he believes in helping people to help themselves. He has set aside \$1,000,000 to assist worthy Oklahoma farmers in carrying over their cotton crops another year. He stipulates that no interest shall be received. He says he has made his money in Oklahoma, has been fortunate, and wishes his fortune used in a way to benefit the people. Wentz is not a selfless assistance, he has rendered Oklahoma. May his kind increase, not only in that State, but throughout the country.

Mob Spirit in Athletics

The killing of Lieut. Charles M. Sessums during a mob fight in a football game between A. & M. College and Baylor University, at Waco, is one of the deplorable results of over-emphasis being placed on inter-collegiate contests of a kind that develops the brutal fighting spirit in men. There was an exciting fight, due to the tense spirit caused by the game, and in some way young Sessums received a blow from which he died. He is described as an abright young student in his senior year at A. & M. College. It is to be regretted that college authorities practically everywhere have come to regard such contests as football essential to student life. Unquestionably the emphasis now placed on football is encouraging the fighting spirit in youth, although it would seem that well-directed education should have an opposite influence. Alfred Dashiell, in The Forum, says: "Football is a barbaric spectacle for a degenerate Roman mob." The Waco incident makes us wonder if he is not right.

The Humble Peanut

O. S. Robbins, a farmer near De Leon, has this year marketed four times the value of the land from six acres of peanuts, and he has not had to hold the crop for satisfactory prices. His neighbors who have been growing cotton have not made the expenses of cultivation and gathering the crops. Which is better, peanuts or cotton?

Railroad Extends North

The Cisco and Northwestern railroad has received permission from the Interstate Commerce Commission to extend its line from Breckenridge to Throckmorton. Gradually, but with painful slowness, Texas railroad development is being permitted.

Abilene Shows Growth

Arrangements have been completed to erect a nine-story, \$600,000 hotel in Abilene, which is splendid evidence that Abilene is a prosperous city that is expecting still greater growth.

RADIO SET CALLS HOGS

San Antonio Light: Few people who read the front page newspaper stories on the recent National hog calling contest realized that radio played a leading role in this event of countrywide interest.

As a matter of fact, the contest was sponsored by the Omaha Radio Trades association during the annual radio show in

that city. The show was very successful from every angle and the hog calling contest brought a tremendous amount of publicity and occasioned a great deal of editorial comment. Moving picture news releases were made and are now being shown throughout the country.

Everybody now knows that the object of the contest was to select the best hog caller. That weird succession of sounds that causes the hog to respond to "his master's voice" was placed literally on the air by the various contestants. The hog callers worked in the Crystal studio. The hogs were out on a farm seven or eight miles in the country.

Arthur C. Storz, president of the Omaha Radio Trade Association and vice president and general manager of Storz-Western Auto Supply company, of Omaha, explained just how the callers worked. He said: "They placed a Fada 8-tube set out on a farm seven or eight miles in the country and tuned it into the Crystal studio. The Fada 8 and speaker were strong enough to call the hogs in from all over the 160-acre farm and in the motion pictures taken you will see the hogs walking right up to the Fada 8 and speaker. A number of radio receivers were tried on this stunt but none of them outside of the Fada 8 had power enough to put it over."

Ford's Low Car-Mile Cost Responsible for Favorable Situation

By B. H. CRAM, Cram's Automotive Reports, Inc.

Is Henry Ford slipping? This question has probably been asked more times in the industry this year than any other. And, the answers have been many—and, varied. The majority which have gained wide circulation, however, have been in the affirmative.

In face of the figures for the early months of the year, this conclusion was a possibility—providing nothing more was considered. But those who know this manufacturer, intimately, and have followed his rise to present heights, said: Wait! Their advice was apparently correct, for the answer to the long asked question is now quite evident.

Henry Ford is still, by far, the greatest producer of them all—and, holding his own, while the balance of the industry is striving desperately to hold up its record during the balance of the year. At the moment, his mammoth plants at the Rouge and Highland Park are humming with activity as they steadily turn out between 6,000 and 6,500 completely machined cylinder blocks daily, 50 of which are used for repairs. Recent figures show the production of 7,900 crankshafts, and 31,600 pistons per day, a greater number of which are used for replacement purposes. More than 6,000 completed motors are being shipped for chassis assembly to the various plants.

On the other hand, the industry, as a whole, is operating on greatly curtailed schedules, with Ford's nearest competitors working on a reduced production basis, and there seems to be little possibility of output being advanced much higher during the remaining nine weeks of the year. This is an entirely different picture than was presented during the month of June, when Ford was seemingly losing rapidly—with a production of 4,500 units daily for four days a week, and his nearest competitor was equaling his efforts with 3,000 units daily for six days a week—and the other big automobile manufacturers were hanging up production and sales record after record.

But, there was a reason. While the industry was living in the present, Henry Ford, as usual, was looking far ahead. He realized that the majority of manufacturers and their dealer organizations were allowing their enthusiasm to run away with them, and that the pace could not be maintained. He saw—not far in the future—the piling up of new and used car stocks to such an extent that it was certain to have a demoralizing effect.

Accordingly, his sales department instructed its entire dealer organization to follow a definite procedure relative to used-car trade-ins. They were told that they, alone, were to dictate trade-in prices—even if sales suffered at the moment—rather than allow their anxiety to make a sale offset their better business judgment and result, in addition to losses on the transaction, in the piling up of burdensome used-car stocks—a situation with which practically every other dealer organization today finds itself confronted.

Also, Henry Ford could see that while public demand, at the moment, was for "car appearance," and that the industry—he included—was catering to this apparent whim, regardless, he realized that a fundamental factor must predominate, particularly to the masses to whom he was appealing, and that was "low car-mile cost." His principal objective has been increasingly in this direction, and unquestionably the pursuance of this policy is enabling him to maintain his present high production schedules and position.

SALES HOLDING UP

Even in the agricultural sections, where sales of practically every manufacturer have eased off to a serious extent, Ford continues to register a good volume of business. This is due principally to the fact that the farmer realizes that the Ford is particularly adaptable to use in these sections, because of its lightness and its ability to traverse rough country. Then again the replacement parts can be purchased for a mere fraction of cost of those necessary in other cars.

Always mindful of his objective—"low car-mile cost"—he has adopted a most radical development in carburetor practice that is providing country-wide reports of such performance as 35, 38, 41 and up to 49 miles per gallon of gas consumed, while others are obliged to be content with a bare 25 and a probable 30 miles per gallon of gasoline. His pursuance of this irrevocable objective, together with his realization that the used-car situation is a tremendously influencing new-car sales factor, is mainly responsible for his present favorable position and probably will result in his 1926 output closely approximating last year's production, which was 7,990,995 units.

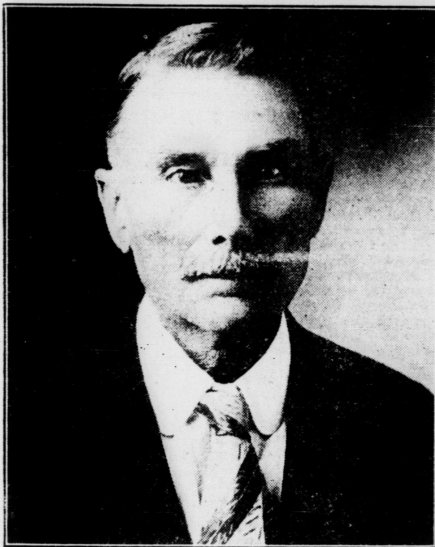

Reminiscences of E. Holekamp, Kimble County Pioneer



MR. E. HOLEKAMP

There was born near Comfort, in Kendall County, Texas, on March 2, 1859, a boy who was destined to have much to do with the early history of Kimble County. His education was obtained in a private school, where by diligent effort, he qualified himself to meet the problems of his future career early in his young manhood.

After he completed school, he moved to San Antonio and secured a position as clerk in a mercantile establishment, and was residing there in 1876, when the first railroad was built into the city.

Shortly after this time this young man returned to the town of his childhood where he resided for about three years. He then decided to cast his fortunes with the pioneers of the west and accordingly set out from his home town enroute to Junction City.

He arrived at his destination July 5, 1881. His first night in this little village will be long remembered. The Court House was a wooden structure located on the present site of the Court House square, and it was the custom of the day to have dances in the Court House in celebration of any special event. On the afternoon of July 5, 1881, Louis Snodder and Miss Evans were granted a license to be married and decided to celebrate the occasion with a big dance at the Court House. The inhabitants of the village and cowboys from adjoining ranches were all invited to be present and help celebrate the occasion.

It was during the days when the Double "O" Saloon was vending its wares and some of the boys who attended, imbibed freely of the vintage of the day.

The festivities lasted far into the night and the entire assembly seemed to enjoy themselves to the fullest extent. Toward dawn, the young man visitor decided to retire and went to the store of Falin and Schreiner for that purpose. He made his bed on a grocery counter and prepared to sleep the few hours of the night remaining before dawn. In the meantime, the dance had broken and the cowboys were preparing to leave for their various ranch homes. Suddenly from almost every quarter of the village a fusillade of shots, accompanied by yells and sounds of running horses, came to the ears of the newcomer. This lasted for some time, and the next morning it was estimated by the natives that some thousand shots were fired. Needless to say, the subject of this sketch, E. Holekamp, was in

some doubt about the safety of a resident of Junction City.

At this time Junction City was a small village of 33 houses and huts. Mr. Holekamp remembers this well as he drew a sketch of the village as it then existed. The main store of the town was located on the site of Wigley's Drug Store and was owned by Falin & Schreiner. Due to the fact that Junction City supplied a vast race territory, this store employed eight clerks, one of whom was Mr. Holekamp. It was the custom of the business houses to remain open week days until 10 o'clock at night and due to the fact that several robberies had been made of the stores, all the clerks were instructed to wear their guns after sundown and keep them handy for use during the day. Allen & Company had just completed the building in which Wald Bros. & Jordan are now doing business. G. W. Ragardill had just completed a hotel on the site of the Fritz Hotel. The Post Office was located southeast from the Court House, and N. C. Patterson, who is still a resident of Junction, was the Postmaster. With the exception of a saloon, previously mentioned, a meat market, restaurant and pool room and drug store, this about comprised the business interests of Junction City at that time.

All freight was hauled from San Antonio by freight wagon, or schooner. These wagons were pulled by about 20 mules and usually had three teamsters to the wagon. This was the sole means of transportation and served the country as far west as El Paso.

There was only one church in the village at this time and was located on the site of the Christian Church now. All denominations worshipped at this place and it was pastored most of the time by Rev. John S. Durst, now deceased.

A dramatic club gave plays at different times, the proceeds of which were used to keep the cemetery in good condition. Mr. Holekamp remembers his experiences with this dramatic club with a great deal of pleasure, and says in his judgment it is educational as well as being a means of excellent recreation and pleasure.

In April 1884, at about 2 o'clock a. m., the Court House burned, which resulted in a destruction of all the county records, with the possible exception of one. The vault in which the records were kept was under the Court House, but at the time of the fire the door to the vault was left open and the contents were destroyed. Mr. Holekamp and many others

rushed to the fire, when the alarm was given, but the building was a mass of flames when they arrived and nothing could be done.

A new Court House was constructed, which was also burned in 1889. The records were kept in a large vault, and the structure supporting the front of the vault was arranged so that it would quickly burn away in case of fire. When the Court House burned in 1889, this arrangement probably saved the records from destruction again, as the understructure burned away and the vault fell on its face and the records were saved.

Mr. Holekamp well remembers when, on occasions, the people of the community were inclined to administer punishment, of their own making, to a transgressor of the law. At one time a Mexican was accused of having outraged a white woman and the people made some investigation and believed him guilty. They accordingly organized a lynching party and requested Mr. Holekamp to become their leader. This he refused to do and very soon thereafter was summoned by Noah Corder, the sheriff of the county, to serve with him as a guard of the jail that night. Mr. Corder had heard of the mob forming and summoned all the men whom he thought were, or might be, leaders.

The posse went to the jail that night for the purpose of holding it against the mob. They were not kept long in suspense as the mob soon appeared. All had handkerchiefs over their faces, but the men were well known, despite their disguise, by their voices and the forms of their bodies. Mr. Corder stopped them at the

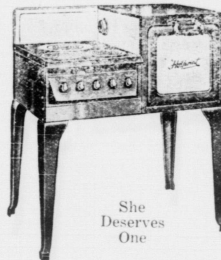

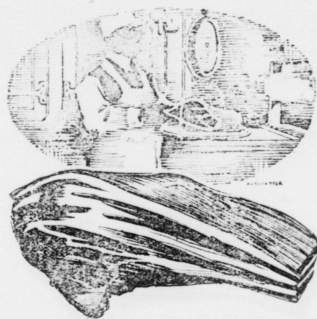

door and told them they could not take the Mexican, and must let the law take its course. This they did not want to do, but finally, after Mr. Holekamp and others talked to them, they were induced to withdraw.

The Mexican so carefully guarded came near meeting his doom later in the night, as one of the posse became intoxicated, and peering through a crack in the wall, saw the Mexican and took a shot at him. The bullet barely missed the Mexican and almost frightened him to death. The party who took this shot is still living and will probably read this account. On a later occasion a Mexican was hung by a mob.

In 1885 Mr. Holekamp had saved enough money to go into business and built a store of his own. He later bought out his uncle, Henry Smelser, and went into business in a building on the site of the Wigley Drug Store and continued to 1906, when he sold out to J. H. Reid. Mr. Holekamp was very successful in business and at one time served many people of this section of Texas, both as their merchant and as buyer of their cattle and other produce. He remembers buying many head of 4 and 5-year-old steers at \$16.00 and \$18.00 per head. They were driven from this county in the spring of the year to the Indian Territory, where they were fattened and sent on to Kansas City and Chicago to market.

In 1895 Mr. Holekamp put in the town's first water works, gin and grist mill. He built the first dam on the river for water power and remembers when he had sufficient power

to gin 10 or 11 bales of cotton per day with one gin stand.

In 1906, together with James L. Beasley, Dr. J. W. Burt, W. R. McKee and Charles Schreiner, he organized the Kimble County State Bank, with a capital stock of \$25,000. He served as president and W. J. Doyle as cashier up until it was merged with the old First State Bank, now the Junction State Bank, in 1908.

Mr. Holekamp has served 17 times on grand juries of this county, 11 times as its foreman and many times on petit juries. He states in his judgment, and from his experience and observation, it is always best and saves the county money to have business men on grand juries as they know how to transact business and conserve lots of time that is often wasted.

There are many other interesting things that have happened during Mr. Holekamp's 45 years of residence in Kimble County, that space will not permit us to relate, but in closing this brief comment we feel that you join with us in saying he has lived a useful and constructive life, and has accepted the responsibilities and discharged the duties of a good citizen.

DON'T SHOUT WHEN USING TELEPHONE

You've talked with him by telephone and you've noticed the tone of surprise in his voice when you say "speak louder." Sometimes he thinks you are hard of hearing, or else the connection is poor.

The telephone is a wonder worker, but it cannot overcome failure to use it properly.

It works best when you talk straight into the mouthpiece, with your lips not more than an inch away.

Another suggestion: If you are told to "speak louder," get closer to the mouthpiece, use a full natural tone and take extra care to pronounce each word clearly and distinctly.

The better you use the telephone the more valuable its service becomes.

A proposition to do away with incorporation would not get far here. Rocksprings will continue to go forward instead of backward.
