Lumber Production Shows Great Gains

WASHINGTON, Jan. 1. (AP)—Lumber production set one of America's 1925 records, the National Lumber Manufacturers' association announced today, placing the country's output for the year "slightly larger" than for any year since 1918. On the basis of weekly soft wood reports made to it by some 250 of the larger mills, the association said 12,423,808,277 feet were produced, against 11,823,948,347 in 1924.

10 TEXAS CONVICTS BREAK JAIL

HUNDREDS ARE HURT AS STAND FALLS

ROSES CARNIVAL IN PASADENA IS SCENE OF CRASH

ONE WOMAN BELIEVED TO HAVE BEEN KILLED IN ACCIDENT

(By Associated Press.) PASADENA, Calif., Jan. 1.—Possibly two hundred men, women and children were injured here today when a private temporary grand stand, seating 450 persons on Colorado boulevard and Madison avenue collapsed. It was crowded with spectators assembled to view the tournament of roses pageant. One woman was later reported to have been killed. Most of those occupying the stand were women and children, police said.

Consisted of 30 Rows.

The temporary stand consisted of about thirty rows of seats 75 feet long which swayed and collapsed into the street with its human load.

Considerable confusion attended the accident and it was difficult to move the injured owing to the great throngs in the streets.

Taxis and other available vehicles rushed the injured to the emergency hospitals and private hospitals.

Hospitals Taxed. Hospital capacity of Pasadena was taxed and appeals were made to Alhambra, Glendale, and Los Angeles. Within a half hour after the accident more than 200 victims had been removed to the Pasadena emergency hospital and Pasadena hospital, but no deaths were revealed by a check an hour after the accident.

CONTRACT IS LET ON OILED ROAD IN COUNTY

The contract for placing oil treatment on a portion of the highway running from this city to Canyon, thru Plainview, has been let, according to information contained in Texaco Tips, official organ of the Texas Oil Company, a copy of which has just been received at the office of Geo. A. Field, Division Superintendent of the State highway department here.

No official information in connection with the contract has been received by Mr. Field from the highway department, but he said he had no reason to doubt the authenticity of the report. It is presumed that the contract was let at the last meeting of the commission at Austin recently.

The publication says that contract has been let for approximately sixty miles of the highway in Lubbock, Hale and Swisher counties, and that the H. K. McCollum company, of Fort Worth, was awarded the work. This is only a little more than half of the proposed program. No information is contained in the publication as to when operations will begin on the oiling process, but the work of grading the roadway in preparation for the treatment is progressing nicely on the south end where the contract, if let, will cover.

Coolidge Greeting Many Visitors Today

WASHINGTON, Jan. 1. (AP)—Although government business was at a standstill today, New Years was anything but a holiday for President and Mrs. Coolidge, as they went through the grueling task of receiving thousands of visitors at the White House. Continuing the annual custom, they gave over most of the day to shaking hands with callers ranging from diplomats to all classes of citizens.

Eleven hundred men and women filed past President and Mrs. Coolidge before noon and while they were being received a long line formed along Pennsylvania Avenue, outside the White House gates to be admitted during the afternoon.

Flanked by military and naval aides with two sections of the famous Marine Band playing almost continuously, the executive and his wife greeted their morning visitors in rapid succession. Foreign diplomats in resplendent uniforms added color to the event.

TWO RETAKEN BY GUARDS AS GUNS BARK FURIOUSLY

(By Associated Press.) RICHMOND, Texas, Jan. 1.—A prison break, led apparently by C. S. Owens, serving a 12-year-term for bank robbery, resulted in the escape of ten convicts from the Harlem state farm at 10:30 a. m. today.

The convicts, making up a work squad, were cutting wood on the Bertrand plantation, south of the farm. Suddenly the guard was overpowered, his gun taken from him and the prisoners fled, two men going toward the main highway nearby, and the others in the opposite direction.

Two Recaptured. Two of the convicts were recaptured a short time later after shots had been exchanged with an officer. W. H. Bertrand saw the break from his home and telephoned Captain E. J. Flanagan, manager of the Imperial State farm, telling him that two men fled toward the highway. Captain Flanagan called two guards and with these rode to the highway in hopes of intercepting the men. As the three reached the highway they halted a speeding automobile. The car came to a stop with a suddenness that wrecked its mechanism and before Flanagan could get a good view of its occupants, one of the men fired at him.

Bullet Strikes Horse. The bullet struck Flanagan's horse in the mouth. Flanagan fired in return, shooting the pistol from the hand of his assailant, barely having time to observe that the man firing was one of the escaped convicts, wearing a heavy overcoat over his prison garb. The other convict in the car made no resistance and Captain Flanagan captured both. He found that the man doing the firing was Owens, the bank robber.

Both were returned to Harlem state farm, while all guards available, with bloodhounds, were put on the trail of the remaining eight convicts, who fled away from the highway.

Owens had two automatic pistols and the rifle taken from the guard. Captain Flanagan believes the two convicts held up motorists on the highway immediately after escaping and took their car and coats.

Neighbors said they knew of no trouble at the Townsend home but added that Mrs. Townsend had been under medical treatment for some time. They expressed belief that she had become suddenly irrational.

New York will exchange music from the Park Avenue Baptist church carillon for the chimes of "Big Ben" in London, and musical programs and greetings will be broadcast and re-broadcast in an effort to reach every end of the earth.

John McCormick and Lucrezia Bori, world known artists are stars on the New York program, which will be carried by nine stations in the United States. Their voices will be picked up in London by the British broadcasting company and will be re-broadcast to thousands of fans in England, Ireland and the continent.

To Broadcast Greetings. Another feature of the New York program will be broadcasting of New Year greetings from the Orient and from South and Central America, gathered by the Associated Press.

Kent Cooper, general manager, will be at the microphone. Mrs. Bori's solo will be mainly operatic arias.

Three Star Aggies To Play In City Grid Tournament

AUSTIN, Dec. 31. (AP)—Three members of the 1925 championship eleven of the Texas Aggies, all Austin boys, will play here New Year's Day in a game that will decide the city championship. Waitts, regular center; Mickey McGulley, regular halfback; and Woodman, first string, substitute, will play on a team captained and coached by Tom Dennis, captain and all-Southwestern tackle of the 1921 Texas University team. Dennis, now athletics director at Austin High school, will compete. He may play at tackle, but it is likely he will play in the backfield where he is perfectly at home. He is a punter of ability. The team that will oppose Dennis' combination is coached and headed by Jack Meagher, former star Notre Dame end, now athletic director at St. Edward's University here. Meagher probably will play in the backfield as his team boasts two other great ends in Bill James and George McCullough. James won All-American mention when playing for Centre college; he is now line coach at Texas University. McCullough won All-Southwestern honors when playing end for the Texas Longhorns in 1920 and 1921, and when playing in France with the 26th Division eleven he was named All-A. E. F. end.

Other players who will play on Dennis' team are Rufus King, Longhorn fullback of '23; "Rocky" Run-dell, substitute Longhorn center for the past two years; "Ug" Neal, Dallas University tackle; Dexter Shelby, Terrell Academy star halfback of '25; and Lewis and Ritter, Austin backs of this past fall.

Among other players who will play for Meagher's combination are: Roger Powell, former Texas Aggie player now coach at the deaf and dumb institute; Dewey Bradford, former Longhorn guard; "Moose" Woerber, former star tackle of St. Edward's University; and Mickey Hart, former Austin High star end.

STRONGEST SQUAD AT RICE SINCE 1918 LIKELY

HOUSTON, Jan. 1. (AP)—Although the Rice Institute Owls are by no means the favorite to cop the 1926 Southwest Conference championship, in basketball, Coach Franklin B. Ashcraft should turn out one of the strongest court combinations to represent the Owls since 1918, when a great Rice quintet captured conference honors. Incidentally the 1918 five was the only championship basketball combination

the Owls have turned out. With the brilliant Kingsland, the outstanding performer, the Owls in that year had a team tall enough to play the game "above the heads" of the average rival team. Provided they passed their fall term examinations, it is likely the following will make up the first string quintet: Morris and Hillups, forwards; "Rube" Borschow, center; "Frank" Grant, and Ralph Nevinger, guards. All the members of this combination, with exception of Morris, are sophomores playing their first year of intercollegiate basketball.

Borschow should develop into one of the outstanding players in history of the conference, if he is handled properly. He is big, fast, and powerful, and seems to be a natural basketball player. In 1924, when playing for Houston Central High school, he was named All-State center. Nevinger is said to have won all state high school honors in 1923 when playing in Illinois.

Former Houston high players make up about half the members of the squad. For example, Coach Ashcraft could form a second string quintet made up of the following Houston youths: Forwards, Gammel and Eckert; center, Fuhrmann; guards, Townsend and Demmann.

Among the other members of the squad are: "Heavy" Underwood, regular guard of last season; Calvin, speedy forward and letter man; McKinnon, Appling, Jenkins, Robb, Joseph and Pys.

IN RETROSPECT

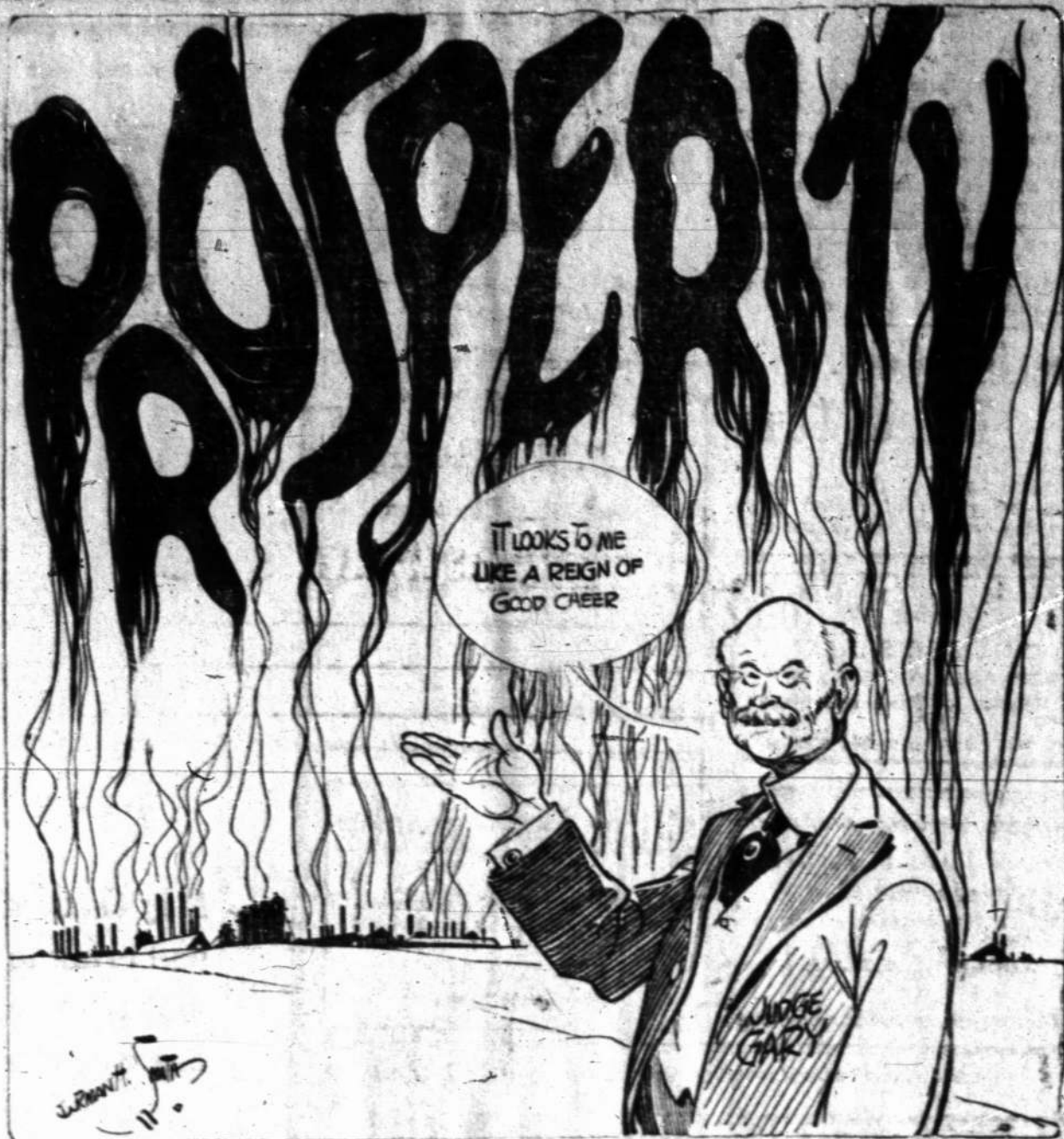

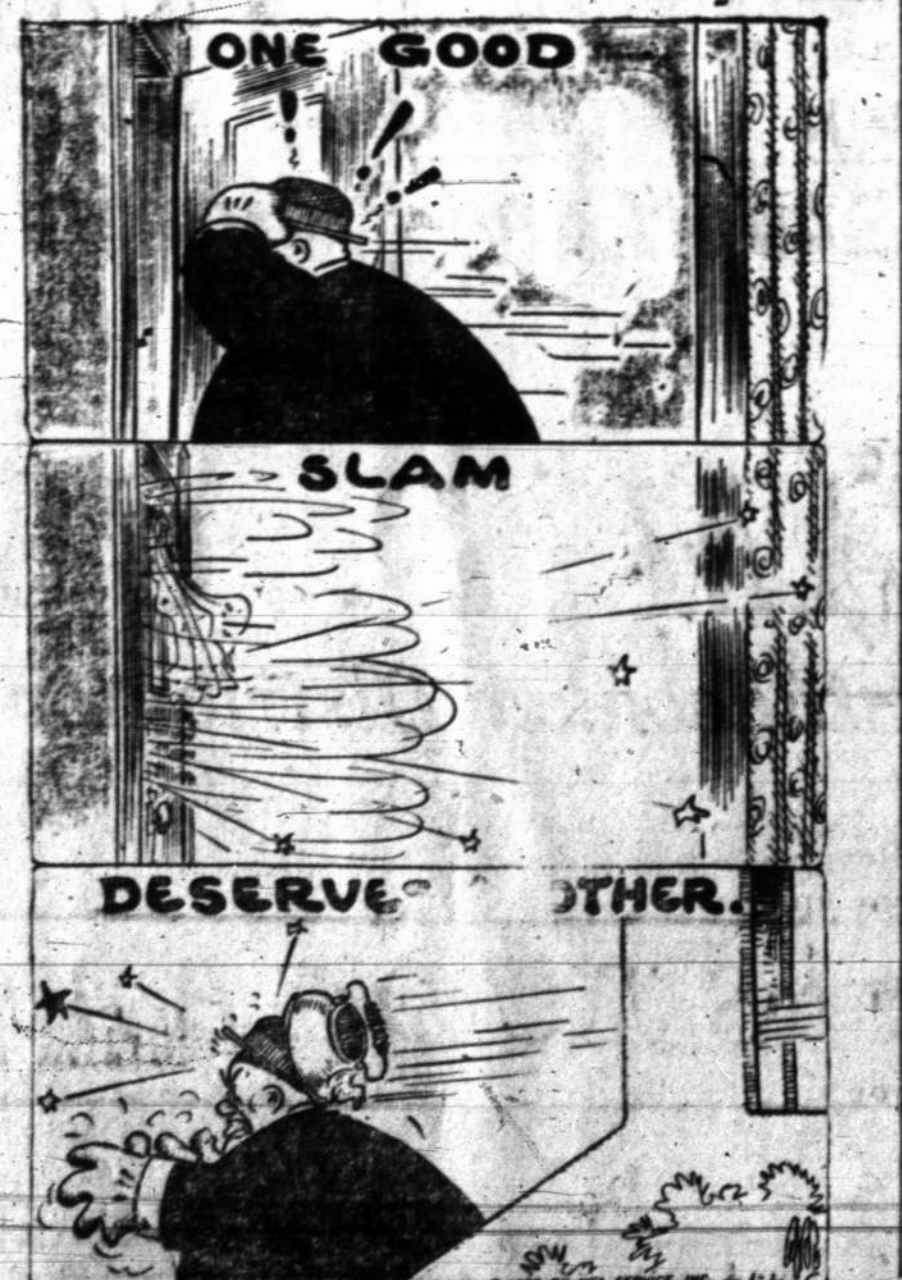

Louie Moore Will Seek Re-Election To Present Office

Louie F. Moore, clerk of the district court in Lubbock county, holds a record that probably has not been equalled by any man near his age in public office in West Texas, having been elected to the office which he now holds for three consecutive terms without an opponent. He has held the office since it was created in 1920.

And now Mr. Moore has announced that he will again seek the office for the fourth term, subject to the action of voters in the Democratic primary next July. Mr. Moore came to Lubbock ten years ago this month, since which time he has been engaged mostly in work of the nature that he is now doing. He worked for a time in the office of tax assessor R. C. Burns in 1917, then worked as deputy county

clerk under Sam T. Davis for the greater part of the remaining time that Mr. Davis held that office. He was elected district clerk in November, 1920, when the district office was made separate to the county. He has been a leader in city activities during his ten years spent here, and holds the distinction of having submitted the slogan that is now used by the city of Lubbock, "The Hub of the Plains." It was only a few days after Mr. Moore came here in a city-wide contest in which several hundred slogans were submitted to a committee.

American Steamer Over-Due At Port

LONDON, Jan. 1. (AP)—The American steamship Cotopaxi has been posted at Lloyd's today as "very much overdue."

The Cotopaxi, bound from Charleston, November 29, for Havana, is supposed to have been lost with her crew of 39 men. Owners of the vessel, the Clyncfield Navigation company, of New York, have had no advices from the vessel crew since she left Charleston.

YOUNG PEOPLE IN CHURCH BIG PROGRAM

MEMPHIS, Jan. 1. (AP)—The church that learns how to make use of the energies, talents and other resources of the young people of today is the church that will tomorrow accomplish most toward the completion of the unfinished task of her Lord and Master, declared Dr. Norman E. Richardson, of Northwestern university, before the Methodist Young People's convention in session here today.

An outstanding characteristic of our modern civilization, he said, "is the universal use of mechanical inventions

to save time, energy and occupational talents. The result is that larger areas of leisure are being created. "Economists are teaching us that if everybody should work enthusiastically with the most improved labor saving devices and to the best vocational advantages, the world's work could be done on the basis of a four hour day. "Our problem is to find what to do with the remaining 20 hours. There is enough leisure being spent in idleness and non-productive types of activity to carry on all the activities required to sustain and maintain the kingdom of God on this continent. There is enough time if it only was available to run all the churches, hospitals, schools and other institutions needed, were the kingdom of God in full operation.

"The ethical ideas of our youth are being influenced by the movies more poignantly than by all the Sunday schools, Epworth Leagues and Missionary societies combined. The motion picture, dramatic art, physical prowess and group competition should be Christianized and included in a comprehensive program of church centered, home centered and school centered recreation.

New Cabinet Has Begun In China

PEKING, Jan. 1. (AP)—A new cabinet with Hsu Shi-Ying, former minister of Justice, as premier, and C. T. Wang, former President of the Senate, as foreign minister, was announced today. It will succeed the old cabinet which was virtually non-existent through resignations after the recent shifting of the political balance.

Spanish Press Is Busy In Attacks

MADRID, Jan. 1. (AP)—The Spanish press is continuing its attacks against the United States in connection with the ban placed by the American gov-

ernment on the importation of rubber and coffee. El Debate says the financial and commercial aspects of American Foreign policy are ruining Europe. "North America," it declares, "will not be content until it has captured all markets and dominates all production and makes Europe her vassal."

DALLAS—More than 100 persons celebrated the New Year in liquor parties in Dallas hotels were ejected from their rooms by federal officers and hotel authorities. About 75 per cent of those ousted were women. A quantity of liquor was seized but no arrests were made and no complaints had been filed early today.

WHERE, OH WHERE HAS MY LITTLE PRINCE GONE, IS CRY AS SEARCH OF QUEEN MOTHER FOR SON OPENS

(By Associated Press)
PARIS, Jan. 1. — Queen Marie of Rumania, is searching far and wide for an errand son, Crown Prince Carol. Since he attended the funeral of Empress Queen Alexandra in London, Carol has failed to show up at the royal palace in Bucharest.

The sunny skies of Italy and a beautiful Italian woman, prominent in the social realm, are declared to be the chief attractions which are keeping the 32-year-old heir apparent in the throne of Rumania aloof from the royal domicile. In other words, it is whispered in Parisian circles that Carol has suffered another heart attack, his third. Venice, Turin and Milan recently have seen much of Carol and in recording his movements in these places where European society gathers for rest and entertainment, the newspapers have mentioned the name of the Italian woman alongside of his.

He Runs Away
During the stay of Carol in Milan as an emissary of Queen Marie was dispatched there with orders to bring back the royal wanderer to Rumania forthwith. The Crown Prince, however, quickly departed for Ravenna, but left there a few hours later with Vienna his supposed destination.

Rumors have it that the purpose of Carol has become somewhat depleted and that he is in need of its replenishment. The daughter of Queen Marie, however, is said to have instructed Italian and Austrian bankers not to supply her son with money, except an amount sufficient to pay his first class fare, alone, back to Bucharest.

Married Twice
Carol has been married twice, once temporarily to Mile Zita Lambrino, the daughter of a Moldavian professor, of good birth, but poor, and the second time to Princess Helen, of Greece.

For some time after Carol's marriage in Odessa with Mile Lambrino, the Rumanian court was much perturbed for Carol was said to have announced that he would stick to his wife and renounce his right to the throne.

The courts of Rumania held that his marriage was null and void because it was solemnized while he was under an incognito. Carol then left his morganatic wife and married Princess Helen, of Greece, daughter of the late King Constantine. Allegedly it was through the skillful work of Queen Marie, who has the reputation of being an astute politician and matchmaker that the marriage was brought about. At the time it was said that the union was desired with a view of cementing the bonds between Greece and Rumania. Some time afterward came the report that Carol and Helen had separated and that the princess would ask for a divorce.

Crown Council Convenes
BUCHAREST, Jan. 1. (P)—Because of the gravity of the political situation created by the absence of Crown Prince Carol, a crown council was summoned unexpectedly today.

A crown council differs from an ordinary cabinet council in that besides the members of the government all former premiers and the leaders of the various political parties are invited to participate.

'We Believe That Christ Lived' Is Statement Of Jew
FORT WORTH, Jan. 1. (P)—"Just a tempest in a teapot, we have always believed Christ was a man and not a myth," Rabbi Harry A. Merfeld of Temple Beth El here, said today of the published criticism of Rabbi Stephen F. Wise, which caused the latter to offer his resignation as chairman of the United Palestine Appeal.

"This same discussion arises in our midst every year," said Rabbi Merfeld, whose congregation belongs to the Reformed Church.

Masons Probing Attacks Against European Lodges

WASHINGTON, Jan. 1. (P)—Take official cognizance of reports that members of Masonic bodies in some European countries are being persecuted and even murdered, the supreme council of Scottish Rite Masonry, Southern Jurisdiction, has adopted resolutions calling upon the American government to protest to the foreign governments involved.

FARM CONFERENCE ANNOUNCED BY JARDINE

WASHINGTON, Jan. 1. (P)—A conference for the discussion of the agriculture surplus question has been called by Secretary Jardine to convene here January 12. It will be the first of a series of conferences planned by the secretary for this purpose.

The date coincides with that for the first day's session of the fourth National Co-Operative Marketing conference to be held here and many leaders in agriculture areas are expected here for both meetings.

Those invited by the agriculture secretary to attend the farm surplus gathering include former Governor Lowden, of Illinois; Sam Thompson, president of the American Farm Bureau Federation; Aaron Sapiro, attorney for a number of co-operative marketing organizations, and editors of leading agricultural publications.

BIG DAMAGE SUIT IS FILED ON LUBBOCK

A suit against the city of Lubbock, seeking collection of alleged damages in the sum of \$25,000, as an outgrowth of the death of Claude Thompson, automobile mechanic here last July, was filed in District court late Thursday by the wife of Thompson through her lawyers, Bledsoe, Woodward and Higgins.

The complaint sets out that Thompson was killed by an electric current from the city power plant while he was engaged in repair work on an automobile in the Gentry garage on July 5, and charges that negligence on the part of the city was responsible for the accident. The petition sets out further that the earning capacity of the deceased was the only means of livelihood of his wife and four-year-old child.

This is the second suit of the same nature filed in district court here recently, the other being filed by E. H. Wilson and son, Harold II, claiming damages in the sum of \$15,000 as a result of a burn sustained on the hand, arm and body of Harold, when he came in contact with a live electric wire from the city plant.

The two cases probably will be called in the next term of district court.

GENEVA, Jan. 1. (P)—The difficulties between Switzerland and Soviet Russia growing out of the assassination of Vaslav Vorolsky in 1923 took a new angle today when the Swiss government sent a communication to the League of Nations, declaring that the question should in no wise affect the problem of Russia's attitude toward the League and her participation in the forthcoming disarmament conference.

NEW YORK, Jan. 1. (P)—Frank Shields, of New York, national boys outdoors champion, will meet Walter Bonas, of Elizabeth, N. J., in the final round of the National Boys' indoor tournament today. In the semi-finals today Warren defeated Cohen, of Kansas City, 2-6, 6-1, 6-1, while Thomas won from Robert Osham, of New York, 6-0, 6-0.

Deputy Dies From Bullet Of Bandit

BATON ROUGE, La., Jan. 1. (P)—John Lejune, deputy sheriff of East Baton Rouge Parish, who was shot Saturday night while trying to arrest Alton Jones, an escaped lunatic, died today. He leaves a widow and seven children.

ANNUAL BANQUET CELEBRATION MARKS CLOSING OF OLD YEAR FOR LUBBOCK FIRE DEPARTMENT

The Lubbock Fire department, including both paid members and volunteers, together with several special invited guests, including newspaper men, Geo. C. Wolfarth, Fire Commissioner of the city, A. B. Davis, manager of the Lubbock Chamber of Commerce and incoming City Manager, and J. Sherrod, chairman of the Public Relations committee of the Chamber of Commerce, very fittingly saw the old year 1925 go into history, and the new year ushered into being last night in the lobby of the Fire station when one of the most sumptuous banquets ever witnessed here was spread before the gathering. Suffice it to say that ample justice was done by attendants to the menu provided largely through the efforts of Mrs. Joe Wolfarth, wife of fireman Wolfarth, but when chairs were pushed back from the feast, it appeared as though approximately thirty hungry men had not just finished, so great was the supply.

The meeting was purely informal, as the usual custom on occasions of this kind, and was presided over by Oscar Phillips president of the Firemen's association here. Several short, peppy talks, all extemporaneous, served to liven up the meeting following the feast.

Newton Recounts History.
The history of the department from its infancy was recounted briefly by Roche Newton, who has been a member since organization. He told of the first struggle of a few straggling boys, purely volunteers, in their efforts to keep down the fire loss here, of the purchase of a hose cart, which was the first piece of equipment, of the times when the boys used to drag this cart behind a wreck of an automobile in answer to alarms, and of the gradual addition of equipment until now the local department is considered as one of the most efficient in the state.

Then in line with this, Fire Chief Twitty told of the work of the organization the past year, saying that 103 calls had been answered during the year with a total property loss of approximately \$55,000, \$11,000 under the loss during 1924 despite the fact that property valuations have practically doubled during the time. He outlined recommendations that had been made to the City Commission whereby saving of two per cent on insurance rates could be effected through purchase of

two additional pieces of equipment, and cited figures to show that these two pieces could be paid for in savings on insurance premiums over a two-year period. These two pieces are a chemical truck and a chief's car. He also explained that the state fire insurance commission had recommended opening of a sub-station somewhere in the southwest part of the city, and that this would take a big slice off insurance rates.

Civic Asks Co-operation.
A. B. Davis, manager of the Chamber of Commerce, who today takes over the managerial reins of the city government followed Mr. Twitty with a few jokes directed at individual attendants at the party, and issued a plea for whole-hearted co-operation of the fire department with other divisions of the municipal government.

George C. Wolfarth, Fire Commissioner of the city, then told briefly of the struggle that the present administration has had in meeting demands made upon it for extensions of various utilities, including the fire department, saying that when the present commission took over the affairs of the city, the finances were in such condition that many pleas for these extensions were necessarily denied, but that the City Commission stood ready at any and all times to meet every demand made upon it as far as is possible. He told the gathering that the commission now has the recommendations of Chief Twitty and the state commission under advisement, and would, as far as possible, meet the requirements.

Other speakers of the opening included B. Sherrod, who boasted of having not missed an annual banquet

of the Fire department, in three years, saying he would not miss another if given an opportunity to attend; W. C. Bryan, former president of the Firemen's association; Neal Douglas, Alex. McDonald, Bob Hurst and Fireman White.

The assembly joined in an unanimous vote of thanks for the efforts of Mrs. Wolfarth in directing preparation of the feast, and expressed regrets that it will now lag a full year before another such occasion, but great strides forward are promised by the Fire department if given reasonable co-operation of the public of this city, during the coming year.
