HOME TOWN TALK

Colorado's office for marketing cotton through the Texas Cotton Co-operative Association, representing the federal farm board, is opening, can through it observe at close range whether Howard county farmers and business men lost anything by failure to provide for such an office here.

Howard is listed with the drought stricken counties of West Texas for which Governor Moody and his state relief committee are seeking special farm aid. Parts of Howard are suffering from lack of moisture but, as a whole, the county is in much better condition than most any other in all of West Texas.

However, crops throughout the county, generously moistened not so long ago, are beginning to show results of a prolonged siege of dry and extremely hot weather. More rain will be needed to make a good cotton crop and failure to get it will materially curtail production of feedstuffs.

Active support of Fort Worth has been promised the Texas & Pacific Northern in its fight to gain permission to build a 333-mile railroad north from here. That means much for the cause. Amarillo and Lubbock apparently will do their parts. All towns along the proposed route have promised to do all possible.

The discordant notes are from three other West Texas towns—Midland, Odessa and Pecos.

Midland's chagrin is of course, natural. The folks out there have long hoped for a north-and-south railroad, just as we have. The same goes for Odessa.

But were wondering why Midland and Odessa and the Santa Fe have not done something about it through these many years and why they suddenly see the wisdom of building a road along a certain route when the Texas & Pacific takes the bull by the horns and announces its intention of building a new road, with a terminus in Big Spring, where there are incomparable terminal facilities.

Speaking of railroads through Midland and northwest, we are reminded that Midland once had a railroad north to Seminole and that it couldn't be made to pay and had to be abandoned.

You've got to show the I.C.C. you know, that the country and the towns along your proposed route are of sufficient strength and importance to support a first-class railroad.

Plainview has announced informally its intention of fighting the proposition. The folks up there don't seem to relish the idea of running a line from Dimmitt to Amarillo, leading so near north-west of Plainview but not touching Plainview.

Oh, boy, what a scrap this is going to be!

Magnitude Of City's Railroad Task Is Emphasized

WOODWARD ADDRESSES KIWANIANS

San Angelo, Carlsbad Men Are Heard At Luncheon

The community's principal subject of conversation this week—the Texas & Pacific Northern Railway—was the topic of one of two addresses at the Kiwanis club's luncheon Thursday at the Crawford. Garland Woodward, a member of the railroad committee, and Rev. R. L. Owen were the principal speakers.

Winters Heard
Talks were given by A. J. Crawford of Carlsbad, N. M., Walter Buck and J. E. Young of San Angelo, the latter two being pioneer Kiwanians, and Buren Edwards, former Big Spring high school athletic star, a recipient of the Kiwanis scholarship.

Nat Shick was program chairman of the day.
The club votes to meet Friday, September 19, instead of Thursday, as usual, in answer to a request from the local Dental Society, which seeks to have all local luncheon clubs meet that day, the first of the two-day convention here of the West Texas Dental Association.

"It is needless, of course, to break the railroad news," said Mr. Woodward. "Last Monday morning I heard the greatest piece of news I believe a West Texas town has ever received in so short a time and so unexpectedly."

He said the hearing before an Interstate Commerce Commission examiner on the Texas & Pacific Northern's application to build into the Panhandle from here likely would be opened about December 1 and that it probably would be held at some plains point.

To Be Expected
"From the Santa Fe we must expect bitter opposition," said the speaker. "Getting this road would be worth as much or more than an oil field. It would make us near neighbors to people who are now only distant neighbors and they live in a section that is settling very rapidly. It will take much work to win this fight. Every man in Big Spring has a duty to perform. I understand many land owners along the route in this county have signified their intention of donating rights-of-way. I hope we will be the first to have all of our part of the right-of-way provided."

"I might add that I believe that in 24 months you can buy a railroad ticket in Big Spring for San Angelo and points south," he concluded.

Rev. Owen's address was inspirational on the subject, WHY GO TO Lubbock Convention? Efforts are being made to get more than half of the local membership of 63 to attend the district convention of Texas and Oklahoma Kiwanis in Lubbock next Monday, Tuesday and Wednesday.

Walter Buck
Mr. Buck, who has attended ten district conventions, urged the Kiwanians to take advantage of an opportunity to attend one so near home. Mr. Young said that "you haven't got an easy job in winning the fight to build this new railroad. We, too, are hoping that before long a railroad will link you and our own home city, San Angelo."

Mr. Crawford, Carlsbad capitalist and owner of the Crawford hotels here and in Carlsbad, pointed out anew the value of the projected road and declared it would make Big Spring the largest city in this section of the country.

Buren Edwards, who will attend Kansas University this fall, partly on funds provided by the Kiwanis scholarship fund, said he would "try to show my appreciation by making good."

Cecil Collins was a guest of the day.

West Texas Oil Proration Order Delayed Month

AUSTIN, Texas, Aug. 28 (AP)—Formal orders embodying proration regulations for all Texas oil fields in which curtailment regulations have been agreed upon were prepared today by R. D. Parker, oil and gas supervisor for the state railroad commission.

These include all Texas oil producing areas except the West Texas, where the Big Lake field is still in controversy, and the Gulf coast field, held in abeyance for thirty days.

Parker said the commission had agreed upon the disputed Crane-Upton fields, allowing them 29,000 barrels with all of the McElroy ranch included except the north tier of four sections.

The remaining sixteen sections, with a production of about 6,500 barrels, will be considered in the West Texas area, subject to the regulations for the Crane-Upton field.

No mention was made in this order of the air and gas lifts used by Gulf and Texas in the field. Gulf had requested the commission to exclude the use of air and gas lifts as artificial stimulation of production out of keeping with the spirit of curtailment.

Mrs. Hilliard In City Office

Mrs. H. D. Hilliard will act as city tax assessor until Jan. 15 it was announced today by V. R. Smith.

Mrs. Hilliard is the wife of H. D. Hilliard, who resigned as city secretary and tax assessor a few days ago to take over the agency of the Simms' Oil Co. Hilliard's resignation was voluntary, according to the records of the city.

Mrs. Hilliard has been engaged by Mr. Smith to serve until J. O. Tamsitt will be able to take over the duties of the office.
Tamsitt was appointed by Smith to serve as the city tax assessor to succeed Hilliard. The appointment was approved Tuesday night by the city commission.

IRA WELL FLOWS OIL

SNYDER, Tex., Aug. 28 (AP)—The Harmon Seifert No. 1 Murphy well near Ira was shot late yesterday with the well making a head over the derrick spouting ten minutes.

The present depth where shot was made at 3100 to 3140 feet was estimated good for 500 barrels. The well will next be shot at 2800 to 2890 pay depth and with gas showing expert oil men believe the well is good for a thousand barrels a day.

Cross Plains Man Held In Shooting

BAIRD, Aug. 28 (AP)—A. C. Harding, 28, oil worker of Cross Plains, was released under \$1,000 bail today charged with assault to murder in the shooting last night of H. Chrisman, Clyde oil driller. Chrisman was shot on the main street of Clyde by another man in an automobile.

Harding surrendered at Cross Plains late last night. He blamed domestic difficulties for the shooting. Chrisman, in a hospital at Abilene, was expected to recover.

Neighbors Visit New Nominee At Home On Bay

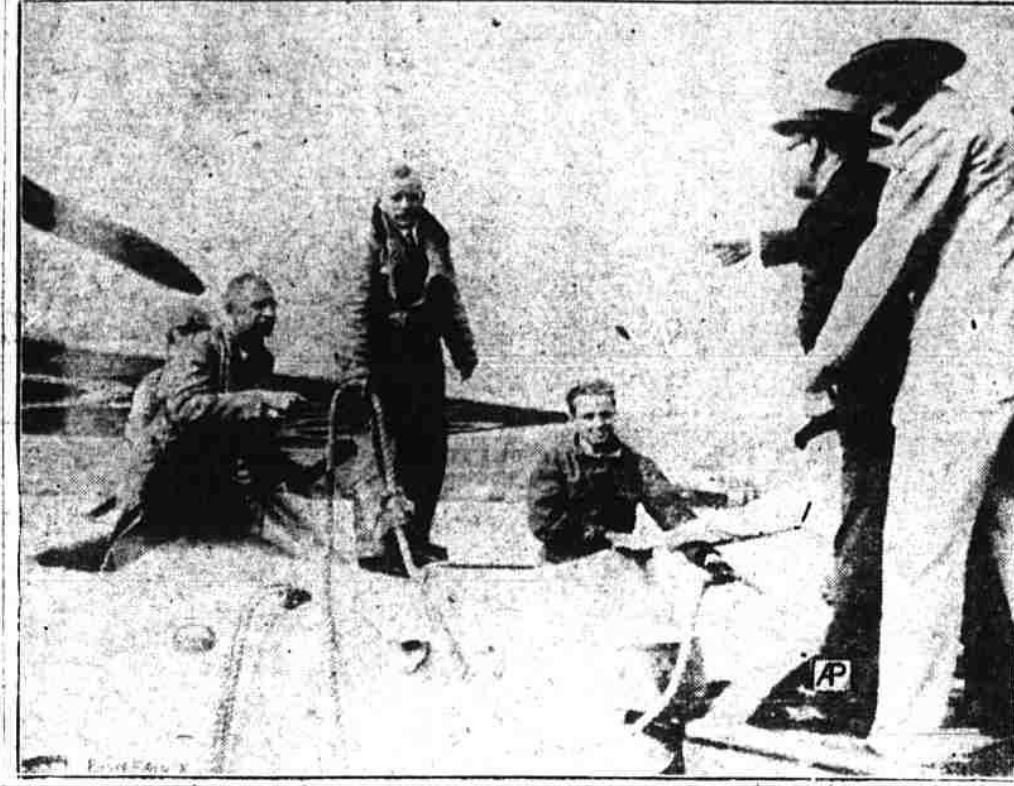

11,000 VOLTS RECEIVED; MAN WILL RECOVER

W. A. Shaw, 307 West 8th street, lives today to tell how 11,000 volts of electricity passed through his body while he was working at the Sweetwater sub-station No. 2, of the Texas Electric Service Co. He is in the Big Spring Hospital suffering from body burns as a result of the accident. He was burned at 2:15 o'clock Wednesday afternoon at the station. He was given emergency treatment at Sweetwater and brought to the local hospital.

He is an electrician working with the power department of the company. He was burned severely on the face and arms, with numerous scars to his body. He is not thought to be critically burned.

Payne Awaiting Jury Indictment

AMARILLO, Tex., Aug. 28 (AP)—A. D. Payne sat in his cell in the Potter county jail today awaiting action of a grand jury on charges of murder detailing that he placed a dynamite bomb in the family automobile which exploded June 12, killing Mrs. Payne and injuring their 11-year-old son, A. D. Jr.

Payne confessed the death plot. The grand jury had deliberated in the case since Monday, examining numerous witnesses, but when it retired last night had failed to take any action. An indictment was expected to be returned today.

Gasoline Tax For Month \$3,150,000

AUSTIN, Texas, Aug. 28 (AP)—The gasoline tax collection for this month of July will be approximately \$3,150,000 with five major companies paying two-thirds of the amount, according to the monthly report of George H. Sheppard, State Comptroller of Public Accounts.

The five major companies and their payments are as follows: Gulf Refining Co., \$614,060.24; The Texas Co., \$597,802.56; Magnolia Petroleum Co., \$462,511.96; Humboldt Oil & Refining Co., \$222,792.68; and Sinclair Refining Co., \$158,832.64.

DEFER REVISION

WASHINGTON, Aug. 28 (AP)—The Interstate Commerce Commission today postponed from October 1 to January 1, 1931, the date when its revision on grain rates becomes effective.

AT AIRPORT

A Lockheed-Vega plane, owned and piloted by J. C. Conner, Hobbs, N. M., spent the night at the local airport and took off for Hobbs this morning. H. C. Bruce and a Miss Brooks were passengers on the ship.

First step to increase Big Spring's water storage facilities from 1,125,000 gallons to approximately 2,500,000 gallons is taking a material shape as a crew of men is busy constructing one of the best reservoirs in West Texas.

A new 1,000,000-gallon steel and concrete structure is being built just west of the present reservoir at the city water plant. This is one of two new reservoirs which are under construction.

The million-gallon structure is said to be one of the most sturdy structures of its kind built in this section. Heavy concrete was being poured Wednesday and Wednesday night, the floor being completed early this morning.

8-Inch Floor

The specifications call for an eight-inch floor, but it will average 10 inches of concrete and steel. Following completion of the floor, work will start on the walls. Specifications call for a 10-inch wall of concrete and steel. Forms will be constructed for the wall next week.

When the new reservoir is completed it will have a diameter of 125 feet and will be eleven feet in depth. Dirt will be thrown against the walls to within one foot of the top of the tank. Beautification plans for the reservoirs then will be adopted.

The contract for construction of this structure and a 215,000-gallon reservoir is held by the Williams-Jacobson company of Amarillo. The cost of erecting the two vital assets to the water supply is \$15,105. The contract was at first held by a Sweetwater firm, but a mistake was found by the bidders and they asked to be freed from their bid.

Approximately 55,000 pounds of steel will be used in the two structures. Big Spring will have a water storage capacity of 2,400,000 gallons.

The entire construction job is under the supervision of Jim Winslow, Big Spring cement contractor who was engaged by the city to check the work.

Local Labor

Local labor is being used on the construction work. A large crew is engaged by the firm, paying 40 cents an hour for common labor. Even the operator of the huge cement mixer is a local resident.

The advantages of having the two additional reservoirs were pointed out Thursday by V. R. Smith, city manager, who also is giving the work his personal supervision.

Upon completion of the 1,000,000 structure it will be possible to drain the 1,125,000 reservoir which is now being used, without any danger to the city's water supply. Heretofore when it became necessary to drain the reservoir for cleaning, the city's water supply

YANKEE TEAM WHIPS BRITISH IN TRACK MEET

CHICAGO, Aug. 28 (AP)—Uncle Sam still reigns supreme in track and field athletics with emphasis on the "field."

Before a crowd of 43,000 spectators, the largest ever to watch a track meet on the American continent, the United States, for the third time, defeated the pick of Great Britain's track and field stars in Soldier Field Stadium last night. The event, conducted under artificial lighting, was more impressive than meets held in the day time and provided the throng with one thrill after another as Uncle Sam triumphed nine events to five.

The American team won over the Gallant Empire team in the same fashion they won the 1928 Olympic games at Amsterdam—by immense superiority in the field events. Not a point did the British score in the field, and had their field strength been comparable to their power in the distance races, the United States probably would have suffered defeat.

Eight meet records were wrecked, five of them by the American. Starting with the 400-yard relay, the opening event, the Americans went on to win the pole vault, shot put, high jump, 480-yard shuttle hurdle relay, hammer throw, broad jump, javelin throw and mile medley relay. The Brits triumphed in the one-mile relay, the four mile relay, two-mile relay, two-mile steeplechase, and three-mile team race.

While the wearers of the American shields were supreme in the field, the British gave them a man-sized lesson in the distance runs.

Records started falling in the first event. Russell Sweet, former Montana sprint star, Cy Leland, of Texas Christian University, Geo. Simpson, Ohio State comet, and Eddie Tolan of the University of Michigan, did 3:75 in the 400-yard relay to defeat Leigh Miller of Canada. W. B. Legg of South Africa, E. L. Page of England and Johnny Fitzpatrick of Canada and better the former mark of 3:78.

Tour of Proposed Rail Route Ended Big Local Party

C. T. Watson and R. L. Cook returned Wednesday night from a tour with Texas & Pacific officials of the proposed route of the Texas & Pacific Northern railroad, and reported citizens of every town along the line were enthusiastically pledging their support.

"That road will certainly traverse a wonderful country," Mr. Watson declared.

He said he had agreed to accompany T. & P. officials on another trip within the next ten days.

WASHINGTON, Aug. 28 (AP)—The Gulf and West Texas railroad asked the interstate commerce commission today to extend from 3 to 6 months the time authorized for beginning construction of a line of road in Gillespie, Mason, McCulloch, Concho and Tom Green counties.

The commission already has authorized the construction to begin October 1 and to be completed by September 30, 1932. The extension was requested because of negotiations for purchase of the road by the Southern Pacific.

NEW YORK, Aug. 28 (AP)—W. B. Storey, president of the Atchafalaya, Topeka & Santa Fe railroad, said today that the road should have a normal seasonal pickup in traffic this fall "although I think our loadings curve for the balance of the year will remain under corresponding curves for the past several years."

He said that the time of the movement of wheat which is now being held back in the road's territory is important because of the lower grain rates which probably will go into effect January 1 and on the basis of the average grain movement will cost the road \$2,500,000 a year.

The drought will have little effect on the road's traffic, Mr. Storey said.

"On the way back from the coast I was amazed at the fine condition of feed crops, outside of corn, and considerable corn will make feed," he said.

FERGUSONS "THROUGH"

AUSTIN, Texas, Aug. 28 (AP)—The statement "we never expect to seek public office again" has broken the silence James E. and William A. Ferguson had maintained since Mrs. Ferguson's defeat for the democratic nomination for governor in last Saturday's primary.

The statement was published in the Ferguson Forum, off the press today. Advance copies of it were given newspaper men yesterday in answer to repeated requests for a statement.

In the same editorial statement, signed "Ma and Pa," it was said that the Fergusons would always be ready to do their "mite" in behalf of the people and as the first contribution offered a legislative program consisting of five planks: abolition of the poll tax, defeat of the \$350,000,000 highway bond issue, investigation of campaign expenditures, investigation of the books of the state highway department and enactment of a law making the highway commission elective.

Governor Moody, when his attention was called to a statement in the Forum that the books of the highway department had not been audited for four years, said that the statement was not in accord with facts. "It's another one of Jim's bad dreams," he said.

Mrs. Ferguson did not congratulate Sterling on his victory because of a statement attributed to him which she considered derogatory, said another statement in the same issue.

LOCAL MEN TO WORK ON HIGHWAYS

AUSTIN, Aug. 28 (AP)—Employment of local labor on road work to give employment to drought stricken farmers has been agreed to by officials of the state highway department, Governor Dan Moody said today.

All contracts entered into by the state will contain the provision that the contractors employ their labor in the section where the road is being constructed whenever such employment is feasible, Moody said.

Buy Cotton
The governor also announced that he planned to ask executives of southern states join him in an appeal to the president for support of the "buy a bale of cotton" movement.

OPERATING INCOME OF TEXAS RAILROADS DOWN 51 PER CENT

AUSTIN, Aug. 27.—Railroads of Texas took in nickels this year where they garnered dimes last year, the state railroad commission has found.

Operating income of an Texas line for the first half of this year fell off 51.1 per cent, from \$14,623,134 the first half of last year to \$6,984,733 the same period this year, a consolidated report of the railroad commission shows.

Operating revenues dropped off 13.26 per cent, from \$117,923,770 to \$102,291,348, while operating expenses were being trimmed only 3.24 per cent, from \$90,219,132 to \$87,784,233.

This resulted in the operating ratio rising from 76.51 per cent last year to 80.93 per cent this year.

Principal items of revenues were \$82,657,852 from freight haulage this year, a decrease of 12.37 per cent from last year; \$10,932,267 from passenger service, a decline of 16.41 per cent; \$2,210,583 for mail, a decline of 25.14 per cent; \$2,733,770 from express, a drop of 11.18 per cent; and \$3,757,030 from other sources, a decline of 16.38 per cent.

Railroads spent \$19,907,753 on maintenance of ways and structures; \$35,420,035 on transportation; \$19,201,227 on maintenance of

equipment; \$3,303,146 on traffic expenses; \$4,942,325 on general expenses.

NEW YORK, Aug. 28 (AP)—Railroads reporting the result of July operations continued, with few exceptions, to show decreases in net operating income for the month compared with the like month a year ago. One of the exceptions was the Atchafalaya, Topeka & Santa Fe, which showed an increase of \$29,592.

Old Foes Matched In South Carolina Run-Off Primary

COLUMBIA, S. C., Aug. 28 (AP)—Political history repeats itself in South Carolina with Senator Cole L. Blease and James L. Byrnes, former congressman, thrown into a run-off primary for the Democratic nomination to the United States Senate.

Six years ago Blease and Byrnes went into a second primary and the nomination went to Blease by slightly more than 2,000 votes.

Democratic nomination in this state is equivalent to election.

Blease in returns from 1,246 of the state's 1,528 precincts in Tuesday's balloting held a command-

ing lead over Byrnes and Leon W. Harris, the third candidate. Olla D. Johnston, opponent of the state's \$65,000,000 highway bond issue, piled up a total of 92,591 votes as returns from 1,302 precincts in the gubernatorial race were tabulated.

Ira C. Blackwood trailed Johnston with 39,840 votes. Ashton H. Williams, who campaigned on a "wet" platform ran fourth with 31,152 votes. There were eight candidates.

SAN FRANCISCO, Aug. 28 (AP)—Mayor James Rolph, Jr., of San Francisco emerged victorious in the race for the Republican nomination for governor—a victory that has led to the governorship of California for every nominee of that party in the last 26 years.

The last unofficial tabulation of Tuesday's primary vote, with only 453 scattered precincts missing out of the state 10,283, gave Rolph 364,898; Governor C. C. Young, 339,913. Both Young and Pitts conceded victory to Rolph and sent their congratulations.

State Senator Frank Merriam of Long Beach apparently won the

Republican nomination for lieutenant governor, noosing out H. I. Carnahan, the incumbent, and State Senator Tallant. Tubbs of San Francisco. The latter ran on a "wet" platform.

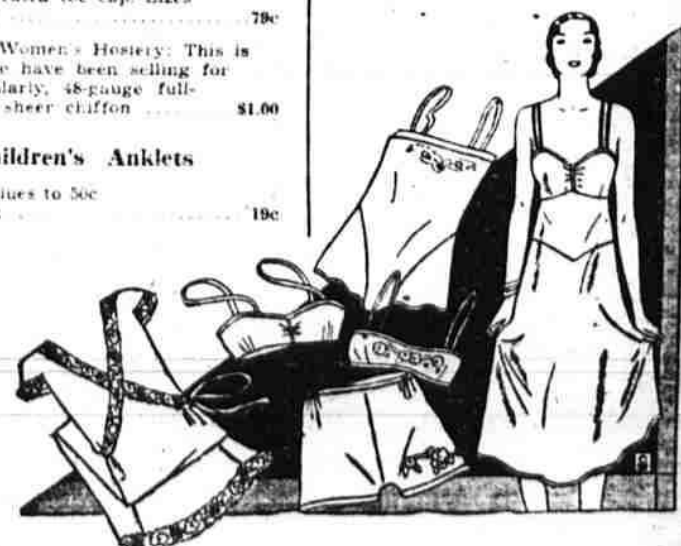

termining the meaning of a contract.

The question came up in a case from Page County in which land was sold with two mortgages upon it, and the clause describing them read thusly: "Subject to a first mortgage of \$11,000 with 6 per cent interest from March 1, 1925; and a second mortgage for \$1,000 with interest at 6 per cent from March 1, 1925, which second parties assume and agree to pay as part of the consideration herein." What is the effect of the semicolon: did the second parties assume the first mortgage as well as the second?

All the dictionary says is that the semicolon denotes a separation greater than that marked by the comma. But people are not experts in punctuation, and few of them read the dictionary. The Century dictionary says: there is much uncertainty about these marks. The supreme court of the United States has laid down the rule:

"Punctuation is a most fallible standard by which to interpret a writing; it may be resorted to when all other means fail; but the court will first take the instrument by its four corners in order to ascertain its true meaning." Look at the semicolon there!

In the Page county case the court had the same clause repeated in another instrument and there no semicolon or comma was used: there was no mark of any kind. That and testimony given of the conduct of the parties decided the case.

But here are the highest authorities in the state and in the nation declaring punctuation is no part of the English language. They are one with E. E. Cummings and James Joyce and Gertrude Stein and all the rest of the modern novelists and poets who have discarded quotation marks and commas and even periods.

Why Argue?

A LIGHT truck driver in a mid-western city stopped at a main street. Directly behind him came a passenger car, whose driver thought he could squeeze through to the truck's right, preparatory to making a right turn.

In doing so, however, the passenger's bumper tore off the fender of the right truck. Both drivers, as is the American custom, got out to argue the passenger car motorist explaining to the other that, since his car wasn't insured and the truck was, it might not be amiss for the truck driver to assume all the blame and let bygones be bygones.

That, too, seems to be a quaint American custom. However, the truck driver was obdurate. He didn't want to imperil his job by not making a statement, especially since the cost of replacing the fender wouldn't be so much. An argument ensued, of course, but the end was tragic. The passenger car driver turned out to be an amateur boxer, and he gave the truck driver such a sound beating that the unfortunate victim is said to be permanently disabled.

All of which may not, from first glance, seem so very significant to us far from the scene. But it reflects an important lesson anyway. Gentlemenly discussion of an unfortunate accident, no matter how trivial or how severe, will get you much farther than any temperamental outburst.

And if the other fellow refuses to meet you on that level, it is wisest to make note of license numbers and witness and retreat quickly on the Faustian principle that "The better part of valor is discretion."

Conventions

BIG SPRING and other cities with sufficient hotel facilities can profit much by entertaining the large conventions, especially during periods such as this when the volume of retail trade is lower than usual.

Not only hotels and cafes but practically all branches of retail trade profit either directly or indirectly.

In a few days Big Spring will entertain the West Texas Dental Association. Next spring the West Texas Druggists will be here, and this autumn the Texas Synod of the Presbyterian church.

With opening of the Settles Hotel there will be plenty of accommodations here for state as well as regional gatherings.

One of the principal lines of endeavor of the Chamber of Commerce and the citizenship at large should now be toward lining up a number of large conventions.

Much money is invested in the three larger hotels. And, we must not forget there are several other hotels here which, though not so large, offer strictly modern accommodations. They can very handily use a few thousand convention reservations.

With the conventions comes a need for additional care and activity toward making visitors feel at home. We must intensify civic hospitality.

No Punctuation

Des Moines Tribune-Capital.

THE courts do not think much of punctuation. The supreme court of this state has just decided punctuation marks are "no part of the English language." It will not reward them highly in de-

termining the meaning of a contract.

The question came up in a case from Page County in which land was sold with two mortgages upon it, and the clause describing them read thusly: "Subject to a first mortgage of \$11,000 with 6 per cent interest from March 1, 1925; and a second mortgage for \$1,000 with interest at 6 per cent from March 1, 1925, which second parties assume and agree to pay as part of the consideration herein." What is the effect of the semicolon: did the second parties assume the first mortgage as well as the second?

All the dictionary says is that the semicolon denotes a separation greater than that marked by the comma. But people are not experts in punctuation, and few of them read the dictionary. The Century dictionary says: there is much uncertainty about these marks. The supreme court of the United States has laid down the rule:

"Punctuation is a most fallible standard by which to interpret a writing; it may be resorted to when all other means fail; but the court will first take the instrument by its four corners in order to ascertain its true meaning." Look at the semicolon there!

In the Page county case the court had the same clause repeated in another instrument and there no semicolon or comma was used: there was no mark of any kind. That and testimony given of the conduct of the parties decided the case.

But here are the highest authorities in the state and in the nation declaring punctuation is no part of the English language. They are one with E. E. Cummings and James Joyce and Gertrude Stein and all the rest of the modern novelists and poets who have discarded quotation marks and commas and even periods.

The Sheikh had said publicly that she was fit to be the mother of warriors. But Dagger had no instinct for motherhood, no more inclination to enter a harem than to reign in the Hotel de Pontoise.

All she wanted or needed was the stimulation of her search for the ashes of Howard's memory—for that was what it amounted to.

And so one morning she said goodbye to the Sheikh and her other friends, and climbed upon the camel the Sidi held for her. He went with her, he and an escort of picked fighting men. It was no trouble, he assured her, in reply to her protestations. There was work for him in Libya and Egypt. The construction of the reservoir is part of the water department expansion program which Smith and others sponsored in a bond election last March. In addition to the tanks, new wells will be drilled and additional lines placed.
