Menu For Today

BREAKFAST—Orange juice, cereal cooked with figs, thin cream, crisp bran toast, buttermilk, pancakes, syrup, milk, coffee.
LUNCHEON—Cauliflower soufflé, toasted graham muffins, celery heart, peach rice pudding, milk, tea.
DINNER—Baked fish with oyster sauce, baked potatoes, scalloped tomatoes, pear salad, peach and cantaloupe, shortcakes, graham bread, milk, coffee.
Equal parts of peaches and melons cut in uniform pieces are combined with orange juice and sugar and used with a rich baking powder biscuit dough for the shortcake. This way of using cantaloupe makes it possible to salvage those that do not seem sweet enough for "plain" serving.
Cauliflower Soufflé
One small head cauliflower, 2 tablespoons butter, 2 tablespoons flour, 1 cup milk, 1/2 teaspoon salt, 1-8 teaspoon pepper, tablespoon minced sweet pepper, 3 eggs.
Let cauliflower stand head down in salted water for one hour. Cook in boiling water, heads up for ten minutes. Drain and chop. Melt butter, stir in flour and slowly add milk, stirring constantly. Add salt and pepper and cook until smooth and thick. Add minced pepper. Beat yolks of eggs until thick and lemon colored and stir into hot sauce. Remove from heat and let cool while beating whites of eggs until stiff and dry. All cauliflower to sauce, fold in beaten whites and turn into a well-buttered baking dish and bake twenty-five minutes in a moderate oven. When firm to the touch the soufflé is done. Serve at once.

ARE COLLEGE DAYS WASTED?
H. G. Wells now comes out with an article on colleges. In letters two inches high he tells his public that "The Four Years in College Are Wasted."

They mean nothing. There is no presumption that the man who has the diploma or whatever they call it, of M. A. is even a moderately educated man."

Overrated centers, only to find themselves confronted with pleasant, easy-going, evasive young men up to nothing in particular and schooled out of faith, passion and ambition."

New Yorker Here Looking Over Cotton

Mr. Harrower is on his regular annual inspection trip of the cotton growing states gathering statistics for the Wall Street Journal. "Conditions over the parts of Texas visited by me to date will not substantiate the recent large cotton estimate made by the government. However, the reports are as near correct as is possible, considering the many sources from which their estimates are received, and the government is taking every precaution to give absolute accuracy in these cotton estimates," said Mr. Harrower. "In the southern part of Texas the flea has caused great damage. Also root rot has done considerable damage in sections. The top crops in the blackland belt is almost a failure caused by boll weevil and the middle crops are practically all they have left," said Mr. Harrower. CARDS INFIELD SAID SUPERIOR ON OFFENSIVE

REGULARS HOLD AVERAGE OF .293 AS AGAINST .274 FOR YANKEES

(By Associated Press) NEW YORK, Sept. 27.—Offensively the infield of the St. Louis Cardinals, champions of the National league, shows a slight superiority over the New York Yankees, coming to bat in behalf of the American league in the approaching world series.

The four regular infielders of the Cardinals have a batting average of .293 against .274 for the same number of players likely to occupy places in the Yankees' first line of defense. These running activities of the two quintets are not impressive, but the westerners maintain their slight edge here also, with a total of 37 to 29.

George Torporec probably will have a chance to look over the tops of his "spec" from an infield position for the Cardinals during the series. He has out-hit Mike Gazella, who has the first call as a Yankee infield substitute, .566 to .232. No excite whatever has been caused by the base running of this skillful but modest pair. Torporec having stolen one base and Gazella barely doubled his out put with two, neither has made any impression on the home run records.

Manager Hornsby, even though below his usual form, has out hit Tony Lazzeri but the Yankee second sacker has been more successful in negotiating triples and home runs, with a batting average of .317 compared to .270 for Lazzeri. Hornsby has made only five triples and 11 home runs while the former Pacific coast star has 14 three base hits and 15 home runs. Hornsby drove out 35 doubles to 27 for Lazzeri and they were all even in stolen bases, 11 to 11.

Lester Bell, Cardinal third baseman, has a better record than that of Joe Dugan who will play opposite him. On paper Bell is the best hitter in either infield. His average for the season is .329. Dugan has hit .284. Bell, however, has made thirty doubles, 14 triples, and 17 home runs while Dugan has been forced to satisfy himself with 20 two base hits, five for three bases and one for the circuit.

ROY AND PENCE TO MEET TODAY IN STEER RING

DALLAS, Sept. 27. (AP)—Deadlocked two-all in the seven game Dixie series following successive victories for the home club since, Dallas and New Orleans baseball teams were to tangle in the fifth contest here today, beginning at 3:30 o'clock.

Probable batteries are Roy and Dowle for the Southern association pennant winners and Pence and Billings for the Texas champions.

Yesterday's 3 to 1 victory for Dallas before 18,507 persons, a record Dixie series attendance, gave Dallas two triumphs in two games before home fans. The Pelicans had won the first two games before their home crowd.

Today's game may or may not be the last of the series here. Whether the Steers or the Pelicans win today, the game in New Orleans Wednesday may decide the championship as four victories will clinch the title. If the sixth game in New Orleans is not decisive, a coin flip will determine where the seventh will be played.

Old Master And Ex-Pupil Will Meet In Big Series

The 1926 world series will develop into one of those "homecoming" affairs.

The fall classic will have the old master and the ambitious pupil flavor.

That will be the official menu when the New York Yankees meet the St. Louis Cardinals in the annual play-off for the world championship.

Miller Huggins' first gained managerial fame as the pilot of the St. Louis Cardinals. He won 100 pennants.

But showed enough ability to cause the owners of the New York Yankees to want him over to their league.

His success as leader of the Yankees is too well known to need much comment. He has already won three pennants and one world series. He appears to be on the threshold of another pennant.

In the fall of 1915, a mere strip of a youth reported to the Cardinals for a tryout. He came to the club as a shortstop. Miller Huggins, then in charge of the St. Louis club, was impressed. However, the rookie appeared to lack the physical stamina necessary to stand the strain of the big league.

That young man was Rogers Hornsby. He has developed into the premier second-sacker of the majors. As a manager he has shown ability on a par with his marvelous play.

In connection I shall recall a story that Miller Huggins recently told me that best gives an idea of the determination possessed by Hornsby, and in a measure explains the success that has come his way.

After watching Hornsby in action for 18 games at shortstop, Huggins realized he possessed great ability, but was very inexperienced. It seemed he would need a year or two in the minors before he was ready for the big show.

Desiring to let Hornsby know that he was pleased with his showing and to prepare him for a possible trip to the minors for a year or two, he called him aside and whispered thusly: "I regard you as a big league prospect. Hornsby, but I don't think you are quite ready. It may be necessary to send you to one of our farms for a year or two."

It was the intention of Huggins to farm him to one of the minor league clubs with which St. Louis at that time had a working agreement.

Hornsby made no reply, but he took what Huggins said literally. He decided he wouldn't wait for the St. Louis club to send him to any farm. He went back to Texas and got a job on one himself.

Hornsby was just 19 years of age and growing fast. A winter on a ranch with its attendant hard work was just the thing he needed to round him out physically.

When he reported to the Cardinals the following spring, Huggins hardly knew him. He had put on about 25 pounds and looked the part of a big leaguer. He proceeded to prove it at once.

His work in spring training was so impressive that Huggins immediately gave up any thought of farming him out. During the season of 1916 he played 129 games for the Cardinals at shortstop, second base and third base.

Playing alongside of Huggins he picked up many of the fine points of second-base play at which Huggins was a past master.

However, as late as 1921 he played four positions for the Cardinals, three infield positions also in the outfield. At one time he took a whirl at first base.

In 1922 Hornsby came into his own as a second-sacker and since that time has been the outstanding player of the National league at that position, as well as at the bat.

Hornsby's career should be one of inspiration to every player ambitious to shine in the major leagues. His road to success was far from an easy one.

While it isn't generally known Hornsby was twice handed his release from minor league ball clubs. The early reverses, enough to discourage the ordinary youngster, simply told him fight back all the harder.

In the spring of 1914, Hornsby reported to the Dallas club of the Texas league for a trial. In the large number of rookies trying to impress the manager of the Dallas club, Hornsby was entirely overlooked. He drew his release April 25.

Willie, yes, anxious to accept chance in a league of lower classification, Hornsby signed with Hugo of the Texas-Oklahoma league. On July 2 of that year, Hugo passed him on to Dornison of the same organization. The following year while with Dornison, his work attracted the attention of the scouts of the St. Louis Cardinals and he was purchased for the sum of \$500.

Just think of it, Rogers Hornsby cost only \$500. In these days, players of far less ability bring 20 times that amount and then do not always deliver. There could be no stranger coincidence than the playing of the world series by New York and St. Louis with Huggins and Hornsby in the managerial roles.

It will truly be a case of the pupil pitting his stuff against the old master.

FOUR PITCHERS ARE MAINSTAY OF YANK SQUAD

PENNOCK, SHOCKER, HOYT AND REUTHER FIGURED TO WIN OVER CARDS

(By the Associated Press) NEW YORK, Sept. 27.—The five star pitching staff that carried the New York Yankees to victory in 1921-22 and 23 has undergone several changes since the American League last faced the National League opponents in a World's series. The New Yorkers will place their main dependence in the seven game series on Herb Pennock and Urban Shocker, aided by Walter Hoyt and Dutch Reuther. Bob Shawkey and Sam Jones will probably share the relief work.

Pennock is generally conceded to be the best left hander in the big leagues today. With over twenty victories to his credit the slender slinger of the Yankees has rounded out his best year in baseball. His control has been uncanny and he has pitched several games without a base on ball, something rare for a southpaw. Pennock employs a spinning curve that breaks down and in to right-hand batters and keeps them popping the ball in the air. He requires at least four days of rest between games and will doubtless face the National Leaguers in the first game. He beat the New York Giants two games in the World's series of 1923.

Shocker came to New York from the St. Louis Browns in a trade for Joe Bush. Shocker showed little last year because of illness but this season found him again the cunning spitter that made him so feared when with St. Louis. Shocker is a right hander and will doubtless be selected to pitch the second game of the series. He has won about a score of games this year. He has never been in a World's series.

Walter Hoyt started the season in a blaze of glory but an injured elbow threw him back and it was not until this month that he flashed his early season's form. Hoyt has been through the World's series five in the campaigns of 1921-22-23. His best record was in 1921 when he faced the New York Giants in three games and held them to two runs in twenty-seven innings of play. A bad error cost him one run. He lost his only game when his mates failed to score a run, the contest going to the Giants 1 and 0.

Dutch Reuther came to the Yankees from Washington by the water route the latter part of this season. His winning record was good with the Senators but there was a belief that he had reached the end of his effectiveness. Joining the Yankees Reuther pitched several good games and Huggins hopes to use him in the series. Last year he was not started against the Pittsburgh Pirates in the World's series either because of lack of training condition or the accepted belief that the Pirates were poison to left handers. Reuther pitched for Cincinnati in two games of the 1919 World's series, winning one and losing the other.

Sam Jones has been through the World's series mill. In 1915 he pitched the fifth game for the Boston Americans against the Chicago Nationals and was beaten 3 and 6. Jones only appeared for a couple of innings in two games of the World's series of 1922 when he pitched for the Yankees against the Giants but in the following year he faced the Giants in the October fray and lost a well pitched game 1 to 3. Jones held the Giants to four hits but Casey Stengel's home run beat him. In the final game Jones pitched the last two innings but the victory of the Yankees was credited to Pennock.

Braxton, a southpaw, Walter Beal and Myler Thomas, are second string hurlers of the Yankees but will not likely be seen on the mound.

ATHLETICS MAY DRIVE INDIANS OUT OF SECOND

WIN TWO GAMES SUNDAY AS CARDS AND YANKS START FOR BIG GO

(By the Associated Press) Only a lone fight for second place remained today in the hectic major league season as the National and American league clubs wind up the remnants of the playing year.

St. Louis has won the National League pennant, the Yankees are safe beyond fear of overthrow in the American league, but the Indians who fought the Yanks bravely throughout the closing days, now find the Athletics threatening to oust them from second money.

Indians Drop Two Philadelphia cut down the Indians twice yesterday, 8 to 5 and 2 to 0, and shaved the Cleveland hold on second place to two games. The Athletics, by whipping the Indians again today, and taking the three games left with Washington, can just nose out Cleveland for the runner-up position.

The season, ordinarily ending today, probably will drag through a few more games, until contests that have a bearing on changes in the standings are played.

Cincinnati nosed out the Cardinals 2 to 1 in the final game of the season for both teams. A ninth inning rally scored both the Reds raps.

The final standing of the leaders: Team W. L. Pct. St. Louis 89 65 57% Cincinnati 87 67 54% Dazzy Vance saved his best pitching performance for his last Brooklyn mound assignment of the year yesterday against the Cubs. Dazzy, winning 3 to 1, held the Cubs to three hits and 3 earned runs, equalling his best major league record. Jess Petty made it two for Brooklyn in the second game, 6 to 2. Both Ed Reubin and Chicago have completed their season's work.

Giants Win Double Bill The Giants wound up the season with two victories over Philadelphia both by scores of 3 to 2. Fitzsimmons and Greenfield pitched fine ball for New York. The Braves, idle yesterday, have three more contests with Philadelphia.

The American League closed its doors yesterday for all teams but Philadelphia, Cleveland and Washington. The Yankees lost two games to St. Louis, 6 to 1 and 2 to 2 with both teams working out reserves. Manager Slater pitched two innings for the Browns in the second fracas and kept the Yanks from hitting safely.

Detroit celebrated the last day of the season by beating Boston twice, 11 to 2 and 5 to 4. Manush, with six hits in nine times at bat, set himself to the forefront of the league batters.

The White Sox ended the campaign with a win over Washington, 7 to 4. Four Senator pitchers were touched for 15 hits.

Two trucks with ladders, hose and other apparatus will be used in the demonstration and about ten men will participate in the feat.

Full Speed promised The tower will be lighted with smoking red flames when the alarm will be sounded. The two trucks and the ten men under Chief W. E. Twitty will be stationed about the livestock barns.

The crowds will be kept back as the two trucks dash up at a terrific speed to connect up their hose and put the water to the burning building.

Long ladders will go up on the tower and the daring fire boys who protect Lubbock homes and business houses from fire damage will go up the ladder to rescue a person who will be in the burning tower. When the fire boys have rescued the person from the flames some of the members of the local boy scout troop will demonstrate life saving by artificial respiration methods and bring the victim back to life.

Big crowds are expected to witness the demonstrations which will be the first of its kind ever staged at the fair.

What's Doing On The Other Side

LONDON IS ENTHUSIASTIC OVER PEACHES GROWN IN AMERICA

BY MILTON BRONNER NEA Service Writer LONDON, Sept. 27.—A peach arrived here from California the other day. It was not at all fatigued by the long journey. Its features were the features of those which grow up in the wind and the rain. The warm rays of the California sun had kissed its cheeks until they were a rosy red. It wore the kind of blush that nature alone can give. There was nothing of the lipstick or the rouge pot. And a lot of experts in beauty and attractiveness said in their calm English way: "Sample it. It'll take four boxes."

For this peach was really a peach. It wasn't a California girl. It was part of one of the first shipments of California peaches ever made to this market. And, directly most of the better class fruitstands were displaying the luscious fruit and selling them like hot cakes at 6 cents apiece.

Clean at That Compared with the price of English peaches they were cheap at that. Because, you see, the only peaches ever grown in this cold and rainy climate are a few which come to ripeness on little trees that are crucified against a sunny wall, or those others which grow up in big greenhouses. Now it costs money to grow fruit that way. Hence English peaches cost anything from 12 to 25 cents apiece. They're not wind-kissed or sun-baked. They have some thing of a woolly taste.

In the winter London sees South African peaches, but they travel three weeks by steamer before they get here. And that doesn't improve them. Also, there are French and Italian peaches, but they don't have the size and flavor of the California article.

The men who sold the latter on London streets 12 days after they were picked in California orchards are highly pleased with their experiment.

More Next Summer Arrangements are already being made to increase the shipments next summer. So about July 1927, the chances are that the American tourists who come to London will see printed in large letters on the restaurant menus in their hotel: "California peaches. The kind you are used to at home."

It will be one more lesson in the way time and space are annihilated these days to satisfy appetites and pocket-books. The time is probably not far distant when a big wholesale fruit dealer in London will pick up his wireless telephone instrument, call up a big orchard owner in California and say: "Peaches ripe? Well, send me 500 bushels by air express via New York."

And that same day, by fast air express, the fruit will leave California landing in New York a couple of days later, where it will be transhipped to the fast freight air express bound for London and due there two days later.

California orchards to London tables in four days! It's a dream today. Tomorrow it may be a prosaic reality. Just as prosaic and everyday as Californians now find receiving their New York mail by fast air delivery.

COOLIDGE IS PINNING HOPES ON BUTLER

BY CHARLES P. STEWART NEA Service Writer WASHINGTON, Sept. 27.—Of all the senatorial campaigns now on, the one in Massachusetts is the most important to President Coolidge.

If his candidate for senator can't carry his own home state next November, the presidential prestige will suffer a job. There's little chance it can recover from.

The defeat of Senator Pepper in Pennsylvania, of Senator McKinley in Illinois, of Senator Cummins in Iowa, and of L. B. Hanna in North Dakota were setbacks for the president, but at least he was in a position to say, "Well, they weren't particularly my candidates."

There were, in reality, but he wasn't formally committed to them. But Senator William B. Butler, in Massachusetts, was his campaign manager in 1924, is chairman of the Republican national committee, figures as the president's personal spokesman in the upper house of Congress and it's in the president's own birth state that he's running.

Butler's renominated, but that was a foregone conclusion. He had no opposition. The job now's to elect him—no, not re-elect him. He's been serving hitherto by appointment, as the late Senator Lodge's successor. Now he goes to the voters, which is entirely different from being named by a governor.

The loss of any other state would be about the same thing as a slap on the president's wrist compared with a wallop from a pair of brass knuckles, if he loses Massachusetts.

Now Massachusetts is doubtful. It's particularly doubtful this year by reason of the contrasting makeups of the two candidates.

Two more widely different individuals don't exist than Senator William B. Butler and David I. Walsh, who opposes him on the Democratic ticket. It's impossible to judge in advance what a fight between them will be like. The campaign will have to develop it.

Walsh is a red-hot speaker, a spell-binder, the fruit of the first water, a political fire-eater, aggressive, magnetic, a liberal, a wet, highly popular, enthusiasm awakening.

Butler's cold, silent haughty. His dictatorial manner was resented in the Senate. Whether he's liked or not seems to be a matter of indifference to him. When he says anything, it isn't a speech. It's an order. He's a dry. In the whole country there isn't a more ultra-conservative.

At a guess, one would say the coming encounter would resemble an engagement between a cast-iron bull dog and a real live one—a live bull terrier, rather as peppy and more punishing.

The live animal's bound to excel in activity but he may break his teeth on the cast-iron article. In a word, this thing is going to be a clash between an irresistible force and an immovable body. What happens is sure to be interesting and instructive but it can't be forecast with any degree of certainty.

Senator Gillett beat Walsh two years ago, but that didn't signify much. It was a "Republican year." At that, Gilbert didn't beat him badly. Besides Gillett himself is popular—not marmite, like Walsh, but well liked. He was speaker of the House of Representatives, too, and his state was proud of him.

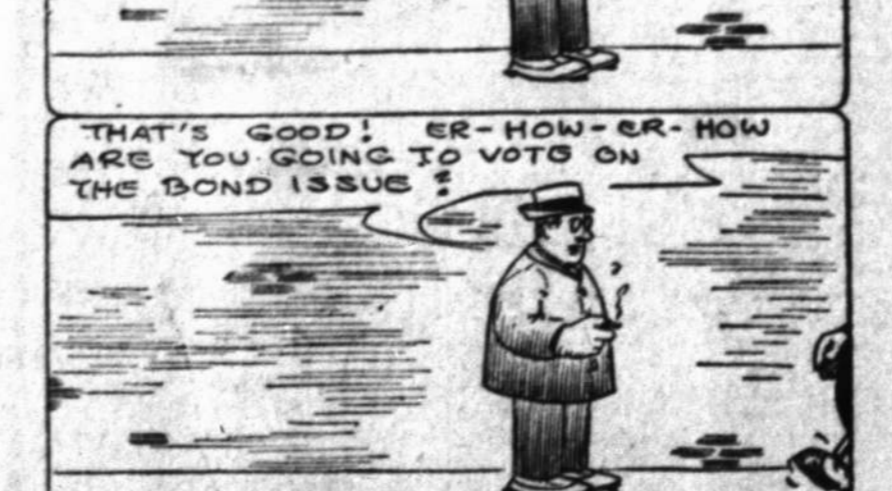

Helpful Health Hints

BE CAREFUL ABOUT YOUR TOOTHBRUSH

BY DR. MORRIS FISHBEIN Editor Journal of the American Medical Association and of Hygiene the Health Magazine

In advising the public regarding the proper care of its teeth, Hygiene has found the necessity for special emphasis on the care of the toothbrush. Realized of the vast amount of information that has been disseminated among the public in recent years, many persons continue to have teeth that are filthy with deposits of tartar, discolored with the accumulation of matter that is easily removable; loose because of unhealed infections, and, in general, a serious handicap to either social or business progress.

The Tooth Brush The toothbrush campaign has done a vast amount of good, but has not accomplished all that it might because of ignorance as to what constitutes a proper tooth brush, as to the proper methods of using a tooth brush, and similar considerations.

Dr. William N. Gardner points out that most of the tooth brushes on the market are too large for efficient brushing. The best tooth brush is small, with stiff bristles. These may be about seven rows long and three rows wide, of uneven length, and with the groups of bristles well apart. The handle should be very heavy, and at least six inches long so as to permit it to reach the molars.

All sorts of odd shapes and distributions of bristles are manufactured, but, so far as known, it is impossible to make a brush that will conform exactly to the dental arch both inside and outside. A small tooth brush with

HISTORY BACKS UP TOWNS OVER SOUTH PLAINS BANDS ARE TO ENLIVEN FAIR

MANY NAMED FOR PROMINENT INDIVIDUALS OR SURROUNDINGS

Towns on the South Plains didn't just happen—they were built for a purpose. A majority of them are comparatively new, but all of them have history. As a rule towns on the South Plains have been named after prominent people, though this is not true in every case. For instance Amarillo is a Spanish word meaning yellow and the city is said to have been named for coloring of the walls Palo Duro canyon.

Lubbock was named for Col. Thos. S. Lubbock, who with Col. R. F. Terry organized the famous Terry Rangers. Lamesa from the Spanish words "La mesa" meaning high or table lands because of its location on the plains. Slaton was named for O. L. Slaton; Plainview so called because of its location on a level plain.

Littlefield was named for the late Major G. W. Littlefield of Austin, while Floydada is going under an assumed name—it should be Floydada. Founders selected the name, but a government clerk made an error when he sent out a postal stamp, and since that time it has been known as Floydada. Uncle Sam doesn't make many errors, but when he does they are fatal.

43 STILL ENTOMBED IN MINE SHAFT

IRONWOOD, Mich., Sept. 27 (AP)—The sight of distressed women and children drove weary men to super effort today in their attempt to reach forty three men entombed by a cave-in three days ago in the shaft of the Faber mine of the Oliver Iron Mining company here.

Bodies of three men, crushed to death when tons of boulders and earth crumpled the cage in the shaft have been recovered. Three separate shafts, each having an objective the eighth level of the mine, 800 feet under ground, where it is believed the men were entrapped, are the means by which the rescuers hope to learn the fate of the imprisoned men.

At least one is expected to attain his objective by tomorrow night, although obstacles encountered in digging through the earth and rock prevents any accurate pre-determination of progress to be made.

Most closely watched is a diamond drill, which must bore 466 feet more before it can reach the eighth level. Communication can be established through this, if it is ascertained the men are alive. Food tablets, badly needed, if the men are alive, can be lowered then through the small drilled hole.
