I. C. C. TO ORDER BIG RATE REDUCTIONS

BRECK TANGLES WITH RANGER IN FOOTBALL FINAL

Visitors Have Heavyweight Backfield and Aim to Plunge Way to Victory.

Coach Brannon's Breck Buckaroos, in our midst with the avowed intention of collecting full measure of revenge from Ranger for the drubbing they received at Ranger's hands at Breckenridge Nov. 5, present a changed appearance when they gallop on the field at Nitro park this afternoon.

Captain Gordon Avery, most consistent ground gainer of the Buckaroos, who was the only back offensive against Ranger in the first game, has shifted from left half to quarter. Bull Rickels, 180-pound lad, with build like a red brick schoolhouse, is at full-back. Buck Williams is at left half in Cap's former place. He is the lightest of this trio, weighing 167 pounds. These backs, who will be counted on for much of Breck's offensive smashing, average 174 pounds. Two of them are youngsters who would do credit to many college elevens, to hear a Breck enthusiast tell it. At the other half is a small man, but fast, Flash Spears, who weighs 150. The flanks have been strengthened by Mac McArron at right end. He is a hard tackler. Dick Allbright is at the other flank.

Rooters With Team.

Eighteen men of the Breck squad and half a hundred rooters caught the early train from Breckenridge. X. Y. Zeverley, relief quarterback, was the only man to miss the train and he will motor through with a train of cars which will bring Breck supporters who were reluctant to arise for the early morning train.

With the improvement of Henshaw's leg, Coach Hart announced this morning that his Rampagers would go into the fray ready to put the brakes on, any time Breckenridge starts on anything but the reverse gear.

Both teams admit the game probably will be the closest and tensest they have played this season, but Ranger has whatever slight edge in morale a previous victory can add. While lighter than the Buckaroos, the Rampagers point to shifty footwork in the backfield, which has made many long gains this year, and to a line which no team has punctured consistently.

A. & M. HOPES TO AVERT KYLE FIELD DEFEAT

COLLEGE STATION, Texas, Nov. 24.—With the odds all the other way, Texas A. & M. stepped out to defend her goal on the football field against the University of Texas here today.

With this little college town crowded to overflowing with Thanksgiving football fans, one of the greatest battles of the season was expected. A. & M. has never lost a game on Kyle field, and this record means much to the Farmers. From the hope, the team from Austin should win by about 21 points, but the hope is not running true to form in most of the big games this season.

PRINCIPAL MEASURES PASSED BY CONGRESS

WASHINGTON, Nov. 24.—Here are the principal laws enacted by the special session of congress, now ended, according to the tabulation of Representative Mondell, Republican leader.

The anti-beer bill, banning beer as medicine and correcting the administration of prohibition.

The budget act, designed to put expenditures on a business-like, scientific basis.

The peace resolution, ending war with the Central Powers.

The veterans' bureau act, consolidating soldier relief agencies under a single administration.

The bill amending the war financing act to provide relief for the farming and livestock industries.

The maternity and infancy act.

The emergency tariff, imposing high duties on farm products.

Boy, 15, Slew Chum, Is Given Life Term

Georgia Youth Is Stabbed in Quarrel After Prayer Meeting.

DUBLIN, Ga., Nov. 24.—George Walker, 15 years old, today faced life imprisonment for killing George Avery, his 18-year-old pal.

The boy was convicted early today in one of the shortest murder trials in the history of this country. His plea had been self-defense. As the last words of the sentence fell from the lips of the judge, George pitched forward in a faint. The courtroom, crowded with interested neighbors of the lads, and curious town-folk, was immediately cleared. The verdict—guilty with recommendation for mercy—which was delivered shortly after midnight, was objected to by attorneys for the defense on the ground that it was pronounced on a legal holiday. The objection was overruled. An appeal for a new trial was made.

"The two Georges," as they were called by their friends, who knew them to be inseparable, engaged in a quarrel following a prayer meeting at a church several months ago. Avery was stabbed to death.

WIFE BURNS TO DEATH IN HOME; HUSBAND HELD

NACOGDOCHES, Texas, Nov. 24.—A charge of murder has been filed against George Bates, whose wife was burned to death Sunday night near Trawick, Nacogdoches county. Bates was arrested Tuesday morning after the ruins of their home had been searched and the body examined. He was placed in jail here.

Sentiment in the community is reported to be very threatening against Bates. Last night about 250 men from the Trawick community came to the county seat and all that prevented the crowd from becoming a mob was the lack of leadership. While this crowd was standing about the plaza near the jail, Sheriff Woodland removed Bates from the jail and spirited him away unknown to those who talked of lynching him. The crowd finally dispersed without any demonstration after announcement was made that the accused was not in the jail.

Bates is about 30 years old. He is a native of this county and has many relatives here. The Mrs. Bates who was burned in the house was his second wife. She was the daughter of Mr. and Mrs. W. J. Coates, well known farm residents of this county. They were married last spring.

The funeral of Mrs. Bates was held last evening. The fire in which she lost her life occurred Sunday night about 8:30 o'clock. Neighbors found Bates in his night clothing lying that his wife was burning to death. The house then was in ruins. He declared that he was awakened by the fire when the roof was falling in and thought his wife was awakened at the same time. Bates had some burned spots on his neck and legs.

TODD'S MOTION FOR NEW TRIAL IS ARGUED

WEATHERFORD, Nov. 24.—The motion for a new trial in the case of Willis Wayne Todd, who was convicted in this court last week of the murder of James McNeal, Fort Worth jitney driver, was called for hearing in the Forty-third district court here Wednesday.

A supplement has been added to the motion since it was first presented, which was read by Sam Shadie, defense attorney. The supplement embodied three main points which were as follows: "First, that the defendant, Wayne Todd, asks that the judgment and verdict of the jury be set aside because of new evidence which has recently been discovered, namely that of Stacy Johnson, who, according to the supplement, swears that he, Stacy Johnson, personally knows the defendant, and has known him for three years and that he believes the defendant to be of unsound mind. Second, the newly discovered evidence of T. W. Heath, who also swears that he believes Todd to be of unsound mind; and third, because of the misconduct of two of the jurors, namely Fred Smith and J. P. Owens. That Fred Smith stated to the jury that he knew Wayne Todd and that he was a bad boy.

Six witnesses were placed upon the stand, three by the defense and three by the state.

Judge McKinney said that he wanted to look up the law a little further on this question and that he would take the matter under advisement, and get to it as quick as he could.

SLAIN MAN'S WIFE COMMITS SUICIDE DURING FUNERAL

ST. LOUIS, Nov. 24.—While mourners gathered around the bier of Henry B. Graham, who was killed by his negro chauffeur Monday, his wife, Georgine Graham, 28 years old, committed suicide in her room on an upper floor early today. A bullet pierced her heart.

BRIAND LEAVES, LLOYD GEORGE MAY YET COME

Washington Conference Marks Time Today as America Observes Holiday.

WASHINGTON, Nov. 24.—Aristide Briand, premier of France, and head of the French delegation at the armament and Far Eastern conference, left Washington shortly after 8 o'clock this morning for New York, from which port he will sail tomorrow for home. The French premier had been in Washington a little more than two weeks.

"The Washington conference has done much for France. I am a happy man."

With these words, Premier Briand of France took smiling farewell of the members of the limitation of arms conference.

LONDON, Nov. 24.—Premier Lloyd George may sail for America on Dec. 3 to attend the Washington disarmament conference, it was learned here today. His departure, however, is still somewhat dependent on the outcome of the present Irish peace difficulties, it was said.

Officials of the Cunard line admitted tentative reservations had been made for the premier to sail on the Aquitania on that date.

DELEGATES NERVOUS

WASHINGTON, Nov. 24.—An atmosphere of nervous irritation pervaded the arms conference today, as America was giving thanks for what has already been accomplished by it. This was due largely to the fact that for the first time since the delegates have begun to lay aside their diplomatic politeness, and talked the way they think.

Although formal proceedings of the arms conference had been suspended for Thanksgiving day, it was expected to be one of only nominal rest for the delegates, and that in the absence of any meetings of the conference or its subdivisions, the negotiations would continue to be pressed through consultations among the various individuals and groups.

GOVERNOR NEFF GRANTS THIRTY-EIGHT PARDONS

AUSTIN, Nov. 24.—Governor Neff has granted pardons to thirty-eight convicts to become effective today. Information to that effect was contained in a telegram received today by Private Secretary R. B. Walthall from the governor, who is at Huntsville making an inspection of the state penitentiary. This is by far the largest number of pardons granted at one time since Governor Neff was inducted into office last January.

While it was not said in the telegram from the governor, it is presumed that the records of the convicts granted Thanksgiving pardons were investigated by the executive on his present trip of inspection.

WOMAN JURY FINES MAN HUNDRED BUCKS

TEXARKANA, Texas, Nov. 24.—For the first time in the history of Miller county, Arkansas, a defendant in a justice court was tried yesterday before a jury of women, which returned a verdict of guilty, recommending a fine of \$100 and costs.

Charles Lawson, the defendant, was charged with transporting liquor.

Prior to the jury trial, Lawson had entered a plea of guilty to a charge of carrying a pistol and was fined \$50 and costs.

MANY CHILDREN AMONG GUESTS AT FREE DINNER

Three Churches Hold Services to Give Thanks for Nation's Blessings.

A true Thanksgiving spirit prevailed in Ranger today, manifested in special services held in three of the Ranger churches and in the free Thanksgiving dinner offered by the retail merchants of the city to those without funds. Practically all of the stores and business houses of the city were closed during the morning hours and the holiday crowd was increased by Breckenridge residents who arrived on a special train early this morning for the football game.

At the Presbyterian church Thanksgiving services were preached by the Revs. A. N. Stubblebine and J. G. Winsett, with special music in charge of Mrs. R. C. McCoy. The Rev. M. F. Drury conducted the services at the East Ranger Baptist church. At St. Rita's Catholic church special mass and communion was held at 8:30 o'clock by the Rev. Father Gherkin.

Children Enjoy Dinner.

Children predominated at the Thanksgiving dinner given by the merchants. A number of grownups were present, mainly women and shortly after the doors opened at 12 o'clock, the tables were filled. It was expected to provide a turkey feast for several hundred people before 2 o'clock and preparations had been made to feed as many as 500 people, should that many decide to accept the hospitality of the merchants in the spirit offered.

The building at 228 Main street was decorated with streamers and a homelike spirit was observed. Members of the association waited on the tables and welcomed the guests at the door. A piano furnished music during the dinner. The menu included celery and olives, turkey and cranberry sauce, mashed potatoes, bread and butter, milk or coffee and ice cream and cookies.

Practically all of the members of the Merchants' association were present or represented among the waiters or in the receiving line.

TURKEY DINNER COSTS 39c LESS THAN LAST YEAR

CHICAGO, Nov. 24.—Even to turkey and its trimmings, the cost here of regular Thanksgiving day dinner for the average family was 39 cents less this year than last, according to Russell J. Poole, secretary of the city council's committee on the high cost of living.

The family dinner cost \$6.70 last year, compared with \$6.31 for the same articles today, the difference in price being distributed between the turkey, sweet potatoes, pumpkin pie, celery, bread and butter.

SOLDIERS IN GERMANY EAT 11-CENT TURKEY

COBLENZ, Nov. 24.—Eleven thousand American soldiers stationed on the Rhine, tucked away 13,000 pounds of turkey, as the piece de resistance of their Thanksgiving dinner. There were the usual "trimmings" of cranberries, raisin and pumpkin pie and piping hot plum pudding. Many units with mess funds added to their menu roast duck, pig, goose and chicken and even pheasant and venison, which are plentiful and cheap this year.

While the plum pudding and pumpkin pie for the pies were sent from the United States, the turkeys were bought from German farmers and cost only 11 cents a pound as compared with 80 cents paid last year for turkeys shipped from America.

NEW HOME FOUND FOR LINCOLN SURVIVOR

NEW YORK, Nov. 24.—Thomas Proctor, who gave up his bed to President Lincoln the night he was shot by Wilkes Booth, ate his Thanksgiving dinner in St. Andrews brotherhood home at Gibsonia, Pa., after spending the past six years as a ward in the city home of Blackwells Island.

Arrangements for the transfer of Mr. Proctor, who is now 80 years old, were made by Chaplain Sidney N. Usher, representing the Episcopal City Mission society. Mr. Proctor and Robert Todd Lincoln, son of the martyred President, are the only survivors of the little group of persons who were present when the great liberator died.

MEXIA, Texas, Nov. 24.—Sale of the production of the wells of the Humphreys interests in this field up to a maximum of 300,000,000 barrels of oil if the wells produce that much, with the exception of a portion for the Pure Oil company made recently by Colonel A. E. Humphreys, was on the basis of more than \$1 a barrel, he announces.

Doctor Gives Fatty Cause for Thanks

He Spends Day in Seclusion as Scandal Weary Court Takes Rest.

SAN FRANCISCO, Nov. 24.—A scandal-weary court had a day of rest today, while Roscoe Ar buckle destroyed a huge Thanksgiving dinner.

The big comedian's trial on charges of having taken the life of Virginia Rappe, stood adjourned until tomorrow morning, when his million-dollar defense hopes to resume its legal bomb throwing at the state's case.

Behind drawn blinds of his brother's home here, the man whose holiday parties were once the talk of moviedom, was to eat his Thanksgiving turkey. No very cafe favorites or rollicking coterie of friends gathered at the table. His wife, Minta Durfee, his brother, Arthur, and wife, perhaps half a dozen intimates were to make up what probably is Ar buckle's quietest Thanksgiving in a decade.

Thanks Due Doctor.

The big comedian's trial on to be thankful today than at any time since the death of Miss Rappe, following his party on Labor day. In particular, thanks are due to Dr. Shaw Collins, nationally known medical authority, who gave highly technical and largely unprintable testimony yesterday. Collins was the first of any array of medical experts and his testimony laid the basis for the following premises:

That Virginia Rappe received her fatal injuries in a bath given her in an effort to stop her hysterics.

That dancing or other violent exercise might have caused the injury.

That the rupture might have been spontaneous.

That any of these occurrences were rendered more probable by the combination of gin and orange juice of which she partook.

Public interest in the trial seems to be growing, despite the fact that the court, lawyers and part of the jury are apparently wearying. The session yesterday drew to the corridors of the hall of justice the largest crowd since the trial opened. Application for the little blue cards which are necessary for admittance, have exhausted the supply through Saturday. More than half are from women. They are modern women who do not blush as the most salacious testimony is revealed.

Two little girls, one about 10 and the other about 12, hung in the doorway yesterday and listened to the details.

"Well, we saw Fatty, anyway," said the older of the two as they finally were chased away by a policeman.

IRISH NEGOTIATIONS ARE NEARING COLLAPSE

LONDON, Nov. 24.—The negotiations for an Irish settlement are feared to be nearing an unfavorable end, according to a high authority today, and there is apprehension that next week may witness their collapse, unless more favorable circumstances not now foreseen shall develop.

A WEALTHY CONGREGATION STOCKTON, Mo., Nov. 24.

The six Presbyterians in this little town have so much money they don't know what to do with it. Hugh Ross, who died here recently, bequeathed \$25,000 for "the construction of a Presbyterian church." Six persons, it is admitted by the members of that faith, could not use so fine a church. They contemplate merging with some other faith.

BANDITS TACKLE WRONG CROWD; TWO DEAD, THIRD DYING

CHICAGO, Nov. 24.—Two bandits were dead today, another may die, following a gun battle with five detectives last night. The detectives were out walking when the three bandits ordered them to put up their hands. None of the police was injured.

CHAMPION MAKER OF CORN BEEF HASH IS GIVEN FORTUNE

WASHINGTON, Nov. 24.—Maggie Maloney, artistic developer of corn beef hash to the point where presidents, senators and other favorites of the capital vied with each other for a chance to partake of it, has been awarded \$25,000.

This sum was willed her by Mrs. Mark Hanna, widow of the famous senator from Ohio. For twenty-eight years Maggie Maloney served as the Hannas' cook. The corn beef hash breakfasts with which Hanna regaled presidents, senators and other persons of importance have become nationally famous.

Mrs. Hanna died recently and left to Maggie one of the largest sums left to anyone not a member of the immediate family.

ARMED NEGROES MAY DO BATTLE WITH OFFICERS

Police at Fort Worth and Dallas Seek Black Wife Slayers.

FORT WORTH, Nov. 24.—Deputy sheriffs and policemen are searching east of Fort Worth for Angus Williams, an alleged insane negro wife slayer. Precautions have been taken by the officers for a hard fight when they meet the heavily armed negro, who shot his wife, Rennie May Williams, last night and who afterward boasted that he would not be taken alive.

When the officers appeared with an ambulance last night, Williams opened fire from a distance of about 100 yards and fled when the fire was returned.

DALLAS, Nov. 24.—Armed with riot guns, police combed the negro section here today for "Texas Red" negro, who shot and wounded his wife, Ethel Holmes, early today.

The negro is said to be armed with a repeating rifle, and to have threatened to kill the first policeman who attempts to arrest him.

STATE TEACHERS HOLD ANNUAL CONVENTION

DALLAS, Nov. 24.—Teachers from all sections of Texas were in attendance here today when the Texas State Teachers' association, in annual convention, was called to order by its president, Miss Lela Lee Williams of Dallas. A number of prominent out-of-state educators also were present. Sessions, which will conclude tomorrow night, were held at First Baptist church and arrangements have been made for more than 4,000 delegates.

ABILENE ORDERED TO PLAY ELECTRA SATURDAY

ELECTRA, Texas, Nov. 24.—Roy B. Henderson, state director of high school athletics, has ordered Abilene to play Electra High for the championship of West Texas in this city Saturday, Nov. 26. His ruling that Abilene should play in Electra was reached after it had been pointed out to him that Electra played in Abilene last year and was eliminated from the finals for the state title.

Electra and Abilene have both won out in two districts and the winner of the Saturday game will be listed among the best three in the state and will participate in the finals.

ABILENE, Nov. 24.—The Abilene Daily Reporter last night received a telephonic announcement from an unknown source that the Ku Klux Klan would stage a parade in the downtown business district at 8 o'clock Thanksgiving night. The Klan made its presence known here recently for the first time with a contribution to the Salvation Army of \$100.

INQUIRY WILL START AT ONCE, OFFICIAL SAYS

Exact Extent and Nature of Cuts Has Not Been Determined.

WASHINGTON, Nov. 24.—Extensive rate reductions will be made by the interstate commerce commission within the next few months, a high official of the commission said today.

The commission has determined, it was said, that more rate cuts must come, and a sweeping inquiry into all present charges, ordered late today, is for the purpose of determining the exact extent of the reductions.

TWO MEMBERS FAVOR SMALLER LEGISLATURE

AUSTIN, Nov. 24.—Two Texas state representatives and one senator favor reduction of the Texas house of representatives according to their statements.

Commenting on the recent movement in San Antonio to reduce the membership of the Texas legislature and have it in session continuously, Representative John T. Smith of Travis county said that "it would be the greatest thing that ever happened."

Mr. Smith's idea, however differs with the plan to have the legislature function all the time. He would reduce the membership to sixty members and have them meet every year instead of every two years. Between sessions he suggested committees to work on various propositions devoting their entire time to such work and report at the next session.

State Senator R. M. Dudley and Representative J. E. Quaid, both of El Paso, are in favor of the smaller legislature movement. Both say that the house is unwieldy and should be reduced probably one-third, or to about ninety of 100 members, but that the figures set by the smaller legislature organization of Texas are too low.

AMERICAN PUBLIC IS TIRING OF JAZZ MUSIC

NEW YORK, Nov. 24.—Is America tiring of "jazz" music, as American popular music is termed?

That is a question which is engaging the attention of theatrical men and professional musicians, as well as the amusement seeking public in general as a result of the announcement of Oscar Radin, conductor of "Blossom Time," a musical show based on incidents in the life of Franz Schubert, the celebrated composer, that his orchestra would play Schubert's celebrated "Unfinished" symphony as entr'acte music at the performances of the play.

Mr. Radin states that it is the result of popular demand, for several strains from the symphony are employed as themes for the musical accompaniment of the operetta. Many of Schubert's songs are sung during the action of the piece, including "Serenade" and others.

MILITARY CAMP FOR CANADIAN JOBLESS

VANCOUVER, B. C., Nov. 24.—Unmarried jobless men here will be provided for this winter in a military camp to be established in a park, it was announced today. The camp will be equipped with military supplies, and prepared to furnish board and lodging at \$5.60 per week per man. Two days' work for each man will be certain.

BELFAST QUIET

BELFAST, Nov. 24.—The scenes of the sporadic outbursts of bombing and shooting which have taken place in various parts of the city during the last few days, were closely patrolled by crown forces during the night and complete quiet prevailed early today. The death of two more wounded persons in the hospitals today brought the total for the series of disorders to twenty.

PANHANDLERS DESERTING NEW YORK FOR WEST

Tramp Horde Catch West- bound Rattlers for Dallas and Los Angeles.

NEW YORK, Nov. 24.—Weary Willie, Dusty Dan and other knights of the road who have found the city prime pasturage during the last few years have begun a migration back to Fort Wayne, Dallas and Los Angeles, according to a survey of conditions made by Public Welfare Commissioner Bird S. Coler.

Repeated warnings in newspapers against giving money to street panhandlers, increased police activity in ridding the city of undesirable and the discontinuance of feeding tramps by charitable organizations have operated to drive professional tramps from the parks and other "hang-outs" of beggars here.

With the first chill of winter there came a noticeable decrease in the number of loafers in Bryant, City Hall, Central and other parks which have long been the favorite camping grounds for idle, fagged, worn-out work dodgers.

Work or Get Out.

The police department hastened this departure by an ultimatum to tramps that they must go to work or leave the city. The alternative to these two courses was an offer of work-sentences such as are meted out to vagrants. The result is that the thousands of professional panhandlers who came here to take advantage of the unemployment situation have been to a large extent weeded out. In groups of from two to a dozen they have gone south and west, or to other cities where their wileless advice told them that the "pickings were good."

One remaining panhandler explained the situation thus: "Most of the guys have gone to better holes. For the last few weeks most of the stemmers (slang for professional tramps who beg for a living, have been moving on. It got too cold to sleep in the parks, and business got bad on the streets. For some reason or other the people, who had been liberal with their money before, became tight, and it got harder to make a living by bumming. Most of the out-of-town tramps have gone south or to the West, where there are reports of work to be had in the mills—short-time work that the beggars will do, if necessary to live."

Few Regulars Left.

A few of the regular tramps still linger about the parks. In front of the cheaper restaurants, where scores congregated a few months ago, one many now see two or three tramps and no more. Some of the tramps have obeyed the police order to go to work. But most of them have "moved on."

Discussing the situation, Commissioner Coler said: "A good part of the remainder of the persons who beg on the streets will be removed by plans now under way. Application will be made to Washington either for authorization to take care of or for provisions to deport aliens now stranded in this city. Many of these men were stranded here by the inactivity of the American merchant marine. Some steps should be taken to care for these helpless men, for there are thousands of them in New York all unable to find work. The city is taking steps to deal with these underserving. Some of the tramps who came here to beg, not to work, have gone to Blackwell's Island for terms in the workhouse. The city found this an effective way to warn them that panhandling had to stop. Few of these men took advantage of legitimate charity. At one time they became angered at the city and picketed the municipal lodging house in the manner of strikers and held up men going there for the night."

KIDNAPPERS DEMAND \$25,000 FOR BOY

ST. LOUIS, Nov. 24.—A demand for \$25,000 for the safe return of Dominick Di Franco, 7, son of Constantino Di Franco, "sugar king of Little Italy," has been made by kidnapers of the youth, it was learned Tuesday.

The Di Franco child was abducted Monday, Nov. 14. Police have been unable to find a clue as to his whereabouts.

RUSSIA EAGER FOR NEWS FROM OUTSIDE WORLD

MOSCOW, (By Mail).—While the western world has been wondering what has been going on in Russia, Russia has been wondering just as much what was going on in the rest of the world.

The average man in Russia has known just as little—perhaps less—about events in America and Western Europe these last four years as the average American has known about the so-called "truth about Russia." The Chinese wall which has separated Russia from the balance of civilization since the Bolshevik revolution has been just as impermeable from this side as it was to us on the other.

Famished for News.

Time and again former professional men, former merchants, have come up to me on the street to ask for news from Western Europe. Drotshky drivers have twisted their increasing avoirdupois—they grow fatter and fatter as the winter progresses with each additional layer of clothing—around on their driver's seats in front to inquire what was happening in America.

The most astonishing conceptions have been revealed. Some thought a soviet republic had been established in Washington. Many had understood that if such were not the case, it would happen soon, as the workers of America were on the point of revolting. This type of idea was for the most part confined to the working people.

Know War Is Over.

The former bourgeois inquired principally about political events, and about living conditions. They knew that the war was over, and that is about all.

While a picturesque-looking old monk was conducting a party of us through Ivan the Terrible's private temple in the Red Square, a former physician from Odessa, now in the Bolshevik Red Cross, glimpsed my American bone-rimmed glasses and edged through the crowd of sightseers to inquire if any great scientific discovery had been made "in the outside world" since the war.

All commerce with the rest of the world has been stopped until a short time ago and it was only recently that mail service was resumed. No pleasure travellers and no business travellers except those on official governmental missions have come to Russia since 1917. Telegrams now go freely to London and Berlin, but this is only a very recent arrangement.

One-Sheet Newspapers.

The Bolshevik newspapers in Moscow are large one-sheet affairs, recalling the editions in London during the war. They are filled with long editorials and polemic articles against bourgeois Western Europe, Communist party news, news about Russia, and a column or two of short paragraphs from foreign countries—a single paragraph from each land. These items are generally labor news however, such as might be found in a typical trade union organ in the United States. The classic paragraph from the United States is about a strike at Pittsburgh, an impending strike of the New York wharfmen, etc.

The biggest political events, such as conferences of premiers, are generally chronicled but briefly—generally in four or five lines.

NO REVELERS.

COSMETICS RUIN PEARLS, SAYS LONDON JEWELER

LONDON, Nov. 24.—"The woman who uses cosmetics and wears pearls is unknowingly allowing her gems to die a lingering death. The better the pearl the more easily cosmetics kill it."

In these words a well-known London jeweler complained of the women who are continually bringing pearls to be repaired, stating that the color and mellow tints are fading.

"We cannot exactly tell these women that if they cease to smear their cosmetics so profusely that the pearls will retain their color, and even improve with time," he said. "A pearl thrives only when worn near the actual skin. It deteriorates so badly when worn over a painted neck that after half a dozen seasons it loses a considerable part of its money value."

FORD-NEWBERRY CONTEST PUT OFF UNTIL JANUARY

WASHINGTON, Nov. 24.—The senate Wednesday agreed to dispose of the Ford-Newberry senatorial election contest early in January. The agreement, which was by unanimous consent, provides that the election case shall be considered to the exclusion of all else on the fourth calendar day, on which the senate is in session after Jan. 1, and to limit debate after two days of general discussion.

That Constance Talmadge, film star, has been separated from her wealthy husband, John Piagalou, was admitted by her in Los Angeles. The trouble culminated a month ago in this city, when she flatly refused to accede to her husband's demand that she give up the screen. That ended the romance that ten months ago united in marriage the youngest of the three Talmadge sisters to the wealthy Greek tobacco importer. Miss Talmadge made this statement: "There is no other man or woman between us. We quietly arranged our parting. We just couldn't get along. My husband is not of the theatre world. He could not understand my going away off to California to appear in the pictures. Perhaps he could not understand because he is a foreigner and I am an American. Besides, as I have discovered, our temperaments are entirely different. He wanted me to give up my movie career. But I cherish that career as I do life itself. He wanted me to give it up and merge my individuality with his. Of course I refused." Miss Talmadge is at the home of her sister, Natalie, Mrs. Buster Keaton, in Los Angeles.

TILE AND MANTEL MAKERS GIVEN JAIL SENTENCE

NEW YORK, Nov. 24.—Four active members of the Tile, Grate and Mantel Manufacturers and Dealers' association, who were among those who pleaded guilty last week to violating the Sherman anti-trust law, were given jail sentences by Federal Judge Van Fleet. F. H. Nobby, Arthur Shilstone and Albert Schaille were sentenced to four months in the Essex county (New Jersey) jail and fined \$4,000 each. Herman Petri was sentenced to two months in the same jail and fined \$3,500.

Blanton has arranged a rapid-fire itinerary of speechmaking during the brief Thanksgiving recess of congress and will visit Brownwood Wednesday, Nov. 30. He is to make two speeches a day during the next week in towns between Goldthwaite and Stamford.

FRATERNAL HEAD FOUND GUILTY UNDER MANN ACT

INDIANAPOLIS, Nov. 24.—John W. Talbot of South Bend, Ind., supreme president of the Order of Owls, a fraternal organization, was found guilty Wednesday by a federal court jury of violating the Mann act. The jury deliberated an hour before reaching its verdict.

HOW RUMANIAN KING GOT EVEN WITH ENTENTE

PARIS, Nov. 24.—King Ferdinand of Rumania wins the crown for originality in showing Clemenceau, Lloyd George, Wilson and all the other peace makers of Paris that he doesn't like the way they cut up the spoils of victory.

The United States refused to ratify the treaties.

Germany kept things in a chaos by threatening not to pay.

D'Annunzio grabbed Fiume and resisted the Powers.

Austria went bankrupt.

General Zeligowski marched into Vilna and defied the peacemakers.

King Ferdinand sat tight and said nothing until the time came. Then he called his two pretty daughters and said:

"Girls, go out and marry some fellows the Allies don't like."

At least this is the interpretation put on the king's acts by a portion of the French press, led by the Petit Bleu. The Petit Bleu goes on a rampage on its first page over the report that Ferdinand is about to give the Princess Marie in marriage to King Boris of Bulgaria, just after marrying the Princess Elizabeth off to a Prince of Greece.

"For some time," says the Petit Bleu, "the king of Rumania has seemed to busy himself in uniting royal Rumanian princesses to the most bitter enemies of France. Yesterday it was a Greek and today a Bulgarian. This seems to be his way of showing discontent with the recent treaties."

The French foreign office says the Petit Bleu is all wrong.

"France likes to see the girls get married," says the foreign office, in substance, "and doesn't see any objection to the Princess Marie picking a Bulgarian king. If that brings Bulgaria into the Petit entente, as dispatches from Belgrade hint, that means more chances for peace in the Balkans and consequently for peace in Europe."

CRIPPLE IS SENTENCED TO DEATH FOR SLAYING OHIO CHURCH WORKERS

PORSMOUTH, Ohio, Nov. 23.—Death in the electric chair at Columbus Feb. 24, 1922, was the sentence given by Judge James S. Thomas to Roy Chamblin, cripple, and self-confessed murderer of John W. Newman and Miss Louise Doyle, both prominent in church work here. Their bodies were found in an abandoned cottage on the Scioto trail, seven miles north of here Oct. 28, a week after they had been killed.

CENTRE WILL NOT PLAY ANY POSTSEASON GAME

NEW ORLEANS, La., Nov. 24.—Centre will not play any post-season game this year, it is announced by Coach Charles Moran, who with his "Praying Colonels" arrived here today for the Thanksgiving clash with Tulane.

WARSHIPS NOW BUILDING MAY BE SALVAGED

WASHINGTON, Nov. 24.—American officials are giving some thought to the possibility of salvaging as non-combatant commercial craft the three new battleships now aloft, but which would not be completed under Secretary Hughes' naval limitation and reduction plan. They are hopeful that in fixing the methods of scrapping, the conferees will not make an arbitrary rule that would require the ships to be sunk or otherwise totally destroyed.

MINEOLA, Texas, Nov. 24.—Pete Lake was shot and almost instantly killed Wednesday afternoon about 4 o'clock at the Burl Thomas home two miles northwest of Mineola. Rufus Browning, 20 years old, was arrested following the shooting. Lake was shot with his own gun, a .45-calibre pistol. Lake was brought to Mineola and died in a doctor's office a few moments after arrival.

Young Browning refused to make a statement regarding the matter at this time. Lake leaves a wife, father, mother and one sister.

MORAN TO COACH AGAIN.

BOSTON, Nov. 24.—Charles Moran will be football coach at Centre college for at least one more year. J. C. Caldwell, head of the Centre College Athletic association, has sent word here that Moran signed a contract to continue next season. He had previously announced that he would resign at the close of this year's football campaign, and it had

been suggested that he might be succeeded by Bo McMillan, Centre's sensational quarterback and former captain. McMillan now has under consideration an offer to become coach at Howard college at Birmingham, Ala.

It was announced by Mr. Caldwell that Claude Thornhill would continue for another year as Centre's line coach.

BLUE LAWS HELD RESPONSIBLE FOR LOVE CRIMES

Reformers Have Tied Down Safety Valve, German Love Expert Says.

BERLIN, Nov. 24.—The epidemic of "love crimes" where emotional impulses overleap or burst the barriers set by law and society, which recently have been so prevalent in the United States, may in no small part be traceable to the puritanical blue laws which seek to repress every expression of pleasure, amusement and diversion not approved by fish blooded reformers.

These reformers, who never have a thrill, in seeking to bring the country to the level of their own thrills, joyless existence, by tying down the "safety valve" to all the healthy diversions, amusement and sport of a virile nation, are but contributing to "seams springing in the body social" when they go to extremes.

That is the opinion of Medical Councillor Dr. Magnus Hirschfeld, head of what is probably the only "Scientific Love Institute" in the world, and Germany's leading authority in the realm of love and sex emotions and relations.

Dr. Hirschfeld is president of the Scientific Institute for Sexual Research.

Dr. Hirschfeld said, "The forces of love and sex are the most powerful in the world. They are potentialized life. Love and the part it plays in the relations of the sexes is both the work and the play force in life."

Woman Is Central Feature In Life.

The doctor was looking over a bunch of American newspapers. He pointed to the picture of women, to headlines over sensational divorce cases with risqué or salacious details, to beauty contests and other evidence in American papers which cause the foreigner to draw the conclusion that in no other country in the world does the public worship at the shrine of Venus as in the United States.

"Woman," said Dr. Hirschfeld, "seems to be the central—yes, the dominant feature of the American newspapers and magazines. In print and in picture you find her everywhere. Every phase of your public and private life would seem to be colored by woman."

Woman, declared the head of the institute for the scientific study of love and sex relations, means love and sex.

"In America, it would appear, two movements are going. On the one hand you are seeking to repress by extreme drastic legislative 'verboten' and prohibitory decrees, the natural healthy buoyant spirits of a young and virile nation in play and pleasure. Your blue-law reformers are trying to make Sunday—the play day of the working men and women—a joyless, playless day.

"They are seeking to prevent natural and healthy impulses and instincts which find expression in play, amusement, sport and diversions.

"That such a condition can contribute to 'seams' being sprung in the social body must be obvious," asserted Dr. Hirschfeld.

HIGH SCHOOLS OF FOUR STATES MAY ORGANIZE LEAGUE

FORT WORTH, Nov. 24.—Plans for the organization of an interstate high school athletic conference, composed of eight high schools in Texas, Oklahoma, Arkansas and Missouri, will be discussed by Coach W. B. Franks of the Fort Worth high school and the athletic director of the Muskogee, Okla., high school when the local football team goes to Muskogee for the Thanksgiving day game there.

The plan for the interstate conference was originated by the athletic director of the Muskogee school about a year ago, Coach Franks said. Details of the proposal probably will be made known after the Muskogee-Fort Worth game today when the two coaches talk over the proposition, according to Coach Franks.

If the conference is brought about, it will be the largest intersectional high school athletic organization in the country, it is stated. The schools that have been mentioned for places in the conference, or league, are Dallas and Fort Worth in Texas, Muskogee and Tulsa in Oklahoma, Fort Smith and Little Rock in Arkansas and Springfield and Joplin in Missouri.

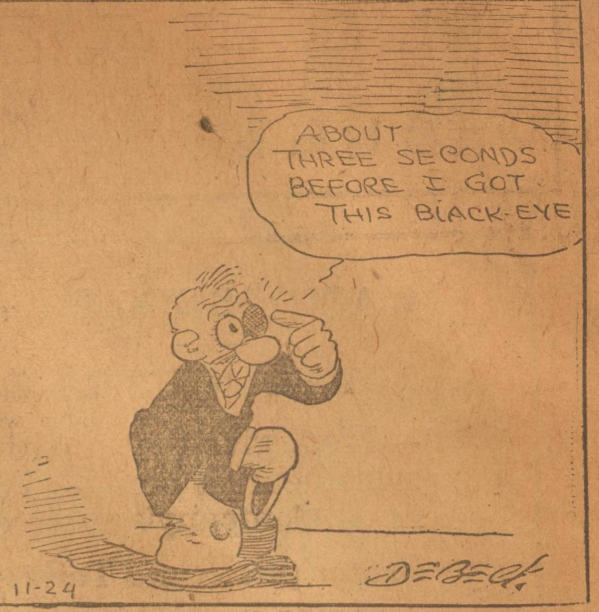
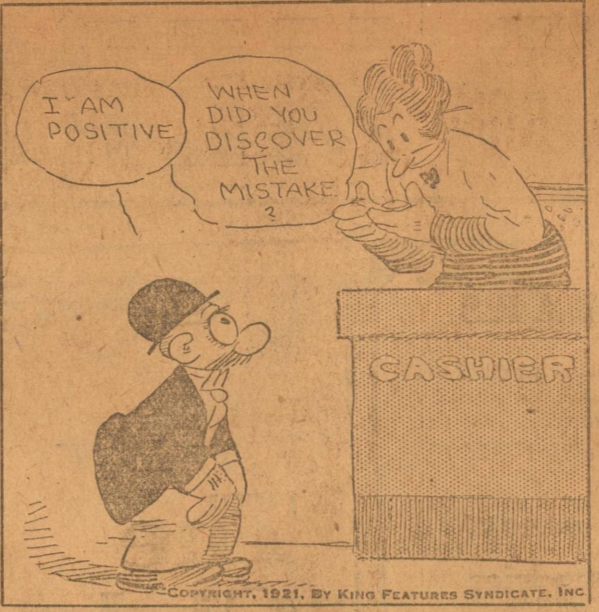
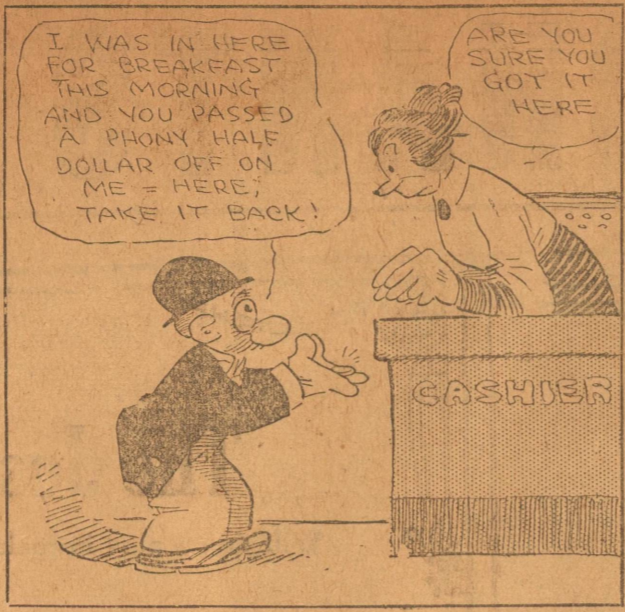
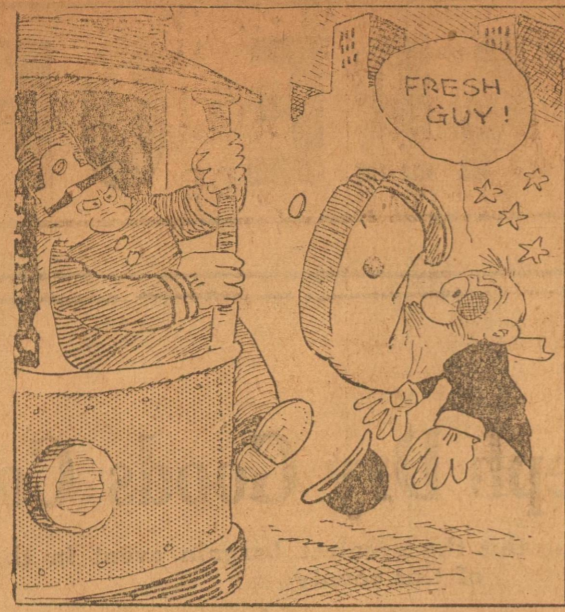
FIVE BOXES OF GOLD VANISH ON SEA TRIP

MORE SPOONING ROOM IN PARKS, PROSECUTION FOR PAYING TAXES, PLATFORM OF NEW MAYOR IN OHIO

YOUNGSTOWN, Ohio, Nov. 24.—A promise that if elected he would donate his entire salary to the community chest for the benefit of the poor may cost George L. Oles, Independent, his election as mayor, it is intimated in political circles here. It is contended that the court will construe this as offering a bribe for votes.

Oles who had lived in Youngstown only three months and whose platform provided for discontinuance of street car service, turning the streets over to jitney busses, and for jailing any citizens who paid taxes under a recent revaluation, was elected mayor over candidates backed by the major party organizations. He came in from the country, established a residence in a hotel and carried on an eccentric advertising campaign without the support of any particular element or organization.

Other planks in Oles' platform included permitting "spooning" in city parks under police protection, dismissing the entire police force if it "doesn't mend its ways" and a promise to turn over his salary to charity. The women's vote is believed to have been responsible for Oles' election.

Oles started in business here, with a barrel of potatoes and a wheelbarrow. Now he has one of the largest businesses in the city.

In his advertising he describes not only the selling of potatoes and onions, but almost every question of public importance.

Mrs. Oles assisted the mayor-elect in his whirlwind campaign, and observers assign to her much of the credit for its success. They inaugurated a plan of political meetings for women, from which all men were excluded.

GIRLS ARE AWKWARD SMOKERS; MANY SUFFER JUST TO BE IN STYLE

Most men want to meet the girl who really enjoys smoking. The exasperation of meeting the girl who smokes without enjoyment is becoming very great. Indeed, this autumn it is ubiquitous. At every dance, in every restaurant, in every home women now perpetrate the annoyance unchecked, even uncriticized, writes Wilson Macnair in the London Mail.

No one apparently dares to tell them the truth—which is that most of them look quite as uncomfortable and silly as a schoolboy on the sly with his first cigarette. They have the schoolboy's self-consciousness, too, an absurd mixture of naughtiness and defiance.

These girls really believe that they like smoking. You could not convince them that they dislike it—or they are unable to form any judgment.

Cigarette Doesn't Linger at Lips.

Yet it is only necessary to watch them for five minutes to convince yourself. The very way they hold their cigarettes is enough. Either their fingers are so stiff as to suggest a cramp or they are poised and posed in the manner of a conjurer handling his wand.

The cigarette very seldom comes to its consumer's lips. Its visit in this direction are more than fleeting; they are positively hurried. They lack all semblance of pleasure, too. There is a kind of spasmodic puff, a big show of

smoke, followed, as often as not, by pre-longed blinking of the eyes. Sometimes the appearance of discomfort suggests the attempt to swallow a pill.

Moreover, the end of the cigarette almost invariably gets sodden and bursts. In consequence its contents are scattered about and must be painfully removed from lips and fingers and even frocks.

This kind of farce may be amusing occasionally. Sooner or later, however, the question arises why girls should put themselves to so much bother and discomfort for so little reward.

If they suppose these antics make them more attractive to men they are vastly mistaken. Men, generally speaking, prefer girls who do not smoke at all. They will assuredly continue in that preference so long as it remains quite obvious that the enjoyment of tobacco is not numbered among the reasons for this new and growing feminine habit.

For most men take smoking seriously. They know how great is the pleasure which may be found in it, the stimulus to thought, the invitation to rest and peace.

Tobacco is one of their truest and most intimate friends. It is always distressing to know a friend abused and insulted.

WET QUEBEC IS IN GREAT FAVOR WITH OUR AMERICAN TOURISTS

NEW YORK, Nov. 24.—The province of Quebec, said no less an authority than the Hon. L. A. Taschereau, premier of that province, recently, expects to make a revenue of \$4,000,000 a year from the liquor traffic. One of his colleagues, the minister of roads, stated that tourists, mostly Americans, were coming in such large numbers "because of the fine highways" that it was estimated that they would leave \$35,000,000 in the province this year.

The people of Quebec do not, of course advertise brazenly that theirs is the only place on the North American continent, except British Columbia (which is 3,000 miles away), where one can legally buy something alcoholic to drink, but undoubtedly, from the advertising viewpoint, they have a great selling argument. So they camouflage it something like this, which is the advertisement of a famous hotel in Quebec:

Camouflage. "Quebec is a refuge place for those who like gracious manners and a spirit of toleration for old systems and institutions as well as new."

A few nights ago I was at an international convention in Montreal (curious the number of international conventions that go to Montreal nowadays) or, rather, it was an evening smoker interlarded into a very serious two-day convention of very

intense business executives. An international gentleman of hearty and enthusiastic voice was declaiming, glass in hand, that he wanted what he wanted when he wanted it, amid the plaudits of a very sympathetic audience.

The beverage which filled his and their glasses had a pleasing transparent, amber color, when, when smelt, had a delightful aroma reminiscent of hops. Yes, it was beer—not 2 per cent beer or half of 1 per cent beer, or temperance beer, or near beer, or would-beer, but Real Beer!

And it was being consumed, not in some hole-and-corner rattery, behind barred doors, or down a cellar, or from teacups, but in a large public room of a large hotel, the doors of which were wide open. No sleuths puffyfooted at keyholes, with hand-cuffs in one hand and a search warrant in the other. No headwaiter had to be bribed with his weight in gold.

The whyness of this wherefore is found in the toleration previously alluded to. The province of Quebec is largely inhabited by French-Canadians, and the French-Canadian has no use at all for prohibition. This neighboring province of Ontario is as much dry as Sahara, and the "blue party" which dominates it rages at Quebec as at the Scarlet Woman. But the Quebecer goes calmly on his way. He tried partial prohibition

once and found it unsuccessful. But being possessed of a genuine desire to eliminate some of the abuses of too much alcoholism, he found another way. He vested the entire control of the liquor traffic in his provincial government.

The liquor commission, which came into existence on April 1 of this year, allows you to buy beer at a tavern (fine old and almost obsolete word, "tavern," with here a specific meaning as to a particular form of license) or beer and wine at a restaurant, hotel, club or dining car; or beer in bulk at the grocer's. But if you want Scotch or brandy or gin or rye or other fiery liquids you have to go to the commission's own stores and buy it by the bottle. You are allowed to buy one bottle a day at each store.

I was speaking recently to a tourist agent at Montreal who makes a specialty of working up the sporting business—bringing the man who wants to catch 'em into personal contact, for example, with the speckled trout, the black bass, the fighting muscullunge and the lordly salmon. He told me that the number of sudden Izaak Walton was 'incredibly enormous. More than that, they come not as single spies, but in whole battalions, regular "fishing" clubs of scores or hundreds of members.

TWO MEN ON WAY TO VIEW WRECK STRUCK BY TRAIN

FORT WORTH, Nov. 24.—G. W. NEW FEDERAL BUILDING FOR DUBLIN TO BE ASKED

WASHINGTON, Nov. 24.—Dublin will secure a \$75,000 federal building from the next session of congress to convene within a few days, if a bill being drawn by Representative Fritz Lanham passes. 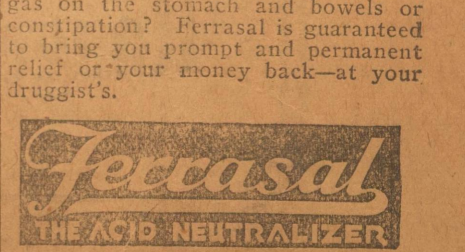



FORT WORTH CAN'T CLOSE DANCE HALLS, BUT WILL BAR CLOSE HOLDS

FORT WORTH, Nov. 24.—Such charges as bunny hugging, Chicagoing, rabbit hopping, toddling and kangarooing would appear on the police blotter of Fort Worth, if a suggestion offered Mayor E. R. Cockrell by a local dancing master for a new city ordinance is carried out.

Fort Worth had an ordinance prohibiting public dancing at which admission was charged. The ordinance was declared unconstitutional and discriminatory when the case of two alleged violators was tried before Judge Seward in the county court at law and the case was dismissed. Mayor Cockrell then announced that public dancing would be permitted in Fort Worth, but some effort would be made to inspect it.

Dancing Master's Ideas. The recommendations of the dancing master came in response to the mayor's request for suggestions. They include:

Ruling against the bunny hug, Chicago, rabbit hop, toddle, kangaroo, and other cheek-to-cheek movements and making them punishable by fine in corporation court.

Requirement of four inches of atmosphere between dancers.

Appointment of a censor, versed in music, dancing and morals, to visit dance halls while they are in operation, watch the dancers and their manners, the cleanliness of the place, have charge of granting permits and power to make arrests and revoke permits.

Presence of hostesses at dances.

Faster Music. Speeding up of the music, to prevent "the slow, swaying 'tom tom dances which bring the dancers in dangerous contact."

Before the new dance hall ordinance is drawn up, Mayor Cockrell has asked for suggestions from interested parties, including club women.

DRUG VENDORS SPREAD HABIT IN N. Y. SCHOOLS

APPOINTED AMERICAN CHARGE D'AFFAIRS IN BERLIN

SAVE US FROM DRY LAWS, BRITISH ADMIRAL'S PLEA

LONDON, Nov. 24.—Two eminent fighting British admirals have been giving their views on prohibition.

Admiral Sir Guy Gaunt, late naval attaché at Washington, speaking at the dinner of the British Saloon Keepers' league, said: "For God's sake, save this country from the 'dry' business. I hold no brief for the liquor business. I have not got a penny in it, but if you go in for this 'pussyfoot' business, you are going to raise a nation of lawbreakers. Why?"

"Over on the other side they talk of nothing but liquor nowadays. The first course was soup; the thing with it a double cocktail. Is it nice to give a girl of 19 a double cocktail in a soup dish? If you are going to do that sort of thing in this country then you can pull down the blinds."

Admiral Sir Reginald Hall, late director of naval intelligence, spoke in similar vein.

"Taking England as a whole," he said, "I contend she is a sober, law-abiding and a God-fearing nation, and in dealing with such a nation our rulers must remember that every law they make has its inevitable reaction in the making of lawbreakers."

"We have an example of this in the United States today concerning the prohibition law, of which I will say no more than that, like Lord Northcliffe, I will discuss American prohibition when it begins to exist."

BATTLESHIP OREGON TO BE SAVED FROM SCRAP HEAP

WASHINGTON, Nov. 24.—The historic battleship Oregon, of the Manila bay memory, probably will be saved when the scrapping of ancient fighting ships begins.

To scrap the Oregon, with its memories and associations, would be sacrilege in the eyes of navy men, and it is understood that some way of preserving the old fighter will be sought. The government will even offer the complete disarming of the ship, providing it is possible to preserve her from future generations.

SYRACUSE, N. Y., Nov. 24.—The drug habit is being deliberately implanted into hundreds and thousands of boys and girls in the public schools of New York and other cities, according to the confession of Jefferson Knepton, former Syracuse policeman and confessed drug addict.

"In the public grammar schools and high schools of New York and Brooklyn," said Knepton, "some of the big drug peddlers, through their confederates in the schoolhouses, are actually giving away morphine, cocaine and heroin to schoolboys and girls, free of charge, so that they will acquire the drug habit."

Knepton, arrested as a drug peddler, declared he had formed the habit in a Brooklyn high school in 1913. He denied that he had ever sold drugs.

According to his story, Knepton has been making a long and unsuccessful fight to rid himself of the habit, acquired, he said, when fellow high school students offered him the drug. "When I first acquired the habit I never had to buy any drugs. Every one of the addicts or peddlers that you would meet in poolrooms and dance halls would gladly give you a little cocaine or heroin to fix you up till you had acquired the habit and had to have some every day. Then they would offer to give it any more, but would offer to sell some or would suggest where you could buy it. I know several handsome, innocent young girls who acquired the habit in public dance halls, where they met addicts and peddlers. The peddlers would even make love to them in order to get them into the habit. No longer able to get money by other means, these girls soon became disreputable in order to get enough money with which to get their needed dope."

Habit Broken in Army. "Finally it became very hard to get drugs. I came to Syracuse and got a position on the New York Central as a trainman. I broke the habit. I enlisted in the United States army April 2, 1918, went overseas, served on three fronts and returned home on May 15, 1919. I returned to Syracuse and started in again as brakeman. Then the railroad strike came on, and I was out of work."

"One day during that period I was sitting in Fayette park and saw several addicts come there to take their 'shots.' Discouraged, it created the old longing in me, and I bought some cocaine from a peddler to forget my troubles."

Worked on Police Force. "On Nov. 1, 1920, I was appointed to the Syracuse police force. I tried to make good, but everywhere I went I ran into addicts who knew me and threw slurs at me as hypocrite and threatened to squeal to my superiors. This discouraged me. I again took to morphine and cocaine."

"While on the force I was taking from four to five grains daily, costing me three dollars. Finally the habit had such a strong hold on me and the addicts in the city jeered me so that it became unbearable, and on Sept. 16, 1921, I resigned from the force. Drugs wrecked me mentally and physically. I have an idea that some of the addicts informed some of my fellow officers of my condition."

OKLAHOMA IS NEAREST PURELY AMERICAN STATE

M'ALESTER, Okla., Nov. 24.—"Oklahoma ranks as one of the nearest purely American states," according to the report of Miss Daisy Moody, state chairman of Americanization, before the Oklahoma Federation of Women's Clubs at their recent annual session here.

Miss Susie Meek, an Indian girl, addressed the women. She said she hoped the members would not consider the Indians as foreigners. She further declared that one-third of the Indians of the United States live in Oklahoma.

GERMAN BOOM CANNOT LAST, ANGELL SAYS

Reduction of Indemnity Suggested as Means of Reviving World Trade.

By International News Service LONDON, Nov. 24.—The man who anticipated fifteen years ago in "The Great Illusion," the present industrial position, returned to London from Germany recently.

Norman Angell is a serious man, but he has some difficulty in not smiling at the panic-stricken efforts now being made in this country to escape from a position that is largely in his opinion, of our own making. "The extremely critical situation," he said, "has in the main been deliberately created by ourselves. The very people who are now crying out for a remedy simply would not listen to any economic consideration when the war settlement was being made. The government at that time was haggard with the clamor to make Germany pay."

Not Surprised. Mr. Angell is not in the least surprised that British manufacturers now find themselves unable to compete against underselling by German exporters. "This competition," he said, "is really the result of a desperate effort to find money with which to make reparation payments. In doing so Germany is ruining the British manufacturer and incidentally, in the long run, impoverishing herself."

"Her factories," he went on, "are being put up with orders, and many have actually to refuse work, but the German people have no shirts on their backs. 'Out of our poverty,' said one manufacturer to me, 'we are making Christmas presents to the foreigner.'"

"No, the German boom can't last?" "No, it can't possibly last, and all the thoughtful people over there know that it can't. When the time comes for them to buy cotton, rubber, petroleum, iron and other raw materials with the present mark they will no longer be able to undersell to such an extent."

"During the next few months the cost of living in Germany is going to soar, and the people will not be able to support themselves on their present earnings. Then there will be grave industrial disturbances, and the currency will depreciate still further."

"Even, therefore, if our manufacturers become comparatively free

from German competition we shall be no better off, because Germany will be still less able to become again a market for our goods."

"Are export credit schemes, the building of garden cities and more generous overdrafts at the banks likely to improve the position in this country?" Mr. Angell waved them aside with a sweep of his arm. "So long," he said, "as you allow the old disruptive influences and prejudices to remain and have regard for special interests and the protection of what are called key industries, such schemes are merely a waste of money."

No Quick Remedy. "What remedies would you suggest?" "There is no short cut back to prosperity and employment. There is no quick way of adjusting the exchanges that are making trade impossible. The process is bound to be a gradual one. The only way that can possibly restore the position of this country must be based on fundamentals. I would suggest: "The wiping away of certain of the war debts."

"Reduction of indemnity. "Abolition of restrictive legislation, such as the Safeguarding of the Industries Act and the economic sanctions on the Rhine. "Cutting out of all waste, such as wars, armies, occupation and excessive armaments, and so making possible a reduction in taxation. "Probably the creation of an international loan for the purpose of facilitating credit."

"Relief of the famine in the re-establishment of trade with Russia." In conclusion Mr. Angell insisted that the problems of peace must be approached in the same spirit as the problems of war. "So long," he said, "as you can't mobilize patriotism for peace as well as for war your peace problems will remain unsolved. And if you refuse to recognize the fundamental economic laws governing the position you will throw away money on schemes that will have only a momentary effect."

ALL WAREHOUSES LEASING SPACE MUST FILE BOND

EASTLAND, Nov. 24.—Every warehouse in the state doing business for hire must file a bond with the state, says a letter recently received by County Clerk Earl Bender from the director of warehouses. The letter follows: "Every warehouse in Texas which does a storage business for hire must file bond with the state, under an opinion just rendered by the attorney general."

"We are therefore forwarding for your convenience and the convenience of warehousemen in your county, all the necessary blanks in connection therewith. The application should first be filled out by the warehouseman and his bond in the sum of \$5,000, either personal or surety, approved by you and placed on file in your office. The law requires that you then forward immediately to this department the duplicate certificate of public warehouseman. "Hoping that all warehousemen in your county will promptly comply with the law, I am, yours very truly, "S. M. RAMSEY, "Director of Warehouses."

For the first time since the meeting of visiting foreigners to the arms conference in Washington, the chiefs of the different delegations assembled to have their photograph taken. These men, who will speak for their nations during the sessions of the conference, all agreed that they would like to pose for a picture that will probably prove unique for one showing so many distinguished representatives of the great nations gathered together at one time.

Miss Anna Elizabeth Niebel, 18-year-old Washington, D. C., beauty, now living in New York, has begun suit against Representative Manuel Herrick, of Oklahoma, charging breach of promise. Miss Niebel was an entrant in a beauty contest conducted by a Washington newspaper. She charges that Herrick corresponded with and called on her. Congressman Herrick's recent introduction of a bill to regulate newspaper beauty contests disclosed that for some time he had been corresponding in affectionate terms with a number of girls in Washington whose photographs had been entered in the beauty contest. Miss Niebel's mother, Mrs. Elizabeth Niebel, was appointed guardian for the plaintiff pending trial of the action.

THERE'S A BAR IN EVERY THIRD BERLIN HOUSE

BERLIN, Nov. 24.—Every third house in Berlin now shelters a bar, the number of drinking places having multiplied by eight since the World War. The Germans today smoke 5,800 times more tobacco than they did in 1875.

Rachitis, tuberculosis and other diseases have increased. These things and the crowding of people in the cities present an acute peril to the German people. Dr. Paul Lazarus told the Berlin Medical Society in an address in which he outlined what medical science must do to keep the German race from declining. His statements aroused heated debating during two sessions of the society.

Dr. Lazarus said the only possible remedy was a back to the land movement, and that the real duty of physicians was to abandon their individualist and specialist tendency and work representatively as social agents.

The discussion was lively, especially on the back to the land issue. Prof. Grotjahn, of the University of Berlin, denied that city life and industrialism had been disastrous in the way Dr. Lazarus maintained. The decline in deaths resulting from tuberculosis he ascribed to industrialism and said that only city hygiene had made possible a reduction in infant mortality, thus raising the average length of life. Prof. Grotjahn agreed that practitioners should devote much of their time to social hygiene pursuits.

AUSTIN, Nov. 24.—Recapitulation of football at the University of Texas since the game was inaugurated in 1893, shows that the Longhorns have played 188 games, including all games of this season played thus far. Of this number Texas has won 139, lost 45 and tied 4.

The feature of the tabulation is the small number of games tied, less than one every seven years. In the twenty-nine years of football the Longhorns have either won or lost games, tying but four.

The outcome of the classic of the present season, the Texas A. & M. game Thanksgiving day, will add one game to the total played.

FOOTWORK WON MAYORALTY JOB IN CLEVELAND

CLEVELAND, Ohio, Nov. 24.—From dethroned chief of police to mayor of Cleveland in eight years was the accomplishment of Fred S. Kohler. Strangely enough Kohler, who became prominent as the "Golden Rule Chief" during Mayor Tom L. Johnson's regime, was elected without making a campaign speech. Instead, for five months he conducted a house-to-house canvass which he carried into every ward and probably into every precinct in the city.

"How many miles did I walk? Thousands, but I have no idea just how many," the mayor-elect said. "Of course, not every doorstep had a welcome sign hanging up for me, but I had one line that I used whenever I found a chilly reception, and it never failed to thaw a cold group. If I introduced myself and no one seemed enthusiastic, I wound up with: 'Well if you'll vote for me I'll appreciate it' and if you don't I'll never know about it."

PROXY WINS FIRST FIGHT FOR THE GEORGIA PEACH

LOS ANGELES, Nov. 24.—Ty Cobb broke even here yesterday. He lost a ball game to Vernon, 5 to 3, and then won a fist fight by proxy.

In the seventh, after Ty had been up for the third time without getting a hit, a bird in the right field bleachers called him a yellow bum. This caused Ty's hot Southern Democratic blood to circulate fiercely even on a cold day, and he made a bee line for the bleachers.

ENGLISH CAN SUE FOR BETS PAID BY CHECK

New Court Decision Paves Way for Actions Involving Millions of Dollars.

By CHARLES McCANN, United Press Staff Correspondent.

LONDON, Nov. 24.—British bookmakers have just received a blow that may mean the end of the present betting system in England and at best means millions of pounds in law-suits before the present law has changed.

The house of lords—the final appeal court—has decided that betting by bank check is illegal.

The decision means that any person who has paid or received a bet by check during the last six years—after which the statute of limitations, invalidates claims—can sue or be sued for the money.

It means that bookmakers may be sued by losers, or by the heirs of losers, for hundreds of millions of dollars and can in turn sue for more hundreds of millions from successful backers; and that the courts, unless the law is changed can do nothing except order repayment.

A backer sued a London bookmaker for \$25,000 lost in betting on a horse race and paid by check. The lower court decided in favor of the backer, and the appellate courts in turn backed up the decision.

Already suits for recovery of losses are pending involving \$3,500,000. There will be nothing to it now except collecting the money. Similarly, the decision affects losses in any kind of betting, such as card playing at clubs, can be recovered provided they were paid—as is customary all over England—by check.

And England is a betting country. The bets range from a penny up to the tens of thousands of pounds that the Solly Joads and Jimmy Whites put up when their horses are running. London papers go to press with every horse race in England, and everyone in London, from charwomen to cabinet members and the royal princes, bets frequently, freely and unashamedly.

The ordinary backer deals with one or two or three bookmakers, with whom he has accounts. His winnings and losses are paid by check. And every bet paid by check by anyone in England within the last six years is illegal.

The house of lords already has discussed the decision (given by the house of lords technically, but by the law lords of the house actually) with a view to obtaining joint legislation with commons to remove the danger of an avalanche of suits that will choke the legal machinery of England. The lord chancellor states his sympathy with the desire of other lords for a measure to legalize the bets. But the decision is the law of the land, and cannot be changed except by legislation by parliament. And parliament has been prorogued.

METHODISTS SHOWS BIG INCREASE IN SIX YEARS

CHICAGO, Nov. 24.—The number of Methodist Episcopal churches with a membership of 1,000 or more has doubled in the last six years, according to Rev. Oliver S. Baketel, editor of the Methodist Year Book. In 1915 there were 163 such churches in the United States, as compared with 232 at present.

Philadelphia leads the list with eleven. Columbus, Ohio, is next with nine. Detroit has eight and Baltimore five.

Rev. Baketel used the statistics up to the fall conferences of the denomination. According to conferences Northeastern Ohio has twenty-five churches with a membership in excess of 1,000. West Ohio seventeen. Pittsburgh eleven and West Virginia five.

Of the six largest churches, all over 2,500 in membership, three are in the colored conferences. The largest is at East Cavalry, Philadelphia, colored membership 4,320.

WRIST WATCHES AS SCHOOL TIMEPIECES ARE COSTLY

PRESCOTT, Ariz., Nov. 24.—Wrist watches recently replaced wall clocks in county schools here when it was found impracticable to keep portable bungalow school rooms furnished with the latter. The idea worked fine until County Superintendent Wheley surveyed the jeweler's item: "Six wrist watches, \$600." She asked the county attorney for an opinion and he found the purchases in conflict with state law.

It being impossible to lock the bungalow school rooms, wall clocks disappeared frequently, so the new system was installed, school authorities said. The timepieces were not gifts to the teachers, but were designed to remain school property during the term of their natural usefulness. The expenditure seemed perfectly natural, according to Mrs. Wheeler, and so the wrist watches were bought. School authorities are pondering over a solution of the difficulty.
