

State Solons Head for Home But Leave Bags Unpacked

AUSTIN, Tex. (UPI)—After writing the second one-year budget in the state's history and offering Texans their first chance in 50 years to legalize mixed drinks, Texas legislators scattered across the state today—but most will wait awhile before unpacking their bags.

At the discretion of Gov. Preston Smith, they could be back in Austin before the last echoes of the 61st regular legislative session have faded away.

While the lawmakers routinely handled last-minute details before adjourning at 4:13 p.m. Monday, Smith made it known that there are at least

two bills on his desk that he doesn't like.

If he vetoes either of them, the legislature will have to be called back into special session this summer.

Those measures are the one-year \$2.8 billion Appropriations Bill for fiscal 1970, and a \$10 student building use fee for state colleges that is necessary to balance the budget plan.

House Speaker Gus F. Mutscher said just before adjournment Monday he is convinced legislators took the right step in writing the one-year spending bill, and again expressed hope that Smith will accept it.

Mutscher also patted solons

on the back for their accomplishments this session.

Major issues approved by the legislature include:

—A proposed constitutional amendment that would legalize the sale of liquor by the drink in Texas.

—An amendment authorizing issuance of \$3.5 billion in bonds for development of a long-range plan to import water from the lower Mississippi River to Texas.

—A state minimum wage of \$1.25 an hour effective Feb. 1, 1970, the first such wage minimum in Texas history.

Watson Elected President Pro Tempore of Senate

AUSTIN (UPI)—Sen. Murray Watson Jr., D-Waco, was elected Monday as president pro tempore of the Senate.

Watson, 37, a senator since 1963, was elected to the honorary post by his colleagues. Traditionally, the job is awarded to the senior senator who has not yet held it.

The president pro tempore serves as governor for a day in the absence of both the governor and lieutenant governor. No date was set for Watson's day as governor.

A new president pro tempore will be elected whenever the legislature meets again, and Gov. Preston Smith is expected to call a special session sometime this summer.

Police Hunt Clues in Deaths Of Two Wealthy College Girls

EGG HARBOR TOWNSHIP, N.J. (UPI)—State and county police used metal detectors today to comb the woods of this seaside community for clues to the murder of two college girls who were stabbed repeatedly and perhaps raped over the Memorial Day weekend.

The search already had uncovered a pair of eyeglasses and a watch near where the nude body of Susan Davis and the partially stripped body of Elizabeth Perry were found Monday with their torn clothes strewn around them.

It was not certain immediately whether the glasses and the

watch were connected with the crime.

The bodies of the college friends, both 19, were identified by their fathers, soft-drink bottler Wesley Davis of Camp Hill, Pa., and papermill executive Ray Perry of Excelsior, Minn. They flew here from Harrisburg, Pa., the city nearest Davis' home, where they had been waiting for word of the missing girls.

Miss Davis and Miss Perry, friends from Monticello (women's junior) College in Godfrey, Ill., spent a few days last week at a rooming house in Ocean City, N.J., a shore resort.

They left Ocean City at 4:30

a.m. Friday, hoping to avoid heavy holiday traffic on a drive to the Davis home in Camp Hill, about 135 miles northwest of here.

The blue 1966 auto in which they were traveling was found abandoned Friday on the Garden State Parkway and towed away by police. On Monday when the car was recognized as belonging to the missing girls, searchers found their bodies about 100 yards from where it had been parked.

The bodies were partially decomposed when they were found, and the autopsy surgeon was unable to determine positively whether the girls had been raped.

Homicide Charges Due in Drownings Of Six Cubans

RIO GRANDE CITY, Tex. (UPI)—Charges of negligent homicide were expected today against a Rio Grande City man in connection with the drowning deaths of six Cubans as they attempted illegally to enter the United States.

Starr County Deputy Sheriff Roberto Pena said the unidentified Cubans were being smuggled into the U. S. Sunday night in a boat owned by two Rio Grande City cousins. One was still at large today.

The boat reportedly hit a rock in the river and capsized, he owners of the boat swam to safety, but the Cubans, two men, two women and a teenage boy and girl drowned.

Convicted Killer Releases Hostage Then Surrenders

LUMBERTON, N.C. (UPI)—Fugitive Ricardo Resendez, who allegedly killed a guard in a prison break Monday, released his last hostage unharmed today and walked quietly from a brick farmhouse where he had been holed up.

Authorities said Resendez surrendered after talking on the telephone with James Lee, a fellow convict who took part in Monday's escape. Lee had surrendered earlier today.

Resendez released his last hostage, Isley Wilcox, unharmed. Wilcox's wife and son and a prison guard were released earlier.

After Resendez talked to Lee, a prisons department officer entered the house and stayed about 20 minutes, then brought out the fugitive.

Resendez, 26, of Los Angeles, and Lee, 21, of Fayetteville, N.C., had been holed up in the farmhouse with a pistol and rifle since Monday.

Authorities had been communicating with the fugitives by telephone.

Resendez, serving 70-120 years for murder and kidnapping, and Lee broke out of the Robeson (Lumberton) County Prison camp Monday.

Prison camp Supt. Joseph Brooks said Resendez "somehow got hold of a gun"—a small caliber pistol—and shot to death guard Earl C. Strickland, 33, of Fairmont, N.C. in a "scuffle."

Lee joined Resendez, according to prison officials, and the men took another guard, Sgt. Ebert Locklear, as hostage. They fled with the pistol, Strickland's revolver and a .30-.30 rifle in a car belonging to another guard.

Locklear later was found, bound and gagged, in the abandoned car. He was unharmed.

The fugitives entered the farmhouse, about six miles south of Lumberton, a tobacco city in southeastern North Carolina, and took Isley Wilcox, 67, hostage. Several other occupants of the house were allowed to leave unharmed.

A posse of more than 200 law enforcement officers, including state troopers, tracked the fugitives to the farmhouse and surrounded it. One of the convicts telephoned the Lumberton Police Station and talked with Chief W. C. Lovette.

56 Missing in Collision at Sea

Melbourne Involved In Second Disaster

PEARL HARBOR, Hawaii (UPI)—The aircraft carrier Melbourne, flagship of the Australian Navy, collided with the U.S. destroyer Frank E. Evans in the South China Sea near Vietnam and today rescue planes searched for 56 men missing from the American warship.

One man was known dead from the 273-man crew of the Evans, the onetime "gray ghost" of the Pacific which was sliced in two by the Australian vessel.

The tragedy almost paralleled a disaster involving the Melbourne in 1964 when the carrier sliced through an Australian destroyer and 82 men aboard the smaller ship lost their lives.

Shortly before sunrise today the Melbourne cut through the Evans. Within two minutes, the forward part of the American warship sank.

Details of the accident, 285 miles southeast of Saigon in the South China Sea, filtered slowly into the U.S. fleet headquarters here. But the Australian navy issued a statement saying that "the Melbourne ordered the Evans, which was ahead of her in the anti-submarine screen, to change course and despite urgent action by the Melbourne a collision occurred."

A U.S. Navy spokesman declined comment on the statement by the Australian navy. "We're waiting for additional information before we can make a comment," he said. "An investigation will be held to determine what happened."

The accident occurred during maneuvers conducted by forces of the Southeast Asia Treaty Organization (SEATO). A U.S. navy spokesman said the (See DIASTER, Page 3)

Pompidou All But Assured Of Presidency

PARIS (UPI)—Georges Pompidou today was all but assured the presidency of France by the Communist party decision to boycott the June 15 runoff election. It robbed Alain Poper of his only hope for upsetting Pompidou.

Poper needed the surprisingly strong vote the Communists rolled up Sunday if he were to have a chance to beat Pompidou. The Communists virtually killed that chance Monday.

Despite that, aides to Pompidou said the former premier would conduct a hard-hitting campaign against Poper in the week of official stumping that begins Friday.

Poper said he would make personal appearances around the nation, having refused two requests from the Pompidou camp that he withdraw.

Nixon Leaves On Peace Mission

WASHINGTON (UPI)—President Nixon today began a peace mission that takes him from a small South Dakota college to the Midway Islands in the Pacific Ocean.

This peace quest involved not only war in Southeast Asia, but unrestrained violence in America. He will meet next Sunday on Eastern Island of the Midway group, about 1,100 miles beyond Hawaii, with President Nguyen Van Thieu of South Vietnam.

En route, however, Nixon scheduled two major addresses. First, this afternoon at General Beadle College in Madison, S.D., where he will concentrate on what the White House described as "basic values of America currently under challenge." Liberally translated, this meant campus unrest, violent demonstrations and what Nixon regards as dangerous slippage of public respect for law and order.

The Chief Executive was to leave Washington at 11 a.m. for Sioux Falls, S.D., switching there to a helicopter to take him to the Madison campus in time for a 3 p.m. CDT address and dedication at a library honoring Sen. Karl E. Mundt, R-S.D.

Soviets Denounce Chinese As Summit Meeting Nears

MOSCOW (UPI)—The Soviet Union today reminded delegates to the upcoming international Communist summit meeting—and the world—of its hostility toward Red China.

The Defense Ministry newspaper Red Star said Chairman MAO Tse-tung has opened "the second front against the Socialist countries" by pursuing his "chauvinistic" foreign policy course.

The attack on the Soviet Union's giant neighbor came at the last summit, including plans for unprecedented attention to non-Communist newsmen. Although the Soviets were unable to push through plans for a condemnation of the Chinese at the upcoming meeting, the Red Star article today left no doubt about its feelings toward Mao and his followers.

"The decisions of the so-called ninth congress of the Communist party of China was another evidence that MAO Tse-tung and his group have fully divorced themselves from the ideology of Marxism-Leninism," Red Star said. "They launched the struggle against the world Communist movement, and along with the imperialist front, they opened the second front against the Socialist countries."

For the first time at an international Communist congress, a foreign press center will be provided newsmen, according to an announcement by the Soviet Foreign Ministry. About 70 parties were expected to attend the meeting.

During past Communist summits, such as those in 1960 and 1957, the Soviets did not have any special arrangements for foreign newsmen. Reporters obtained what information they could from the official press releases.

South Viet, U.S. Troops Discover 259 Cong Bodies

SAIGON (UPI)—South Vietnamese troops today reported finding the bodies of 259 Communist soldiers slain in American air and artillery strikes against the new guerrilla threat to Dak To in the Central Highlands.

The announcement from Saigon headquarters said the government soldiers turned up the bodies Monday seven miles southwest of Dak To where U.S. B52s and artillery strikes had raided during the weekend.

The find by South Vietnamese soldiers was one of the biggest of the year following American bombardments and indicated the value of the big bombers and guns—a tactic that gets results without risking lives.

Headquarters in Saigon simultaneously announced several small but sharp skirmishes that killed 246 Communist troops from the Mekong Delta to the Demilitarized Zone (DMZ) Monday and today.

At least four of the battles raged on Saigon's outer defense ring, on three sides of the capital from 34 to 55 miles from downtown. Seventy-three Communists died in these battles, with U.S. losses put at four killed and 53 wounded.

War communiques also announced the end of Operation Speedy Express, a six-month offensive that centered 35 miles south of Saigon and accounted for 10,899 Communists killed and 2,579 suspects captured.

Viet Cong and North Vietnamese gunners fired 11 overnight rocket and mortar barrages into Allied towns and military camps, causing damage and casualties at four sites, the command said.

KANSAS CITY, Mo. (UPI)—Five children and two adults were killed early today in a midtown apartment house fire. One of the children, an infant, died in the arms of a man who leaped from a third floor window.

Thirteen other occupants of the building were not immediately accounted for but police said "this does not mean they are in there."

Eighty persons were left homeless by the three-alarm fire.

Firemen reached the top floor of the three-story brick building after an hours-long battle with the flames. They found the bodies of Mrs. Barbara Smith, 19, Edmond Godden Jr., 5, Scarlett Godden, 3, Mrs. Joyce Franks, and two unidentified children, a boy and a girl,

Briscoe Making Noises on Bid For Governor

AUSTIN (UPI)—Dolph Briscoe Jr., an unsuccessful candidate for governor last year, has told a select group of political campaigners he is available to run for governor in 1972. But he reportedly told them he will not run against Gov. Preston Smith next year and does not intend to run against U.S. Sen. Ralph Yarborough in 1970.

Briscoe's political future was the subject of a previously unreported meeting at his Uvalde ranch last month. A reporter for a Dallas newspaper was there but apparently was invited on condition that he not report the meeting.

Briscoe, contacted at his ranch, declined to comment. Briscoe invited about 30 men, most of them prominent behind the scenes in past campaigns, to his ranch for a weekend of fishing and political talk.

Among those present were Herbert C. Petry Jr. of Carrizo Springs and Garrett Morris of Fort Worth, state highway commissioners; George Christian of Austin, former press secretary to Gov. John Connally and President Lyndon B. Johnson; and State Rep. Dave Finney of Fort Worth.

A participant in the meeting said only five of the 30 men present were Briscoe supporters last year when he ran fourth in a field of 10 in the Democratic primary for governor. The others attending the meeting included backers of Gov. Preston Smith and men identified with Connally, he said.

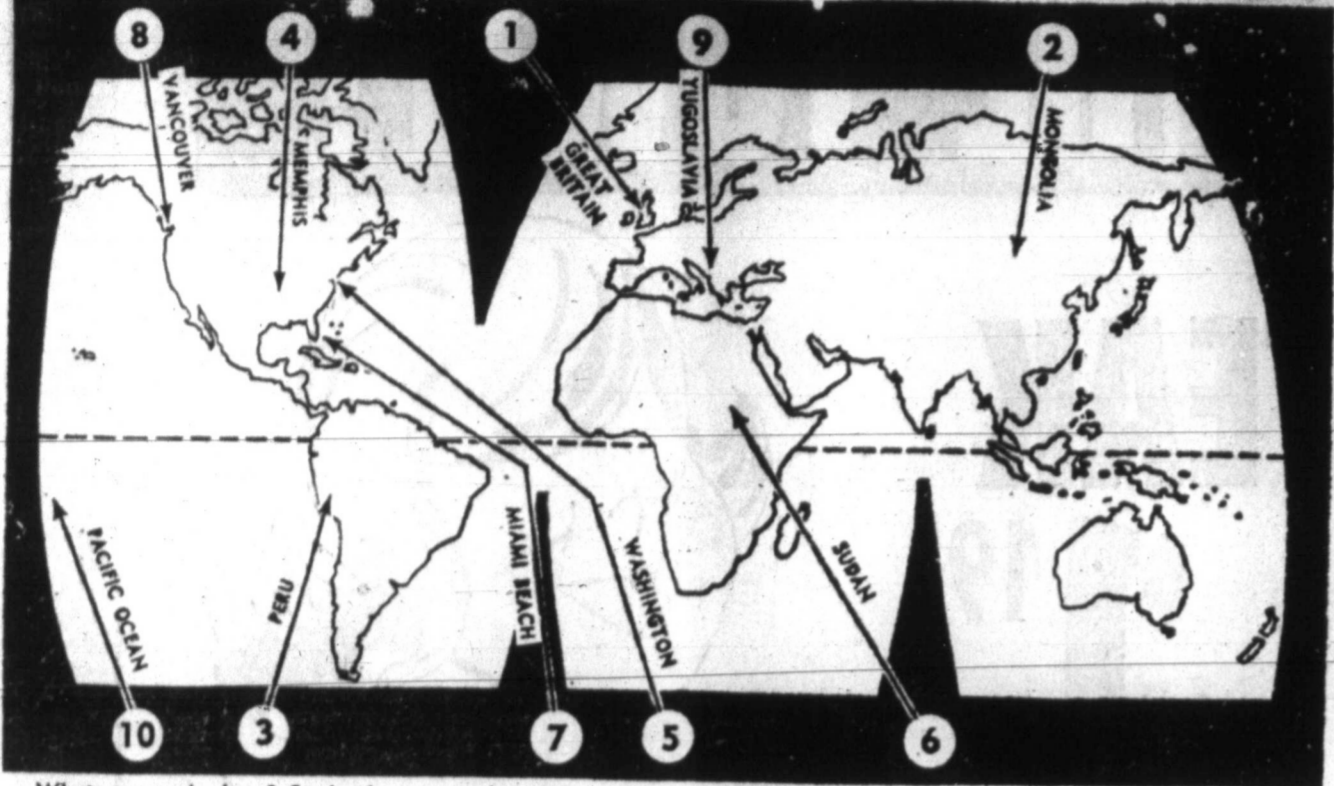

TV In Review

HOLLYWOOD (UPI)—If you took a poll of the favorite people of actors and actresses, Dave Tebet would be high on the list.

A lot of people think he has the best job in television. If that is so—and perhaps it is—then it is because he has personally made it so. He is one of a kind—a human link in the steel-and-glass jungle of video.

Tebet is vice president in charge of talent for NBC-TV, and no other network has anyone quite like him. Aside from his professional knowledge, performers speak with affection about his dash and intimacy; as one of them puts it, "a personal grace that most junior executives don't understand."

Middleaged, a former publicist and Temple University product, Tebet is therefore an ideal connection for NBC-TV between the more colorful days of individual Broadway stylists and the current era of corporate rule in show business.

Tebet's job is to acquire major talent for NBC-TV, and to take care of the problems and needs of the network's performers.

"You see," says Tebet, "there are things with actors that people don't understand. Some put them down. I don't. I love them."

"The ones that are trying to make it often live a life of rejection. Someone is always saying no. I have a rule with the casting department: Anybody, known or unknown, who wants an interview or audition must get it if they've had some experience, even in college or drama clubs. They have to get the opportunity to be heard—they must be listened to—even if they're not signed or hired. "Stars also have rejections. The turning off of a knob on a television set is one. A bad notice is a rejection. Not buying a ticket for their show is a rejection. So how about somebody tries to understand them? You have to take the time with them—everybody is so busy."

Loud Music Injurious to Ear Drums

WASHINGTON (UPI)—The not-so-silent generation may give to a deaf one unless the tender ears of rock and roll fans are protected from their addiction to over-amplification, according to consumer safety critic Ralph Nader.

"Acoustic trauma from rock and roll music is emerging as a very real threat to the hearing quality of young people who expose themselves to substantial durations of this music by five rock groups with high amplification," Nader said in letters to Sens. Warren G. Magnuson and Philip A. Hart.

"This country may be producing a new generation of young Americans with impaired hearing before they reach the age of 21," Nader wrote Sunday.

He called on Congress to act quickly to avert widespread disabilities in the letters addressed to Magnuson as chairman of the Senate appropriations subcommittee for labor and health and Hart as chairman of the subcommittee on environment.

"The nature of this hazard and its avoidance merit your attention, if only to foresee and forestall even more aggravated risks and to focus public concern on noise traumas of all kinds in our occupational and public environments," he said.

Nader said the American Medical Association, the Workmen's Compensation Board of New York State and other groups consider a level of 85 to 90 decibels over a long period of time to be "hazardous" to hearing. At the same time, he said, soundings at discotheques had disclosed levels of 125 to 138 decibels, although the pain threshold is at 140 decibels for most people.

Night Bob Kennedy Was Shot Was Confusion

LOS ANGELES (UPI)—It was nearing midnight in the suite on the fifth floor of the Ambassador Hotel and Bobby Kennedy was slumped down in a chair with his feet propped up on a bed watching television and sipping from a glass of ginger ale.

The returns showed he had beaten Sen. Eugene J. McCarthy in the California Democratic presidential primary and Pierre Salinger was urging him to go down to the Embassy Ballroom below and speak to the jubilant crowd assembled in a victory celebration.

The senator seemed reluctant. Someone asked him if he had information about the returns other than the figures on the TV tube.

"No," he said. "It used to all sorts of reports but now television gets it all first. It's getting to be an awful bore."

Mrs. Ethel Kennedy was sitting on the other side of the bed and someone said the vote showed that not everybody disliked her husband. She took a playful poke at the speaker.

Dog and Astronaut
"I wonder if we should take Freckles down," Kennedy said. "You know they say I used a dog and an astronaut to win."

John Glenn, who was on the other side of the room, chuckled.

Lill Barry, Kennedy's bodyguard, was off in a corner, chatting. The senator had declined any police protection and Barry had the responsibility for his safety though pro football player Roosevelt Greer and decathlon champion Rafer Johnson often helped in crowds.

"I get mixed up with the crowds and I can't see," Barry was saying. "And I get tired. Maybe I won't be able to react quickly enough. I wish somebody would talk to him."

It was midnight now and finally Bobby got up and put on his coat jacket and straightened his tie and walked out the door toward a service elevator.

Someone asked if he ever wondered if it was all worth it.

Implicit in the question was the tragic death of his brother in Dallas four and one-half years before.

"I like politics," Kennedy said. "It's an honorable adventure. Lord Tweedsmuir said that: 'It's an honorable adventure.'"

Then Kennedy and his wife and Barry and Jess Unruh and a few others got into a service elevator and went down to the second floor and through a kitchen area and out onto a small stage overlooking the Embassy room which was filled to bursting with a crowd perspiring under the brilliant television lights and buoyed up with elation and other spirits.

In The Mood
Kennedy got into the mood immediately. He played around with the microphone and asked whether people could hear him.

"I want to first express my high regard to Don Drysdale who pitched his sixth straight shutout tonight and I hope that we have as good fortune in our

campaign," he said. Then he turned serious.

"What I think is—what I think is quite clear is that we can work together in the last analysis and that what has been going on in the United States over the period of the last three years, the division, the violence, the disenchantment with our society, the division whether it's between black and white, between the poor and the more affluent or between age groups or over the war in Vietnam, that we can start to work together. We are a great country and an unselfish country and a compassionate country. And I intend to make that my basis for running in the period of the next few months."

He turned and jumped down the two feet off the back of the stage and started the wild push through crowds that extended their hands to shake his or just touch him which marked his every appearance.

Mrs. Kennedy, pregnant with their 11th child, was on the other end of the stage and Bill Barry hesitated a moment to help her down off the platform and that brief span of time the crowd closed in between him and the senator.

Karl Uecker, the assistant matre d' at the Ambassador, had Kennedy by the right hand and was leading him through a pantry toward the Colonial Room where the "pencil press" reporters were banging out their stories. It was a last minute change of plans. Kennedy originally had been scheduled to go downstairs to another victory celebration in a ballroom on the ground floor.

Kennedy stopped to talk with the kitchen help. He shook hands with Juan Romero, a 17-year-old busboy.

Pulls Trigger
Seconds later, a tiny little fellow named Sirhan Bishara Sirhan stepped off a tray rack, shouted "Kennedy, you son of a

bitch" and shoved a .22 caliber revolver an inch from the senator's ear and pulled the trigger.

The gunman kept firing until he had emptied the eight cartridges in the chamber. Two other bullets entered Kennedy's body below his right armpit and the others felled five persons standing nearby.

It was 12:15 a.m. Wednesday the 5th of June, 1968.

In one lightning moment—the old superstition came true—tragedies, big and small, come in threes. John Kennedy, Martin Luther King, Robert F. Kennedy.

There was a frozen instant incomprehension and then it was pandemonium.

Kennedy crumbled to the floor. Juan Romero bent over him and put a rosary in his hand. A wild-eyed Ethel Kennedy came tearing her way through the crowd, knelt in a pool of blood and began shouting:

"Get back, all of you! Get out! Please get out! For God's sake, give him room to breathe."

Eight feet away, Barry, Grier and Johnson were struggling for the gun and pinning the tiny assassin down on a steam table.

In the ballroom, a noise like "Chinese firecrackers" had been heard and then shouts for a doctor went out over the public address system and the word spread: "Bobby's been shot."

Whisked Away
Two police officers arrived and literally ran with Sirhan out of the hotel. They whisked him into a patrol car and sped off to Ramparts station. California legislative leader Jess Unruh was in the car and Sirhan mumbled "I did it for my country." For the rest of the night and well into the next day the 24-year-old Arab immigrant refused to tell police anything—not even his name.

It seemed an eternity until ambulance arrived. Then two

attendants carried Kennedy out on a stretcher with Ethel holding back their pace so they wouldn't jostle her husband. They sped to Central Receiving Hospital. Kennedy had sunk into a coma.

A young doctor at Central Receiving examined Kennedy and then roughly slapped his face in an attempt at revival. Ethel Kennedy, sitting on a high metal stool, gasped. The doctor handed her a stethoscope and put it to Kennedy's heart. An expression of relief spread over Ethel Kennedy's face and she said: "Will he live?"

"Yes, right now he's going to be all right," the doctor said. Father Thomas Peacha of nearby St. Basil's parish entered the room and performed the last rites of the Catholic Church.

But at that time, no one could comprehend that Kennedy would die.

Kennedy stayed at Central Receiving less than 30 minutes.

Then he was transferred to Good Samaritan Hospital.

Remove Fragments
Surgeons spent three hours and 40 minutes removing the fragments of the bullet from his brain.

Frank Mankiewicz, the senator's press secretary, hid his grief and dealt with the horde of newsmen.

At 2 a.m. on the morning of June 6, Mankiewicz read a brief statement. Robert Kennedy had died at 1:44 a.m.

It has been a year now since those shattering days.

This correspondent sat for three and one-half months in a fortress courtroom for the trial of Sirhan. Sirhan said he could not even remember killing Kennedy, that he was in a "trance" when he fired the fatal bullets.

A jury of seven men and five women did not believe him. They sentenced him to death. He sits now in death row in San Quentin awaiting an order to enter the gas chamber which probably will never come.

COLORADO SPRINGS, Colo. (UPI)—President Nixon, many executive officials, along with members of Congress are deeply disturbed—even puzzled—by what is generally described as campus or student unrest.

One question intrigues certain government officials: Who finances so-called leaders of campus unrest as they move swiftly from one trouble spot to another? A number of studies in this area are taking place on and off Capitol Hill.

Visiting on the beautiful, rolling campus of the U.S. Air Force Academy, the President did not expect to encounter any visible evidence of student unrest or demonstration against his policies. Also, there was no question about who finances these students—Uncle Sam.

There might be some among the large Air Force cadet corps who question certain aspects of national policy, but shouting out their feelings to the commander-in-chief was another thing—provided they wanted to remain in the Air Force and on the government payroll.

To some more liberal young Americans, the life of a service academy cadet, be it here, at West Point or Annapolis, may seem repressive. But so, too, are conditions which some activists attempt to impose on those with whom they disagree on other campuses.

Large Difference
There's another large difference between a service academy cadet and libertarian students picketing or sitting-in at other universities: source material, origin of information and whether it is to be believed.

One primary stated complaint on some of the campuses this spring is that required subjects and the grading systems are not relevant to the times.

Clean Shaven Cyclists Go to Court

LAS VEGAS, Nev. (UPI)—Shaved and shorn, 36 disgruntled members of motorcycle clubs went to court today on charges ranging from drunkenness to marijuana possession.

The men, plus 16 women from three Western motorcycle clubs, were arrested late Saturday in a sweep by sheriff's officers at Charleston Park, 30 miles north of Las Vegas.

Campers there had complained of harassment and fighting.

The shaves and haircuts were administered Sunday over the outraged protests of the cyclists.

Grimacing sheriff's officers denied it was discrimination. They said baths, shaves and haircuts are normal procedure for all men admitted to the Clark County Jail.

Deputies said that in arresting the 52 suspects they confiscated two pistols, a shotgun, four packets of marijuana, pills and a variety of knives.

Those arrested included members of the Misfits from San Francisco, the Devil's Disciples from Arizona, and the Gents of Nevada. They assembled at the mountain campground for the Memorial Day weekend.

Sirhan Spirits Low As Death Time Near

SAN QUENTIN, Calif. (UPI)—Sirhan B. Sirhan has suffered a slight declension in spirits and is a trifle pale since entering San Quentin Prison's death row, according to the youngest brother of the convicted slayer of Robert F. Kennedy.

Munir Sirhan, 21, met his condemned brother privately for 90 minutes Sunday as guards watched through the barred windows of a special interview cell.

Munir later told newsmen outside the gate he thought Sirhan "looked pale."

"I also thought his spirits were getting down a little bit," Munir said. "They were real high during the trial, but I noticed a slight difference now."

Munir also said Sirhan was willing to accept the legal assistance of San Francisco lawyer Melvin Belli, who accompanied Munir to the fog-shrouded prison but was denied permission to visit Sirhan.

Young Sirhan and Belli arrived at the prison in a Rolls Royce owned by the lawyer, who wore black cowboy boots, a brown pinstriped suit, checkered bow shirt and black tie. He said he was hired by the condemned man's mother to work at overturning Sirhan's death sentence but San Quentin officials said he could not speak with Sirhan because Belli did not make previous application and "was not an attorney of record."

Russell Parson and Grant Cooper represented Sirhan during his trial in Los Angeles, where he was formally sentenced May 21 to death in the gas chamber for the fatal shooting of Kennedy last June 5. In California, an appeal is automatic and no date for the execution has been set.

Munir quoted his brother

Sunday as saying, "I'm willing to accept any help that is offered me and won't turn down anybody. If Mr. Belli wants to help me... let him do it."

Belli said he would examine the trial transcript of the Sirhan case and file a "friend of the court" brief with the California Supreme Court "within a month or 60 days."

He said he would base the appeal on the contention the death penalty constitutes cruel and unusual punishment.

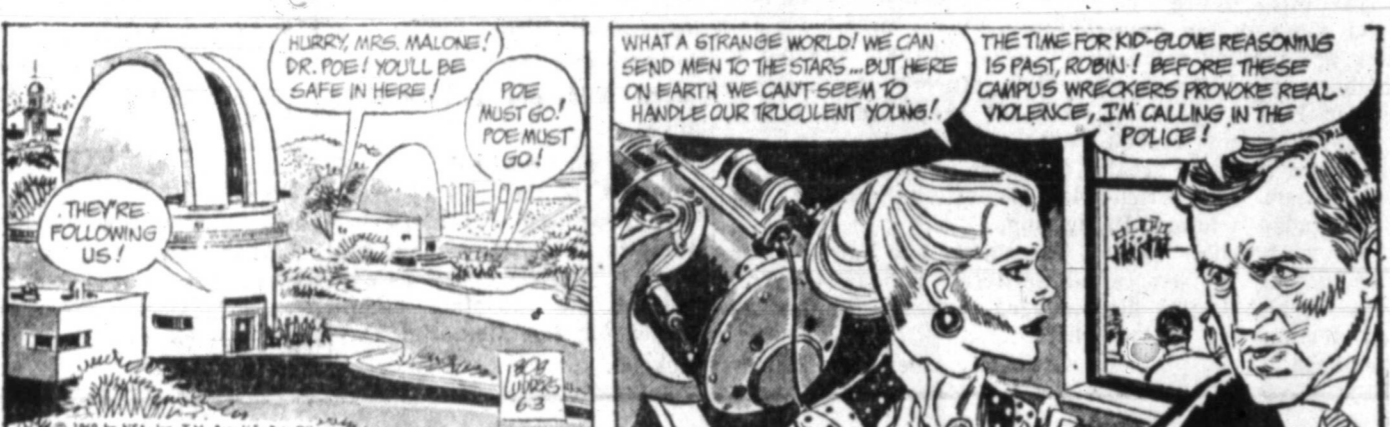

LBJ Is 'Disconnected'

Looking back, with the advantage of four months' hindsight, it appears that few, if any, of the accounts we read were very precise on the events at the White House on Jan. 20, and so we still do not know if Lyndon Johnson turned out all the lights before going up to the Capitol to turn over the reins of government to Richard Nixon.

But it seems clear one thing he did do was to call the telephone company and tell them to take out the phones at his Texas ranch. And that set in motion what is surely the biggest demolition team in Texas history.

Don't misunderstand. This demolition team did not break up the 6,300-foot airstrip that was built on Lyndon's ranch; it did not tear down the several buildings and trailers that were used to house guests, staff and newsmen. These buildings will be needed to quarter the dozen or so secret service men who guard Mr. and Mrs. Johnson, as well as the two Air Force sergeants who are on detail at the ranch. Nor were all those "wild flowers" which the Bergstrom Air Force men planted at the ranch dug up.

The demolition team was concerned only with the telephone equipment. And would you believe they've taken out 330 telephone lines which run out of the ranch to Washington, to

neighbors and to the Lord only knows where? It's revealed that 10 of those lines—yes, — were direct to the office and home of Lyndon's business partner, Judge Albert W. Moursund. And one of those lines was connected into the judge's bathroom.

Not many business partnerships are carried that far. Cmdr. Bucher couldn't rate a phone reliable enough for him to call the engine room on the USS Pueblo. But, somehow, we feel equally sorry for Judge Moursund who couldn't escape one anywhere, even in his own bathroom.

But, that's the way things are when you're government. Economy is a relative thing. You save a penny here on the light bill and spend it there on the telephone bill.

Sometimes you have to spend money to save it. The University of Texas is spending \$6 million for a Johnson museum and library. Atop it will be a helicopter landing pad for a government-provided helicopter, and an oval office that is a copy of the one in which Lyndon worked in the White House. As soon as the building is completed, it will be permanently leased to the General Services Administration in the government. That's when the saving will begin.

How can you duplicate the White House oval room any cheaper than that?

Nudity Is Nothing New

A Sunday supplement carried an article by Edward Silberfarb, "All That the Law Allows." It revealed the popularity of nudity in modern plays and movies, complete with illustrations.

The openness with which all aspects of sex are treated today does not mean the subject is new. Far from it. The orgies of ancient, decadent Rome and the mystic clubs and secret societies of London's history have been dealt with in literature. Today's unclothed scenes are baring nothing sensational or novel. That exposure is synonymous with entertainment has been rejected before.

Those who would foist unhealthy appetites, upholding just as inspirational material for celebration on stage and screen, are struggling for its legality. Witness the decision in their favor just handed down by the Supreme Court. The high court let stand a court decision that an act by a topless dancer in a nightclub is the type of freedom of expression protected under the Constitution. Tried first in a Municipal Court, the entertainer and her manager

were convicted of being involved in indecent exposure and outraging public decency.

The whole matter boils down to a matter of taste, rather than laws. No one yet is coerced to buy a ticket to such shows.

The article tried to explain the nudity vogue by giving Fordham University's Father John Culklin's answer that the root of it all is puritanism and reaction to the repressive atmosphere of family, church and school. Father Culklin said, "What we're going through now is a shake-down cruise, exploring a new morality."

There are strong doubts that this phase is "new morality" at all. It just seems to be another example of the poor logic that "if a little bit is good, surely a whole lot is better."

Treated to a diet of overabundant exposure, theatergoers, book lovers, newspaper readers and TV viewers will become bored and reject such fare. Moreover, there are doubtless, counter measures being cooked up even now by the fashion designers and costume makers who are not about to let such a trend run them out of business.

Despair: The Great Hang-Up

Two unrelated studies from the same city give a picture of a different kind of "generation gap."

The first, a study of 993 arrests of persons over the age of 60 in San Francisco, discovered that more than 80 per cent were for intoxication. This is a much higher proportion than in any other age group. The overwhelming majority were males.

About 15 per cent of the elderly arrests were for petty theft and relatively minor violations, such as drunken driving. Only 2 per cent were for offenses against others and, contrary to the Dirty Old Man myth, fewer than 1 per cent were for sex offenses or narcotics.

The image of the Brutal Cop also suffers in the report. Arresting officers do not regard elderly alcoholics as lawbreakers, dislike picking them up but often do it for their own protection and often give the men small sums of money to help them on their way.

In a very real sense, policemen give the equivalent

of "psychiatric first-aid" which is not available elsewhere.

Elderly arrests for intoxication increase during Thanksgiving and Christmas, when the loneliness of the derelict life is most acutely felt. In numerous instances, arrestees ask the judge for a jail sentence extending through the holidays.

Meanwhile, in the Tenderloin area of San Francisco, an estimated 1,000 young people from 12 to 25 spend their days looking for the fix, the high and the trip vouchsafed them from a variety of drugs ranging from methamphetamine, heroin, morphine, LSD and marijuana through Seconal, Nembutal, Dexamyli, Dexedrine and Benzedrine.

About 600 of these young people are chronic drug users, reports the Economic Opportunity Council of San Francisco, and they spend from \$150,000 to \$200,000 a month to feed whatever "monkey" is on their backs. In 1966, there were 324 narcotics arrests made in the Tenderloin; the average age of juvenile offenders was 16.

ABOUT TIME TO BECOME ANGRY

(Santa Ana, Calif.) Register
Two more college presidents have resigned from their offices within the last few weeks. Nobody knows precisely the current total of college presidents who have stepped out of office in the past few months, but one needs more than the fingers and toes to count them up.

It's all blamed on the confusion, turmoil, and outright meanness on the part of students on campus and their outside agitator reinforcements an. sympathizers.

Some of the resignations resulted from undeniable inability to cope with the campus problems, and others resulted from a feeling of just plain disgust and a desire no longer to be connected or associated with such goings on.

Collectively, the ex-presidents are being called "casualties of the current student unrest," and the impression one gets, unless he is careful, is that college presidents as a group are milling around dangerously nervous and on the verge of stampede.

No such thing is the case. Only a small percentage of them have yelled quits. Most are continuing with their work and at the same time trying to take sensible attitudes and act reasonably in the new situations as they present themselves.

So a question is raised. We'll not attempt to answer it, but it does seem appropriate to ask if many of the resigned college presidents would not have been better off — and their colleges as well — if they had not been in office in the first place.

Any suddenly changed situation requires adaption on the part of all who are in it. If the change is great enough, some persons are bound to be squeezed out, one way or another, and they must seem to be, though there are exceptions, the marginal performers anyway.

Sen. Abraham Ribicoff says he thinks the student unrest will prove in the long run to be a good thing. Maybe he has the quitters in mind and maybe, to that extent, he is right.

Others like Columbia University's Jacques Barzun, think that great and lasting damage is being done. Barzun told a House Education subcommittee that American universities will not recover for decades from their current straits.

Well, the resignations will run their course, not only for presidents of universities, but also for the professors who are quitting or thinking about it. At some future time one must hope not too long from now, all who will throw up their hands will have done so.

Who will be left? Eric Hoffer, also testifying in Washington, pointed directly to some of the qualities hopefully to be found in the men who survive and remain as college heads.

The longshoreman-philosopher said, "We need to get angry!" He is absolutely right. "We ought to be shocked!"

The attitude of men and women who hold more degrees than Fahrenheit toward the self-taught San Francisco dock worker is not well disguised; there is some admiration in it, perhaps a little fear, some amusement and rather reeking condescension.

He has his attitude toward them, too, finding most, "intellectuals" a sorry lot who pervert rather than lead, who contribute little, and who say elaborately but with cotton lined mouths only that which will help to preserve the concealment that "they never had an original thought in their lives."

In his testimony, as in many of his lectures, Hoffer was holding out for the whole, healthy man. And in his view, no man is complete if he does not have the capacity to get mad when mindlessness, meanness, and criminality rise up and rear.

—Not even college presidents. Maybe the lack of that quality marks the line of the margin, the division between those who quit and those who will remain and perform like whole men in the coming months and in the decades of damage repair.

Blackmail in the Church

Who are these characters running up and down the aisles of our churches demanding "reparations"? Blacks insisting that you and I must pay them millions of dollars because our ancestors kept their ancestors in slavery. The protection racket is nothing new to us Chicagoans. We learned from Al Capone how to get money from anybody by threatening to firebomb his business.

But whatever they are calling it now, the law still calls it "blackmail" and "extortion." Sunday before last an unidentified black entered into the King Avenue United Methodist Church in Columbus, Ohio, strode down the aisle shouting "Black Manifesto! Black Manifesto!"

He demanded to read aloud his document demanding that churches and synagogues pay \$500 million in reparations to the Negro race.

He was allowed to read his document, declined an invitation from the pastor to remain for the worship service.

In one of the largest Presbyterian churches in the South, in Atlanta, militants similarly interrupted services, demanding \$500 million reparations from white churches.

The similar strategy and identical sums and parallel wording of their "manifesto" is immutable evidence that this is a co-ordinated campaign.

So we who might have wished to dismiss the petition as absurd and unworthy of mention don't dare now. Too many confused Americans are beginning to take it seriously.

It was angry militant Negro leader James Forman who launched this "black manifesto" campaign when he invaded services at the Riverside Church in New York City last month, shouting his demand for \$500 million specifically "for 80 per cent of the annual income of the Riverside Church, 12 hours of free radio time each day on its radio station and free office space."

Perhaps unfortunately, he received immediate encouragement from the pastor of that church, Dr. Ernest Campbell. Dr. Campbell publicly agreed with Forman that the American Christian church had profited from the black man's bondage (he did not explain when or how), that the church should and would contribute a fixed amount of its annual income.

Having fasted blood, the National Black Economic Development Conference promptly moved in on other churches. They may seek to "sell protection" to your church next Sabbath.

This is nothing you can ignore any longer. If churches refuse to "buy protection," Forman urges blacks to seize church property; says "we are not opposed to force or violence."

The American Baptist Convention is right now seriously considering paying this blackmail.

But most churches are still mostly supported by white contributors. And there is evidence that some of them are reaching the stomach-turning point—and may in fact reduce rather than expand their traditional support for Negro causes.

Then again the cruel paradox: The deserving blacks will be deprived because of the militancy of these mercenaries.

UNREALISTIC RULING

The Supreme Court again has gone into the "one man, one vote" concept in setting the boundaries of congressional districts and again has departed from reality in its decision. This time a divided court struck down congressional district plans in New York and Missouri.

The Missouri case shows how far the court majority has gone in requiring the impossible. That state has 10 congressional districts. The "ideal" population per district would be 431,981. In 1967 the Missouri legislature came up with a plan with an average variation from the ideal of 1.6 per cent. The greatest variation was 3.33 per cent in one district, in which the legislature properly had taken into account such factors as the location of a university and a large military base.

But the court said this was not satisfactory. The majority ruled that unless a state can justify "any" numerical variance between districts, "no matter how small," the plan is unconstitutional.

Justice White, voting with the minority, commented that when the court finds a three per cent variation not to be constitutionally permissible "it is losing perspective and sticking at a trifling." And he added that "to inject the courts into these minor squabbles is an unacceptable pre-emption of the legislative function."

That seems to be putting it mildly. This latest ruling gives strength to the rising demand for a constitutional convention, called by Congress in response to state petitions, to rewrite the rules regarding the function of the Supreme Court. Many state legislatures already have approved petitions to call such a convention.

Unwelcome Mat for Fortas At His Old Law Firm

WASHINGTON — If former Justice Abe Fortas insists on returning to his old law firm, of which he was one of three founders 23 years ago, it will be over the opposition of an overwhelming majority of its partners and associates.

That was made starkly clear at an unusual showdown on the matter.

Only three senior partners voted in favor of Fortas' rejoining the firm.

Following is the inside story: Accounts differ on who proposed that Fortas resume connection with the firm. According to one version, he initiated the move. Another, it was made by his close friend and fellow founder Paul Porter, New Deal chairman of the Federal Communications Commission.

Porter is credited as being very eager to have Fortas back. But in sounding out firm members, Porter, to his dismay, discovered considerable objection. After talking it over with senior partners, decision was reached to hold a meeting of the entire firm.

The discussion was thorough and frank. Porter and Thurman Arnold, the third founder and top partner, vigorously urged that Fortas be asked to return.

Arnold, crusading head of the Anti-Trust Division and a federal judge in the Roosevelt Administration, particularly lauded Fortas' "idealism" and legal efforts in behalf of civil rights.

Both Porter and Arnold contended the firm owed it to Fortas to invite him back.

But younger partners and associates didn't see it that way. Without directly chiding or criticizing Fortas, they made it very clear they felt the firm could best do without him.

Some voiced surprise that Fortas would want to resume the practice of law. They implied he would be better advised to occupy himself with writing or teaching.

Carolyn Agger (Mrs. Fortas) attended the meeting, but said nothing. She is sixth-ranking partner and head of the firm's tax division, with a number of lawyers and accountants working directly under her. Among attorneys, her income is reported to be in excess of \$100,000 a year.

The vote produced the following results:
For Fortas' return — Arnold, Porter and William McGovern, fifth-ranking partner.
Against — 34 other partners and associates.

Not voting — Miss Agger and Norman Diamond, fourth-ranking partner.

Since this meeting, some firm members have hinted they will quit if Fortas disregards this overwhelming rejection and does come back. One promising young attorney slated to join the Arnold, Porter "shop" changed his mind and accepted another offer.

Rep. Clark MacGregor, R-Minn., who spearheaded the House drive that led to the resignation of Justice Abe Fortas, is proposing that to committee chairman Emanuel Celler, D-N.Y. MacGregor is sponsoring a bill imposing stringent limitations on the outside activities and income of federal judges and wants Douglas interrogated in connection with this legislation.

Celler is cautiously not committing himself on MacGregor's extraordinary proposal.

The long-time Judiciary chairman says he wants to see what the Judicial Conference headed by Chief Justice Warren does about formulating a code of ethics for federal judges. Also the report of the Ethics Committee of the American Bar Association which is considering the charges and complaints against Douglas.

"This is an extremely serious matter," said Celler, "and I do not intend to shoot from the hip. Whatever is done must be done deliberately and objectively. At the proper time, the committee will consider all the proposals before it and act accordingly."

MacGregor, who has been highly critical of Douglas, asserts he is not going to let the matter lag.

"Congress has a direct and pressing responsibility in this affair," declared the forceful Minnesotan, "and I am going to do my utmost to get action. I shall press for that vigorously in committee and on the floor of the House, if that is necessary."

In letters to Chief Justice Warren and William Gossett, president of the American Bar Association, MacGregor raises a number of questions regarding the adequacy of the Canons of Judicial Ethics adopted by the ABA in 1924. Wrote MacGregor: "In your judgment, are these standards of conduct, adopted some 45 years ago, sufficiently precise and adequate in scope to effectively deal with the problems of today. What investigatory and disciplinary authority exists within the Judicial Conference of the United States or the American Bar Association to determine if federal judges are in violation of the Canons and to require adherence to their provisions?"

"On the basis of information which I have, I feel most strongly that the Canons of Judicial Ethics are imprecise and inadequate, and that the machinery to ensure compliance with these standards of conduct is ineffective. Should you agree with me in whole or in part, I would welcome your suggestions as to how these matters might be remedied."

The ABA Ethics Committee has been urged by Rep. Paul Rogers, D-Fla., to make public its report on Justice Douglas when completed.

In a letter to members of the Ethics Committee, Rogers states, "It would appear that Justice Fortas, and I believe the American people have a right to know the findings of the Ethics Committee of the American Bar Association."

The Doctor Says:

A mother writes that about three years ago she took her son, then 12, for his regular tetanus injection. He had a severe reaction and since then she has taken him to a skin specialist who gives him two small tetanus injections two or three hours apart. These are painful and the boy dreads to take them. This mother wonders whether he can be tested to see if he is still allergic to tetanus shots and whether he is likely to be allergic to other immunizing injections.

Because of the increasing number of reported reactions to tetanus toxoid boosters, authorities now recommend a booster not oftener than once every 10 years. This has been shown to maintain an adequate level of immunity. When a person has shown a sensitivity to this toxoid he should be tested with a minute dose of highly diluted material before the booster dose is given.

A person who is allergic to one immunizing agent is not likely to be allergic to another. A person who is allergic to horse serum, however, cannot

take an antitoxin derived from horses and one who is allergic to eggs cannot take a vaccine from chick embryos.

Q — Is giving an infant an immunizing injection against two or more diseases at once as effective as giving them separately? What shots should a baby have and at what age?

A — The combined diphtheria-tetanus and whooping cough vaccine is just as effective as the three taken separately and has the advantage that it avoids making the baby a human pin cushion. A 5-in-1 vaccine that also contains polio and measles vaccine is being tried out and may be available soon.

It is now customary to give the first dose of the 3-in-1 vaccine and the oral polio vaccine at two months of age. At four months the second dose of both is given. At one year, smallpox and measles vaccines are given. This completes the basic immunization program. Smallpox revaccination should be given every three to five years.


