





BERLENBACH TO FACE STRIBLING IN N. Y. TONIGHT

CHAMPION WILL RECEIVE ACID TEST IN LONG FISTIC BATTLE

(By the Associated Press) NEW YORK, June 10. (AP)—Paul Berlenbach will have an advantage of 3 1/2 pounds tonight when he defends his world's light heavyweight championship against Young Stribling of Georgia in a 15-round match at Yankee Stadium.

NEW YORK, June 10.—Paul Berlenbach, the fighting champion, takes his light heavyweight crown across the water tonight when he faces Billy (Young) Stribling of Atlanta in a 15-round battle at the Yankee stadium tonight.

But Berlenbach never has gone to the dugouts with his title, since winning it from Mike McTigue at that same stadium a year ago, and against the men against whom he has defended it successfully in Jack Delaney of Bridgeport, Conn., considered by many the "uncrowned champion" of more than one division.

Delaney Bout Real Test That bout with Delaney was an acid test, for previously Berlenbach had gone to the canvas for the full count from a scorching punch delivered by that same opponent. Again in that second meeting came the terrific shot, the driving right of the Canadian, and again Berlenbach went down. But it was not as before, for the champion gained his feet and fought desperately to win.

Critics believe that Berlenbach will have the advantage if he shows that aggressiveness that made him famous, a continuous drive with both hands, with an outstanding power in his left.

Stribling Real Fighter But he will find Stribling hard to hit and at the same time hard to avoid, for Paul is not the fastest man in the ring.

Stribling is the younger man by three years and has gained most of his experience in battle. He possesses two good hands, with the right most effective, but he never has considered an aggressive ring man. Tonight, perhaps, with a championship at stake, that aggressiveness, in the form of unrelenting attack, has been awarded many a victory in New York State.

The Atlantan is growing and feels that soon he will come face to face with the champion of all the heavyweights, probably Dempsey. He has asserted that he expects to knock out Berlenbach, and there are many to side with him, although the champion is likely to carry slight odds to the ring side.

Two great champions—Harry Greb of the middleweights and Mickey Walker of the welterweights—have gone down this year, and it may be Berlenbach's turn.

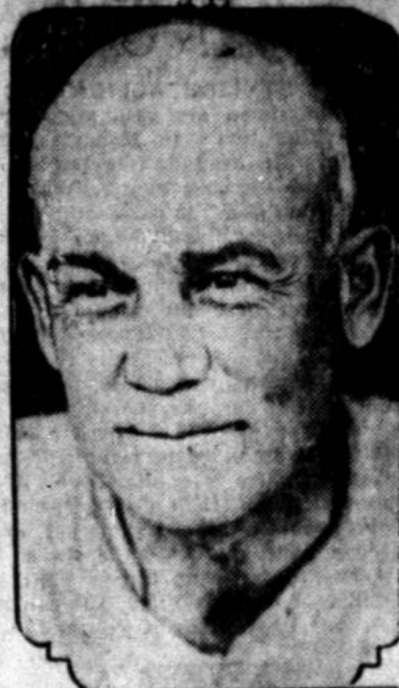

BRAVES WIN 7TH IN ROW AND YANKS INCREASE AMERICAN LEAD

(By the Associated Press) Today the world champions of baseball once again met their league with an uprising. The Reds of Cincinnati suppressed.

But it was not a pirate horde that put down the revolt, but a brave band of armoured men from Boston, considered fighting men of calibre heretofore, yet not quite capable of carrying forth squabbles in the first division of the National League.

Seven straight battles have gone to the Braves and they have not hesitated to toll from the best opponents available.

The Pirates took the lead by downing the Philadelphia team yesterday, to 7, in ten innings. Third baseman Huber of the Pirates, made it hard for the champions by hitting a homer to tie the score in the ninth, but Cuyler singled with the bases filled in the following frame to gain the decision. Meanwhile, Brooklyn accomplished the rest by taking a ten-inning struggle from Cincinnati in which Dozy Vance recorded fourteen strike-outs, only one away from his record for nine innings. At that, Vance did not receive credit for the victory for he gave way to a pinch hitter in the ninth.

Bill Sherdel is Right Bill Sherdel of the Cardinals left-handed a six hit effort against the Giants and won, 4 to 2. St. Louis having little difficulty in solving the service of the veteran Jimmy Ring.

The Braves made the Cubs their seventh straight victims, 6 to 3, sending across four runs in the opening inning to give Joe Genevick courage.

Once more the Yankees fell upon the Tigers when all seemed lost and won, 4 to 2, giving them a lead of 8 1/2 games in the American League because Chicago downed Philadelphia for the second time, 4 to 1. The White Sox won by linking their bingles with misplays by the Athletics and giving Thomas brilliant support throughout.

Miller of Cleveland allowed Washington 14 hits, but won, 11 to 5. The Browns took their second straight from the Red Sox, 5 to 4, making ten victories out of fourteen starts since they returned home.

CURL LEITCH Care For Socklets

Looking up is often the cause of that terrible complaint called socklets. The very word is hideous, but it is nothing compared to the results of the disease. I can truthfully say that I very seldom fall a victim to this complaint, but I have socketed quite enough shots to be able to realize the agonies one can suffer when in its grip. There is no bad shot in golf which flurries a player so much as a shot off the socket and this accounts for the repetition of the mistake.

The more socketed shots I see played, the more I am convinced that the cause is to be found in the arm action.

The club is taken back in a hurried manner, and on the forward swing the player throws out her arms, with the result that the club-head is thrust too far out at the moment it meets the ball.

The player who is suffering an attack should go to a quiet corner of the course and try the following cure: Put a handkerchief under the left arm-pit, take a firm stance with the weight well on the heels, keep the head still and the left arm close to the body throughout the shot. If the handkerchief remains in the position in which it was placed, it is almost impossible to socket.

SECRETS OF STARS on INSIDE BASEBALL as told by BILLY EVANS

Most catchers make the mistake of calling for too many waste balls. Often I feel that I am guilty of such a blunder, which, if overdone, has a tendency to upset the pitcher, particularly one not strong on control.

The strength of a catcher's arm must be considered in the calling for waste balls. The receiver with a strong arm should not call for nearly as many pitchouts as the backstop with just a fair whip.

The waste ball often helps the catcher with just a fair arm by breaking up the hit-and-run play, also giving the catcher the edge on the runner because he receives the ball in such a position that little or no time is wasted in getting it away.

It is my observation that a lot of players never run bases unless sent down by the manager. Few try to steal on their own initiative. Base-runners like Ty Cobb and Max Carey are the exception. They run on their own judgment and put it entirely up to the catcher to stop 'em by making the better guess as to their intent.

A great many managers have a set sign for a steal. If some players on your side get it, the rest is easy. A great many players tip their intentions.

Notification Received. PARIS, June 9.—War Minister Painleve upon the recommendation of American ambassador Herriot that, if a sentence of death has already been passed upon Bennett J. Doty of Memphis, member of the French Foreign Legion in Syria, it shall not be carried out until all the papers in the case have been referred to Paris.

Will Straighten Out Case. The foreign office assured the ambassador it would do all possible to straighten out the case, in which Doty, who enlisted under the name Gilbert Clare, is charged with desertion from the foreign legion and rebellion.

The opening was steady at a decline of one to five points, and more active positions soon sold off about four to six points. July declined to 18.24c and December to 17.17c. There was further evening up of the October contracts, but demand seemed to be readily supplied at a premium of 100 points over October and 104 points over December. The maintenance of this near month premium helped to steady the undertone of the market, but prices were within a point or two of the lowest at the end of the first hour.

Offering increased following reports of beneficial showers in Georgia and the mid-afternoon market was easier, under liquidation, Southern and local selling. At 2 o'clock July was selling around 18.16c and October 17.01c, net declines of 14 to 26 points on active months.

A more optimistic view of coming crop prospects probably found encouragement in reports of comparatively light emergence of boll weevil to June 1, and prices worked off to 18.25c for July and 15.14c for December. The market was within a point or two of these figures at mid-day or about 8 to 10 points net lower.
