AUDIT SHOWS HIGHWAY FUND SHORTAGE

FUNDS TO MEET VOUCHERS SAID NOT AVAILABLE

"INVISIBLE HIGHWAY" IN BELL COUNTY COSTS \$200,000 CHARGE

(By The Associated Press)
AUSTIN, Texas, Nov. 11.—Outstanding liabilities of the state highway department as of October 31 aggregated \$4,745,004.24, while on the same date cash to the credit of the department in the state treasury amounted to \$97,909.21. This report was made Thursday to the house investigation committee by L. P. Echols of the Houston branch of Ernest and Ernest, who audited the highway's books.

Placed in Record
Representative John Wallace of Freestone county, committee secretary, said Echols' report would be placed in the committee's record.

"One feature of the audit is the fact that the department has unpaid vouchers on file for \$451,469.77, and doesn't have the money to pay them," Secretary Wallace said.

"Invisible Highway"
AUSTIN, Texas, Nov. 11 (AP)—Tom Beila, a Bohemian farmer in Bell county, built several bridges on the east end of the experimental Bell county road under the supervision of S. B. Moore, engineer of Temple, and Fred Ferguson, county of former Governor James E. Ferguson, furnished some of the gravel and sand for the construction of the "invisible highway," R. T. Smith of Temple, superintendent of construction, told the house investigating committee Thursday.

Cost Over \$200,000
He estimated that it would cost about \$7,000 to complete the end of the 21 miles of experimental roads. The east end is between Belton and Temple. He was informed that the road has already cost the state more than \$200,000.

Bolts was paid \$6 a yard for labor on the concrete work and claims to have lost money, Smith said, on two bridges and some culverts. The state furnished the material.

Overpaid For Sand
Fred Ferguson was paid \$1.00 a cubic yard for concrete gravel and for screened sand, but now sand is being brought at \$1 a yard and gravel is being brought at \$1.40 a yard at the pit with the state still doing the hauling, Smith explained.

F. C. Fenison of Temple has the contract at cost plus ten per cent and S. B. Moore, the owner of the patent rights of the "invisible" road, is the engineer and is being paid \$375 a month and has an expense account. Smith said, Moore rented the home of Roy L. Tennant, member of the state board of control and Judge Richard C. Criss asked Smith if the state was paying the rent. Smith replied that Moore had an expense account.

Fred Ferguson has stopped selling gravel for the job, but is furnishing some sand in the road, Smith said.

Smith said the runners on the five mile stretch on the invisible highway between Belton and Temple were, high class brick pavement and would last forty years, but that the crushed stone and asphalt paving between the runners would have to be replaced and repaired.

The Rev. J. J. Stevens, a Simmons minister, testified in a similar vein.

FAMILY POISONED AT BALLINGER

BALLINGER, Nov. 11 (AP)—Mystery revolving about the poisoning of eight members of the W. M. Ashton family at their farm home near here probably will be taken before the Runnels county grand jury. District Attorney Walter Early of Brownwood said today.

Early and other officers investigating the case indicated that an arsenic poisoning of the family still are in serious condition.

A physician's analysis of flour used in breakfast biscuits showed liberal quantities of arsenic, as also did the biscuits, officials said. The family died after breakfast, and it is believed that the poison was placed in the flour sack the night before.

J. J. Ashton, 55, father of W. M. Ashton, who was the most critical condition, it was reported today. The latter's wife and two of the girls, Elma, 20, and Mary, 16, are the other victims. Three boys of the family recovered.

COOLIDGE SAYS PROBLEMS MUST BE MET FAIRLY

AMERICA IS RESPONSIBLE FOR OWN SENTIMENTS, HE SAYS OF REPORTS

LIBERTY MEMORIAL, KANSAS CITY, Mo., Nov. 11 (AP)—Facing 150,000 persons, lined on an avenue of flags at the liberty memorial here today, President Coolidge was cheered and applauded when he declared that the United States would adhere to the world court only on the conditions laid down by the senate.

Standing bareheaded and without an overcoat the president gave his message.

Views Colorful Scene
A colorful scene spread out before him. Down the Hall at the front of the memorial a great crowd listened attentively. Flags stood stiff in the brisk breeze which chilled the spectators and hundreds of army and naval uniforms lent a martial air to the occasion.

As a giant bell in the memorial shaft tolled eleven times at 11 o'clock calling the nation to silence in memory of the Armistice, President Coolidge walked to the front of the presidential stand. He began his speech and gradually worked up to the climax where he declared his position on the world court. His audience caught the significance of his words and a thousand "hurrahs" rang out.

Blue Over Blindness Man Takes Own Life

BROWNVILLE, Nov. 11 (AP)—"I cannot see I do not want to live," was the remark of Pablo Portales, 79 years old, who lived on the Carmen ranch near Brownsville. A few minutes later the family heard the report of a pistol, and found the man lying on his bed with a bullet hole through his temple and a smoking pistol at his side.

Portales was stricken with blindness several years ago, and recently had been very despondent, stating frequently that without sight there was little to live for.

GIANT PARADE FEATURES FULL DAY'S PROGRAM

EX-SERVICE MEN JOIN IN UNIQUE PROGRAM THAT FEATURES "OLD DAYS"

(By The Associated Press)
WASHINGTON, Nov. 11 (AP)—Minority stockholders, who have attacked more than one plan of railroad consolidation, today entered into the situation surrounding the proposed merger of southwestern railroads.

Walter E. Meyer, a director of the St. Louis-Southwestern, declaring he represented 14,000 shares of minority stock in the company, appeared before the interstate commerce commission and attacked the plan of the Kansas City Southern to take over the Missouri-Kansas-Texas, while that road in turn would take over the St. Louis-Southwestern. He said the project was neither in the interests of the public nor the owners of stock.

Competitive Roads
"The St. Louis-Southwestern and M-K-T are highly competitive roads as to traffic moving between St. Louis and Northern and Central Texas," Meyer declared. "To group them together will eliminate competition and will disrupt existing routes and channels of trade and commerce and will result in the diversion of the M-K-T of traffic from the Cotton Belt."

"There appears to be even less justification for grouping the St. Louis-Southwestern with the Kansas City Southern. The two roads cannot be effectively combined so as to promote efficiency and better service to the public."

"I am also opposed to the granting of the application because it will confirm the present control which has been exercised in the interest of the majority and in utter disregard of the interests of the minority stock holders of the St. Louis-Southwestern. The purchase of 100,000 shares of Katy stock at an average price of \$44.83 per share is an example of exercise of minority control to the detriment of the majority. The price paid by the St. Louis-Southwestern was close to the highest price that stock has reached during the past two years and ten months. Other examples of the disregard for the rights of minority stockholders are not lacking. The fact that the St. Louis-Southwestern was the owner of 100,000 shares of Katy stock was disclosed to me until September 29, 1926. No record of the transaction appeared in the monthly balance sheet furnished the directors other than an entry of funds in suspense accounts."

The classes will be free of any charge and from present indications, there will be a great number of local women as well as many from surrounding territory, attending the school.

All women interested in the subject of home-making are invited by the Avalanche-Journal to attend the classes and are requested to bring note books and pencils to write down the various directions and recipes that will be given by Mrs. Chitwood.

REVIVAL OF THE AGE-OLD PROBLEM—WHERE TO LIVE

Have you heard this one? Is it better to live in the country or in the city?

I thought it was all settled long ago, until I received a letter from a debating society last week asking my opinion. It always was a hard one, but now it's a harder one. If you live in the country you can step on the gas and be in the city. If you live in the city you can join the Sunday parade on Gasoline Way and be

in the country in a few minutes.

It isn't like it used to be in the days of the Caesars when the whole countryside moved to the City of Rome about three millions of them. I believe the figures are, and left the country and the wheat-growing to take care of itself. That is why the Roman Empire "busted up," as Tom Sawyer said. Fortunately in America some are "fortified" the country and some are "fortified" the city, which keeps a nice balance of production. That is as it should be if a nation wishes to be a top-notch power on this terrestrial globe.

The city and the country augment each other, naturally. But as for individual advantages of living in either locality, let us consider.

People in cities are close to the sources of culture. They have easy access to libraries of exhaustive information, art galleries, the best music, drama, film theater, not to mention the fact that it is more wonderful than ever if one chooses the right things and opportunities for every sort of self-improvement.

But after all, city dwellers live a more or less artificial life. Culture in spite of its uplifting influence, is only life by proxy, predigested life in a way, presented to us after being manipulated to suit the taste and ideas of another. And stores, offices, high buildings, steam-heated apartments, movies, how far removed from nature are they also.

It is one thing to look at a picture of a field of sheep—another to see a field of sheep, and still another to care for those sheep. It takes nature to teach us life, and true values of living lie behind all culture.

Country people live close to nature and now have easy access to the advantages of the city. City people are answering more and more the call of the country. Who can decide it?

I heard a publicist say one time, "Live provincially, but keep a cosmopolitan mind." That strikes me as a nice balance.

tion began near the city hall and the body marched south to Broadway thence westward to the Tech College campus. It can not be said just how many individuals took part, but as the last cars turned the corner at Avenue I and Main, the leaders were crossing Avenue U some 12 blocks away.

Tech Band Leads The Tech band in American flag formation headed the parade, but were closely followed by Tech girls in United States formation. George Burns of Cleveland, the most valuable man in his club in the 1926 race, is far from being a youngster. Burns finished his thirteenth season in the big test when he learned he had received his diploma.

Ty Cobb, with something like 20 years of active campaigning to his credit, is another American league winner of the most valuable trophy. Jot down the ancient names of Roger Peckinpaugh, Walter Johnson and Eddie Collins and you have three more veteran stars who have captured the diploma.

Babe Ruth and George Sisler of the Yankees and Browns, are the youngest American league players to be so honored and neither can be called youngsters. Ruth is a veteran campaigner while Sisler has spent over 10 years in the big show.

A youngster may flash through the sky like a meteor in flight in the world series but it's the veteran player who is declared the most valuable man in his club in the season's run.

Curiously enough, all departments of a ball club have won the American league's most valuable player award save the catching department.

Walter Johnson is the only pitcher so far to take the laurels. Peckinpaugh, Sisler, Collins and Burns are infielders while Ruth, Cobb and Speaker represent the outfield patrol.

Ray Schalk, brilliant White Sox catcher, passed the zenith of his flaming career behind the plate before the most valuable player award was born, costing him a great opportunity to gain the fame of such an appointment.

'Sure Hit' Jumps
Into Fielders' Hand
HOUSTON, Texas, Nov. 11. (AP)—Homer Peel, left fielder for Houston in 1926, who is slated to see service with the St. Louis Cardinals in 1927, remembers the time during the 1925 season when he was robbed of an apparently sure hit by Gonzales, second baseman for San Antonio, during a game at San Antonio.

"I had hit a ground ball toward right field, and it seemed I certainly had a single," he recounted. "It was headed about the middle of the area between second and first base. Gonzales made a dash for the ball, but realizing it was seemingly impossible to stop it, looked toward right field to see if the right fielder would be able to stop it. His hand was still outstretched.

"Would you believe it, the ball took a crazy jump and hopped into Gonzales' glove, enabling him to throw me out at first base."

Ball Player Glad He Missed Hit For Lives Endangered

BEAUMONT, Texas, Nov. 11. (AP)—Bernie Devivores, Beaumont shortstop for several seasons, who will try out next spring with the Detroit Tigers, is glad that at one time at bat he failed to get a hit, for, if he had hit safely, he might have caused indirectly the death of a number of Dallas fans.

In the ninth inning of a game at the old Dallas baseball park in 1924, the Steers were leading 2-0, when Beaumont came to bat. The Exporters got a man on first and second with one out. Beaumont, next man up, went out, advancing the runners. As Devivores came to bat, after having made three hits in his previous appearances that day, and a homer the day before, some of the crowd yelled for him to hit another home run. But he swung at the first ball pitched, hitting a high fly to Beaumont at second base, and the game ended.

The fans departed, and 13 minutes after the stands were cleared, according to the fire department records, the whole park burst into flames. The players still were in the clubhouse and had to flee virtually naked. "If I had got a hit, the score would have been tied and the game likely would have gone on for several minutes and probably wouldn't have been over when the fire, which had been smoldering for some time under the grandstand, broke out," Devivores said.

"There were 6,000 fans at the game and there was only one exit, so some of the spectators undoubtedly would have been trampled or burned to death. "Bernsen and I shook hands that night and said we were thankful neither of us had got a hit in the ninth inning."

Unique Incident On Diamond Is Recalled

SAN ANTONIO, Texas, Nov. 11. (AP)—Fred Merkle, famous for his failure to touch second base on a certain occasion, hit a home run for Rochester in the International League with two men on base, during the 1924 season, but did not get credit for the blow.

Mike Gonzales, San Antonio infielder of 1925, told the incident in this way: "We were playing Reading and Griffith was on second and I was on third with two out and Merkle next at bat. I hit a home run over the fence. This should have won the game, as Rochester was two runs behind when Merkle came to the plate.

"But Griffith came tearing to third from second. As it looked as if the ball would drop inside the park and be caught instead of going over the fence, I held third until I was sure, but Griffith hadn't waited, and he passed me at third. As there were two down already, Griffith was the third out and the home run didn't count."

PRINCETON AND HARVARD BREAK ATHLETIC TIES

LAMPOON'S TART JIBES
SAID DIRECT CAUSE
OF SEVERANCE

(By the Associated Press)

PRINCETON, N. J., Nov. 11.—One link of the big three chain, strained to breaking point by the jibes of a Harvard humorous publication, has finally snapped and carried away with it the most colorful and ancient rivalry of the American college sport world.

Dr. Charles W. Kennedy, chairman of the board of athletic control at Princeton university announces that all athletic relations with Harvard have been broken. Resolutions adopted by the board and set to Harvard authorities say that "Princeton should never accept the implications of the athletic policy recently adopted by the Harvard committee on regulation of athletic sports set forth in their resolution of October 14."

Resolution's Nature Unknown

The nature of the Harvard resolution was somewhat of a mystery when the break was announced last night. The resolution was received at Princeton only yesterday. It is understood it provided for Harvard-Yale games every year and contests with others only "intermittently," but both Harvard and Princeton declined to say what the resolution was.

Harvard planned to drop Princeton next year in football in order to play Michigan but after a peace meeting at Yale last month it was announced relations were friendly and the an-

nual football games would continue. Then came the Harvard-Princeton game last Saturday. Harvard rooters booed Princeton when Harvard players were hurt by hard tackles.

Fight With Police

Princeton rooters had a fight with Boston policemen in the Harvard stadium. The police failed to prevent the goal posts being torn down in Princeton's celebration of its victory, and what was most serious, the Harvard Lampoon, sold to the football throngs, had tart jibes at Princeton.

Although the Lampoon apologized and authorities at the university joined in admitting the poor taste shown, the feelings of the students of the institutions flared into open hostility despite efforts of President Hibben of Princeton and the Crimson, a daily Harvard newspaper, to pour oil on the troubled waters.

The Lampoon said: "While it is customary at times of athletic lavation to extend the glad hand to the visitors, Lammy sees no reason to disguise the fact that brotherly love and friendly rivalry existing between Harvard and Princeton are purely imaginary." The magazine adds hints at loose morals and drinking proclivities at Princeton.

COUNTY GRAND JURY RECESSES

Thorough House-Cleaning Is Promised Before Body Is Finally Adjourned

The Lubbock county grand jury recessed for a midday adjournment Wednesday afternoon, but members of that body may be expected to again be at the post of duty when doors of the court room are thrown open in the morning.

As a rule a grand jury in this county remains in session from two to five days. A six day session is considered a lengthy one, but the present body will be in session for six weeks, and even then night sessions are necessary. Just what kind of investigations they are making is not known. Witnesses who are called before the body have an idea concerning some of the cases, but they are not at liberty to tell of conversations behind the doors in the grand jury room.

Judge Mulholland instructed members of the body to investigate law violations in this city and county, and they took him at his word. Scores—even hundreds of witnesses have been called up to testify, and some people, high in the grades of the "common run" have been forced to drag out the family skeleton and tell just why such a thing occurred.

Already the grand jury has shown that it was not only after the "small fry" but the higher-ups as well. Many indictments have been returned, and others are expected to follow. Lubbock is being given a general house-cleaning.

American Made Autos Popular In Mexico

LAREDO, Nov. 11 (AP)—American-made automobiles of all types and models continue to hold their popularity with the people of Mexico.

A monthly report issued by a local firm of customs brokers shows that in October 65 carloads of automobiles made in the United States were exported into Mexico through this place of entry. Planning seven automobiles to the carload, there were 453 automobiles shipped through here in October.

Automobile exports always show a large decline in the summer months, with Mexican buyers waiting for new models.

The shipments decrease in the fall, however, and it is expected that from nine to ten thousand automobiles of all makes and models will be shipped into Mexico in 1927 through Laredo.

Dice Collection Of A GENERAL ASSORTMENT Sheriff Is Imposing

COOLIDGE SAYS PROBLEMS MUST BE MET FAIRLY

(Continued from Page 1)

In the court, was made clear in an Armistice day speech in which he discussed world problems and called for action for the first time for conscription of capital as well as man power in time of war.

Dedicate Memorial
The address was in the dedication of the Liberty memorial, erected by the people of this city in memory of its citizens who served in the world war. Delivered at the hour when eight years ago the Armistice went into effect, it was devoted to a discussion of problems arising out of the war with a restatement of the position of the Washington government on many questions of world interest while mention was made of national antagonisms against this country.

"A permanent court of international justice has been established," the president said setting forth his position on the world court, "to which nations may voluntarily resort for an adjudication of their differences. It has been subject to much misrepresentation, which has resulted in much misconception of its principles and objects among our people. I have advocated adherence to such a court by

this nation on condition that the status of treaty creating it be amended to meet our views. The senate had adopted a resolution for that purpose.

Went Ask Modification

While the nations involved can not yet be said to have made a final decision, and from most of them no answer has been received many of them have indicated that they are unwilling to concur in the conditions adopted by the resolution of the senate. While no final decision can be made by our government until final answers are received we have sufficiently developed so that I feel warranted in saying that I do not intend to ask the senate to modify its position. I do not believe the senate will take favorable action on such proposals and unless the requirements of the senate resolution are met by the other interested nations I can see no prospect of this country adhering to the court.

In speaking of conscription, Mr. Coolidge said that it is more and more becoming the conviction of students of adequate defense that in time of national peril the government should be clothed with authority to call into its service all of its man power and all of its property under such terms and conditions that it may completely avoid making a sacrifice of one and a profiteer of another.

"To expose some men to the perils of the battle field while others are left to reap large gains from the distress of their country is not in harmony with our ideal of equality," he said. "Any future policy of conscription should deal inclusively applicable in its terms to the entire personnel and the entire wealth of the whole nation."

After asserting that the armistice in

1918 "did not mark the end of the war, for the end is not yet," Mr. Coolidge declared for adequate military, naval and aviation preparedness while he emphasized that the United States does not seek to be a military power and "cherishes no imperialistic designs."

At the same time, he referred to the desire of the Washington government for a lessening of competitive armaments.

Enter Treaties With Powers
"We have at last entered into treaties with the great powers," he said, "eliminating to a large degree competition in naval armaments. We are engaged in negotiations to broaden and extend this humane and enlightened policy and are willing to make reasonable sacrifices to secure its further adoption."

In mentioning the war debts owed the United States by foreign countries and their adjustment, Mr. Coolidge again emphasized that "moderation is a mutual international obligation."

"Our government," he said, in this connection, "has steadily maintained the policy of the recognition and sanctity of national obligations and the performance of international covenants. It has not believed that the world, economically, financially, or morally, could rest upon any other secure foundation. But such a policy does not include extortion or oppression. We have therefore undertaken to deal with other countries in accordance with these principles, believing that their application is for the welfare of the world and the advancement of civilization."

Wants America in Right

Reports that Europe dislikes America were met by the president with the statement that he wanted to be sure that the attitude and acts of Amer-

ican government are right and that he is "willing to intrust others' responsibility for the results of their own behavior."

"If we are to have peace," he asserted, "we are to live in accordance with the dictates of a higher life. We shall avoid all international spirit of suspicion, distrust and hatred toward other nations. The old world generations indulged itself in this form of lust. The results have been ruinous. It is not for us who are more fortunately circumstanced to pass judgment upon those who are less favored. In their place we might have done worse. But it is our duty to be warned by their example and to take full advantage of our own position. We want understanding, good will and friendly relations between ourselves and all other people. The first requisite for this purpose is a friendly attitude on our own part. They tell us that we are not liked in Europe. Such reports are undoubtedly exaggerated and can be given altogether too much importance. We are a creditor nation. We are more prosperous than some others. This means that our interests have come within the European circle where distrust and suspicion, if nothing more, have been altogether too common. To turn such attention to us indicates at least that we are not ignored."

Responsible for Sentiments
"While we can assume no responsibility for the opinions of others we are responsible for our own sentiments. We ought to be wise enough to know that in the past and informed thought of other countries, we probably held the place of a favored nation. We ought not to fail to appreciate the trials and difficulties, the suffering and the sacrifices of the people of our sister nations, and to extend to them at all times our patience, our sympathy, and such help as we believe will enable them to be restored to a sound and prosperous condition."

There was little need to inquire how the world was began, Mr. Coolidge said in discussing the conflict. "Nothing is to be gained from recriminations and recriminations," he declared. "We are at a tempting to restore the world to a state of better understanding. We can even leave to others the discussion of who won the war. It is enough for us to know that the side on which we fought was victorious."

**Origin Of False
Fire Alarm Here
Today Is Sought**

A false fire alarm—one that endangered the lives of several thousand Armistice day paraders in Lubbock, was turned in shortly before 10 o'clock this morning, and was answered by the fire department. Officers are now trying to apprehend the guilty party or parties responsible for the act.

The alarm was turned in over telephone No. 1462 which is in the office of the Ellis Martin Cotton company on 18th street, though the fire department was instructed to go to 1308 Avenue G, some eight blocks southwest. At the time the alarm was turned in both of the large fire trucks were in the west end of the city where the Armistice parade had just broken. The call was answered, however.

Owners of phone No. 1462 told officers they knew nothing of the alarm, and that if it was turned in over their phone it was done by outside parties unknown to them.

Two officers have been detailed to clear up the case, and they will exert every energy to do so. At the time of alarm there were several thousand people on the streets of Lubbock, and in the part the fire trucks should have followed to the "fire," and it would have been impossible for firemen to have made any speed without disaster to the paraders.

Officers have a clue and they will not stop until the guilty are brought to justice.

**Lockhart Wins First
Race On A. A. A. Card
SPEEDWAY, CHARLOTTE, N. C., Nov. 11 (AP)—Frank Lockhart won the first 25-mile race in the American automobile sprint race championship here this evening. Bonnie Hill was second.**

Lockhart broke a world's record in winning the race at a rate of 123.3 miles an hour. The previous record of 120.39 miles an hour was held by Leon Duray.

Frank Elliott finished third, and Doctor William B. Shattuck fourth.

NEGROES SLAIN AT RANCH HOME

**House Riddled With Bullets
And Fired; Two Charred
Bodies Found**

(By The Associated Press)

HOUSTON, Texas, Nov. 11.—Seven unmasked men, at least one of them white, shot and killed three negroes and burned the bodies of two of them in their cabin at the Bassett Blakely ranch near the Harris and Fort Bend county lines Wednesday night, according to a report to Sheriff T. H. Blinford's office here Thursday.

First reports to the sheriff's office were that four negroes had been slain and their bodies incinerated. Investigation showed, the sheriff said, that one of the occupants of the cabin had escaped. The scene of the murders is 26 miles from Houston.

One Arrest Imminent
Arrest of at least one white man is imminent, the sheriff announced.

According to the sheriff's deputies, a number of men in cowboy garb, surrounded the cabin of Scott Evans, 26, negro, for 20 years foreman of the Blakely ranch. The structure was about a mile and a half from the main ranch building. In response to their call, Evans came out of the house and was shot. His body was found near a rear gate with his head split open.

In response to other calls, Broder Holmes, negro cook for Evans, appeared. He was told to leave and was unharmed. Robert Brown, negro cowboy, and his wife Sylvia, elected to stay in the house, which was riddled with bullets and set on fire. Their charred bodies were found in the ruins.

No white people were on the ranch at the time of the tragedy, it indicated. Sheriff Blinford said that the raiding party might have come from Harris county.

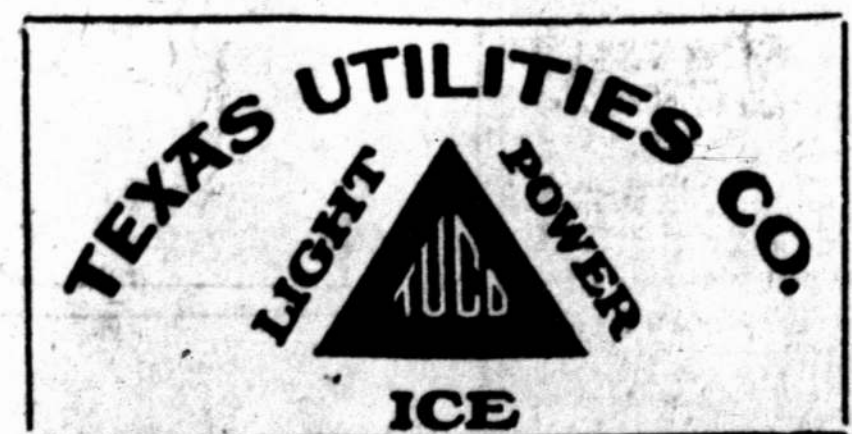

Editorials

ARMISTICE DAY

Eight years ago today was the first
Armistice Day. Guns which had been
spreading death and devastation for
four long years ceased firing, men
stopped their killing, the lust for
blood was abated and a weary
world turned slowly to its task of re-
building—a task which is not yet com-
plete.

As we look back over the years
which have followed the great war
the comfortable security of peace
looks more important, perhaps, than
ever. The unconscious of that awful
struggle of nations is probably the
most strident note in the retro-
spection. It serves to make us re-
member that which we forgot between
the years of 1776 and 1812; 1812 and
1861; 1861 and 1898; 1898 and 1917.

America's record in war, as in
peace, is glorious yet it is a record
on which we can well afford to stand
unless we are faced with a greater
necessity than that of 1917, which
plunged us into a crater of blood and
called our manhood to arms over a
question which was not of our own
making.

Let us hope that our Armistice Day
celebrations and observances will be
confined in the future to that Armis-
tice which was signed in France in
1918. Let us fervently hope that it
will never again become our lot to
take up arms.

PRIDE IN OURSELVES

Invariable, as men banded together
do wholesale thinking, turning out
this wholesale thinking in the way of
"resolutions"—at conventions and
such—the brains of the individuals
shrink and dwindle away.

So says Dr. Charles Gray Shaw, pro-
fessor of philosophy at New York uni-
versity.

Whether the professor is right or
wrong, whether we agree or disagree,
a nice point would be the way of
man's reaction to this supposed art.
Would this individual man, whose
brain possibly is growing skinner and
skinner, rejoice in the increasing
strength of mankind as a whole, or
would he mourn the passing of his
own individual greatness?

The latter, of course. For without a
personal premium placed on self, call
it egotism, or call it what you will,
individuals never could have suc-
ceeded to the point where as units they
compose strong and powerful associa-
tions.

It is only pride in self that spurs the
race on, and if this pride is to be
annihilated, what lies ahead for any
of us?

EFFICIENCY, OR LAZINESS?

Emperor Augustus of Rome was a
lax fellow, say those who are ex-
cavating in the subterranean cellars
of Rome to restore her to imperial
grandeur.

They have discovered that the em-
peror, to save himself trouble in de-
scending from his home on the Pala-
tine to the temple of Vesta in the
Forum, where his duties as Pontiff
took him had a new temple built ad-
joining his home on the Palatine.

Washington, our own capital city,
is discussing a new group plan for
housing executive offices. They dis-
cuss enclosing the White House with
shadowing ranks of skyscrapers, tear-
ing down homes of sacred tradition
to make way for this new efficiency.

"The president should be near his
workers," they say.

President Coolidge is not lazy, we
know, but it is conceivable that some
of those who want to be close to him
are.

In other words, is this century
"efficiency" that would destroy
Washington's beauty the same old
betrayer of the Emperor Augustus,
under another name?

No, the battleship is not to be
abolished, but unless it becomes an
airplane carrier somebody is pretty
sure to "abolish" the battleship from
the air, in the event of war.—Lafay-
ette Journal and Courier.

men can possibly be produced.

Yet, somehow or other, those very
districts about which so much is said
and written continue year on year to
produce young athletes of high caliber.
An east side grammar school, fam-
ous for the number of tongues to be
heard within its walls, wins most of
the loving cups in athletics and
scholarships alike. Its track teams
win its baseball teams win, its de-
baters, orators, essayists win—and
yet it is in that section of the ghetto
where tenements pile one upon the
other in dirty monotony. And the
children who represent it come from
every kingdom upon the earth.

Going up a notch—the universities
within the city turn out football teams
which prove a match for the best of
the great open spaces. Did not
New York university recently van-
quish the worthy southerners from
Tulane?

Did not a New York girl swim the
channel? And another New Yorker,
the mother of two, repeat the deed?
And a third New Yorker make a most
valiant struggle?

I have often thought of these mat-
ters as I honeycombed the drab and
dirty streets of the east side.

I have noticed the streets and side-
walks, ankle-deep in debris from the
pushcarts. I have seen youngsters
running in the streets until midnight.

Walk through these highways on hot
days or cold, or at almost any hour
of the day or night and you can see
the sidewalks lined with baby car-
riages.

Often have I heard mothers gasp at
seeing an east side baby soundly
sleeping in its street crib on nights
that snapped with the chill of ap-
proaching winter.

This is no belt for hot-house plants.
The youngsters who survive have got
to be sturdy. They must have under-
gone a period of struggle that made
them proof against almost anything.

They can fight their way through
traffic and blizzards alike.

Also, in these tenement belts, the
social workers have been busy for
years. Clinics have sprung up in hos-
pitals and settlement houses. They
have learned cleanliness and hygiene.

Poverty has meant going without
fuel in winter and without ice in
summer. They have learned to stand
both the cold and the heat. They
have learned to accommodate them-
selves to inconveniences and to close
quarters.

Take a child from another section
of town and subject it to a few weeks
of this life and it would be ill or dead.

**HOME'S BEST, SAVE FOR SO-
LONS: CAMPAIGN OVER, THEY
FLOCK BACK TO CAPITAL**

WASHINGTON, Nov. 11.—With
election out of the way, Washington
will be filling up with national leg-
islators pretty fast. It always does
right after every election.

Congress doesn't meet for nearly a
month after any election date—it's a
little more than a month this year—
but there always is considerable pre-
liminary work to be done.

Besides, a great many congressmen
are very much infatuated with Wash-
ington.

Perhaps it isn't surprising that a
man from some jerkwater little town
in the sticks should prefer the capital.
Perish the thought that he should ad-
mit it to the home folks, but it's
noteworthy that he makes for here the
minute he's sure he's safely re-elected.

According to early arrivals it's been
an unusually grueling campaign for
an off presidential year, except in
parts of the country which always go
the same way, regardless of issues or
candidates or anything else.

The individuals who have been do-
ing the spellbinding are pretty well

personal contact with the electorate.

primaries. As an orator, politicians
don't consider him much of an asset,
anyway.

was on the job early and late. Mis-

begin to shape themselves for con-
gress. Committee meetings already
are beginning to be called.

ted to congress they must be appoint-

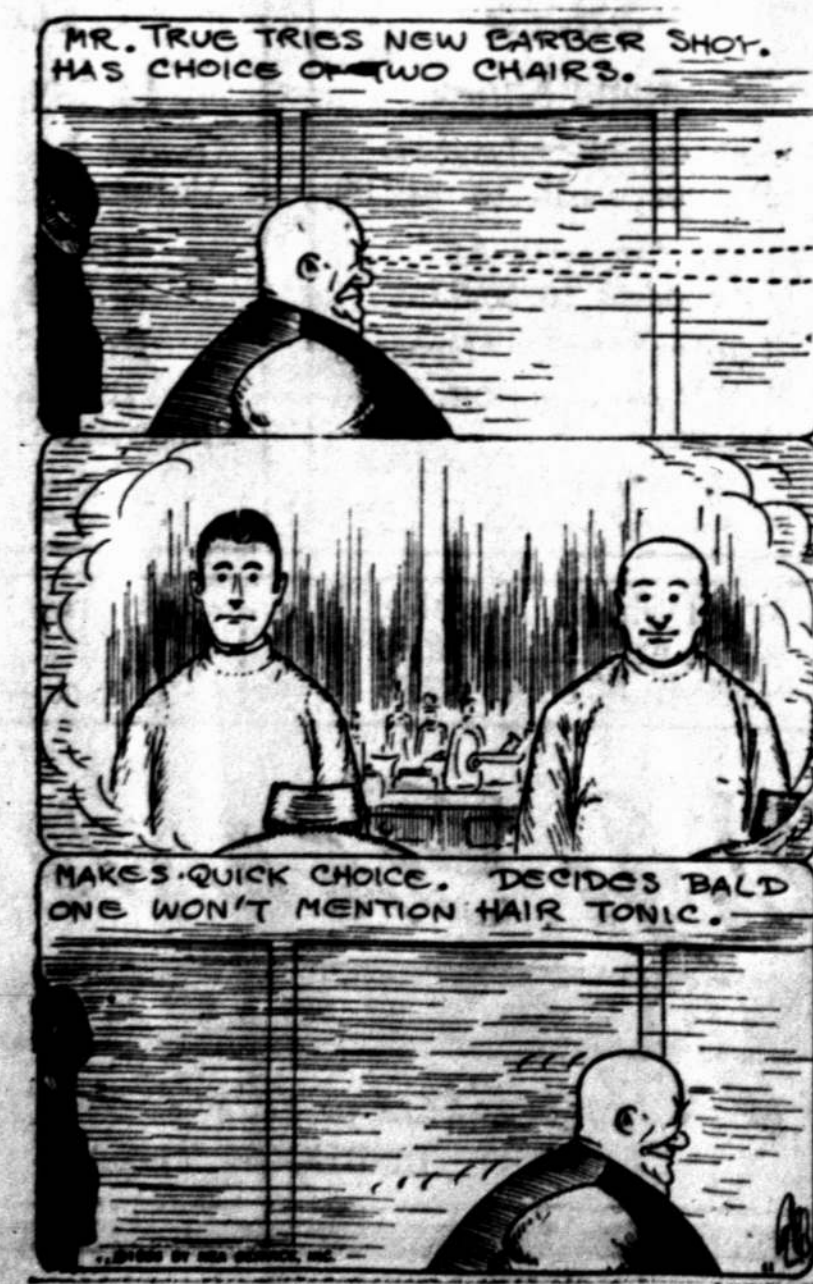

Wild Turkeys

When our forefathers first possessed
and settled our eastern country, they
found in the forests a large bird the
like of which they had never seen,
save perhaps as a rare exotic.

When the custom of giving thanks
for the harvest was inaugurated, the
finest and most delicious product of
the country was selected for the
Thanksgiving feast. The custom has
persisted, so that native Americans,
wherever situated, feel less homesick

if permitted to celebrate Thanksgiv-
ing with the traditional bird, Turkey
falling, they make the best of some
substitute.

Though the wild turkey was origi-
nally a common denizen of our east-
ern woodlands, the tame counterpart
of our barnyards is not its descend-
ant.

Gees Traveling

Long before our eastern seacoast
was settled, the Spaniards had found
in Mexico a southern race of the
same widespread species, and had
taken breeding stock to the old world.
There it prospered, and in due time
reached England. Being supposed to
be a product of Turkey it has ever
since remained.

Though readily distinguishable, the
two races freely intermingle when
chance brings them in contact, and
thus it comes about that many flocks
of tame turkeys, now ranging the for-
est bordered farms of our mountain
sections, show the markings of wings
and tail peculiar to our wild bird.

Toll of the Gunner

With the ruthless waterfowl which
has characterized our conquest of
the forests this beautiful and once
abundant bird.

Turkeys have been planted in cer-
tain areas, and have met with a mea-
sure of success, but the fruits of such
introductions are seldom equal in vi-
gor to the native stock, and rarely do
more than furnish to later gunners a
taste of sport, and then follow their
predecessors to oblivion.

Helpful Health Hints

TOLL OF REAPER TRAFFIC BECOMES TREMENDOUS

By DR. MORRIS FISHBEIN

Medical Association and of Hygiene,
the Health Magazine

Four-wheel brakes have perhaps
helped to lessen the severity of many
accidents, though they do not seem to
have greatly decreased their number.

A. A. Mowbray of the National
Safety Council has pointed out a per-
fect system of traffic signals, with
police officers at every busy corner,
which will do much for safety. But
these things have no advantage if an
automobile with a drunken driver
speeds through the warning signal
section.

2000 Hurt Daily
There is evidence that more than
2,000 persons are injured by auto-
mobiles every day in the United
States, and that at least one-third of
these are under 15 years of age. In
most instances, the pedestrian is in-
jured rather than the driver.

Statistics show that most of the
traffic accidents occur between 5 and
7 p. m., that more than half of them

take place at street corners, but that
more than 60 per cent of pedestrians
are injured while crossing in the
middle of the block.

The most dangerous driver is the
one who contests the right of way,
who tries to pass the street car on
the opposite track, who drives on the
wrong side and who disregards
safety zones.

Child and Adult

"The child who dashes out into the
street to recover some plaything, with
himself and then changes her mind,
the absent-minded citizen who reads
his paper in the middle of a busy
street are special types who con-
stantly tease the fool-killer.

Engineers who have studied this
problem have found that the most
important factors in preventing street
accidents are engineering revision of
streets, to make vision clear and room
sufficient; regulation of the traffic
and enforcement of the traffic laws,
so that both the motorist and the
pedestrian may know what to expect
when moving about, and education of
motorists and pedestrians to danger's
and how to avoid them.

SAYS HOGS ARE BOOTLEGGED

Rules Of Texas Commission
Flagrantly Violated, Is
Charge Of Officials

(By the Associated Press)

STAMFORD, Nov. 11.—"Bootlegging" in hogs is threatening to hamper development of hog raising in West Texas.

Word has come to the offices of the West Texas Chamber of Commerce here that rules promulgated by the Texas Livestock Sanitary Commission to regulate shipment of hogs into Texas are being flagrantly violated along the Oklahoma-Texas and New Mexico-Texas lines.

The alleged practice, according to the report, is to buy porkers in New Mexico and Oklahoma and ship them across the Texas line without dipping, vaccination, inspection, or the certification required by the Texas regulations.

One instance was cited of a shipment of 250 hogs to Mulchoe, Texas, in a short time 51 of the animals died of cholera, and the disease was transmitted to other hogs in the section. In another case, 15 out of a shipment of 250 hogs died of the same disease, which was spread throughout the neighborhood.

In neither case was vaccination or dipping done under the supervision of the veterinary department of the Livestock Sanitary Commission.

Homer D. Wade, manager of the West Texas Chamber of Commerce, has written commercial organizations along the state line urging that they resist such infractions of the regulations. He also has appealed to Federal and state authorities and, because there is a pressing need for more hogs in the state, he is appealing to commercial secretaries through out West Texas to lend full cooperation in fighting infractions of the rules.

The organization's interest is due to the work of the last two years in the hog importing campaign for West Texas.

"Special rules were promulgated by the Livestock Sanitary Commission at the request of our organization and if obeyed these would give full protection," Wade said.
