GRAND JURY GIVEN MULLEMAN'S CHARGEFALL TERM OF
COURT OPENED
THIS MORNINGHUBERT L. ALLEN CHOSEN
JURY FOREMAN; JUDGE
PLEADS FOR ACTION

Insisting that members of the grand jury were court officials and that the law enforcement program for Lubbock county is directly in their hands, District Judge Clark M. Mullican opened the regular fall term of court here this morning and, in his charge to the jury, urged members to do their duty, not only because they should but as a matter of protection to society.

Fifteen of the sixteen men cited to appear for grand jury service were present when the roll was called, and the missing member was excused by the judge who stated he was sure the man would have been present had it been possible. H. L. Allen, of Lubbock, was appointed by the court to serve as foreman.

Duty Is Stressed

The jury was informed that nine or more members constituted a quorum, but asked that as many of them as could be present for all investigations. "It is the duty of you, gentlemen, to investigate the commission of crime in Lubbock county," said Judge Mullican. "No other court in the world can try these cases other than Lubbock county courts, and your power as an inquisitorial body is almost unlimited. You have the right to send out for witnesses, and if they fail to answer tell me and I think we can arrange a place for them in the county jail until such a time when they will see fit to answer your questions." The jurors were told that they had no right to bring witnesses before them because of personal animosity, and they were told to allow others to pass because of love or friendship.

"Crime," said the judge, "is divided into two classes—felony and misdemeanor. Only felony cases may be punished with death or penitentiary sentences, and it is this class of crime you are to give your attention. Very often the grand jury is imposed upon by people who wish to settle family or community troubles. When you find a case of this kind pass it up for you do not have to give attention to these minor affairs."

Plans Are Explained

"You are to investigate all felony matters and you must do this if you do your duty as jurors. Burglary, swindling, robbery and bootlegging are all felonies." Under the head of swindling the court mentioned "cold checking," and insisted that it is up to the grand jury to see that the

VERNON, Texas, Oct. 18 (AP)—The body of Roy Barker, 21, Friendly, Okla., who had been missing since Tuesday night when he started to swim the North Fork of Red river near Tipton, was found by a searching party early Sunday morning near Hays, two miles south of the point where he entered the river. The body, badly decomposed, had been washed ashore. Burial was made at Altus Sunday evening.

Queen Marie Arrives For First
Glimpse Of America Amid CheersAnother Chicago
Gangster "Taken
For Ride" Sunday

(By Associated Press)

CHICAGO, Oct. 18.—Another man connected with Chicago's illicit liquor traffic has been "taken for a ride," and a new notch has been whittled on the city's most powerful bootlegger's hand.

At the very moment police were rounding up and questioning gangsters in connection with the recent slaying of "Hymie" Weiss, leader of the city's most powerful bootleg band, the body of a man identified as John Dano, a relatively unimportant figure in the "alibi" business, was found near the intersection of two main travel roads in Franklin park, a suburb.

No Immediate Evidence

Although the authorities were convinced Dano was a victim of a bootleg feud, there was no immediate evidence to connect his slaying with the machine gun killing of Weiss.

The latest murder had the customary setting of the gangster who had been taken for a ride. The man, with five bullet wounds, was tossed from an automobile, which apparently lost itself in the heavy traffic on Mannheim road, a short distance away.

Dano, the police were informed, was active in bootlegging under the Genna regime. When the power of the Genna brothers was eclipsed, Dano sank in importance, and finally retired to a suburb, where he operated a cafe.

Three More Are Held

Three alleged gangsters, including Vincent "Schemer" Drucel, reputed successor to Weiss, were seized Sunday at a football game, and another man was picked up at a hotel for questioning in connection with the Weiss killing. All denied any knowledge of the North State street machine gun fight.

After futile questioning, Chief of Detectives Shoenack observed: "All those fellows could tell us a lot—if they would." Drucel, at least, should know all about the Weiss murder.

American Is Slain
By Mexico Bandits

MEXICO CITY, Oct. 18 (AP)—The American consul at Mazatlan reports that an American, J. E. Spriggs, manager of the Milwaukee Fruit company, had been murdered at Oahuacan, capital of the state of Sinaloa. The motive is presumed to have been robbery. The address in the United States of Mr. Spriggs is not known, and no details of the murder have been received.

Charge Schoenack of the embassy has made representations to the foreign office asking the Mexican government to investigate the affair.

Jury Sought For
McInish Murder Case

SAN ANGELO, Texas, Oct. 18 (AP)—Selection of a jury from a special venire of sixty to try Roy Spens, Coke county ranchman, for the murder of Leo McInish, here last February 8, was begun this morning in the 31st district court of Tom Green county. McInish, a San Angelo wholesale butcher and stockman, was shot to death in a rooming house. Spens' defense will be that he fired at first sight after insult to his wife, his counsel stated when examining trial was waived and bond allowed shortly after the killing.

BRIEF CEREMONIES HELD
AND VISITOR LEAVES
FOR WASHINGTON

(By Associated Press)

NEW YORK, Oct. 18.—Queen Marie of Rumania was whisked through the city so quickly today that New Yorkers as a whole were hardly aware of her passing. She stepped ashore with her party at the battery shortly before noon and hardly an hour later was on her way in a special train to Washington, ceremonies at City Hall having occupied the interim.

Heena, a slender pale girl, wore a dark blue velvet coat trimmed with fur, a semi-clothe hat with a silver ornament in front, a power blue dress, beige silk stockings and black skin pumps. Nicholas was in conventional morning attire.

Greeted by Salute

After the interview the royal party was escorted aboard the Macomb and the tug proceeded to the Battery. Opposite Governor's Island the party was greeted by an official salute of 21 guns.

On the Macomb she was asked if when she returns to Rumania, she would take with her her son, Prince Carol, who renounced his rights as heir apparent to the throne but with whom she was reported to have effected a reconciliation just before sailing.

"I am afraid not yet," she said. "He has made a great mistake in his life and he will just have to take his punishment like anyone else. I hope he can come back some day."

Police Lead Parade

In a long line of automobiles, with Queen Marie in the leading car, the royal party drove up Broadway to City Hall between ranks of eager watchers. The procession was led by

The girls were sent by the Chamber of Commerce for winning first places on their complete exhibits of first, second and third year's work in the Panhandle South Units fair in competition with other girls from Lubbock, Deason and Lynn counties. They were Miss four Allen, Southwest Ward, first year; Miss Kathryn Armstrong, Estacado, second year; Miss Elouise Wilke, New Hope, third year; Miss Leola McIntire, Carlisle, who is to go on her fourth year's work but could not leave her home at this time.

To Hear State Officers

Each girl in the group won a number of other premiums in addition to the one which sent them to Dallas. While there they will be given instructions under State officers of home demonstration work and they are to bring back what they have learned to other club girls of the county. All competitors were with girls from the three counties.

Jealousy Hinted In
Death Of Oklahoman

TULSA, Okla., Oct. 18 (AP)—Jealousy was hinted by officers today as the motive for the slaying Saturday night at Savinaw of L. Floyd Greer, sporting goods merchant, and one of the builders of the town. Greer's wife has been arrested, and Ben Schue, discharged employee, is sought by county officers as an accomplice.

Greer's body was found in a burning bed late Saturday night by customers in his store, who were attracted to his room, where he lay ill, by a cloud of smoke. His head had been crushed with a blunt instrument, investigators said.

Mrs. Greer was to be arraigned today on charges of murder and has indicated that she will plead not guilty. She has steadfastly maintained innocence but is declared to have admitted that her husband was jealous of Schue but without cause.

HAND OVER CASH
AND JOB YOURS
IS CHARGE MADE

SPECIAL COMMITTEE OPENS
INVESTIGATION INTO
HIGHWAY MATTERS

(By the Associated Press)

AUSTIN, Oct. 18.—Charges that James E. Ferguson, husband of Governor Miriam A. Ferguson, had offered to obtain road maintenance contracts for a money consideration were made here today before the legislative committee investigating state departments.

J. D. Winder, highway contractor of Belleville, Texas, testified that Ferguson had made a proposition to obtain contracts in five counties for \$7,000 to be delivered to Ferguson in five and ten dollar bills. The offer was made in April, 1925, the witness said.

Probe Started Today

The committee, which began work today, was created by the special session of the legislature called by Governor Ferguson to study Texas road bonds and among other things, to investigate state departments. The session adjourned last week.

W. G. Hill, president of the central of Austin, who was the first witness, testified that he had given money to Eugene Smith, former secretary, and now chairman of the state highway commission.

Termed Attempt to Bribe

The offer Winder said, was made by Ferguson in the office of Frank Latham, then chairman of the highway commission. Winder termed it "an attempt to bribe me."

"I told him I never had stolen anything and did not intend to start," Winder testified. "He made no reply to this remark and walked out of the room."

Winder expressed the fear, on the stand, that his testimony would result "in the highway commission breaking us on a contract in Austin county." He said the commission had been trying to break this contract for a year.

Hill related that he presented his bill in August but was not paid until October 1925. He said he spoke to Smith about the bill and at that time promised to make him a present. On the Sunday following payment of his warrant Hill said he took Smith for an automobile ride and gave him \$250.

Money Passed in Car

"We drove around the block and I handed to Smith \$250 in currency wrapped in a newspaper," Hill said.

Menu For Today

BREAKFAST—Apple sauce, spinach with poached eggs on toast, crisp Graham toast, milk, coffee.

LUNCHEON—Cream of cauliflower soup, croquettes, pear salad, whole wheat bread and butter sandwiches with jam.

DINNER—Scalloped potatoes with sausage, broiled tomatoes, stuffed celery, sweet older jelly with custard sauce, nut cookies, bran rolls, milk, coffee.

Small children may be served the scalloped potatoes without the sausage and the celery without the stuffing. As to the dinner dessert, more sauce than jelly should be their portion.

The pear salad suggested in the luncheon menu might please your bride or serving club some afternoon. Serve it with tiny assorted sandwiches or dainty hot buttered finger rolls.

Pear Salad (for Four)
Two large pears, 1 orange, 1 cup sugar, 1 cup water, 1 cup walnut meats, 1 cup seeded California grapes, 1 cup whipped cream, boiled salad dressing.

Make a heavy syrup of sugar and water. Add pears, pared, cut in halves, cores removed and cook over a low fire until pears are transparent. Add the orange cut in thin slices with this jelly. When pears are tender and clear, remove from syrup and reduce to jelly. Fill cavities of pears with this jelly. Arrange on hearts of lettuce and sprinkle with orange slices. Add grapes and nuts to salad dressing and fold in whipped cream. Mask pears with this mixture and serve.

The fruit is of course well chilled before arranging as a salad.

Successful Revival Closed By Evangelist Trigg Thomas At Presbyterian Church; Forty New Members Added To List

The successful revival conducted by Rev. Trigg Thomas, D. D., General Assembly evangelist from Mississippi, at the First Presbyterian church during the past fifteen days, closed out strong last night when an unusually large crowd gathered for the final service.

Chairs had to be placed wherever any space could be found in the church and some stood in the church entrance throughout the entire service.

Whites are Winners
The "Win-One-Club" divided into the "golds" and "whites" which has been active during the revival ran up over 600 points each for attendance and activity, but the "whites" made a few more points than the "golds" and thus won the friendly contest.

There have been scores of conversions any many conversions during the revival and last night the pastor, Rev. Jack M. Lewis, read the names of about 40 new members who had been received at the close of the service and more will be received later as a result of the revival.

Sermons are Strong
Dr. Thomas preached two of his strongest sermons Sunday. Before the morning sermon at 11 o'clock Mrs. Thomas, wife of the evangelist, sang "The Old Rugged Cross" and before the evening sermon she sang "There Is No Disappointment in Heaven."

Several united with the church at the close of the sermon.

The evening sermon was on "The Value of the Soul," taken from the text Matthew 16:26. "What shall a man be profited, if he shall gain the whole world, and lose his own soul, or what shall a man give in exchange for his soul?"

Dr. Thomas preached for an hour and held the great throng of people spell-bound with his logic, eloquence and strict scriptural interpretation of the text, showing by plain comparison the value of the soul above all other things combined, that may be known to man in this world; and also how some are selling their souls for business, so-called worldly pleasure and the perishing and trifling things of this life, which in the end mean failure, disappointment and eternal misery.

practice is abandoned. "Giving a cold check means that one did so for the purpose of swindling another. It is just as serious as forging or passing a forged instrument. If the practice is not broken up it will be only a matter of time when business men will refuse to take a check of any kind. This would work a hardship on all of us. So in order to protect society—people who want to do right, law breakers must be punished."

Run Law Stressed
"There is one kind of crime that no grand jury, since the passing of our dry laws, has escaped—that is bootlegging and the manufacture of bootleg liquor. In Texas this is a felony, and we propose to see those who are guilty brought to justice. The manufacture, sale, possession for sale and transportation of liquor are equally serious charges so far as guilty parties are concerned."

"I am sorry we do not have a graduated punishment. An old timer or bootlegger who is ruining the country may be sent to the penitentiary for a period of from one to five years, or a high school or college student with a half pint may be given the same punishment. This is the law, but the law, here, fails in its purpose or intent. One jury of 12 men may send the bootlegger to prison for one year, while another will vote, to imprison the boy for a period of five years."

Considerable Drinking Here
"There has been considerable drinking in Lubbock, and I have been informed that some of our college and high school students have been guilty. This must not be, and I charge you gentlemen right here to investigate this. There is nothing more dangerous than an automobile with a drunken or crazy driver."

"Now, I do not want to send these boys to the penitentiary, for this would absolutely ruin them, and we do not want to do this. Neither do I want to see them go unpunished, for punishment is justly due them. The only way out of this, as I see it, is for you gentlemen to investigate these cases and, when the guilty parties are apprehended turn them over to the city or the lower courts of the county for punishment. This means they may be given jail sentences and fines. It will not ruin them, but will help save them."

Wants Law Enforced
"Now, there are counties in Texas where the liquor laws are not enforced. Judges have not charged their juries to do this, but this is not the case in Lubbock county. A chemical analysis is necessary, and here we can get that analysis. If you have any liquor you wish to have tested, just let the sheriff know your desire. Any kind of liquor containing more than one half of one per cent alcohol is considered intoxicating."

Judge Mulligan then spoke of a number of conditions that exist in the city and county at this time. He told of the increase of petty crime during the past few weeks and placed the blame on a low class of "hoodlums" who have followed in the wake of decent people from other sections who have come here to work. "I see hundreds of idle men and boys on the streets every day, and they are not making any attempt to work. Farmers tell me they still need hundreds and thousands of cotton pickers. If these fellows do not get some other kind of work and quit loafing, if they refuse then we must insist that they move along for they are not wanted here to prey upon the good people of this community."

He Raps Vagrants
"The vagrant does not live upon his own toil, but that of others. We keep him up while he spends his time idly walking around. He is responsible for many of the thefts reported to officers and unless he is willing to go to work we have no place for him."

"Law enforcement has been too slack in this county for many months, and Lubbock is known far and wide as a haven for this undesirable element. We do not want this kind of cattle in our midst and we are not going to keep them any longer. Let them go to Borger or some place where they are wanted."

"I would rather you gentlemen would devote your time to the cleaning up of our city, ridding it of these

undesirables, than anything else. Let us deter our growing manhood in their vicious acts, but let us not ruin them."

Business Session Wanted
"I want you gentlemen to handle your work in the jury room with the same good sense you employ to operate your private businesses. I am sure this work will prove pleasant and profitable and you can render a service to the community."

After the grand jury had been empaneled G. R. Scott, J. T. Williamson and Scott Rheudall were sworn in as bailiffs. They will serve during the present term of court.

At 1:30 this afternoon the civil and jury dockets were called, while the appearance docket will not be called until 3 o'clock tomorrow. The last two weeks of the term will be given

to the trial of criminal cases. Those serving on the present grand jury are Hubert L. Allen, foreman; R. H. Martin, E. B. Green, C. E. Inman, T. L. Holt, J. T. Overby, Sam E. Stages, Bob Crump, E. R. Davis, Will Murray, Ray Graham and Ward Crim.

Catisthenics Class Is Organized Here

Killen, in charge of Physical Training at Texas Tech, assemble in the basement of the Leader building and go through a rigid series of calisthenics which gets them keyed up just right for the day's work. The class is inviting every man of the city to join with them in taking these exercises in order to show the need of a Y. M. C. A. in Lubbock, and to present themselves each morning on time. Sixty men can easily exercise at one time in the large room and in a short time boxing, wrestling, etc., will be added to the curriculum, and keen competition is expected among the members.

SATURDAY PLAY BIG FACTOR ON EASTERN GRID

DEFEAT OF DARTMOUTH IS SIGNIFICANT; PASSING GAME GOES ON

(By United News.)
NEW YORK, Oct. 18.—Several important questions relating to eastern football were answered by Saturday's contests.

Dartmouth's reign is at an end. The defeat of Jesse Hawley's men by Yale at New Haven was another demonstration that 1926 is one year in which champions can not rule by prestige alone.

Football's popularity is not waning. Attendance at Saturday's games, with \$2,000 in the Yale bowl and good sized crowds elsewhere, was larger in the aggregate than never before in mid-October.

Pass Not Minimized

The forward pass has not been minimized as an offensive weapon by the rule makers who sought to curb indiscriminate throwing. The victory was won in a majority of the eastern clashes.

It is unfortunate that New York university and Pennsylvania are not on Yale's schedule this year, for the manner in which New York university and Penn won their intercollegiate contests showed they had two of the strongest defenses in the east. Princeton, succumbing to the quick stab through the line and encircling runs of the navy backs, proved a disappointment. The easy victory of the Middle by a 27-13 score makes Yale's pathway to eastern supremacy appear easy.

Games Cleanly Fought

Saturday's games, for the most part, were cleanly, if strenuously fought. A regrettable exception was furnished by Syracuse at West Point, the orange eleven resorting to fists and cleats when strength and skill failed.

Penn's easy victory over Chicago was a surprise, but the red and blue might have rolled up a larger score even than 27 to 9 had it not been for costly fumbles near the maroon goal line.

Tad Jones, at Yale, has one of his greatest back fields. The Bull Dogs forward passing was unerring in its accuracy, and the few passes which were uncompleted failed as a result of fumbles on the part of receivers. With Captain Bunnell, Larry Noble, Bill Klein, Foote, Ordway, McGuinn, Goodwine and Caldwell all capable of holding down first string back field jobs, the Bulldogs are having only one difficulty. That is to restrain the optimism which he feels spoiled Yale's chances in 1925.

There were few upsets Saturday outside of New Haven. Ohio state's easy victory over Columbia was what might have been expected. Tulane's vaunted pig green wave, which was simple in the north-south contest with New York U., the New Yorkers winning 21 to 0, with plenty in hand.

Harvard finally has won a game beating William and Mary 27 to 7, but the crimson was harder pressed than the score indicates.

REDHEADS ARE ALA. STANDBYS

Trio Of Fiery-Haired Backs To Perform This Year For Southern Eleven

UNIVERSITY, Ala., Oct. 18.—Three fiery-topped youngsters will have important roles with the Crimson Tide of Alabama this fall.

One, probably the most important of the lot, will be Captain "Red" Barnes, a halfback. To be "Red" Barnes, a brother of the famous Johnny Mack Brown of last year's team, is going to be either a regular halfback or an end again this year. The third, while not a player is yet pretty important at Alabama, is Manager "Red" Joyce.

These three will be the only red-headed youngsters around Wallace Wade at Alabama this season, but the Crimson mentor thinks quite a bit of them. Barnes and Brown are half-backs that give joy to a coach's heart and Joyce is that type of a student manager who has the head-gears, the kidney pads, the tape, water and everything right there when the call comes for it.

Because of the fact that Pooley Hubert and Mack Brown, outstanding backs last year, were in the twilight most of the time, Captain Barnes did not receive the credit due him. He is a fast-stepping youngster, a good punter, and may develop into a capable passer this season. His favorite play is a delayed buck on a cork-screw turn.

This will be his fourth and last season with Alabama and critics are of ready stamping him, even before the season starts, as one of the great backs of this fall, all things taken into consideration.

Brown played end last season for Alabama except in cases where his lack of weight proved too much of a handicap to Alabama. With several good backs missing, Coach Wade intends using him in the backfield this season. He played as a back in his prep school days and while a freshman at Alabama and will need very little polishing to make the grade as a varsity man. His older brother was fast, but Tolbert is just as speedy, if not more so. Whether he can bend and twist as Johnny Mack did is another question.

Of course, Joyce will never enter into any lineup, but folks can tell whether he is doing his job right and how much he is helping the cause along by the record the Crimson Tide makes this year.

Offense Carries Biggest Thrill Ernie Nevers Says

The offense in football carries the greater thrill.

To the ball carrier goes most of the praise, while the players, who by their interference make possible some long runs, are generally overlooked.

The football enthusiast, who has never played the game gives but little thought to anyone other than the player carrying the ball.

Only the spectator who has taken part in the game, either in high school or college, really appreciates the important part of interference in the successful execution of a play.

In a previous article, I discussed various phases of a backfield man on offense. I will now briefly discuss the duties of the defensive back.

Keep your eye on the ball is one of the chief fundamentals of most sports, and certainly football is no exception in this respect.

Play the ball, not the men, is the way to emphasize the keep-your-eye-on-the-ball theory as it pertains to football.

No defensive back can offer worthwhile assistance to his line unless he keeps his eye on the ball and is familiar with the attempt of the opposition to advance it.

Another very necessary thing is to perfect a good stance. Unless the stance is firm, it is an easy matter to get a defensive back out of the play because he usually is off-balance.

Legitimate use of the hands also is a most important feature of a defensive back's play. The hands are a very powerful agent in stopping the thrusts of the opposition.

I like to play close to the line on defense, because it prevents the guards and ends from slipping. While such action is contrary to the rules, it often is done in such a way that it escapes the attention of the officials.

A careful study of the opposition's methods during the first period of play often is invaluable to a defensive back in the later stages of the game.

In discussing the methods of an offensive back I revealed how many of them often tipped off their intent. In other words, made it plain as to who was to carry the ball.

Having a fairly good idea of who is to carry the ball and some knowledge of the rival team's methods as gleaned from the information supplied by the scouts, a player is more than ready to do his bit toward stopping the advance.

When you think you know the play about to be pulled, keep the hands out in front, the legs spread for firmness, the knees down and the head up.

Football is no gentle game, but it can be played cleanly as well as hard. When I hit a man to stop a play I always try to make him aware of the fact.

While coaches vary on the methods to be used in trying to break up the passing game of an opposing eleven I always have been taught to watch the man doing the passing and always play your own allotted territory.

While most of the praise goes to the backfield man on offense much credit rightfully belongs to the defensive player. Keep your eye on him and you will appreciate his efforts.

Youth And Speed Meets Craftiness

SAN FRANCISCO, Oct. 18 (AP)—Whether age and craftiness can match the flashing speed and stamina of youth is a ring problem expected to be worked out for several thousand persons here tomorrow night when Tod Morgan, world's junior lightweight champion, defends his title against the veteran Johnny Dundee in a 10 round bout at Recreation baseball park.

Betting odds continued to favor Morgan today with the figures of 19 to 8 quoted that he would retain his honor by a decision. Dundee, however, with 17 years of experience behind him is considered a chance by some critics to outsmart his youthful opponent.

A victory for Dundee will give the New Yorker two titles. He retired as undefeated featherweight champion in 1924 and with the present come back, has claimed the title he vacated two years ago.

Los Angeles Wins Pacific Coast Flag

LOS ANGELES, Oct. 18 (AP)—The eight teams of the Pacific Coast Baseball League yesterday brought their 1926 baseball season to a close.

Assured of its seventh pennant victory three weeks ago, the final curtain found Los Angeles club leading its nearest rival, Oakland, by a margin of 11 games. The loss of three mainstay players and their manager, Bert Ellison, in mid season, appeared to take the heart out of the San Francisco Seals and the 1925 champions terminated play in the cellar position.

Western Coaches Perturbed Over "Loafing" Tactics Of Team Saying Fight Must Be Had For Plainview

As the football season for Lubbock High School rapidly nears the crucial stage with the new approach of the annual contest with the Plainview High School Bulldogs that it is admitted will probably be the turning point for the Westerners. Coaches of Lubbock High are turning their attention to what they term is a dire lack of fight among the personnel of the squad under their supervision.

Coaches Tungen and Frnka admit that a wealth of material is available, the most of which, though, is largely inexperienced, but they look with some awe on the apparent habit of the squad to "take things easy and loaf" when they do not feel that over-exertion is necessary. This spirit has been very noticeable during the last game or two, and seemingly is growing worse as the season progresses.

Coaches Are Worried

Coaches admittedly are worried over the situation, believing that not only is had for the first string squad, but in a measure instill the same spirit into the younger boys who must of necessity offer a big fight to make the first string.

Now, the ultimatum has come from the coaching staff that unless a different attitude is assumed by some of the older heads, they will soon find themselves "sunning out" along the side lines while their younger and less experienced cohorts are tussling with the opposition on the field. In fact, several changes, both in the line and backfield, are in prospect for this week, not only in practice scrimmage, but in the real test of the team when Plainview is met Friday on the Plainview grid.

Must Have Fight, Said

The spirit of apparent indifference that might be termed over-confidence due to the easy victories that have been registered this year to date, must stop, coaches say, and if the older boys cannot hustle and offer the best fight that is in them, they will immediately be replaced by others who in the opinion of coaches will at least make an effort to deliver their best. When it is considered that the team has not yet met any very stiff competition, the victories do not count for so much.

But Friday at Plainview, the real test is coming, and coaches intend to have the squad in a mood to fight that will supercede all former efforts, and they will have this fight, or know the reason why. Plainview's line will be several pounds heavier than the Westerners, and the backfield, though of about the same experience, is, to say the least, one of the hardest scrapping combinations ever met by the Westerners.

Game Is Real Test

The game is looked upon as the point of climax for the squad, and will in a large measure determine which of the two class A squads will go on into further competition for state honors. The Westerners will be put through some stiff practice this week in preparation for the contest, and some new stuff that has not yet been shown probably will be opened up for the game. Suffice it to say that the Westerners have a busy week in store for them, and it is very probable that several of those men who "have a cinch" will find plenty of us riding down the track toward "cow-town."

Smith told me that Ferguson has said if I would go to Houston and testify in the Sherman-Youman's Construction company case that I would get my money. Frank Lanham, and Joe Bucklett, who were the commissioners, told me to go to Jim Ferguson to find out from which fund my money was to come."

Holding Back 17 Per Cent

Winder charged that the commission was withholding 20 percent of each monthly estimate on a contract for 17 miles of certain federal aid project, instead of 10 percent as provided in the specifications.

"Highway contractors generally understood," he testified, "that it would cost them 10 percent of the contract to get a county maintenance contract."

When Winder talked to Ferguson about the contracts in the five counties he said Ferguson told him he had bid too high.

"Winder you've bid too high," the witness quoted Ferguson. "I want you to cut your bid 20 per cent and resubmit it as once. We want the people to think we're saving money as compared with the expenditures of the last commission."

He was asked by Richard Critzattorney for the committee, when Ferguson had told him about the 20 percent he was to cut from his bid.

Must Replace Supervisor

"He told me," replied the witness, "that I'd get that back on forced account and he also said that if the road supervisor in this district made me do too much work that the supervisor would be replaced."

Winder said his bid for the five counties aggregated \$75,118 and that Ferguson asked \$7,500 or practically 10 percent of the bid.

"When I walked into Lanham's office to talk to Ferguson about the matter, Frank Lanham, then chairman of the highway commission was present," said Winder. "Lanham asked how I happened to bid so close to the budget estimates for each of the counties, and walked out."

The witness explained that he had been able to approximate the budget figures for maintenance in the five counties but these figures had been given to him by Leo Ehlinger, an engineer of the commission, who had helped to make up the budget figures.

11 Vessels Reported Wrecked By Hurricane

LONDON, Oct. 18 (AP)—An evening news dispatch from Tokyo says eleven vessels are reported to have been wrecked by a gale in Northern Japan, including the Katsur Maru, which foundered with many passengers.

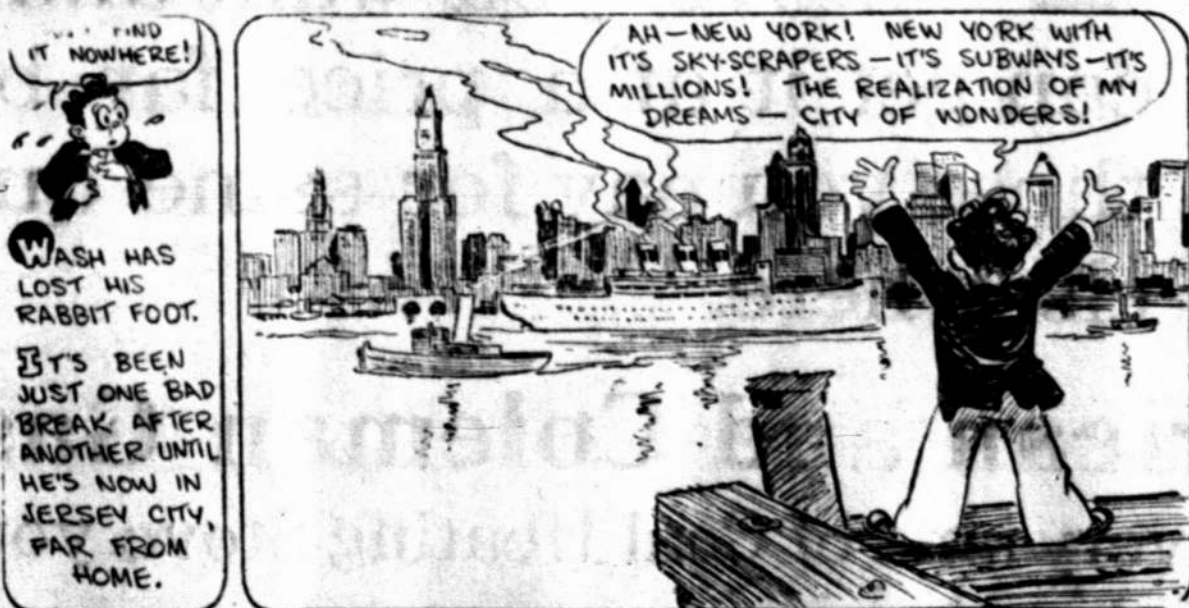

A large detachment of police, soldiers, sailors and marines.
City Hall plaza and the streets for blocks around were jammed with thousands gathered in the hope of catching a glimpse of the royal passengers.
Mayor Walker presented the queen with a scroll, on behalf of the city, in which he praised her for her work in improving the status of Rumania as a nation.

Drizzle Falls

NEW YORK, Oct. 18 (AP)—Queen Marie of Rumania and her royal party stepped onto American soil at the Battery today in a drizzling rain which dampened everything but the spirits of the smiling visitors and the cheering hundreds who crowded the great square for a glimpse of the first queen to visit America in several years.

Interview Granted

Before her arrival the queen granted an interview, possibly the only one she will give, on board the Leviathan.
There were some 200 reporters huddled together in a dripping mass in the Foyer outside the presidential suite about a roped enclosure. Clad in a wine colored velvet coat with black fur collar and cuffs and with a gold turban topping her chestnut bob, the queen was in striking contrast to the bedraggled throngs about her.

Telling the reporters that she had heard on the boat about the barrage of questions they would hurl at her, the queen proceeded to take the interviewing into her own hands.

Very Much Excited

"I have not yet had time to see much of America," she said, "but I am very much excited. I anticipate having a lovely time. I came here to see all the beautiful things of America."
"I don't know what I want to see most. I want to see everything beautiful. And I know that Rumanians have some of the love that Rumanians have for Americans."

"I am especially interested in the position of women here, what they have been doing in the cause of peace. Women have done so much for peace. Some day women will end war; that is, if they don't start fighting among themselves."

She Talked Steadily

The interview lasted but a scant five minutes and during that time the queen talked steadily, her voice a soft ripple with a suggestion of the Scotch burr. Two or three times, however, reporters broke through with questions and the first of these, asked by a woman reporter concerned the city's sky line. Both the queen and the other reporters broke into a laugh at the little stock query which was allowed to go unanswered.

"Do you like American cooking?" was the next question, and the queen replied: "Oh, don't I!"

The almost countless trunks brought by the royal party also came in for notice. "They aren't really all full of my gowns," the queen assured her hearers. "I don't spend so much for clothes as has been reported."

After the interview the queen, her daughter, Princess Elena, and her

son, Prince Nicholas, posed for photographs.

Wanted to See Skyline

Like the humble Rumanian immigrant who has sought American shores her greatest desire was to see New York's sky line, fantastic with varied monuments to the commerce and industry of the western Eldorado.

Ever since the Versailles conference the dashing queen of the little country so cruelly overrun by powerful enemies during the great war has longed to visit America.

Although the blood of English and Russian royalty courses through her veins, she has realized that the bustling world republic whose progress dazzled Europe could give her more than war-riven Europe for the betterment of the state which has fallen under the husband's scepter through the crumbling of the empire over which sultans once ruled.

Son to Be Engineer

With her sailor son, who hopes to devote his engineering training to the betterment of Rumanian industry, and agriculture, and to the development of Rumania's oil and mineral wealth, Marie, one of the most forceful of women rulers since Catherine the Great of Russia, gazed wonderingly at Lower Manhattan's towers, which have none of the antiquity in the midst of which the queen has lived in England, in German principalities, and in the Balkans, product of the never ending wars of the near east between Christians and Moslems.

Still An English Princess

She has never ceased to be an English princess. English is the language she always uses in talking with her children—but she has become more democratic than English royalty. More of her luncheons on the Leviathan and many of her dinners were eaten in the common dining room. She talked with fellow passengers on the promenade deck, and demonstrated that she is a thoroughly charming human woman and devoted mother and thereby doubly charming queen who throws no regal barriers about herself and family and wins through graciousness and simplicity the dignified position which less attractive monarchs might give attempt to achieve through pomp and ceremony.

Three Rescued After 8-Day Battle In Sea

HAVRE, France, Oct. 18 (AP)—An eighty day battle in a disabled motor boat with the tall end of the Florida hurricane ended in almost miraculous rescue for three Americans, who were taken from their tiny craft a few moments before it sank in the raging seas.

The three, William Sandberg, of Brookline, Mass.; Patrick Nash of San Francisco, and Russell Young of Cambridge, Mass., arrived here today on the U. S. shipping Board steamer Meantime, which picked them up after they had given up their last hope and were prepared for death.

The hurricane hit the launch without a moment's warning as the boat was chugging down the Florida coast. The men were forced to head to sea to avoid being swamped under the monster waves that time and again smashed over the deck of their craft and buried the bow under tons of water.

Hurricane Reported On Honduras Coast

WASHINGTON, Oct. 18 (AP)—The tropical disturbance was reported by the weather bureau today to be central over latitude 16; longitude 82, which is off the northeast coast of Honduras. So far the storm, which is moving slowly northward, has been of slight intensity, but indications are that it probably will increase.

The weather bureau at noon issued this warning:
"Advisory noon: Tropical disturbance increasing intensity, moving northward. Steamship 9 a. m. latitude 16 degrees, 30 minutes north; longitude 82 degrees, 12 minutes, reports barometer 29.46 with wind 42 miles from the northeast. Caution emphasized all vessels northward Caribbean sea and Yucatan channel next 24 hours."

Dempsey To Hunt Near San Angelo

SAN ANGELO, Oct. 18 (AP)—Jack Dempsey, recently dethroned as heavyweight champion by Gene Tunney, will coquet with San Angelo to hunt quail, wild turkeys and deer shortly after the season opens November 16, according to information received here by J. Miles O'Daniel, secretary of the Wool Growers' Central Storage company, from Cy Edwards, of Fort Worth, his brother-in-law. H. B. Bonner and a Mr. Quigley, both of the Fort Worth Sand and Gravel company also will be in the party.

Ford Asked To Aid Cotton Situation

GADSDEN, Alabama, Oct. 18 (AP)—Henry Ford has been asked by M. C. Allgood, representative in congress from the seventh Alabama district, to buy two million bales of the present cotton crop in an effort to stabilize prices.
Mr. Allgood made the request in a telegram sent last night to Mr. Ford in which to congressman pointed out that such a move would not only benefit the farmers of the south but would aid business of the Ford agencies which would suffer in almost every county in the cotton district from the low price existing.

Another Songbird

NEW YORK.—John McCormick's daughter, Gwendolyn, is to have a musical debut. When she is presented to society in the gold room of the Ritz in December, she will sing duets with her father and her brother, Cyril. She has operatic ambitions. Her voice is a clear, high soprano.

Mrs. J. E. Rowe of Post, who underwent a serious operation last week, is reported recovering nicely.

Petroleum Firm Loses Court Fight

WASHINGTON, Oct. 18 (AP)—The appeal of the General Petroleum corporation, protesting against taxes imposed by Kern county, Calif., was dismissed by the supreme court. The action affirmed the lower courts in holding that states and counties may lawfully impose taxes upon oil land of the United States leased under the act of February 25, 1933.

Parade Planned To Precede Norris Trial

FORT WORTH, Texas, Oct. 18 (AP)—The First Baptist church today announced a parade of the faithful, 18,000 strong, for the night of October 31, eve of the trial of its fundamentalist pastor, Rev. Dr. J. Frank Norris, on a charge of murder.
Banners bearing biblical quotations and expressing faith in the pastor will be carried by the marchers. It will be Halloween.

WOMAN KILLS 3 CHILDREN THEN TAKES OWN LIFE

FIERCE STRUGGLE AGAINST MODERN LIFE RECALLED IN WOMAN'S NOTE

LOS ANGELES, Calif., Oct. 18.—An eerie pact with death, that snuffed out the lives of a woman of culture and her three small children, while the husband and father frantically searched the city for traces of them Sunday, told a fierce struggle of an elemental parent against the swift pace of twentieth century life.

Mrs. Ada Chamberlain, 40, university graduate and wife of John M. Chamberlain, prominent Los Angeles attorney, carried out her grim intentions to save her children from a "world so full of temptation," in the shabby confines of a rented house.

Lying On Floor
When police broke into the room the woman was lying on the floor. On the cheap iron bed were her three children, made peaceful in death by the thoughtful care of the mother, who first administered a sleeping potion before turning on the gas.

After leaving her home, Mrs. Chamberlain had taken her son John, four, to a nearby school house, and there secured her daughters, Edwin, 9, and Delany, 7, and with the children, went to the scene of her planned tragic act.

A rambling and sometimes incoherent note, written by Mrs. Chamberlain was found in the dining room of the house, in which the woman became muddled as she apparently tried to offer an explanation for the act.

But mingling with the sickening odor of gas was the terrified echo of motherhood, driven into a frenzied state of fear by constant brooding over her self-confessed failure to prepare her children for life in this age of jazz.

Passively Decent Wife
That she fought against being a passively decent wife was indicated in a message which read: "Feware of negative goodness—do not let yourself drift for one day—surely America must have definite training for each school and home making. I save them their naps and cared for them quite well, when they were babies, but I failed to train them."

The meaning of the dying woman's note became obscure as she wrote: "We do not smoke. We do not drink, but we spend too much money in needless ways." And then she emphasized that she was a woman of education, that her husband was a college man, that she had lived in the right environment, that her husband was generous, thoughtful and competent; that her people and she had been good to her, but this somehow she left failed to convince herself that she was a success.

Note Written as Babies Die
The note was written by the woman as her babies were dying from the effects of the sleeping tablets, which she said, "The children took willingly as a germicide for their mouths."

"I took the children to the Western movie for a little while—an hour. It was enough to fix my resolve to end all."

"It is almost twelve, midnight. I go now. I have said nothing and have not looked at the children. The girls made no sound. Junior moaned just a little. What would I not give to be able to go back a few years and make a real home for them," the note read.

"Let us have more flower gardens in fenced back yards, a pet, some tools and the activities that are related to real life. Nature study and nature stories. The child's environment must have closer supervision and parents should be compelled to wear simple clothes and live simple lives."

Admonitions Not Enough
"Telling our children to be good and having them say the Lord's prayer is good, but it isn't enough. They must have protection, peace and tender mercy," the message said.

Mrs. Chamberlain was a housewife to the end. In final instructions to her husband concerning the disposal of their bodies she wrote: "Please put their coats on with the fronts open and cremate us."

She left home last Friday morning after leaving a note saying that she was going to take the children with her and after killing them, committed suicide. When Chamberlain returned home from his office he found the notes and notified police, saying he believed his wife was mentally deranged.

"A lost soul was never adequately described by Milton or Dante," wrote the woman in a final postscript.
