

# RUSSIAN MINISTER TO SWITZERLAND IS SHOT DOWN IN STREETS OF BERNE

## First Japanese Army Has Recently Been Engaged in Very Important Operations— Towns Are Occupied, Dislodging Russians—No Chances Taken and St. Petersburg Is Being Fortified Against Attack By the Baltic Sea

BERNE, Switzerland, June 10.—The Russian minister here, M. V. V. Jadovski, was shot in the street here this afternoon and seriously injured in the head. He would be assassinated, a Russian agent is believed to be a foreigner. His identity has not been ascertained.

M. Jadovski's assailant was a Russian named Linitski. He has been in Berne some weeks and complained that the Russian authorities confiscated an estate belonging to him. M. Jadovski's wound, although at first it appeared to be severe, is not dangerous.

FU SAN, Korea, June 10.—The first Japanese army has recently been engaged in most important operations. For two days past four columns have been reconnoitering the roads towards Liao Yang, Hai Cheng, Saimatsza and Siu Yen, and have occupied the towns mentioned, dislodging the Russians, numbering several hundred, from each, after sharp fighting. The Japanese casualties were sixty-five men killed.

## FORTIFYING THE CAPITAL OF RUSSIA

ST. PETERSBURG, June 10.—Remote as now appears the chance that the Japanese fleet will ever be in a position to venture up the Baltic and make a demonstration against the Russian capital or that any European power will be drawn into the war, Russia is evidently making nothing for granted. The possibility of the fall of Port Arthur or a disaster to the Baltic squadron after the latter sailed for the far east, has been considered and no precautions will be omitted to protect St. Petersburg against attack. The Japanese fleet, being killed and fifteen wounded. NEW YORK, June 10.—The czar of Russia has sent to the New York Stock Exchange a magnificent silver gift as a token of his appreciation of the courtesy of the exchange in listing Russian bonds a year or two ago. A large part of the loan securities was floated in this country through the action of the stock exchange.

TOKIO, June 10, 5 p. m.—General Kuroki reports a detachment of Japanese troops Tuesday routed a battalion of infantry and two guns at Hai Mach, the Japanese losing three men killed and twenty-four wounded. The Japanese captured two officers and five men. The Russians left on the field twenty-three dead or wounded and probably lost seventy men. A Japanese detachment was dispatched in the direction of Tung Yuan Hu and repulsed six of the enemy's infantry at Lin Chao Tso. Monday and Tuesday they encountered six companies of Russian infantry and 300 cavalry at Chan Chiah Sui. After a two hours' engagement the Japanese drove the Russians off in the direction of Tung Yuan Hu. The Russian casualties were eighty men killed or attacked. The Japanese lost four men killed and fifteen wounded. Wednesday a Japanese detachment co-operating with another detachment from a force landed at Taku Shan, encountered a Russian force of 4,000 cavalry and six guns at Siu Yen and drove them back toward Kai Chuan, losing three men killed and two officers and twenty-eight men wounded.

## FORT WORTH MAN ONE

### Short Story of Tribunal and Statistics Showing Increase of Traffic in Texas

AUSTIN, Texas, June 10.—Today marks the thirteenth anniversary of the organization of the railroad commission of Texas, one of the new departments of the state government.

On the 10th day of June, 1891, Judge John H. Reagan, Hon. L. L. Foster and Judge W. P. McLean, the commissioners appointed by Governor Hoag, met and organized by the election of Judge Reagan as chairman.

The following day, June 11, J. J. Arthur was appointed secretary and John T. Estell and Asa H. Willie Jr. clerks. September 20, E. D. True was appointed expert clerk and H. G. Askew appointed October 4 and H. T. Ziegler March 1 of the following year.

The above is the personnel of the first commission officers and employees. In 1893 Judge L. J. Storey succeeded Judge McLean, in 1895 Judge N. A. Stedman succeeded L. L. Foster, Allison Mayfield succeeded Judge Stedman and Senator O. B. Colquitt succeeded Judge Reagan.

In January, 1900, J. J. Arthur was made assistant expert clerk and E. R. McLean became secretary. Mr. McLean was appointed general clerk in 1896, R. A. Thompson engineer in 1897, O. D. Hendall rate clerk in 1898, J. E. Stubbfield general clerk in 1899, M. Scott assistant expert clerk in 1902 and Tabant Bowman stenographer in 1902.

When the commission was organized thirteen years ago there were 8,812 miles of railroad in Texas, and now there are 11,294 miles and ranks first in mileage of any state in the union. During that year the number of passengers carried was 5,881,451, and for the year ending June 30, 1903, there were approximately 10,000,000 carried. In 1891 the number of tons of revenue yielding freight hauled by the roads was 10,944,195, in 1903, 23,959,293. The gross earnings in 1891 were \$35,656,498; in 1903 \$62,760,577.

DENISON, Texas, June 9.—Bert Good, a gentleman of the territory, arrived here yesterday. To The Telegram correspondent he said:

"I am just from Paul's Valley. I was at Rush Creek and Washita Valley when it rained. Thousands of cattle were driven to the high lands, and many families had to move from the river low lands. Rush creek and the Washita river overflowed and the damage to crops must have been great. The whole country is literally under water. Bridges are all washed out. The damage must run up into the thousands. The oldest inhabitant I know says that the rainfall exceeded anything ever recorded in this territory. It is known to be the heaviest that has ever been pushed."

## KNOW TO BE SENATOR SUCCEEDING M. S. QUAY

Philadelphia Record Says the Appointment Was Forced By a Caucus of the Trust Leaders Which (Was Held Yesterday)— Roosevelt Agrees to the Appointment of His Attorney-General to Senatorship— Helps Democratic Chances

HARRISBURG, Pa., June 10.—Governor Pennypacker today appointed Philander C. Knox as successor to the late United States Senator Quay.

Congressman O. W. Gillespie this morning received this telegram: Philadelphia, Pa., June 9.—Oscar W. Gillespie, Fort Worth, Texas. The trusts represented by Frick, the heaviest stockholder in the Steel trust; Cassat, president of the Pennsylvania railroad, which is one of the defendants in the coal trust suits now pending, and Don Cameron, representing the Standard Oil and Wall Street interests, at a meeting yesterday in Cassat's office, demanded that Penrose, the republican state boss, accept Attorney General Knox as Quay's successor. This morning Knox met the aforesaid gentlemen in Cassat's office and yielded to their persuasions. Immediately the demand upon Penrose was renewed and he surrendered. Knox states his consent is given with Roosevelt's acquiescence. # NO UNION CARD GOES IN CRIPPLE CREEK WHERE BEFORE IT WAS BUSINESS NECESSITY

## BUSINESS MEN THOROUGHLY ORGANIZED, AND THE CLERKS, BARBERS, CARPENTERS, BARTENDERS AND OTHER TRADESMEN MUST GIVE UP THEIR ORGANIZATIONS OR THEIR JOBS

### Authorities Claim That for the First Time in Months Life and Property in Cripple Creek Are Safe—Work Has Been Resumed in One Mine Employing Non-Union Men—Action Brought Against Officers for False Imprisonment

CRIPPLE CREEK, Colo., June 10.—Excitement throughout this district is gradually subsiding. Work was resumed today in a mine employing non-union men, which had been closed since Monday, the Stratton Independent being the first to reopen. The Portland mine remains closed by orders of General Bell and the employees will be compelled to abandon the union or leave the district.

Employers in all branches of business in the city, without exception so far as known, have signed the agreement proposed by the Citizens' Alliance, "not to employ help of any kind that is in any way connected with the district trades assembly or the State Federation of Labor or any kindred organization." This agreement of the proprietors has caused consternation among clerks and employees of shops and stores who are members of the retail clerks, barbers, carpenters, bartenders, cooks and other trades unions, as all will have to resign to hold their position. Union card which were demanded in this camp in order to transact business will no longer be a necessity; in fact, it is intended the cards shall be surrendered as soon as committee reports can be acted upon. The authorities are now in control and declare there has not been a day for months when life or property here were as safe as they are today. Streets are quiet, as those of the lawless element who have not gone are prisoners. No further disturbance is expected.

## BOYCOTT AGAINST SOME OF THE UNIONS

CRIPPLE CREEK, Colo., June 10.—An amendment has been made to the agreement being circulated by committees from the Citizens' Alliance, pledging its members not to employ members of unions affiliated with certain labor organizations. Labor has been stricken out and that of the American Labor Union will be substituted. As it now stands the agreement applies to the local trades assembly, the American Labor Union, the State Federation of Labor and the Western Federation of Miners.

## MINERS ENDORSE PRESIDENT MOYER

DENVER, Colo., June 10.—A silent endorsement of the official acts of President Charles H. Moyer was given by the Western Federation of Miners when the election of officers was had this week.

According to the constitution of the federation any person nominated for an office must be a delegate, and on the floor of the convention when the nomination is made. President Moyer, being in a military prison, the delegates simply refrained from making any nominations for the office, the effect of which is to continue President Moyer as the regularly qualified head of the organization.

## EXILE MAKES STATEMENT

## A Chapter Of Surprises

(Original.)

When we were at the university, Peter Densky was a marked man among us. In everything he stood head and shoulders above the rest of us.

One thing troubled me with reference to Densky. He had a little sweet-heart—Aline was the only name I knew for her—in his native town, and I feared that by marrying a simple country girl he would be less likely to attain that career which I felt was in store for him. I rather hoped he would marry Olga Varenka, a graduate of the girls' seminary near the university where we studied. Olga appeared to me to promise as much for a woman as Densky did for a man. The only thing I had against her was that she was tainted with revolutionary notions, but as Densky was a man to do his own thinking and seemed to be especially bitter against nihilism I doubted if she would influence him in this respect. She gave evidence of being partial to Densky, and before he was graduated it seemed plain to me that she had won him from his rural sweetheart. Every one said, "What a couple those two will make—all intellectual and physical vigor."

After leaving the university I corresponded for a time with Densky, but he was too secretive and undemonstrative for a letter writer, and our correspondence was soon dropped. I supposed he was engaged to Olga Varenka, but heard nothing of this or an approaching marriage. One day I took up a newspaper and was astonished to see a report of Densky's arrest. The government gave no reason, and as Densky had only been outspoken in one matter—his antipathy to the methods of nihilism—I naturally supposed his arrest was one of the many mistakes that were made and that he would soon be restored to liberty.

The arrest occurred in St. Petersburg, and I hurried there to be of service if possible. I was not permitted to see Densky. I called at the house of Olga Varenka, but was told that she was so prostrated on account of the arrest that it was not best for her to see any visitors. I volunteered my evidence to the police as an intimate friend of Densky, who knew his habits, and swore that he was bitterly opposed to nihilism. I looked for some favorable result to follow my statement, but was very much shocked to learn that a few days after I had given it Densky was sent, with a gang of political prisoners, to Siberia.

Three months passed, during which my old friend was in my mind nearly all the time. I feared he had been influenced to change his views with regard to nihilism by Olga Varenka and that what I had hoped would be a benefit had been the cause of his ruin. I heard from the city that she had given over mourning for her love and was engaged to an officer high in favor with the government. One of my friends wrote me that she lived comfortably, and he suspected that Densky had been able to turn over to her some means that had been left him shortly before her arrest.

The next surprise in store for me was that Olga had been found dead in her bed with a knife in her heart. There was no clue to the perpetrator of the deed, but the police don't talk much in such matters, and I presumed they would give nothing out until after they had arrested the murderer. I spent much time wondering as to the motive for the murder and trying in some way to account for it in connection with Densky's imprisonment, but the more I thought the more mysterious the whole affair appeared to me. What was most remarkable was that, though the government made a special effort to discover the slayer of Olga Varenka, offering as high as 10,000 rubles for his detection, he was never discovered.

It was two years after Densky's arrest, eighteen months after the murder of Olga Varenka, that a young German nobleman called to see me with a letter of introduction from—whom? I could scarcely believe my eyes when I recognized the writing and saw the signature of Peter Densky. He was living in obscurity in a little German town. But a matter no less surprising was that the little country girl, Aline, was living with him as his wife. The object of Densky's taking the risk of writing me was to ask me to endeavor to secure the property he had inherited and had hidden from the government. The young German had been a pupil of Densky and idolized him.

Drouth in Early Part of Season Has Put That Crop Back But Cotton and Corn Good

T. R. Jackson, crier for the United States and territorial courts at El Reno, Okla., arrived here last evening and is the guest of his brother, Judge J. H. Jackson, for a few days. Mr. Jackson has been connected with these courts for a number of years and consequently is well acquainted with conditions in the Oklahoma country. "We expect single statehood when both Oklahoma and Indian Territory are ready to be admitted into the sisterhood of states," said Mr. Jackson, "but I hardly think that this will occur during the next session of congress, as is believed by many people who live in both territories. In the first place, the work of allotment among the five civilized tribes of Indians is a much larger task than most people realize, and in my opinion these allotments will not be completed in time for the next congress to act upon the matter. I believe that when single statehood prevails that country will be thoroughly democratic. I am confident Oklahoma is now democratic. The general desire in my country among the people is for single statehood first and all the time. "There is much improvement going on in the Oklahoma country and during the past ten or twelve years hundreds of newcomers have located there. Development is gradually taking place and it won't be many years before Oklahoma will stand at the head of progressive states." Mr. Jackson said that there was a very poor show for crops of wheat and oats this year in Oklahoma on account of the drouth in the early part of the season. In fact, he says that there will be very little wheat raised in many sections of the territory, but that the cotton and corn crops are going to be fair.

Mr. Clark is not like Frank G. Carpenter, the noted writer, who was sent to New Zealand to "write down" the institutions of that country and who was converted by his investigations. Mr. Clark is open-minded.

In one of his articles the distinguished minister says: "If law can make a paradise for the workingman New Zealand is certainly such a paradise."

He recites the solicitude of the laws for the protection of women and children who work, the laws governing the hours of labor, wages, the weekly half holidays, etc., in this land without a strike.

Strange to say, New Zealand business men encourage the organization of unions and at the same time promote the formation of employers' associations. Matters of difference between employers and employes are submitted to boards of conciliation. Falling to effect a settlement the entire controversy is brought before the court of arbitration, whose finding is final. Both sides accept and there are no strikes. In New Zealand compulsory arbitration not only arbitrates, but compels.

Mr. Clark finds much to commend in the public trust office which administers estates without fees, the trustee being paid a salary. State life insurance he says is successful and nearly every one carries a policy. The people's savings are cared for by banks connected with the post-office. And, if a workingman has led a decent life, when he is unable to work, the government pays him a pension.

When the man who is opposed to paternalism reads these things he is led to exclaim, "Impossible!" Yet the facts remain. The experiment is no longer experiment. Here are the results as Mr. Clark sums them up:

"A land without paupers and without millionaires; an amount of private wealth that gives to each individual on the average more than \$1200, ranking him very high among the inhabitants of the most favored nations in the world in this respect; a country where every individual spends more for food, drink and clothes than in any other country in the world in spite of the comparative cheapness of staple articles; a country of industrious, prosperous, contented, law-abiding, God-fearing people. These industrial facts surely speak well for the industrial conditions in the world's economic experiment station—New Zealand."

One who desires fuller information concerning the advanced theory of government wrought out in this colony should read a recent article in the Arena by Mr. Frank Parsons.

In New Zealand, there are no party machines, caucuses, campaign funds or graft. There is a system of direct nominations and elections. "This," says Mr. Parsons, "is one of the fundamental elements in New Zealand progress."

These things being true, it would appear that this country is more than one kind of a paradise and that a like system of direct representation in the United States might help to solve the problem of the purification of politics.

The man who thinks there is only

one theory of government and that the party leader in its grasp will be inclined to push both the personal and the party system employed by the New Zealanders. He will offer in objection that the people are governed to death. But he will have difficulty with the facts as shown by all the investigators. The attestation of theory is the fruit of its application. The open-minded man will always welcome all the facts concerning all the forward movements of the race.

THE STEAM TURBINE

The steam engine has had its day. Watts made a great discovery when he made possible a reciprocating steam machine. The engine was a revolution in mechanics. But now the steam engine is to be supplanted largely by the steam turbine. An article in the Review of Reviews tells about it.

In a word, the steam turbine is the old water turbine turned by steam. Its merits over the steam engine are, in brief: The power is rotary instead of reciprocating and is therefore continuous. There is no thrusting or jarring. Friction is limited and the parts do not wear out as do the parts of the steam engine. Economy of space is an item also. The machine is very small compared with the engine.

Also there is scarcely no cost of installation, no expensive foundations, little delay in setting up. When delivered from the shop the turbine is almost ready to run.

It may surprise some persons who have not watched the development of this new steam motor to learn that it is in use throughout the world.

The turbine furnishes power for the diamond mines of South Africa and drives ships across the English channel. Two ocean greyhounds are equipped with it. In many places in this country where power plants in connection with dynamos are used the motor has been installed.

DAMAGES FOR HAZING

A citizen of New York has sued an eastern college for \$10,000 on account of injuries sustained by his son while being hazed by some of the college students. The story as told by the complainant and not denied, is that the boy was pulled out of bed one cruelly cold night in February. He was not permitted to dress, but in his night gown was compelled to run the gauntlet, being beaten as he ran. The boy finally fell exhausted and was ill for quite awhile because of the exposure and beating. It is related that the father appealed to the college authorities, who refused to proceed in any way against the perpetrators. It is to be hoped that nominal damages at least may be recovered of the college.

Fun has its limitations. Sport may be engaged in to a certain extent. But hazing of this sort is neither fun nor legitimate sport. It is downright cruelty. It is perhaps not possible to eliminate college hazing. Perhaps it is not desirable. Mild hazing is permissible, and the initiate expects something of the sort. Some license is permitted to college boys.

The sentiment against brutal hazing was well brought out by the investigations concerning the practice at West Point. When hazing becomes a mantle for cruelty and brutishness, it is not to be endured. A legal precedent is needed, and it is to be hoped the New York case will make it. If the trustees of an institution are held responsible in damages for the injuries sustained by a pupil during the hazing process, the cruel practices will be stopped. A college is the last place for the teaching of brutality. Young men are not sent to schools to learn to be savages.

There has been a decrease in the coinage of silver by the Mexican government, the total being produced by the mints of that republic being placed at \$23,000,000, this being the combined coinage for the fiscal year 1903 and 1904, against \$27,000,000 coined in 1902 and 1903, from all the three mints in the republic of Mexico. The production in the two outside mints, Zacatecas and Culicán, is small, say less than \$2,000,000 per year. The Mexico mint is where the coinage is mainly done. During the month of May there were coined a total of \$1,303,758, and coined in the ten months of the fiscal year, \$15,957,423. The total for the eleven months of 1903 and 1904, \$17,261,181.

TEXAS TO FURNISH CATTLE FOR CUBA

Texas is being looked to as the state from which must come the greater part of the shipment of breeding cattle for Cuba and other points. In the past quite a number of large shipments have been made, and it is learned here that similar deals are under way at the present time.

Negotiations are pending for the consignment of 100,000 head of sheep and several hundred head of horses to South Africa. It is said that the sheep will come from the sheep country between El Paso and Albuquerque, N. M. These animals are to move at the rate of about 6,000 each month, until the entire number has been exported through the port at Galveston.

The horses will come from Southern Arizona and New Mexico. These will move at the rate of about 500 head per month. It is estimated that it will require about two years in which to complete these shipments to the Transvaal country.

These animals are being taken to South Africa to stock up the ranges of that country, which were depleted by the ravages of the Boer war.

HONOLULU ASKS AID IN A FIGHT WITH LEPROSY INCREASE

Hawaii is in need of money. Since annexation all her customs and Internal revenues have gone to the United States treasury and she has received but little in return. Here is Hawaii's brief but pointed way of explaining the situation:

- The United States government collects annually per capita from Hawaii \$8.53
The United States government returns directly per capita annually to Hawaii 1.62
The United States government expends annual per capita for its mainland population 7.95

WASHINGTON, June 9.—Dr. Charles B. Cooper, for years president of the board of health of Hawaii, is in Washington attending the annual convention of state health officers. Dr. Cooper is also presenting the claims of Hawaii to Surgeon General Wyman and is asking that Uncle Sam open his purse and assist the people of the faraway islands to continue the wonderful struggle that they have been waging against leprosy.

This disease has always been regarded with terror, but Hawaii has demonstrated that it is not the "incurable plague" and that it can be controlled, stamped out and in some cases cured.

"White people need have little fear of leprosy," said Dr. Cooper today. "The disease was taken into the Hawaiian Islands in 1849. In 1855 the island of Molokai was set apart as a leper settlement and a struggle was begun that has been going on ever since.

"The result is that the other islands have been purged of the disease and each year we have learned more and more about it. Scientific research is costly and our islands have many burdens to bear, so that we want the federal government to send us a bacteriologist and equip a laboratory where a series of experiments can be had.

In all the years that Molokai has been a leper island not one of our doctors has controlled the disease. I myself have visited the island for years and in the past thirty-eight years only forty-nine whites have been sent to the island.

"We want the United States to help us find the cure. We have succeeded in

OTHO HOUSTON HAS HAD SUCCESS IN HIS BUSINESS

Story of a Young Man Who Walked Into Granbury, Tex., Eighteen Years Ago, and Is Now a Bank President

Eighteen years ago, when the line of the Fort Worth and Rio Grande had been graded into this city, but not yet completed, a young man, full of energy, but with decidedly limited resources, walked down the line of the road until the swiftly flowing Brazos river put a stop to his progress.

At this point he encountered W. H. Butler, now well known as the Dublin quarryman, but then the proprietor of a small ferry operated by himself across the stream. Crossing the river in any other way with his traps was a practical impossibility. The fare charged by Mr. Butler was 50 cents. Such a sum would have proved too great a depletion of the young man's funds, and a long argument resulted at the termination of which he and his limited baggage were set down on the other shore. The ferryman receiving 25 cents for the passage.

Seeking work, the young man secured employment with Dan C. Cogdell, president of the First National bank of Granbury. Working faithfully in his service he finally left the employ of Mr. Cogdell about nine years later, having advanced from an humble bookkeeper to the position of cashier in that bank. He then went to Stephenville, where he opened his first business venture, a bank of his own. That bank was successful. Last year he came to Fort Worth and became president of a similar institution, the Hunter-Phelan Saving Bank and Trust Company. This week, as president of this institution, he received as a director of his bank Dan C. Cogdell, his former employer.

Today, still a young man, and reckoned one of the wealthiest young men in the state, maintaining still his indomitable energy, owner of one of the most pretentious houses in this city of homes, he signs himself Otho S. Houston, president of the Hunter-Phelan Savings Bank and Trust Company.

Now, when he meets the Dublin quarryman, Mr. Butler insists that he owes him 25 cents balance on that trip across the Brazos. Mr. Houston has been successful, and his success shows what will come to a young man who has the energy and the ambition. His announcement that the Fort Worth bank with which he connected has increased its depositors in number from 1,881 in December to 2,698 at the present time shows that he knows how to push a financial institution to the front.

robbing leprosy of its terrors—that is, of the unfounded fear of contagion, and we have cured forty-eight cases, absolutely.

"We are spending \$300,000 a year on treatment and maintenance and we feel that we are doing a work for the United States and for humanity that the rest of our fellow Americans will be glad to assist in.

"We know that the disease is caused by a special bacillus, but we have been unable with our apparatus, and because men have too much else to do, to devote enough time to purely scientific research, to isolate the bacilli and to study them.

"In 1899 there were 1,213 lepers in the settlements; now there are 883 and in the past year there were only nine deaths, while in 1891 there were 219 deaths. In all, since 1856 about 7,000 patients have been taken to the island, and as I said, of these less than fifty were whites.

"We have destroyed the ancient idea that leprosy is terribly contagious, and is one case on the island of a woman who went to Molokai twenty-four years ago with her husband, who was a leper. He died and she remained and did the washing for the boys' cottages. She has washed the clothing of lepers every day for twenty years and today she is as well and as free from the disease as I am.

"We send lepers over to the islands and their average term of service is fifteen years, yet less than 20 per cent of them contract the disease and then only because of gross carelessness on their part. None of our white doctors or helpers ever caught it.

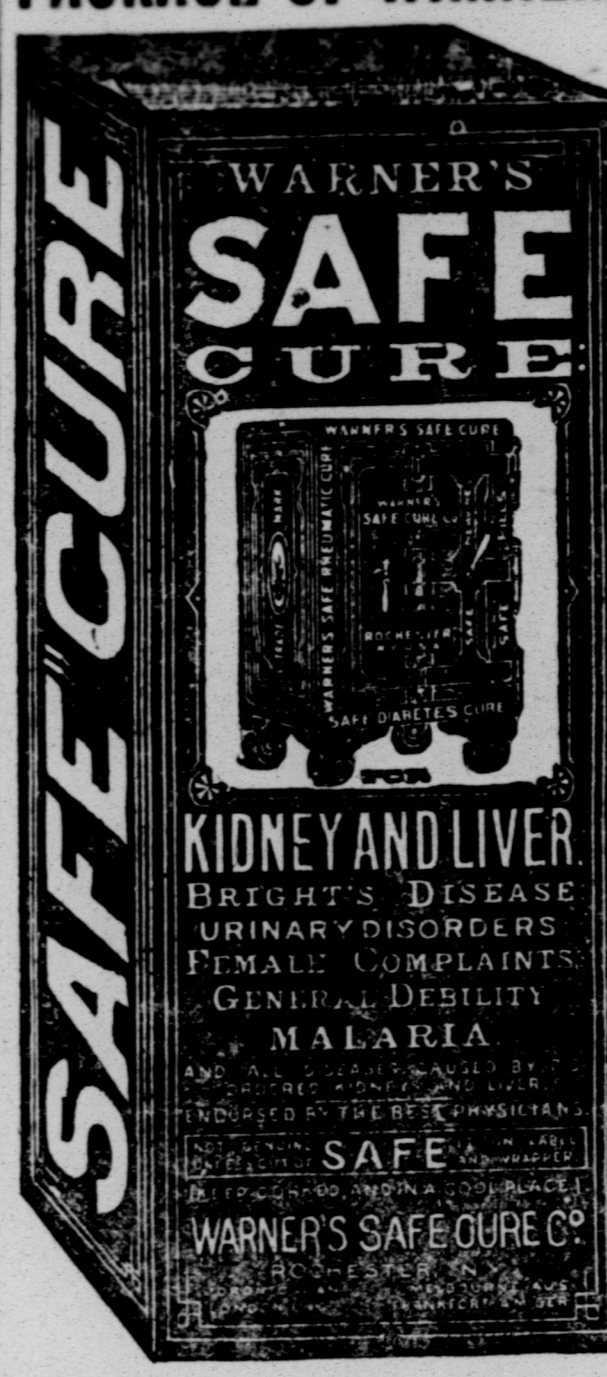
"There is one old man on the island who has been there since 1875, when he went with his leprosy wife. She lived eight years, and after her death he was allowed to remain at his own request. He is now 87 years old and in perfect health.

"The disease is not even hereditary, for I have taken children, whose father and mother were both lepers, and have sent them away and saved them from ever having the disease.

There are two villages on the island—Kalaupapa and Kalawao. There are 450 pretty cottages, and stores, hospitals and churches on the island. Now we ask that the United States government bear the expense of a laboratory and a specialist, and we will, I feel sure, be able to discover a positive cure for the leprosy.

"As it is, no one need fear to go to Hawaii, as we have eliminated all danger—if there ever was any—to white people."

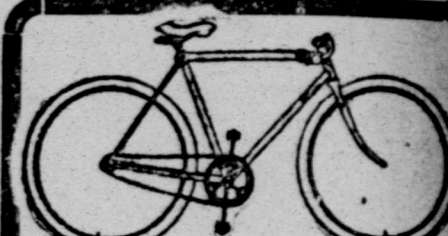

# TWO TRAINS TO RACE ON TRIP TO NASHVILLE

## Sons of Veterans on the Cotton Belt and Old Soldiers on T. & P. Try for Speed

The matter of how fast the Nashville reunion trains on the Cotton Belt and the Texas and Pacific roads out of Texas will make the trip is the basis of a warm discussion among the managers of those two roads. The Cotton Belt has made the statement that its trains out of Fort Worth will leave this city two hours later than the Texas and Pacific and will arrive at Nashville one hour sooner than its competitor. This the Texas and Pacific management assert is impossible, but the Cotton Belt people maintain that the company will be able to fulfill the pledge made at all hazards. The matter of quick time seems to be reason for the contention between the roads.

The Cotton Belt has been selected as the official route for the Sons of the Confederacy out of Texas for Nashville, while the veterans, or a majority of them, will go to the reunion over the Texas and Pacific. This is the route chosen by Major General VanZandt, his staff and other members of the parent order. Because of this division as to routes the companies are waging a miniature war as to which route will make the best time and carry the most people.

Last year there were about 5,000 people who went out of Texas to the reunion at New Orleans, but it is conservatively estimated that the number who will attend the reunion this year will not reach more than half that number, but despite this fact the competition is just as sharp as though the number was going to be as many as last year.

Both companies have arranged to give the veterans and old soldiers the best possible service and it is safe to say that reunion visitors will have occasion to find no fault whatever route is selected.

The Cotton Belt and the Texas and Pacific will both run special trains out of Fort Worth to Nashville and the best possible time is to be made by each, according to statements made by the managements.

# CHICAGO OFFICER GOES TO MEXICO FOR PRISONER

## Chief Auditor of Corn Exchange Bank Is a Fugitive in the Republic and Is to Be Found

G. L. Marsh, a sergeant of the detective force of Chicago, passed through here yesterday on his way to the City of Mexico, where he hopes to make a clever capture of a man named Hermann E. Haas, who is alleged to have embezzled about \$20,000 in gold from the Corn Exchange bank of Chicago while its chief auditor.

From Mr. Marsh it was learned that Haas had been located at San Juan del Rio some weeks ago, where he was held for seventy-two hours, according to the laws of the republic, pending telegraphic authority from Chicago as to what should be done with the prisoner. No information came and Haas was given his liberty and is now supposed to be in hiding in the City of Mexico, to which place Detective Marsh as gone. When he reaches Mexico City the detective will enlist the aid of the local police in finding the fugitive.

The pursuit of Haas is being carried on at the instance of a surety company of Philadelphia, which was his security for \$10,000 gold. This company has secured Mr. Marsh and will continue the search until Haas is finally run down. Mr. Marsh said, referring to the escape of Haas:

"No chapter from a French novel could be more full of incidents than is the story of the downfall of Hermann E. Haas. Until his shortage was accidentally discovered, while he was in his annual vacation in Colorado Springs, about twenty days ago, Haas was considered a model young man by his employers and his associates had no idea of the mad pace he was leading.

It seems that a gay Parisienne was at the bottom of the whole transaction. The story dates back to last summer, when Haas attended the Trocadero theater in Chicago, sitting in the "hard head row." One of the performers was a gay French dancing girl called Mile. de Modern Illustration, who was a Spanish custom, the dancer threw her garter into the audience. It was caught up eagerly by Haas, who attached to it a \$500 bank note, with a request for a further acquaintance and an invitation to dinner. Matters went from bad to worse and finally showed a shortage aggregating between \$17,000 and \$20,000. Then it was that the Philadelphia Security Company took up the matter of prosecuting Haas."

"Detective Marsh says that he went on to Colorado Springs. Arriving there he discovered that Haas had departed for Mexico, leaving his wife behind.

The fugitive is a son-in-law of I. N. Lombard, one of the heaviest stockholders in the Corn Exchange bank, and who was president of the American National bank before it was merged into the Corn Exchange bank.

Haas had been auditor of the American National bank and later was made auditor-in-chief of the new bank. Haas and his wife lived at the Lombard flats on Indiana avenue, in Chicago.

Acting Chief of Police Allen, asking for information as to the condition of her brother, George Walker Davis, reported in the storm.

The acceptance of this position takes Judge Tarlton into the faculty of the State University, and he will spend the summer preparing to enter upon his duties September 1, next. Just now it is not decided whether he will be called on to move his home to Austin. That is a question to come up later.

Judge Tarlton is one of the most prominent attorneys of Texas. Tall, with all the dignity that goes with a jurist who has a conscientious knowledge of the honorable profession of which he is a member, with gray hair and smooth face, Judge Tarlton is one who will attract attention in a crowd, and will be singled out as a man of importance. He is slow of speech and selects his words carefully, every sentence being correct as to language and pronunciation. That he is learned in the law is shown by his record as an attorney and as a judge on the bench, and in the selection of him for the position in the faculty the regents have taken from Fort Worth's bar one of its most distinguished members. Some time ago when the federal court in this city decided upon an investigation of the barratrous conduct of certain attorneys here Judge Tarlton was one of the first to be named by Judge Meek as one of the most distinguished members of the profession and of his friends and acquaintances in the city.

Judge Tarlton is a native of St. Mary's parish, Louisiana, where in childhood he attended the neighborhood schools and was instructed by private tutors at home. In 1868 he graduated from St. Charles college, St. Landry parish. During four years he taught school and studied law without other aid or instruction than occasional advice from Hon. George W. Eastman of Opelousas. His law studies were completed in the University of Louisiana, which is now known as Tulane University. He received his diploma there in 1872. He practiced his profession in St. Landry and other parishes until 1875, and then removed to Washouche, Texas. In March of the following year he moved to Hillsboro, Texas, and formed a law partnership with Hon. Jo Abbott.

Judge Tarlton was a prominent member of the Seventeenth and Nineteenth legislatures and chairman of the house judiciary committee No. 2 in the latter body. In 1882-4 he was a member of the democratic state committee and in August, 1890, presided as temporary chairman at the state convention held in San Antonio.

In May, 1891, Judge Tarlton was appointed by Governor Hogg as one of the judges of section B of the commission of appeals. The next year the constitutional amendment creating the courts of civil appeals was adopted and in an election before the people he was chosen chief justice of the court of the second supreme judicial district, which position he held for six years. During that time he moved to Fort Worth, where he has since resided, taking up a law practice after returning from the court.

The latest estimate of the population of China is based upon a census, taken by order of the imperial government, for the purpose of reassessing taxes. It gives to China a population of 420,000,000. The son of a tribal policeman, who had in his day assisted in the capture of Sitting Bull, Jerome was educated at Hampton, Va.

Armed with a collapsible air mattress to fortify himself against being overtaken at night away from habitations, F. V. Coville of the department of agriculture reached this city last night to begin important investigations for that department of the federal government in this state. Amusing as such an equipment may seem, it is a decidedly sensible idea, as Mr. Coville's investigation of the land leases of this state will take him into sections of the state practically in a primeval state. Overtaken at night in some of the western counties, a tenderfoot will be only too proud of his mattress, always provided some reckless cowboy does not object to this infringement on frontier life and puncture the balloon.

Mr. Coville, who registered at the Delaware hotel last night, going on to Dallas this morning, states that his work will be to investigate the leasing of state lands, with the idea of ascertaining if the system in vogue in this state is preferable to that used by the government. In regard to the matter he said last night: "The system used by the state of Texas is a unique one and is exceedingly interesting. I am investigating the system used to see if it would be beneficial to the United States government to adopt several features of it, either directly or in a modified form, in its use of the government land. The conditions of the public lands in this state exist as they do in no other state in the union, and I understand that the revenues from the leases go toward defraying the expenses of the public schools. One thing, however, that has struck me in this state is the vast agricultural richness of it."

PHIPPS DIVORCE SECRETLY FILED

J. P. Morgan and United States Steel Corporation Restrained From Paying Dividends

DENVER, June 10.—As soon as the necessary papers can be served in New York, John Pierpont Morgan & Co., the United States Steel corporation and the United States Trust company will be formally notified that a temporary restraining order has been issued from the district court of Denver prohibiting them from paying the customary dividends to Mrs. Genevieve Chandler Phipps until the suit for divorce which has been filed in the district court in behalf of Laurence C. Phipps by his attorney, Gerald Hughes, has been finally disposed of.

Despite the fact that the greatest precautions were taken to suppress the application for absolute separation and the strict secrecy was maintained by Mr. Phipps, his attorney and the court house employees and judges who handled the case, the fact that it was filed is undisputed. The details of the complaint, however, were effectually concealed from the public by means of an order received from one of the judges ordering the sealing of the complaint in an envelope, and placing it in the vault of the district court for safe keeping. It is not believed that any co-respondents are named in the bill, although this cannot be ascertained with certainty. Presumably the case was filed at 10 o'clock Monday night, and is believed to have been filed under the number 37,344 and assigned to division 2, over which Judge Mullins presides. When questioned as to whether or not he had any connection with the filing or in granting the formal temporary restraining order prayed for, Judge P. L. Palmer replied: "I have nothing to say about the case."

The granting of the temporary injunction, however, is a purely formal matter, and is done simply to preserve the status of the property which may be involved in any pending suit, and is uniformly granted upon request unless there be some very pertinent reason for refusal. Later in the day another suit is said to have been filed by Mr. Phipps to prevent his wife from disposing of the \$125,000 home at Colfax and Marion streets, during the pendency of the legal proceedings. The principal bone of contention in the pending litigation, it is believed, will be the custody of the children, and it is expected to make a strong contest in this particular, even if she does not contest the suit for separation.

TALKS OF SENSATIONAL INCIDENT NEW YORK, June 10.—Mrs. Laurence Phipps, through the local attorney, gave out a statement concerning the recent removal by her husband of their children without her knowledge from a hotel in this city. Mrs. Phipps says that she was about to undergo a surgical operation and desired the presence of her children in what might prove to be the last hours of her life, and that it was not her purpose to take the children from Mr. Phipps. She says that it is due to Mr. Phipps to say that the statement that she was bound and gagged in her room at the hotel when the children were taken is untrue. She declines to state the cause of the differences that she says "have existed between her husband and herself for several years."

FAILURE OF SALE OF THE WAR VESSELS

NEW YORK, June 10.—Negotiations for the sale of several war vessels have practically failed, according to a Herald dispatch from Buenos Ayres, Argentina. It is understood the government is not disposed to renew them.

PEACE IS ASSURED IN SANTO DOMINGO

Revolutionists Have Accepted and Whole Country Is Under Control Morales Government

NEW YORK, June 10.—The revolutionists of Santo Domingo are reported, in a Herald dispatch from Puerto Plata, to have accepted in full the terms of peace proposed by the government. Although General Rodriguez had difficulty in convincing his companions that they should accept, every one is satisfied with the arrangement. The success of the peace commission was due to Governor Cespedes of Puerto Plata, United States Vice Consul Lithgow and Commander Dillingham, whose courtesy in placing the Detroit at the disposal of the commission in Monte Christi harbor greatly aided its work. Commander Dillingham has taken great personal interest in the matter, and the correspondent adds much credit is due to him. The blockade of Monte Christi has been raised, the whole country is now under the control of the Morales government and peace is assured.

ARGENTINA REFUSES WIRELESS CONCESSION

NEW YORK, June 10.—The general director of posts and telegraphs has refused, says a Herald dispatch from Buenos Ayres, for the reception of stations in Argentina, to attempt wireless communication with Italy. CHICAGO BABES TO USE GOAT'S MILK

St. Louis Capitalists Propose to Give Lessons in Nourishment of Children

CHICAGO, June 10.—St. Louis capitalists are interested in a plan to relieve Chicago's scarcity of milk and improve the quality of food given to infants. They propose to establish a number of distributing stations in Chicago from which goats' milk will be sent out whenever an order for fresh milk is received. And, since there are dangers for the babies in the nursing bottles as well as in the ordinary milk of commerce, it is planned to have the infants take their nourishment entirely from the goats—a method which is said to be in vogue among the Latin races.

RAILROAD NEWS

CHICAGO, June 10.—At a meeting of committees representing the Western, Southwestern and Trans-Continental Passenger Associations held here, it has been decided to make important changes in the arrangements for clergy certificates for the year 1906.

As present 55,000 dergymen are using permits which are good west of Chicago and St. Louis for any distance. These certificates have been subjected to more or less abuse and manipulation by brokers. Accordingly the certificates of 1905 will be good for all distances up to a point where the rate is \$20. Beyond that special permits will be necessary.

DEPOTS ARE BURNED

NOGALES, Ariz., June 10.—Fire has destroyed the federal custom house here, as well as the Southern Pacific and the Sonora railroad depots. The Wells Fargo & Co.'s Express office was completely gutted. Many freight cars in the yards were burned. The total loss is estimated at \$100,000. The cause of the fire is not known.

LET OUT FIFTY MEN

As has been noted in The Telegram the order of retrenchment has been in full force on nearly every railroad system in the country for many months, and as a result thousands of employes have been laid off. A few days ago the Rock Island let out fifty men at Goddard because of slack business. The men thus affected are in the train department, as well as in the mechanical department. It is stated that this reduction is only temporary and will last only so long as there is a let-up in traffic business.

HEARING AGAIN POSTPONED

The second rehearing by the interstate commerce commission of the complaints lodged by the Texas Cattle Raisers' Association against the Texas railroads in an effort to have cheaper rates on interstate cattle shipments, has again been postponed and will probably come up for a third hearing in September.

FAIR VISITOR SUICIDES

ST. LOUIS, June 10.—William A. Aler, general agent here of a life insurance company, has been found dead in a Turkish bath. Heart disease is supposed to have been the cause of death.

BANDIT RAISULI POSES AS SAINT

Captor of Perdicaris Is a Person of No Small Distinction. Wears Green Robe

LONDON, June 10.—Raisuli, the rebel Moorish chief, who has made booty of Ion Perdicaris, the wealthiest man in Tangier, is a personage of no small distinction. Gossip does not fix the date when he was first put into prison nor specify the cause. But since he belongs to the holy tribe, none of whose members may be killed without impiety, and which is therefore the greatest association of cattle lifters in Morocco, it may be assumed that he was caught raiding mules, and, as a measure of prevention rather than of vengeance, was incarcerated; soon to be released by the late sultan, who paid proper respect to him as a "sheikh" or lineal descendant of Muley Israh, the conqueror of Morocco from Islam.

A second time Raisuli was taken, a second time he was let out. When it came to a third capture matters were serious. Even so, Raisuli's adherents came to Torres, the minister for foreign affairs, and pointed out with vehemence that the imprisoned chief came of a line which had produced many saints, and added at every stage sanctity to the initial consecration derived from the blood of the prophet. Further, that the minister himself, born in Raisuli's own tribe, but of a lineage far less illustrious, was bound to be one of his "believers." Torres, like a good Mahometan, listened, considered and went to see Raisuli in prison.

Raisuli told him that he was repentant; that he asked only for a peaceful life, in which to meditate upon religion. Torres stimulated his devotion by the gift of a place in the customs at Tangier, where nothing was to be done but to sit at the receipt of duties. For a while the population of Tangier was edified by the spectacle of a true convert. The ex-brigand put on the green robe, which is the special mark of sainthood; he let his beard grow long; he spoke "whatever came to his mouth"—that is, he rhapsodized like a dervish. No one was surprised, for the sainthood was in his family. But behind the impassive, bearded face and in the heart of the green-robed figure, about which hand-kissing worshippers clustered, like swarms around honey, there stirred memories for two months or three he endured; but the night came when he slipped out unnoticed, gave his green robe to whoever deserved it, cut his beard short and trim, discarded the snowy turban for a rope of camel's hair, shaved around his temples, and took to the hills again, with a string of iron-cloaked brigands to burn and harry at his bidding.

That was a matter of two or three years back and since then how many luckless proprietors have come to the confiding Torres with claims for compensation? The sultan's government is very angry and puts \$50,000 on the head of the outlaw, but no one earns the blood money. You sit in Tangier, in your comfortable hotel, and look across the lovely bay to the Azore mountains, four or five miles distant. Where you are in perfect security, electric lighted, five miles off, if you go look for it, the certainty of capture. Along the beach which skirts the bay, you trot or canter pleasantly and safely; but if you do, it is in virtue of a permit, and there is safety also for the rough-bearded mountaineers, who, with rifle on arm, trudge along past you into the town to do their trafficking. Noted rebels they may be, but while the rebels abstain from capturing Europeans on the beach it is understood that they shall have free access to the market.

Last January things were quieting down, it seemed, and there was a general feeling that Raisuli was in some danger. Two enterprising Americans, who were organizing a Moorish show for the St. Louis exposition, thought that the moment was propitious for securing a supreme attraction—the most famous brigand in Morocco, knew Raisuli (an acquaintance begun with pistol shots), and approached him through envoys; the affair seemed in good train; but at last Raisuli's last word came down. He would go, gladly, to St. Louis, trusting the promoters to smuggle him out. But as security for his return he suggested that the brother of his friend, also a resident in Morocco, should take up his quarters in the brigand's own fortress. The negotiation fell through. Raisuli captured the correspondent of the London Times a year ago and held him for ransom.

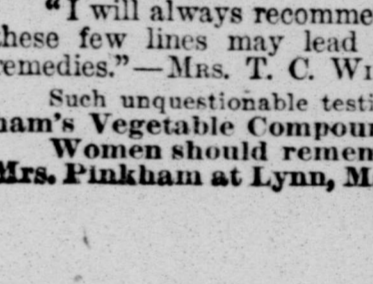

## UNDER A DECISION CITY CAN PAVE STREETS

Alderman Moreland Is in Favor of Going Ahead With the Work of Improvement at Once

Attorney Q. T. Moreland said this morning: "I notice that the supreme court has refused a writ of error in the case of James Kettle against the city of Dallas. In this case the question at issue was whether or not a lien could be fixed on the homestead for street improvements. The court of civil appeals at Dallas had held in the affirmative. The refusal of the writ of error by the supreme court opens the way to extensive street improvement in the cities of Texas. The homestead law has hitherto stood in the way, and it has been considered that a constitutional amendment alone could remove the difficulty. This decision seems to settle it otherwise. For a while it may work a hardship on many to have a lien fixed on the homestead for street improvements, but there are numerous other states where the homestead is liable for street improvements and there is no general complaint of the law in those states, otherwise the people would have it changed. "Fort Worth needs better streets and

needs them badly, and has needed them for a long time, and now that we have one or two good streets and can see and enjoy them daily, the wonder is that this city has waited so long for the much needed improvement. But we have a good-natured community and a patient citizenship. People who are willing to live and let live and wait and abide their time, assured that a better day is coming in the sweet by and by. "If the recent decision of the supreme court stands it looks as if the sweet by and by is nearly here, and to forestall the worst and get ready for the impending trouble, I have already engaged a pavement contractor. So I think that there is a bright outlook for street and pavement improvements in this city in the near future. The public may rest assured that the city council will advance in this direction with all possible rapidity."

The next meeting of the association will be held in Amarillo on the second Tuesday in September of this year. The association will include about fifty banks. The primary intention of the organizers is to bring the Panhandle banks into closer relationship, and for the mutual protection of each other.

## PADDOCK TALKS OF TEXAS BUILDING

Secretary of Board of Trade Has Returned From Visit to St. Louis and the Exposition

Secretary B. B. Paddock of the Board of Trade and one of the Texas World's Fair commissioners, returned last night from Chicago and St. Louis, where he went to confer with General Manager Wortham of the Texas commission in regard to the finances of the commission.  
"I always had an abundance of enthusiasm over the Texas building and exhibit at the World's Fair, but now that I have seen the whole thing with my own eyes, my enthusiasm is without limit," said Captain Paddock to The Telegram.  
"Texas at the fair is the whole thing and is attracting more attention than any other state making exhibits. More than ten times the number of people visit the Texas building and exhibit than any of the other buildings. The mineral and meteorology display in the Texas building, while it is not as spectacular as that of Colorado, addresses itself to the minds of thinking people. In forestry Texas is far ahead of any other state, while the agricultural show is superior to all other states in quantity and quality. The Texas building is also ahead of all others and is attracting more attention. It is as far ahead of the other state buildings as is an electric headlight of a locomotive ahead of a firefly. Texas Ben Davis apples on last Saturday carried off the blue ribbon. The furnishings and arrangement of decorations of the Texas building are simply superb and excel, in my opinion, those of other state buildings."  
Captain Paddock said that before he visited the fair he had heard much talk about the grandeur of the Texas building and its displays, but thought this praise was due to the fact that those who expressed themselves lived in Texas, but he is now thoroughly convinced that the praises of Texas' display have not been overdrawn. He says it is simply immense and must be seen to be thoroughly appreciated.

## MOTHER AND BABE DROWN IN FLOOD IN TERRITORY

Cloudburst at Ardmore Causes Loss of Life and Much Damage to Property—Track Is Washed Away

ARDMORE, I. T., June 10.—The worst cloudburst known in the history of this country occurred at Mill Creek last night. The home of R. H. Wilson on Mill creek washed away. Mrs. Wilson, infant baby and a guest, Miss Davis, were drowned. The bodies were found this morning several hundred yards down the stream.  
Pennington and Mill creeks are higher than ever before.  
Two hundred feet of railroad tracks were washed away. Crops in the lowlands are devastated.

## GOVERNOR PARDONS TWO YOUNG MEN

WAXAHACHIE, Texas, June 10.—Yesterday afternoon Bob Black and George Woodruff, two young men living at Ferris, entered pleas of guilty to a charge of violating the local option law. Each was fined \$25 and given twenty days in jail. An application was immediately made to the governor to remit the jail sentences in both cases, which was done this morning, and the young men were released from jail.  
It has been raining here since noon, the precipitation being heavy, accompanied by high wind.

## RAILROADS MAY ASK INJUNCTION

It is understood that the railroads of the state will soon bring a suit in the federal court, seeking an injunction against the railroad commissioners to prevent them putting into effect their recent order reducing the tariff on lumber three and a half points.

**FOR A RECEIVER**  
NEW YORK, June 10.—Argument will be heard June 20 before Judge Holt of the United States district court on motion for a vacation order appointing a temporary receiver for the brokerage concern of A. B. Baxter & Co., which failed January 30, and for a dismissal of the petitions to have the company adjudged an involuntary bankrupt.

# IMPROVEMENT IN GENERAL BUSINESS

In the South Excellent Sales Have Brought the Volume of Better Distribution

RETAIL TRADE STRONG

If Fall Business Is as Good as Indication, Previous Condition Will Be Equaled

NEW YORK, June 10.—Reports made to the International Mercantile agency from special correspondents at trade centers throughout the country indicate some improvement in general business during the last week. This has been most noteworthy in the south and southwest, where excellent sales have brought the volume of better distribution. Hats and caps are active, but boots and shoes in certain sections have not done as well as usual.

The St. Louis district reports increased prosperity in most line of trade owing to the influx of exposition visitors. Sales meet expectations and merchants in the immediate vicinity expect even better results as the attendance becomes heavier. Increased travel to St. Louis is also helping business in contiguous territory. Jobbers in many sections report improved business, although country merchants in some instances have been prevented from visiting trade centers owing to increased business at home, since farmers have finished planting. Retail trade is strong, and if fall business turns out as well as indications now indicate the total for the year to September will average fully as much as that reported during the corresponding period of 1903. Labor difficulties of the great lakes appear to be nearing solution with the prospect that most of the congestion in traffic will be relieved within a fortnight or so. At Milwaukee the strike has already been partially broken, and negotiations at other points are progressing satisfactorily. The tie-up has been very disastrous and losses sustained aggregate a very much larger sum than was looked for when the disturbance began.

Iron is still stagnant, most branches of the industry being virtually at a standstill. The only exceptions are structural materials and raw pipe, where a large business is reported. Half the merchant furnaces in the Pittsburgh district are likely to be out of blast by July 1, which will materially lessen coke production. The outlook is for dull trade during the summer. Crops have made excellent progress owing to the prevalence of more reasonable weather in many sections of the southwest. Corn has been to an extent retarded by too much moisture.

but the present acreage ranks probably as the largest ever planted, so that the actual harvest may exceed expectations. Business throughout New England is still depressed by unsettled conditions in manufacturing, due to the shut-down of the cotton mills. Wool prices are uncertain and mills run on orders only. Some activity is reported in leather goods, but the tendency everywhere manifested is to "go slow."

## DR. MILLER GETS THE LAST NUMBER

It Is Believed That all Automobiles in Fort Worth Are Now Registered

Falling to be registered as No. 1 in the list of automobiles in the city under the city ordinance, Dr. R. E. L. Miller runs his machine in the repair shop and kept it there until all others had registered, and now he has the last number issued, which will remain the last until more are brought to the city. The complete list shows twenty-eight machines in Fort Worth. The Telegram yesterday published a list of all which had been registered up to the noon hour. Dr. Miller's machine was given No. 27. Then came Dr. Miller, and he was given the last number to be issued. The new ordinance appears to be in general favor, there being no protests against it, and the drivers appear to be staying inside the speed limit.

## REV. R. R. HAMLIN HOME FROM MEETING

Rev. R. R. Hamlin, pastor of the First Christian church, has just returned from Greenville, Texas, where he has been attending the Texas Christian missionary conference. "The conference was largely attended," said Rev. Mr. Hamlin, "and was the most successful and harmonious meeting in the history of the organization. Corresponding Secretary J. C. Mason report showed the largest amount of money ever raised for missionary purposes, \$42,000 being the sum collected, and thirty-six missionaries having been supported during the past year." The convention will meet next year in El Paso.

## IN CAP AND GOWN WACO GIRL WEDS

WACO, Texas, June 10.—A romantic marriage has just come to light. Miss Mary Estel, the beautiful and accomplished daughter of Mr. and Mrs. E. E. Fitzhugh, immediately after graduating from Baylor Wednesday drove to the parsonage of the Columbus Street Baptist church and was married to Rev. Arthur Wakefield, leaving at once with him for Kansas City. The young woman was attired in the cap and gown of a graduate, the ceremony following at once after graduation.

**THE WACO CROWD**

## CARDINAL SATOLLI HERE FROM ROME

The Former Papal Delegate Revisits This Country, His Mission Being Important

NEW YORK, June 9.—Cardinal Satolli was a passenger on the steamer Princess Irene which arrived today. The cardinal was accompanied by Revs. McConnell, Perry and Sullivan.

Through a high ecclesiastical source it was learned here that Cardinal Satolli's visit to this country is for the purpose of establishing a nunciature at Washington. Archbishop Ireland, of St. Paul, and Monsignor O'Connell of the Catholic University, are to aid him in his efforts. Should they be successful Monsignor O'Connell is to be the first Nuncio at the American capital, and Archbishop Ireland is to be made a cardinal.

The authority giving this information, after calling attention to the fact that Cardinal Satolli's program did not include a visit to Cardinal Gibbons, says: "It is true, there exists no very harmonious relations between the two cardinals, and Cardinal Gibbons has repeatedly declared his opposition to any diplomatic relations between Washington and the Vatican."

"In Washington Satolli will be the guest of Dr. O'Connell, and will call upon the president while by regular council the Papal Delegate Falconio disappears from Washington. It is not known whether Falconio has been recalled definitely, or whether it has been deemed prudent to have him out of the country so that Satolli may approach President Roosevelt. "It will be remembered that while himself papal delegate, Satolli was eager for diplomatic recognition from the president of the United States. Archbishop Ireland is known to possess greater influence with the republican party than any other ecclesiastic in this country."

## CITY FIREMEN TO PUT IN GOLD FISH

They Will Stock the Fountain at Central Station With the Pretty Things

Among the first to comply with the suggestion of the city physician, Dr. Chambers, that those having fountains in their yards would do well to stock them with gold fish will be the city firemen, who are at present enlarging the fountain on the lawn of the central station. When completed the fountain will be stocked with the gilded fish. This precaution is being taken because of the fact that the gold fish consider the mesquite larvae or eggs one of the choicest morsels for a meal. Mosquitoes invariably lay their eggs on the top of water and therefore unless the stream or pond be stocked with fish it soon becomes the home of increasing numbers of the pests.

## TIRES OF TRAVEL AND COMES HOME FOR A VISIT

Texas Boy Has Been Around the World and Now Goes to See Those Who Are Dear to Him in West of State

Having been away from his parents and friends sixteen years and at times within three hundred miles of home, Ernest Lane, a young man of perhaps 27 or 28 years old, passed through this city last night, en route to his home in Schleicher county. The story of his life is indeed a strange one and only through persistent effort was he induced to tell of his strange adventures. While awaiting his train, in answer to a few casual questions, he eventually admitted that he knew very little of Texas and the United States, as he was now on Texas soil for the first time in over sixteen years, although he claimed the Lone Star state as the place of his birth.

When 11 years old young Lane, in a fit of anger, determined to leave home and cast his fortunes in a strange land. Bundling up a few clothes he stole away during the early hours of the night, and, with little knowledge of the outside world, made his way from his home near the little town which held all that life had ever given him, and making his way to the railway station, boarded a freight train and bid farewell to the scenes of his early boyhood. He was not content with stopping in the state, the warmth of whose suns had generated a spirit of unrest in him, but continued his journey with many difficulties to a far distant city in the north, where, amid strange surroundings, he cast himself on the billows of a new sea. Knowing nothing of the busy rush which accompanies a city life he joined the ever-moving crowd, and, with no object in view, moved on—ever silent but watchful of his new surroundings and trusting that Providence would put something in his way—something that could make him feel independent and perchance should his parents hear of him make them feel proud of his achievements when they drove his way to a great foundry and applied to one of the men for a place. He was referred to another, who in turn referred him still to another, the third after questioning him minutely promising him a place as general utility boy in the machine department. This place he held for half a year and, with untiring work, he was promoted, going in as an apprentice and assistant to one of the machinists. Off and on he worked with the foundry, and in the shadow of the great volumes of black smoke, for more than two years, finally leaving for a city on the coast, where he succeeded in becoming an assistant to a marine engineer on a boat of one of the great commercial lines. Proving himself able and competent he remained in the employ of the ship company nearly five years, during which time he, at various times journeyed to nearly all navigable points on the compass. Upon arriving at Liverpool, England, after a long service with the company he decided to again cast about on "terra firma," and, with his knowledge of machinery and engineering he set forth in quest of new fields. He worked in various cities in England for two years, but the spirit of unrest and the desire to visit his native country overcame his continental ambitions and four weeks ago he set sail for his native country over which the stars and stripes make it the country of unlimited freedom.

He arrived in New York and, after visiting places of interest in the north, where his early working days were spent, he directed his journey homeward. He arrived here yesterday and tomorrow will again be with his parents and friends, who now know him as the wayward son of a loving mother and the forgotten companion of early childhood days, when life was one long dream of future ambitions.

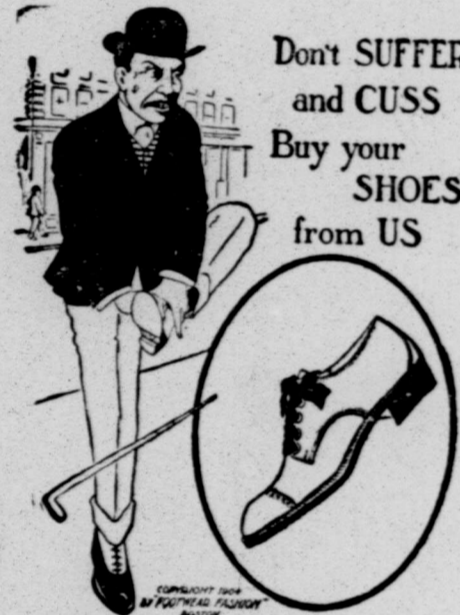

# JUSTICE GAYNOR CONDEMNS OPPRESSION BY THE POLICE

## HE SAYS THAT IT IS BY VIRTUE OF THE SCHEMES FOLLOWED BY THE CAPTAINS OF PRECINCTS THAT SO MANY OF THEM ARE ABLE IN A FEW YEARS TO RETIRE WITH WEALTH

NEW YORK, June 10.—In granting a permanent injunction restraining the police captain from stationing officers in the cafe near Washington market for the ostensible purpose of preventing gambling on the premises, Justice Gaynor of the supreme court handed down a decision denouncing what he calls acts of oppression as commonly practiced by the police. He was particularly severe in denouncing the captain in question, whose action he declared to be "outrageous, criminal lawlessness."

usually in the city of New York and the police officials have been able to retire, one after another, with great wealth. His (the captain) acts clearly constitute a crime of oppression and it is fortunate they have not provoked violence and even bloodshed. We read of such official conduct in Europe and profess to be astonished over it, but we have had more of it in the city of New York for the last twenty-five years, and especially during the last eight or nine years, than there has been in any other place in the civilized world. Such police lawlessness is far more dangerous than all the gambling combined. It brings in its train all vices and debauches the government and society. The law can be effectual and permanently enforced only in a lawful, orderly and uniform manner."

# A FAITHFUL NEGRO WHO SERVED WITH SOUTHERN MEN

## General Van Zandt Has a Letter From Body Servant of Adjutant Blain of the Seventh Texas

Major General K. M. Van Zandt, commanding the Texas division of the United Confederate Veterans, yesterday received a letter from an old negro named Nick Blain, who soldiered with him during the Civil War, expressing regrets that he would be unable to go with the veterans from Texas to the reunion at Nashville. The letter is dated at Avalon, Texas, and is as follows:

"Dear General: From the great depth of my heart, I wish I could see your train all decorated with the old Confederate flags yet so dear to me. Oh, how glad I would be to be at Nashville. Nothing would do me more good, but old age and poverty have fastened themselves on me; but the proud and faithful old body-guard will never waver in spirit for the valiant old soldier and his cause. Soon, dear General, I must cross over the river; there I hope to clasp hands with George Blain, General's Granbury, Cleburne and others that I was with during the Civil war. Best wishes to you and all the old soldiers. I am yours truly, "NICK BLAIN."

Major VanZandt said that when the war ended Nick returned home and he never saw him again until the reunion at Memphis. The major says that the negro was always faithful to the cause of the south. He came to the Memphis reunion as an accredited delegate from Fairfield, Texas, camp of veterans. When Nick met General VanZandt it is said the scene was an affecting one. The old negro is now past 75 years of age and is a Methodist preacher. "He is a really good citizen," said General VanZandt, in speaking of him.

The Sons of Confederate Veterans will hold a meeting at the court house tonight at 8 o'clock at which time final arrangements will be completed for the Nashville reunion. The question of representation will be discussed and determined and the remainder of the delegates will be selected at this meeting. Information was received today that the Mount Vernon band of twenty-one pieces will arrive at Fort Worth Sunday morning, and headed by General Freight and Passenger Agent Lehane of the Cotton Belt, will parade the principal thoroughfares.

Colonel J. Q. Chenoweth, superintendent of the Confederate home at Austin, has arrived in the city and is the guest of Commander W. P. Lane of the Texas division, and will accompany the sons to Nashville.

These dogs may be seen any morning in great gangs, trotting this way and that, running over and through the lawns and lawns of every and anybody and apparently assuming the rights of citizenship in its fullest form. "The complaint is justified that these dogs, which are utterly useless and frequently dangerous, should either be kept at home or put out of the way. "The dogs that are permitted to run at large and forage from one end of the city to the other can certainly be of no benefit to their owners. They are a great public nuisance and there is no justifiable ground for their existence. "I have great respect and admiration for a good dog. He may be, and often is, a valuable friend. # CHURCH SCANDAL IN DIVORCE SUIT

## Rev. Bartlett Called So Often That Hilligoss Sues for \$5000 After Getting a Divorce

MUNCIE, Ind., June 10.—In a suit filed today by Edward C. Hilligoss of Anderson against Rev. Martin C. Bartlett of this city, the plaintiff alleges that the minister alienated his wife's affections. He demands \$5,000. The suit is the culmination of a church scandal that set the little town of Fairmount, Grant county, into a future last year, but which never reached the public prints until now. Rev. Martin Bartlett, past the prime of life, was the pastor of a happy flock, that of the First Christian church in Fairmount. One of his most active members was Edward C. Hilligoss, aged 60, whose wife, fifteen years younger, was also a devout member of the flock. In 1903 the talk began to disturb the congregation. It was whispered that the minister was paying an unusual number of calls to the home of Deacon Hilligoss. When one member of the church ventured to make a remark to the pastor he laughingly replied that "Sister Hilligoss could make better pies than any other cook in his congregation."

Finally Deacon Hilligoss noticed that the minister's visits were surprisingly frequent. He remonstrated with his wife, but the minister kept up his visits. And now, in his complaint for damages, the deacon says that one day he went home and found the reverend gentleman in the act of kissing his wife. Deacon Hilligoss was angry, but he remembered the principles taught to him by Rev. Mr. Bartlett and did not do bodily harm to the clergyman. However, he took steps at once to procure a divorce. Divorce was granted in the Grant county circuit court in Marion. The notoriety was such that Rev. Mr. Bartlett removed from Fairmount to Muncie. He is married and has a large family. Deacon Hilligoss has made his home with his children in Anderson. He is possessed of enough property to render him an income sufficient to maintain him. Hilligoss also alleges in his complaint
