LUBBOCK MAN IS MURDERED

Texan Raps Present Livestock Freight Rates

11 INJURED AS TRAINS CRASH HEAD-ON

TWO PASSENGERS CRASH AT SWITCH NEAR TEXARKANA

FIREMAN AND EXPRESS- MAN SERIOUSLY HURT; NONE KILLED

(By Associated Press.)
TEXARKANA, Texas, May 26.—
Passenger trains number one and two,
Kansas City Southern Railroad, crashed
head-on at Acron, 5 miles north of
Mena, Ark., early this morning. Eleven
persons were reported injured,
though information received here said
none were fatally hurt.
Will Hartman, DeQueen, Ark., fire-
man on number 1, and F. L. Lin-
necott, address unknown, express mes-
senger, on number 2, were the most
seriously injured, according to infor-
mation received here. They were
given medical treatment at the scene
of the wreck and are still at the scene
several hours later. Passengers were
given a severe shaking up but those
injured received only slight cuts and
bruises.

Engines Demolished.
The wreck will not delay traffic, it
was declared, since it occurred beside
the switch at Acron. The two en-
gines were telescoped. Four coaches
and express coaches on each of
the two passenger trains being splin-
tered in the collision. Number 2 was
standing still when number 1 ploughed
into it. It was reported over long
distance phone from Mena. Number 1
which had a sidetrack order, was
going about 25 miles an hour when it
crashed into the other train.

Hartman, the more seriously hurt,
sustained a severe scalp wound. The
two engines apparently escaped in-
juries, except for slight bruises. Nel-
son train had been removed from the
scene at 10 o'clock this morning. The
wreck was about 3 a. m. Responsibility
for the wreck has not yet been es-
tablished.

A wrecker was sent to the scene of
the wreck. Relief engines were dis-
patched from DeQueen.

Meager Report Given.

KANSAS CITY, May 26. (AP)—A fire-
man was seriously injured and eleven
other persons slightly injured in a
head-on collision of two Kansas City
Southern passenger trains north of
Mena, Ark., early today, according to
reports to the road's general offices
here. The two trains were number 1,
which left Kansas City for Port Ar-
thur, Texas, yesterday afternoon, and
number 2, which left Port Arthur for
Kansas City yesterday morning.

Only a meager report of the wreck
has reached the offices here as it oc-
curred several miles from a telegraph
station. Available information was
that only the one engine had been in-
jured.

Baseball Accident Fatal At Brownwood

BROWNWOOD, May 26. (AP)—Mar-
vin L. Lancaster, 21, died last night
after being struck behind the right
ear by a baseball during practice for
a City League game. He was rushed
from the playing field to a hospital,
and died thirty minutes after the ac-
cident. His wife survives him.

Accident Halts Paris-Tokio Flight

PARIS, May 26. (AP)—Captain Georges
Pelletier, Dole's flight from Paris to
Tokio was halted because of an ac-
cident at Warsaw today.

While taking off his machine over-
turned, into a ditch and was hopelessly
damaged, the air ministry announced.
Neither the flier nor his mechan-
ician was injured.

Santa Fe Seeks To Acquire N. M. Central

WASHINGTON, May 26. (AP)—The
Atchafalaya, Topeka and Santa Fe asked
the Interstate Commerce Commission
today for authority to acquire control
of the New Mexico Central Railway,
a 116-mile line, by purchase of its cap-
ital stock and by lease. The stock was
valued at \$700,000.

Action Of B. C. D. In Vetoing Gas Proposition Is Not Final; City Heads Disagree As Final Action Is Deferred

COMMISSION'S STAND ON GAS PROPOSAL

Here's the way members of the
city commission feel regarding the
proposal of A. J. McMahon, Okla-
homa City broker, to pipe natural
gas to Lubbock from the Amarillo
field, at a cost of 6 1/2 cents per
thousand cubic feet:

MAYOR PINK L. PARRISH —
Mr. Parrish's stand on the propo-
sal is not known, the Mayor hav-
ing been called to Dallas because of
the death of his brother, before the
contract was presented.

R. W. BLAIR, COMMISSIONER
OF STREETS AND ALLEYS—After
a thorough study of the propo-
sal Mr. Blair favors the con-
tract.

J. O. JONES, POLICE AND
FIRE COMMISSIONER — Follow-
ing a perusal of the contract, with
Commissioner Blair Mr. Jones fa-
vors its being accepted.

WALTER S. POSEY, FINANCE
COMMISSIONER — Mr. Posey is
opposed to the contract on the
grounds that better facilities can
and will be presented in time to
give Lubbock natural gas by the
fall of 1927, which time, in his
opinion, is the earliest that Lub-
bock will have it at its disposal.

J. H. HANKINS, UTILITIES
COMMISSIONER — Mr. Hankins
has not yet made up his mind
concerning the proposal, but he
does not believe "rushing into"
this or any contract is the best
for the interest of the city at large.

Youth Sought After Foul Play Feared

CORNICANA, May 26. (AP)—County
officers are searching for Pruitt Duk-
emeier, 20, employee of Fortson Broth-
ers at Rice, who disappeared Tuesday
while enroute in a truck to Richland
in company with a negro. Efforts also
are being made to locate the negro
and truck.

Dukemeier was sent to Richland
with belongings of the negro who had
been given work with the Fortsons at
Rice. Tom Fortson, authorities were
informed, gave Dukemeier \$55 in the
presence of the negro before they
left in company with a negro. The
truck was last reported seen in Cor-
nicana Tuesday afternoon. Later in
the day, Fortson received a telephone
call from the negro saying that Duk-
emeier had gone to Cheneyboro.

The call aroused Fortson's suspicion
and an effort to trace led officers to a
house occupied by negroes. Officers
insisted the missing negro had not
telephoned from there although they
said he had been there Tuesday.

Mexican Banker To Address Convention

GALVESTON, Texas, May 26. (AP)—
International banking problems were
to be discussed before the 42nd annual
convention of the Texas Bankers As-
sociation in session here today by Ro-
berto Riveroll, of Monterey, Mexico,
who was to speak on the relations be-
tween the bankers of Texas and those
of Northern Mexico.

Charles O. Austin, State Commis-
sioner of Banking, was scheduled to
talk on the state banking system; R.
G. Smith, Dallas, on every day bank-
ing; M. P. Dalton, of San
Antonio, on the financing of the cattle
and sheep industry; Raymond F. Mc-
Nally, of St. Louis, on the community's
debt to the bank.

The trust section of the association
will meet this afternoon.

Action of the board of City Develop-
ment in advising against the accept-
ance of a natural gas contract offered
by A. J. McMahon and associates, of
Oklahoma City will not be final in the
matter because the City Commission
has not yet acted on the plan. Com-
missioners J. O. Jones and J. H. Han-
kins told the Journal Wednesday
morning. Present conditions, however,
point that the commission will follow
the advice of the B. C. D. directors
and will veto the proposition.

At the present time members of the
commission are taking different views
on the project and a final vote in an
official meeting will be necessary to
decide it. Commissioners Blair and
Jones, who have gone into the plans
to a considerable extent, favor the
contract offered by McMahon, an Okla-
homa City broker, and his associates,
whereby a gas line will be run from
Amarillo to Slaton, through Canyon,
Happy, Tulsa, Kress, Plainview, Hale
Center, Abernathy and Lubbock and
will be furnished customers here at a
rate of 6 1/2 cents per thousand cubic
feet.

Mayor Pink L. Parrish, who has
been away from the city attending the
funeral of his brother, has not heard
the McMahon proposition, hence his
stand in the matter is not known. Com-
missioner J. H. Hankins told the Jour-
nal that while he favored natural gas
for Lubbock he had not yet made up
his mind on the present project al-
though he did not favor rushing into
this or any other contract which has
so much at stake for the city.

Walter S. Posey, finance commis-
sioner, is opposed to McMahon's plan
and says that in his mind he is certain
that a better proposition can be as-
sured for Lubbock. Mr. Posey does not
believe it possible for the McMahon

HUDSPETH SAYS CATTLEMEN USE PIONEER METHOD

HERDS DRIVEN OVERLAND TO FIGHT RATES, HE TELLS I. C. C.

(By The Associated Press.)
WASHINGTON, May 26.—The In-
terstate Commerce Commission which
is hearing arguments on the proposed
Western freight rates increase, today
heard a complaint that livestock rates
in the Southwest already are so high
that cattlemen are avoiding use of the
railroads.

Appearing as a cattle raiser, rather
than as a member of Congress, Repre-
sentative Hudspeth, Democrat, Texas,
told the commission that one of his
herds recently was driven on foot over
the trails 150 miles at a cost of 50
cents a head, otherwise it would have
cost him \$125 to ship them to the
same destination. Another cattleman,
he declared, drove a herd from the
Texas Panhandle to a Kansas ranch,
500 miles away, to avoid payment of
freight rates.

Challenging the "evangelist of the
railroad companies," to show where
any cattle raiser in Texas had earned
more than 3 1/2 per cent in the last
five years, Mr. Hudspeth said that the
cost of the matter was that the growers
of livestock were leaving the ranches by
the thousands.

"It is a serious condition for the
cattle men of Texas," he said, "when
they have to return to the old trail
driving days to save themselves against
excessive freight rates."

He argued that it was in the interest
of the railroads, as well as the pro-
ducer, to reduce livestock rates to the
pre-war level.

He also protested against "discrim-
ination" in the transportation of
sheep in double-deck cars, rates for
which from Texas, he said, were \$2.50
more to Kansas City on a spread of
sheep than on a carload of steers.

New Rail Line In Panhandle Asked

AMARILLO, Texas, May 26. (AP)—
Representatives of several oil and in-
dustrial concerns here today will pre-
sent a petition to local officials of the
Santa Fe Railroad, asking that a
branch line be built from Spearman,
Texas, in Hansford county, to Signal
Hill, a new oil field north of the
Canadian river in Hutchinson county,
a distance of about 25 miles. Signal
Hill is about five miles north of Ison,
the terminal of the Santa Fe oil field
branch running out of Panhandle City,
now under construction.

Details of the proposition have not
been made public.

Identity Of Wreck Victims Yet Uncertain

AMARILLO, Texas, May 26. (AP)—
Authorities are experiencing difficulty
in identifying one of two men killed
and a third, who was injured, in an
automobile wreck near here yesterday.
One of the victims has been identified
by papers in his pockets as W. C. Ren-
shaw, 55, of Mannington, W. Va.

The other dead man is believed to be
John W. Massener, but efforts to find
where he is from have been fruitless.
The injured man has not regained
consciousness.

No clues as to his identity have been
found.

A check of the license plate shows
the car is from Fort Worth.

The accident occurred a short dis-
tance East of Amarillo on the high-
way. The car turned over plunging the
men underneath it.

Cow Has Rabies and 25 RABID WOLF IS SOUGHT

MINERAL WELLS, Texas, May
26. (AP)—An automobile caravan of
25 persons who had been drinking
milk given by a jersey cow afflicted
with rabies left here last night
for Austin to take the Pasteur
treatment, and at the same time
efforts were made to locate a rabid
wolf from which Louis Harvey,
16, escaped yesterday by climbing
a tree on a farm near here.

The cow, property of T. P.
Bradford, developed strange
symptoms and died Tuesday. The
head was hurriedly taken to Fort
Worth for laboratory examination
and shortly afterward a telegram
was received here stating that it
was a well-developed case of rabies.
The exodus of milk drinkers
followed.

Young Harvey, plowing in a
field, saw the wolf, red-eyed and
frothing at the mouth. He sought
trees, none too soon and after
several attempts to reach him, the
wolf disappeared.

HOMER SMITH IS FOUND SLAIN AT AMARILLO TODAY

SHOT THROUGH HIS BACK PRESUMABLY VICTIM OF HI-JACKERS

(By The Associated Press.)
AMARILLO, May 26.—Homer Ly-
man Smith, 21, of Lubbock, a travel-
ing salesman, was found dead near his
motor car on the Amarillo-Panhandle
highway early today, a bullet hole
through his back. He apparently was
the victim of hi-jackers, as evidences
of a struggle were found. Authorities
have no clues as to the identity of the
slayer.

Early yesterday Arthur Wolfe of
Amarillo was held up near the same
place by a lone hi-jackman, who had
parked his car across the highway.
Wolfe was robbed of \$200 in cash.

Nothing is known of a travelling
salesman here by the name of Homer
Lyman Smith. The Journal has dis-
covered following an exhaustive search
today—but records of Homer Dick
Smith, 21, representative of a com-
mercial tailoring firm were uncovered
by a Journal reporter.

Homer Dick Smith, with his wife
and four children resided at 904 Ave-
nue R from January, 1926, until about
a week ago, when the family moved to
Panhandle where Mr. Smith was to
have opened a drug store. H. R. Strat-
ton, of the Barrie Brothers store, a
brother-in-law of Homer Dick Smith,
says that aside from the fact that the
Smith family left here to make their
home in Panhandle where Mr. Smith
had contracted for a drug store, he
knows nothing of him or his family.

In addition to Mr. Smith and his
wife there were four children, all under
ten years of age, in the family. N. R.
Morgan, secretary of the Lubbock or-
ganization of the National Comm-
ercial Travellers' association, told the
Journal that the only Homer Smith
known in the commercial fraternity
here was Homer Dick Smith and that
to Homer Lyman Smith had ever put
in an appearance in travelling men's
circles in Lubbock.

Amarillo officers have been follow-
ing every clue available today in an
effort to establish the identity of the
murdered man, advices from the North
Plains metropolis said.

Editorials

THIS MORAL TURPITUDE STUFF

Some time ago the Countess of Cath-
cart, a British subject, whose illicit
love affairs with an English noble-
man were once the talk of two con-
tinents, was barred from residing in
the United States on charges of "moral
turpitude," which, in plain English,
means nothing more or less than de-
generate immorality. The English
government failed to make a protest,
in fact took no official notice of the
case.

Yet today, with a worse case facing
us from one of our own citizens, the
English government is probably smil-
ing—if not laughing out loud—for
surely Earl Carroll presents a better
example of immorality than the
Countess ever has and his recent es-
capade would no doubt force the Brit-
ish subject to blush with shame. That
is, providing anything could.

Earl Carroll, the dapper and non-
chalant theatrical producer of New
York, who is being tried for perjury
in connection with his infamous
"Bathub Party," offers the courts of
America the opportunity to make an
example—and a lasting one—out of
one of these "play boys" whose antics
are from time to time aired before the
public.

Yet, taking as a criterion of retro-
spect the other cases of this type
which have been tried in the past, Mr.
Carroll, at the conclusion of his trial,
will not only be allowed to go scot
free but in all probabilities both he and
his 17-year-old victim will com-
mercialize their stained reputations
and reap a veritable harvest of tainted
gold.

If Mr. Carroll is not found guilty of
perjury he might on a number of other
counts, including the possession of
intoxicants, and making a public dis-
play of immorality. The Journal
would like to see Mr. Carroll's con-
viction on both these charges and the
extreme in penalties exacted.

As long as our citizens are permit-
ted to exploit immorality and public
contempt of the laws—as long as we
smile benignly while misconduct is
being flaunted in our national face—
the barring from our shores of persons
alleged to be guilty of "moral turpi-
tude" will be utterly useless and a
burlesque on our laws and constitution.

The Journal is in perfect accord with
the barring of immigrants on the
charge of "moral turpitude" yet at
the same time it bewails the fact that
there is not a clause in our laws which
will permit us to deport a few of our
own people for the same reason.

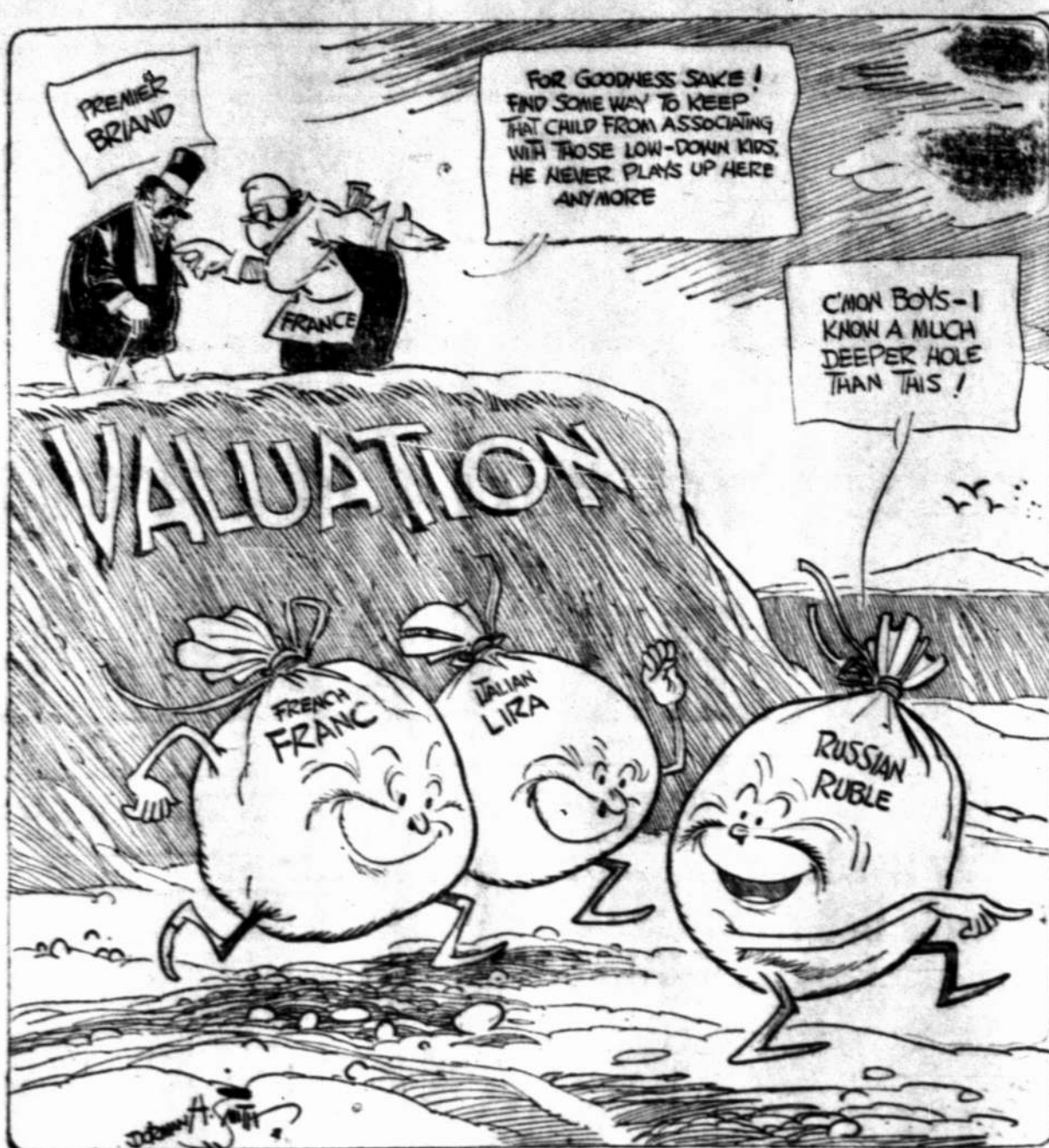
NATURAL GAS PLANS

NEW ORLEANS TRADING

NEW ORLEANS, May 26. (P)—The cotton market opened quiet with no trading except new sales in July at 3 points advance. Liverpool was lower than due, but the market here was supported by dry weather in the Eastern belt. Near the end of the first hour July traded up to 17.70c, October to 17.15c and December to 17.15c or five to seven points above yesterday's close. The market was dominated by the drought in the Eastern belt and fears of a return of rain in the West.

Although the market ruled quiet during the morning the tone was steady and prices worked up to new highs. Values were sustained by the forecast for showery weather in the Southwest and continuance of the drought in the Atlantic states as shown by the weekly report. New private condition reports were issued making the average 72 against 77.5 last year, and 71 against 75.2. July traded up to 17.71c, October to 17.16c and December to 17.16c or six to eight points above the close yesterday.

The market continued to rule quiet but steadily after mid-session. There was little disposition to trade, prices being supported by fears of the effect of the Eastern drought. July continued to rule at the earlier high and October making a new high at 17.17c or seven points above the previous close. December, on the other hand, eased off to 17.15c.

NEW YORK TRADING

NEW YORK, May 26. (P)—The cotton market opened steady, unchanged to an advance 6 1/2 points. More active months showed net gains of 4 to 8 points before the end of the first hour, on covering, by near month shorts, buying for Liverpool or centennial account and moderate demand for new crop positions which was probably inspired by reports of unsettled weather in the Southwest and drought complaints from the Eastern belt. July sold up to 18.41c and December to 17.55c on a comparatively moderate demand.

A private report estimated the crop condition at 71 percent and the acreage at 2 percent. This figure, comparing with a ten year end-May average of 71.4, was below expectations and probably brought in some buying at that influenced by unfavorable features in the weekly weather report. As a result, the advance extended to 18.46c for July and 17.56c for December, representing net gains of about four to 12 points. The buying tapered off at these figures and the market was a few points below the top at mid-day.

Early afternoon reactions of five or eight points from the best were attributed to realizing, and the market held steady around 2 o'clock, July selling at 18.41c and December 17.55c, or about four to eight points higher.

DALLAS LAWYER'S TERM UPHELD IN HIGH COURT

AUSTIN, May 26. (P)—The Criminal Court of Appeals today affirmed the manslaughter conviction and five-year sentence of William Lester Crawford, prominent attorney in Dallas, who shot and killed Paul M. O'Day, in September, 1924.

The court granted the State's motion for rehearing and affirmed the life term sentence of J. A. Claxton from Milan, convicted of murder in connection with the slaying of Otto Jurek, July 23, 1924.

The five-year sentence of Ab Weaver, convicted in Navarro county of murder in connection with the killing of T. Averhart, February 22, 1925, also was affirmed.

The ten-year murder sentence of S. E. Goss from Fannin county was reversed and remanded because the trial court erred in refusing to charge on negligent homicide in the second degree. Goss killed Claude Mainey, September 14, 1925. He contended the killing was accidental. The car in which Goss was riding passed a truck on the running board of which Rainey was riding.

Evidence was introduced to show that the truck had been backing. Goss testified he thought the young man in the truck was playfully discharging firearms and as his car passed the truck, he playfully fired his pistol from the side of the car, and did not know until some time later the bullet had struck Rainey.

All of the members of the commission are in favor of natural gas for Lubbock, they said Wednesday, and the Board of City Development takes the same stand in the matter, several committees having heard propositions to bring gas here from time to time in the past. What both organizations are trying to do is to assure the gas for Lubbock along terms which will be the most beneficial to the city at large.

Local Franchise In Force

At the present time there is a local gas franchise in force, controlled by Sam C. Arnett and associates, and present plans are now to go ahead with the test for gas and oil on the Green place, several miles north of the city. There is also a plan to bring a pipeline here through co-operation of the Lubbock franchise holders and Amarillo producers. There is nothing definite known regarding this plan at the present time.

The survey of the line proposed by McMahon was made by E. A. Stephenson, of the Ralph E. Davis engineering firm of Pittsburgh, Pa. The rate offered is in direct equality with rates in Oklahoma City, Abilene, Wichita Falls, Cleburne, Dallas, Gainesville, Fort Worth, Corsicana and Graham but is higher than Amarillo's, which is 45 cents per thousand cubic feet.

Motion Is Not Seconded

PRIZES IN CHORUS CONTEST FIXED AT AMARILLO

(By Associated Press.)

AMARILLO, May 26.—The prizes and the conditions under which the awards will be made in the Chorus contest, which will form a part of the fine arts program scheduled for Monday evening of the annual convention of the West Texas Chamber of Commerce on June 21, 22 and 23 have just been announced from the convention headquarters here. The contest represents a new departure in musical competition and is looked upon with a great deal of interest. The fine arts program and the contest will this year be given under the auspices of the Seventh District of Federated Music and Women's clubs. It will take place at the city auditorium.

Mrs. I. D. Cole, of Amarillo, chairman in charge, stated that the purpose of the contest, which will be annual, is "to assist in making music an integral part of the civic, industrial, educational and social life of West Texas. Also to encourage and advance American musical creative art."

This purpose is akin to that which prompted the institution of the band contests which have met with signal popularity and success.

The regulations state that the choruses entered must consist of not less than 10 voices, nor more than 20. They may be either ladies' or mixed voices. The number to be sung must be a three-part composition by a recognized composer.

Three judges will be selected by the committee in charge and these will not be allowed to communicate with each other or with any person during the contest.

Two prizes are being offered, the first a prize of \$50.00 and the second a prize of \$25.00.

These awards are to be made upon the following basis of judging: pitch, 15; balance, 15; enunciation, 15; ensemble, 15; interpretation, 40.

JARDINE TALKS TO CREDIT MEN

Tells Convention Question of Farm Relief Not Killed By Haugen Bill's Defeat

(By Associated Press.)

NEW YORK, May 26.—Speaking before the National Association of Credit Men, Secretary Jardine declared today that the recent defeat of the Haugen farm relief bill had not changed the agricultural situation or the need for sound legislative assistance to the farmer.

He said the Tincher bill would be a long step toward the solution of the farm relief problem and that he was hopeful of action on it by the present congress.

Legislative relief for the farmer is needed, Secretary Jardine asserted, because, as the result of agricultural expansion and the increased use of machinery, the farmer has greatly increased his output at a time of a world-wide slump in the price of farm products, which has made marketing rather than production of crops his chief anxiety.

While declaring it was true that agriculture had enjoyed a remarkable recovery from the post-war depression, the secretary said such recovery was merely superficial and that "underneath the surface the farmers of the United States are struggling with a disparity between their receipts and costs, debts and fixed charges that is peculiarly a heritage of the war."

Illinois Warden To Be Removed, Is Said

JOHLET, Ill., May 26. (AP)—Governor Len Small of Illinois, indicated today that he contemplates removal of John L. Whitman as warden of the State penitentiary, because of the recent murder of a deputy warden and the continued escape of convicts.

In a statement issued shortly after he testified for two hours before a special grand jury investigating prison affairs, he expressed certainty of the warden's sincerity, but deprecated the apparent lack of discipline at the prison.

Four more conquests for the New York Yankees will tie the American League record of 19 straight games made by the Chicago White Sox.

Huggins' hammerers added two more in a double-header with the Boston Red Sox yesterday, 5 to 3 and 5 to 4. Babe Ruth increased his home run string for the season to sixteen, placing him more than a week ahead of the record he made in 1921. Herb Pennock, left-hander, scored his eighth victory of the year in the second battle, although the Red Sox found him in 12 safeties against ten for the Yankees. Fourteen hits, three each by Ruth and Lazzari, settled the opening encounter in favor of youthful Myles Thomas.

There was some lively pelting of baseballs in other cities of the American League. At Washington the Senators and Athletics split a double bill. The first went to the league champions, 17 to 12, eleven passing over the home plate in the seventh inning. The Athletics gained the second encounter, 7 to 6, Sam Gray pitching strongly after relieving Eddie Rummel in the second inning. Hauser, Hale, French and Cochrane, all Philadelphia,

GOOD REBATE FROM STATE MEET IS ANNOUNCED

AUSTIN, Tex., May 26.—Rebate on railroad fare for contestants and delegates to the Interscholastic League State meet held at the University of Texas on May 6-8 will amount to nearly \$7,000, according to Roy Bedichek, Chief of the League Bureau. The rebate, according to Bedichek, is distributed to those contestants and delegates whose railroad fare amounted to more than \$7. If, for illustration, a contestant's railroad fare amounted to \$10, the rebate this year is \$3; if \$20, the rebate is \$13, and so on. The distribution is made so as to equalize the expenses of contestants from various parts of the state.

Of the other prominent American players, Bobby Jones, the present American champion, came through in the shape, defeating C. C. Aylmer, a veteran Britisher, by five and four, while Jesse Guilford of Boston played sterling golf to defeat P. Mackenzie Ross of Scotland, three and two.

Another all-American match, between Grant Peacock of Garden City, N. Y., and L. L. Lloyd of Greenwich, Conn., was won by Peacock, 4 and 3.

B. O. MCWHORTER SAYS S. W. TEXAS IN GOOD SHAPE

RANGE AND CATTLE LOOK
FINE, HE SAYS, AFTER
INSPECTION TRIP

Cattle and agricultural conditions in Southwest Texas were never better than they are today, B. O. McWhorter, pioneer South Plains cattleman, told the Journal today following his return from a business trip to El Paso and the Jeff Davis mountains, where he looked over a number of cattle.

According to Mr. McWhorter the range is in fine condition, having had a great deal of rain, and the cattle are fat and looking fine. Alfalfa and cotton in the irrigated valley, are also looking good, he said.

Oil Test Being Sunk

An oil test in the Balmorhea vicinity is being sunk at the present time and residents of the section are confident that the country has petroleum and natural gas possibilities. The well at the present time has been drilled to a depth of 4,700 feet and the contract calls for a depth of 6,000 feet before the project is abandoned.

While in the Jeff Davis range country Mr. McWhorter spent two days on the hurricane deck of a cow pony riding in the round-up at Balmorhea between 5,000 and 6,000 feet above sea-level. Although he has been in the cattle business all his life Mr. McWhorter said that that was the highest above sea-level that he had ever rounded up cattle.

SENATE TO TAKE UP LEGALITY OF PRO LAW ORDER

WET LEADERS TO FIGHT
PROPOSED EXTENSION
OF AUTHORITY

WASHINGTON, May 26. (AP)—The controversy raging over President Coolidge's order extending Federal authority to State, County and City police officers, working on prohibition cases, had advanced today to the point where its legality will be investigated by the Senate judiciary committee.

In addition, unless it is revoked within a few days, Representative Hill Republican, Maryland, wet leader in the House, plans to call up his resolution, introduced yesterday to prohibit employment of Federal officers by States or of State officers by the Federal government.

The Senate inquiry, to be conducted under a resolution by Senator King, Democrat, Utah, will have a sole purpose of ascertaining the legal status of the order. To enable the Senate to determine whether legislation is advisable or necessary in the connection with the enforcement embedded.

Meanwhile those opposed to the order are waiting with considerable interest to see whether any definite action will follow the White House announcement, that while the President did not regard it as an invasion of State rights nor as inconsistent with the national enforcement policy, he was willing to modify it if its operation threatened to lead to harmful consequences.

This latest center of the wet and dry storm had its origin in California and apparently is still whirling there although its main force seems to be over Washington.

FEZ, French Morocco, May 26. (AP)—Abd-el-Krim caused all the French prisoners in the Rif to be taken to Tangier this morning for liberation.

Clubwomen Ready To Open Big Convention

ATLANTIC CITY, May 26. (AP)—Club women of America tonight will begin a series of ten day discussions on their work as home builders, which, in the opinion of Mrs. John D. Sherman, national president, will enable them to chart safer courses through the surging tides of restlessness.

The thirteenth biennial convention of the general federation of women's clubs will be formally opened on the steel pier with Representative Charles A. Eaton of New Jersey delivering the principal address on "woman's influence in the life of today." Mrs. Sherman will preside.

Red Cross Meeting Opened At Capital

WASHINGTON, May 26. (AP)—With President Coolidge delivering the address of welcome today, the second Pan-American Red Cross conference will devote the remainder of this week and all of next to study of the various problems encountered in the work of mercy throughout the western hemisphere.

Judge Spanks Grown Man, Following Case

DUNKIRK, N. Y., May 26. (AP)—Judge Anthony Johnson who boasts some 200 pounds of brawn and muscle, took George Goutcher, 42-years old, over his knee in his private office yesterday and spanked him. Goutcher was before the court for disorderly conduct on complaint of his wife. After administering the thrashing, Judge Johnson sentenced the prisoner to five days in jail but later suspended the sentence on the plea of Goutcher's wife.

The spanking was in the nature of punishment for contempt of court, as before his arrest, officers told the court, Goutcher had referred to Judge Johnson and the arresting officers in uncomplimentary terms.
