

Old Landmark Razed By Sunday Morning Blaze

The Commercial Hotel, located on Austin Street at South Second, was completely demolished Sunday morning by a fire which also destroyed the personal property of all the roomers. The fire was first discovered about 9:30 and was thought to have started from the hot water heater.

Within 45 minutes after it started, only the charred remains was all that was left of what had been the first hotel in Lamesa.

Most of the roomers barely had time to get out of the building, and one roomer, a Mr. McKinney, who was confined to his bed on the second floor was brought to safety by Volunteer Firemen Rube Kelley and Weldon Lindsey only a few moments before the walls of the structure collapsed. He was taken to a local hospital and treated for burns suffered but is not seriously injured.

The heat of the fire was so intense that several plate glass windows in the Higginbotham-Bartlett building across the street was cracked and broken. A small blaze also started in the lumber yard but was extinguished by the quick work of the Fire Department. The fire had too much headway to save the hotel building, so the firemen devoted most of their time to preventing damage to surrounding property.

The building, which has always been used as a hotel or rooming house, was originally built in 1905 by a Mrs. Shirley, and occupied by S. L. Wooten. In 1908 a Mrs. Morton moved the original building back on the lot and built an addition to it making about 25 rooms in the entire building.

The hotel was owned and operated by Mrs. Carl Marshall, who was in Central Texas visiting her husband at the time of the fire. She is reported to have carried \$2,000 insurance on the structure.

No information could be obtained as to whether the owner contemplates replacing the building or not.

Burkhart And Strange Grocery In New Location

Clyde Burkhart and Ogden Strange, proprietors of the Burkhart and Strange Grocery are now located in the Adams building at 222 North Austin street, having moved their stock last week from their former location one block east on Main street.

The larger building they have leased gives them room to carry a larger stock and be better prepared to care for their increasing patronage. They are adding some new lines to their present lines of groceries, feed and produce.

Wilson Receives Certificate Of Standardization

A certificate of Standardization was received this week for Wilson School by Miss Pauline Bulsterbaum, County Superintendent.

It is the purpose of the State Department of Education to standardize the elementary grades of rural schools in such a manner that there will be no question of the pupils being accepted in accredited high schools after they finish a standard school.

In order for a school to receive standardization it is necessary that a standard achievement test be given in each elementary grade and that the median of each grade be standard. In addition attention must be given to buildings, playground facilities, physical equipment, and libraries, plus the academic training, professional spirit and successful experience of teachers.

Teachers, pupils, trustees, and patrons of the Wilson community are to be congratulated upon this achievement. Wilson has the distinction of being the first standard school not seeking accreditation in the county.

Teachers for the 1935-36 school year were: T. H. Bass, Principal; Mrs. T. H. Bass, Miss Edith Muri Baker and Mrs. Geneva Brandenburg. All teachers have been re-elected for the coming term.

The Board of Trustees consists of F. L. Norris, E. L. Craddock, H. L. Coon, L. D. Ham, B. R. Proctor, L. P. Batson, E. G. Murphy. Members on the board whose term expired last April were Amos Painter and J. B. Anderson.

Figures released from the state Old Age Assistance commission reveal the fact that 572 checks have been received in the Big Spring district, of which Dawson county is a part. The total amount of the checks were \$10,610, or an average of about \$18 per check, which is about \$2 higher than the state average.

The report showed 453 more men on the pension rolls than women. The figures were 20,276 and 19,823.

Federal Site To Be Chosen Soon

With only four sites offered for sale to the government as a post office site, officials are anxious for other property owners to take an interest in securing this much needed civic improvement for our city. Jernigan of Fort Worth, will be in Lamesa on or about July 27, which is Monday of next week, to inspect the proposed sites and to interview proponents and other business men of the city who are interested in a Federal Building for our town. The site selected by Mr. Jernigan will be selected by the Department for the building.

Everyone interested in this should watch for announcement of a meeting which is planned for Mr. Jernigan, and plan to be present, as the enthusiasm displayed at this time will very probably be one of the deciding factors determining the recommendation made by the inspector to promote this project.

This is a public building and the public should interest themselves in getting the best location and getting it built as quickly as possible.

Elections Bulletins Will Be Placed On Court House Steps

As announced by the City and County officials, arrangements have been made for the election returns to be posted on the two large election boards, one on the east steps and one on the west steps of the Courthouse.

This change from previous years has been made to eliminate hazardous traffic conditions and the blocking of the streets. This is thought to be a good arrangement and will be much more convenient for the crowds. This arrangement has been made possible by agreements between the drug stores and the City and County officials.

Allred Supporters Confident He'll Win

Austin, Texas—(Special)—This sensitive political atmosphere in the state capital is becoming charged with a feeling that Jimmy Allred has a good chance to win in the first primary.

The argument is this: Allred is a sure shot for re-election. So why not get it over with in July and thus release thousands of persons and many thousands of dollars for the Centennial observances in Dallas, Fort Worth and elsewhere?

That argument seems to hold water. In a trip over a good big stretch of South and Central Texas you find a few persons who concede any of Allred's opponents a fighting chance to be nominated.

The two questions flung at you are whether Allred will be nominated in the first primary, and, if he is not, which man will have to take the trouble of beating in the runoff. Reports from North and West Texas are the same and Allred is expected to run stronger in those sections than in South and Central Texas.

1,201,817 Home Owners Receive HOLC Loans

Loans made to distressed home owners by the Home Owners' Loan Corporation up to June 13, when by law the lending period expired, totaled 1,201,817 for an average of \$3,027 or a total of \$3,629,870,784.

More than 98 percent of the loans were made to refinance defaulted mortgages which had come due in whole or in part at a time when over a million home owners faced immediate loss of their properties if the Government did not come to their aid. The borrowers were given 15-year loans, repayable in small installments which would leave their homes free of debt at the end of that period.

44,360 Texas homeowners took advantage of this opportunity to borrow an average of \$2,317.

LOOP STUDENT WINS WATCH IN CONTEST

Juanita Liles, daughter of Mr. and Mrs. J. E. Liles of Loop, Texas, who were former Dawson County residents, is the happy winner of a new star-timed Elgin watch. All because she told convincingly in 30 words "Why I believe Americans should buy things made in America." This was one of 50 to be awarded in Elgin's "America First" contest.

The watch was delivered to Miss Liles through E. C. Adams, Lamesa Jeweler.

Dawson County Candidates Have Spent \$3,290.81

Expense accounts filed by 40 candidates for county and precinct offices up to last Friday totaled \$3,290.81, according to records in the county clerk's office. It is a Texas election law, requiring every candidate for office to file a list of his expenses, at stated intervals, with the county clerk of the county. Another report must be filed by Friday night before election.

Total expense for running for office here, ranged from a low of \$2.50 (filing fee of an unopposed candidate for a small precinct office) to \$151.00, spent by one candidate seeking the favor of the electorate of Dawson County. The average expense was \$82.27, with eleven candidates having spent over \$100.00 each.

It is a wonder all the candidates don't have a severe case of the gout, from eating all the rich pastry they purchased at pie suppers over the county. Several candidates quizzed at random about their pie expense, gave answers ranging from \$10 to \$34 they had paid for pies.

State School Board Sets Per Capita Appropriation \$19

The State Board of Education fixed the per capita appropriation for next year at \$19.00 at its meeting last week, the highest payment in the history of the state.

The State Board originally set \$17.50 as the appropriation for this past year, but a supplementary appropriation of one dollar was granted by the Board at its meeting in May after it became apparent that there would be a surplus on hand September 1.

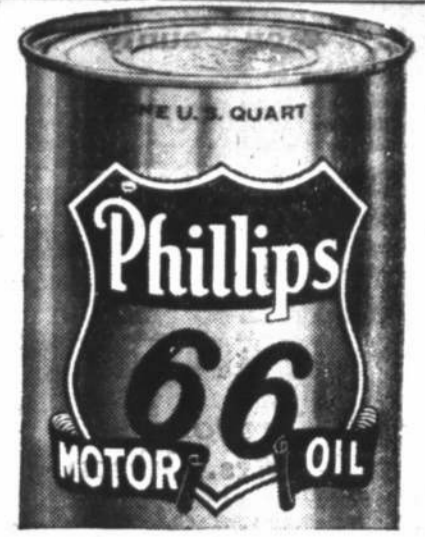

Margaret Borden's Story Of Winning 4-H Club Project

The sun peeped through the window at me. What a beautiful day, but what a perfectly horrid room. The outside world was bright, pretty and cheerful but alas my room was dull and gloomy. Its walls were papered but what ugly wrinkles, the ceiling being dark brown clashed with the walls. The east window through which the sun tried so hard to shine, was covered with cardboard, and hid the beauty mother nature offered as a picture for my room. I had no closet to hang my clothes in, only a shelf with a faded curtain. Or shades at my windows. The floors were rough and dark with larger cracks. My furniture consisted of a small battered up rug, a bed and a dresser with only two knobs for the drawers.

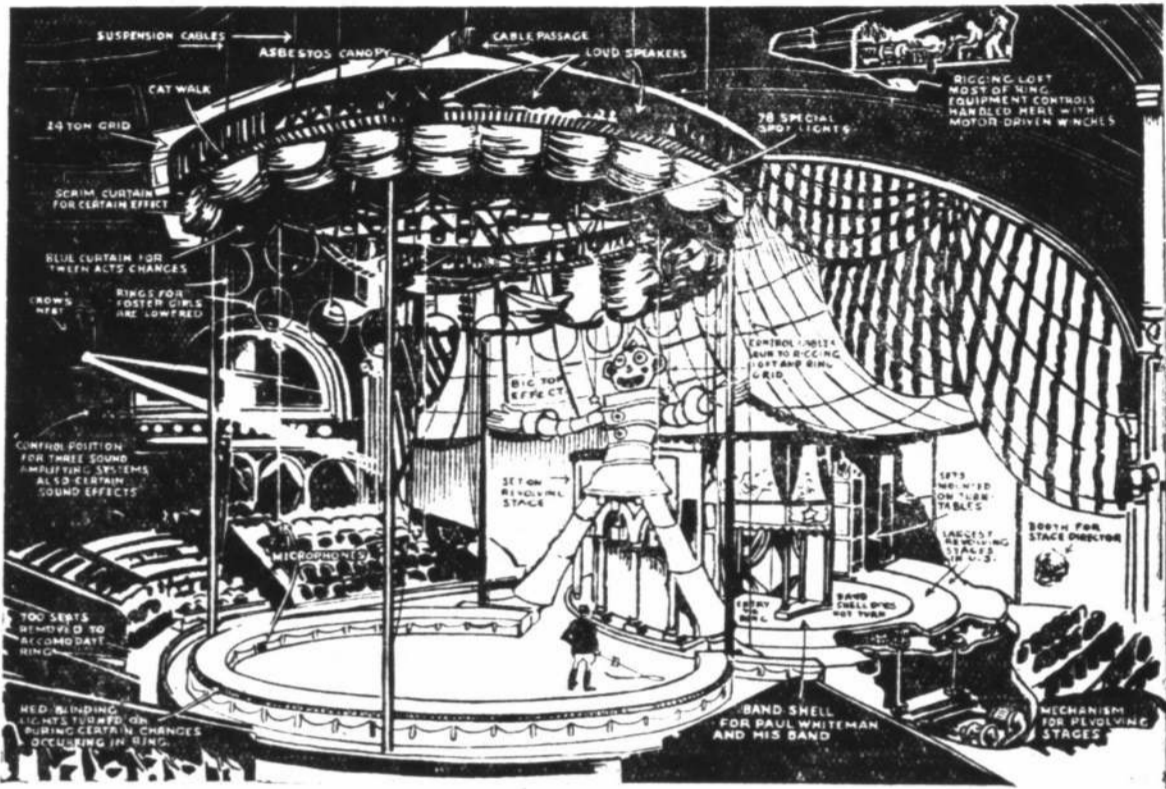
Resolving to make my room more attractive, I began by scrubbing the floor, woodwork and ceiling, and rubbed the dust off the walls. My daddy built a closet with my assistance, then I painted the ceiling and woodwork ivory. The paper I selected for my wall can be rubbed off with a damp cloth, another point for cleanliness. For the floor, the paint is buff. The east window which was covered with cardboard, now has a new shiny glass and screen.

When I started on my furniture, my resting center was first. The bed in my room was too large for the size room. So I exchanged for a three-quarter bed mother had. It had two rollers and lacked two slats and had very little paint. I found two old discarded rollers and slats in the smoke-house. Having my bed all together I began my repainting. Jess McWherter Makes Statement To Dawson Citizens

As it is nearing time for the selection of your next Tax Collector-Assessor, I wish to say these few words for your consideration.

Besides my high school work I graduated from two commercial business colleges. After completing these courses I served as corporation record and book-keeper for two years and general book-keeper and stenographer six years for the public. I believe the training and experience gained thru the duties of general office work would enable me to make you a desirable and efficient Tax Collector-Assessor, if I were to be your choice.

I have always tried to be trustworthy. This office being the source of income for your county, I believe it essential that it be considered as a public trust and filled by a man who has known the ups and downs of responsibility. In being a farmer for a few years I believe it would better enable me to value and assess the rural part of our county to your satisfaction. I have lived in the county for thirteen years, am thirty-one years old and have been married for five years. Modernization Credit Plan To Be Extended One Year

Latest figures reveal that 67 loans amounting to \$20,895.53 have been made in Dawson County under the Modernization Credit Plan or Title I of the National Housing Act, according to a statement of P. S. Luttrell, Associate Director of the Northwestern Texas District of the Federal Housing Administration.

Title I or Modernization Credit Loans are made by banks and other financial institutions approved by the Federal Housing Administration; the loans are made for repairing, altering, modernization and the improvement of real property. The obligation is repaid in small, equal monthly payments over a period of years not to exceed five. This particular section of the National Housing Act expired on April 1, 1936, but because of the demand for this type of loan, and the great benefits to property owners, building material dealers, and labor in the building trades, the Modernization Credit Plan was extended to April 1, 1937.

"Altogether, many thousands of business firms, and millions of wage earners, have profited," says Mr. Luttrell. "The recovery evident during the past year and a half in practically all lines of industry related to housing indicates that the Modernization Credit Plan of the Federal Housing Administration has acted as a substantial force."

Islands of Pacific Visited By Marines

There is scarcely a spot in the whole Pacific Ocean that is not familiar to the U. S. Marines, and today many of them are on duty in Hawaii, Guam, the Philippines or elsewhere amid that vast expanse of water that borders our West Coast.

These voyages by the sea soldiers have been made for almost as many reasons as there are islands, according to Lt. Col. Thomas E. Thrasher, Jr., who answers many queries about the Marine Corps at his recruiting office, 237 Douglas Building, 237 South Spring Street, Los Angeles, California.

"On this isolated ocean do they hold target practice, held reconnaissance surveys, swim, fished and carried out some of the details of an important fleet problem. After twelve days of camp and went back aboard ship."

"The pioneering spirit of the old American Navy fully equaled that of the navy Norsemen who visited our shores years before Columbus," says Colonel Thrasher. "Our sailing frigates were called upon to protect our merchantmen, and they often made cruises to far-away Pacific islands on diplomatic, scientific, rescue, or other missions."

"The marines helped to man these frigates, and prior to the advent of steam vessels saw action in the Marquesas in 1813, went to the rescue of Americans in the Falkland Island in 1831, and fought savages in the Fiji Islands in 1840 and on several other occasions. They made their first important landing in Samoa in 1841.

"An important event in our national history occurred in 1854, when the U. S. Marines visited Japan with Commodore Perry, and the treaty was signed which opened that country to the commerce of the world. They were landed in an expedition against savages in Formosa in 1867, and they have crossed and recrossed the ocean trails of the Pacific over and over again.

"Hawaii has been the scene of so many visits by Marines that the modern history of that country has become closely identified with that of the naval service. Marine detachments have been there continuously since 1904, and they have been stationed in Guam and the Philippines since the days of the Spanish-American war.

"These islands of the Pacific have been visited by thousands of marines who have been ordered to duty in China in recent years, and they often include in their itinerary a voyage to Japan before they return home.

"For years a solitary marine sergeant has commanded the native troops who guard the naval station at Tuleia, Samoa, far from his comrades at other Pacific points. Every two years a new man gets the assignment—one of the most novel ever given to any enlisted man anywhere.

"On errands of diplomatic commerce, science, peace or war, there are few important islands that are a part of all oceans where at some time or another the marines have not landed and had the situation well in hand."

DEVIL'S FOOD CAKE

2-3 cup butter; 2 cups sugar; 2 teaspoonful vanilla; 1 cup cocoa; 3 cups flour; 2-3 teaspoon soda; 2 teaspoon baking powder; 2 cups sour milk; 4 eggs; 1 teaspoon salt.

Cream butter and sugar well. Then add unbeaten eggs one at a time, beating constantly. Sift flour, salt, baking powder and cocoa together 4 times, then add to shortening mixture alternately with sour milk to which the soda has been added and dissolved. Beat rapidly for few seconds. Add vanilla. Bake in 2 large layers in oven 375 degrees F. until well brown. Remove from pan. Cool and stick together with following filling:

2 cups confectioners sugar; 1-4 cup melted butter, 1 cup cocoa.

Add enough thin cream to make right consistency to spread.

PLAIN WAFFLES

2 cups flour; 1 1/2 cups milk; 1 teaspoon salt; 3 tablespoon melted shortening; 2 teaspoon baking powder; 1 tablespoon sugar; 2 eggs, whites and yolks beaten separately.

Mix and sift dry ingredients together 3 times. Blend the milk and well beaten flour and beat for 2 minutes. Add melted shortening and beat for a second or two again. Fold in stiffly beaten egg whites. Bake in a hot ungreased waffle iron until the escaping steam ceases to come through the edges of iron.
