ELIGIBILITY BAN AND INJURIES EXACT TOLL

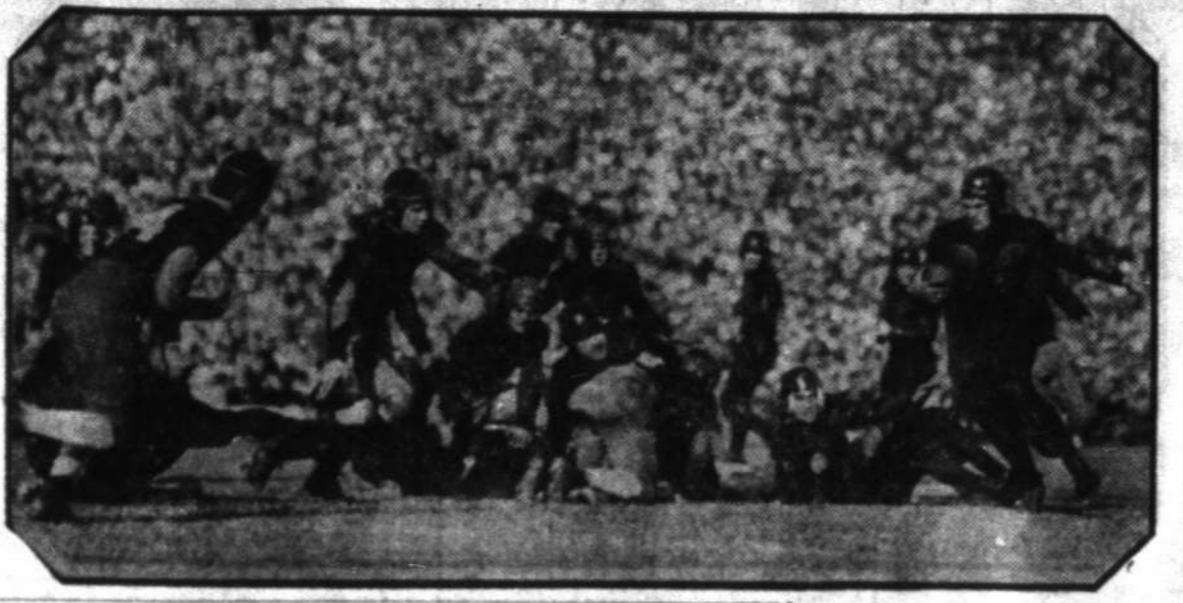

It is quite likely that the back field to be sent in against the veteran Billie combination will consist of a truly new crop of Texas Tech gridsters. Coach Higginbotham feels the hardest blow came in the announcement of the ineligibility, since it takes from his machine the services of Jack Hardy, Pickett and Hamilton; while both Percy (classmate) Ransome Walker and Coach Higginbotham, and Nicholas, charging fullback, are nursing injuries and will neither be able to take part in the clash.

Ewing Y. Freeland's line will miss the services of "Chubby" DeWitt guard, Tomer, guard; Harris, guard; Coach Higginbotham, tackle; Barber, tackle, when the time for the game starts. On the wing position every thing looks all right, as both Al Jennings and "Dope" White were at the regular wing posts in yesterday afternoon's workout.

BILLIES LOOKED GREAT VERSUS COWBOYS

(Special To The Avalanche) BROWNWOOD, Tex., Nov. 3.—"Daniel Baker expects every man to play football," is a 40-year-old slogan of Blue and White elevens. That is exactly what the big Baker eleven did against Simmons here last week. That slogan was in force at Daniel Baker college 10 years ago when Ewing Freeland was the Hill Billie mentor. Freeland knows how well Daniel Baker team fought in those days; he has reason to be proud of their performance; and, on the other hand, eyes of today who made up those Baker elevens of other years have not forgotten their old coach, the present director of athletics at Texas Tech.

The Daniel Baker squad has been slow in getting off this year; it has on occasions played "heads-up" football, and again it has shown a lack of its usual flash and determination. Upon occasion, the Blue and White can rise to great heights. Whether the team will do that against Texas Tech remains to be seen. The two elevens have met only once before on the gridiron, the regular season game, scoreless tie, and the game is expected to develop little antagonism on either side. Of course each team will try to win, but there will be no ill grudge to settle, as was the case in the Baker-Simmons fracas.

Baker and his staff think the Hill Billies would have little trouble winning their remaining schedule in the T. I. A. A. including games with St. Edwards, A. C. C. and McMurry, if the Goats can be kept up to the fight spirit exhibited in their slaughter of Simmons Cowboys, both this year and in 1924 at Abilene.

The Hill Billies came out of the Simmons game with only a few casualties. Moore, regular center, sustained broken blood vessels in his leg and will be out of the Hill-Matador game, as will the rest of the year. Tony Cobb will likely get Moore's place in the starting line-up. Villa, quarter, and McWilliams, halfback, have had shoulder injuries, and Red, guard, has not gotten off free of injury, but it is hoped all these will at least get into part of the game with Tech. Montgomery, regular end, was severely injured in Simmons game and may be out for a week.

The Cowboy-Hill Billie show here last week developed some startling ball-carriers among Hillie reserves. Coaches Ransom and Blair stated that they were uncertain whether these new likely prospects from the "Kids" would be taken to Lubbock, but that they will all likely get into the McMurry game on Armistice Day in Abilene.

No Outstanding Stars. The half-season of play has developed no outstanding stars at Daniel Baker this year. Brownwood fans who saw the Simmons game said they were all stars—no every Baker man surely did play football against a desperate, fighting Cowboy eleven. The Daniel Baker coaches are endeavoring to develop team-play rather than individual stars, and the result is beginning to show in a closely welded eleven.

Rules Protect Team's Punter

A great many times the reason for the foul is because some player on offense has run into the man kicking the ball.

The football fathers have felt that the man who has just kicked the ball is usually off balance and is unable to protect himself. It was then legislated that this man should not be run into.

As a matter of fact, any player, who even touches him can be held in violation of Rule 21, Section 2, which states that there shall be no running into or roughing the player who kicked the ball.

NEW YORK COTTON
NEW YORK, Nov. 3. (AP)—Bullish from an early decline in the cotton market were followed by renewed weakness today. After a decline of 1/8 to 10/16, January advanced to 21 1/8 and closed at 20 3/4, compared with 20 5/8 at the close of the previous day. The general market closed barely steady, at a net decline of 1/4 to 3/8 points, late months being relatively easy.

WOOL MARKET
BOSTON, Nov. 3. (AP)—Wool trading continued slow and spotty. A few sales are reported at prices as high as the recently quoted maximum range. 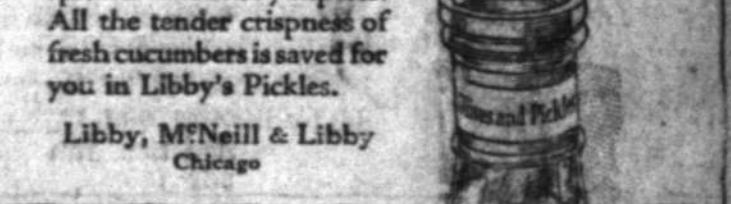

Statements designed to show action between Day and Sinclair were furnished by Eugene Blauvet, who told Neil Burkishaw, assistant district attorney conducting the grand jury investigation that Day had employed him to drive Sinclair about Washington in a high priced automobile.

The record as it stands in the district attorney's office is that Day first communicated with Frank T. Hurley, agent here for the Lincoln Motor company in an effort to hire several automobiles for 30 automobiles. He was referred to Blauvet, who said he went to the Mayflower hotel, where Sinclair had his headquarters during the trial, and was directed to a room in which there were several men. He agreed to hire himself and a car for \$27 a day.

Drive For Sinclair. Blauvet told Burkishaw that he drove Sinclair to and from the court and to the Metropolitan club and various other places; that he did not go to the home of Donald Woodward, wealthy Washington merchant, where it is charged Day got his reports from the detectives. On at least one occasion, Blauvet said, he changed the license number on his car, but added, Day had told him to do this; he had acted because he had a private tag on the car and was apprehensive that he might get into difficulties with the authorities.

The trial in Woodward's home was followed by news of Lincoln's automobile. Roberts told authorities that on several occasions the same car bearing different license tags on almost each occasion had been seen going into LeRoy place which is a short street in a fashionable residential section.

DUNDEE FAILS TO APPEAR, ACE ASKS TITLE

(By Associated Press) WIGLEY FIELD, LOS ANGELES, Nov. 3.—When Joe Dundee, welterweight champion, failed to show up in the ring here tonight, Ace Hudkins, the challenger, left the ring at the order of his brother, Manager Clyde Hudkins. The latter declared he would claim the forfeit money.

Hudkins had entered the ring at 10:30 preceded by two policemen and a huge floral horseshoe. After further delay Tom Kennedy of Los Angeles, one of Hudkins' handlers, announced that Dundee had not arrived at the field and that the Nebraska claimed the welterweight title.

After Kennedy made his statement, Ace Hudkins, with his ring tugs discarded and fully clad in street clothing, stood behind him and nodded assent. Then he left the ring for the second time but still the crowd held its places in the stands and ringside seats on the field.

Ring attendants reported that Dundee had arrived in the dressing room and was waiting his hands preparatory to filling his engagement. This was told to Clyde Hudkins, but the latter was obdurate and led his fighting brother protesting back down the aisle while the crowd stood up open mouthed, waiting for the next development in the comedy of the day.

LOS ANGELES, Cal. Nov. 3 (AP)—Max Waxman, manager of Joe Dundee, welterweight champion, declared tonight the title holder would not enter the ring in his title bout tonight with Ace Hudkins of Nebraska unless he is paid the \$60,000 which Promoter Dick Donald in a contract guaranteed him.

Waxman said he could produce Dundee within 15 minutes of the time the money was paid him. Sixth W. P. Strelinger, commissioner of the state athletic commission, declared that the only contract on file with that body was one guaranteeing Dundee only a per centage of the gate. This, he said, conformed with the rules of the commission whereby no fighter could be made a guarantee.

If such a contract as Waxman describes exists, Strelinger said, it was on the side between Dundee's manager and Donald.

been tried in "conformity with the constitutional and statutes of this state," and added that "I do not consider that I shall delay the execution of the sentence of the law in order that application may be made for the purpose of raising questions of law which seem to have been disposed of by our courts."

Millikin was found sane Tuesday by a Caldwell county jury and was started back toward the electric chair by the verdict. Three times he barely had escaped death through reprieves by Governor Moody, the last of which was based on the action of the court of criminal appeals in ordering the sanity trial. The others had been granted to allow him more time to prepare pleas for clemency.

Throughout his last trial, and after the decision, he declared his innocence of the crime and professed an abiding faith—engendered, he said, by messages from the "spirit world"—that he would not die in the chair.

Millikin was sentenced to death November 11, 1926, by District Judge M. C. Jeffrey before whom the sanity trial was held. The case was transferred from Comal county, scene of the killing.

Allegations of prejudice in Caldwell county on account of the murder trial figured in unsuccessful defense efforts to have the venue changed again for the sanity trial. The defense also attacked the three removals of Millikin from Lockhart to Austin for sanity examinations before and during the trial for lunacy.

In refusing to grant Millikin commutation to life imprisonment, Governor Moody some time ago declared that the murder trial evidence left "no reasonable doubt that he is guilty."

HUNTSVILLE, Nov. 3 (AP)—Non-chalant and unshaken, A. V. Millikin, submitted coldly Thursday night to shaving of his head by the prison barber in preparation for execution in the electric chair shortly after midnight.

The prisoner ate heartily at dinner, and had nothing to say. Several Caldwell county officials and San Antonio newspaper men were here for the execution.

Millikin was to die for the slaying of Mrs. Virginia Petty of San Antonio last year.

to increase production. Same Ratio Applies. The same ratio obligations as to wells outside any of the established pools. Although some operators insisted

that pinching in methods were resulting in the encroachment of salt water in their wells, and that restrictions should be raised for that reason, Collins tonight minimized that situation. He declared, however, that it had been necessary to plug back some of the wells several feet to prevent cessation of production. Collins blamed the artificial means of making wells behk forth large amounts

of crude oil for the encroachment of salt rather than the natural flow of salt water into the wells, which he said was a difficulty in every oil field.

Most of the salt water wells, Collins said, were on the edge of the larger pools and such encroachment was not prevalent; in the wells tapping the heart of the area. Even as the operators were in session came the news that the area had broken the bounds of 400,000 barrels a day, to which it had confined itself for three days.

Production for the 24 hours ended at 7 o'clock this morning was 432,468 barrels, an increase of 11,967 barrels over the preceding 24 hours period.

More Paving Is Ready In Valley

SAN BENITO, Texas, Nov. 3 (AP)—With the completion recently of the first project under the recent \$6,000,000 bond issue, the road from San Benito to Rio Hondo, county authorities estimate that approximately 35 miles additional paving in the county will be open for traffic by February 1, if weather conditions remain favorable. The estimate was announced by the County Judge, Oscar C. Dancy.

This will include the 7.6 miles between San Benito and Rio Hondo, opened to traffic already, the highway through El Jardin, 6.5 miles, to be completed November 14, the Harlingen Rio Hondo road, 9.1 miles; the Barreda road through Los Fresnos (Highway No. 100), which will be paved for 6.5 miles, and is now half completed; the Paredes (in) road north from Brownsville to Highway No. 100, 10.5 miles; the highway from San Benito to the military road, 6.1 miles, and the La Feria—Santa Rosa, Highway, seven miles.

Contracts for paving of additional projects will probably be awarded in January, Judge Dancy stated.

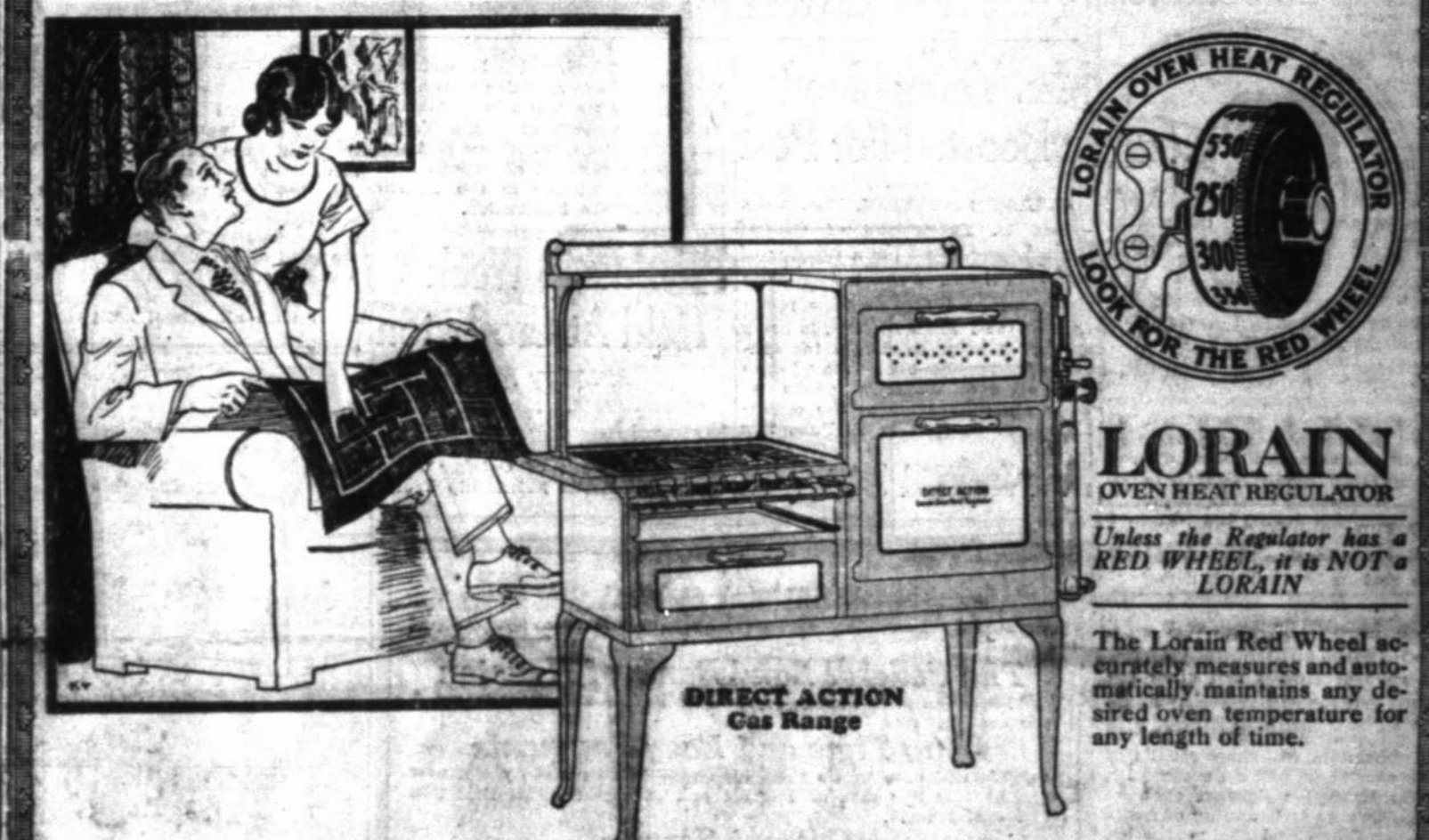
