STATE WINS IN JURY SKIRMISH OVER HICKMAN

PROSECUTION UPHELD IN CLAIMED RIGHT FOR CHALLENGES

HALL OF JUSTICE, LOS ANGELES, Jan. 30.—The right of the State to exercise further peremptory challenges in completing a jury in the sanity trial of William Edward Hickman, kidnaper and slayer of Marian Parker, was upheld today by Judge J. J. Trabucco.

The prosecution and the defense both had accepted the jurors in the box last Friday. But District Attorney Asa Keyes at the resumption of

JURY ACCEPTED

HALL OF JUSTICE, LOS ANGELES, Jan. 30.—A jury of four women and eight men was accepted by the defense and the state shortly before noon today for the sanity trial of William Edward Hickman, kidnaper-killer of Marian Parker.

Judge J. J. Trabucco immediately swore the jury, while the defense entered on the trial record its declaration it was "not satisfied with the jury."

The state protested the motion as unnecessary. Judge J. J. Trabucco denied the motion, commenting it would only delay the trial.

Wash On Stand
Wash then was the first one to take the witness stand, where he pleaded for his motion, declaring the defendant to be without funds, and that he himself was at personal expense handling the case.

District Attorney Asa Keyes inquired if a motion was being made in Kansas City was not paying the expenses.

"That is absolutely false," Wash said from the witness stand.

"I have already used \$600 from a personal bank account, and have a \$300 bill outstanding, of which I expect to recover from the defendant or his family."

Scientific Motives
Wash said in suggesting the calling of three experts from outside the state he was "motivated by purely scientific motives."

Tailor Held After Woman Found Dead

WICHITA FALLS, Jan. 30.—Paul Hunter, a tailor aged about 30 was formally charged with murder in a complaint filed Monday following the death Sunday of Mrs. Fay Robertson, 36, from injuries allegedly sustained when she was beaten in her home a few hours before.

Hunter surrendered, declaring he knew nothing of Mrs. Robertson's injuries but that he had been informed that officers were seeking him in connection with her death.

The body of Mrs. Robertson was sent to Fort Worth Monday for burial. She came here from Fort Worth three or four years ago, authorities were informed.

Bank Closes After President's Suicide

SENECA, Kans., Jan. 30.—The First State Savings bank here failed to open its doors today, pending an examination into the condition of the institution following the suicide yesterday of L. D. Allen, 56, president.

Mr. Allen shot himself through the heart with a 32 calibre revolver in a room of the bank yesterday.

Decisions to make a thorough investigation of the bank's condition before re-opening came today after an early conference between the bank examiner and directors of the institution.

MAN SUICIDES BY BATTERING HEAD THROUGH WINDOW

BALTIMORE, Jan. 30.—Battering his head twice through a plate glass window, then slashing neck and wrists with the glass fragments, a well-dressed man about 40 years old killed himself at the terminal station of the Washington, Baltimore and Annapolis electric railway here today.

A letter in his pocket, signed by William A. Comstock, Democratic national committeeman from Michigan, was addressed to Frank R. Lamb, Rosedale Park, Detroit. From Washington word was received that Lamb had been publicity agent for Detroit in the recent fight to take the Democratic national convention to that city and that he had also been employed as a reporter by a Washington newspaper.

Police found the man with his head through the broken window, slashing at his wrist with a piece of glass, with which he struck at them when they tried to pull him from the window. He was pronounced dead when taken to a hospital.

Two Women Die In Fort Worth Suicide Pact

FORT WORTH, Jan. 30.—A few minutes after taking poison in a hotel room, Mrs. Iva Lee Joiner, 18, Decatur, Texas, and Lillie Show, 17, Robert, Oklahoma, collapsed in a rooming house here before noon today. Both died a few minutes after reaching a hospital.

Brooding over a convict husband and a disappointed love affair were given as the reason for the suicide pact, Mrs. W. R. Thomason, sister of Mrs. Joiner. However, she said that she believed the two girls were joking when they told her that they were going to commit suicide.

Calls Undertaker
After taking the poison the two young women walked into the cafe where Miss Snow sat down on a counter stool while Mrs. Joiner attempted to call her mother in Decatur. When she failed to get immediate connection she switched her call to a local undertaker asking that an ambulance be sent to the cafe at once, declaring that "it would have to hurry to beat the death angel."

Both scribbled notes on card board back of a writing pad. Mrs. Joiner's husband was recently convicted of murder and sentenced to 99 years from Vernon, Texas, Mrs. Thomason said.

MOTORISTS WITHOUT NEW LICENSE ON CARS FACE HEAVY FINE IN ADDITION TO BIG PENALTY AFTER FEBRUARY 1ST

There are approximately 2,300 motorists in the county who have only one day in which to register their cars for 1928 or be liable to a state highway fine of from \$1 to \$250, I. F. Holland, county tax collector, informed the Journal this afternoon. At noon today the total number of cars registered for the year stood at 6,200 while officials estimate that there are between 8,000 and 9,000 vehicles in the county.

All licenses bought after tomorrow will have a penalty of 25 percent attached thereto, Mr. Holland said.

LAST SEEN IN BIG GALE OFF CAPE HATTERAS

WASHINGTON, Jan. 30.—The submarine S-3, sister ship on the S-4, has been separated from the submarine control force en route from Hampton Roads, Va., to Guantanamo, Cuba, and has not been heard from since late Saturday.

The navy department was informed today that the S-3 was lost from the rest of the force at sunset Saturday about 100 miles south of Cape Hatteras and had not communicated with anyone up to 2 o'clock this morning.

Other Ships in Hunt
The aircraft carrier Saratoga, the tender Caniden, and the seven other submarines making up the force en route to Cuba are searching the vicinity.

The ship commanded by Lieutenant P. W. Warren of Springfield, Ill., disappeared from view of the other vessels during a rain squall and a heavy gale. Although some apprehension was felt, it was said at the department that disappearances of this kind are not unusual and generally the vessels later turn up all right.

40 Men on Board
On board are three officers, four chief petty officers and 33 men. The officers are Lieutenants W. F. Weddler, Charles B. Garvin and Jose M. Cabanillas.

The water where the S-3 is missing is reported to be almost two miles deep.

Officials expressed the belief that she would be found shortly.

The control force left its Hampton Roads base Friday for Guantanamo to participate in winter maneuvers.

Smoke Filled House Brings Fire Alarm

The smoke filled building of the Southwestern Bell Telephone company caused a fire alarm at ten o'clock last night. Investigation by members of the fire department resulted in the discovery that the thermostat heating control in the basement was out of order. The building being too warm, the control had shut the fire off and the fire-light had gone out. Later with the lowering of the temperature in the building, the control had turned more oil into the burner which only created a smoke in the heated furnace.

New Discovery Of Gas Believed Made

NEW YORK, Jan. 30.—O. R. Seagraves, president of the Houston Gulf Gas company reports that withdrawals from the eight new wells in the new Refugio field, averaging a volume of fifty to sixty million feet apiece indicate discovery of the most prolific sands yet penetrated in the great southwestern area of Texas. The company has twenty additional wells ready for completion of the lowlands under the 2,000 acres the company controls.

Motorists Without New License On Cars Face Heavy Fine In Addition To Big Penalty After February 1st

In the meantime, John C. Keller, state highway license inspector for this district, will renew his work of making arrests on all cars not having the new license plates. CHICAGO BANK EMPLOYE HELD IN GIANT RAID

KIDNAPED AND FORCED TO AWAIT OPENING OF TIME LOCK

CHICAGO, Jan. 30.—The "kidnaping" system of bank robbery used for the third time within a month in Chicago today netted its practitioners \$35,000. James Dillon, teller of the Industrial State bank of Chicago, told police that he was held a prisoner in the bank all night while his four captors waited for the time lock in the vault to open at 7 a. m.

The quartet escaped after looting the vault, leaving the cashier bound and gagged in the bank.

Kidnaped Sunday
Dillon, 22 years old, said he was kidnaped while returning from church at noon yesterday by two men who forced him into an automobile, threatening to shoot him if he made an outcry. He said he was taken to a small garage and kept for six hours, then was forced to call his landlady and inform her that he would be out for the evening playing cards, after which he was taken to an apartment and finally to the bank which he was forced to open at 6:30 o'clock last night.

He was taken inside and a negro porter was seized, the robbers standing watch over the two until the time lock was released. The robbers bound their victims before leaving but Dillon crawled to a telephone and knocked the receiver from the hook which resulted in the police being notified.

Third Raid Recently
It was the third such robbery here in the past month. Eight robbers by a similar ruse obtained more than \$80,000 from the Ravenswood National bank. Last week men believed to be the same robbers obtained several thousand dollars after kidnaping the president of a small west side bank.

Highway Division Engineers Gather

AUSTIN, Jan. 30.—The seven-member highway division of the state highway department met here today with the highway commission to take stock of their work up to date and plan for the coming year.

The commission also opened bids on the 19 remaining miles of concrete to complete the Galveston-Houston highway. Ten miles are in Harris county, three in Galveston. County officials for both counties were here.

FUND ASKED IN CONGRESS FOR FIGHT ON WORM

\$400,000 IS NEEDED FOR PEST IN TEXAS, IS COOLIDGE'S PLEA

WASHINGTON, Jan. 30.—Supplemental appropriation of \$400,000 to fight the pink cotton worm in Texas was asked of Congress today by President Coolidge.

The President in his communication to the House recommended that \$100,000 of the appropriation be made immediately available to meet an emergency caused by new outbreaks of the pest. The money would be supplied by the agriculture department appropriation bill.

May Involve Five Counties
Accompanying the President's communication was a letter by Director of the Budget Lord which said the outbreaks of the cotton pest had occurred in the western part of the state involving three and possibly five counties. He added that "the seriousness of the present outbreak is that it is in the beginning of continuous cotton cultivation and unless control measures are promptly undertaken presents a great menace not only to the cotton areas of Texas but to the entire cotton belt."

Plan Clean-Up Provided
The appropriation provides that the immediate fund of \$100,000 be used for a complete clean-up of all farms and cotton oil mills prior to the emergence of the boll worm moth and for an intensive survey of all counties surrounding the infested area as a basis for quarantine lines. The entomologists of the agricultural department "are confident that the present outbreak can be completely eradicated." Director Lord's communication said.

Banquet For Real Estate Men Friday

W. A. Thomas of Dallas, president of the Texas Association of Real Estate boards, will be present and will make the principal address. Mr. Hess announced. Robert J. Murray, president of the Lubbock organization, will preside and an interesting program has been arranged. Tickets for the affair are being circulated this week. The banquet will be held at Hotel Lubbock.

Victim Of Gunshot Accident Is Buried

DALLAS, Jan. 30.—Charles Brown Jr. 3, who was killed instantly yesterday by his brother, Elton Llyard, 2, as they played with their father's pistol, was to be buried here today.

The older boy was killed when he was playing with his brother, thinking he was playing with a toy pistol, pulled the trigger of his father's weapon. A bullet pierced Charles' lung, and he died instantly.

The two boys had arisen early, and were searching for candy their father had hidden in bureau drawer when they discovered the pistol. Their parents, both asleep in the same room, did not know the children were awake until they were awakened by the discharging pistol.

Infant Dies When Fire Wrecks Home

SAN ANGELO, Jan. 30.—Vivian Cardiel, age six months, was burned to death in a fire that badly damaged the home of her parents, Mr. and Mrs. Victor Cardiel, here today.

Mrs. Cardiel was at a grocery store when the fire broke out, and upon her return was met by a wall of flame from the room in which she had left the baby.

SOUTHLAND BOY FOUND BEATEN IN AUTO AT SLATON

(Special to the Journal)
SLATON, Jan. 30.—Dorson Hammett, 17-year-old Slaton high school boy whose home is in Southland, was found lying in the back seat of his car in an unconscious condition and nearly frozen at 5 o'clock yesterday morning. The boy was badly beaten and had severe wounds on his head and face. He was brought to Slaton by a passing motorist.

As he had not yet gained consciousness today, the story of how he was beaten could not be determined. The boy had started for his home in Southland late Saturday as was his usual week-end custom.

Local physicians have little hope for his recovery. He is partially paralyzed, they report.

Highway Club Proposal For Revenue Given

FORT WORTH, Jan. 30.—A \$100,000,000 road bond issue for Texas advocated by the Highway Club of Texas will be retired by the special gasoline tax now in effect and not from ad valorem tax, it was announced today by W. T. Wheeler, general manager of the club.

A statement issued by Wheeler today in connection with the club's proposal for state and county roads for county. This, Wheeler explained, means that the state roads will be built by the state and federal government and the county lateral roads will be built by local revenue, which includes automobile taxes, road and bridge taxes.

"Under the Highway club plan the state will be enabled to connect up the cardinal highways without a big expenditure of the counties or the floating of big bond issues to connect them."

"At no time has the Highway club advocated an ad valorem tax for this work and speakers already have been engaged to tour the state in the interest of the statewide bond issue to remove from the public's mind such propaganda as is being spread by aspiring politicians," Wheeler said.

Baptists To Hold Rally Here Friday

Approximately six hundred South Plains Baptists are expected here next Friday for an all-day rally at the First Baptist church in the interest of the "Conquest Campaign" of the church.

Dr. S. P. Groner of Dallas, secretary of missions in Texas, and Dr. G. L. Yates, pastor of the First Baptist church, Amarillo, are to be the principal speakers. Rev. W. A. Bowen, pastor of the local church, announced this morning.

The "conquest campaign" is a three-year movement in the Texas association of Baptist churches designed to liquidate indebtedness on Baptist institutions in Texas. Last year initiated the campaign.

One Held Here With Bottle Of Extract

A small bottle bearing a label, "useful and economical flavoring for cakes, jellies, etc.," explaining the condition of one Lubbock young man who was lodged in the county jail by members of the sheriff's department Saturday night. According to the officers, the young man was "all flavored up" with imitation Tutti Frutti, a flavoring of 60 per cent alcohol.

Another small bottle of the "Even your best friends won't tell you" content was also found on the young man's person.

Tax Penalty To Be Added After First

A penalty of ten per cent will be charged on all state county, city and school taxes paid in the city after February 1, according to statements made by the various collectors today.

Officers of the collectors were crowded with tax payers throughout the day.

Man Dies As Home Destroyed By Fire

FREDERICK, Md., Jan. 30.—Dennis P. Staley, 46, was burned to death early today while drift blocked roads prevented efforts to save his home at Yellow Springs, from destruction. The charred body was found in the cellar after the fire burned itself out.

DIVISION SUPERINTENDENT OF SANTA FE IS SHOT BY FORMER CONDUCTOR WHO SHOOTS SELF

LATE BULLETINS

(By the Associated Press)
TEMPLE, Jan. 30.—K. S. Hull, about 55, division superintendent of the Santa Fe railway, was shot and killed here today at a downtown corner. W. J. Henderson, about 50, former conductor of the same road, was seen to shoot himself just after Hull had fallen to the ground. Henderson died soon after he had been taken to a hospital.

The shooting occurred in front of the Grace Presbyterian church while Hull was on his way from his home to his office. Hull was shot three times.

There was a heavy fog at the time of the shooting, and no witnesses saw the men before the shots were heard. Several persons declared they saw Henderson point his pistol at himself.

Relieved From Service
Henderson was relieved from service with the Santa Fe several years ago when a charge of robbery with firearms was filed against him in connection with the holdup of Coleman Roddy, local department store owner. Henderson was acquitted of the charge, but was not restored to service.

He recently had been employed as a switchman by another railway, but left the employ of that line about two weeks ago.

Hull was one of the most prominent division superintendents of the Gulf system. He began with the Santa Fe as a brakeman on a bridge and building gang at Copperas Cove, soon becoming bridge and building foreman, later superintendent at Beaumont where he was transferred to the Temple in 1925 years ago. Twenty years ago his vision with headquarters here.

Director In Bank
He had varied interests, being a director of the First National bank here, and a member of the Rotary and other organizations.

Hull is survived by his widow and two sons, Cecil Hudson of San Antonio and K. S. Hull, Jr., of Temple. Henderson is survived by his widow, two sons, and two daughters. Funeral arrangements have not yet been made.

Sheriff Dies

ARDMORE, Okla., Jan. 30.—(AP)—Sheriff Sam C. Long of Love county, wounded last week in a fight with bandits who were robbing the Love County National bank at Marietta, died today in a hospital here.

Cosgrave Safe

MONTREAL, Jan. 30.—(AP)—The train bearing William T. Cosgrave, head of the Irish Republic, left the tracks 23 miles from Ottawa this afternoon. Story the car bearing the President and his party remained upright and no one was injured in the car.

The derailment was caused by a switch at Limoges, Ontario. Another train was despatched from Ottawa to complete the presidential party's trip to the Canadian capital.

One of the injured, Arthur Boyd, head of the Ontario branch of the Red Cross, died here today in the locomotive of the train.

In his announcement Mr. Woods declared he was not guilty of any of the charges, that they were the outgrowth of his refusal to be dominated and controlled as county attorney by certain influences and that he wanted a speedy trial.

He asked that judgment on him be reserved until he was "exonerated by a jury."

The Fitzmorris and Reid bombings, the warning that the Lawdell hospital was to be bombed and the telephone threats of Saturday against Mayor Thompson lives have been linked together as part of a "bomb trust" plan to intimidate Mayor Thompson for clamping the lid on gangsters and open gambling.

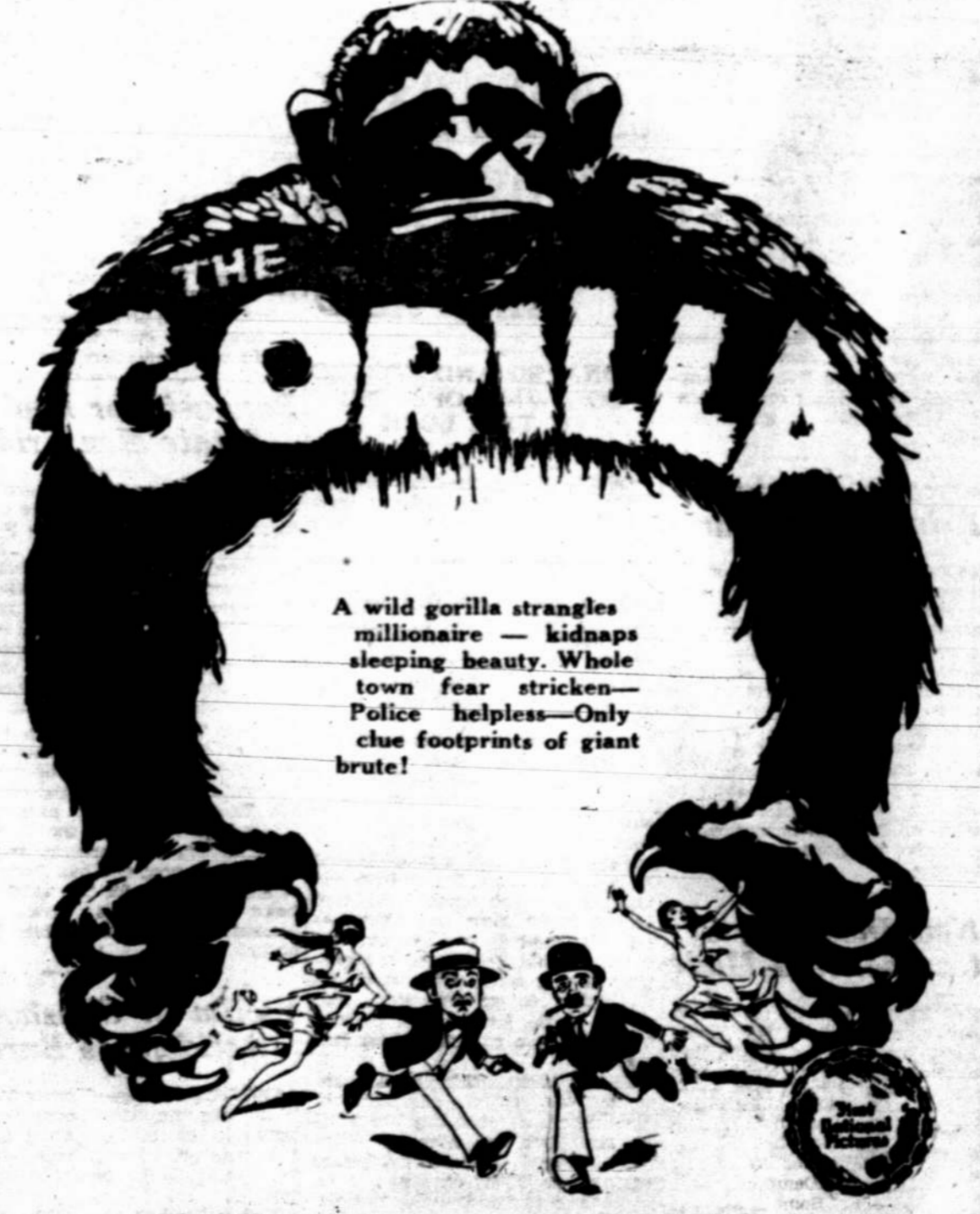

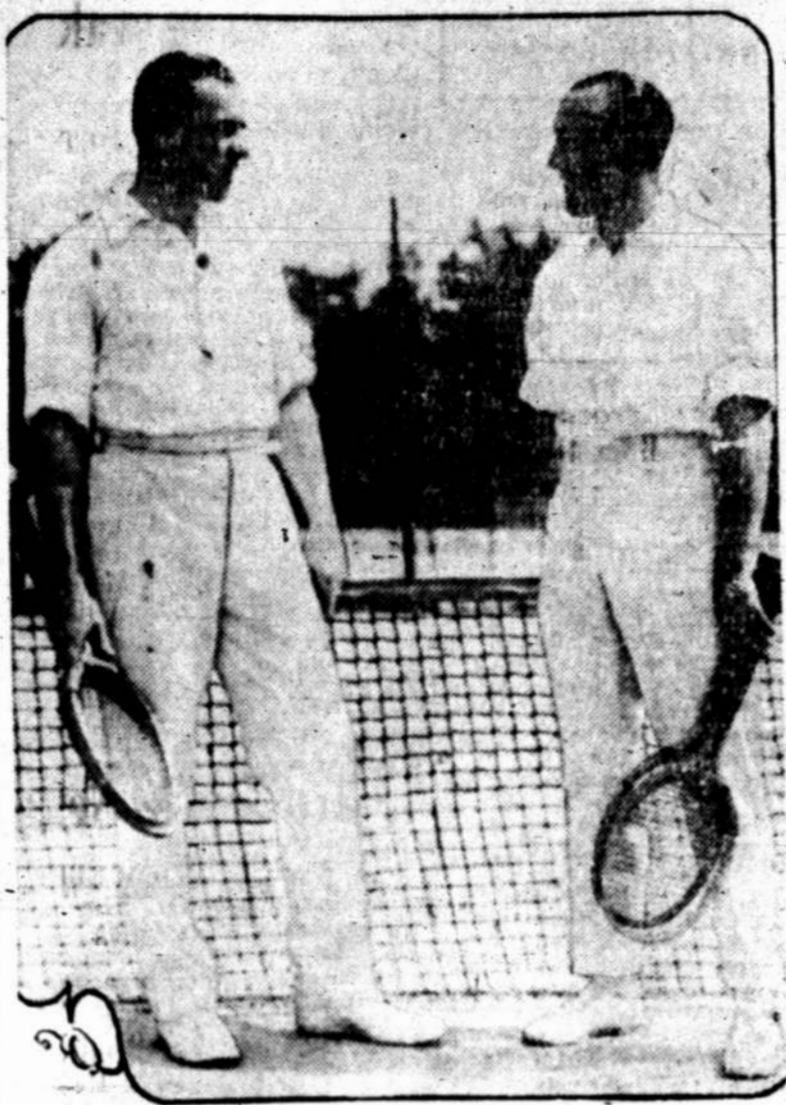

"THE HOUSE THAT JACK BUILT"—THAT NAME HAS BEEN GIVEN THE MADISON SQUARE GARDEN BY DEMPSEY FANS

By HENRY L. FARRELL, NEA Service Sports Writer
NEW YORK, Jan. 30.—Baseball's greatest monument, the million-dollar Yankee stadium, is often referred to by the more practical-minded as "the house that Ruth built." Official baseball does not feel flattered that any individual instead of the great pastime itself should be considered as the inspiration for the greatest plant of its kind in the world.

Perhaps it was the great love of the public for the national pastime and an unswerving faith in its integrity that demanded of baseball such a plant. Perhaps it was merely a coincidence that the stadium happened to be built at the same time that the Babe was lambasting balls all over the geography. And perhaps it was merely coincidental that when the Babe happened to break a record that had been set down as permanent by the Yankee owners found it necessary to spend many more thousands in increasing the seating capacity of that park.

Coincidences as applied to this particular case are the bunk. It was the Ruth who made necessary the erection of the Yankee stadium and who made it pay. These stands in the heart of the playground district of New York, a three-million-dollar monument to the sport of boxing. Tex Rickard's new Madison Square Garden is not solely a fight-arena. It is used for other purposes, as the Yankee stadium is used also for amusement outside of baseball. But it was the profit of big boxing that enabled Rickard to get the backing for the finest enterprise of its kind in the world.

As the Yankee stadium is the "house that Ruth built," even more so, in the last analysis, is Madison Square Garden "the house that Jack built" and the builder, if it be necessary to mention, was Jack Dempsey.

Gene Tunney may be right in his claim that he has a public as large as Dempsey's and that the former champion always was overrated as a drawing card. Tunney may also have just grounds to complain that Rickard is too partial to Dempsey; but listen to this little story and you may understand why the garden was built on Dempsey and why Rickard should like him.

It was back in the early days of 1919, Tex Rickard had the itch to put on another champion heavyweight championship fight. The war was over and the customers were crying for some recreation. Rickard had Jess Willard, the big champion, to use as he wished, but he couldn't find another man big enough and with a reputation to furnish the kind of an attraction he had conceived in his dream.

RICKARD SAYS REPORT ABOUT DEMPSEY FALSE

EX-CHAMPION NOT TO RETIRE DUE TO EYES PROMOTER SAYS

MIAMI BEACH, Fla., Jan. 30 (AP)—Denying Chicago reports that Jack Dempsey had announced his retirement from the ring on account of eye trouble, Tex Rickard, New York boxing promoter, today told the Associated Press "it's an old story." "There's nothing to it," he declared.

Reports Say Jack Barred By Doctors

(By Associated Press) CHICAGO, Jan. 30.—The Herald and Examiner in a copyrighted article today said that Jack Dempsey, former world's heavyweight champion, has been forbidden by his physician ever to enter the ring. The Dempsey telegram informed Rickard that Dempsey's eyes had gone back on him and that doctor's orders prohibited further fighting, the account added.

The Herald and Examiner said it had been unable to corroborate the facts from Dempsey efforts to locate him in California proving unavailing.

The newspaper's Miami Beach informant understood that as a result of the former champion's decision Rickard has finally abandoned hope of rematching Dempsey with Gene Tunney, titleholder, and is looking around for another challenger.

Work Retarded But Report Is Denied
LOS ANGELES, Jan. 30 (AP)—Jack Dempsey today revealed that a recent injury to his left eye had retarded his work toward another attempt to regain his lost heavyweight boxing crown. He denied, however, that the ailment was serious enough to force his retirement from the ring.

Dempsey said a muscle of his left eye had been injured in one of his bouts but that his physician had told him it would not interfere with a return to the ring "if I decide to accept another bout."

"The injury," said Dempsey, "is of such an unimportant nature that I did not mention it when I wired Tex Rickard in Miami that I would not be in condition to accept a bout as June."

"I have been working out nearly every day and physically I feel in good shape, but not quite good enough to take on a match as early as June."

"There has been no definite arrangement between Rickard and myself regarding another title match with Gene Tunney, but we

Good Old Days

Then came the puzzling post-war days, with a sort of melancholy which the average man never could hope to discuss with any sort of fervor. Few Americans ever got really mad discussing reparations or the world court.

But now Congress is debating the tariff. The good old days!

Wealthy Nation

How big is this nation of ours, anyway? Just how extensive are its resources? The House of Representatives has just voted \$89,000,000 to support the Departments of State, Commerce, Labor and Justice during the next year.

This seems like a great deal of money. Yet after all, it is a small sum. It is a mere fraction of our government's total yearly expenditures. No watchdog of the treasury however zealous, will feel that it is too large.

We are a tremendous nation, with tremendous resources. The sum of \$89,000,000—an incalculable sum to most of us—is tossed into our budget as a mere slice of the total.

A Minister's Son

It begins to look as if the minister's son were a much maligned character. The clergyman's committee of the American Eugenic Society has just completed a canvass of 100 leading ministers of America. It has been found that two-fifths of these men were themselves the sons of ministers. Ten more had clerical grandfathers. Both are useless economically perhaps, but either one both present a psychological question worthy of the thought of the wisest of our seers.

After two and a half years of travel, Aime Felix Tschiffely, school teacher and adventurer, has arrived on American soil on his horseback journey from Argentina to New York. The trials and hardships which he has encountered in his long and arduous journey must have been thousand-fold and the risks which he took no doubt outnumber those taken by an aviator, should an aviator attempt a similar journey.

A short time ago Colonel Lindbergh flew from Washington to Mexico City. He made the trip in slightly less than thirty hours and although his trip was not as long as Tschiffely's horseback ride, it serves as a comparison of travel methods of today and yesterday.

Our forefathers, travelling by horse and ox-drawn carts, risked life and limb in their journeys, just as the airman to-day risks life and limb. But the glamour is missing in the old way and only for the reason that it is an old way and we are not accustomed to it. We get right down to the bottom of the thing air travel does not outstrip the travel of other days when it comes to taking risks. We only feel it does because we are used to people riding horse-back or in carts and we are not accustomed to travelling above the surface of the ground. It won't be long before we humans will be accepting the plane with the same abandon with which we now accept the automobile and with which our ancestors accepted the slower, less complicated methods of travel.

John D. Rockefeller, according to James L. Dow in the Morning Avalanche, is out with the statement that "all laws, good or bad, should be obeyed." The Plainsman as usual begs to disagree.

If the law is bad it cannot be obeyed. The public mind, whatever may be its faults, is undeniably fair and a fair mind will never bend to the obedience of a bad law. Al Smith Looks Like A Certainty For The Nomination But You Never Can Tell Is Rodney Dutcher's Opinion

WASHINGTON, Jan. 30.—There ought to be enough sweet harmony in Democratic throats these next few months to drown out the sour notes which unquestionably will echo until the last.

It does seem likely that the Democratic convention will be little more than a ratification of Governor Al Smith and that Reed, Ritchie and the others will have to be contented with promises of cabinet posts or whatever else they decide they want in case Smith becomes able to reward them.

It seems likely, but the gentlemen who predicted a week or even a couple of days in advance the selection either of Kansas City or Houston as the next Convention site may now rise and tell us with certainty just who the two party nominees will be. Does any gentleman rise? He does not.

ONE has a much better chance guessing nominees than one ever had to guess convention cities. And when it comes to guessing as between Democrats, no one now seems to be guessing anyone but Smith.

Guessing as among Republicans is much more difficult. It may be as the Democrats say, that someone pushes a button and then the Republican candidate is nominated. If so, Republican guessing becomes all the harder unless one is so extremely fortunate as to know the button-pushers and learn just what is on their minds.

At this moment some guessers think the button will be pushed for Hoover and others that it will be pushed for Dawes. Some of the Hoover folk seem to be frothing at the mouth in their anxiety to have the button pushed right now, but the button-pushers are in no hurry, and the longer they delay the more guessers will there be to figure that the button won't ever be pushed for Mr. Hoover.

THE double-crossing season has not arrived yet. Being out in front and still not so far out in front as to be without serious competition, Mr. Hoover may be the principal casualty when it comes. Every political year, it should be borne in mind, has its double-crossing season.

In the Republican party, it isn't as if nearly all the smart politicians thought Mr. Hoover would be nominated or as if they thought General Dawes would be nominated. A complete canvass of minds, however, wouldn't mean anything any way, but some of the wise money, if any, is placed on Mr. Hoover and some of the wise money, again if any, is placed on Mr. Dawes.

The anti-Hoover attack, designed to show up what Hooveries like to think of as their bandwagon, has begun, emanating from more or less mysterious sources. He has been assailed in gunshop fashion both through raising question as to his constitutional eligibility and his partisan record.

You have read all about that, but you haven't read who started it. No one attempted to spread the anti-Hoover propaganda thru the medium of this writer and he hasn't inquired as to where it came from, but it is funny how stories will get into the newspapers. There's sure to be more of the same.

HARDLY CONSISTENT

A Mr. William E. Hawkins, who is described in press dispatches as a candidate for Governor this year, says the first message he will send to the legislature, in the event of his election, will be one recommending the submission of a constitutional amendment which will change the term of the governor from two to four years and prohibit his re-election to succeed himself and prohibit him from seeking or holding any other constitutional office for at least a year after his retirement from the office of governor.

Evidently Mr. Hawkins is of the opinion that the governorship should be the ultimate goal of the political ambitions of any man and that he should give no thought to anything but the best service politically beyond the duration of his term as governor. That some holders of public office do neglect their official duties in order to pay more attention to their political interests may be conceded. It is not certain, however, that we should be able to exact the best service from our governors if we were to remove from the office the possibility of holding the office again. In fact, it might be argued with considerable reason to support the view that we are more likely to get the best service from our officials by reason of the fact that their official records will be called in question in their campaigns for re-election.

The test of any measure is whether it makes for better or worse administration. Oklahoma, our neighboring state on the north, has a provision in the constitution which limits a governor to one term in succession, and it is doubtful, exceedingly doubtful, judging from happenings in Oklahoma during the past few years, whether they have any better government than we have in Texas. So if no improvement is to be effected, there is little reason for the change proposed by Mr. Hawkins. Four years, or even two years is too long to keep a corrupt or incompetent governor in office, and if they are corrupt or incompetent, we may do better if the people will not reelect them. If their services are satisfactory there should be no constitutional inhibition against continuing them in office.

A strange phenomena is the zeal which politicians of a certain type profess complete confidence in the ability of the people to govern themselves, and then advocate the adoption of measures which betray a lack of confidence in the electorate.—Vernon Record.

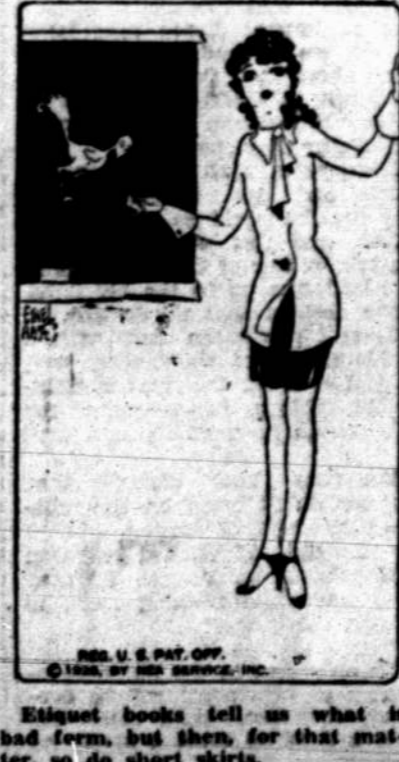

Trabucco reiterated his denial of the motion and in the same sentence ordered the jury returned to the box.

LOS ANGELES, Jan. 30 (AP)—Superior Judge J. J. Trabucco, presiding over the sanity trial of William Edward Hickman, was faced today with the necessity of making one of the first major decisions in the sensational case.

Judge Holds Decision Upon the word of the veteran and energetic judge whose decisions previously in the case came with trip hammer rapidity, rested the question of whether the jury, technically accepted for the sanity trial of the confessed kidnaper and slayer, would be sworn in or whether the prosecution should be granted the privilege of using further peremptory challenges.

The district attorney at the time he asked the privileges of using more of his allotted challenges last Friday, indicated that he might be willing to waive the demand after the week-end adjournment. Last night, however, the prosecution disclosed that it desired to make at least one change in the personnel of the jury and would fight determinedly for the right to do so.

The defense attorneys declared they would take up the battle to keep the present nine men and three women in the jury box, contending that the prosecution had accepted the jury.

Expect Testimony Today Whatever the judge's decision might be, court attaches predicted that the work of definitely obtaining a jury and two alternates would be complete and the first of the preliminary defense testimony—in the form of more than 600 pages of depositions—would be flowing into the court records before the end of the day.

Through these depositions and perhaps through the testimony of Hickman's mother, the defense counsel said, they would attempt to show three generations of insanity in the young prisoner's family—his grandmother, his mother and himself.

He was standing there in the middle of the room, completely enveloped in flames, and I rushed in and carried him out. His clothing already burned half off, dropped to the floor as I reached the front door."

Funeral services are to be held at Elkhart, Texas.

MEXICO IS HOST TO TWO FRENCH AVIATORS TODAY

MEXICO CITY, Jan. 30—Mexico City, which was the first port of call for Colonel Charles A. Lindbergh on his goodwill tour, today entertained two French fliers who plan to make a non-stop flight from here to New Orleans, enroute to New York.

Dieudonne Costes and Joseph LeBrix flew here from Guatemala City, Guatemala, yesterday, covering the 670 miles in 7 hours and 26 minutes. On arrival at Valbuena field they were greeted by President Calles and his staff, Jean Baptiste Perier, French minister, representatives of various South American countries and Dwight W. Morrow, American ambassador. A crowd of 10,000 persons acclaimed them.

Shower of Flowers
Still attired in their flying togs they were driven into the city through a shower of confetti, flowers and colored tape.

Frequently the Frenchmen caught the flowers and tossed them back to the crowd. At the French legation they kissed a number of babies handed up to them by proud mothers.

They said they had encountered some bad weather, with fog, clouds and a little rain.

The Blazing Horizon

THE STORY THUS FAR
The story is laid in the Indian territory and along the Kansas border in the '20's when a fight was being waged for the opening of the territory to settlement.

Chief characters are: **TONY HARRISON**, orphaned at 13 when his father was shot in a poker game; **PAWNEE BILL**, adventurer, teacher, Indian interpreter, showman; **JOE CRAIG**, who takes Tony to the Bar K ranch to live; **TITUS MOORE**, owner of the Bar K brand; **RITA**, his daughter, with whom Tony later falls in love.

Moore is one of the chief opponents of the movement to open Oklahoma. **DAVID PAYNE**, leader of the movement, dies suddenly in a treacherous ambush because of his sympathy for Payne's cause. He tries to forget Rita Moore and accompanies Pawnee Bill and **BUFFALO BILL** on a wild west show tour.

After many adventures he returns, but Rita comes back for a visit and he is unable to keep from declaring his love for her. When she admits she is engaged to another, he leaves the ranch and disappears.

PAWNEE BILL organizes his own show. Tony goes with it. It is Pawnee Bill he is persecuted by the city of Wichita to go there and lead the Boomers into Oklahoma. The fight finally is won. On April 22, 1906, the gun is fired that sends 50,000 homeseekers scrambling over the border in a wild rush. Tony rides on to Guthrie which in one day is springing from nothing to a city of 8,000. There he accidentally gets into the hardware business.

CHAPTER XLIV
Men trudged behind the plow on Oklahoma farms, and in Oklahoma City, Guthrie and other towns the hammers continued to ring as little buildings with false facades reared proudly from street level.

Slowly some of the excitement and furore died in the initial faints of a new land settled down to business. The exodus of the disappointed ones who had failed in the rush to find an unclaimed piece of land was over. Presently more would leave here and there a discouraged farmer would give up in the grim battle to wrest a living from barren land.

Hundreds of the best farms were occupied by Sooners—men who sneaked into Oklahoma by stealth and hid until the opening. Court battles for years but all too often would end in their favor for lack of evidence against them.

Al Little, brother of Pawnee Bill, himself had found a Sooner on his own claim. Neither man would compromise and sell out, knowing that one Sooner would stick with another, even to perjury himself in court.

A people were trying the experiment of governing themselves, hoping that government governs best which governs least. In Guthrie, as in Oklahoma City, Stillwater and other towns, there were marshals to uphold law and order. Federal marshals continued to range the territory, nevertheless the country, and men who had plied their vicious trade along the Kansas border rode south to greener fields.

In Guthrie Tony Harrison found the stimulant he had long needed. He said drifts in the morning town in the role of spectator with only the vaguest notions of finding anything that would claim him; but now he was a part of it all, a force in the building of a new city. Men walked into the little hardware store with money and walked out with tools and beneath their hands Guthrie grew.

And Fred Perkins, his fat little partner, looked ahead. The man had a positive genius for fooling around with figures and estimating costs, and already the firm of Perkins and Harrison had contracted for the erection of two buildings and taken a nice little profit.

"A nice side line, Tony. Some day it will be the biggest part of our business," Perkins and Harrison, contractors—how's that? They'll be another big boom when Guthrie's named capital of the territory; by that time we'll be able to bid for something big."

Harrison smiled. "You're making me rich in spite of myself. I put five hundred dollars into business for which you furnish the material, a site and all the brains—it isn't right."

"Am I kidding? You saved my life. Where would I have been if you hadn't come along and put me on my feet? And about the brains part—don't be foolish. You've provided more than your share of the firm's intelligence, and thrown in more hard work than any two men I could have found."

Which was largely true. Never had he thrown himself more wholeheartedly into any task. He had discovered that salesmanship was something more than standing behind a counter, filling orders, and had gone out and solicited business in large quantities, trading on men's belief in Guthrie's future.

For between Oklahoma City and Guthrie a feud had developed. Each claimed the honor—and the material benefits—of being designated as the capital city when a territorial government should have been established. In their efforts to make an impressive showing, both cities plunged ahead in a wild race to build, to grow to attract more business to them. Trains from the north and south continued to be laden with supplies and with men lured by the far-flung accounts of great cities springing up over night from the plains.

The hardware business took on more ramifications. It became a builders supply house; and while Tony Harrison made his calls in town or, on Cherokee, rode mile after mile to outlying farms to tell

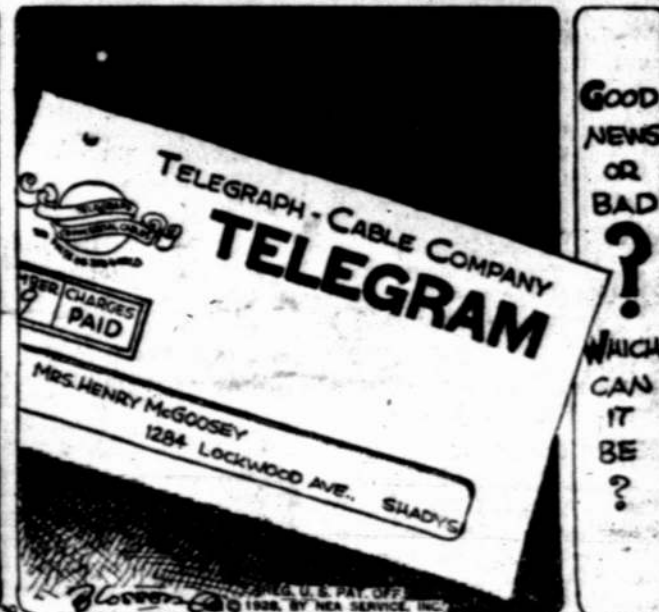

FOREIGN NEWS

Weekly Summation of Events Told By Oscar Watson

By OSCAR WATSON
(Cable Editor of Associated Press)

World economic problems have received an impetus by the Pan-American conference meeting at Havana, which, while having many important questions under consideration, has always in front of it the economic resultant of whatever convention may be adopted of whatever action may be taken.

High tariffs, introduced in the committee discussions of the conference by the Argentine delegate, Honorio Pueyrredon, proved somewhat of a stumbling block last week, and Argentina put herself on record as being unable to sign any convention bearing on the reorganization of the Pan-American union which did not take a material reduction of tariffs into account.

U. S. Dollar Supreme

The former British chancellor of the exchequer, Reginald McKenna, in a speech before the Midland bank at London, placed the dollar ahead of any other unit of currency in the way of purchasing power. He predicted that the United States would be able to continue her credit policies without regard to gold movements and to maintain control over the world's level of prices.

At the Havana conference, the dominating subjects were commercial aviation, tariffs, reorganization of the Pan-American union and regulation of frontier patrols. The United States went on record as opposed to the projected commercial aviation convention as at present drafted, and also to the codification of private international law where this would conflict with the laws of the 48 states in the union. Nor will the United States recognize the right of asylum as a principle of international law, or the right of pursuit across international borders.

May Name Representative

The delegates are agreed that their representative, either their ambassador or minister at Washington, or some other individual to represent them on the governing board of the Pan-American union, which, if the general desire of the assembled delegates prevails, will be kept a non-political body.

Another great continent has taken America's goodwill courier, Colonel Charles A. Lindbergh, to its heart—South America. Cartagena, Bogota, in the republic of Colombia, gave him warm welcome, and the Venezuelan long wishing for him, have prepared to greet him royally. Lindbergh spent last week in the forests of Panama and on the waters nearby, hunting and resting. His game bag was not heavy, but he appeared a very much refreshed birdman when he resumed his journey to South America.

Other air expeditions are in the making. Lieut. James H. Doolittle, who crossed the Andes in a crippled condition and Lieut. Leigh Wade, of world fame, are to demonstrate the superiority of American airplanes in Bolivia, Chile, Argentina and Brazil. The French aviators, Coates and LeBlanc, are on their way north after a marvelous series of flights, starting from Paris, to South and Central American cities.

United States marines in Nicaragua have driven the forces of Sandino out of El Chipote. They are occupying these almost inaccessible heights and laying plans to clear the province of Nueva Segovia of the disturbing elements.

Spain's great writer, Vicente Blasco Ibañez, died an exile, in France. The death of another distinguished man, Major General George W. Goethals, of Panama canal fame, was commemorated by flags at half mast throughout Panama.

Canada will send ministers plenipotentiary to Paris and Tokyo, and the Japanese government has announced that its representative will soon go to Ottawa.

Raid in Mexico

In Mexico the federal government raided numerous schools and convents and arrested several hundred students and teachers alleged to be engaged in propaganda and violating the religious laws by religious teaching and the use of religious emblems, which have been forbidden.

In London the Prince of Wales has endorsed the "Peace in Industry" movement, expressing the greatest satisfaction that employers and employes are beginning to realize that their interests lie in large production and thriving trade.

Buenos Aires, Argentina, has been enjoying a revival of Gilbert & Sullivan operas.

At a whist party at Southwark, England, recently, the winner was named Lucky.

MUCH BUILDING FOR PLAINVIEW NOW UNDER WAY

PLAINVIEW, Jan. 30.—Approximately three quarters of a million dollars worth of building is under way at Plainview.

The major pieces of construction are the Harvest Queen Mills addition to its elevator and storage capacity, and the Skaggs four story office building. Guy B. Speed has practically finished the group of buildings that has been under construction for the past 90 days, and D. M. Thompson and P. Flaxman have finished their buildings adjoining the Speed buildings. Speed's buildings, among other things, will house the Plainview postoffice, and new fixtures are being placed now in the rooms which will be occupied by the postoffice.

Cost Added to Mills

The Harvest Queen Mills is adding a unit to its elevator storage bins which will bring the capacity of the storage facilities to a million bushels of grain, or double the capacity. The approximate cost of the construction is about \$250,000.

The excavation for the basement of the Skaggs building is finished and the foundation is being poured. The building is designed to house the Third National bank on the first floor, and will have up-to-date offices on the other three stories. This building will cost approximately \$200,000 when completed.

Forty residences in various parts of the city are under construction or nearing completion.
