Girls 5th In Snyder Meet

Colorado High School girls track team placed fifth in the Canyon Reef Relays in Snyder Saturday with a team total of 59 points.

Girls coach Carol Dakan said that the girls did O.K. in the meet against AAA and AAAA schools. Snyder, Breckenridge, Big Spring, Ector and Brownfield were competing, along with Colorado City.

The 440 and Mile relay teams set their best time of the season in the meet, both teams placing fourth. Team members in both relays are Maxine Scott, Vicki Lewis, Ginger Noel and Ruby Green. Mrs. Dakan said that Kathy Moore is a regular relay starter in these events but was not present for the meet.

Vicki Lewis was clocked at 11.9 seconds in the 100 yard dash in the preliminaries, a new record in that event for CHS girls, but in the finals, Mrs. Dakan said that somehow Vicki was overlooked, although she finished fourth.

"That happens sometimes," the girls coach said, "and even though it was obvious to me and to some Colorado City fans in the stands, when we got the final sheets back, Vicki was overlooked. I would like for her to get some recognition, though, because she set a new record for our CHS girls."

Body Found North Of I-20 On Iatan Road

A partially mummified skeleton, possibly of a man, was found Tuesday morning under a bridge on the Iatan Road one-half mile north of Interstate 20.

Discovery of the body was

made by Short Womack, a former resident who was on his way to the Iatan community to visit. He reported his discovery to Mitchell County Sheriff Bill McGuire.

The remains were taken

to Austin Wednesday morning for laboratory testing. A wallet found in the back pocket of the jeans was badly deteriorated and no attempt was made to open it locally in order to preserve any shreds of identification possibly inside.

"We don't have any idea as to the identity," McGuire said. "We'll be checking through records of missing persons and the lab tests will show if there was any foul play. As far as we know, it could have been someone hitchhiking on I-20 who crawled under the bridge and died."

The body had been dead and exposed to the ravages of weather for at least a year and maybe more. Trash had been thrown into the deep ditch on each side of the bridge and it was only by going under the bridge that Womack made the discovery.

Pieces of clothing on the skeletal remains indicated the body was a man wearing jeans and white sweatshirt, but that was a guess and not definite. No guess could be made as to age.

A Kiker-Seale ambulance was called to the scene of the discovery and the remains

arranged for testing in Austin.

Following Womack's call to the sheriff's department, McGuire and Deputy Jim Reynaud went to the Iatan bridge to investigate the area but found nothing that might have meant foul play.

The body was lying in a protected area underneath the bridge near a brace in a position that indicated reclining, head slightly higher than feet and feet crossed in a relaxed posture.

"We were afraid to try to open his wallet to see if there was any identification. If there is something and by

forcing it open, we destroyed it, then we would never know. They can find out what's in it in Austin and let us know in just a few days," Reynaud said.

"We'll be looking into every possibility," Sheriff McGuire said, "including the possibility that it was someone killed somewhere else and dumped in the remote Iatan area, but as far as we know, it couldn't have been anyone from around here or else they'd be reported missing."

ASCS Sends Reminders

Letters to about 25 farmers were mailed from the ASCS office this week, requesting that they come to the office and sign yield cards.

Joan McColum, program assistant, said that low yield or disaster payments cannot be made until the yield cards are affirmed.

ASCS executive director Don Stewart also said that reminder notices were mailed so that producers who have damaged terraces and have not yet applied for ECM (Emergency Conservation Measures) funds, might remember to make application for the cost-share money.

County Court Cases

--Jay Bob Dement, charged of criminal mischief filed Jan. 2, tried March 12. Entered a plea of guilty and was fined \$50 and paid \$46 court costs, sentenced to 60 days in county jail, probated for six months.

--Benny R. O'Dell, charged of theft by check over \$20 but less than \$200 filed Jan. 28, case heard March 10. Entered plea of guilty and fined \$10 plus \$46 court costs. No sentence passed but notation of restitution.

--Louis A. Franco, charged of possession of marijuana less than two ounces filed Feb. 6 and heard Feb. 20. Entered a plea of guilty and was sentenced to 60 days in jail, required to pay \$46 court costs.

--Two separate charges filed against Leroy Lydia Jr. March 15: possession of marijuana less than 2 ounces and driving while under the influence of drugs. Hearing pending.

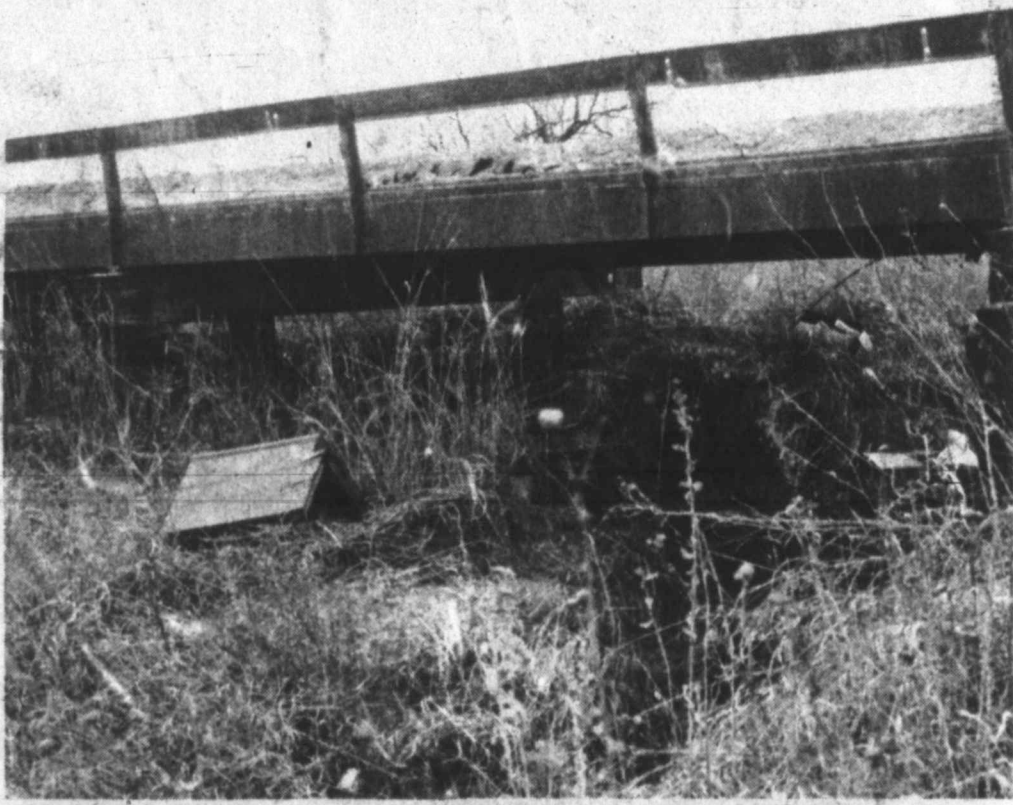
--Seferino DeLapaz charged with evading arrest and driving while intoxicated filed March 15. Pled guilty to both charges and was fined \$50 on the evading arrest charge, fine and sentence waived; fined \$50 and \$46 court costs on the DWI charge and sentenced to 60 days in jail, probated for one year.

--James Ray Green, also known as James Ray Clary, charged of knowingly and intentionally threatening another, to wit, Pam Clary, with imminent bodily injury filed March 17.

--Joe Tom, charged with theft of a shop-made tank valued at \$116.05, filed March 19.

--Johnnie Mae Hardin, also known as Johnnie Mae Jackson, charged with obtaining assistance by false statement, filed March 17.

No disposition has been made in the more recent cases but will be heard by Mitchell County Judge Bill Carter at a later date.

Suit Claims \$12,878 Loss

Royce Mahon of Loraine has filed suit against the Indiana-based Elanco Products Co., makers of Treflan, claiming more than \$12,000 in damage for crop failure allegedly caused by using the herbicide.

Mahon states in his suit that he put Treflan on 50 acres of his land in March 1974 and planted cotton in May. Then one year later he said he planted a hybrid sorghum crop, noting the herbicide directions which said that no sorghum or oats should be sown until 12 months after the Treflan was applied.

Mahon said some of his

crop died and growth of the remaining plants was retarded, although the sorghum was planted 14 months after the Treflan was applied.

The suit states he contacted an Elanco representative who told him to replant the crop.

Mahon said he did this, but alleged the crop failed again. He estimated his alleged loss at \$12,878.

The suit was filed in 32nd District Court Jan. 28. Motion to transfer the suit to Federal District Court in Abilene was filed March 11 but no order of removal has yet been issued.

Wind From Northwest

If wind drift at sunrise following the first full day of spring is any indication, then Mitchell County is in for an average crop year in 1976.

The annual Taba'na Yuan'e ceremony, according to Indian legend a prediction of crops for the coming year, showed a wind drifting from the Northwest this March 22 at sunrise.

A northwest wind indicates an average crop year ahead.

Smoke from a small twig fire just as the sun came up over the horizon showed a definite drift from the northwest toward the southeast in at least two different spots in the county this year.

Council Reviews \$800,000 Budget

The City Council of Colorado City Tuesday night reviewed a proposed budget in excess of \$800,000 for the 1976-77 fiscal year which begins May 1.

The proposed budget includes a 40¢ tax increase as proposed in the March 6 bond election in which voters approved four out of five issues. The only issue turned down was for \$75,000 for park improvements. The four issues approved by voters totaled \$825,000.

Of that total, \$400,000 was for street improvements, \$25,000 for work at the cemetery, \$250,000 for water system improvements and \$150,000 for sewage treatment plant renovation.

The proposed budget will be acted on during the council's regular monthly meeting Monday, April 12 following the April 3 council election.

Under the proposed budget as prepared by City Manager James Campbell, anticipated revenues and expenditures include the following:

--General Fund, revenues of \$526,800 and expenditures of about \$525,000.

--Water & Sewer Fund, revenues of \$291,100 and expenditures of about \$284,595.

--Revenue Sharing, revenues of \$30,086 and expenditures of \$27,900. (These figures do not reflect monies that will be received by the city if Congress agrees to extend the revenue sharing act. The existing revenue sharing act expires in December and the amount budgeted by the city is only money that the city will receive under the existing revenue sharing act.)

The proposed budget con-

tained no surprises. It provides for pay raises for city employees as set out in a pay merit plan approved by the council last year.

The budget does not reflect monies to be spent under the bond program but does reflect monies that must be paid toward paying on the bonds.

Regarding the bond issue, Campbell reported that the city should soon receive its credit rating and will be able to put the bonds up for bid in early April.

Purchases of new items under the proposed budget includes two new pickups, one for the water department and one for the street department, two new police cars for which the council has authorized Campbell to seek bids, renovation to a number of city owned pieces of equipment, new water hoses and nozzles for the fire department, new water meters for replacing old ones and a new sewer rodder.

The council also discussed raising the pay of volunteer firemen who now each receive \$2 per call. This does not nearly cover their expenses, Campbell pointed out.

This item will be explored in more detail later this year when the city renegotiates a contract with the county, Campbell said. The county now pays the city \$45 per call and 75 per cent of the city fire department's activity is on fires in the county, Campbell pointed out. The current contract for the county to provide fire fighting service for the county expires in December, Campbell pointed out.

It was also noted that the fire department is seeking a place and equipment to do

repair work on fire department equipment. This request is being looked at, Campbell told the council.

Prior to the budget discussion, the council went into executive session and afterwards announced and voted their approval of a \$1,000 a year pay increase for the city manager. Mayor Larry Hamner, speaking for the council, expressed the council's appreciation for the job Campbell is doing.

The council also approved a mobile home permit as requested by Tom Studdard to place a mobile home at East Main & Division.

Rifle Teams Formed

Two 4-H rifle teams, both Junior and Senior age groups, have been formed in Mitchell County.

The 11 Juniors and 5 Seniors will be practicing for competition May 1 at the District 4-H Rifle Meet in San Angelo.

Coach-instructor Ronnie Aston said that the best four in each age group will compete at the district level and the first two teams in district will go on to state level competition.

Travis Turner is Junior leader and Jim Dockrey is Senior leader.

The team will meet each Monday afternoon for practice at various places, Aston said.

"We'll follow National Rifle Association rules and use .22 rifles," Aston said. "Standard 50-ft. targets will be used and fired at from three positions: prone, kneeling and standing."

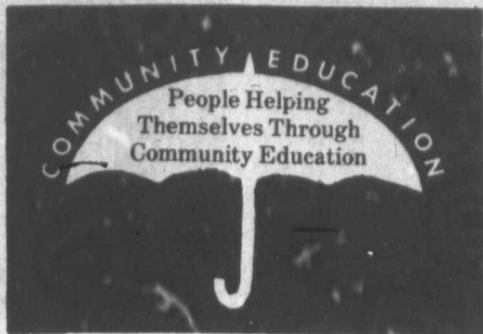
R. M. Reed attended the Mesquite District meeting of P.W.C. Tuesday and Wednesday of last week. They each reported on something which interested them about the meeting.

WHICH ONE ALMOST BECAME AMERICA'S OFFICIAL FLAG?

The "Pine Tree Flag", a simple but dignified flag bearing the device "AN APPEAL TO HEAVEN" appeared as early as 1775 in Boston, and later in 1775 on the sea, the ensign of cruisers commissioned by George Washington. It was both beautiful, and popular — but the pine tree had been so long connected with New England that it was not entirely acceptable as a symbol common to all the colonies.



AN APPEAL TO HEAVEN

The "Rattlesnake Flag" was derived from Benjamin Franklin's famous political cartoon, published in 1754: a rattlesnake, severed in 13 pieces, each bearing the initial of one of the colonies, wriggled over the warning, "Unite or die." Twenty years later, the colonies were united into one fighting unit; the serpent was coiled for attack, hissing the defiant "DON'T TREAD ON ME." While the hissing reptile fit the colonial mood of revolution, it was felt that later, the snake symbol would be offensive.



THE RATTLESNAKE FLAG

The "Grand Union Flag" was raised on January 2, 1776, at Cambridge, Massachusetts, where the militia troops of the colonies gathered to form an army under the command of General Washington. It was raised, in Washington's words, "in honor of the united colonies." But it showed double allegiance - loyalty to Great Britain as shown by the presence of the "Union Jack"; and devotion to the cause of the American colonies, represented by the stripes — "thirteen lists symbolizing the number & union of the colonies."

Texas Taxes

If Congress fails to extend federal revenue sharing, taxpayers of cities and counties throughout Texas may find their pocketbooks a little lighter because of increased local taxes or they may be deprived of services they have come to count on.

Last week House Subcommittee in Congress voted to eliminate small one-function county and municipal governments from the revenue sharing program even if it is continued past the end of the year.

It is a step in the wrong direction for local governments in Texas who are being pushed even closer to the choice: increase taxes or reduce services.

Local officials have been compelled by inflation—which the federal government has been incapable of controlling—to rely on revenue sharing for part of their operating budgets. Now the federal government is thinking about causing their further problems by ending this important source of money.

Revenue sharing, which began in 1972, will end on December 31st if Congress fails to extend the program. The people of Texas stand to lose \$300 million dollars a year.

At least 68 County-areas in Texas would have to increase their revenues by 30 percent or more—some almost 1000 per cent—in order to maintain the present level of services without revenue sharing. Another 196 County areas would face tax increases up to 30 percent.

I think it's time for State government to stand up for the taxpayers of Texas and support the needs of grassroots government in this State. Texas ranks 46th of the 50 states in financial assistance to local governments.

The first thing leaders at the State level can do—and it won't cost State government much—is fight for an extension of revenue sharing past the end of the year.

If we don't do that, the Legislature may have to start figuring where the money is going to come from to bail out our cities and counties. Any way you look at it, the taxpayers will get hit with higher taxes if revenue sharing is abolished and they want to keep having their garbage picked up.

It's fine to talk about no new taxes and to criticize the concept of the five-year-old federal revenue sharing program, but it's time for all of us to be realistic and practical about the matter.

A vote in Congress for extension of revenue sharing is a sound and constructive step in avoiding the need for new taxes at the State and local levels in Texas.

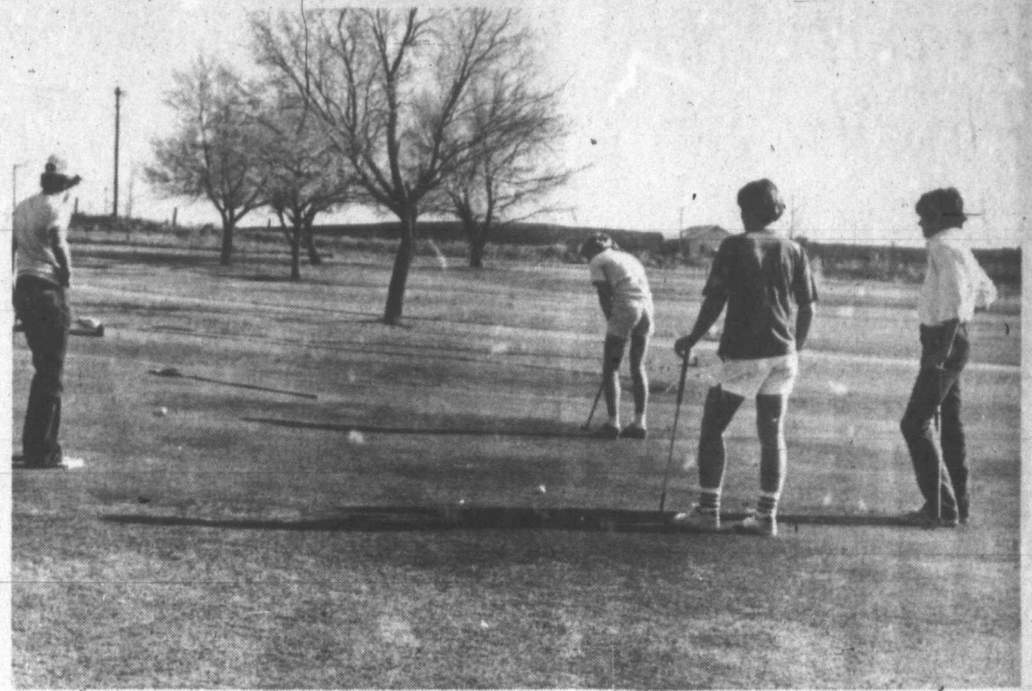

day Girl Scouts of America" and blew out the candles. Following this ceremony the buffet meal was served.

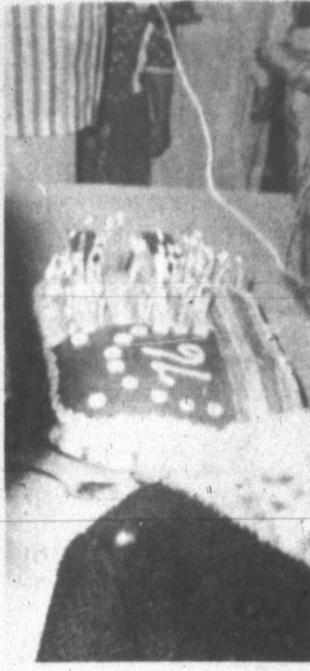

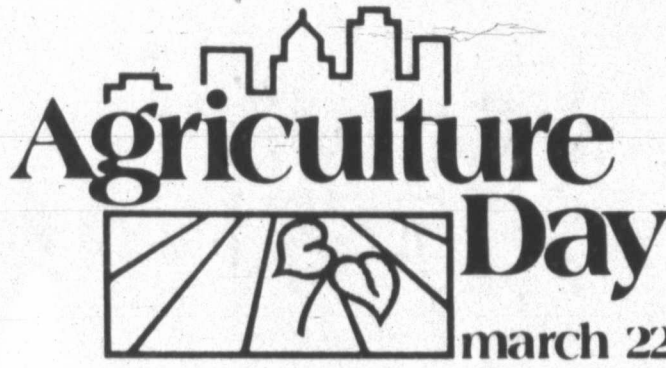

The meeting held at the Houston Oaks Hotel, was attended by members of 66 Federal Land Bank Association in Texas. There were about 550 persons in attendance.

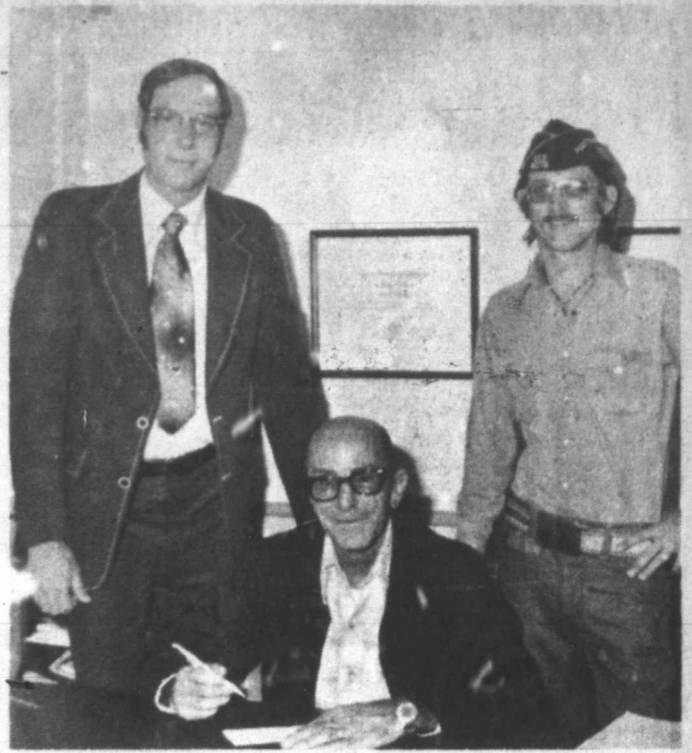
George W. Cunningham, President, in his annual report to stockholders, re-

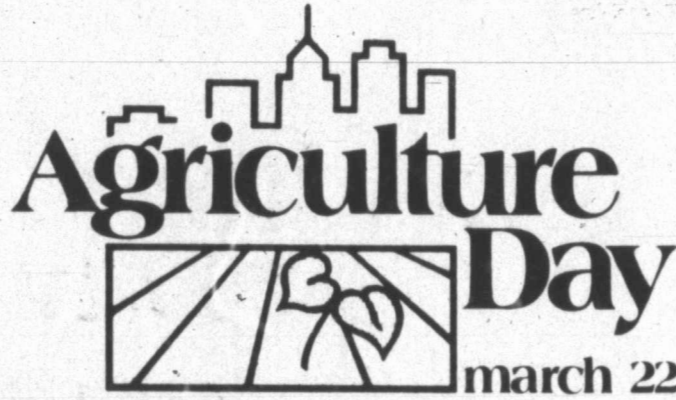

For the home gardener who wants a "day-to-day" plan to follow throughout the year, the Texas Agricultural Extension Service has the answer—a new "Garden Calendar."

The calendar has just been published and is available from the Department of Agricultural Communications at Texas A&M University for 25 cents per copy, announces Bob Benson, county Extension agent.

Benson describes the new calendar as a daily guide that lets the gardener know "When to do what" for a successful garden. The calendar also features a list of recommended vegetable varieties for this particular area of the state along with a planting guide which provides such useful information as row and plant spacings, time required for crops to mature, and expected yields.

The "Garden Calendar" deals primarily with vegetable gardening, but also includes timely hints on growing fruit and nuts, shrubs, flowers and lawn grasses, points out Benson.

Since the key to a successful garden often hinges on doing the right thing at the right time, the "Garden Calendar" should be just the thing for most home gardeners in Mitchell County, believes Benson.

Social Security Reports

According to Don Minyard of the Big Spring Social Security Office, Social Security beneficiaries who earned more than \$2,520 in 1975 must report their exact earnings to social security before April 15, 1976.

Minyard explained that this is a separate report from the income tax return that must be filed before April 15. Often people become confused about this report and feel the one report to Internal Revenue Service is sufficient.

If social security is aware that you planned to earn over \$2,520 in 1975 you will receive a form in the mail. If you do not get an annual report form in the mail you may get one from our representative at the contact station in your area.

Our representative will be in Colorado City every Wednesday at the Chamber of Commerce Office from 10 a.m. to noon.

These reports are not difficult to complete but if you feel you need assistance our social security representative will be glad to assist you in completing the form.

It is important that the earnings you show on this report are exactly the same as is shown on your W-2 forms and income tax returns, so be sure to show your wages exactly as your employer showed them on your W-2 form and your self-employment income exactly as it is shown on your income tax return.

Social Security beneficiaries receiving benefits because they are disabled, and beneficiaries over 72 in all months of 1975, are excluded from those who must make an annual report of their earnings.

All others whose earnings exceed \$2,520 are required to complete the report even if they are paid correctly for 1975.

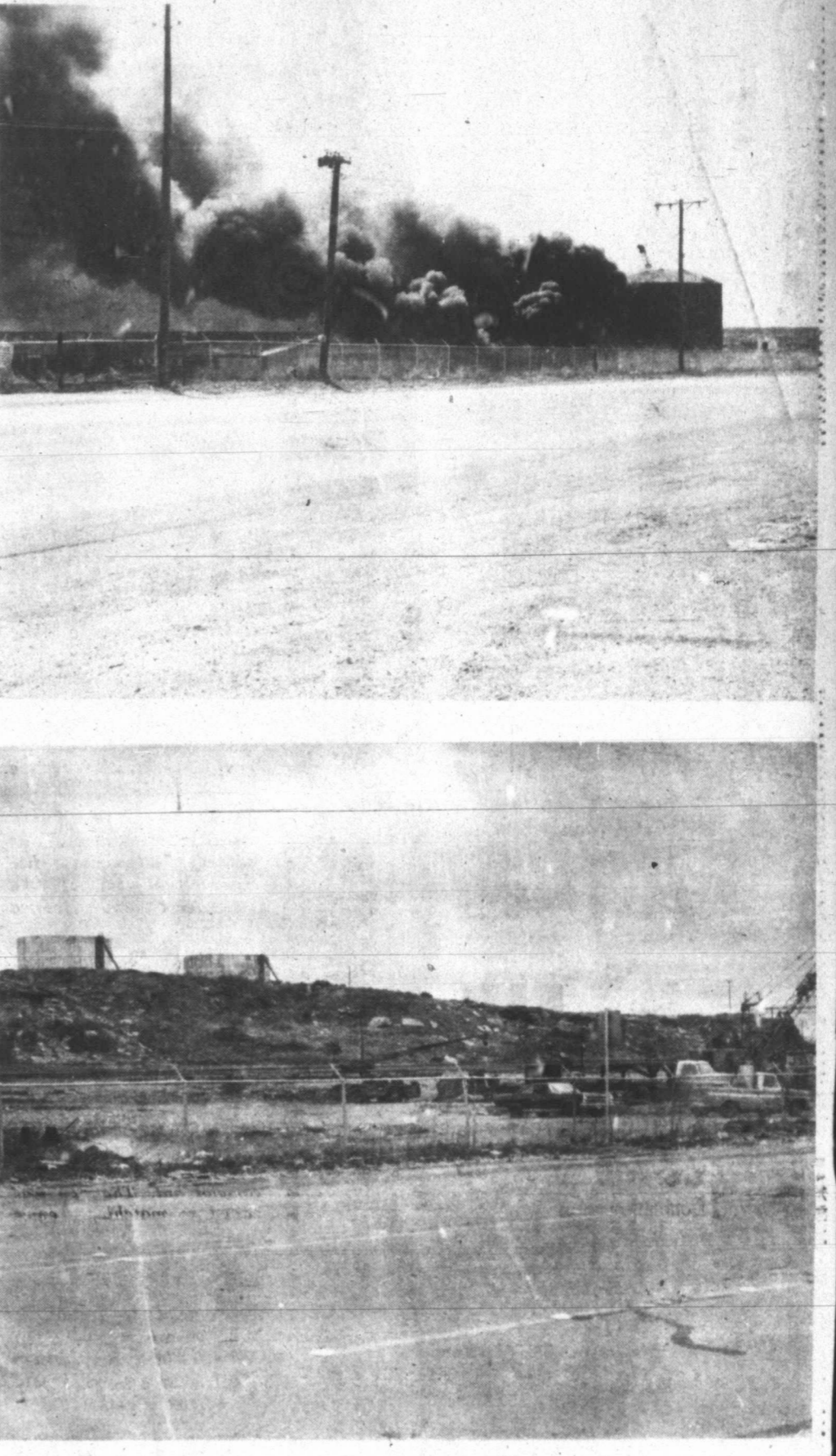
