FIRST DEMO SESSION ENDS QUICKLY

"FIGHT TO DEATH" IS PLEDGED AGAINST AL SMITH

REED AND ANTI SMITH FORCES FIGHT TO END

SENTIMENT BACK HOME COUNTED ON TO AID DRIVE OF DRYS

HOUSTON, June 26.—Battling "to the end of the road," the thin line of anti-Smith forces were counting today on a reaction "back home" to stiffen the wavering ranks threatening to decide the issue for the New York governor in the democratic convention.

It has developed that part of the strategy of the southern drys has been a campaign with home folks, and they insist there has been a veritable deluge of telegrams pouring in during the last few hours to delegates protesting against Smith.

Read Center Of Fight
At the same time, Senator Reed of Missouri, is going ahead with his drive, as he promised and his modest room high up in the Rice hotel continues to be the center of many a conference during the last ditch battle.

Reed and his friends are centering their attention on Oklahoma, always counted by them as their state, which has delayed until tomorrow its decision on how to cast its first vote. Both Smith and Reed men on this outpost delegation of the southern states were claiming victory today. The twenty votes are bound by the majority under the unit rule.

Decisions of Kansas, Texas and Mississippi last night to stand pat for their favorite son in the opening round put new heart into the opposition which is convinced that it is can withstand the New Yorker's onslaught for three or four ballots the tide will turn.

Drys Busy At Work
Down the street away from the bustling bunch of delegates the drys are busy at work. A "pep" meeting yesterday provoked speeches from delegates from many sections with Al Smith as the target.

Among the speakers who are reported to have voiced considerable protest against Smith and Tammany were John A. McSparran of Pennsylvania; C. C. Johnson of

DIRECTORS OF FAIR MEET TO INITIATE WORK

BIGGER, BETTER SHOW PLANNED THIS YEAR IN PLAINS HUB

Starting out on another year's work and preparing to make the "Show Window of the South Plains" a bigger and better attraction for another year, directors of the Panhandle-South Plains Fair association met in a short call session in the offices of the Lubbock Chamber of Commerce yesterday afternoon and discussed plans for the coming exposition. The fair will be held from October 1 to 6.

Four new directors are to be elected by the stockholders of the association this year and eight names were prepared for the election in the meeting yesterday. The eight nominees from which the four directors will be selected are: J. J. Clements, B. C. Dickinson, F. J. Friend, E. B. Green, I. F. Holland, J. A. Hodges, N. L. Peters and W. C. Rylander. Their names will be submitted to the stockholders for balloting soon, it was said.

Hold-Over Directors
The hold-over directors of the association are: Dr. I. E. Barr, A. W. May, Alex McDonald, M. B. Hillburn and S. O. Wilson.

The directors voted to continue the plan of giving an automobile away each day of the fair and Dr. Barr, A. W. May and M. B. Hillburn were selected to arrange for this detail.

Enlargement of the grounds and "widening" was discussed but no definite action was taken; the matter to be referred to the new directors. A. B. Davis, manager, was authorized to secure an assistant to aid him in arranging for the fair. A committee was also appointed to select the various superintendents of the fair.

Light Rains Fall Over South Plains

Accompanied by a colorful display of electrical disturbances, heavy clouds deposited scattering rains over the South Plains last night, according to reports received here today.

According to the gauge at the state experiment station east of town, Lubbock only had .09 inches. Six one hundredths of an inch fell Sunday.

NEWSPAPER IS VICTIMIZED IN BOLD ROBBERY

TRIO JUMP INTO CAR AND ESCAPE THROUGH HEAVY TRAFFIC

SAN ANTONIO, June 26.—Three men held up a messenger here today and obtained \$6,736.68, the payroll of the San Antonio Light.

The robbery occurred at the entrance to the Light building. George Farmer, paymaster for the newspaper, was returning from the bank with the payroll in a bag.

At the building entrance he was confronted by a revolver in the hands of a large man who leaped to the sidewalk from a car parked in front of the building. Two other men were in the car.

Many persons were passing on the street and there were a number of newsmen at the entrance. The bandit backed Farmer into an alley beside the building, seized the money bag and leaped into the car, which sped away and was lost in the traffic.

Miss Boone Given Oxford Appointment

Miss Lilla Boone, member of the history faculty of Texas Technological college, received official notice today of her appointment to Oxford University in England. She will study there on a leave of absence from the Tech next year, working on her doctor's degree in history.

Officials of the Tech were highly elated at Miss Boone's appointment today as it comes as a special honor, not only to her but to the college, as only five women in the United States are eligible for the appointments.

Miss Boone will leave Lubbock in September for England.

TWO KILLED IN 'SUICIDE PACT'

FATHER AND SON ARE FOUND DEAD NEAR NACOGDOCHES

NACOGDOCHES, Texas, June 26.—S. G. Flowers, 73, and his son, Glenn Flowers, 33, are dead as the result of a double tragedy early today at the home of the elder Flowers' niece 14 miles from Nacogdoches.

The father was found on the floor with knife wounds in his throat. The son had two bullet wounds in his head. Justice of the Peace rendered a verdict of suicide in each instance.

Two letters left by the senior Flowers said: "You will find \$10 in my grip. I am ruined and have no home and could not make a living for me and Glenn and can not bear for him to be left as he does not know how to get along."

The two men came here from Nocona, Texas.

Moody Dominant Figure In Houston Convention

Reaps Harvest Today Of Pronouncement On Prohibition

(By Associated Press)
HOUSTON, June 26.—Governor Dan Moody of Texas began Tuesday to harvest the reaction of his prohibition declaration of Monday which put him at the forefront of southern dry leaders.

Soon after he was elected to the democratic national convention platform committee by the Texas delegation which voted in caucus Monday night to support Jesse H. Jones of Houston for the presidential nomination, Mr. Moody began a series of conferences with prohibition spokesmen of other states with a view of definitely organizing support for the dry plank adopted by the Texas state convention.

See Daniels and Glass
The first of the conferences, which will continue until the convention settles the prohibition issue, was with former Navy Secretary Josephus Daniels of North Carolina and Senator Carter Glass of Virginia. They talked at length with the Texas executive at his hotel suite and left with tentative promises to support the Texas dry plank or its substantial equivalent.

Monday night's caucus failed to reveal the actual strength of supporters of Governor Al Smith, the Texas delegation as had been expected.

WOMAN READY FOR SEA HOP

MISS RASCHE AWAITING GOOD WEATHER FOR QUEBEC TAKE-OFF

THREE RIVERS, Que., June 26.—Miss Thea Rasche and the monoplane North Star, purchased for her by Mrs. James A. Stillman were at Cap De La Madeline flying field near here today awaiting favorable weather for a flight to Europe.

The plane was flown here from Hadley Field, N. J., yesterday by Ulrich Koenemann, Miss Rasche's German mechanic who is to be her co-pilot on the flight. The German aviatix came on by train and was at the field when her plane arrived.

Officials of the airport stated that arrangements had been made to fuel the plane here fully for a trans-Atlantic flight and they believed she would make no stop once she took off until she reached her destination, which probably would be Berlin.

The take-off from Hadley Field was made while the temporary injunction brought by her former backers, Howard W. Harwell and the Hollis Corporation, was being argued in a New York court. The injunction was dismissed but Miss Rasche was ordered to post a \$10,000 bond to protect her former backers in case they should win their threatened suit for breach of contract.

KEYNOTE TALK IS POSTPONED UNTIL TONIGHT

MEETING ENDS BEFORE DELEGATES SETTLE FOR FIRST ROUND

SAM HOUSTON HALL, Houston, June 26.—A democratic national convention whose major decisions were all but made before it ever convened began here today in an opening session so brief that it was over before the delegates got settled in their seats.

Leaving the keynote speech, the usual magnet of opening day interest, for an evening session, the convention merely went through the motions of getting itself legally afloat, and then after a session of one minute less than a half hour, recessed until 7:30 p. m.

Al Smith Demonstration
The only convention hall thrill was not a part of the session itself. It was a short demonstration for Al Smith, put on impromptu by democracy from Herbert Hoover's home state of California. The solid Smith California delegation raised a big picture of their man high above their place in the convention floor and a cheer went up to the rafters from the legion of linen-suited Smith men on the sweltering convention floor and their summer clad women companions of the Smith delegations.

Shouts of "no" came from all over the great hall as the chairman announced with the preliminary rapacity of a machine gun that the organization-sponsored motion for a recess had carried. Now that they were at it after many days of travel southward and hotel room waiting, the delegates seemed to like it and want to go on with it, heat or no heat.

Platform Board Busy
A newly appointed platform committee was working forward during the next 24 hours in the hope of getting a finished product, including a prohibition plank that may avoid a floor fight, ready by tomorrow night. Although the convention officials forgot to go through the motions of formally giving convention approval to the new committee, its members already have been designated by the various state delegations and they are ready to go to work informally.

The keynote will be virtually the only business at the evening session. Voting for a presidential candidate probably will not begin before Thursday or Friday.

One-Minute Interviews An Historian Sees Decline Of the Male

Experts in various lines of research are concluding that the long prevalent male sex is fast disappearing. Constance Lindsey Skinner, historian, recently elected Fellow of the American Geographical society, whose first novel will appear soon, has stated:

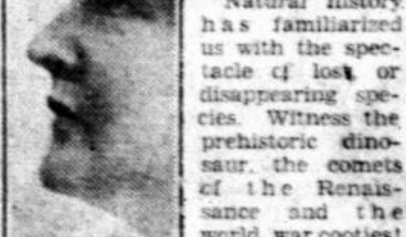
"Natural history has familiarized us with the spectacle of lost or disappearing species. Witness the prehistoric dinosaur, the comets of the Renaissance and the world war costumed."

"This information—that the male of the species is on the wane—may seem unimportant to Americans. For in our present social life, manhood scarcely functions."

"The early American male, the 'hero-man' who became later the 'he-man' of the western plains, is an extinct type now. Modern man runs for his commuting train. When he gets home he watches the woman of the house serve the meal and timidly calls her Momma."

"The manner in which the inspiring oaths of the frontier century have diminished to the butter and egg man's plaintive Momma tells the decline of man."

"All this explains why women no longer need charm. Women always had hard work of life to do but they didn't realize it. They needed charm as an additional asset to win their men. Now, with the departing masculine, it looks like as if charm might be banished from the world, as an anachronism."

PRO LAW HOLDS LONE RIFT IN DEMO'S TANGLE

PLATFORM BUILDERS TO BEGIN WORK TODAY TO DRAFT POLICY

BY JAMES L. WEST

(Associated Press Staff Writer)
HOUSTON, June 26 (AP)—After days of preliminary skirmishing, those charged with framing the 1928 democratic platform turned today to real work with apparently but a single rift in the clouds, a disagreement over the prohibition plank.



Extensive views on the wet and dry question presented by several eastern states on the one hand and the solid south on the other with some prospects that only the convention itself could settle the issue. However, every effort will be made to compose the differences in the committee if that can be done.

Farm Relief Agreement

There seemed to be a very general agreement on the farm relief and other planks in the platform which Senator Key Pittman of Nevada, who is to be chairman of the resolutions committee, said he hoped to hold down to 3,500 words so as to present to the country the shortest party declaration in several decades.

Last minute conferences on the prohibition question were held by Governor Moody of Texas, Joseph Daniels, secretary of the navy in the Wilson administration; Senator Carter Glass, Governor Byrd of Virginia, and Representatives from Georgia, Mississippi and other southern states. All were agreed that there should be a law enforcement plank naming the 18th amendment and pledging the party to its sincere enforcement.

Maryland, New York, New Jersey and several other states were ready for a fight for a plank declaring at least for modification of the Volstead act so as to permit the states to fix the alcoholic content of beverages. It was generally conceded that this plank would be voted down overwhelmingly and at least a general law enforcement plank approved by the committee.

Counter Pleas Seen
Several party leaders expressed the view that should the drys present a minority report to the convention, the wets also would come in with their proposal for modification so that the convention floor fight would be over the very extremes on the question with little doubt that the convention would go on record by a large majority against any changes in the prohibition law.

While a few individual delegates favored a farm relief declaration endorsing at least the principle of the McNary-Hauser bill with its equalization fee, the general opinion was that the agriculture plank would be general in character with the party pledged to use every endeavor to find a solution of this problem.

There was a decided division of opinion as to whether the platform should commit the party to the calling of an extra session of congress if victorious in November for the purpose of dealing with the farm subject. Some leaders, like

SMITH'S FIRST-BALLOT VOTE 50 SHORT, TABULATION REVEALS

OTHERS READY BUT FAVORITE SONS INCREASE

OPPONENTS CLING TO HOPE OF BLOCKING HIS NOMINATION

By PAUL F. RUPERT
(Associated Press Staff Writer)
HOUSTON, June 26.—Alfred E. Smith enters the democratic national convention today with first ballot votes definitely in line for a short of the nominating mark, but he is assured of so many more whenever he needs them that his friends and many of his political foes regard his nomination as inevitable.

Although his managers had given no indication that they were trying to bring about the New York governor's selection on the first roll call, there were predictions that this would happen. They were based on a belief that Smith would be so near the nomination as the initial ballot that an end to many delegates, having discharged obligations by voting for favorite sons, would shift to his standard before announcement of the result.

Cling to Block Plans
From some quarters, however, came forecasts that two or more ballots would be required, and here and there bitter opponents of the New Yorker clung to the belief that in some way he could be headed off.

Overnight, several new favorite son candidates had sprung up to claim the support of some delegates on at least the first ballot. Senator Pat Harrison was put in the field by the Mississippi delegation. The forty delegates from Texas mustered under the banner of Jesse H. Jones, Chief Justice Watts of South Carolina was brought out as the favorite of the 18 delegates from that state. In addition, at caucuses, the Indiana delegation decided to stand by Wyllen, the Kansas delegates by Ayres and the two dozen Tennesseeans by Hull, and the Alabama delegates decided to split their votes among George, Hull, Donahay, Jones and Woodlen.

Lends Encouragement
These developments encouraged some of the Smith opponents, who have been striving to keep enough votes away from the leading candidate to wear down his strength after a few ballots. They also have been hoping that the Arkansas and Oklahoma delegates, at caucuses still to be held, would remain aloof from the Smith camp at least at the outset of balloting.

But the leaders of the movement to make Smith the presidential nominee looked forward with confidence, certain that the Oklahoma and Arkansas delegates would be ready to board a Smith band wagon just as readily as they believe those from favorite son states will when it passes by.

As it shaped up today, with the balloting for a presidential nominee still 48 hours away, the first ballot which have been announced as committed to Smith, either through instructions or by definite pledges given by individual delegates or by authorized spokesmen totalled 687 or 461-3 votes short of enough to put him over. Here they are:

The Smith managers expect to pick up before the window more than enough votes to put their candidate over the 733 1-3 nominating mark from such states as Arkansas, Indiana, Kansas, Mississippi, Nebraska, Ohio, Oklahoma and Texas. The final lineup of the delegations from these states which have a combined voting power of 212, has not been determined.

Crosby County Man Harvests His Wheat

CROSBYTON, June 26.—The first wheat of the season was brought to town off of W. M. Romane's farm just about one mile north of town last Saturday. Mr. Romane has one of the finest pieces of wheat in the county and is making about twenty four bushels per acre, which is mighty good when it is considered that this wheat had practically no rain on it until the eleventh of May. Mr. Romane is not selling his wheat, but is storing it for planting purposes next fall, as there will be a shortage of good seed wheat here on account of the prolonged drought this spring.

SOUTH IS HOST TO FIRST BIG DEMO SESSION

SMITH NOMINATION IS SEEN BY LEADERS AS EARLY BUSINESS

HOUSTON, June 26.—The first democratic national convention to assemble in the democratic south since the civil war was called together in Sam Houston hall today with a Smith nomination as the first order of business.

A final period of pre-convention argument and a caucusing served only to accentuate the dominating position of the New York governor and the protest of many southern communities against his nomination. Despite a southern rally to favorite sons, so great a majority were preparing to go to Smith's support that even his enemies saw but a slender prospect of encompassing his defeat.

Seen As Foregone
Balloting will not begin until late this week, but the opening day of the convention saw the presidential contest taking such definite form that an increasing number of the leaders accepted the nomination of Governor Smith as a foregone conclusion, and centered their attention on the vice presidency. Senator Robinson of Arkansas, democratic leader of the senate, came vividly into the foreground as an available running mate for Smith, his ascendancy completely eclipsing an earlier boom for Evans Woodlen of Indiana.

Under a New Convention Plan
Under a new convention plan, made to order for the age of radio, party managers clipped in two the program for today's noon-day opening session, leaving delivery of the keynote speech, always a first day drawing card, for a second session to be held this evening.

Thus the preaching of this democratic gospel will coincide with those hours when the great audience of listeners-in is at its maximum. The arrangement left for the noon session only a few dry and dusty formalities, consisting chiefly of setting to work the committee machinery by which the convention shifts many of its troubles to other shoulders.

Hall Is Unique
Like the convention it was built to house, Sam Houston hall is in itself a unique embellishment to party history. High against the west wall, at the rear of the platform, a mammoth reproduction of the great seal of the United States stood flanked by 13 American flags to form a background for the scene that are to be enacted on the convention rostrum. Hanging free, high above the delegate section, their poles standing out from the rafters, two rows of state flags formed the center piece among the abundance of color lining the body of the hall itself.

THREE GROUPS OFFER PLANKS FOR PLATFORM

EXTREMES ON WET AND DRY PLEAD WITH CONSERVATIVES

HOUSTON, June 26.—Three widely differing groups of democrats turned today to the resolutions committee of the national convention to fight out the position the party must take on the prohibition issue.

Unable to compose their views in many pre-convention conferences each camp plunged into the fray with a determination to battle to the end for the cause with which their lot was cast.

On the one hand there were the ultra-dry under leadership of Dan Moody, the youthful Texas governor, and others lined up under dry banners were such bulwarks of democracy as Josephus Daniels of North Carolina, secretary of navy in the Wilson cabinet; Senator Carter Glass of Virginia, a former secretary of treasury under Wilson, and a host of other party leaders.

Ritchie Leads Wets
At the other extreme were the wets, insistent upon a platform plank declaring in favor of some modification of the prohibition laws. They were found chiefly under the standard raised by Governor Albert C. Ritchie of Maryland, a champion of state's rights, who has taken the position that the 18th amendment should be given this

power to settle the prohibition for themselves.

In between these two extremes was a far larger group of self-styled conservatives, intent upon the adoption of a plank declaring for rigid enforcement of all laws including the prohibition statutes, but at the same time a plank that would not commit the party to an extreme position upon the one question which above all others has threatened to disrupt the spirit of harmony that has permeated the gathering here, of th democratic hosts for the convention opening today.

Aside from these three main divisions, there were numerous minor groups each with views a tangent like nature and each displaying ardent enthusiasm for their respective positions. This latter class included those who have declared that under no conditions would they support a wet candidate as well as those championing the outright repeal of the 18th amendment.

But out of this vortex of conflicting opinions, there came a positive current of thought which was epitomized by Senator Edwards of New Jersey, an ardent wet, who said that the battle should be fought out behind the closed doors of the resolutions committee and not permitted to reach the convention floor.

Whether leaders would be able to hold the disagreeing groups under control, however, remained a question which no one was able to answer.

Delegates from other states are feeling an intriguing spectacle in the tall, boyish Texas governor, minutely scrutinizing for prohibition as a "moral issue," and yet not giving the appearance of a reformer or extremist. Mr. Moody is sought out frequently by northern and eastern visitors who want to look him up. He also is getting "written up" at some length in the eastern papers.

A lighter turn to the caucus proceedings developed when state highway commissioner, Gene Johnson, objected to consideration of

women as "female citizens" as a class separate and distinct from "male citizens." He was opposing a resolution by Mrs. A. C. Zehner of Dallas, delegate at large, recommending inclusion in the national platform of a declaration for equal representation of women on state delegations. The resolution was defeated by vote of 21-6 to 8-5-6. Johnson's position was that women should earn their places in politics by merit alone. Mrs. Lee Joseph of Austin and Mrs. Jessie Daniel Ames of Georgetown came to Mrs. Zehner's defense.

Moody Wins Selection
Supporters of Governor Moody were chosen for the various other officers of the delegation. Myron Black of Marshall was made vice chairman; Walter Woodward, Coleman, credentials committee chairman; L. D. Davidson, Houston, rules committee chairman; Mrs. Frank Gilbert, Dallas, organization committee chairman; H. P. Horn, assistant secretary to the convention for Texas; Mrs. Lee J. MOODY URGES NO QUIBBLING

PROHIBITION IS GREAT MORAL ISSUE, TEXAS GOVERNOR SAYS

(Associated Press Staff Writer)
HOUSTON, June 26.—Any "quibbling" on the "great moral issue of prohibition is unthinkable," Governor Dan Moody, chairman of the Texas delegation to the national convention, declared today in a formal statement.

"I do not believe," he said, "that the delegates from other sections of the country will be controlled by the few places in this nation that are opposed to prohibition, but it is my judgment that they recognize the serious thought of the south wherein is the heart and soul of the democratic party. No attempt should be made to draw

an overdraft on the democratic loyalty of the south."

The governor is working on a dry plank which he expects to urge on the national platform committee as the Texas member.

"We want agriculture placed on a basis of equality with other business and industries and we want measures adopted that will relieve the millions who toil on the farms from state or practical bankruptcy into which they have been carried under the 'republican rule,' the governor's statement said. "We want the corruption of the republican party denounced and it is sufficient upon which to base an appeal to the people to 'turn the rascals out.'"

"We also want the democratic party to take a forward position on the great moral issue of prohibition upon which the public mind feels with intensity. Any quibbling upon this matter is unthinkable."

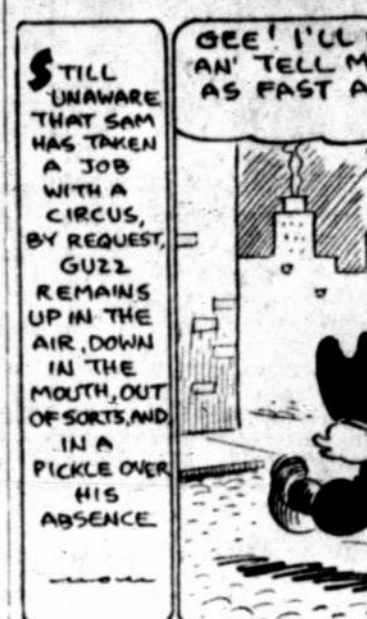

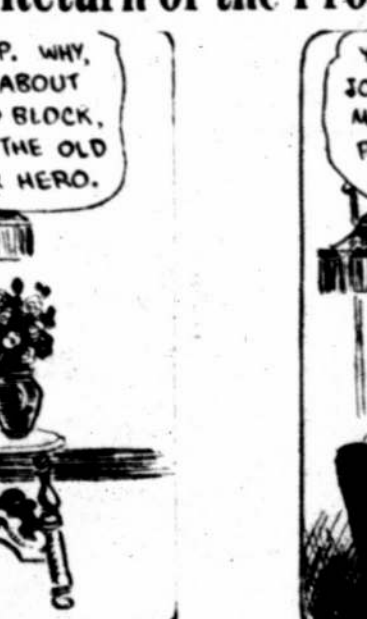

Imagination

Three American women are off
for Baghdad on a quest that will cer-
tainly be fascinating, even though it
probably will prove fruitless. They
want to find the storied palace of
Haroun al Raschid, and in the
process, they hope to find out
who wrote the Arabian Nights
stories.

Maybe it is unkind, in advance of
their explorations, to say that their
venture probably will fail. There
are certain riddles, bequeathed to
us by history that weren't meant to
be solved; and it does seem as if
this Arabian Nights business were
one of them.

Haroun al Raschid, like King Ar-
thur, Ulysses and other romantic
figures of the past, was very likely
a more or less legendary creature.
It is more than possible that old
Bagdad never knew a ruler by that
name. Hunting for his palace will
be much like trying to find King
it will mean looking for a place that
never was on the map that never
had reality. The quest is a noble
one for the profane feet of realistic
antiquarians.

Yet, for all that, the old Arabian
and his storied palace are quite as
real today as most flesh and blood
personages of the old days. More
so, in fact, anyone who can read
and can walk to the nearest library
can make the acquaintance of both
in short order. For when you in-
vent a man, or a place, you at once
make all ages from to come and
see. The things we imagine are
nearly always more real and sub-
stantial than the things which ac-
tually happen. What boy hasn't
stroled the quarter deck with Long
John Silver?

The truth is that we are not real-
istic people. We are servants of
dreams. The shapes that we con-
jure up in cloudland are the forces
that mold our lives. Even in our
history books this truth is apparent.
George Washington, for instance,
was once a live human figure, yet
we have interwoven into the story
of his life so much legend, so many
fanciful tales, that the Washington
of popular imagination probably
would be unrecognizable to Benja-
min Franklin, say, or John Adams,
who knew him in the flesh. And
that is not a fact to be regretted
either, for the legendary Washing-
ton has become gigantic, lordly, an
image of the ideals and aspirations
of his countrymen.

The ladies who are hunting Har-
oun's palace are not real, either.
somewhat those present day biog-
raphers who are trying to "de-bunk"
our histories. Their motive is very
likely highly praiseworthy, yet
there is a limit to the usefulness of
hard facts. Legends are more im-
portant. They are the stuff our
souls grow on.

It does no good to try to take the
old tales apart. The man who is
nourished and supported by them is
the man who suspends his faculties
of belief and absorbs them for
what they are. He is the man who
can sleep his ship into a harbor on
the southeast of Bohemia, while the
saber fact seekers beat to and fro
outside, looking in vain for a sea-
son.

Keep Moving

Fame is a fleeting thing, es-
pecially when gained in the realm
of aviation. Only Lindbergh seems
able to make his shine as brightly
as ever.

The other morning we saw a lit-
tle one-paragraph item buried on
an inside page of a newspaper tell-
ing how three flyers were preparing
to return to Europe. The three
named Voh Ruenfeldt, Kozel and
Pittsmaurice. On the same day we
read that Clarence Chamberlain had
had to cancel a lecture engagement
in an Ohio city because the man-
agement had been unable to sell
the tickets.

All of these men have enjoyed
front-page prominence. Quickly
they have slid back into compara-
tive neglect. A flyer these days
must keep moving if he would
maintain his fame undimmed.

Twas the jury that was hung.

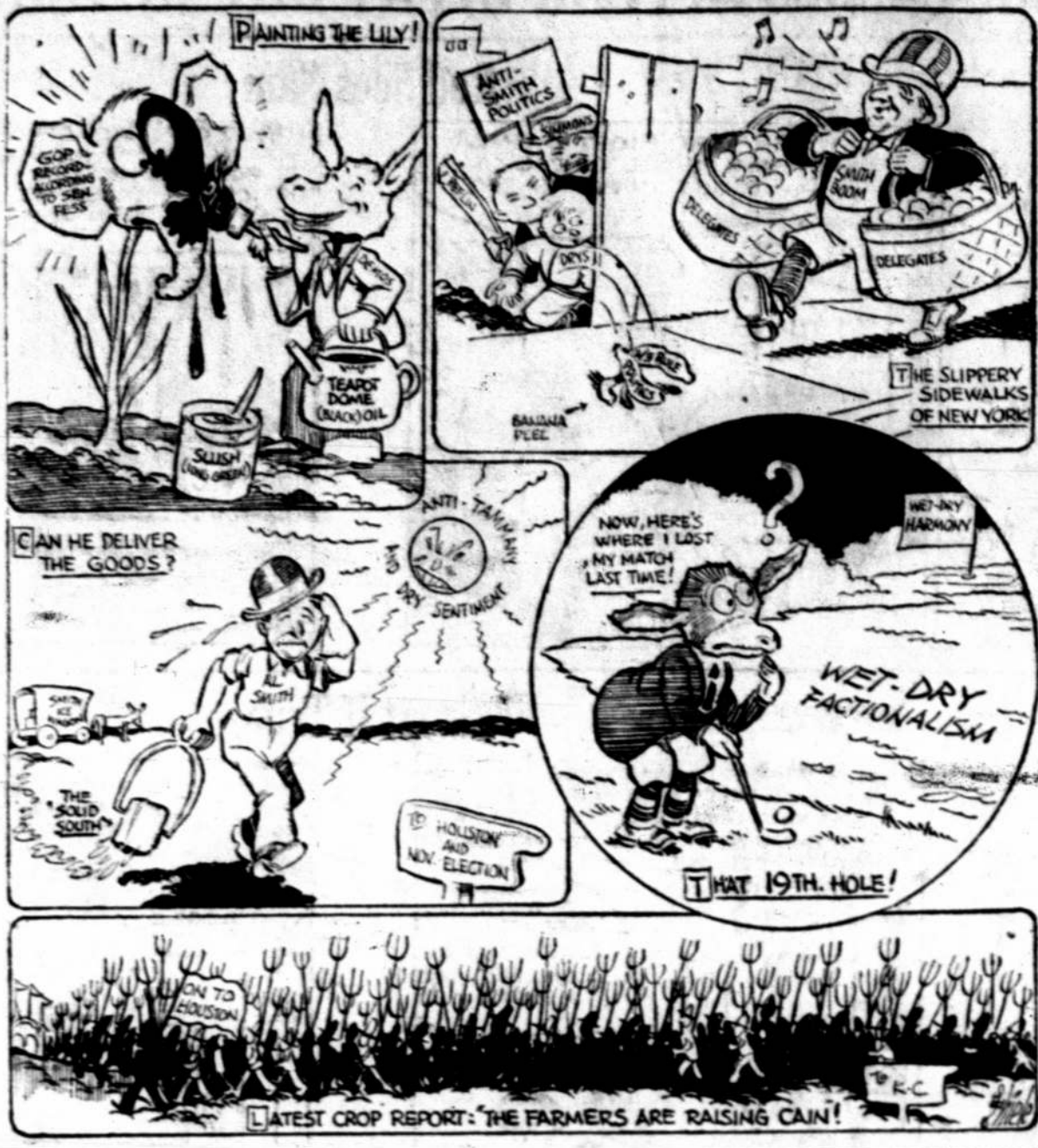
A recent edition of a bulletin,

SPRING VEGETABLE SHOW

Comparatively few Brownwood
people visited the spring vegetable
show in Soldiers and Sailors Mem-
orial Auditorium the other day, be-
cause limited publicity had been
given the exhibit, but all who saw
the many varieties of fine vegeta-
bles exhibited there expressed
both surprise and pleasure. Eighty
varieties of thirty-two vegetables
were exhibited by eight of the wom-
en's clubs of the county under the
direction of Miss Mayvase Ma-
lone, county home demonstration
agent, and some especially fine
specimens were noted in each com-
munity exhibit.

Brown county women and girls
have been giving a great deal of at-
tention to gardening in recent years
as a result of the development of
methods for canning fruits and
vegetables, and that they are suc-
cessful gardeners is attested by the
exhibits of both fresh and canned
vegetables they are able to present
in the vegetable show and in the
annual fall fair. In addition to the
standard varieties of vegetables,
Brown county women have been ex-
perimenting with many little known
varieties, some of which are com-
monly thought to be peculiarly the
products of tropical sections, and
they have succeeded remarkably well.
Some of the garden products are
consumed at home, some are
sold on local markets and the re-
mainder are carefully canned and
laid away for consumption next
winter or whenever desired.

In all sincerity it may be said
that Miss Mayvase Malone, the
county's efficient and hard working
demonstration agent, is entitled to
a major portion of the credit for
developing home gardens of the
county yet this is only one phase
of her work as a friend and
counselor of the rural women. She
has given generously of her knowl-
edge and skill in aiding women in
rural homes to beautify their home
surroundings, increase the produc-
tion of the farm and garden, and
preserve and market surplus prod-
ucts which in former years were
wasted because of lack of ade-
quate preserving methods. Miss
Malone has earned and received in
unlimited measure the friendship
and gratitude of the hundreds of
rural women with whom she has
worked and likewise has earned and
received the grateful appreciation
of all other citizens of Brown county.
Special events such as the
spring vegetable show merely serve
occasionally to call public attention
to outstanding products of her
work.—Brownwood Bulletin.

There is rather a tendency to
overlook some of the things that
our farmer women accomplish in
the matter of raising gardens, can-
ning fruits, etc. The farm women
contribute much to the upkeep of
the family, as well as to supplying
the needs of the people who live in
the cities and do not grow the vege-
tables and fruits that they use.

We make great exhibitions of the
fair products of the things that the
farmer raises, and the club boys and
girls but the housewife seldom gets
the notice of what she does to
make life worth living on the farm,
and we are glad to see that these
things are being brought into a
certain amount of recognition, and
though the meeting at Brownwood
may not have been very largely at-
tended, it is a beginning of a recog-
nition that will mean much in the
future.

HOUSTON, June 26.—The Demo-

of Wyoming for vice president on
the ticket with Al Smith.

If they do that,
we shall have
proof that there
is, after all, some
justice in this
world. The party
owes something to
Kendrick.

Not one person
in a thousand
knows it, but
Kendrick is a
man who first
had experience with
Teapot Dome scandal
out into daylight and caused the
sensational train of events among
which were the prosecution of Fall
Doherty and Sinclair and the re-
turn to the navy its oil reserves.

The glory all went to others,
principally Senator Tom Walsh of
Indiana and the late Senator La
Follette of Wisconsin. Probably

him.

But Kendrick, except for his oc-
casional unheralded appearances as
a government witness against the

will remember that it was he who
gave it the best yelling point it has
had for years in its attempts to
convince voters that the Republi-
cans should be driven from power.

In all sincerity it may be said
that Kendrick, as governor of Wyom-
ing, had had experience with grasp-
ing oil men and frail public offi-
cials. During his term the state
was seized with something of a
frenzy following discoveries of oil
on state lands. After the voters
elected him to the senate by writ-
ing his name on the ballots, he
promised that he wouldn't leave for
Washington until the oil rights
were farmed out on his own terms.
He won and the state obtained
from the oil men what Kendrick
considered an adequate price.

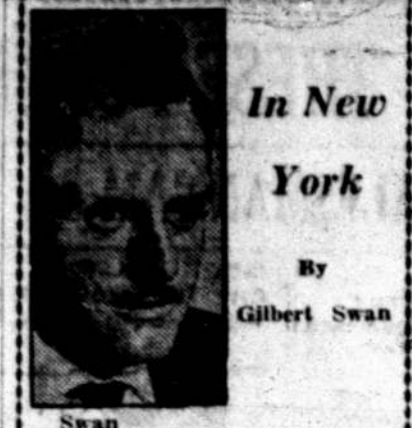

noon before administration leaders
knew what was going on, was a

clair and Standard Oil.
"This contract," he said, "can be
justified only by the insatiable
greed of monopoly, and I venture
this prediction, if every other ob-
jection to this contract were removed,
the secret method of its consumma-
tion is enough to condemn it in
the mind of every citizen, and it
will forever discredit the adminis-
tration of this great department;
and if it is defended by the na-
tional administration it will eventu-
ally plague and damn the adminis-
tration."
"That speech will never be an-
swered," an important oil man cor-
rectly predicted at the time.
Other hands took over the job of
exposing the pecking scandals of the
 Harding administration. Kendrick,
perfectly willing, made no attempt
to regain the limelight. La Fol-
lette, while he lived, often gave
Kendrick credit on the senate floor.
Kendrick is one of those special-
ists in congress who seldom land
on the front pages. He is a wealthy
stock owner and is the recognized
spokesman for that section of ag-
riculture in congress. He enjoys
the respect and confidence of his
colleagues and is known as a square
shooter.
Although his vice presidential
boom is considerably more than the
conventional favorite son boom, his
principal handicaps are that he has
no generally established reputation
as a campaigner and that Wyom-
ing has a very small electoral vote.

Just as Broadway suggests to the
world the radial center of the
American theater, just so—for some
reason or other—the Yankee Sta-
dium seems to be the goal of base-
ball fans. One may have watched
the national pastime from every
point of vantage, from the sand-
lots of the home town to the big
league contests. One may have
watched the Giants or the Yan-
kees perform on any one of the
outside lots—yet a glamor attaches
to the exhibit when staged in Man-
hattan that can be found nowhere
else.

The Stadium is the fan's para-
dise, not because it is any more
elaborate, comfortable, spectacu-
lar.

or impressive than any other ball
park, but because it has become as
legendary in its way as Broadway
or Park Avenue or the Fifth
Avenue shops. A ball game, good or
bad, takes on a glitter, a suppressed
excitement, a sort of end-of-the-
trail to the visiting fan.

games at Yankee Stadium still car-
ry a certain amount of allure.
Just over the fence and a few
steps away runs the sluggish river,
standing on your toes to shout, or
sitting high up in the rafters you
can watch the heavy laden barges

creeping by.

If the dullness of the game falls
upon you, you can meditate upon
the huge signs that rise at every
side, informing you of the virtues
of toilet soaps, motor lubricant or
breakfast food.

Where an outfielder waits lazily
for something to happen, the black
skeleton of the elevated rises and
now and then, the shouts of the
crowd are magnified by the crunch-
ing of the elevated train wheels as
they come and go.

You can watch the conductors
and motormen leave their trains
and run to the railing. You can
see small boys and passengers do
the same. I know a three train
crew that, possessed, jumpers so
that in the few moments between
schedules, they can get a better
sleep at the tiny figures on the
ground below.

By this time, perhaps, you get
my point. There is a certain an-
granny that typifies New York
which adds a tobacco flavor to the
routine of pitching, catching and
running bases. Even the vendors
of pop, peanuts and hot dogs seem
to have a circus twang to their
blase peddling of wares.

Outside the grounds the players'
entrance is an interesting point to
watch, before or after the game.
Babe Ruth, by the way, never leaves
the grounds by the regular exit.
This would be the sheerest of fol-
lies. For he would never get to his
car, which stands at the curb
guarded by a special policeman.
Were he to exit by any famu-
gate the mob would be upon him.
They would have baseballs to au-
tograph and cards to write upon.
Yet the crowd waits, not any too
patiently, for a glimpse of him—
which it seldom gets.

The fact is that Babe escapes
each day by means of a secret by-
way. He has a peephole through
which he first peers to see whether
anyone is watching. When the road
is clear he ducks out, makes a wild
dash for his car and is on his way
to his Bronx dwelling before any-
one knows what it's all about.

JONES SPEAKS TO BIG CROWD MONDAY NIGHT

PAST RECORD IS CITED AND PROMISES MADE FOR FUTURE WORK

Pledging future work, if re-elected, and pointing out his past record in the interest of the farmer, Congressman Marvin Jones of Amarillo addressed a large crowd of Lubbock citizens in the district court room last night in the interest of his candidacy for re-election.

Mr. Jones presented a comprehensive discussion of campaign issues, declaring that he was unqualifiedly stating his opposition to any "wet" presidential candidate. A discerning and intelligent discussion on the outstanding national issues of the day, stressing the urgent need of coping with the cotton situation, came in the course of his address.

Honored in Banquet

Prior to his address at the court house, he was tendered a testimonial banquet at the Lubbock hotel by the directorate of the Board of City Development in showing Lubbock's appreciation for his work in securing the federal court and building for the city.

Just before his speech in the court room, he was presented with a large basket of flowers by Mrs. Harter D. Woods, wife of Mayor Woods, who expressed the appreciation of Lubbock citizens for his services to them. He was introduced to the audience by C. E. Maedgen, local banker, one of the men who aided in securing the court in Washington, who called Congressman Jones the "deal congressman," young, energetic and affable one of the best liked and most highly respected men in Washington.

"It is a pleasure," stated Mr. Jones, "to work for appreciative people, and the people of West Texas are thoroughly sincere in their appreciation. Much of this tribute, however, should go to the work of the committee and to the committees of former years who laid the basis of our success."

Government A Business

"The government of the United States is the biggest business institution on earth, and we are all stockholders in it. Everyone's interests are indirectly involved, therefore, we should think seriously about the men who we put in office."

Mr. Jones, who represents 53 counties, 4500 square miles of territory, and who is the youngest congressman from Texas, then gave a summary of his work since he has been in the House of Representatives.

"I voted for the acts of 1917, 1921 and 1924 for restricting immigration. There is no room in America for men whose feet are on our shores and whose hearts are in another land. I do not want America to become a baffle of strange voices. I shall always state my position frankly on any national issue."

As regards prohibition, let me say that I am against nominating any wet candidate, no matter who he is. I believe that Cordell Hull of Tennessee, is the most capable man in the United States today for president. He is one of the best financiers of the country has ever known."

Congressman Jones was primarily interested in the agricultural situation and attempted to get on the Agricultural Committee the first year of his term, but was unsuccessful. Later, however, he became a member of that committee, and

immediately he began to make his influence felt.

"Three years ago," he said, "I introduced a bill to require the making of separate bills for merchantable and non-merchantable cotton. It fell through, but the next year, it was re-introduced as a joint bill with one proposed by a senator, and was passed successfully."

Seek Cotton Users

Then I introduced a bill to investigate new uses of cotton and just as the other did, it failed the first time, and was passed the second. Now more than 20 different new uses of cotton have been found, and 400,000 bales have been utilized."

Mr. Jones discussed very clearly and forcefully the cotton problem as it exists today. He said that, when he began investigating the Department of Agriculture was spending ninety percent of its appropriations on production and ten percent on distribution, when it should have been spending seventy percent on distribution, as every farmer and cotton dealer realizes that therein lies the real fault. He threatened to use his influence, as second-ranking man on the agriculture committee, to have the appropriations cut if they were not directed differently and as a result, he won his case. Dr. B. Youngblood, of Texas A. & M. College, who is considered one of the most capable students of agriculture is now in charge of the work in Washington of investigating and improving cotton conditions.

Mr. Jones denied the charge, which he said was made by his opponent that he had voted to increase his own salary.

"If I have no merits of my own to run on, it is not my nature to run on the merits of my opponent," said he. "I think it only fitting, however, that I defend myself from the charge which has been made against me."

"I do not say," he added, "that the charge was made maliciously, but I do say that it was made carelessly."

Mr. Jones discussed the outstanding national issues of the day in a highly discerning and intelligent manner, but he stressed throughout his speech the urgent need of coping with the cotton situation. "I have spent the bloom of my youth in dealing with farm problems, because I am interested in them, and because I believe that I owe it to the people I represent to spend my time on the things in which they are interested. I am

The boys are to come from Dawson, Scurry, Terry, Gaines, Hockley, Hale and Garza counties accompanied by their respective county agents, C. B. Martin, C. C. Willis, R. B. Davis, R. N. Mithollian and Knox Parr.

Over 300 Expected

More than 300 boys and girls will be here for the encampment, Mr. Eaton said today, making it the largest annual encampment that the county has ever had and one of the largest gatherings of 4-H club members in West Texas. The meeting this week will more than likely call for an annual district meeting of clubs from all South Plains counties to be held in Lubbock.

Local club leaders and officials are busy today cleaning out the buildings and arranging places at the fair grounds for the encampment.

Study and pleasure will be mixed in the encampment, the boys being escorted to the college soon after their arrival here where they will take part in the judging training course which will be held under the direction of Dean A. H. Leidigh, Prof. W. L. Stangel of the Tech school of agriculture and Don L. Jones, superintendent of the state experiment station. Poultry judging work will be held under the direction of Miss Myrtle Murray, of College Station, district home demonstration agent.

Wednesday Start Day

Wednesday night will be start and program night at the grounds with W. P. Knox, scout executive of the South Plains in charge of the camp fire program which will be given. Mr. Knox will also have charge of registration and organization of the boys during the morning of the first day. On Thursday morning, the group will be escorted to the city municipal swimming pool where they are to enjoy a good swim under the direction of K. N. Clapp.

In the judging work at the college, the seven boys who are to make the trip to the State Short Course at College Station will be

held. Expenses of five of them will be paid by the Lubbock Chamber of Commerce while the Farm Bureau will pay a boy's and a girl's expenses.

Three meals during the encampment will be given through the cooperation of the Lubbock Chamber of Commerce and the Lubbock County Farm Bureau.
