

# TEXAS STORMS MOVING INLAND

## Dollfus and Cabinet Said Captured by Nazi Rioters

VIENNA, July 25. (U.P.)—Austrian nazis seized the chancellery today and made prisoners of Chancellor Engelbert Dollfus and members of the cabinet. An unconfirmed report said Dollfus was wounded. Martial law was declared and troops filled the streets but the nazis, barricaded in the chancellery, threatened violence to prisoners if attacked. All communication with foreign countries was cut off. Guard barracks in the seventh district were seized by 300 nazis who took machine guns, rifles and ammunition. The extent of casualties was unknown but at least ten were killed in street fighting of troops and police. The Heimwehr was prepared to attack the chancellery if prisoners indicated they preferred storming to surrender to the nazis.

## CATTLE RECEIVING CONTINUES HERE

Temporary cessation of receiving government cattle at Midland was broken Monday and Tuesday, 71 cattle being taken Tuesday alone. News of the extensive strike at the Chicago yards, however, has put a slight kink in the program, though Midland cattle go to Fort Worth, Dallas and El Paso. Glutted yards in those places have come more to slow the program here than anything else.

If the Chicago disorder goes no further, extends to no other yards, the impediment to local shipments and its attendant reflection on buying and receiving can be adjusted in 10 days, believes County Farm Agent S. A. Dobbin.

It was announced at the agent's office this morning that more than 2500 cattle had been shipped from Midland since the program began. There have been 125 applications made out by ranchmen and farmers, 4,039 head inspected, 930 head condemned. The 125 applicants reported they will have 30,565 head left on their ranges after selling the government part of their herds.

An order to cease buying cattle under the government drought relief until further instructions and a subsequent dispatch countermanding the first order threw the buying campaign at Big Spring off stride. County Administrator R. H. McNew Monday morning was notified to cease purchasing cattle offered to the government until congestion at shipping points was relieved. Acting on this advice, County Agent O. P. Griffin dispatched two of his office employees to notify those listed on the schedule through Wednesday not to expect the appraiser and inspector until further notice.

Soon after they left on their mission, he was notified of the countermanding order. He could not reach his employees to tell them of the change. Monday afternoon he said he would have to start from "scratch" revising the schedule for the inspector and buyer. It had been his intention to start Monday on a new arrangement which would tend to serve most urgent cases first. Some of the strike had not paralyzed the handling of cattle there. Under the present condition, buyers were awaiting government orders.

Young Lloyd refused to let word of his accident get home because he was afraid the account would retard the race of Joe Bailey Jr. for U. S. senator.

Absentee voting has been heavy this year and is expected to exceed the 20 per cent mark. All ballots mailed at the clerk's office by midnight Thursday will be counted. Absentee votes number approximately 140.

## Only Nine Races Elicit Much Midland Interest

Evidence that the apathetic response of Midland county to political campaigns is crystallizing in suddenly awakened interest is being encountered, and those who make a habit of peering into the possible voting strength of the local electorate say at least 1,800 ballots will be marked. District candidates evidently believe that many votes will be cast, judging from their last-minute solicitation of those who bought poll taxes. Adding the customary 15 per cent allowable for exemptions, a potential vote of approximately 1975 is seen.

A curbstone canvass this morning established Midland's interest as far ahead as the Midland county pick of agricultural commissioner, as is J. H. Walker of Hill county for general land office commissioner. For residential care being exercised to contact several partisans in a given campaign. Findings show that Tom Connally is a heavy favorite for U. S. senator, with some favoring predicting he will get no less than 1400 votes here, others saying he will get more. Clint Small of Potter county seems to have the edge in the gubernatorial race, with Tom Hunter or C. C. McDonald running second. About an equal number of partisans predicted Hunter and McDonald for second place.

J. E. McDonald of Ellis county is far ahead as the Midland county pick of agricultural commissioner, as is J. H. Walker of Hill county for general land office commissioner. A Midland woman, Mrs. J. A. Haley, will carry the county to representative, all agree. State highway commissioner, Charles L. Klapproth, the incumbent, is odds-on favorite. Beyond predicting close contests, little could be learned about the races for judicial attorney, county treasurer and commissioner of Precinct 1.

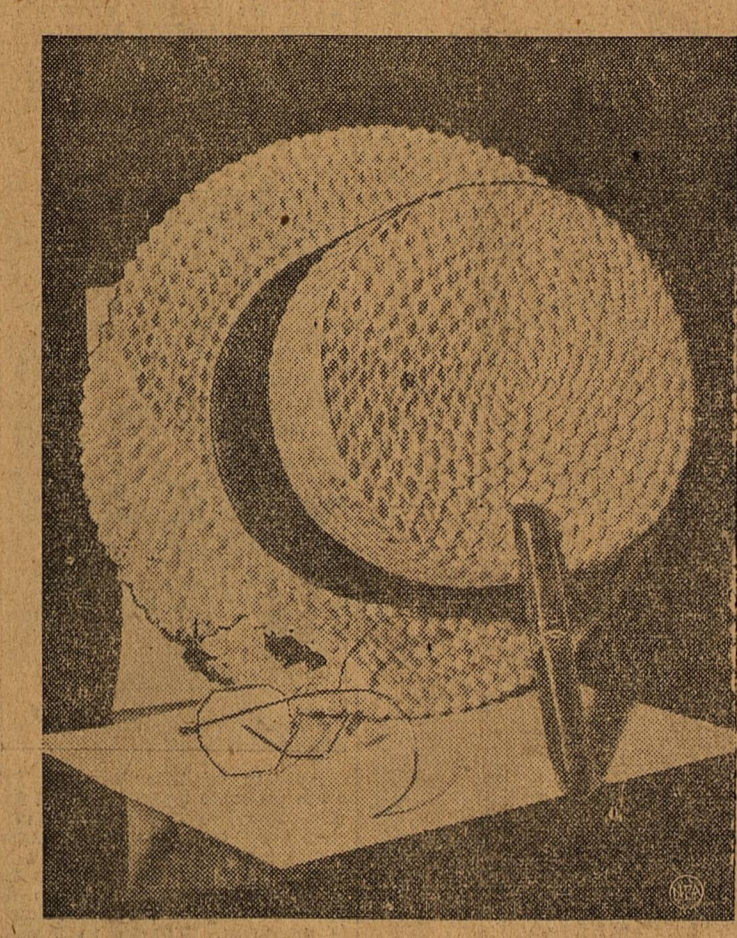

## ELECTION PARTY HERE SATURDAY TO GIVE RESULTS ON COUNTY, DISTRICT

The Reporter-Telegram will hold an election party Saturday night, beginning about 7:15 and post county and district returns on a bulletin board. Votes on all county and precinct offices, and for district offices, will be announced and state representative will be announced as soon as they are gathered and compiled. County results will be posted by boxes every two hours until the returns are complete. The Reporter-Telegram will issue extras during the evening as returns from the state rates are received. The Texas Election Bureau, operated by the Texas Managing Editors' association for more than 20 years as a cooperative agency for gathering election returns for newspaper use, will furnish The Reporter-Telegram with state returns on all offices. The bureau announced several days that returning supplies that organization will not be broadcast, telephoned or placed on bulletin boards. All returns from the bureau, however, will be carried in The Reporter-Telegram, in extras and in the regular Sunday morning edition, which will come off the press about 3 a. m. Another extra will reach the streets Sunday afternoon if results of races have not been determined in time to be included in earlier editions. The Reporter-Telegram has gone to considerable expense to obtain this service, information supplied by which may be given the public only through newspapers. The Texas Election Bureau's announcement in regard to broadcasting and bulletin boards follows: "In the past few years election news gathered by the bureau has been used so largely by persons who contribute nothing to the expense as to destroy its value to the newspapers that do contribute. This election news has been obtained from bulletin boards, and from broadcasts. Attorneys advise that when news is broadcast or put on bulletin boards it becomes public property. Hence, to protect its rights in this news, the bureau has prohibited the use of its returns on bulletin boards, and incorporated so that it may assert in court its property right in whatsoever news supplies to its members. "The ban on broadcasts and bulletin boards is merely a move to pre-empt the only agency we have for gathering returns at all on election night." Accordingly, The Reporter-Telegram in adhering strictly to the terms of the contract signed with the Texas Election Bureau can give no state returns over the telephone, interpreting the broadcasting clause to include that form of communication.

## WAVES WASHING HIGH ON COAST AROUND CORPUS

Aransas Reports 700 Marooned as Ferry Is Suspended

BULLETIN  
Army craft at San Antonio, were ordered grounded early this afternoon when a tropical hurricane "apparently was headed for the San Antonio area and inland," according to a telegram sent the U. S. army airbase at Midland by Col. C. L. Prosser, Fort Sam Houston.

HOUSTON, July 25. (U.P.)—A gulf storm of hurricane force at the center was expected to move inland by 2 o'clock this afternoon between Port O'Connor and Rockport, 30 miles north of Corpus Christi.

Hurricane warnings were flying from Galveston to Corpus Christi. Heavy seas were buffeting the coast along a wide front and 700 were marooned at Port Aransas as the ferry was suspended. They were believed not in danger. Eighteen were marooned in the coast guard station at San Luis pass and others were reported missing elsewhere. Winds of from 70 to 80 miles velocity lashed Freeport where 50 persons were killed in the storm of 1932. Barometers were falling, accompanied by torrential rains. Power and communication service were interrupted in Bay City and Port O'Connor areas. Highway patrolmen were ordered from Houston to the storm area. Wind disturbances and unsettled weather extended into central Texas, damaging buildings in Kaufman county and blowing down lines at Temple and between Kemp and Dallas.

Jelly Making In Three Steps

EDITOR'S NOTE: In response to requests for plum jelly, the following was taken from champion jelly makers who win ribbons year after year at state fairs.

Ripe Plum Jelly 4 cups (2 lbs.) juice 7 1/2 cups (3 3/4 lbs.) sugar 1/2 bottle fruit pectin. To prepare juice, crush thoroughly 4 pounds fully ripe fruit. Do not peel or pit. Add 1 cup water. Bring to a boil, cover, and simmer 10 minutes. Place in jelly cloth or bag; squeeze out juice.

Measure sugar and juice into large saucepan and mix. Bring to a boil over hottest fire and at once add bottled fruit pectin, stirring constantly. Then bring to a full rolling boil and boil hard 1/2 minute. Remove from fire, skin, pour quickly. Paraffin hot jelly. Makes about 11 glasses (6 fluid ounces each).

Jelly making can be simple if the three following steps are followed: 10 o'clock—Squeeze juice, after simmering 10 minutes. 10:08—Add pectin and stir. 10:10—Pour jelly quickly, paraffin hot jelly.

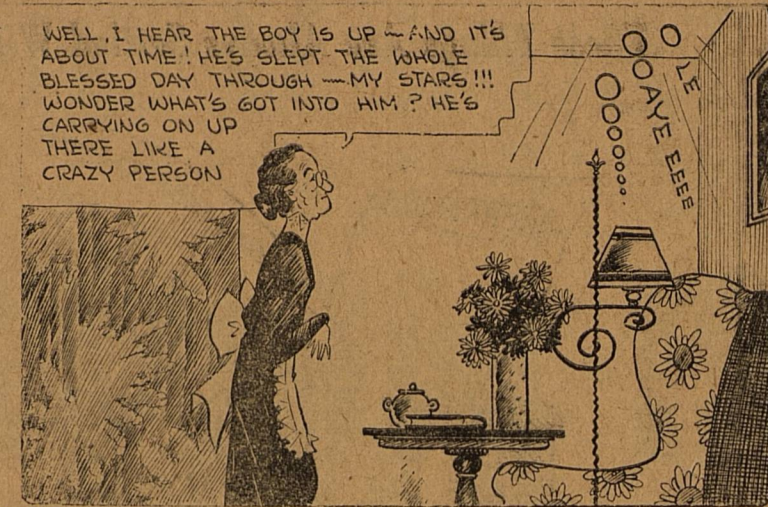
PLANS ALTITUDE FLIGHT
